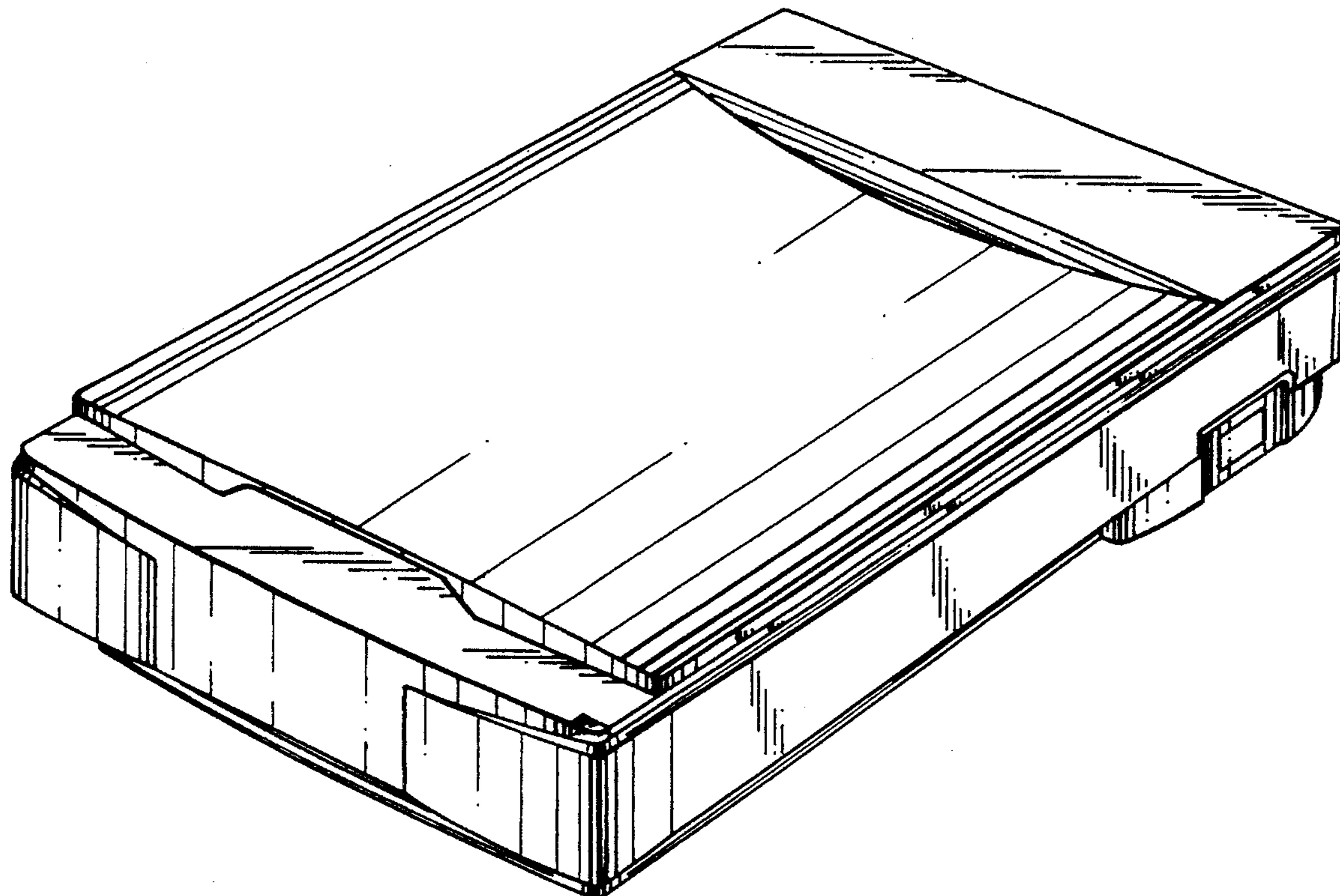
### [57] CLAIM

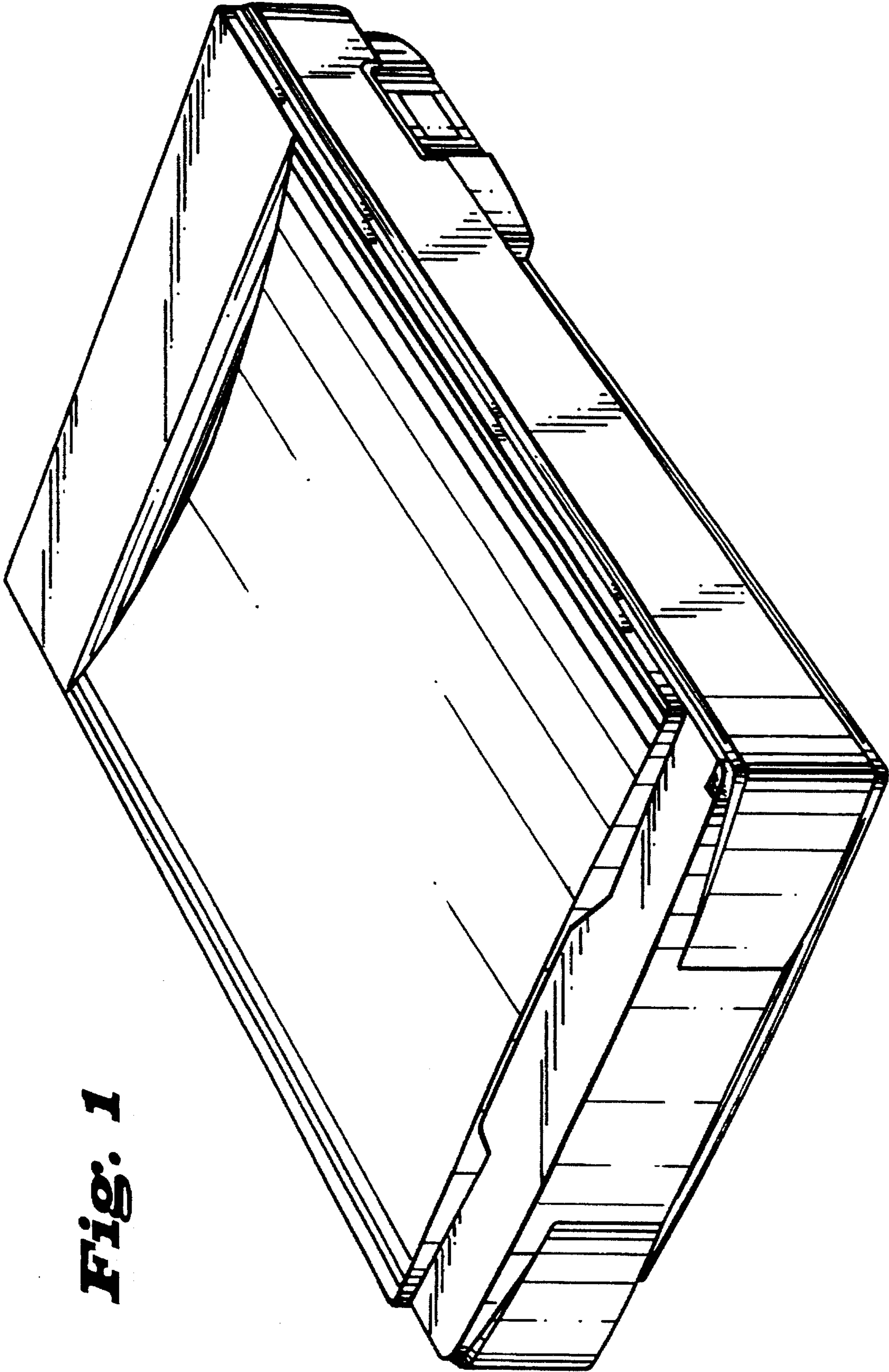
The ornamental design for a scanner, as shown and described.

### DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a scanner according to my invention;

FIG. 7 is a bottom plan view thereof.

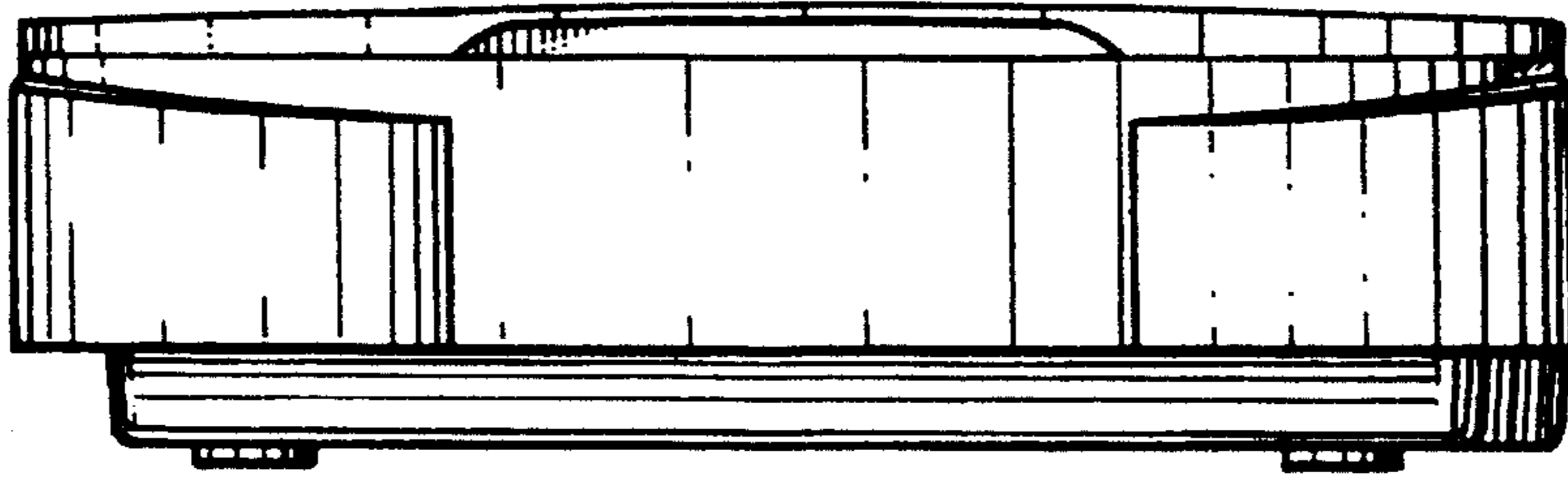

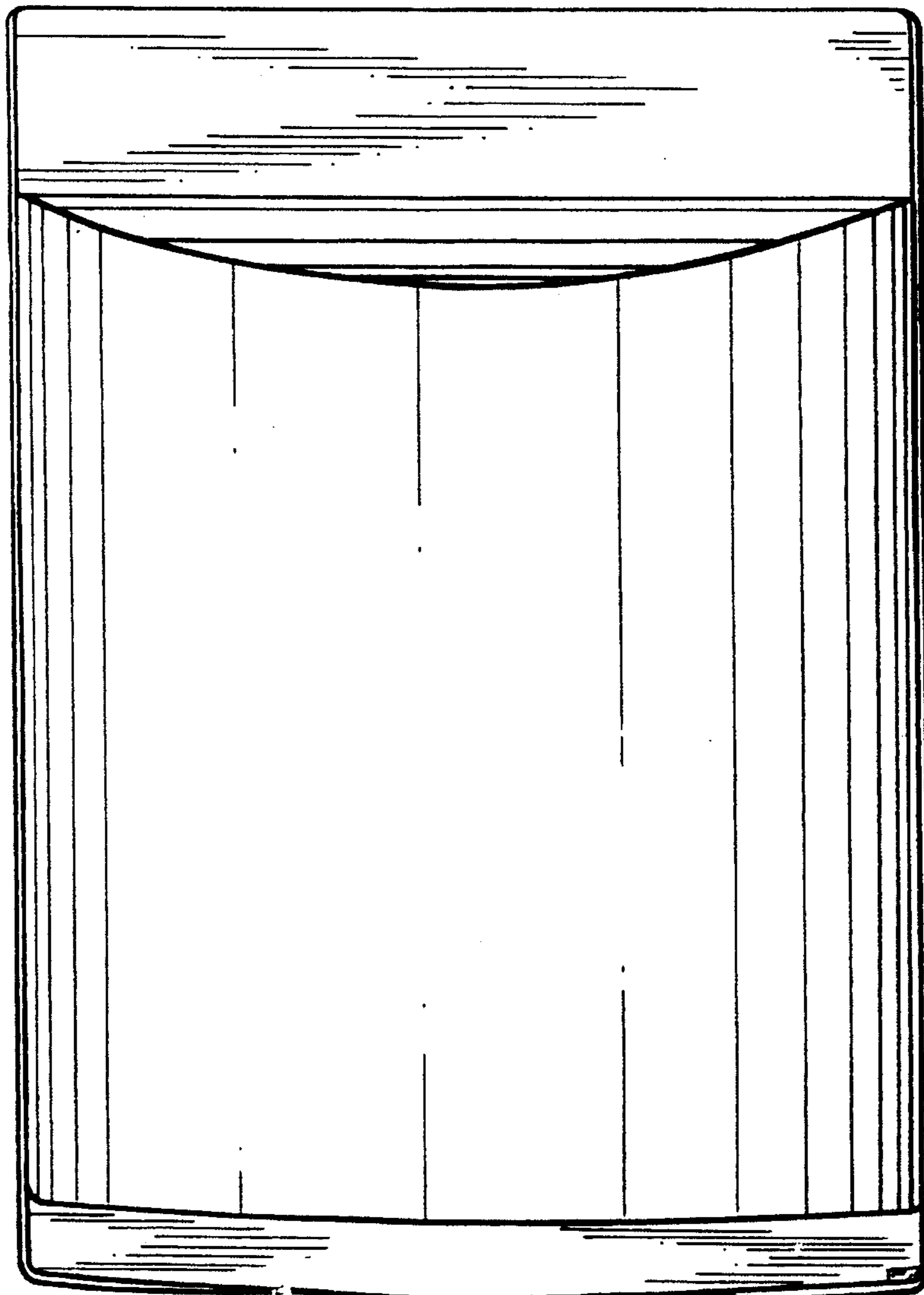

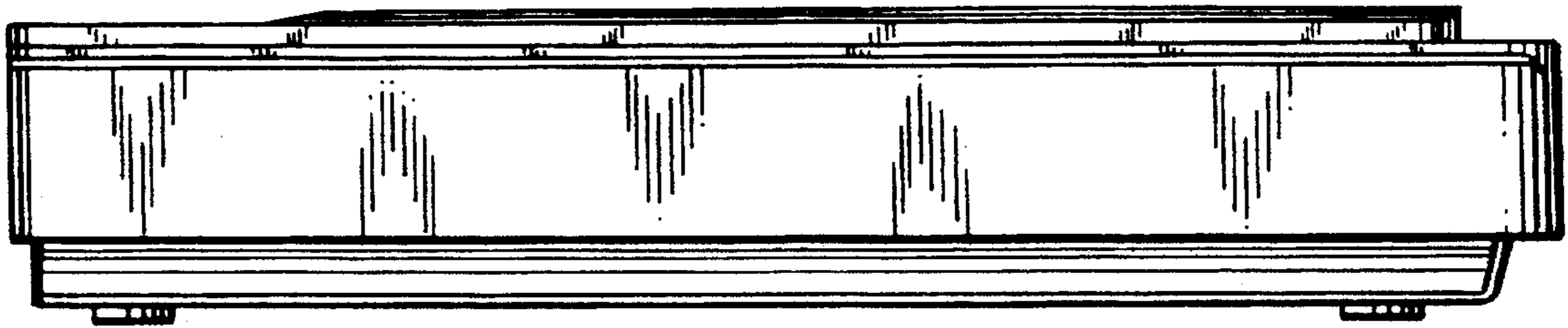

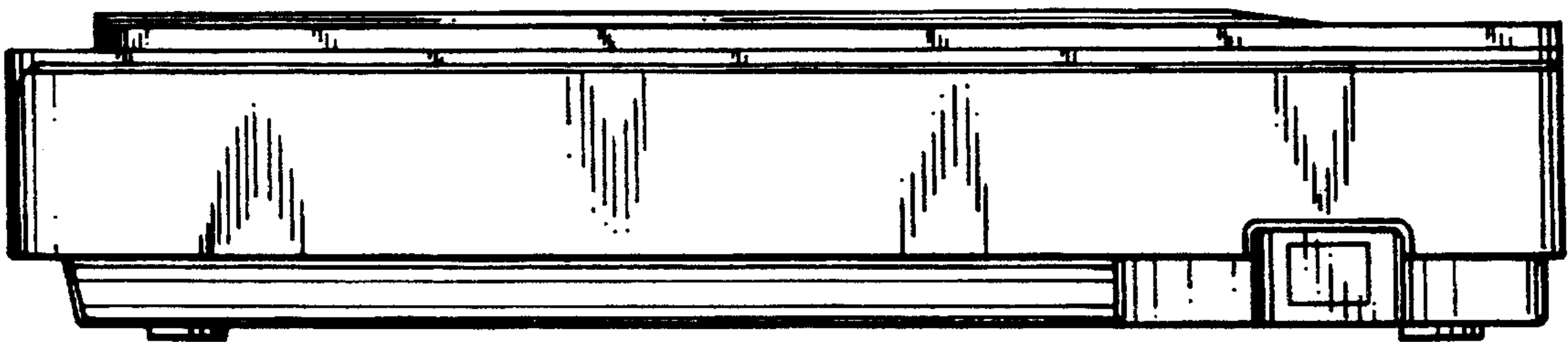

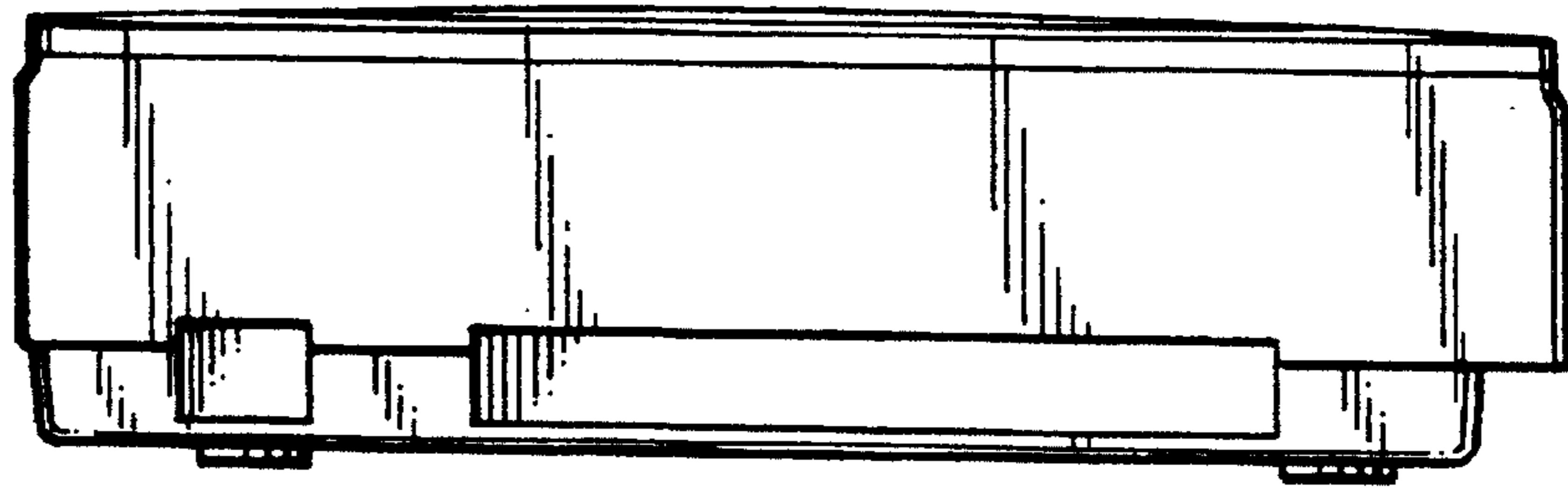
