[57] **CLAIM**

The ornamental design for a football motif computer dust cover kit, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a football motif computer dust cover kit in accordance with my invention; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; FIG. 4 is a left-hand side view thereof; FIG. 5 is a right-hand side view thereof; FIG. 6 is a back side view thereof; and, FIG. 7 is a bottom view thereof. The broken lines are shown in the figures for illustrative purposes only and form no part of the claimed design.

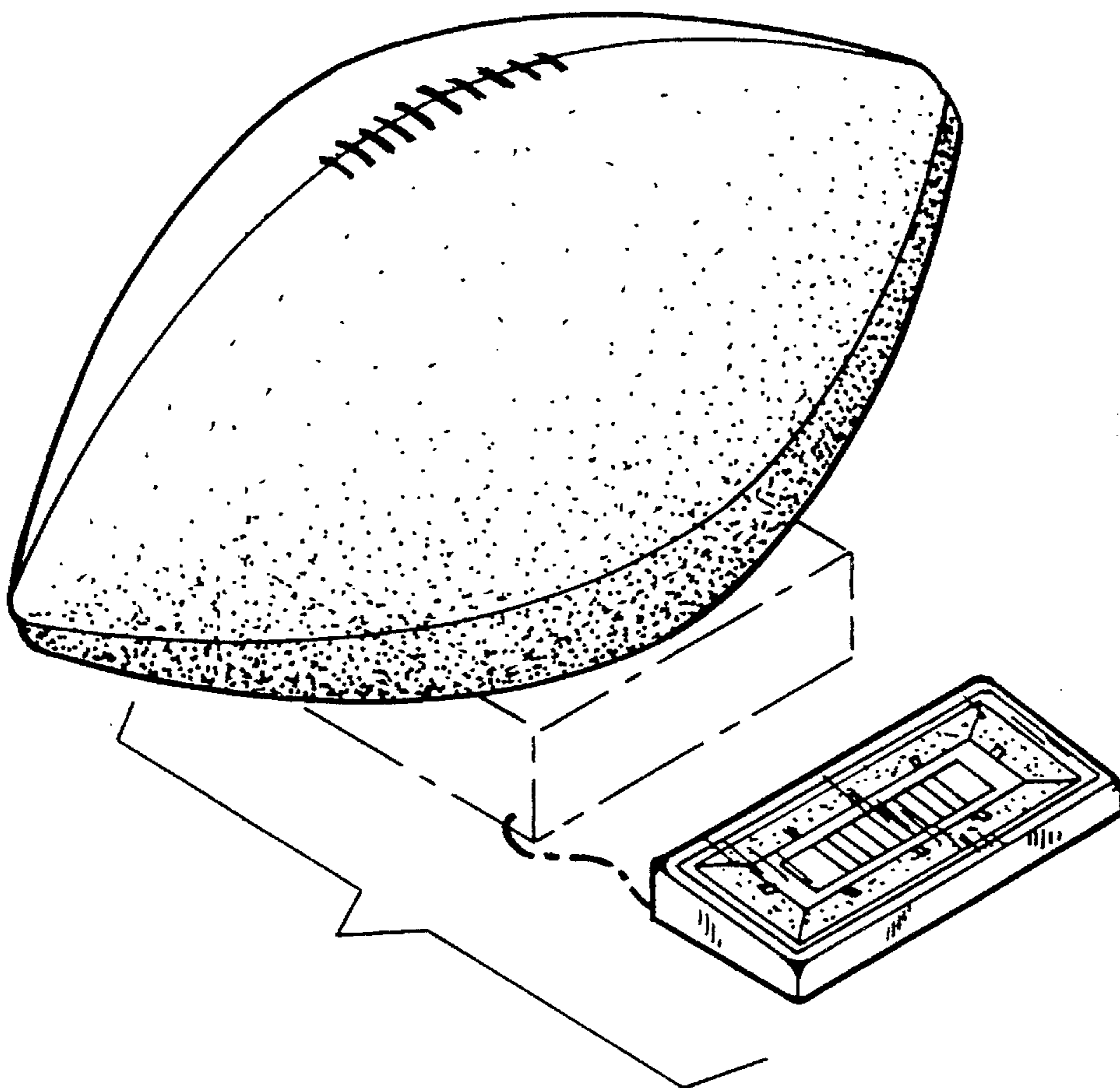

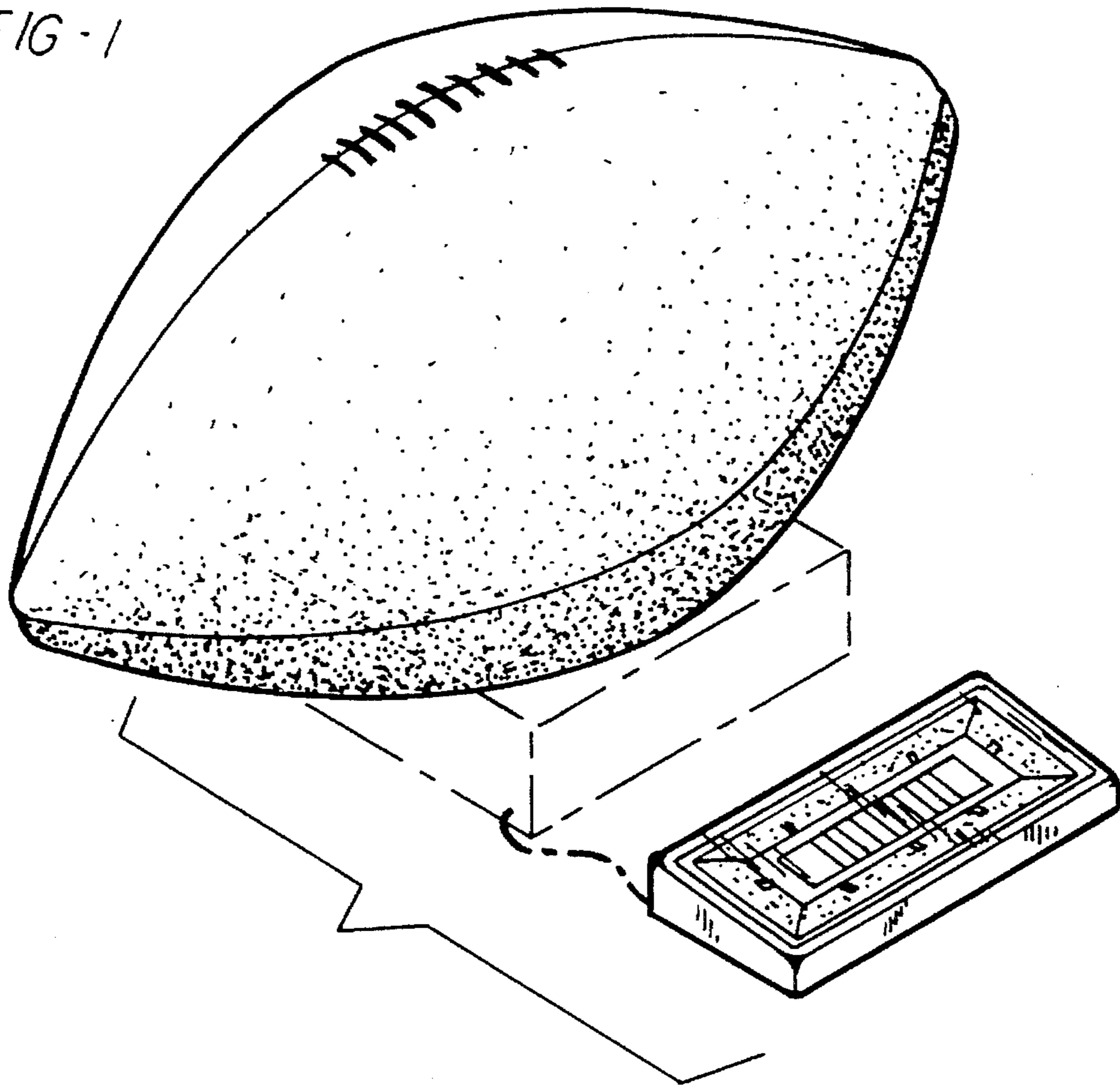

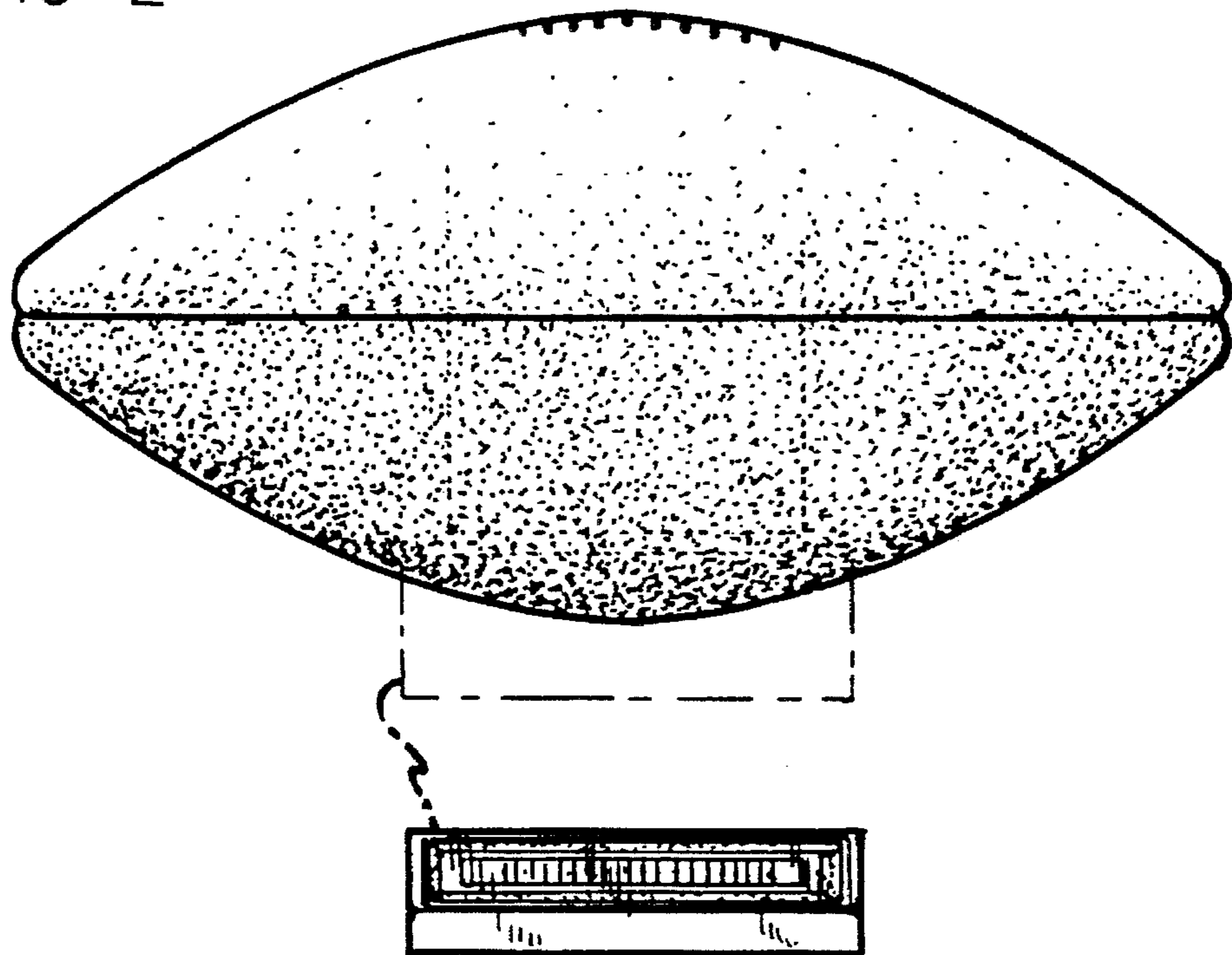

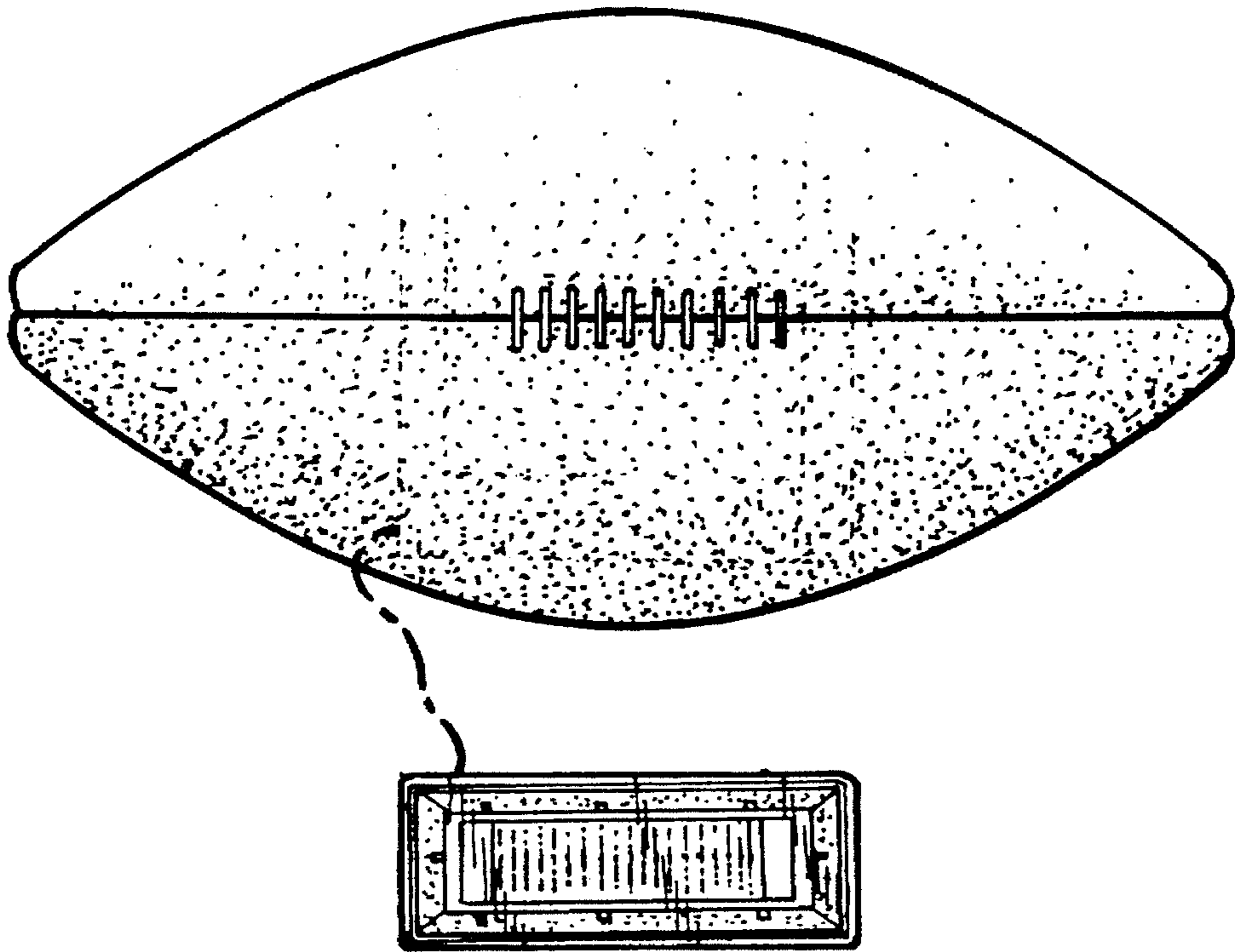

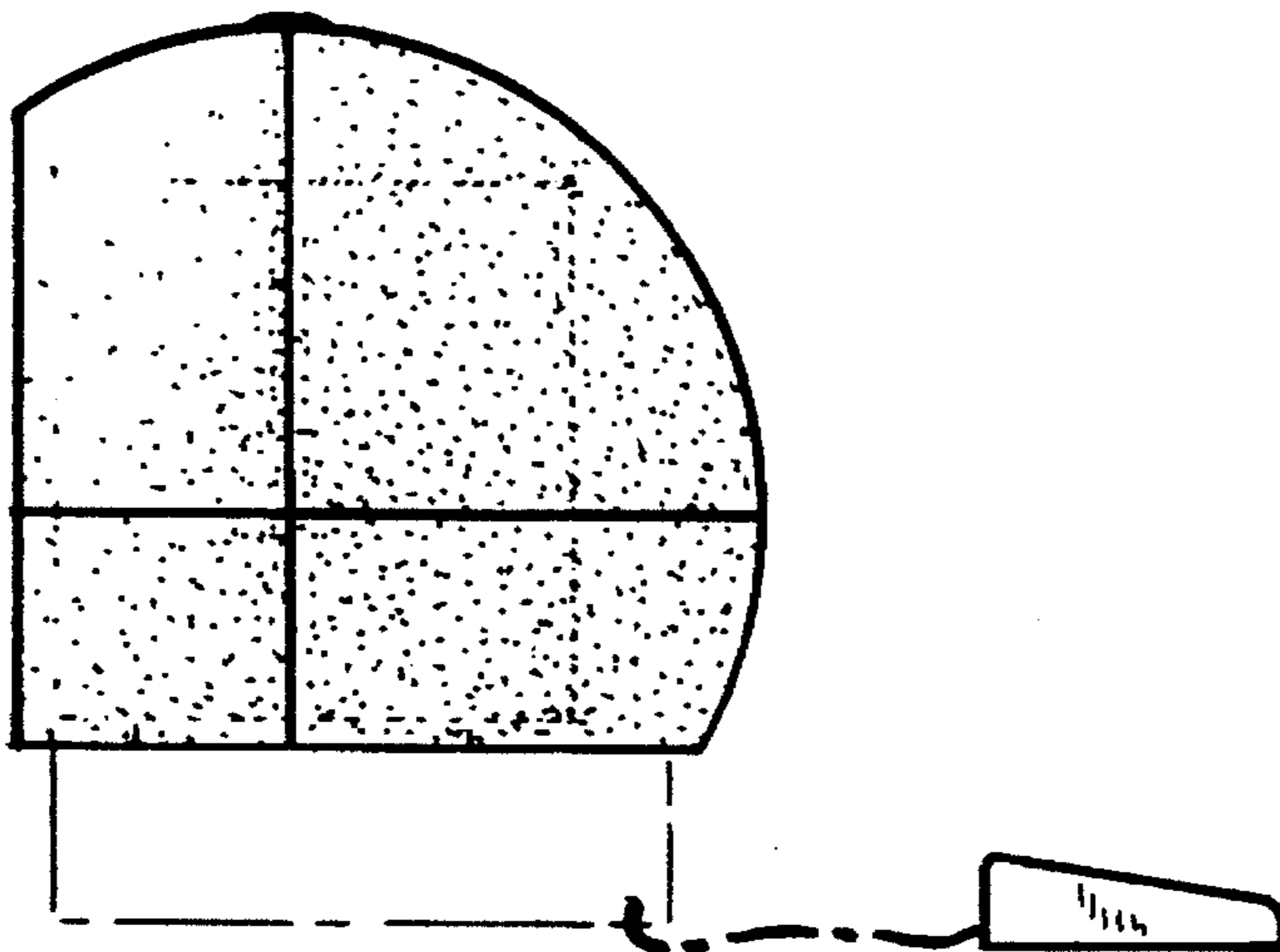

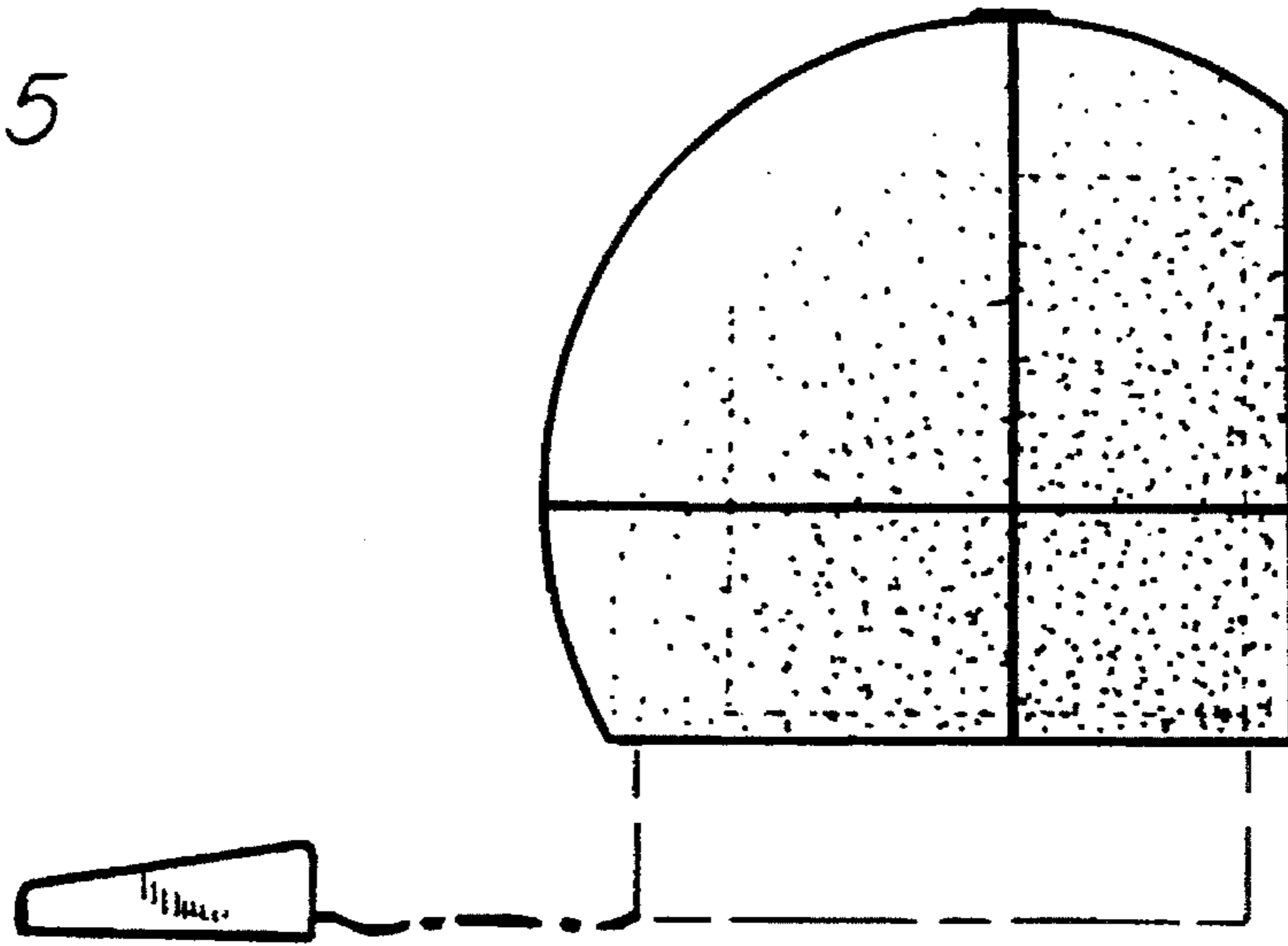

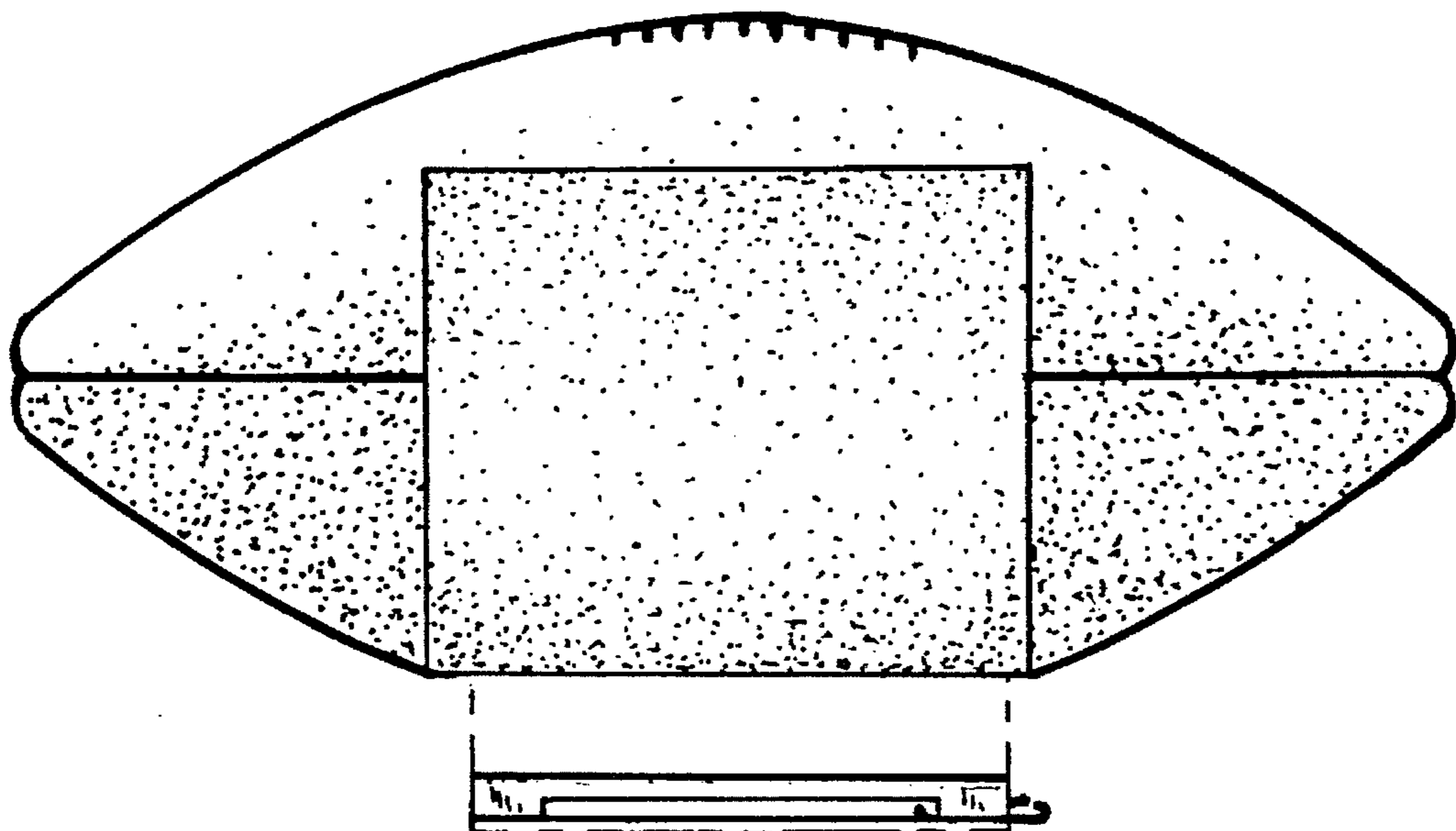
