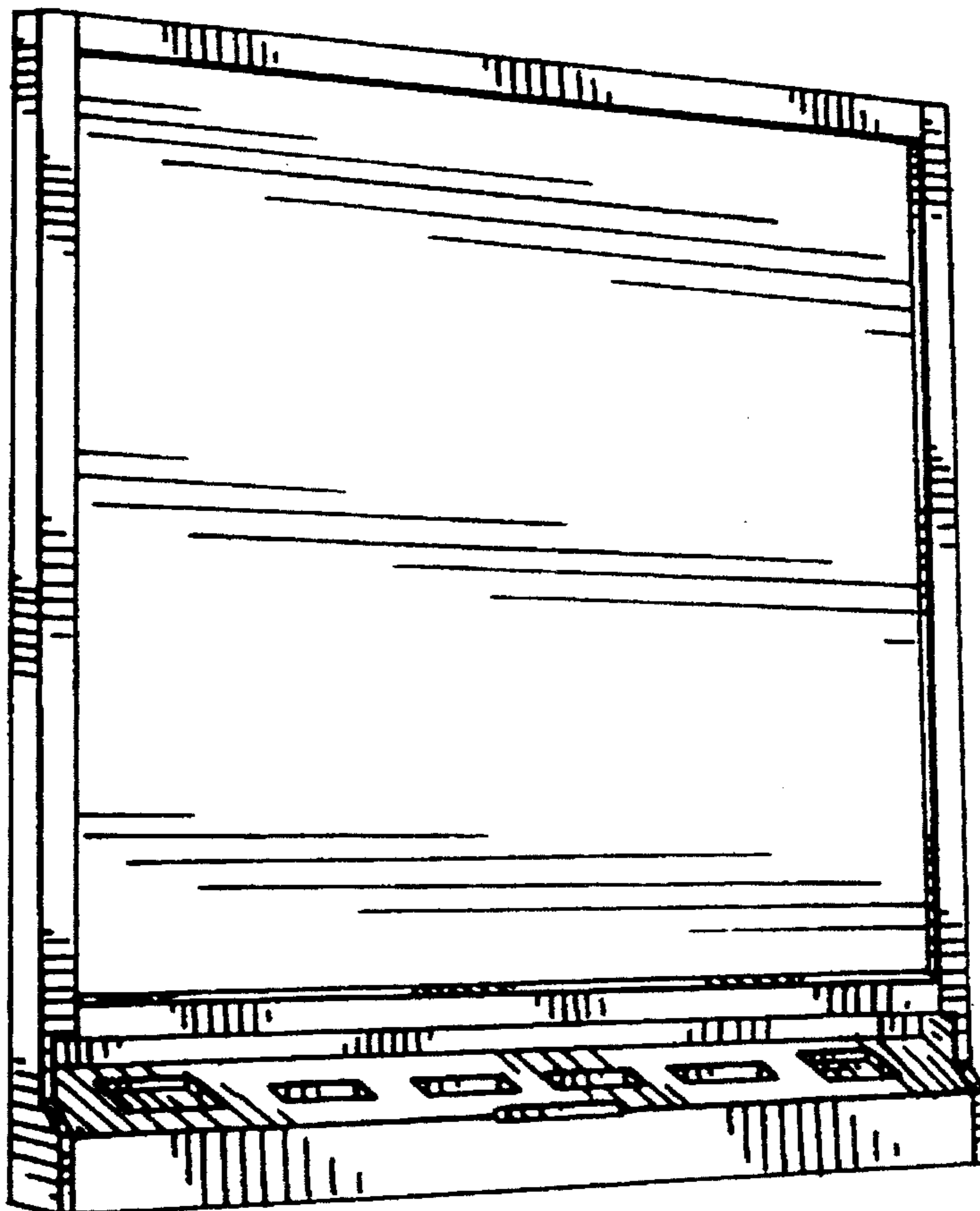
The ornamental design for a display board, as shown and described.

DESCRIPTION

FIG. 1 is a prospective view from the front and to one side of the display board;
 FIG. 2 is a top plan view of the display board of FIG. 1;
 FIG. 3 is a front plan view of the display board of FIG. 1;
 FIG. 4 is a side view of the display board of FIG. 1;
 FIG. 5 is a rear plan view of a display board of FIG. 1;
 FIG. 6 is a prospective view from the top and to one side of an alternate embodiment of the having doors;
 FIG. 7 is a top plan view of the display board of FIG. 6 with the doors open;
 FIG. 8 is a front plan view of the display board of FIG. 6 with the doors open;
 FIG. 9 is a side view of the display board of FIG. 6 with the doors open;

 FIG. 11 is a front plan view of the display board of FIG. 6, with the doors closed.

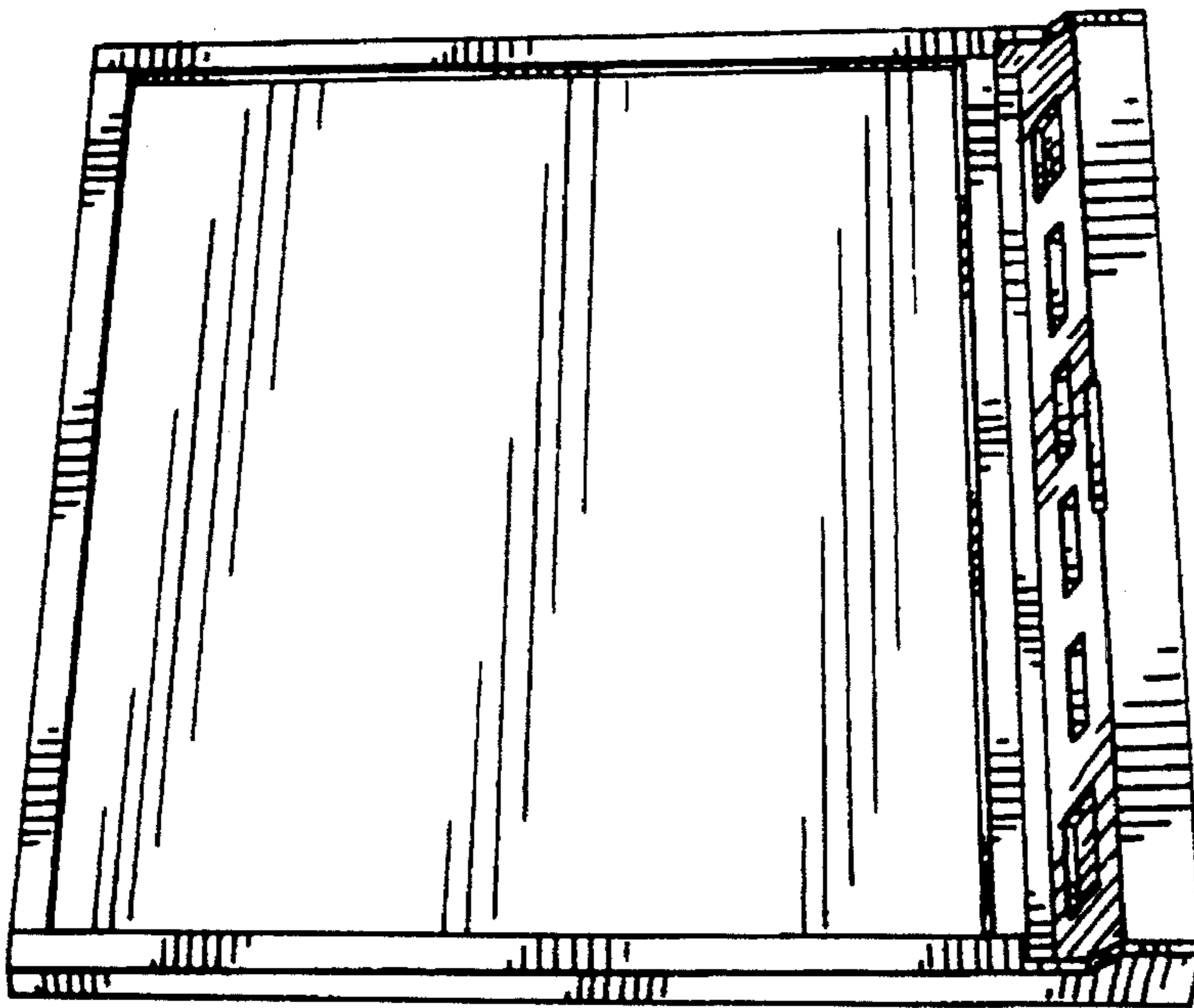

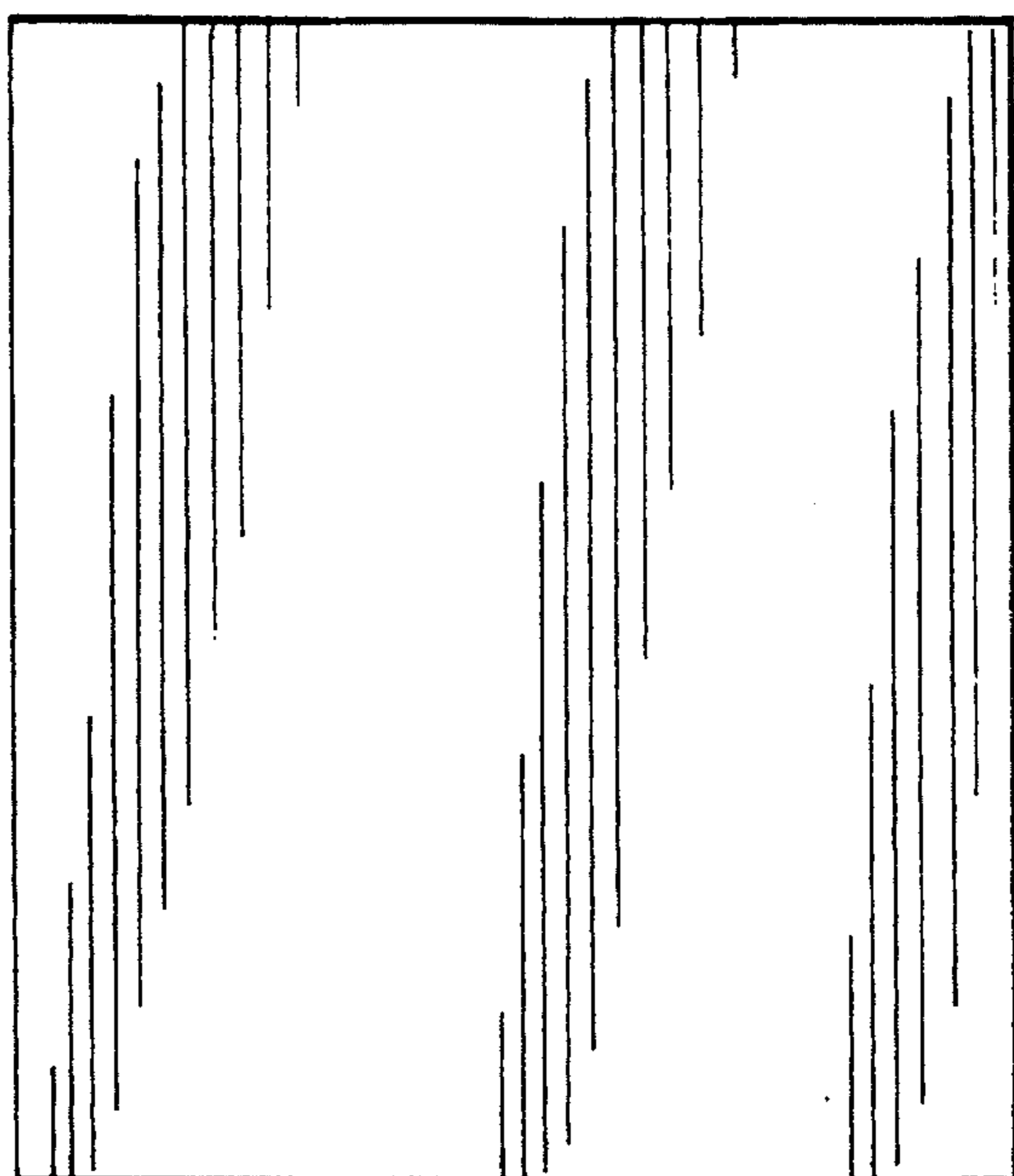

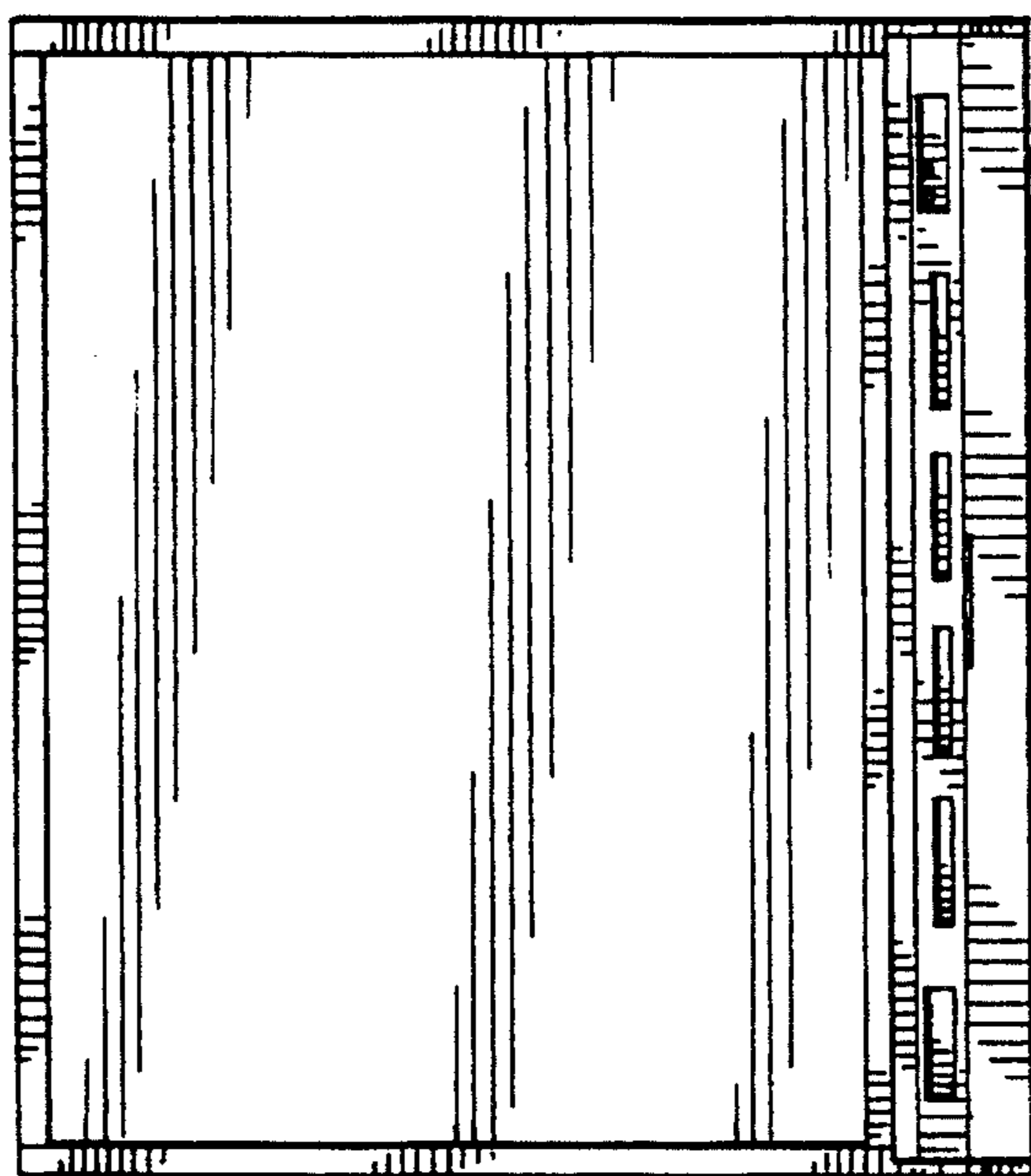

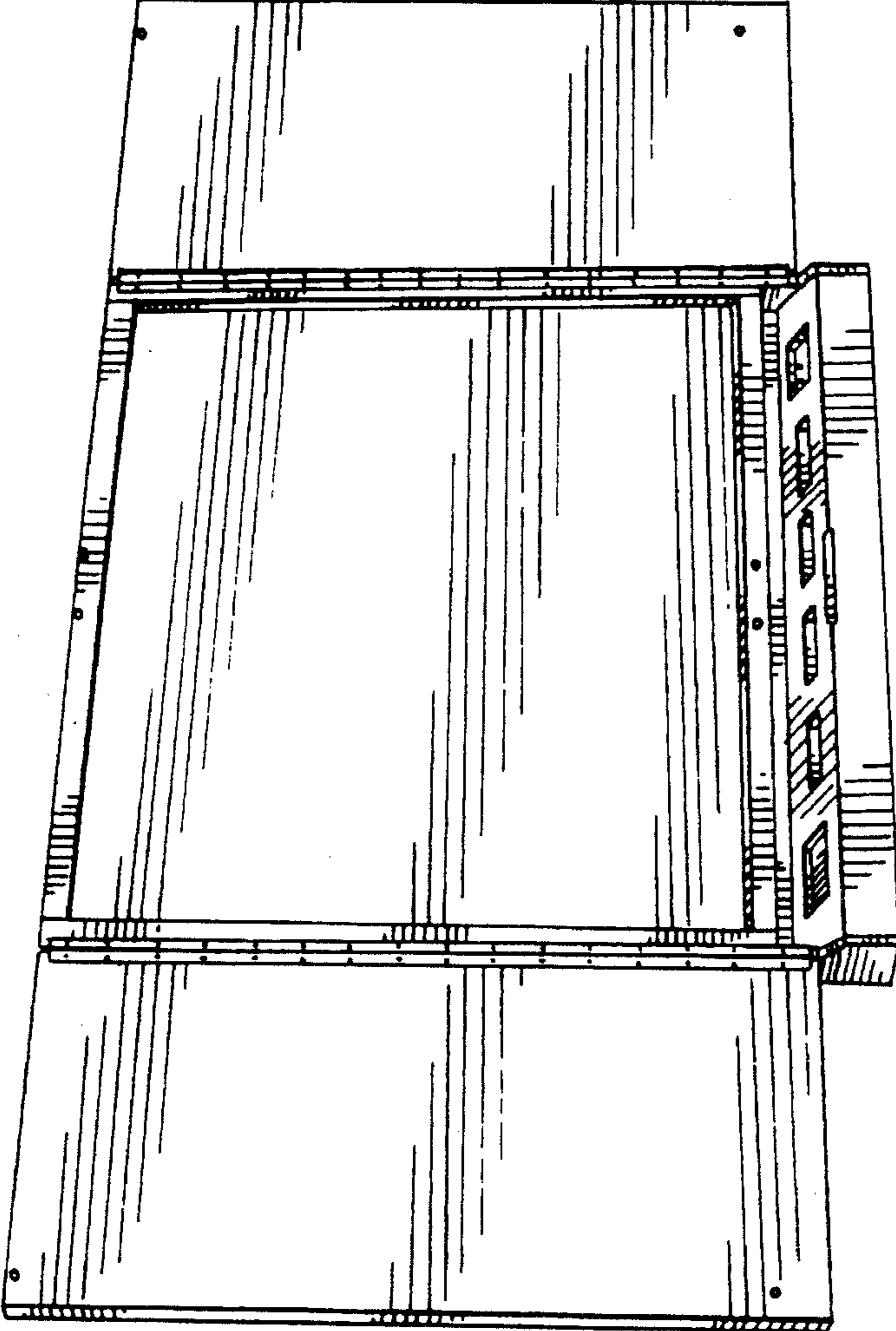

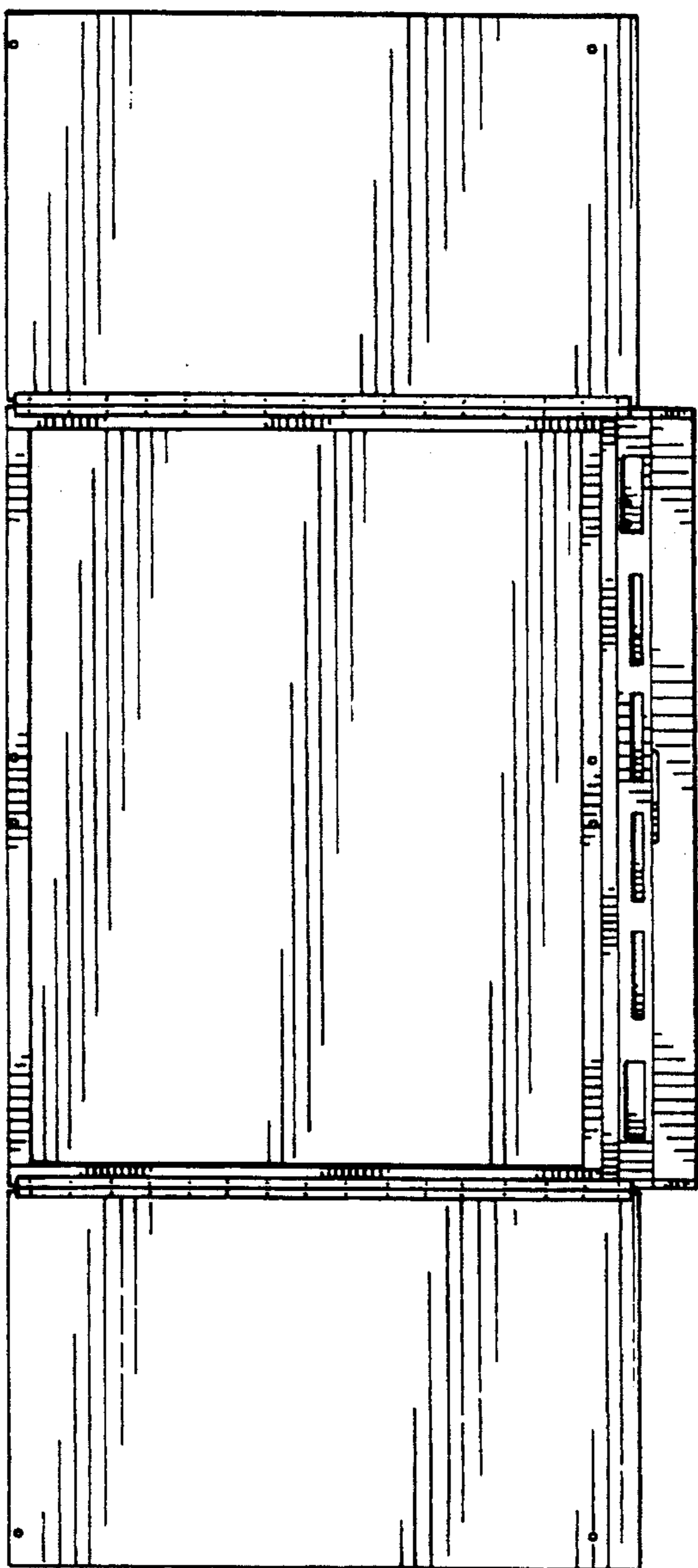

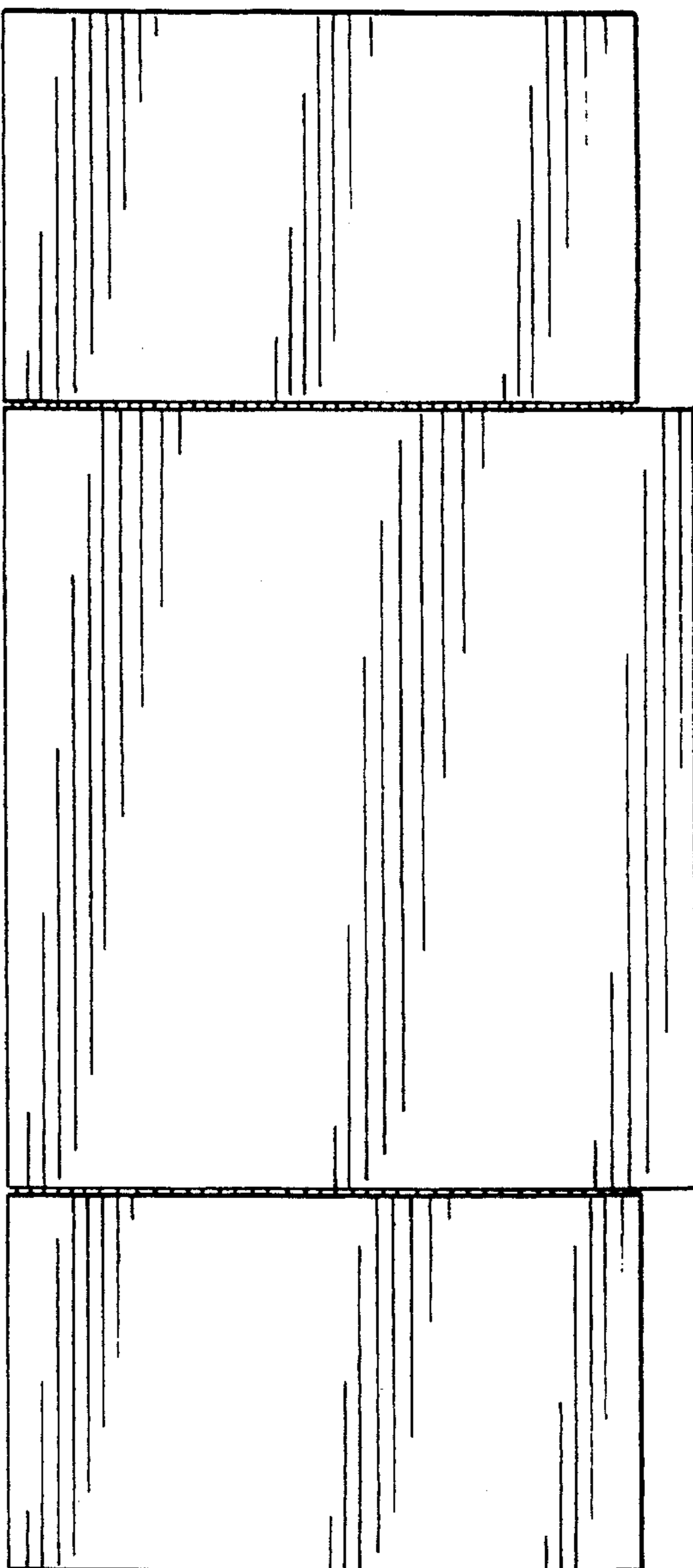

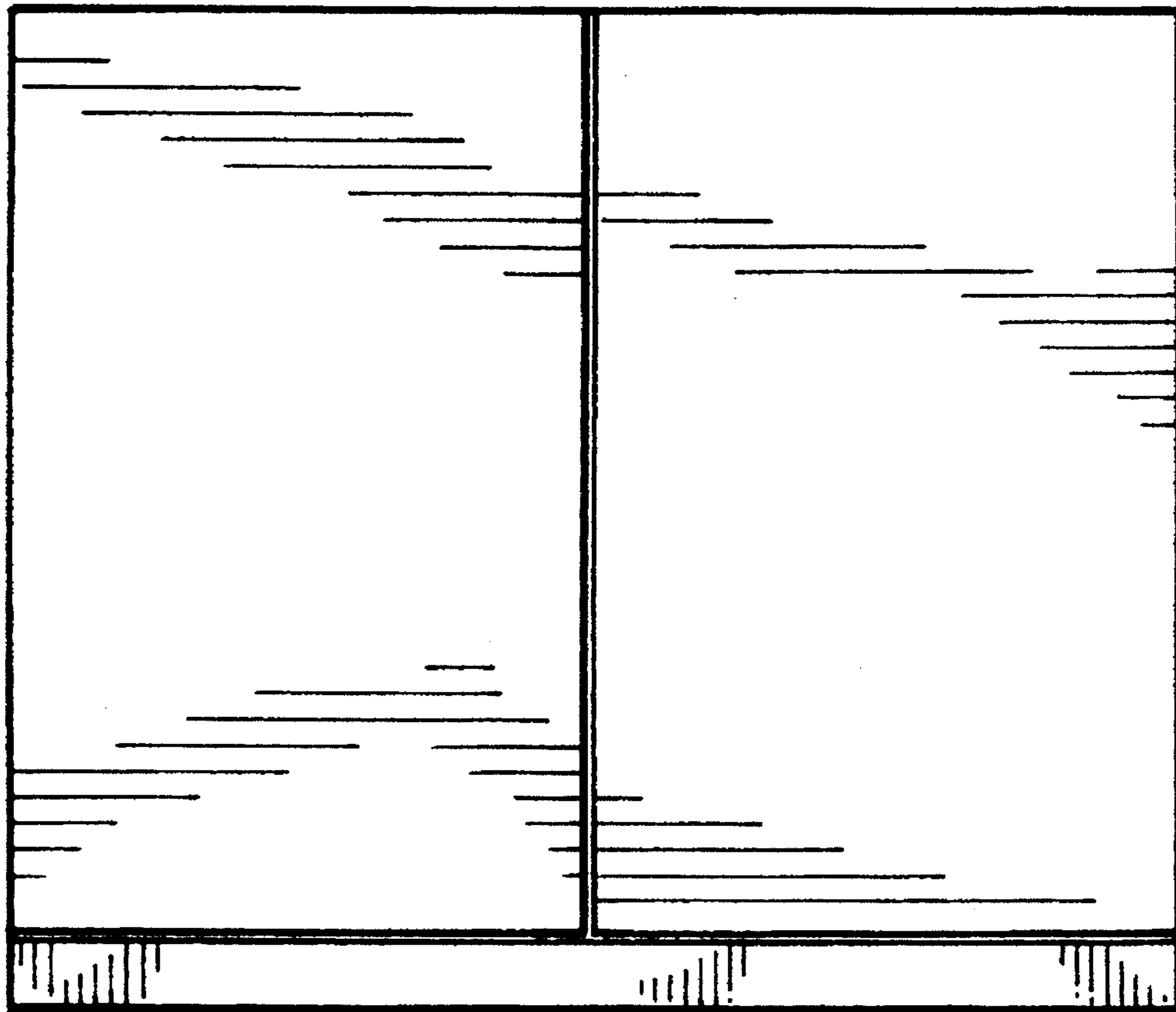
