The ornamental design for a winter golf spike with stud, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a winter golf spike with stud, showing our new design, the broken line showing of a shoe is for illustrative purposes only and forms no part of the claimed design;

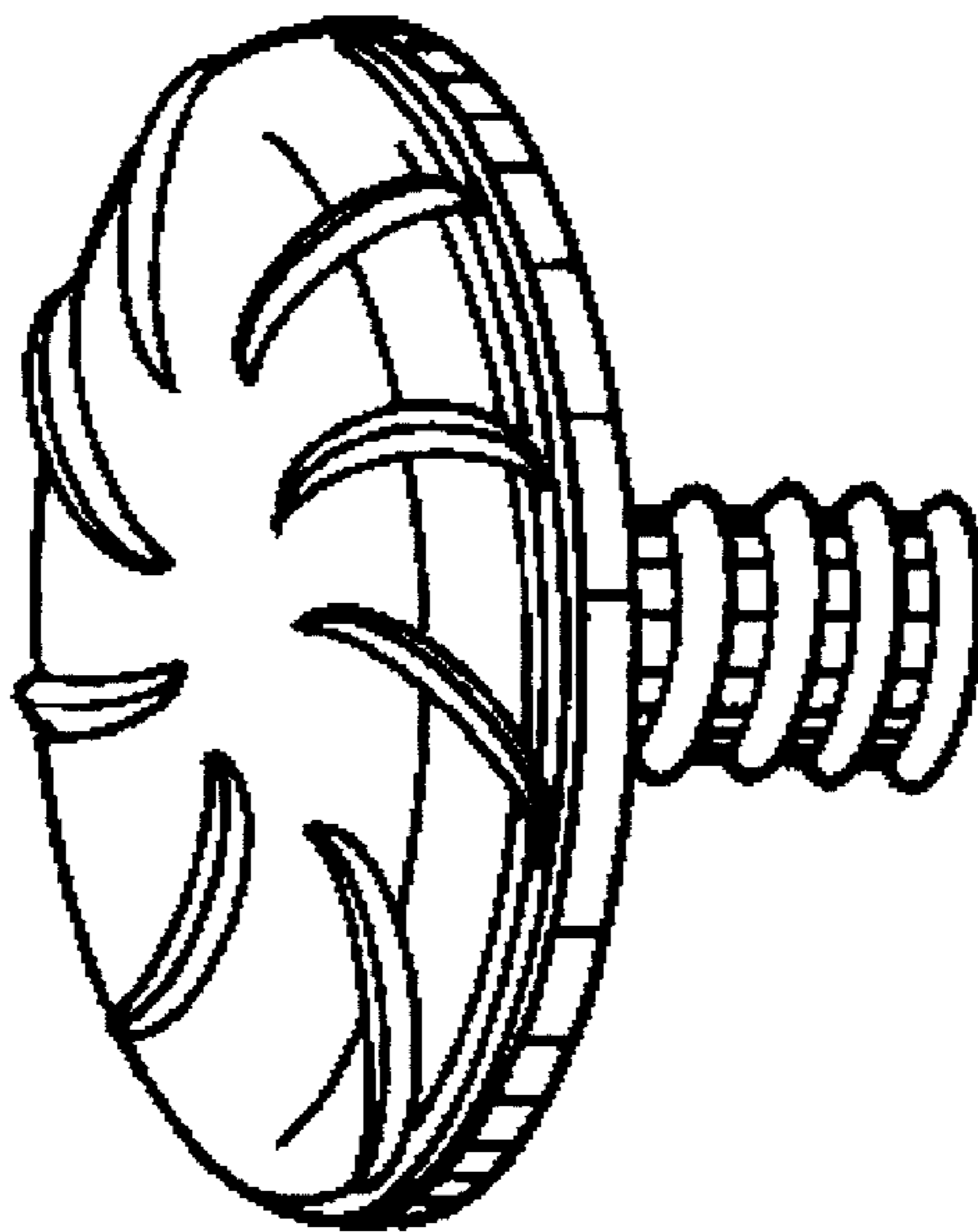
FIG. 2 is a bottom perspective view thereof;

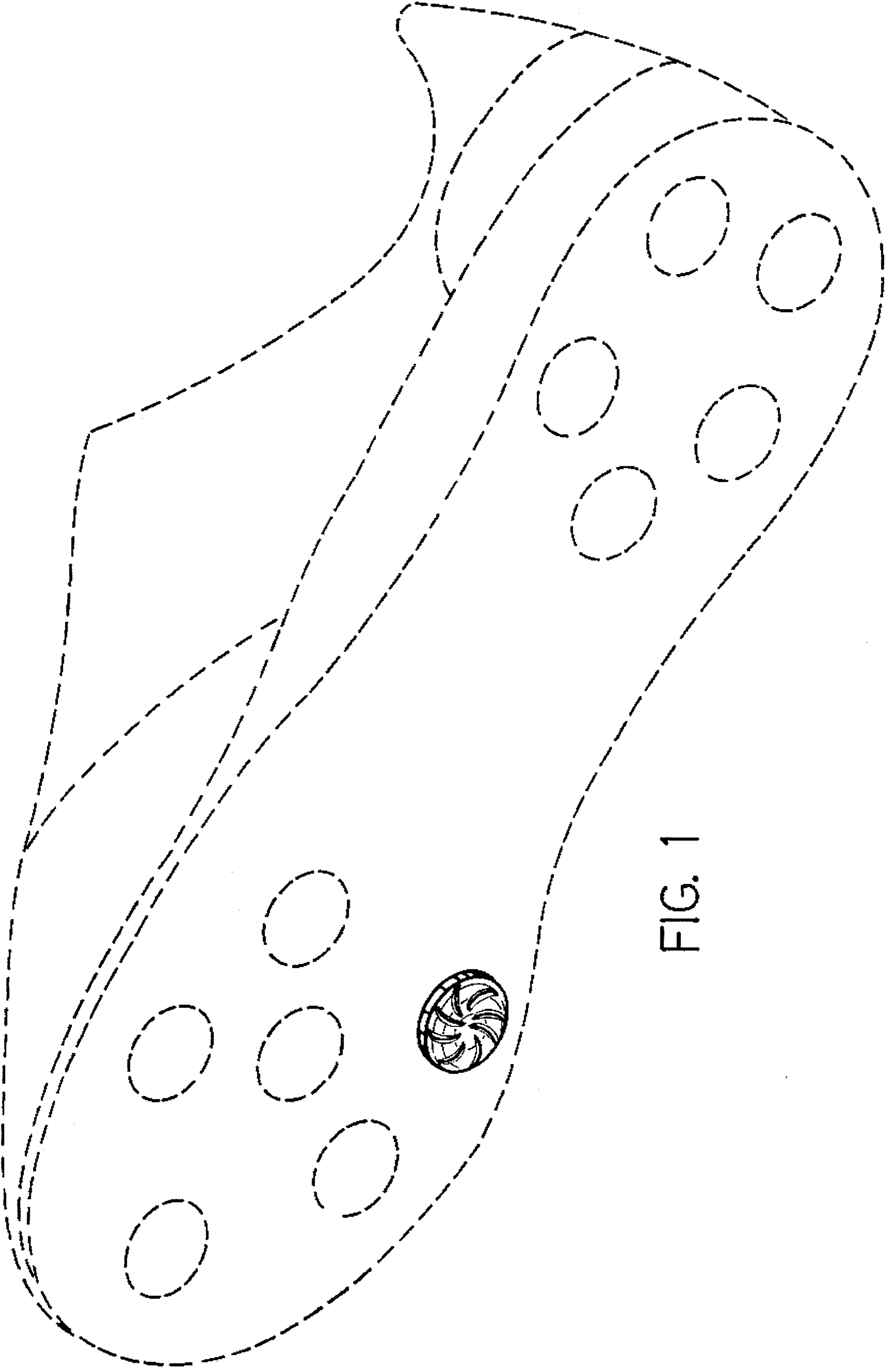

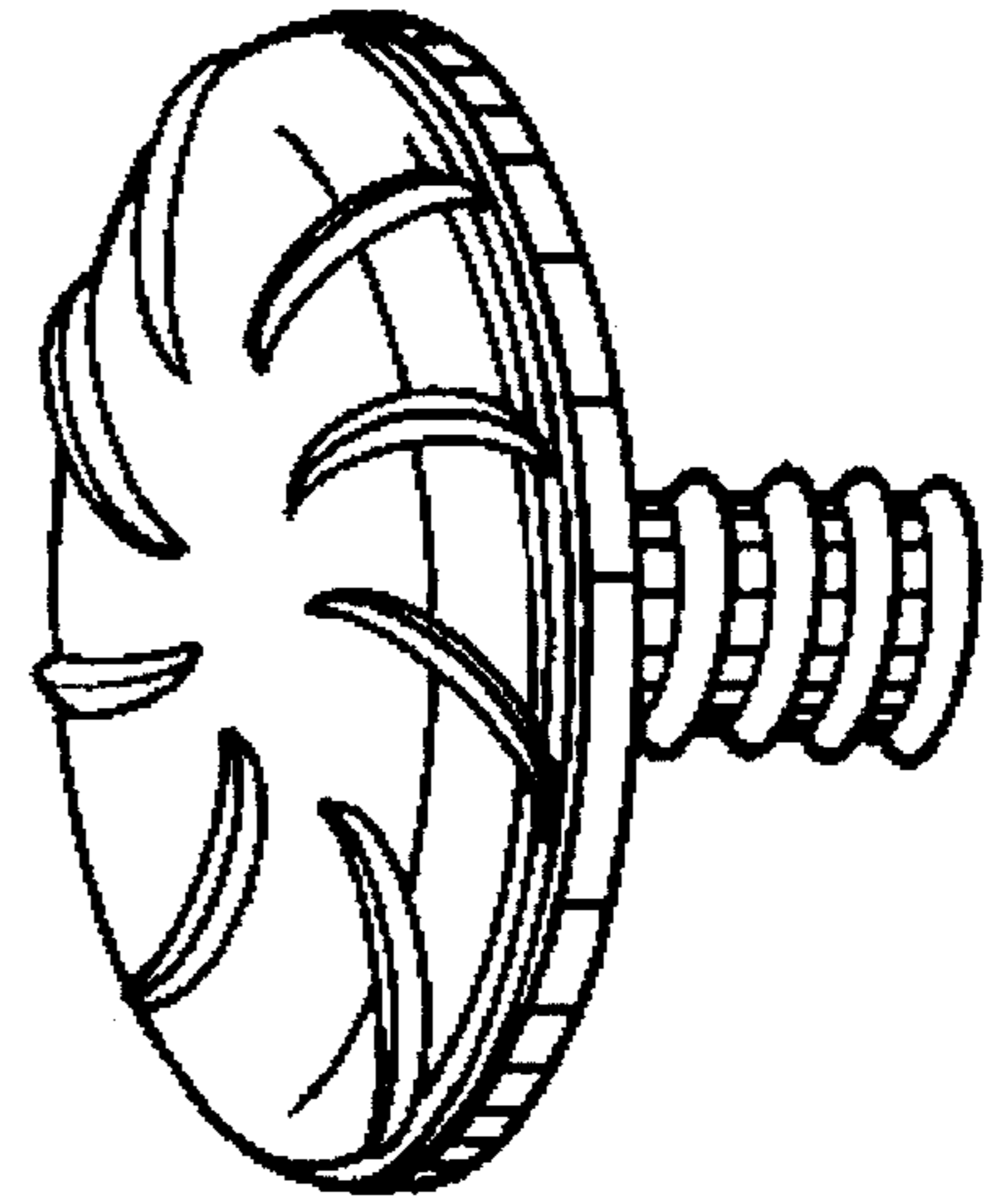

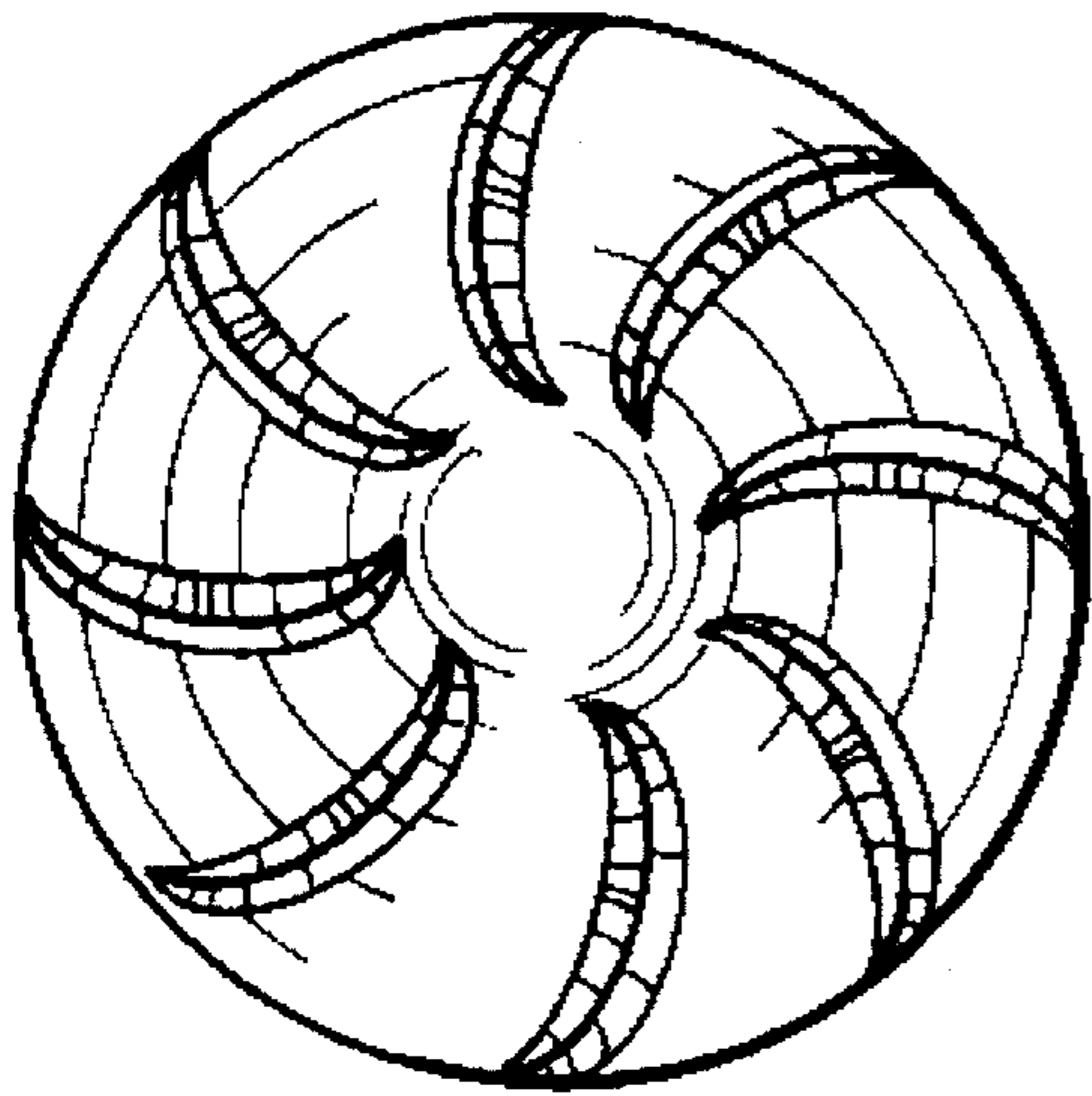

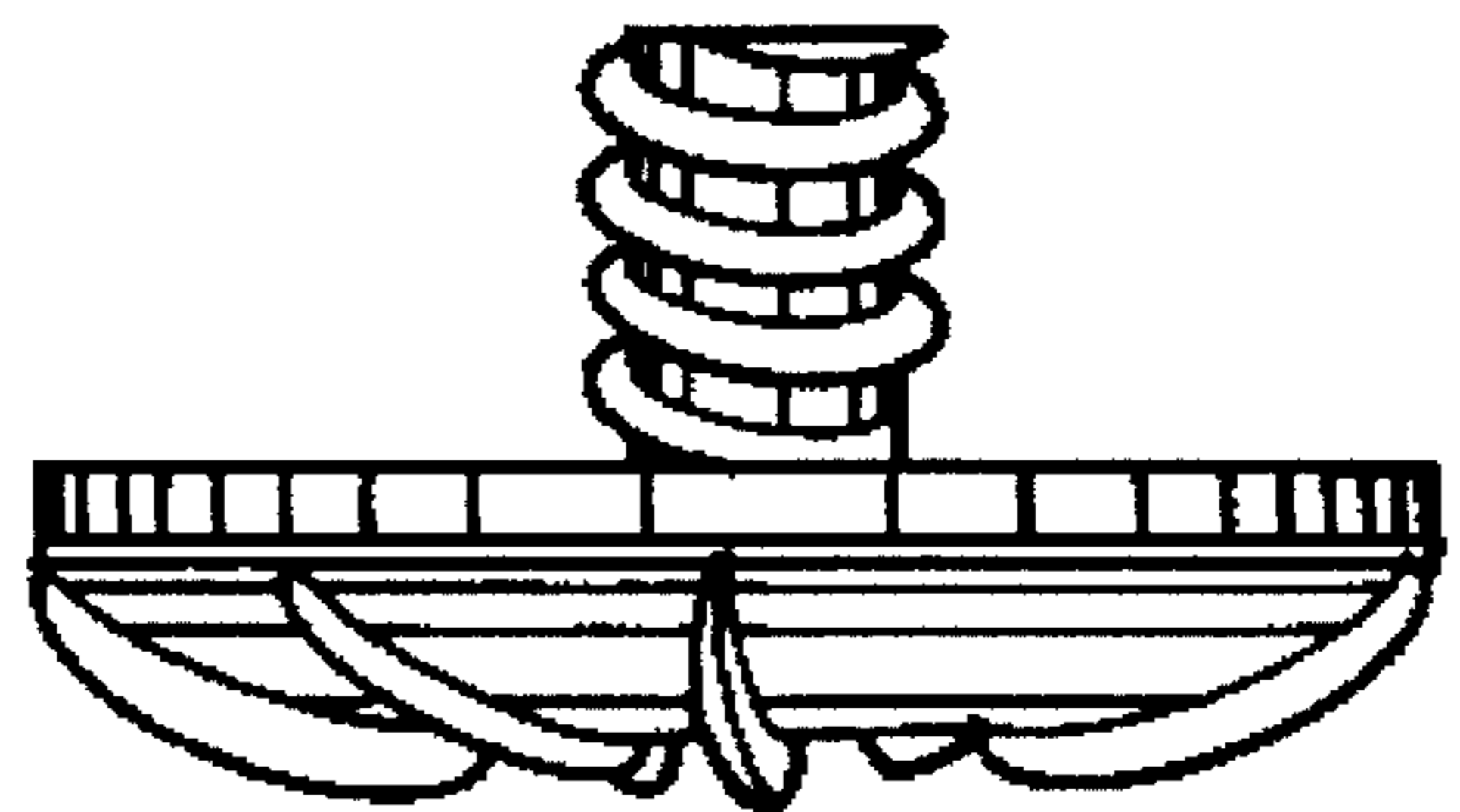

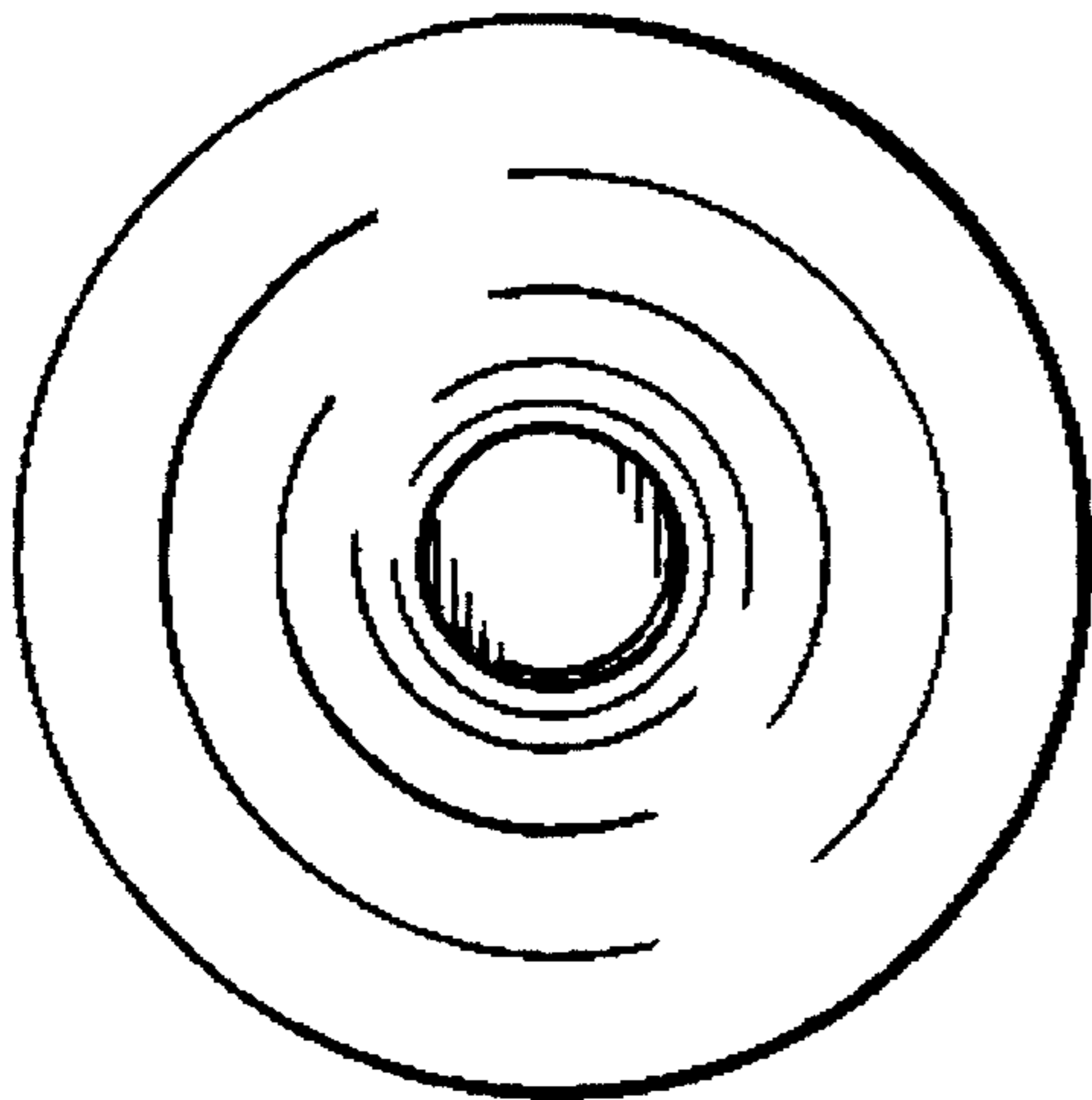
