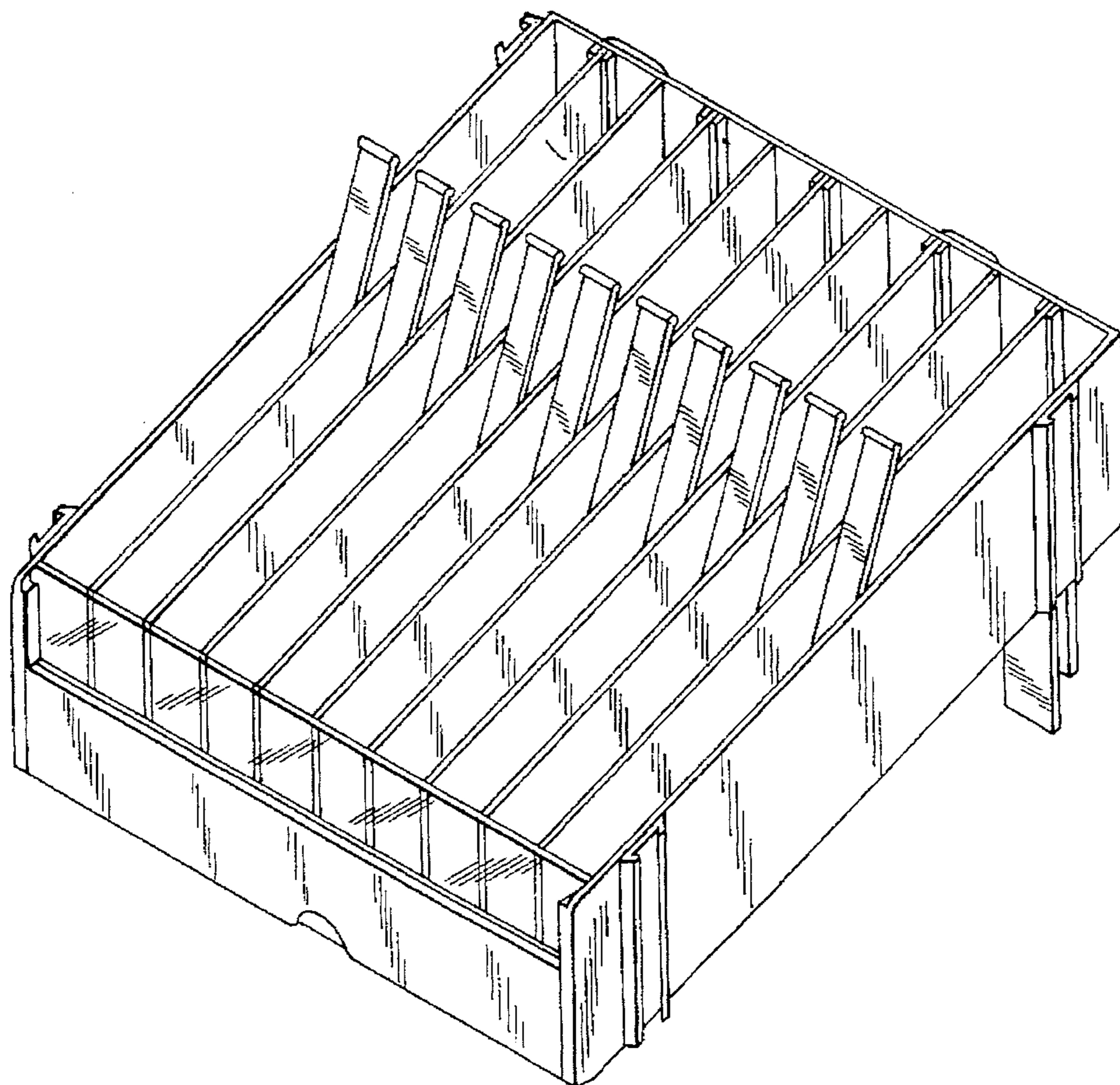
FIG. 1 is a side elevational view of a display rack showing our new design;

FIG. 8 is a perspective view thereof.

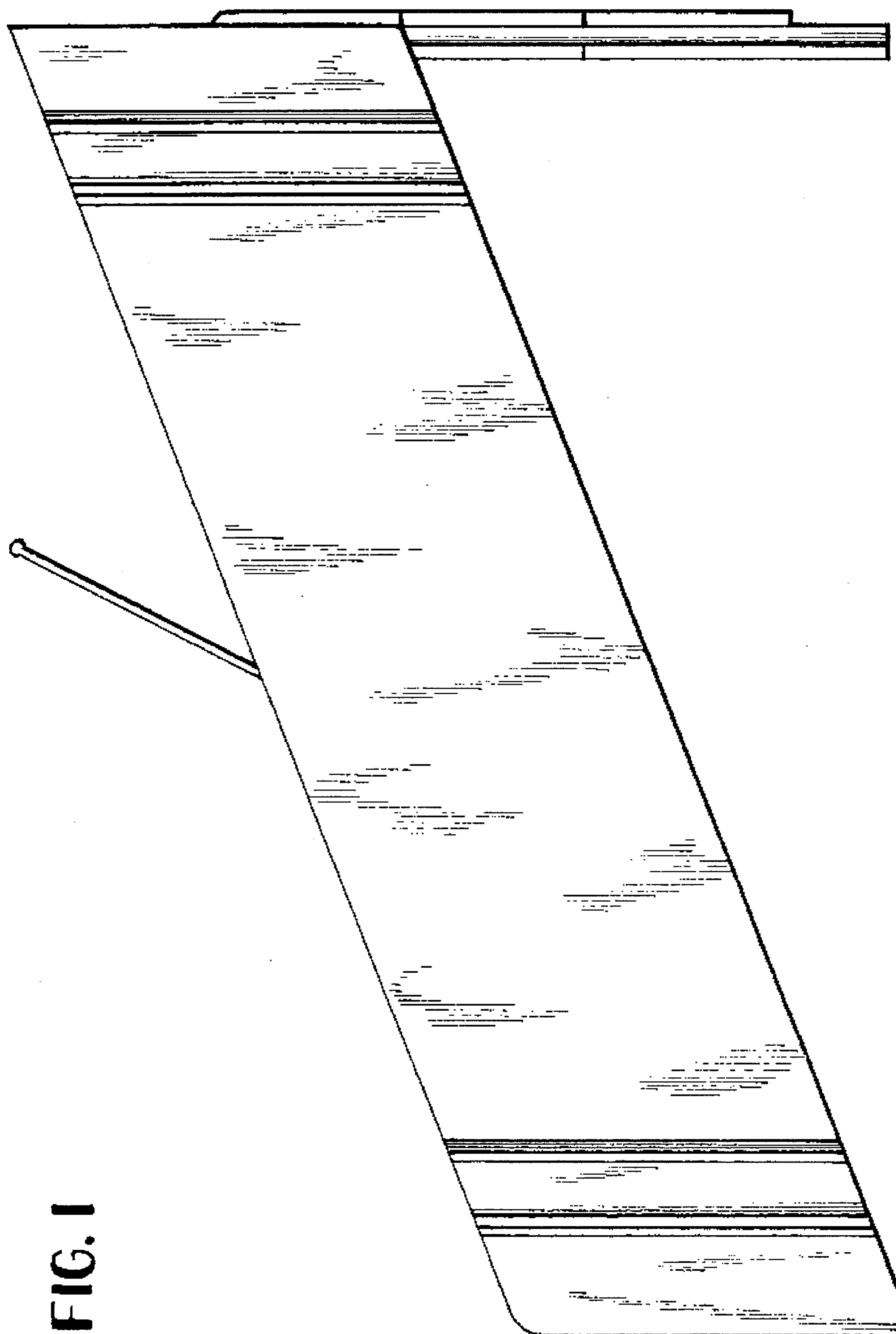

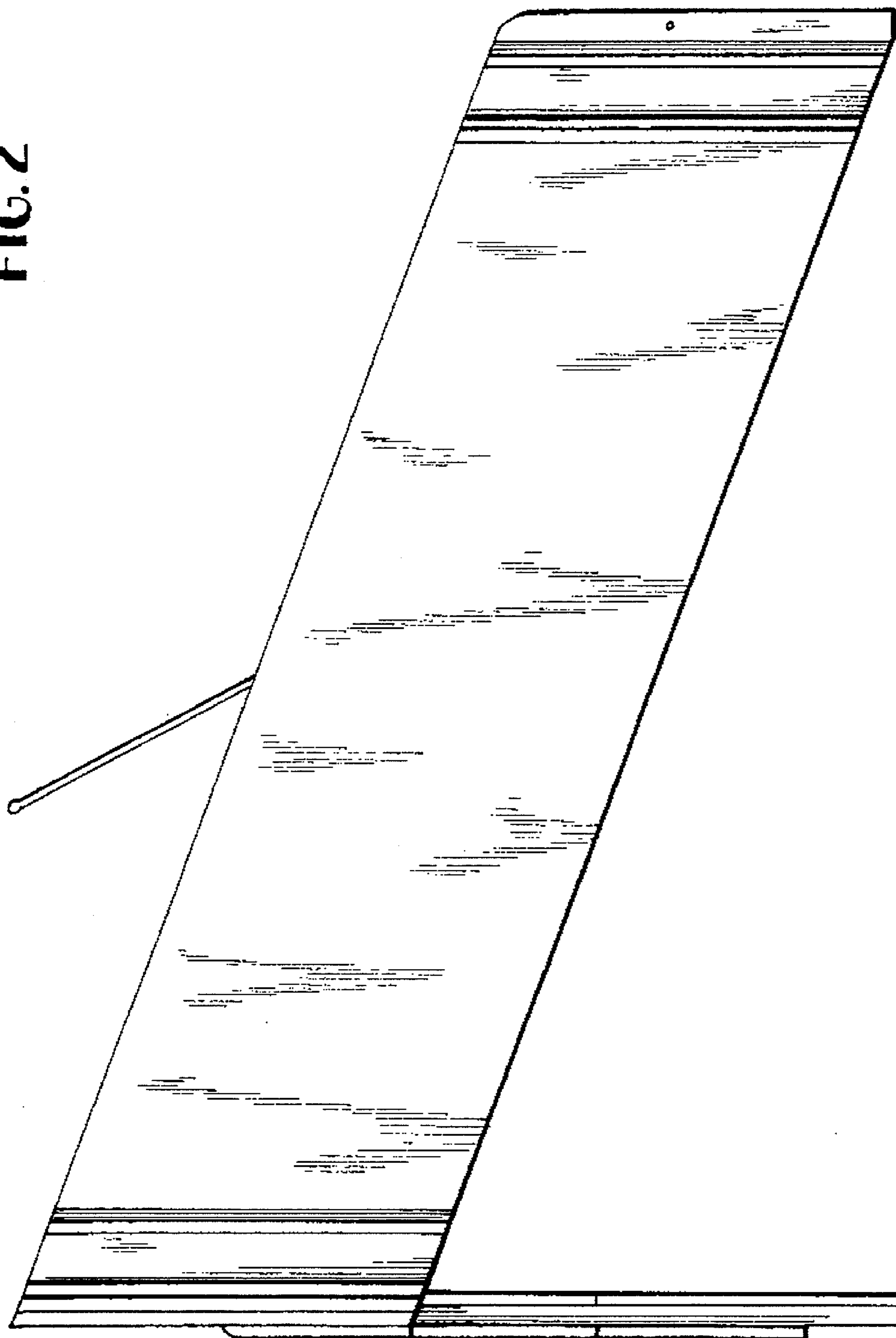

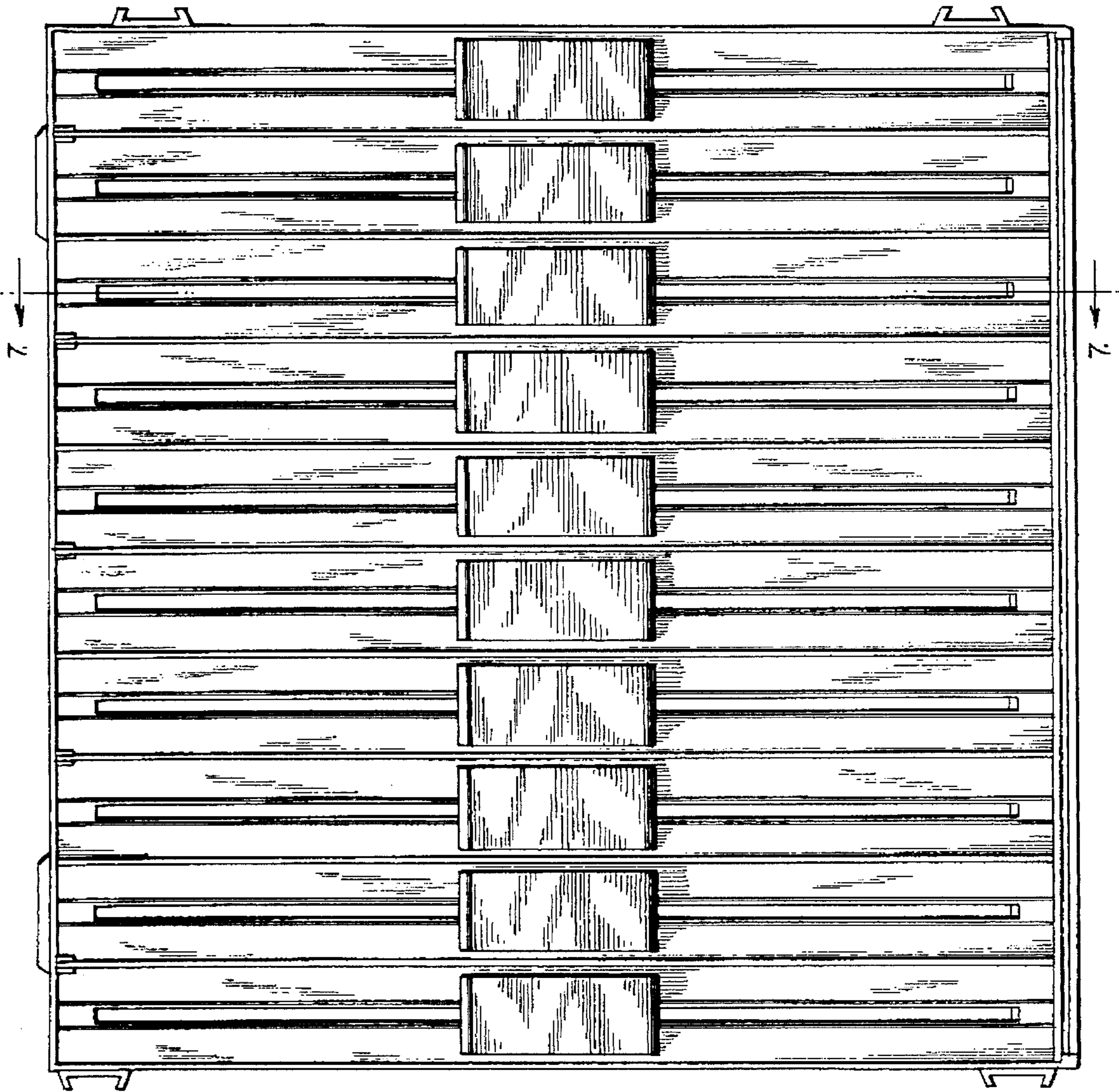

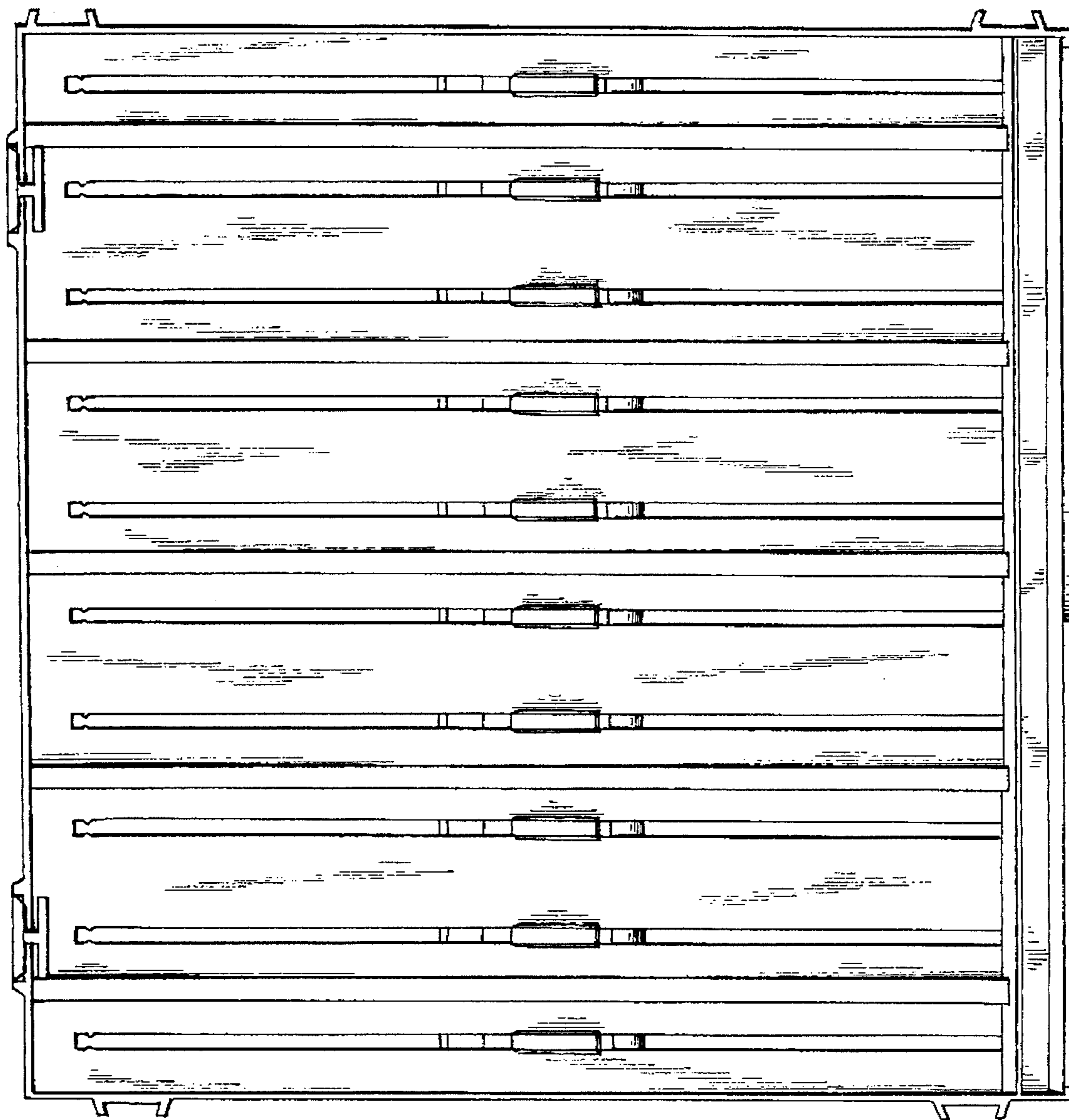

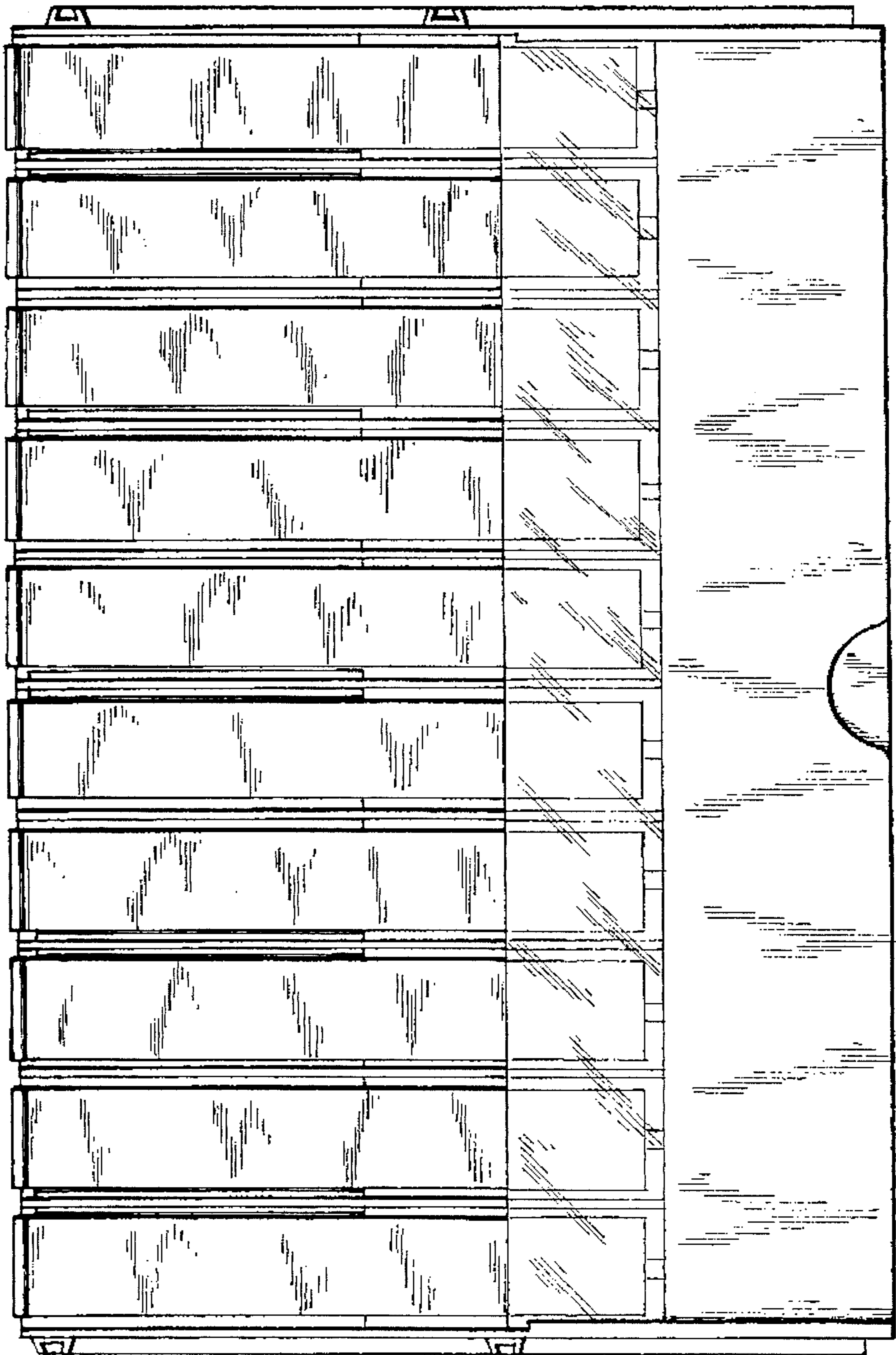
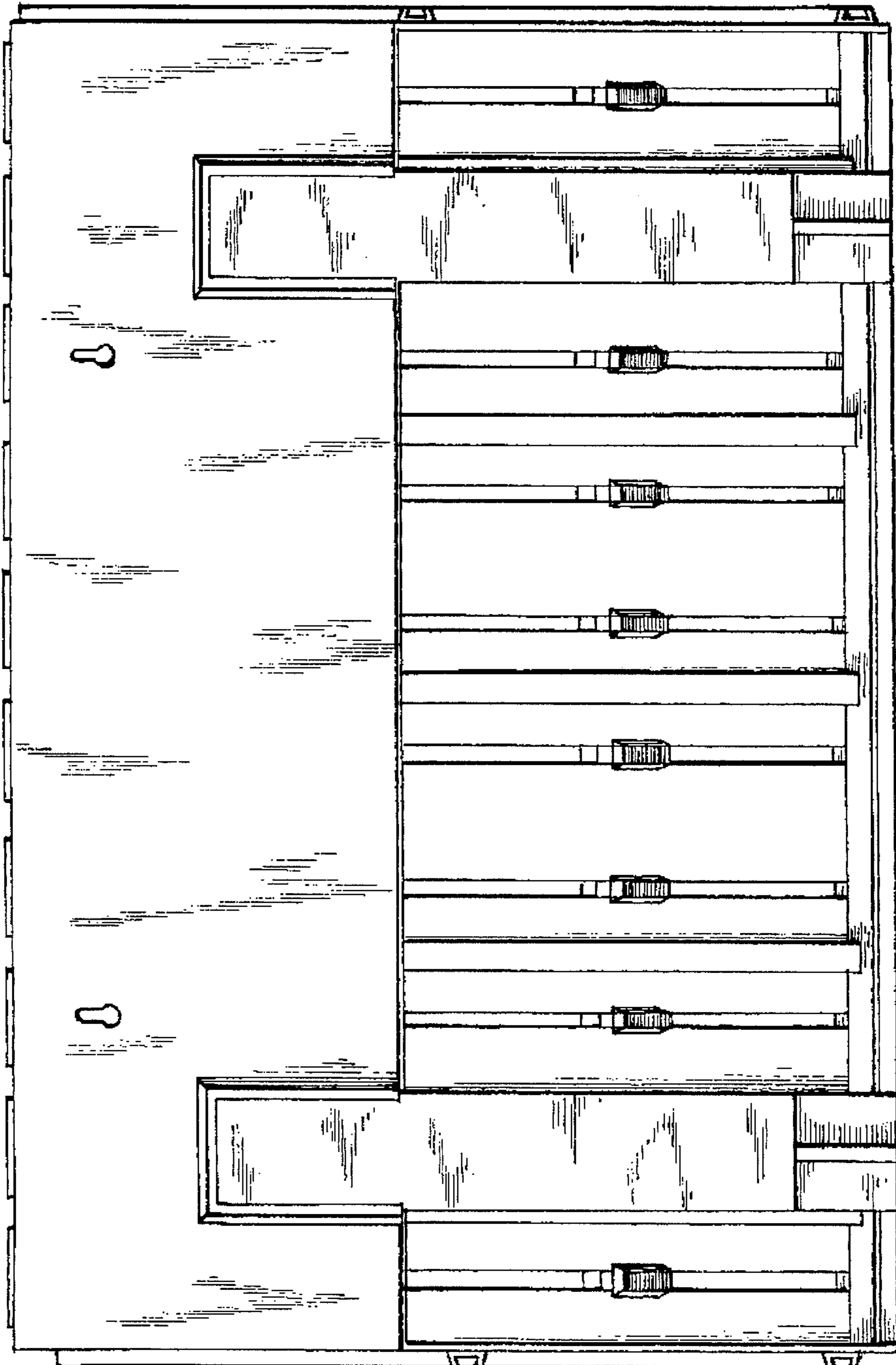

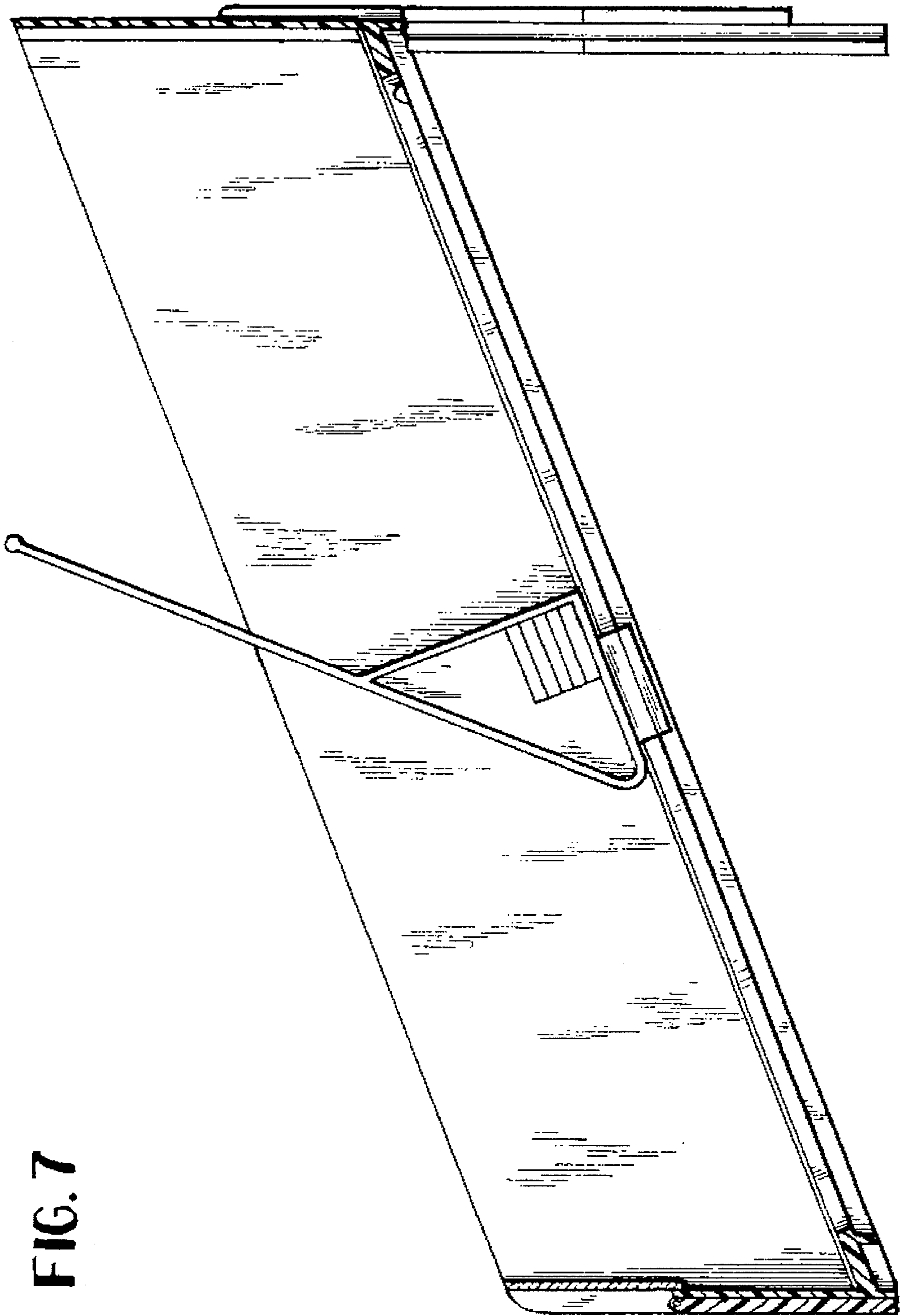

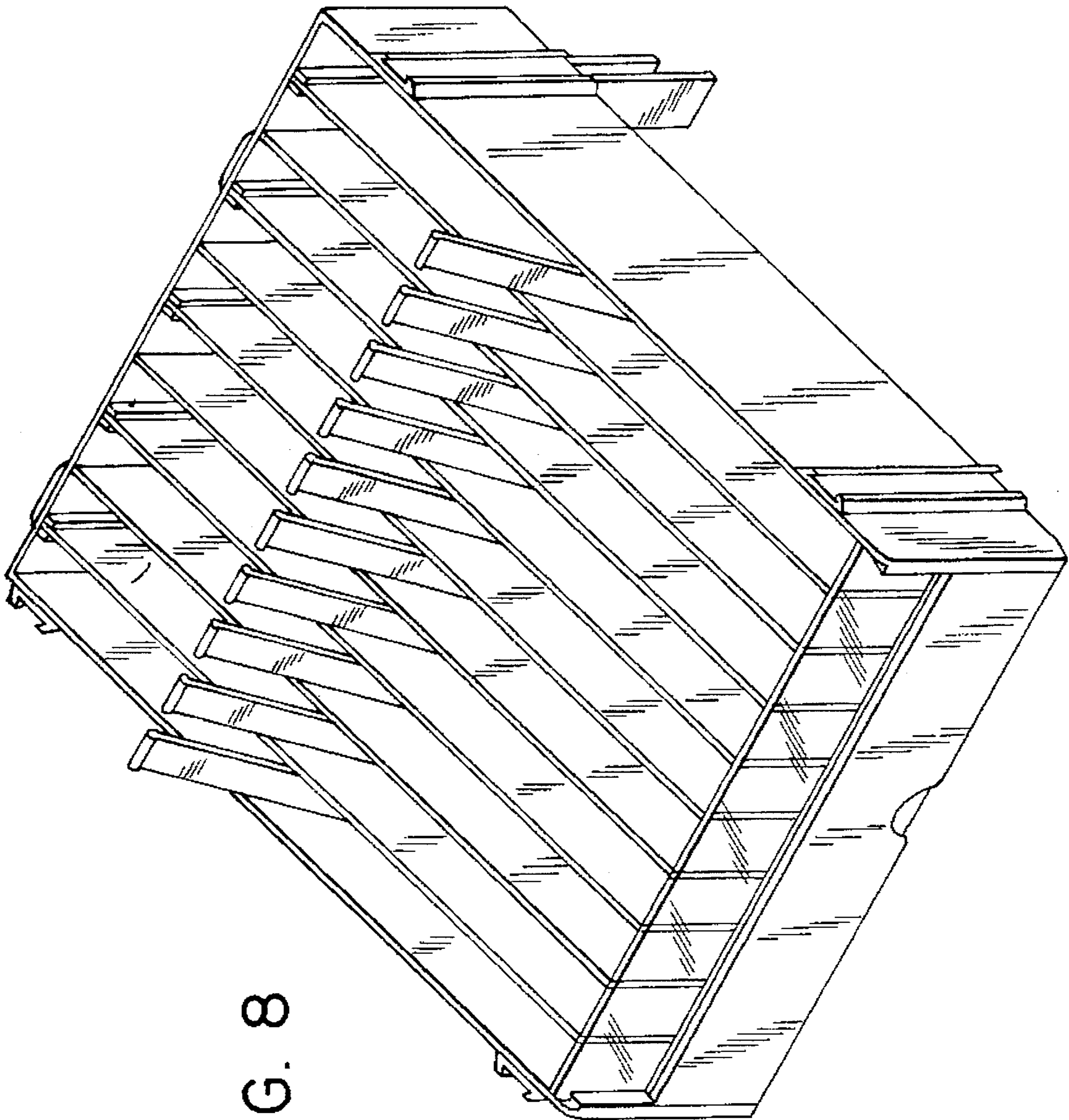
