[57] **CLAIM**

The ornamental design for a table, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the table of the present invention having a table top comprising a transparent material;

FIG. 2 is a front elevational view of table of FIG. 1, which also illustrates the identical rear elevational view of the looped-leg elongated table of FIG. 1;

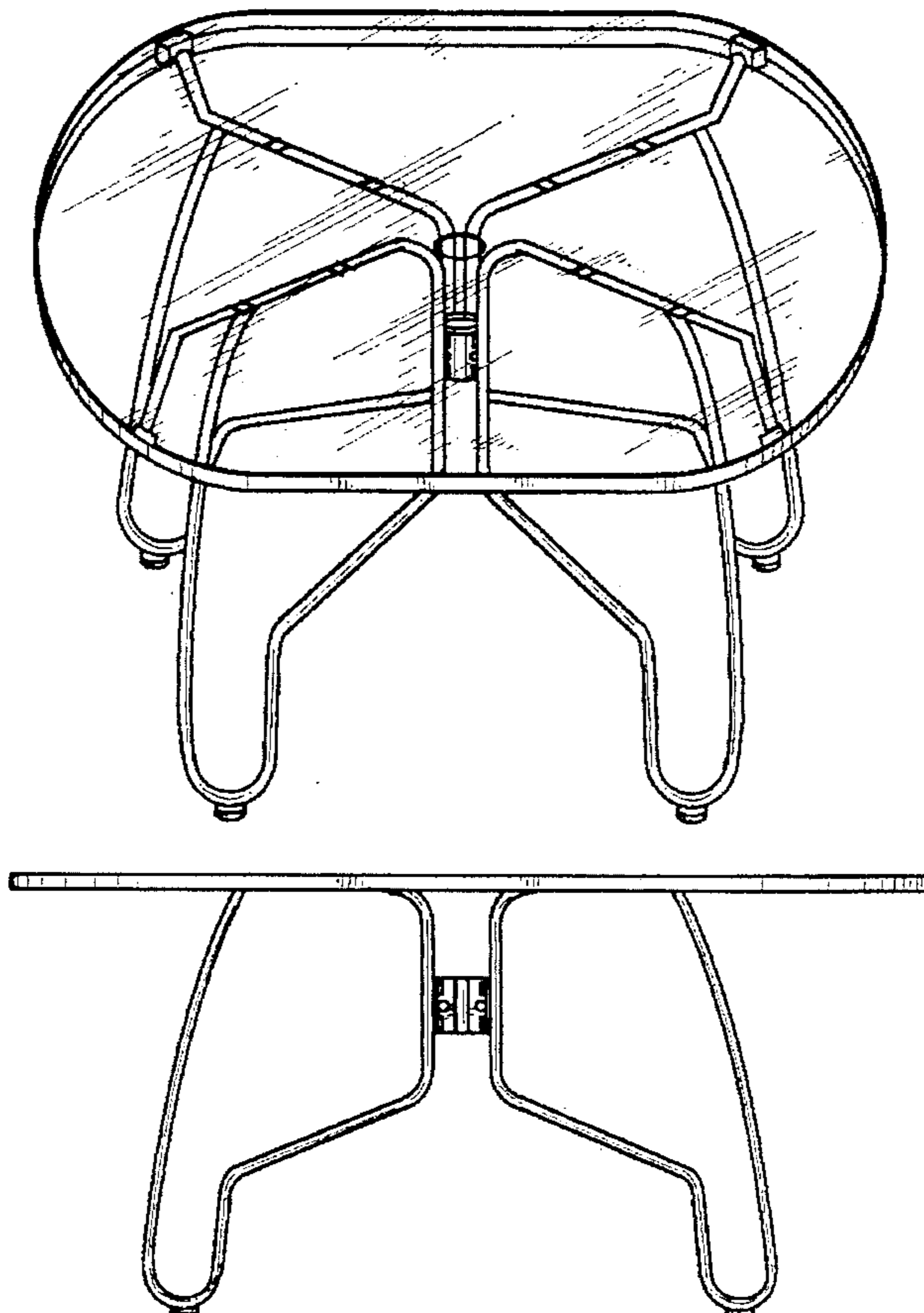
FIG. 3 is a top plan view of the table of FIG. 1;

FIG. 4 is a bottom plan view of the table of FIG. 1;

FIG. 5 is a left side elevational view of the table of FIG. 1 which also illustrates the identical right side elevational view of the looped-leg elongated table of FIG. 1; and,

FIG. 6 is a front perspective view of the table of the present invention having a table top comprising an opaque material. The characteristic feature of the design resides in the particular configuration of the tubular leg members as best shown in FIG. 2.

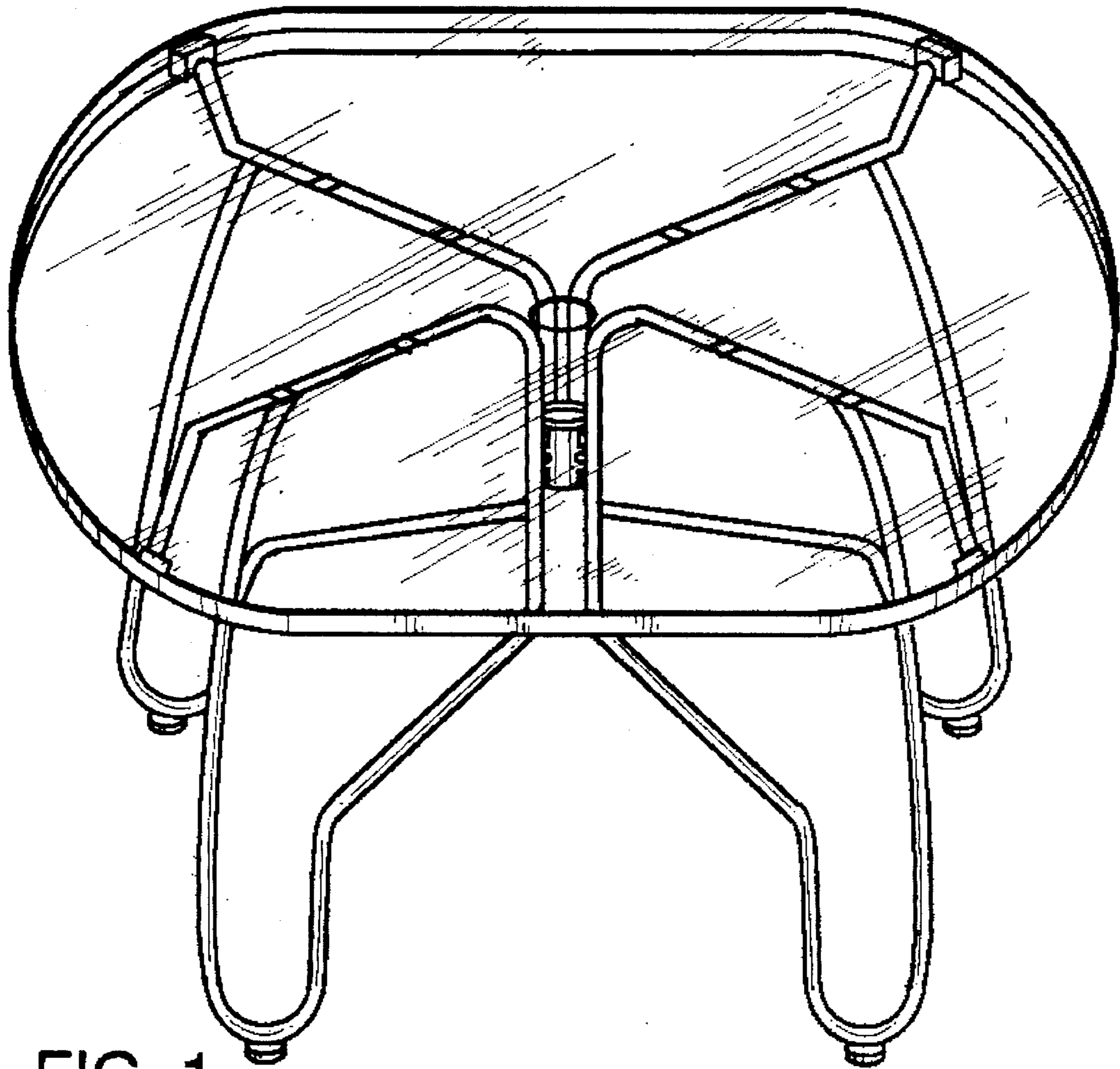

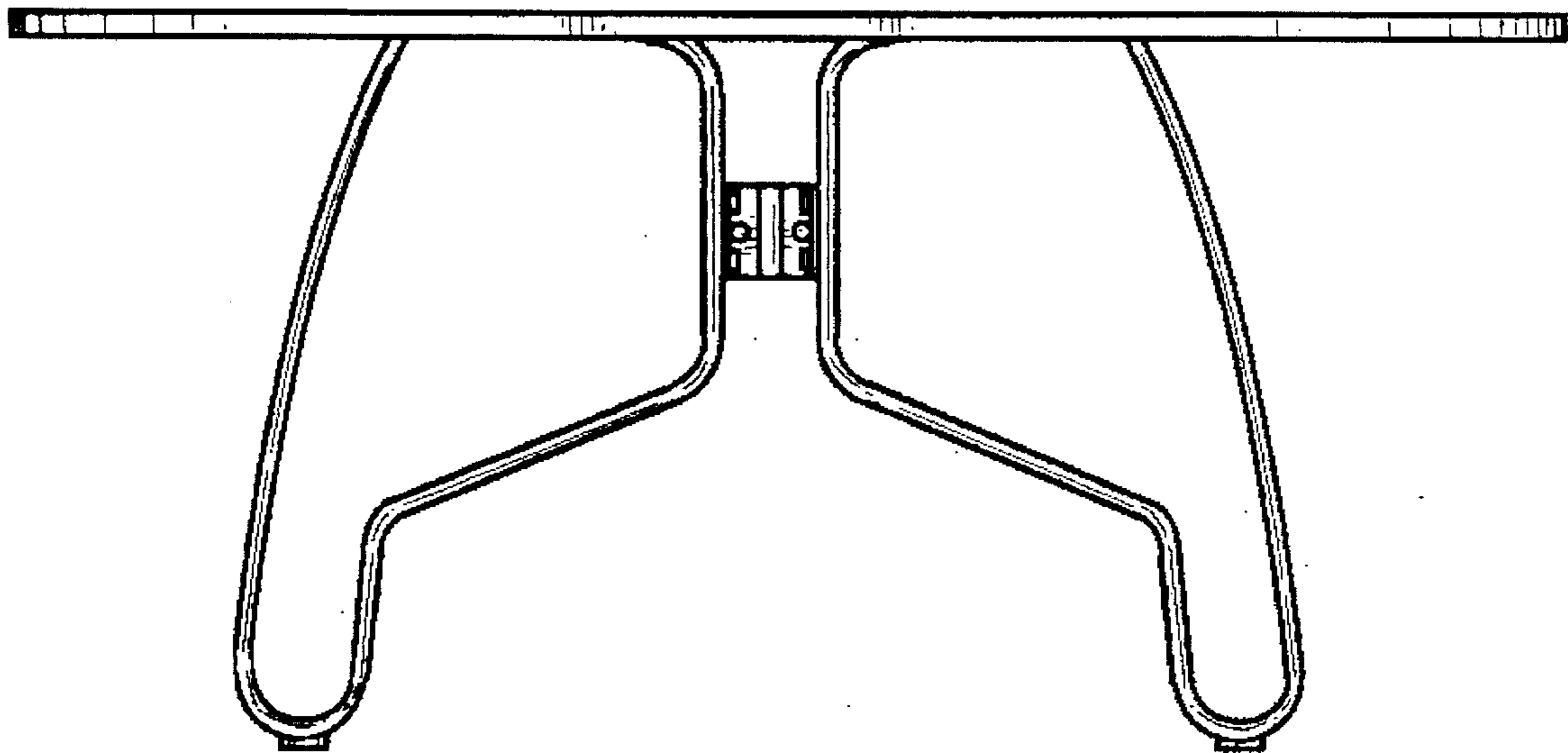

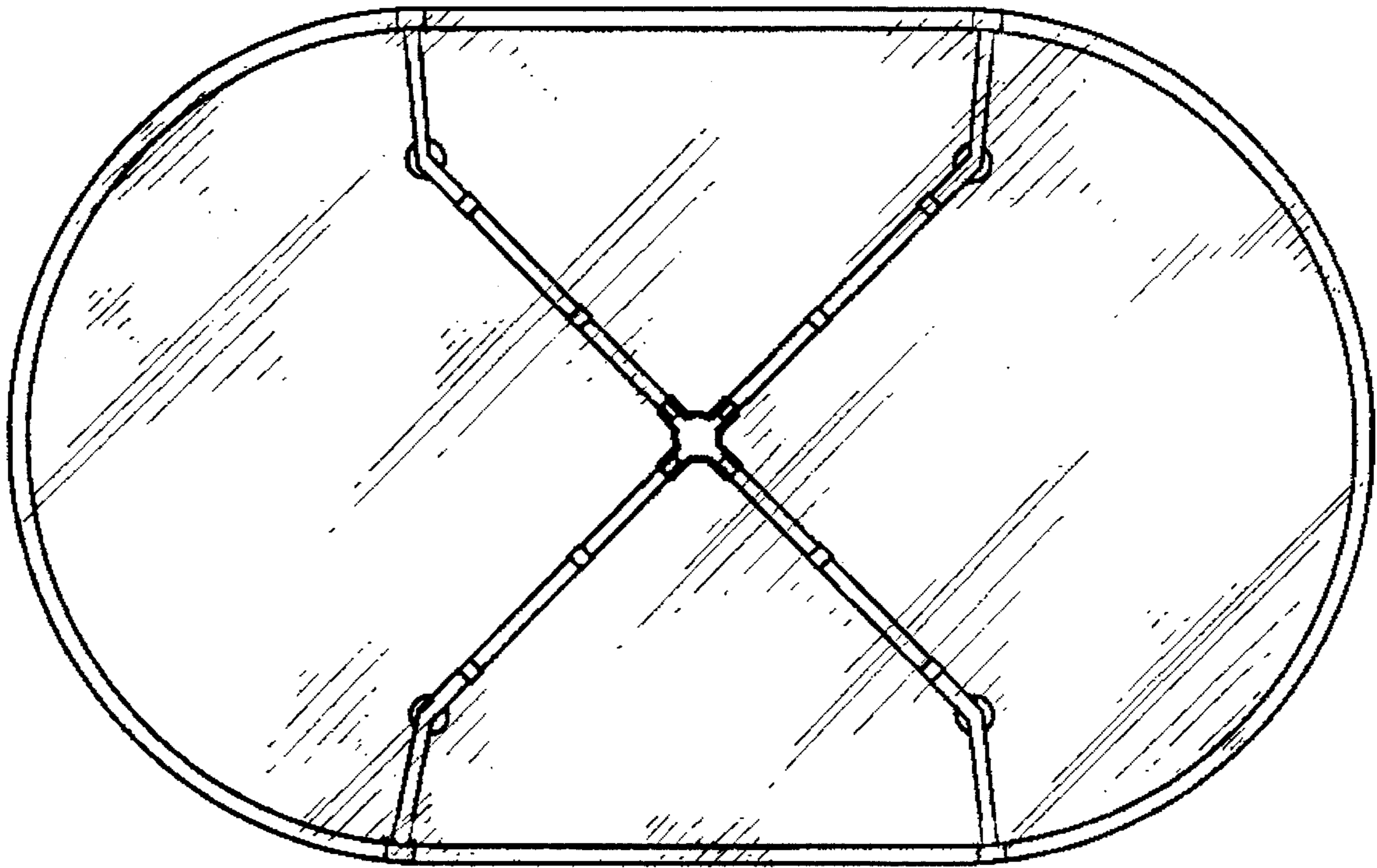

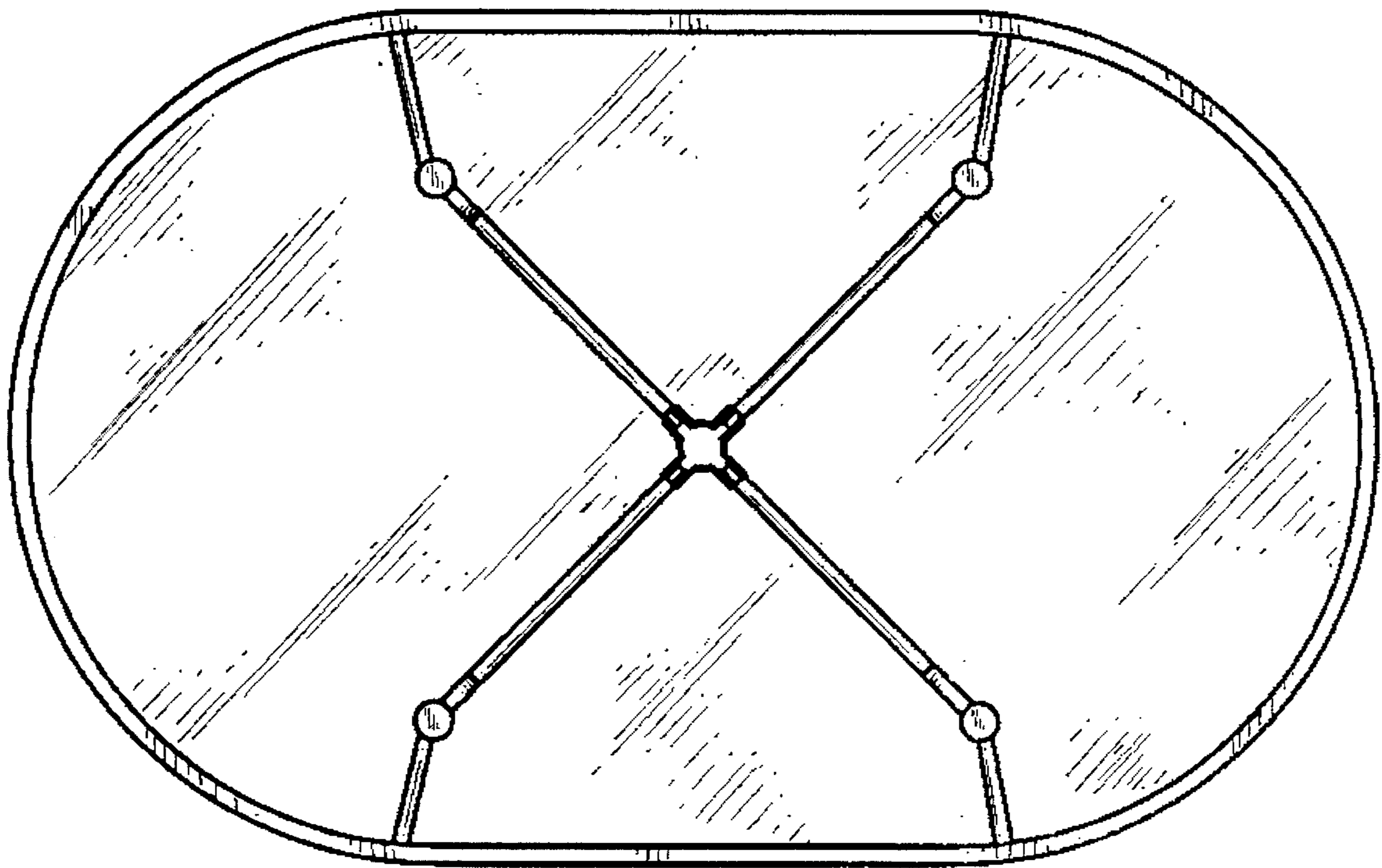

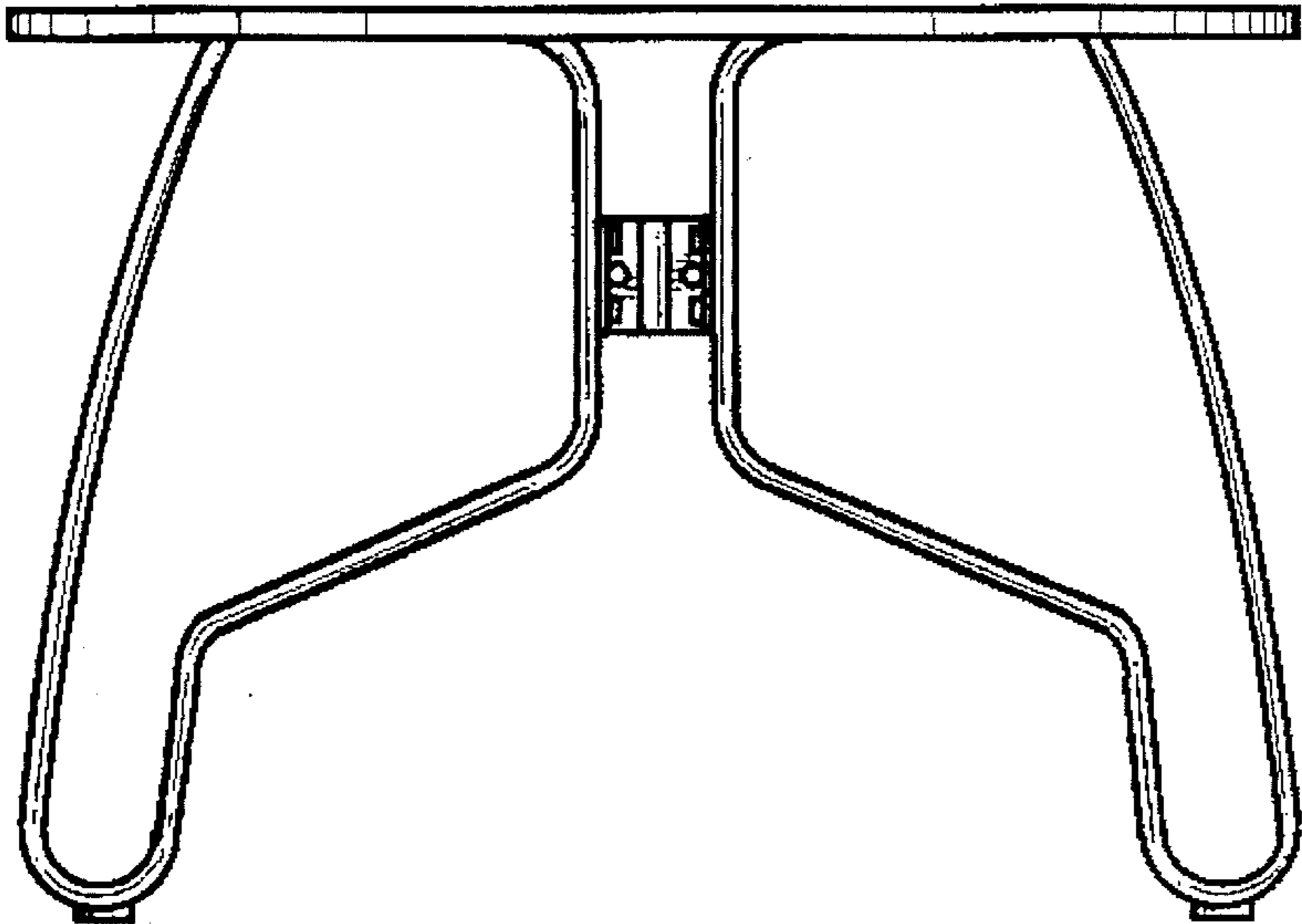

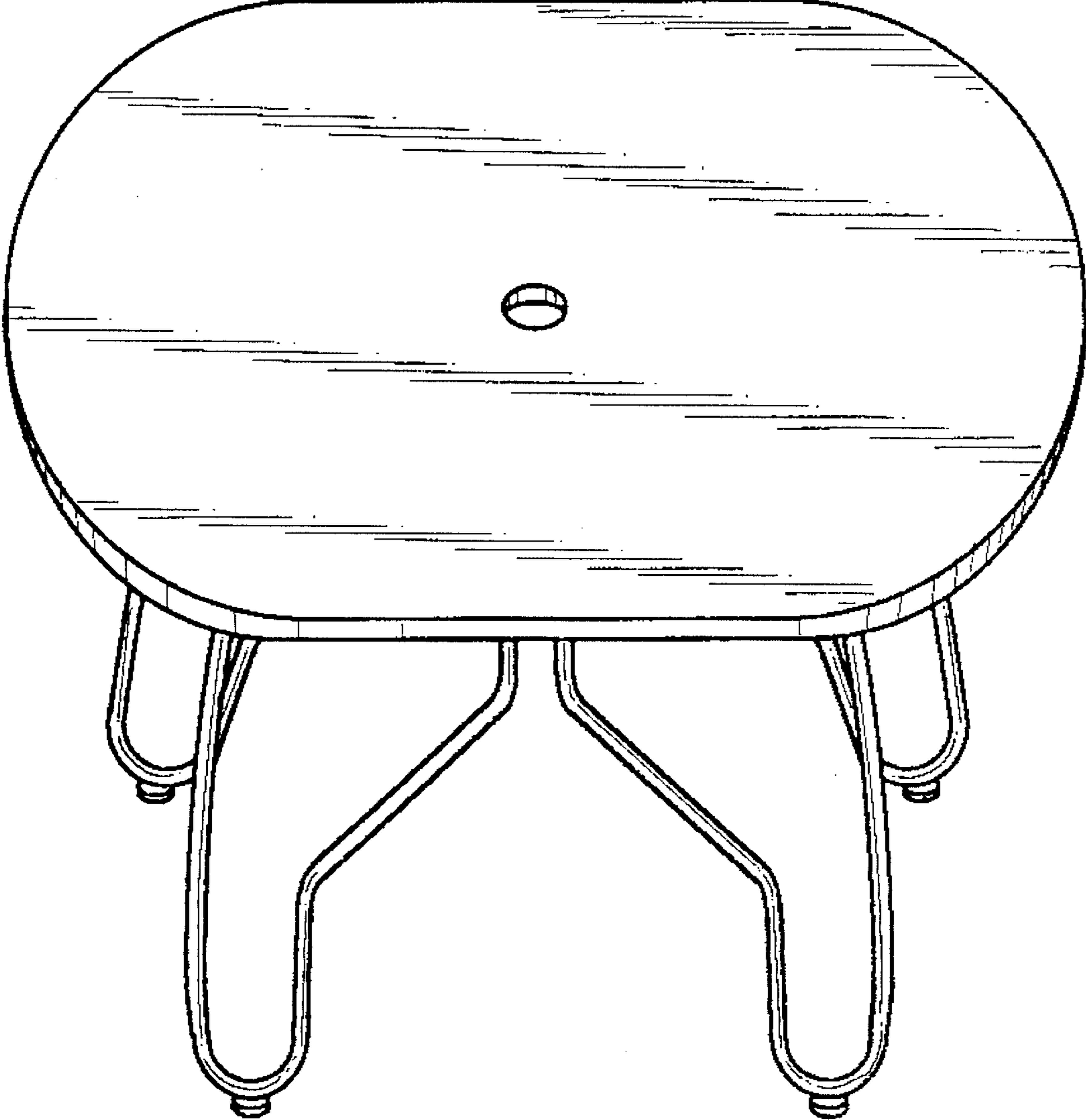
