[57] **CLAIM**

The ornamental design for a screwdriver handle, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a screwdriver handle showing my new design, the three other sides being the same as the side shown;

FIG. 2 is a side elevational view of the screwdriver of FIG. 1, showing the opposite side thereof in an alternate position;

FIG. 3 is a top plan view of FIG. 2;

FIG. 4 is a left end elevational view of FIG. 1;

FIG. 5 is an enlarged sectional view along the plane 5—5 of FIG. 2 and showing the surface dimpling;

FIG. 6 is a sectional view taken along the plane designated 6—6 on FIG. 1;

FIG. 7 is a sectional view taken along the plane designated 7—7 on FIG. 1;

FIG. 8 is a sectional view taken along the plane designated 8—8 on FIG. 1;

FIG. 9 is a sectional view taken along the plane designated 9—9 on FIG. 1; and,

FIG. 10 is a sectional view taken along the plane designated 10—10 on FIG. 1.

The broken line showing of the shaft in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.
