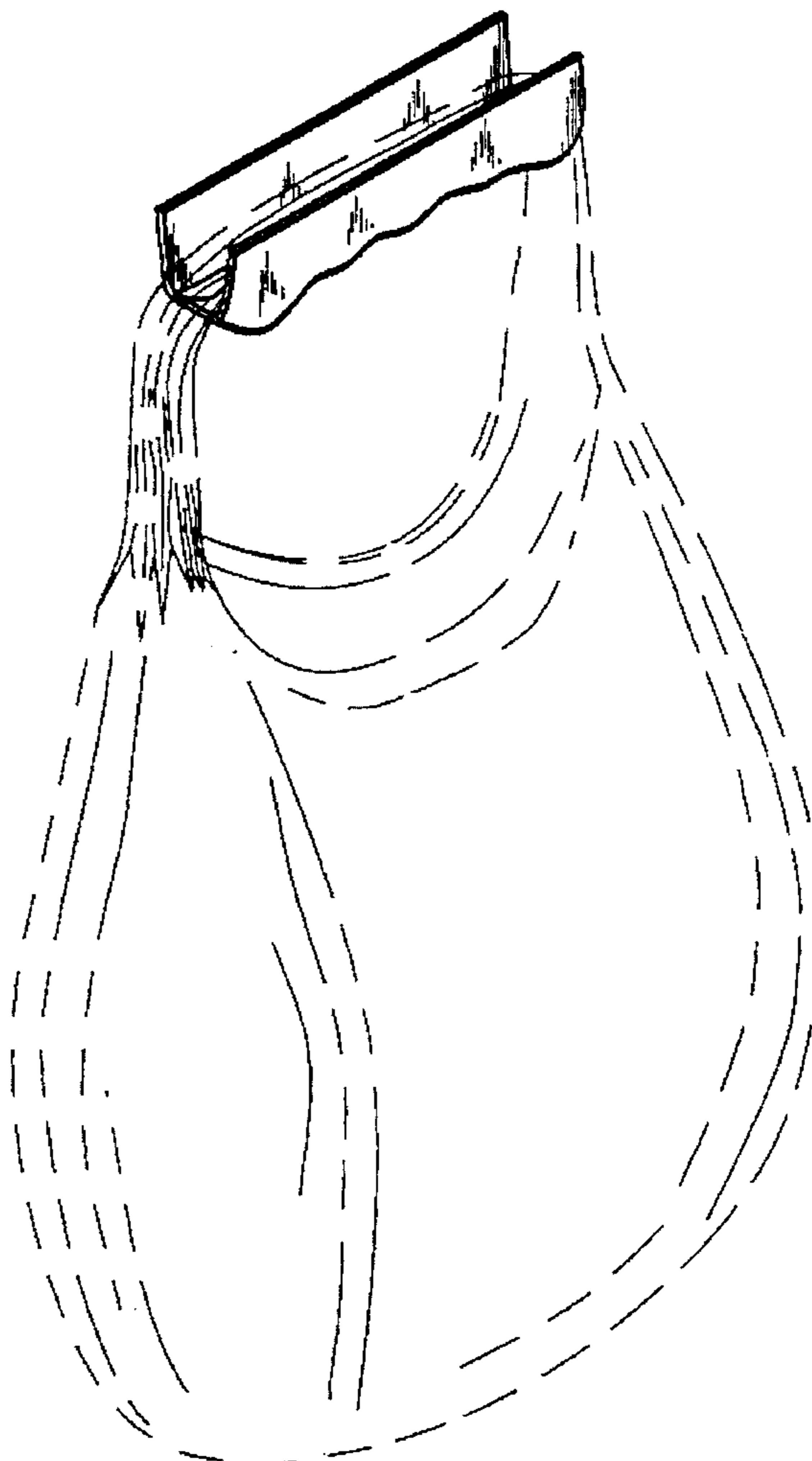
[57] **CLAIM**

The ornamental design for a shopping bag handle, as described and shown.

**DESCRIPTION**

FIG. 1 is a perspective view of my shopping bag handle with a shopping bag shown in dotted line for illustrative purposes only and forming no part of the claimed design; FIG. 2 is a front view thereof, with the back view being a mirror image thereof; FIG. 3 is a top view thereof; FIG. 4 is a right side elevational view thereof with the left side elevational view being a mirror image thereof; and, FIG. 5 is a bottom view thereof.

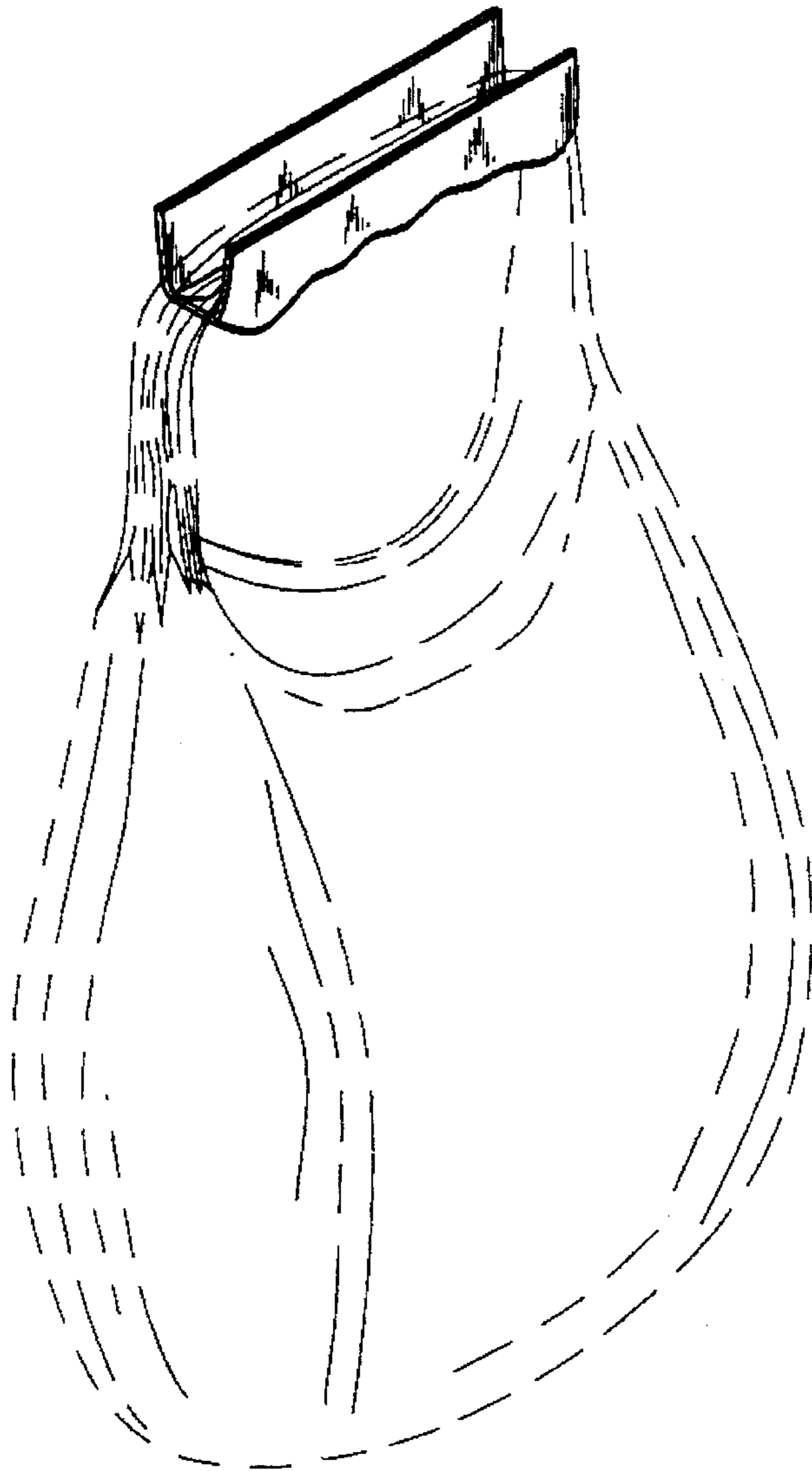

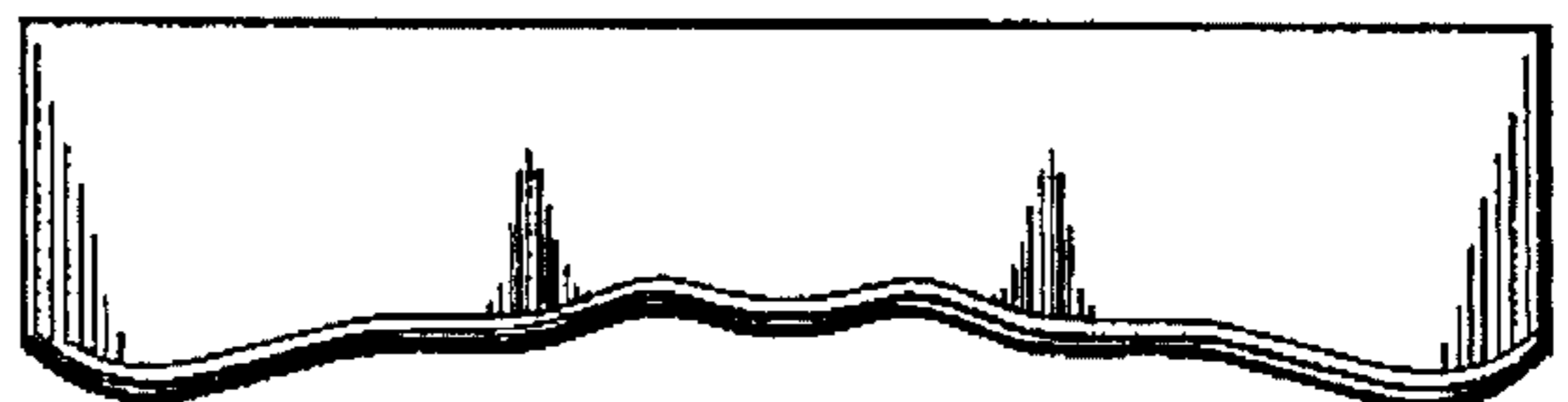
