## [57] CLAIM

The ornamental design for a combined whirlpool bathtub and shower stall, as shown and described.

## DESCRIPTION

FIG. 1 is a right side perspective view of a combined whirlpool bathtub and shower stall, showing my new design; FIG. 2 is a left perspective view of a combined whirlpool bathtub and shower stall, with the shower portion removed; FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a cross-sectional view taken along line 5—5 of FIG. 3;

FIG. 6 is a cross-sectional view taken along line 6—6 of FIG. 3;

FIG. 7 is a right side perspective view of the shower portion;

FIG. 8 is a right side perspective view of the shower portion, with the door partly closed;

FIG. 9 is an end view taken in the direction of line 9—9 of FIG. 11;

FIG. 10 is a side elevational view taken in the direction of line 10—10 of FIG. 11;

FIG. 11 is a top plan view thereof;

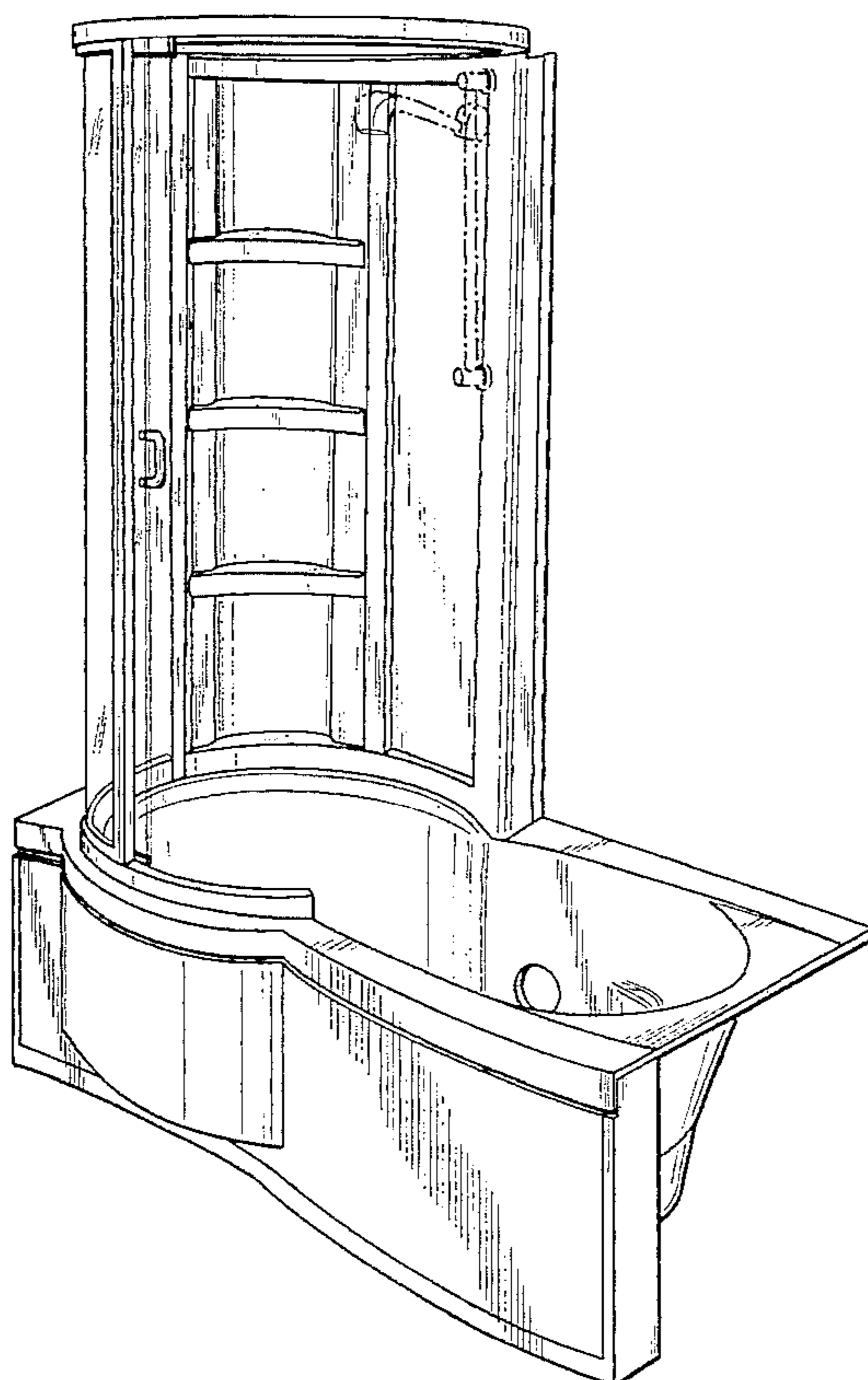
FIG. 12 is a cross-sectional view taken along line 12—12 of FIG. 13;

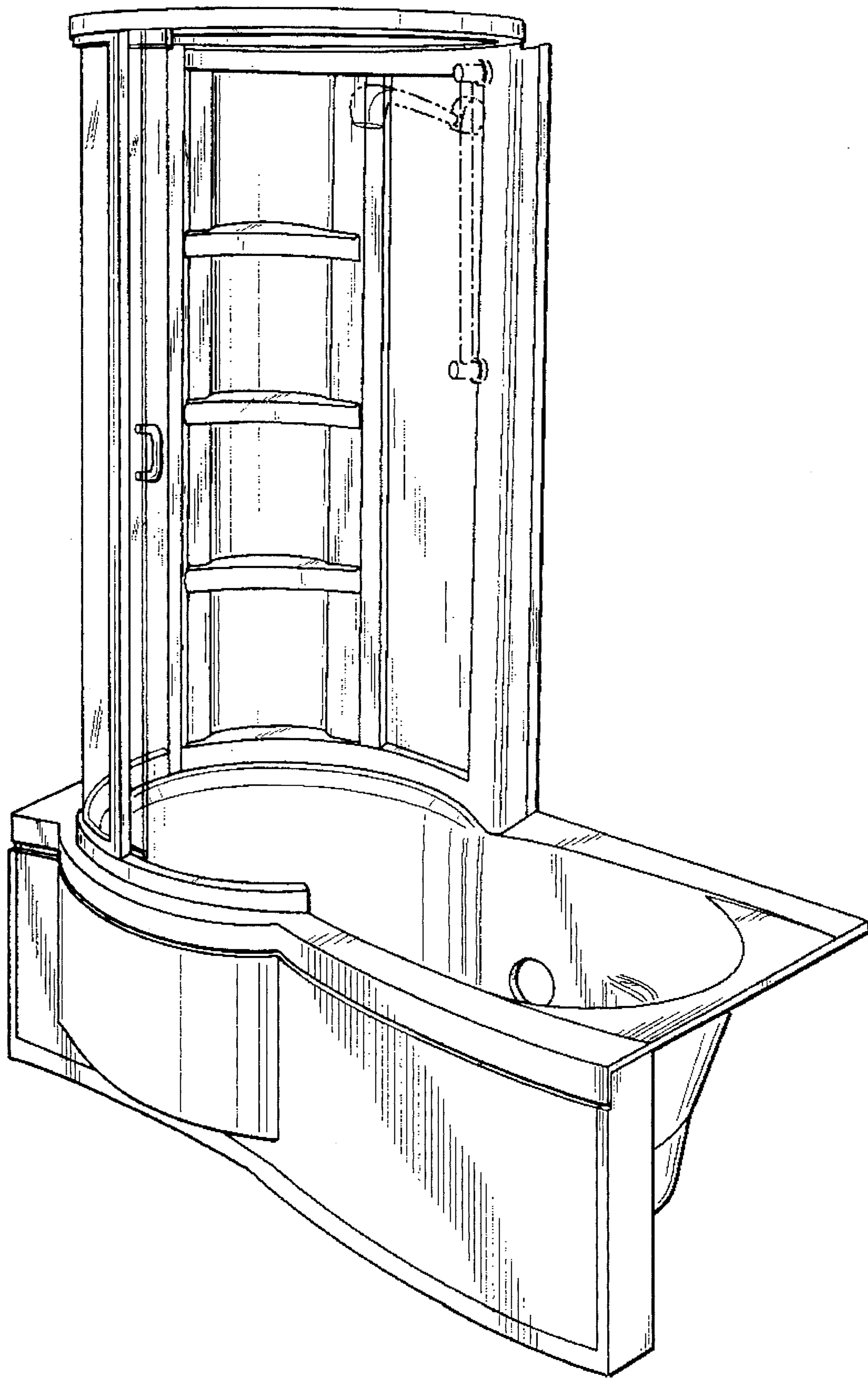
FIG. 13 is a cross-sectional view taken along line 13—13 of FIG. 8; and,

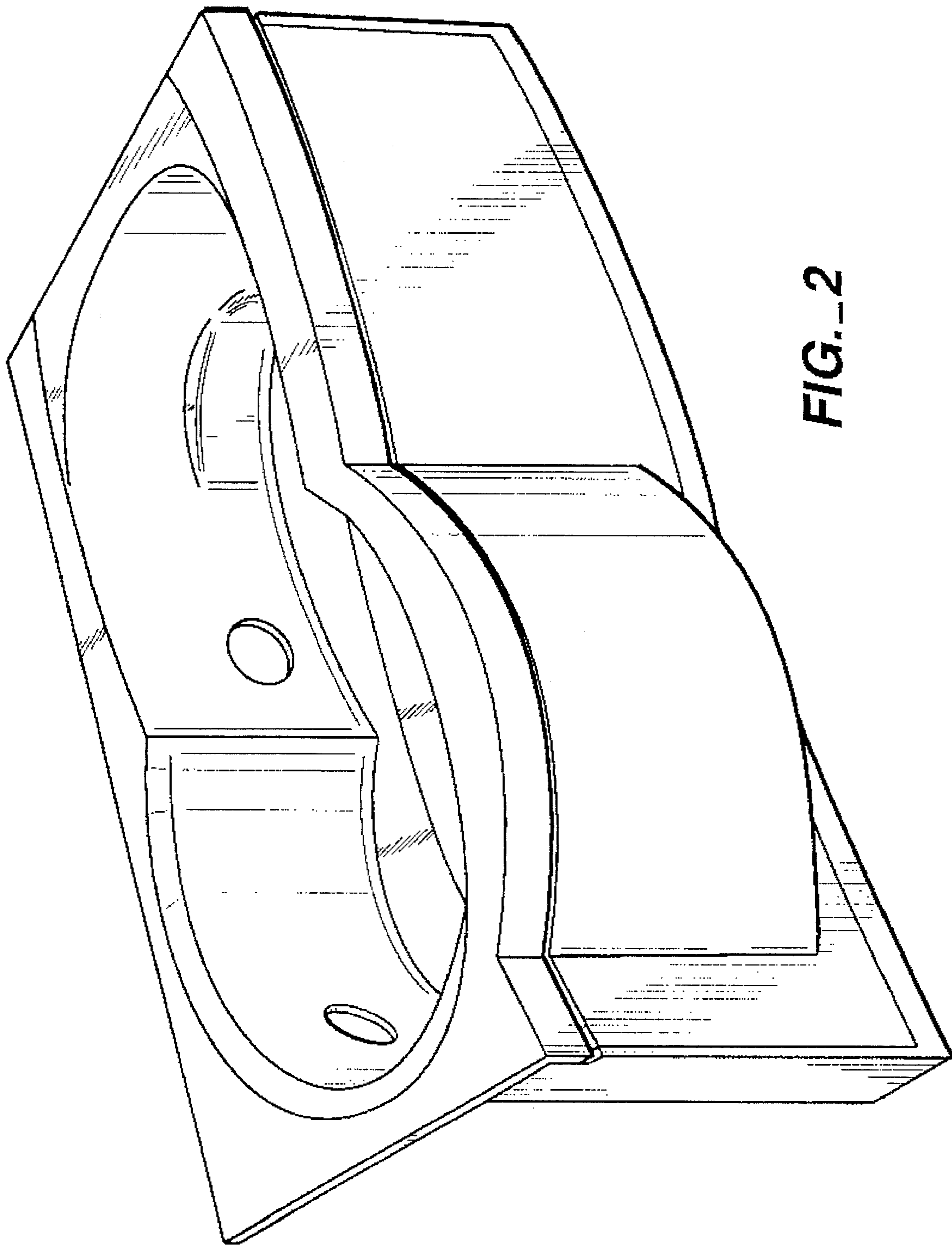

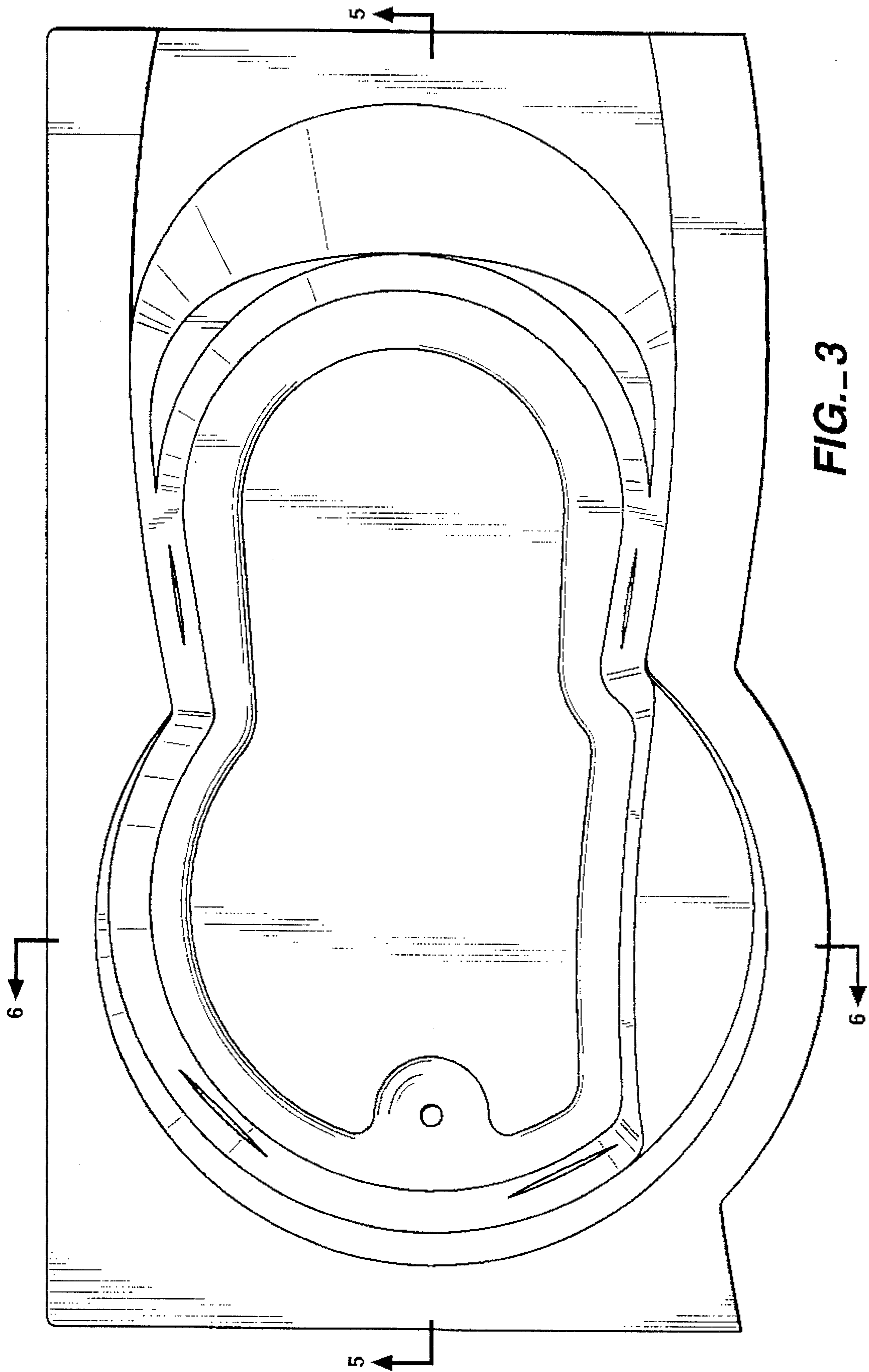

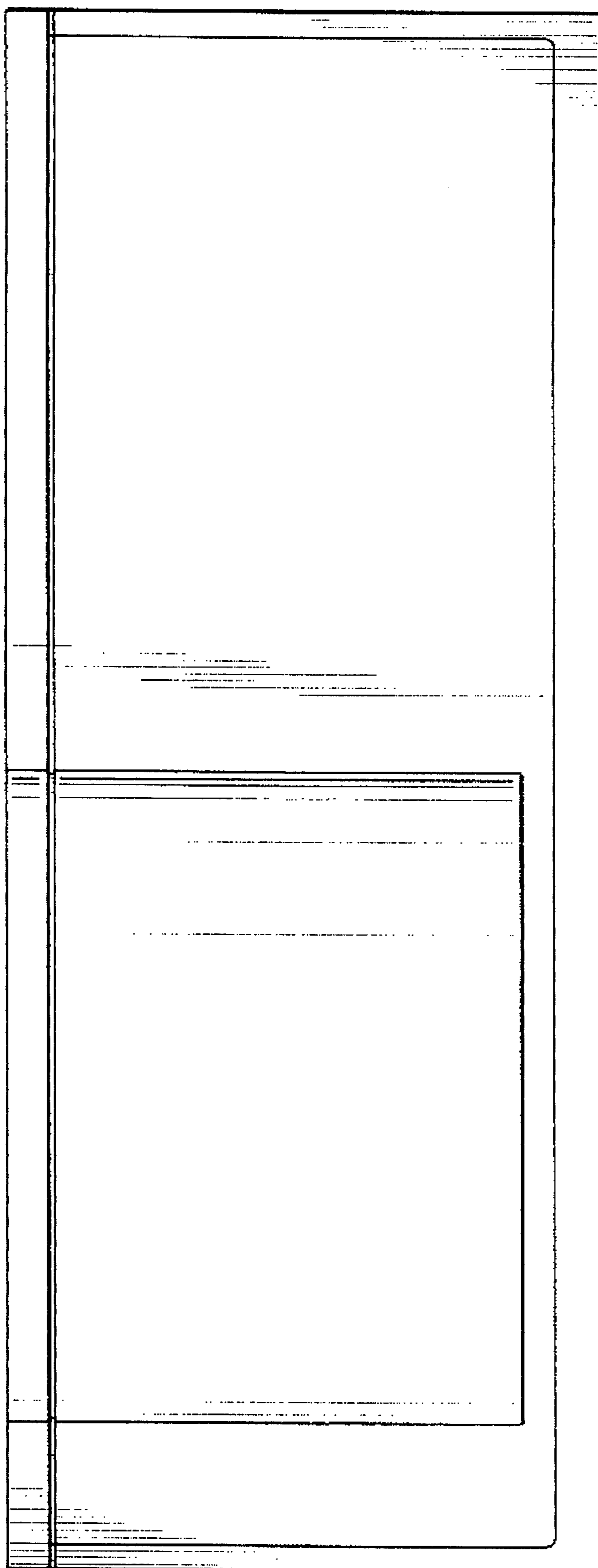

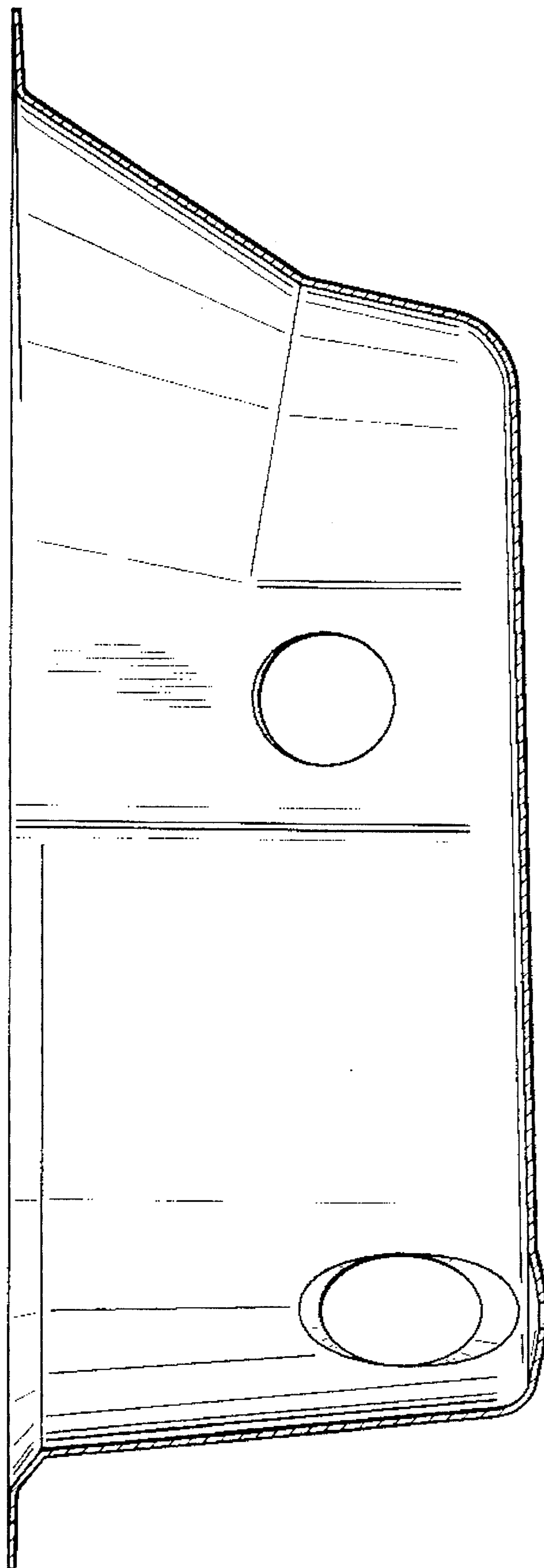
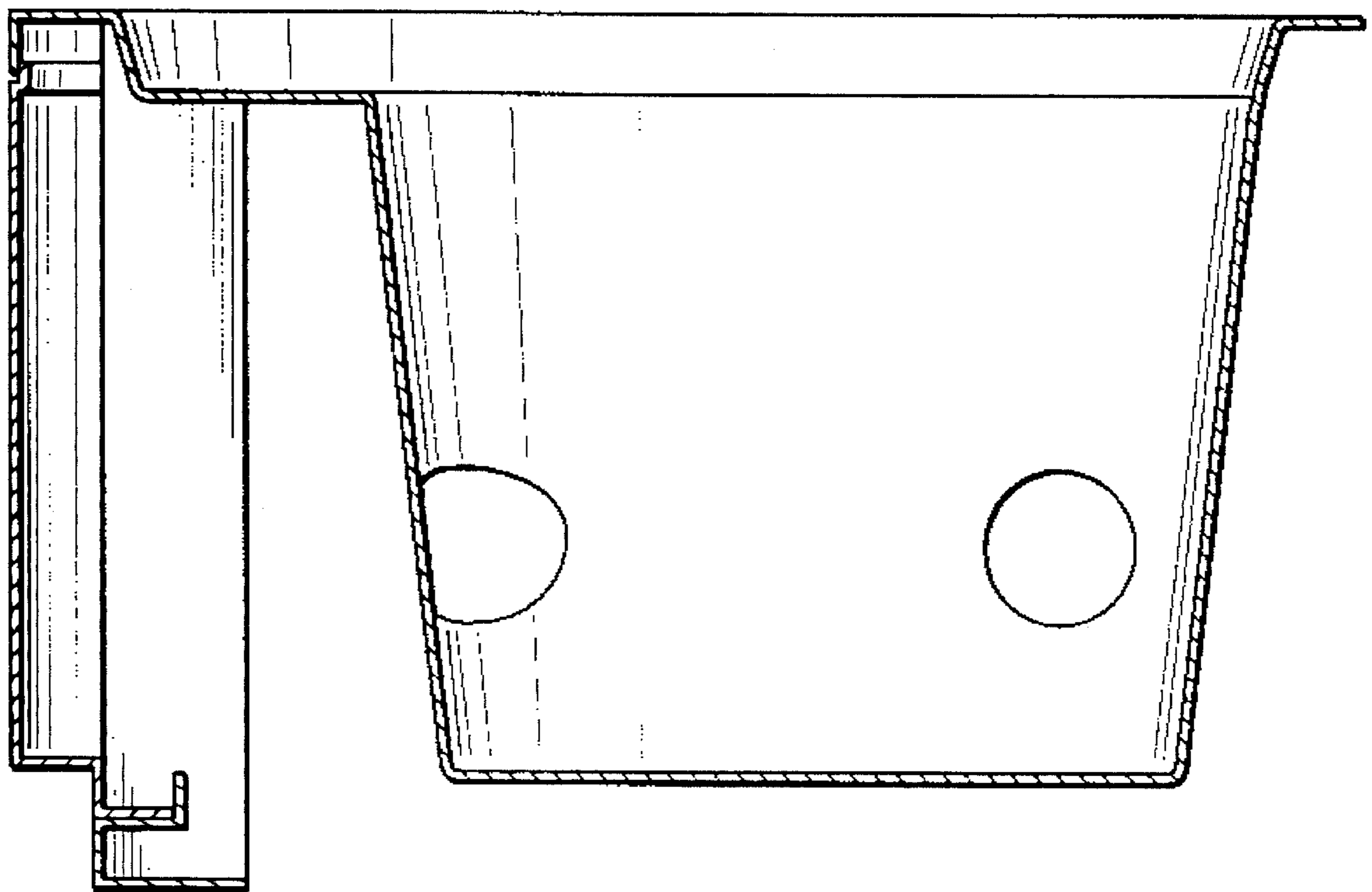
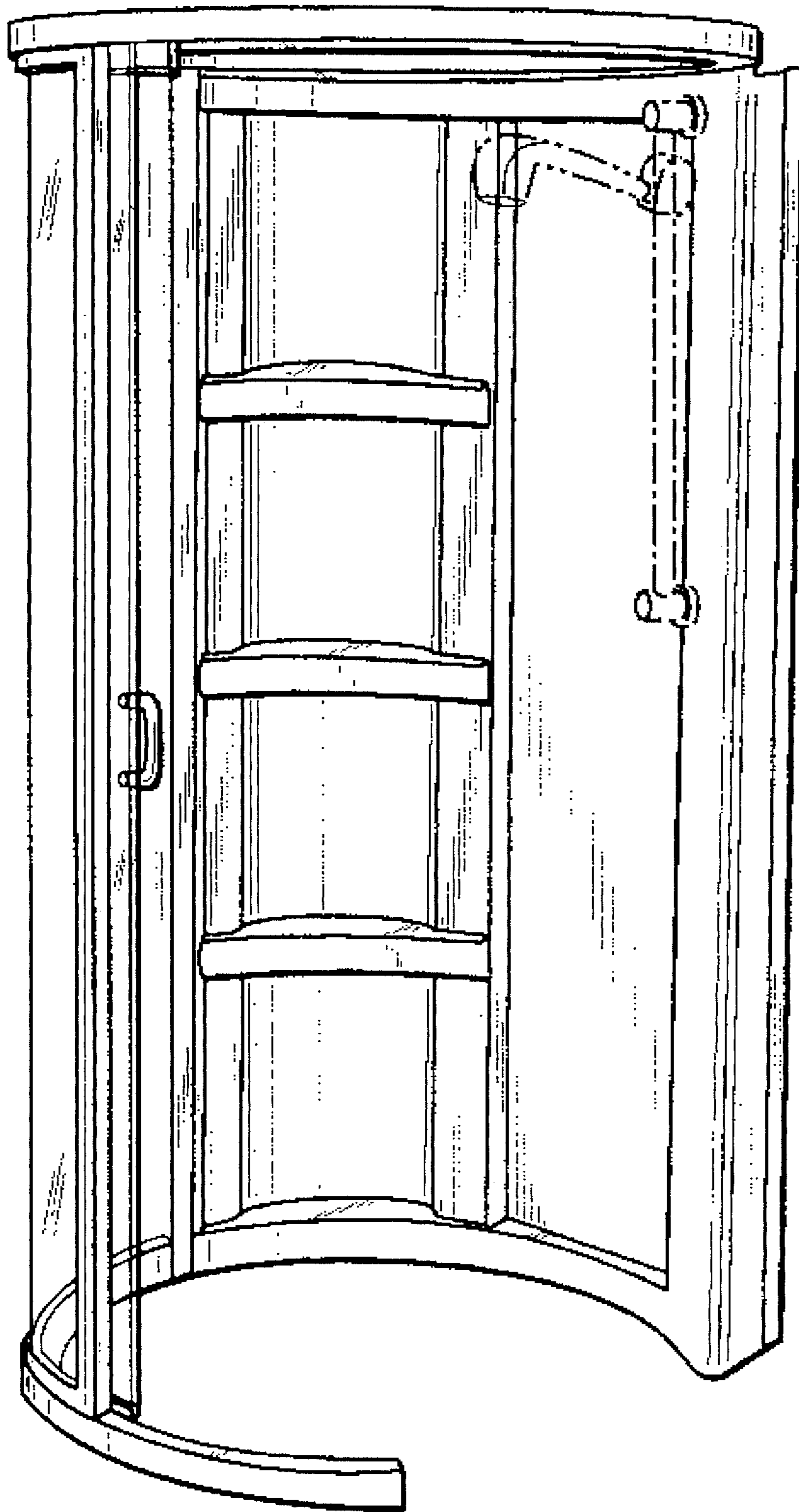

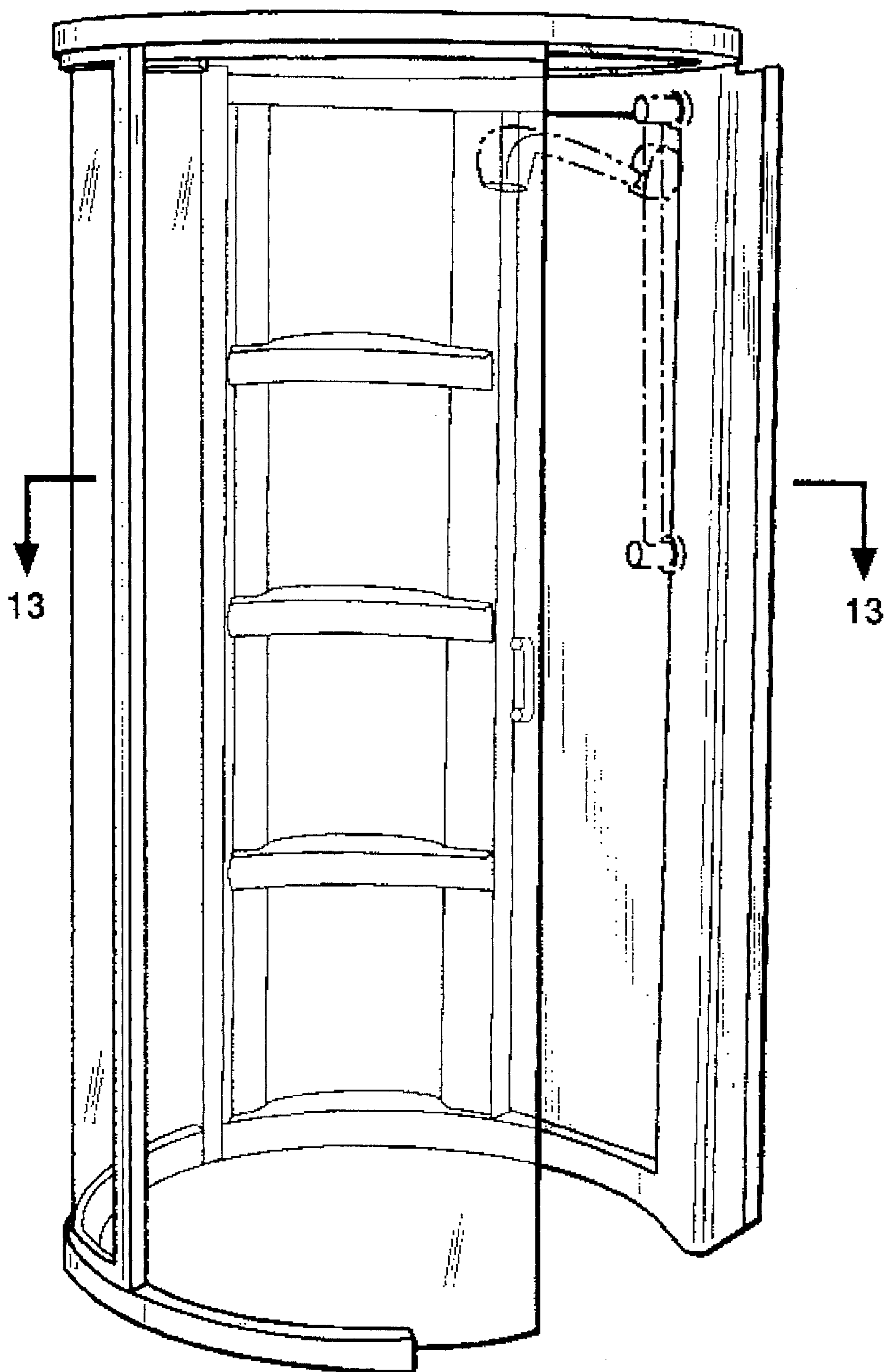

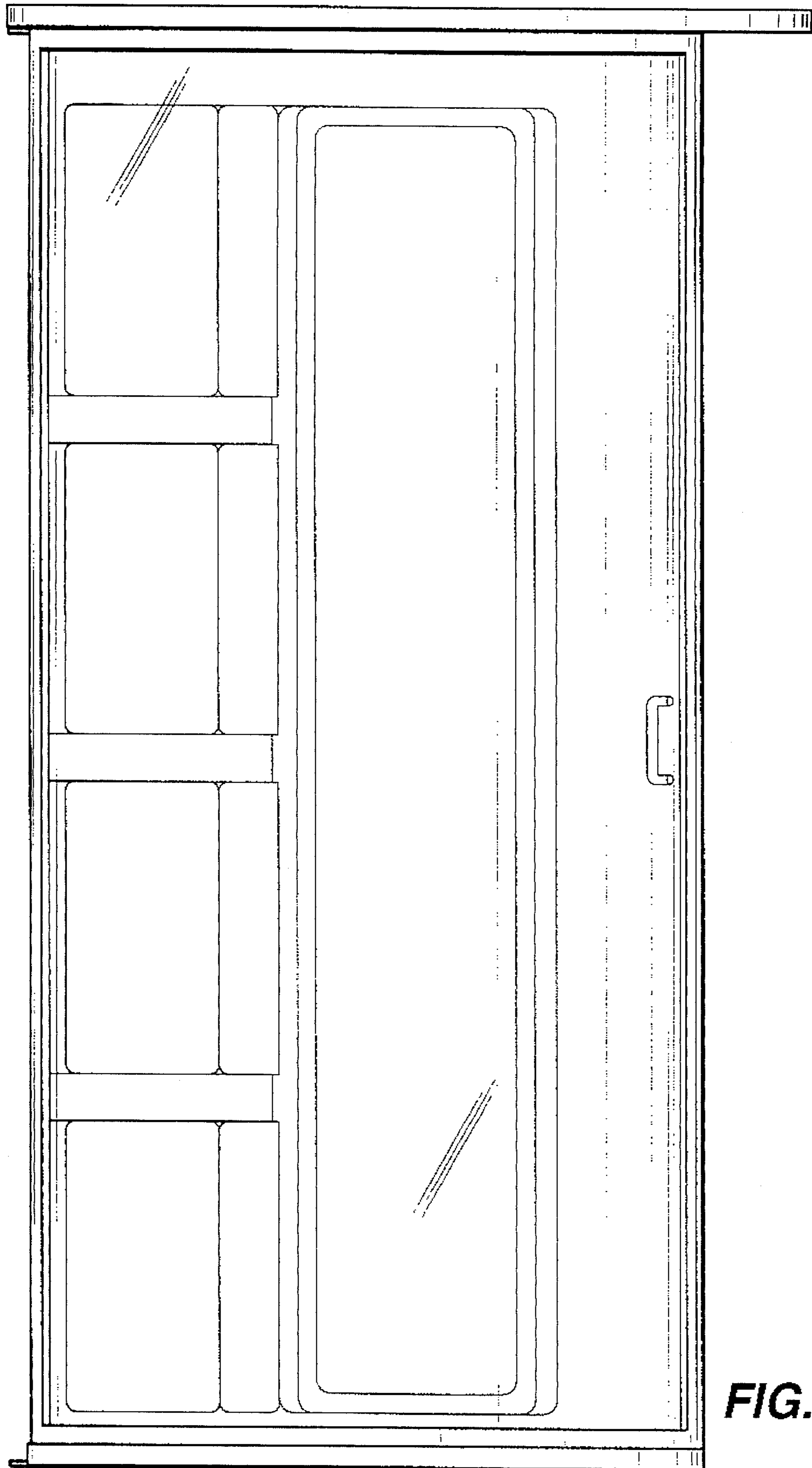

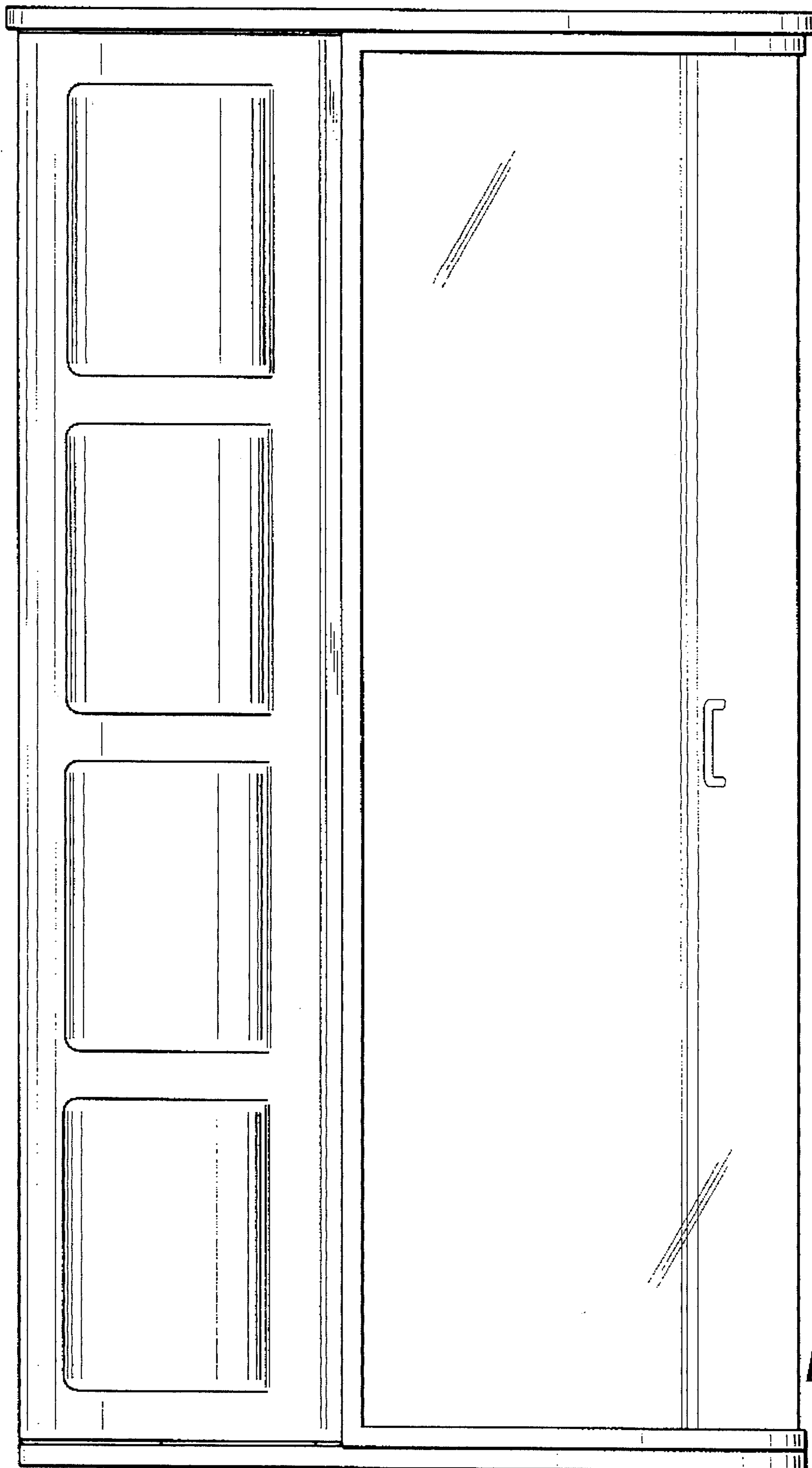
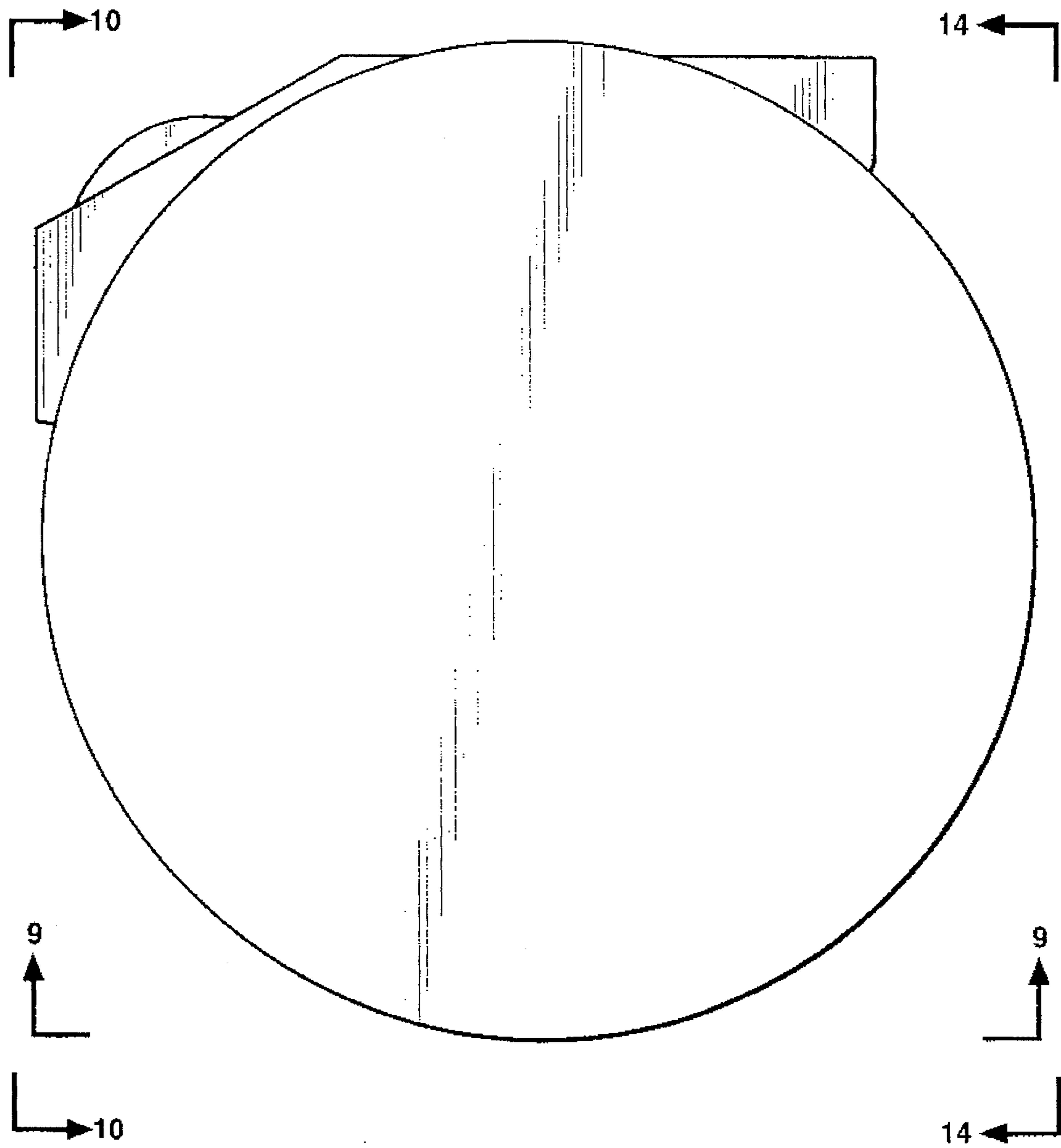

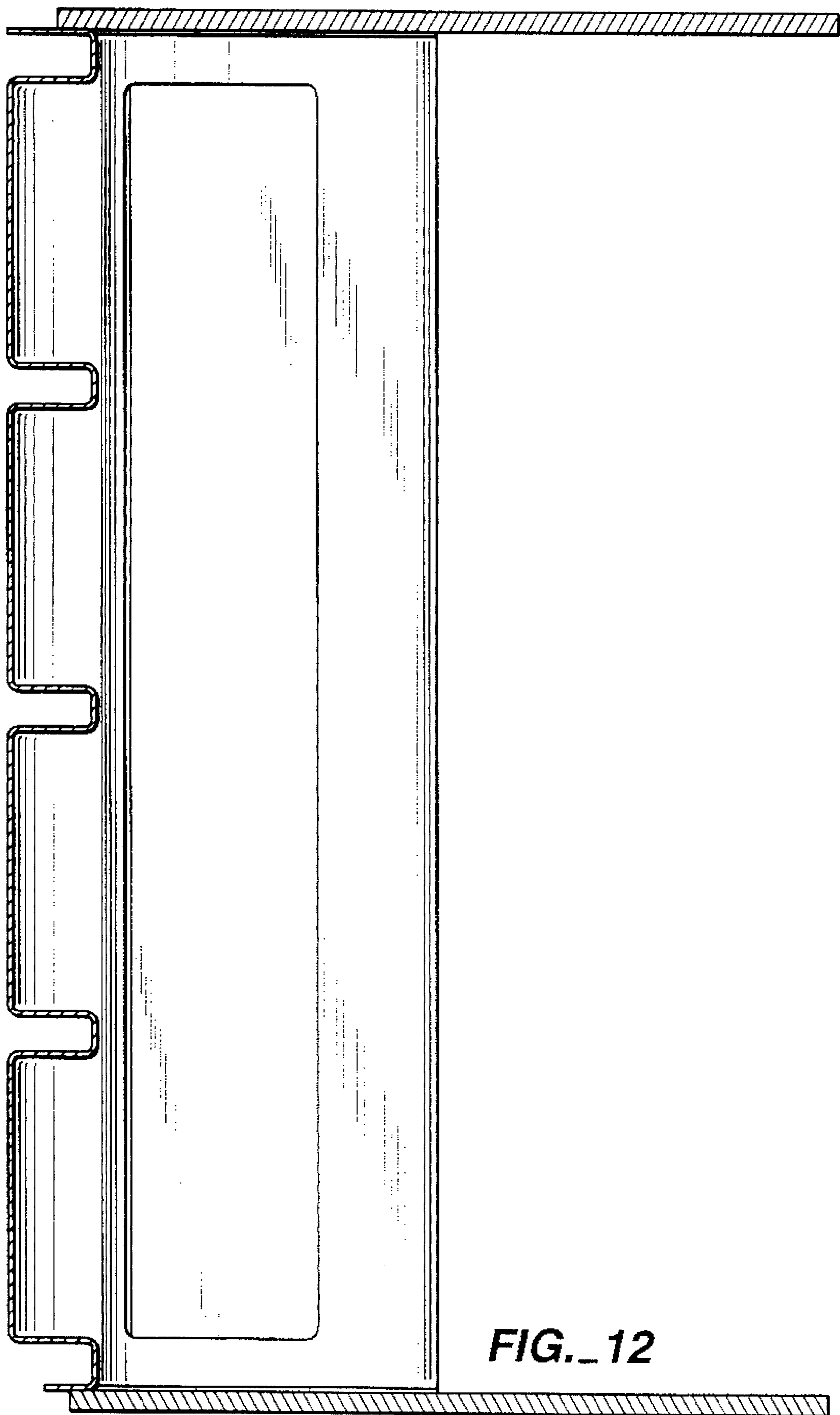
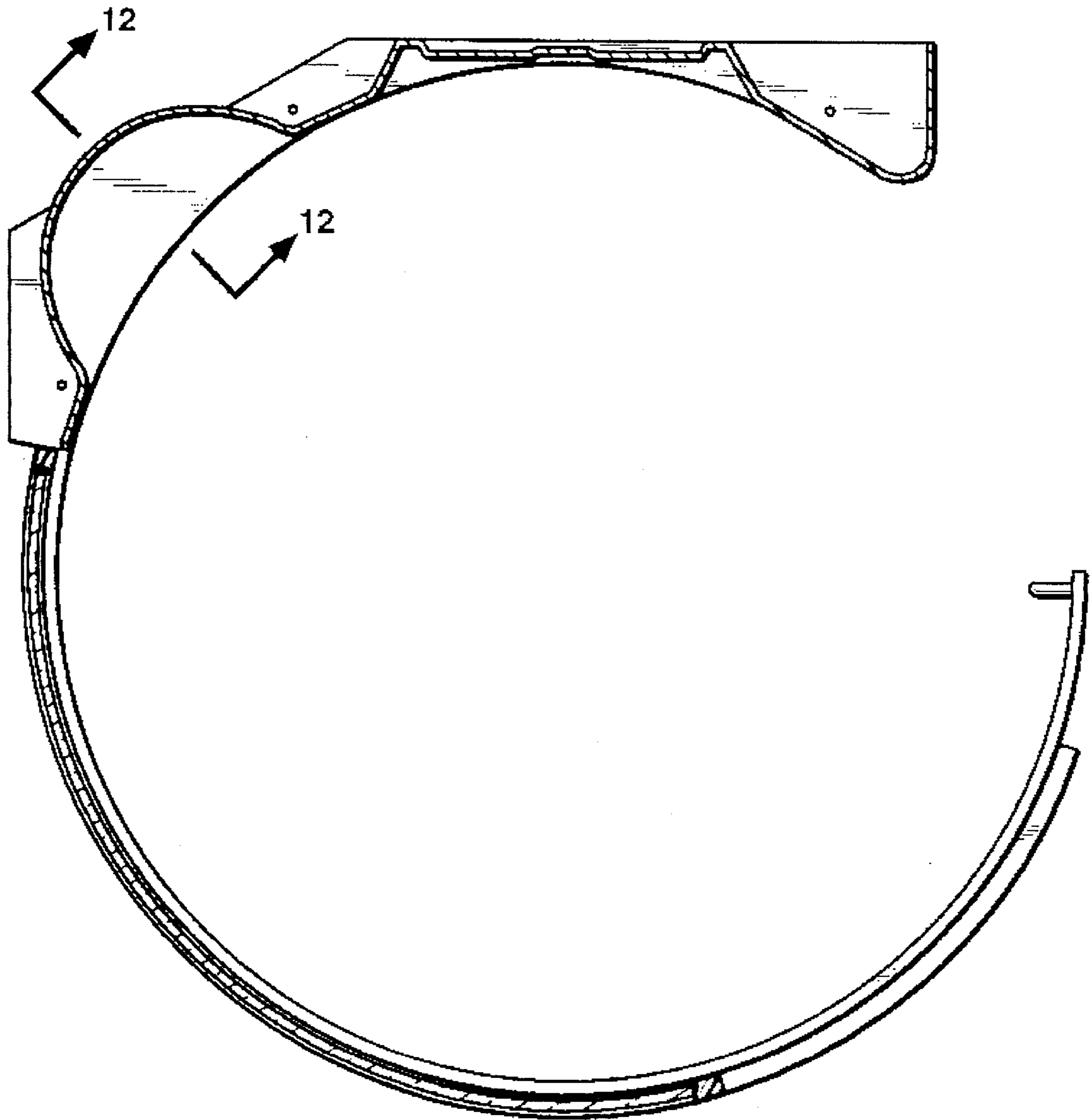

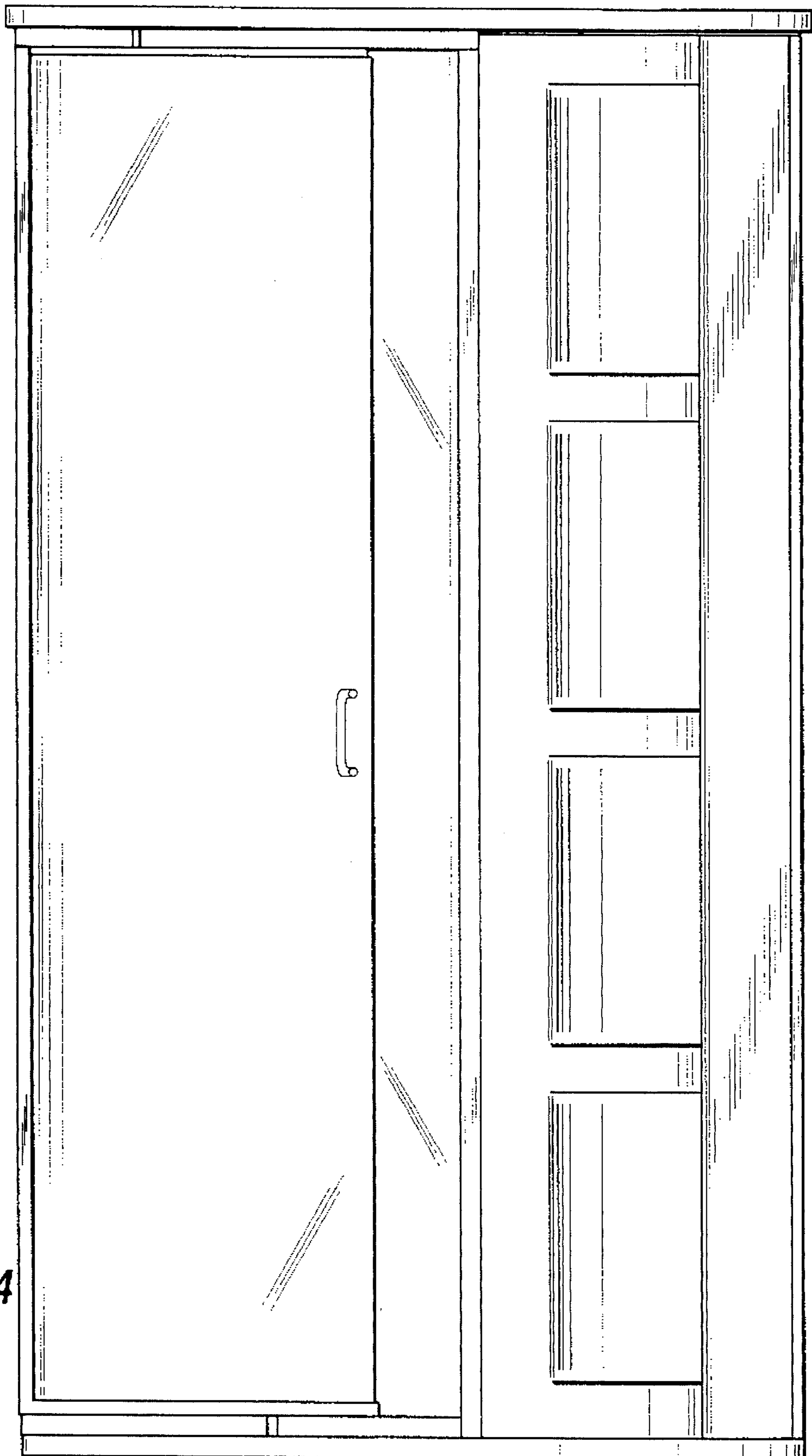
