### [57] CLAIM

The ornamental design for bathroom tissue with floral design, as shown and described.

### DESCRIPTION

The sole FIGURE is a plan view of bathroom tissue with floral design, showing our new design, shown broken away to indicate indeterminate length, the pattern on the single sheet repeating uniformly throughout the design.  
The claimed bathroom tissue has no substantial thickness.
