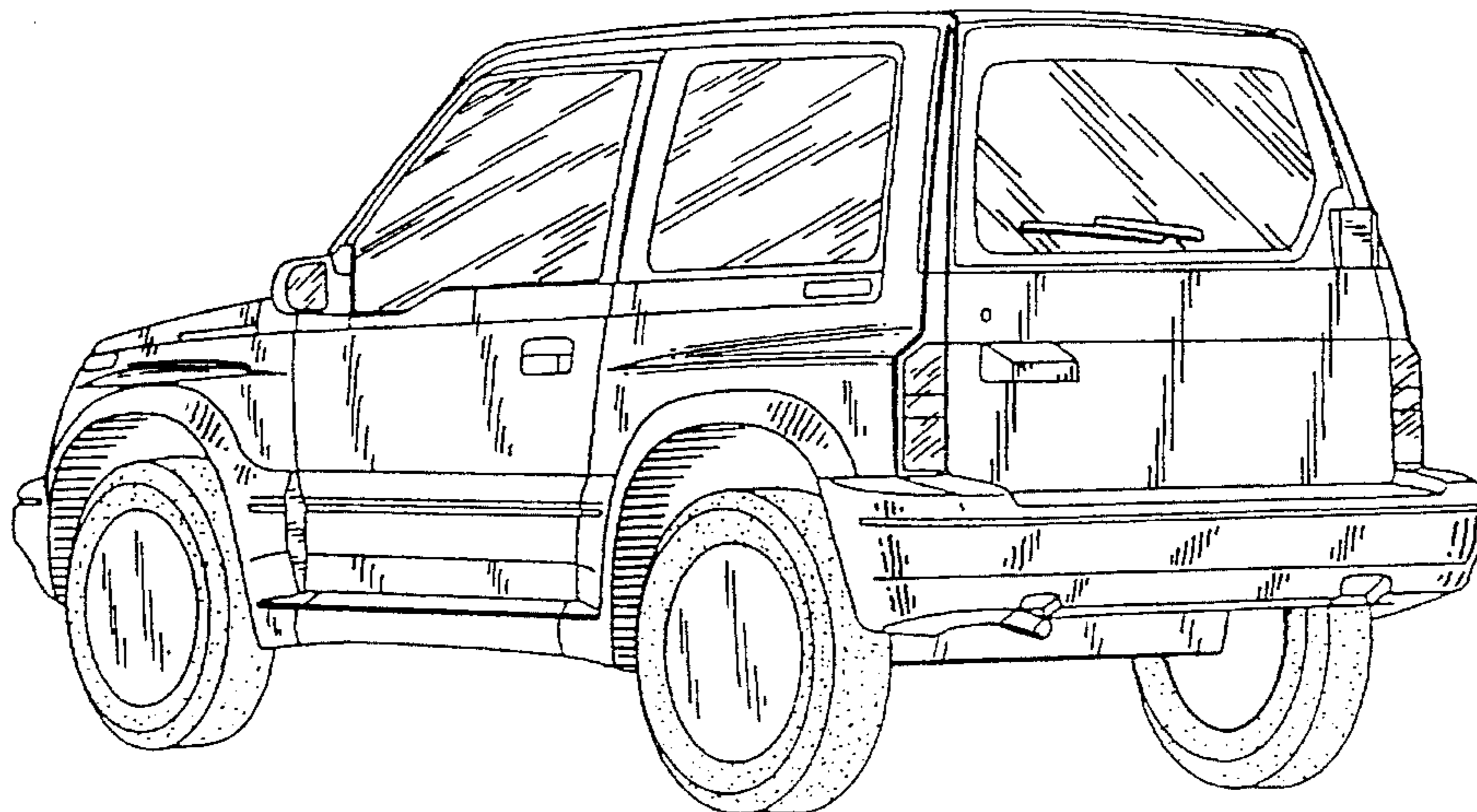
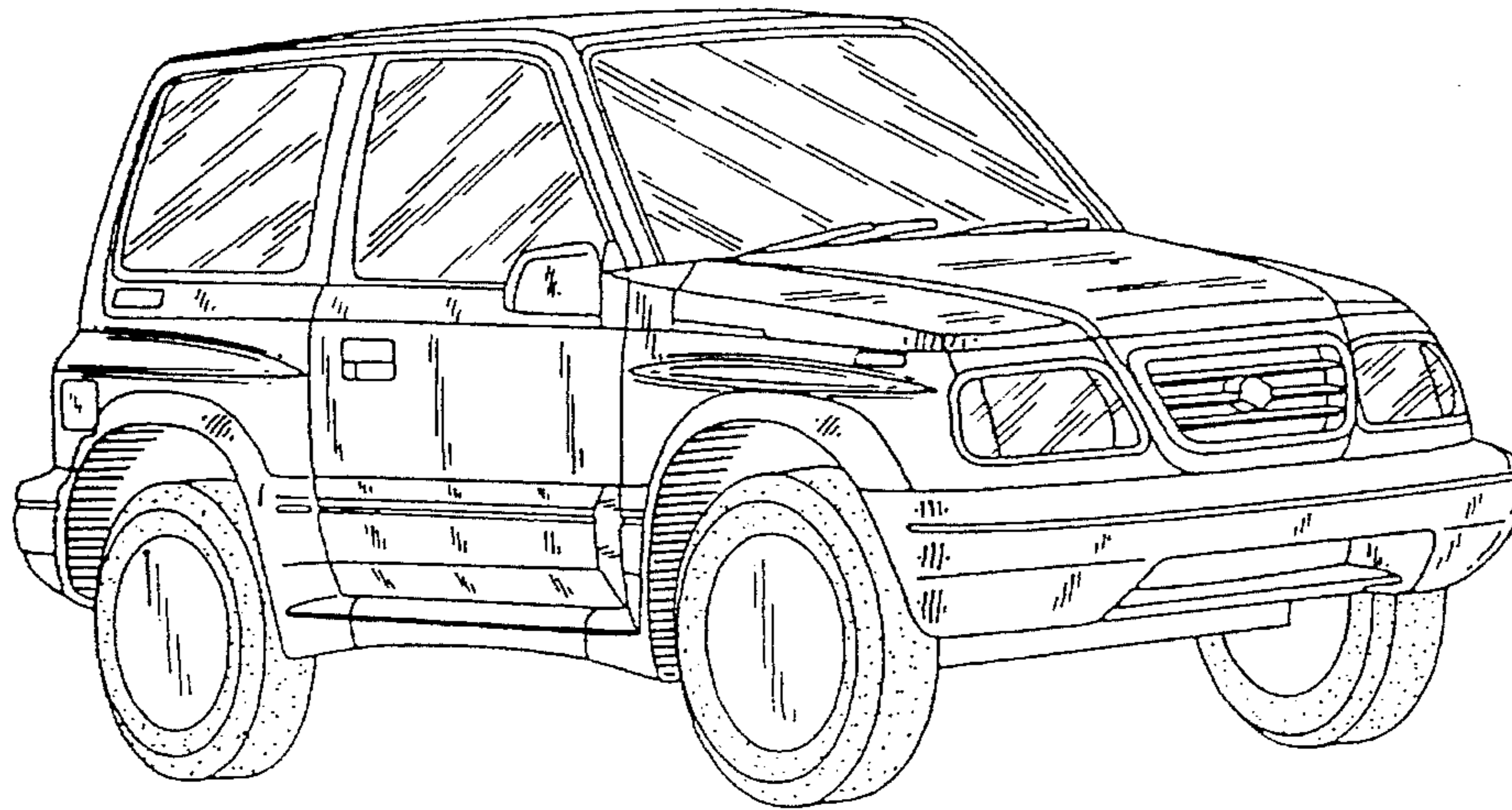
FIG. 1 is a front elevational view;

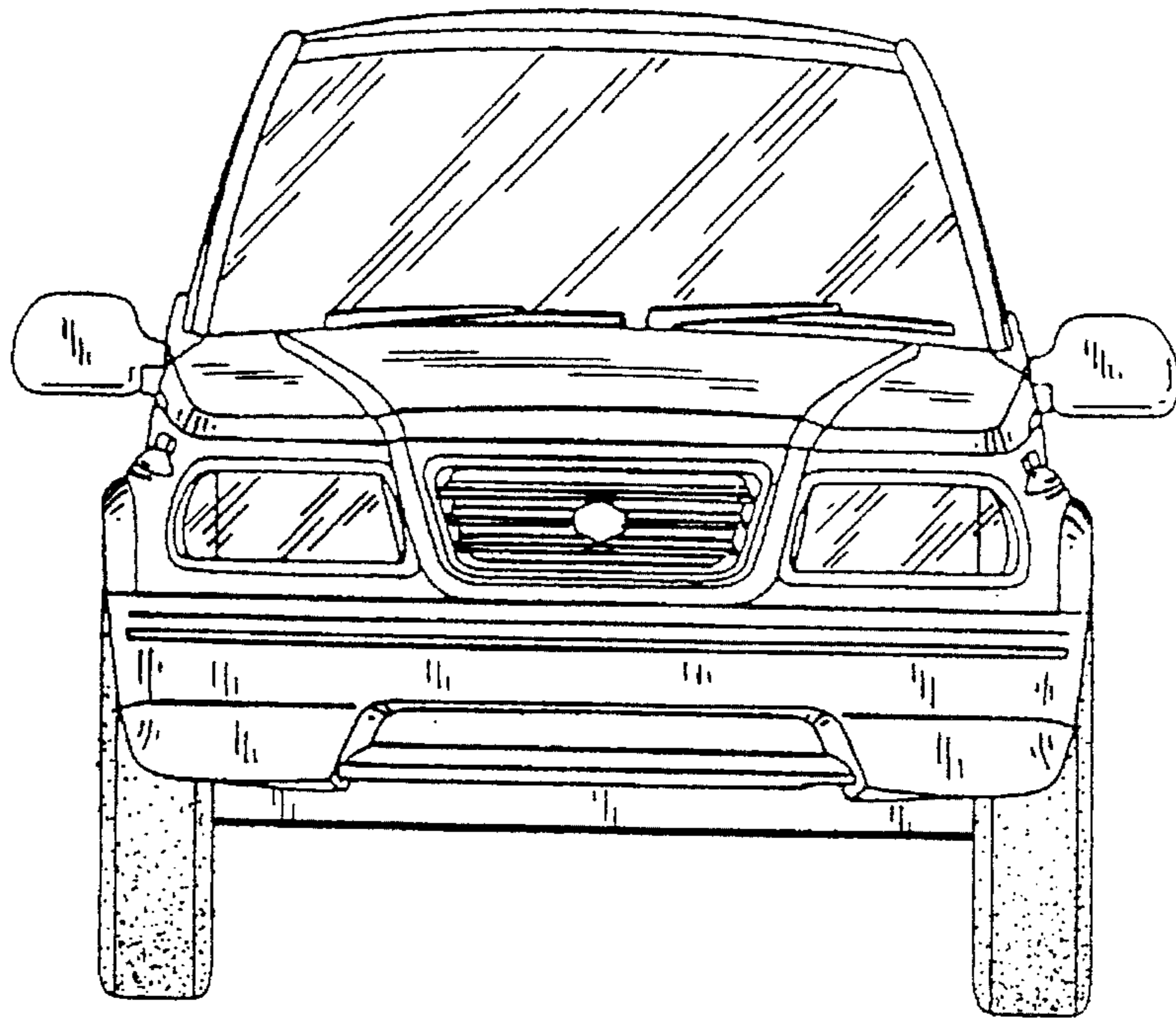

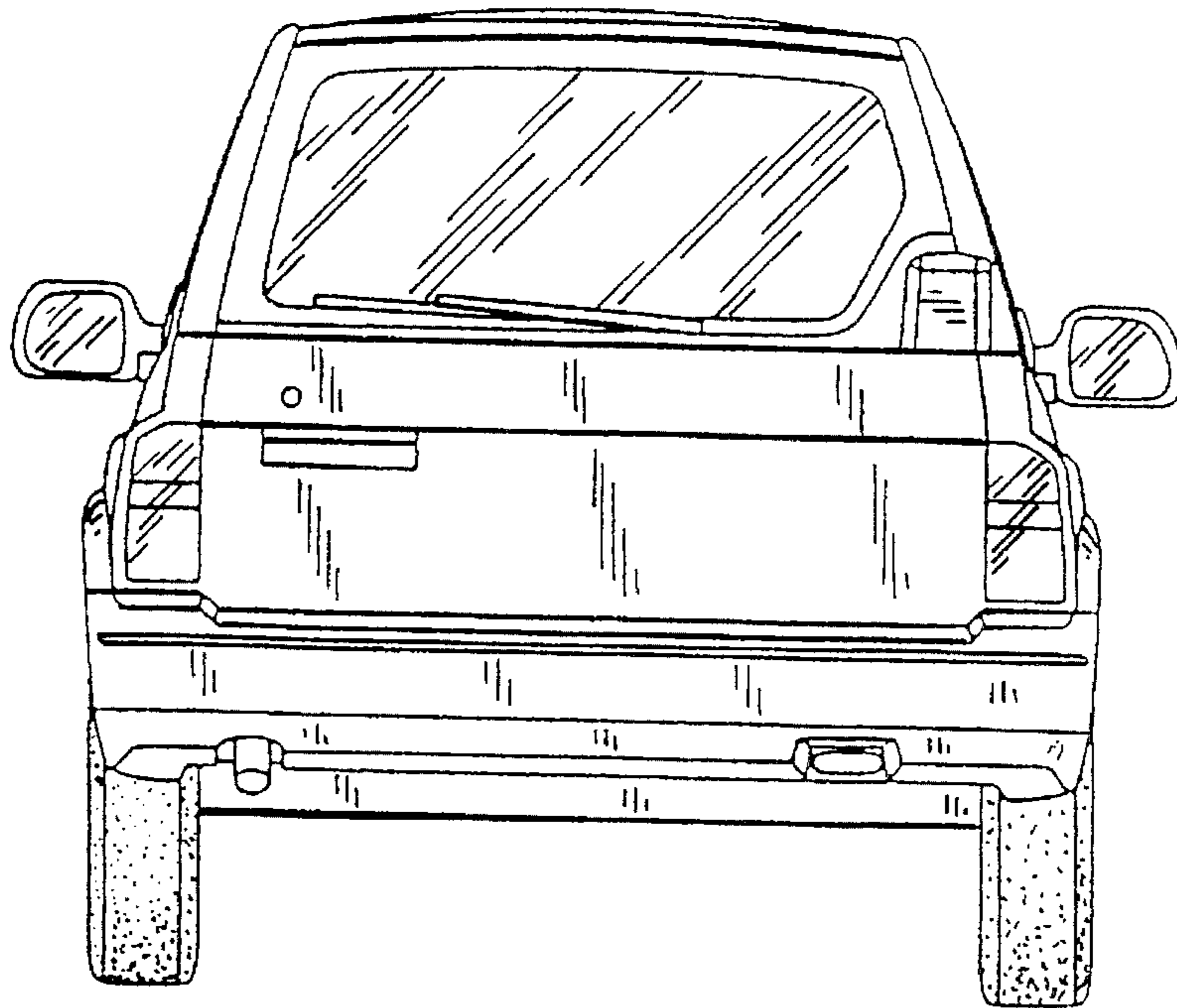

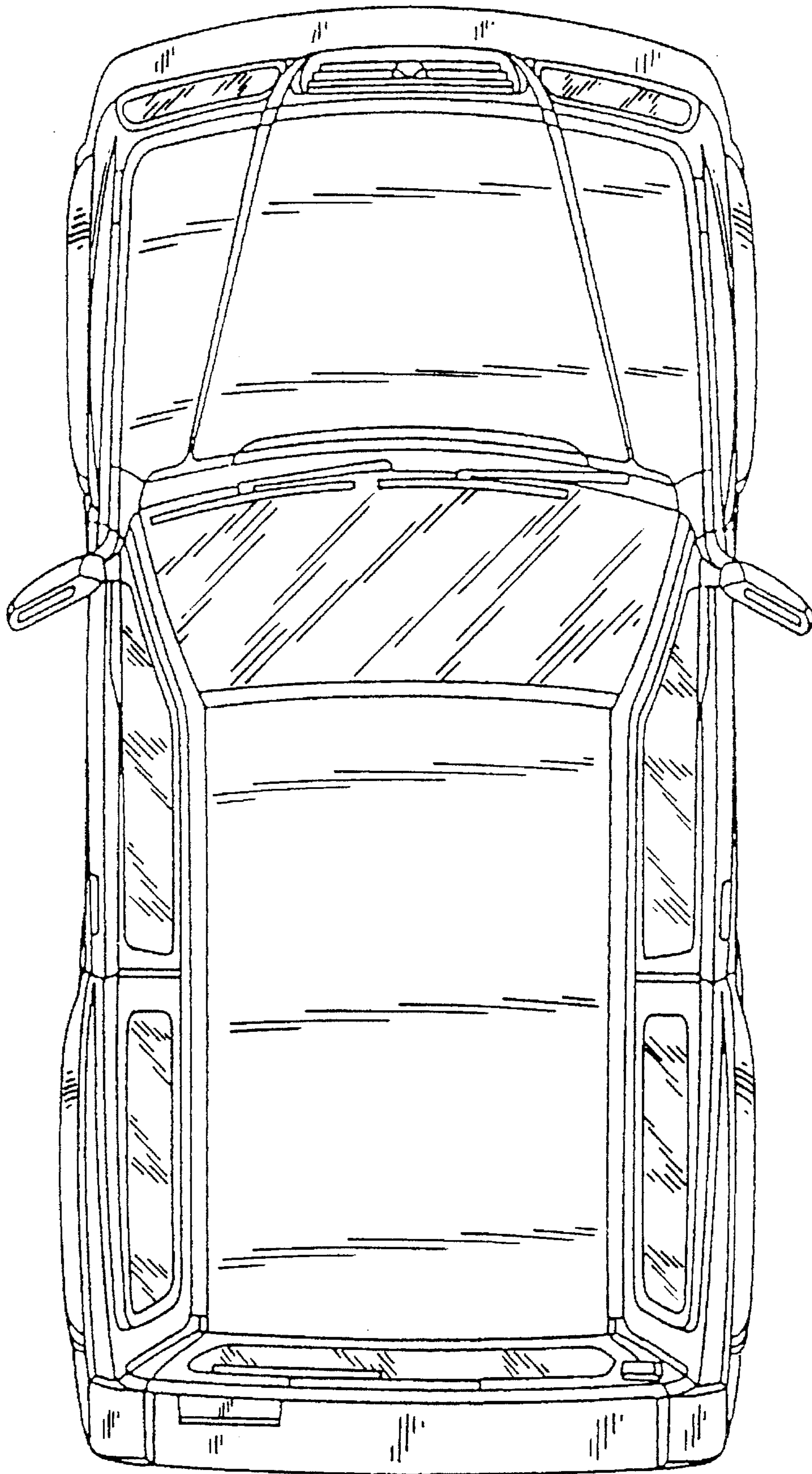

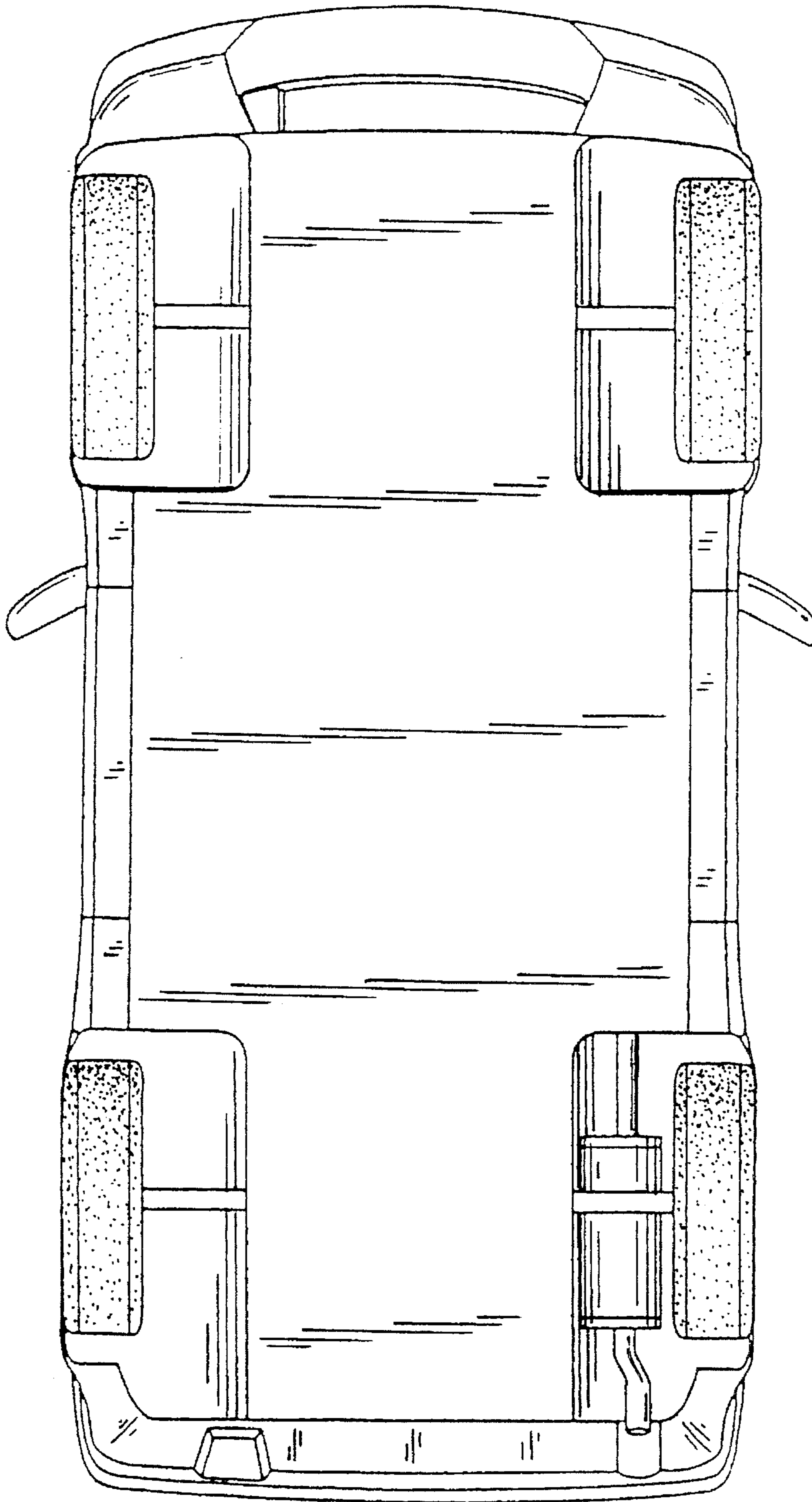

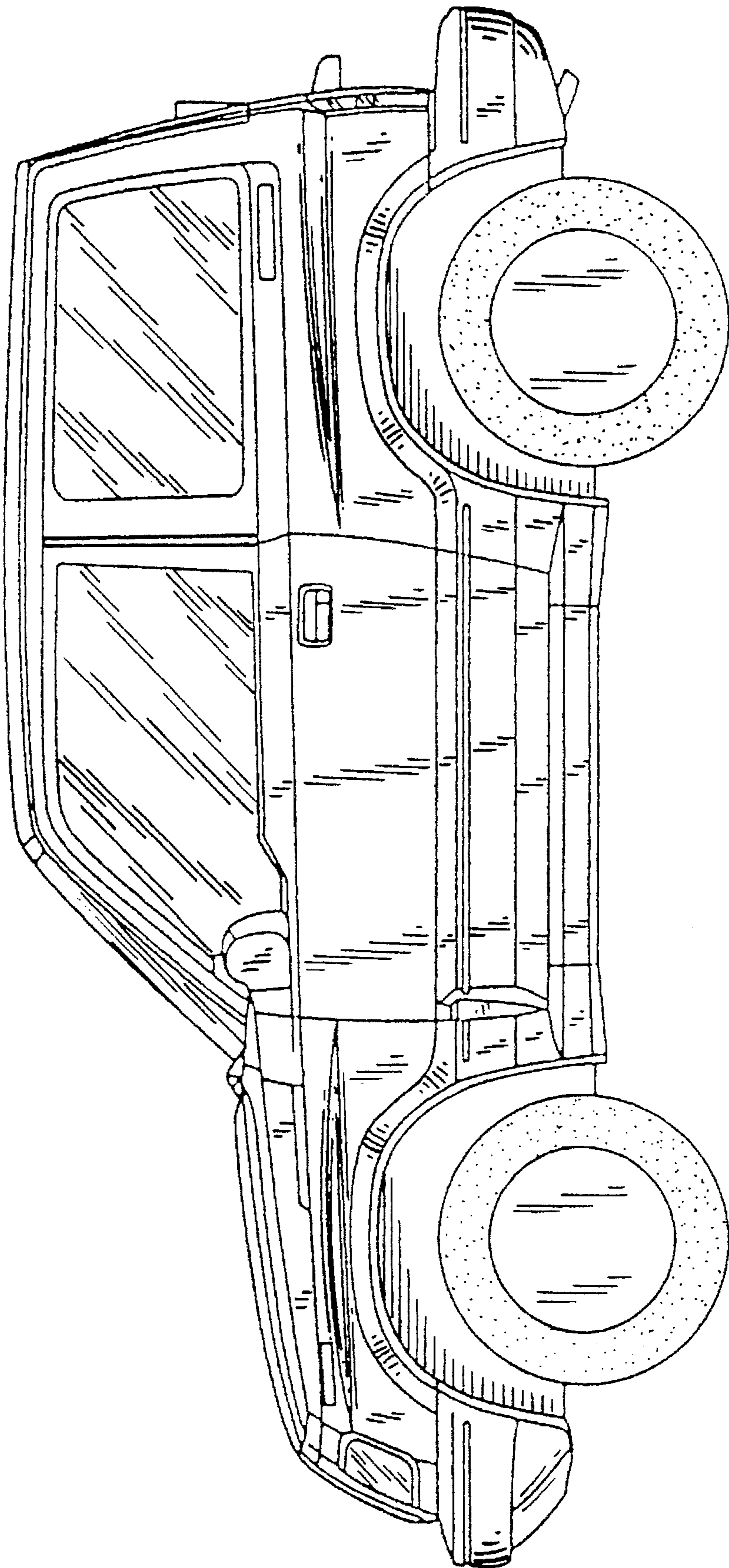

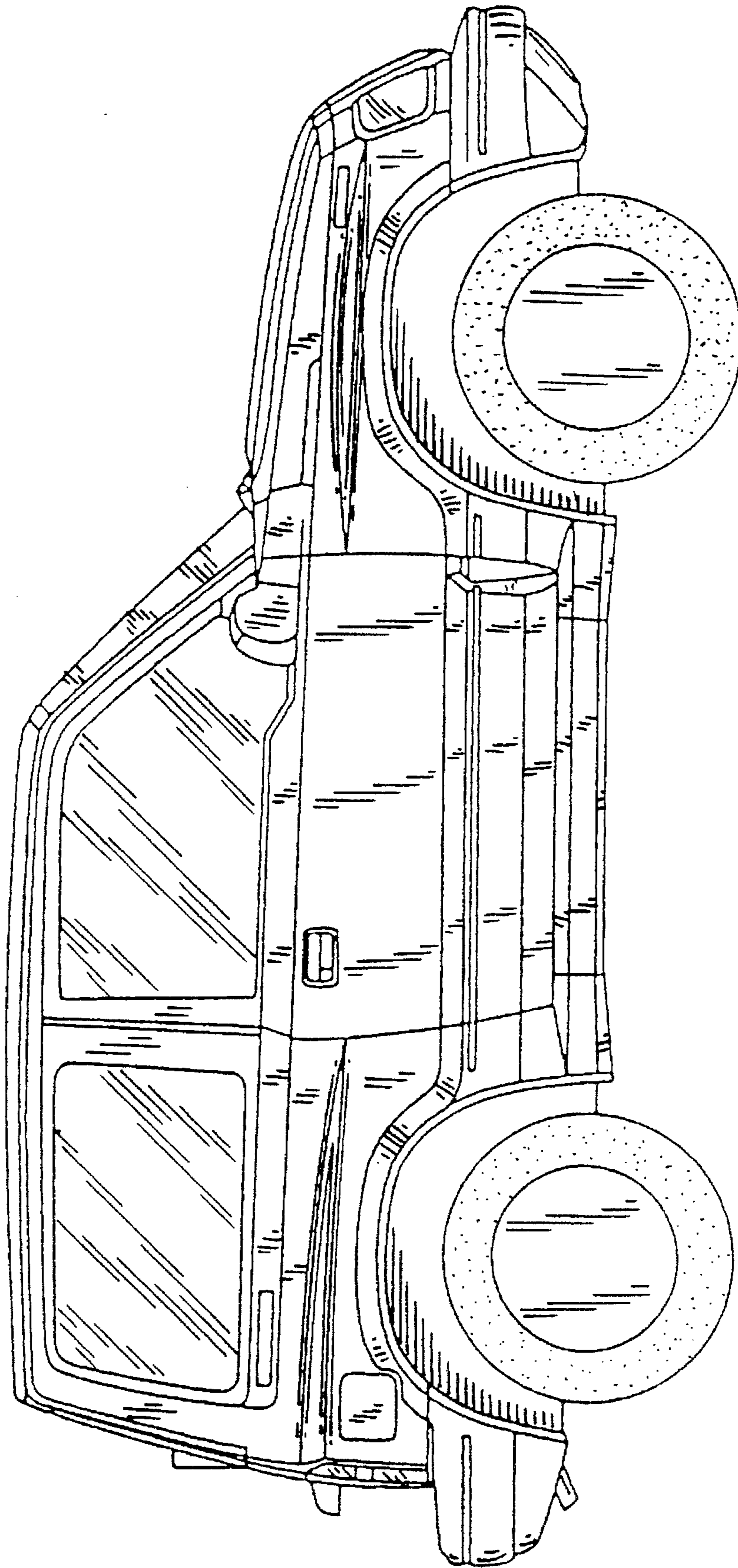

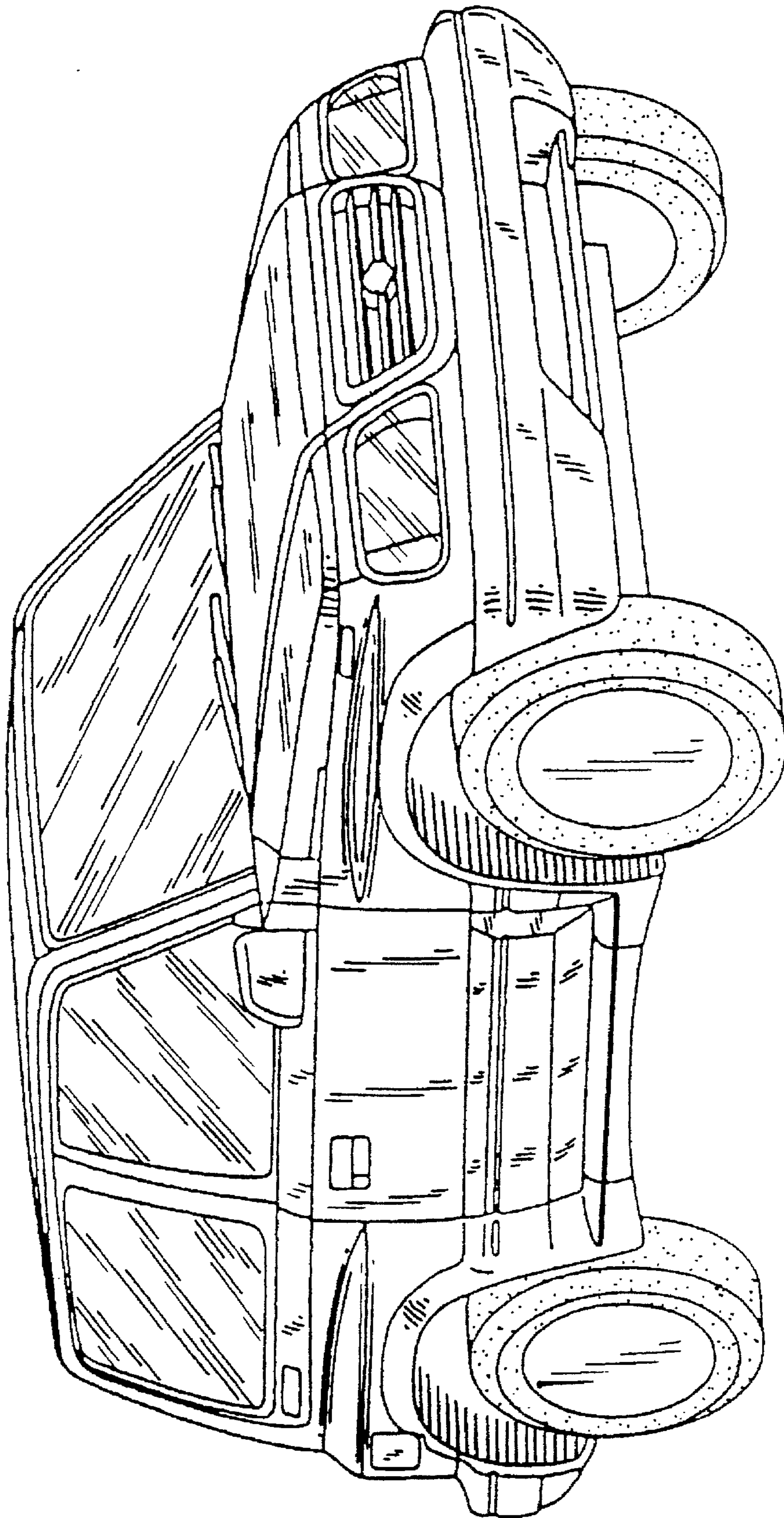

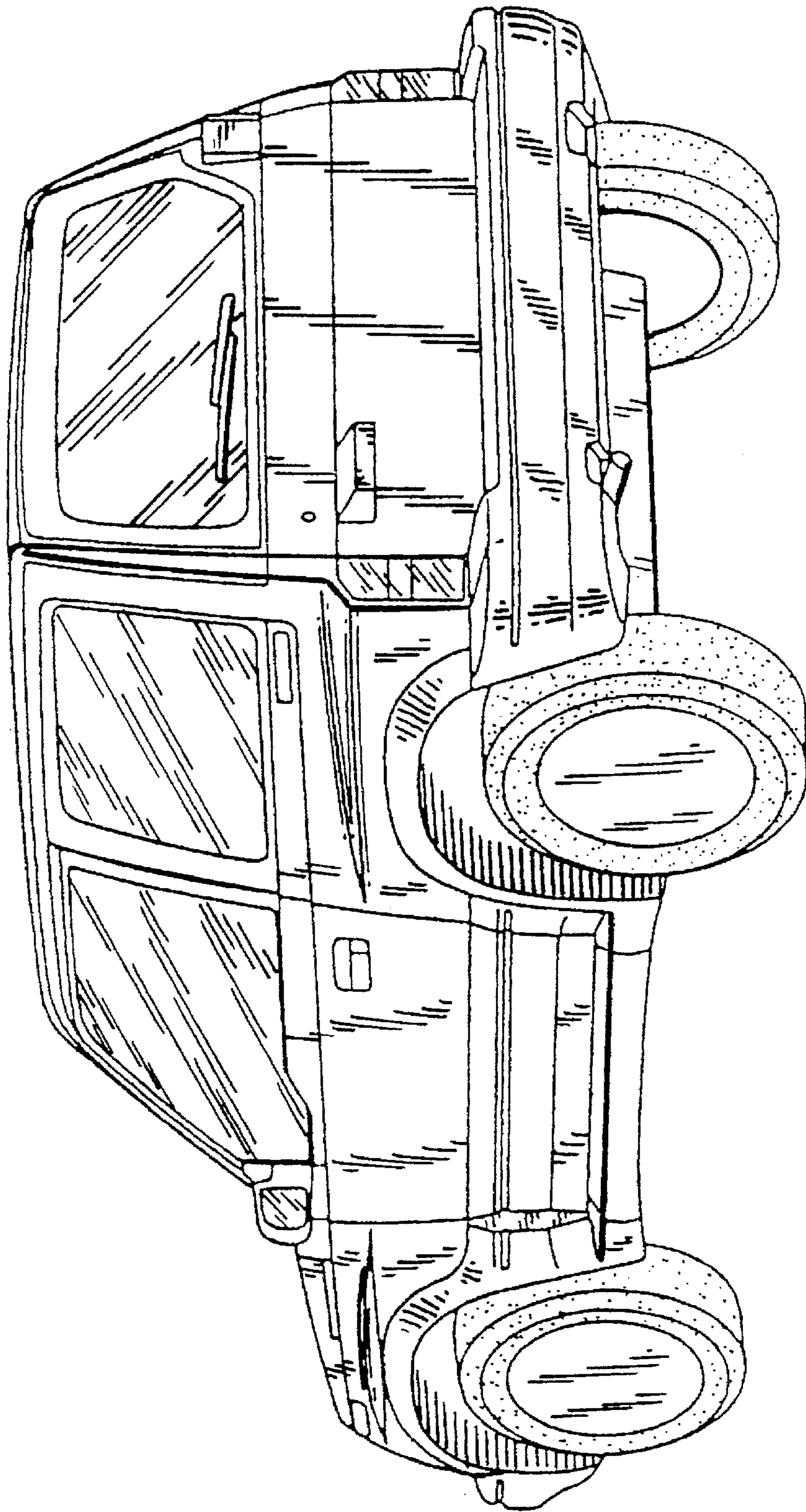
