The ornamental design for a combined tie and fastener, as shown and described.

**DESCRIPTION**

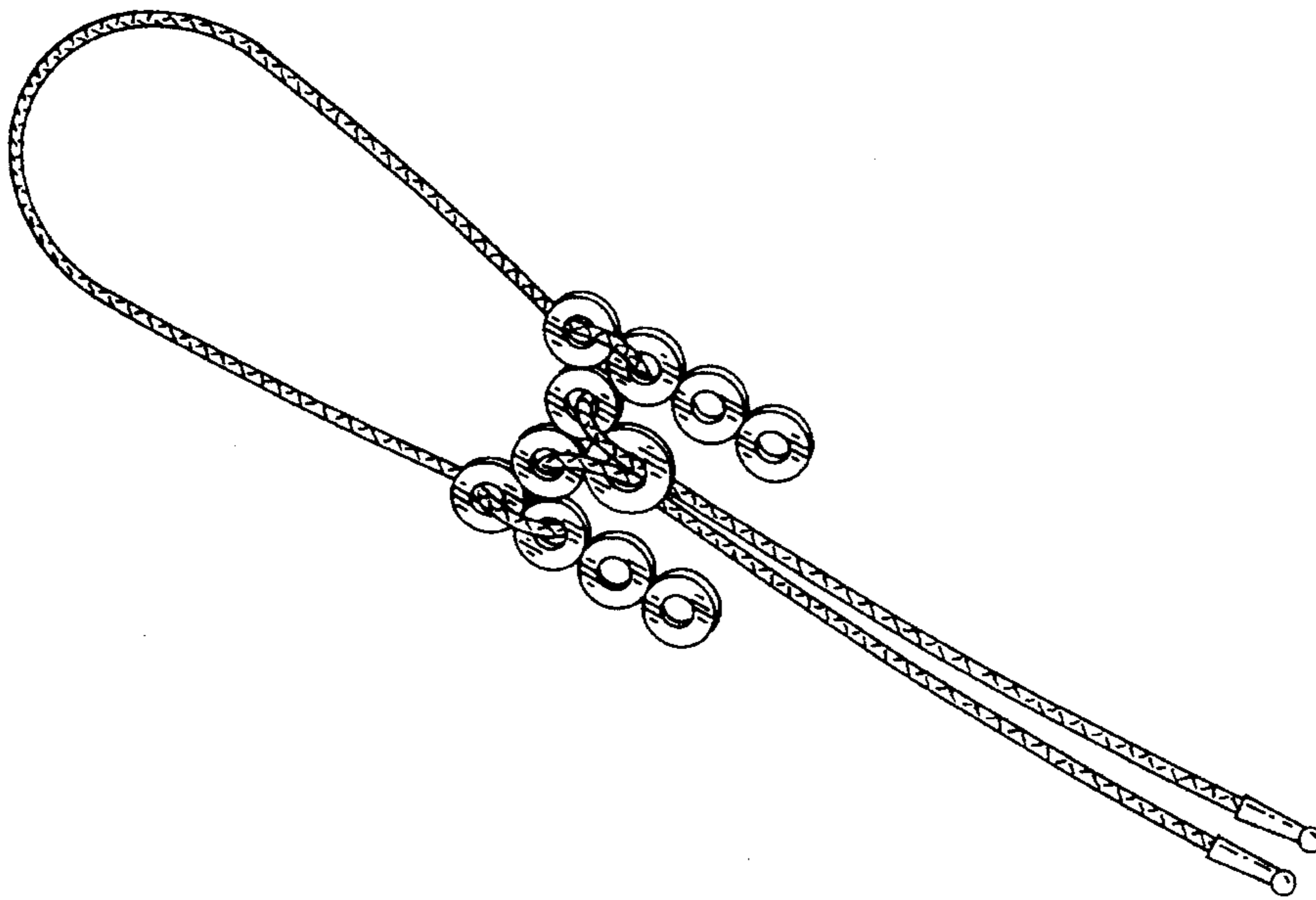

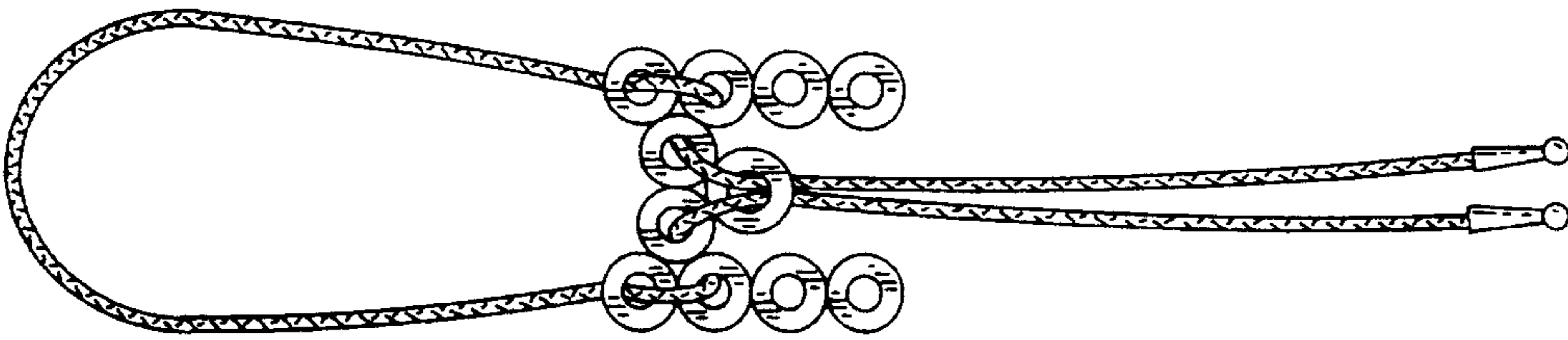

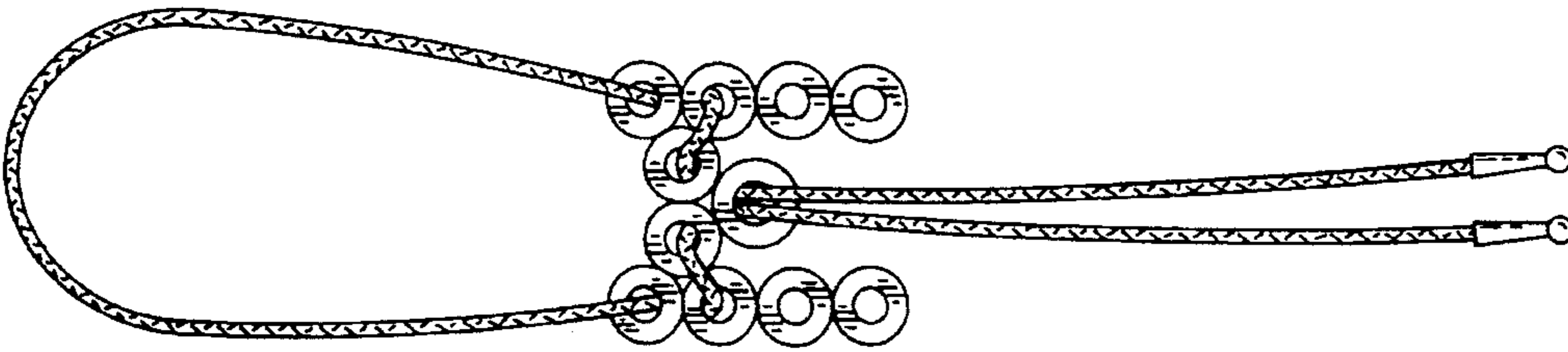

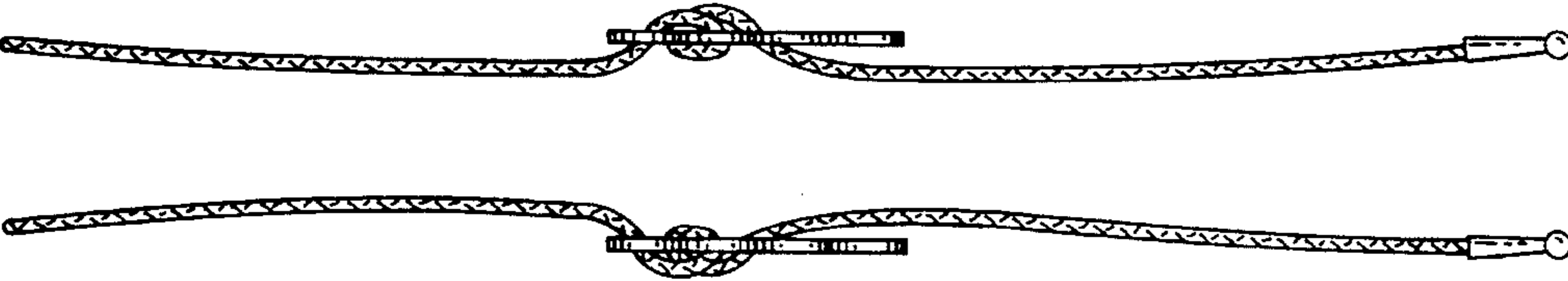

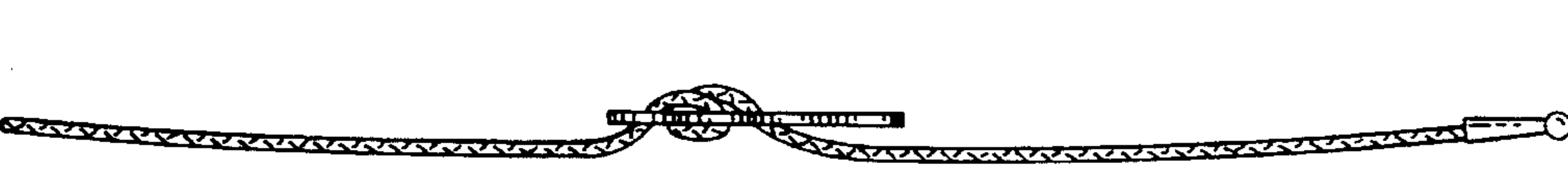

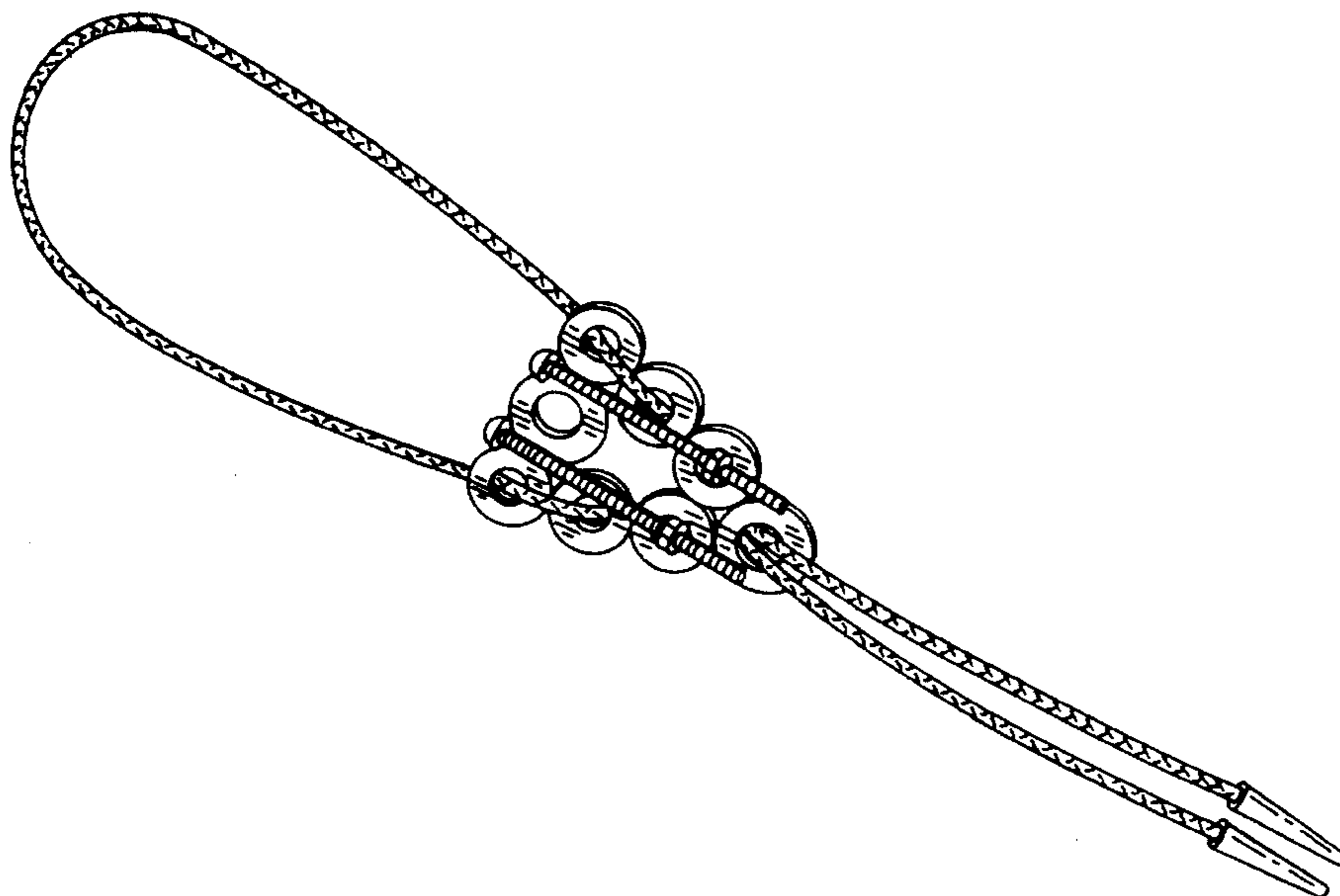

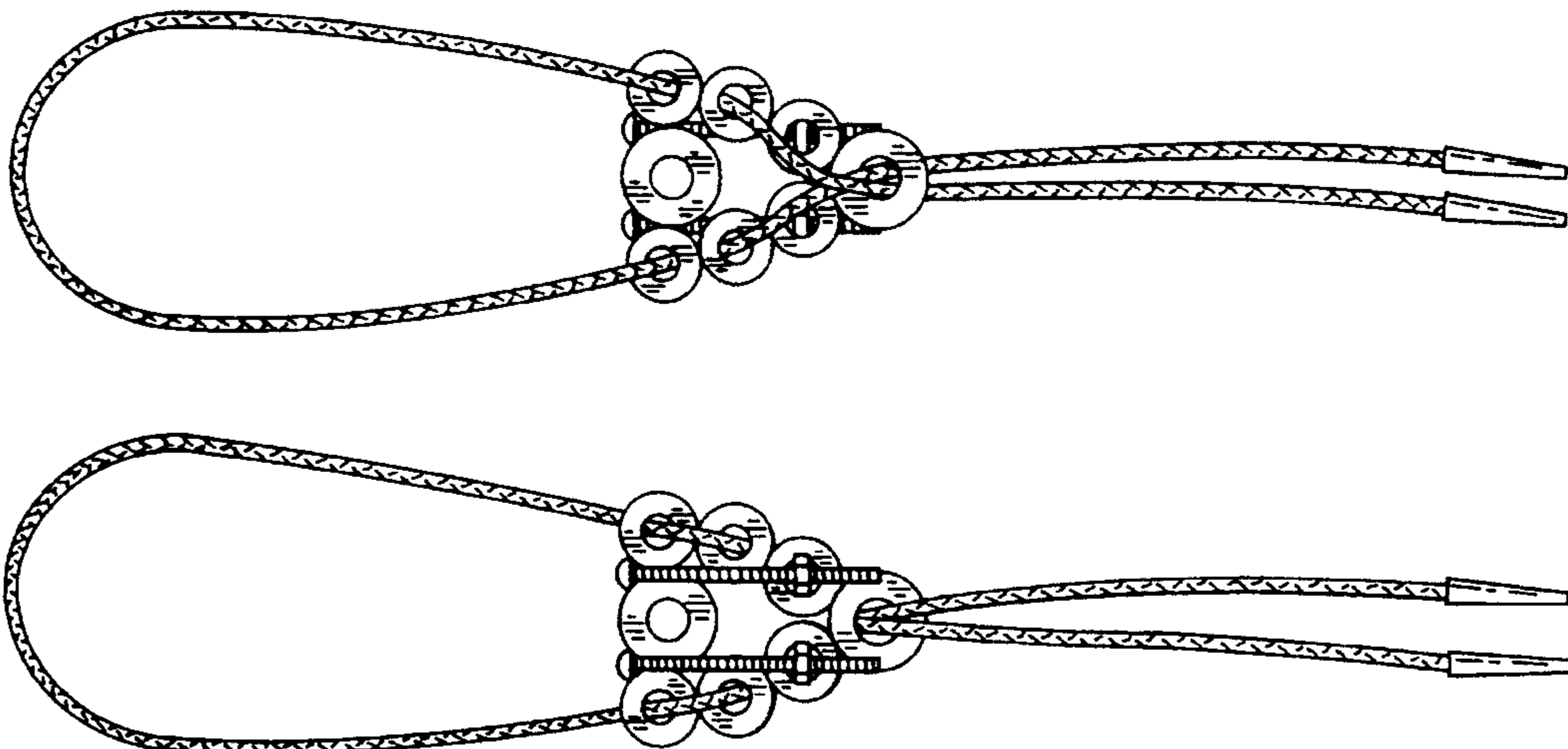

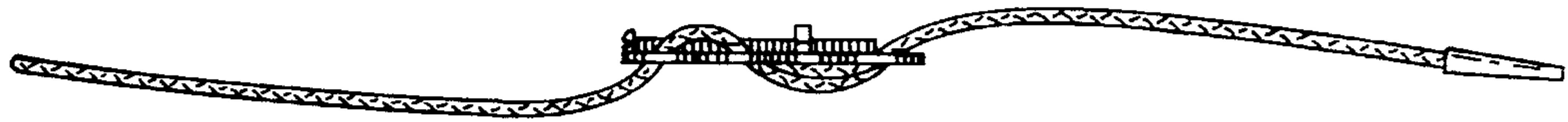

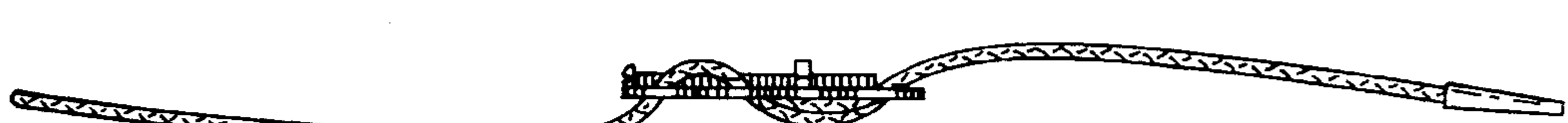

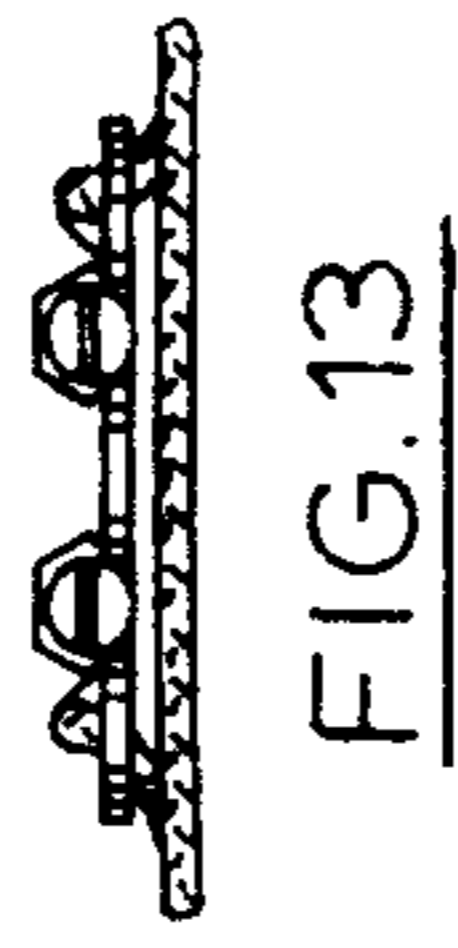

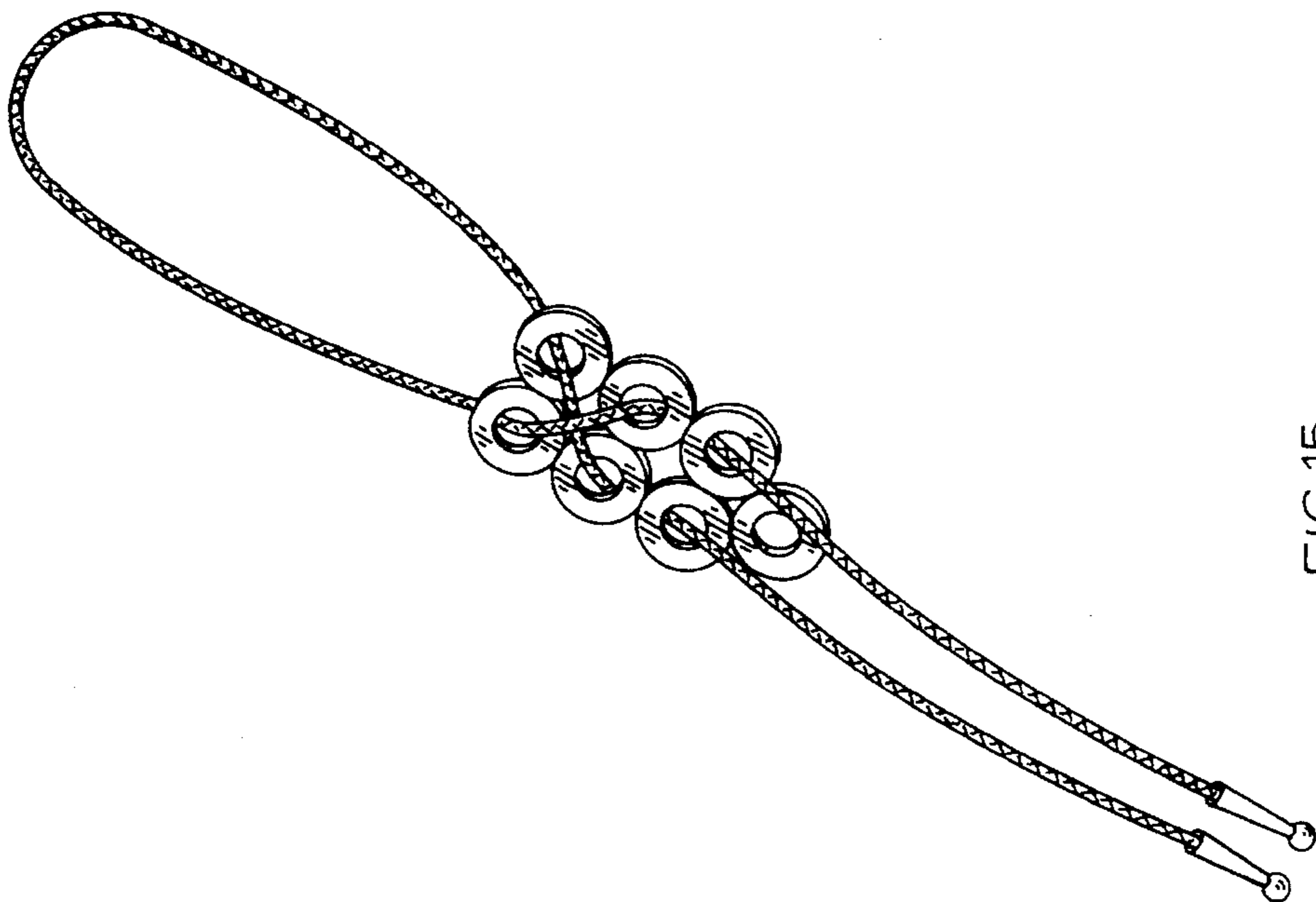

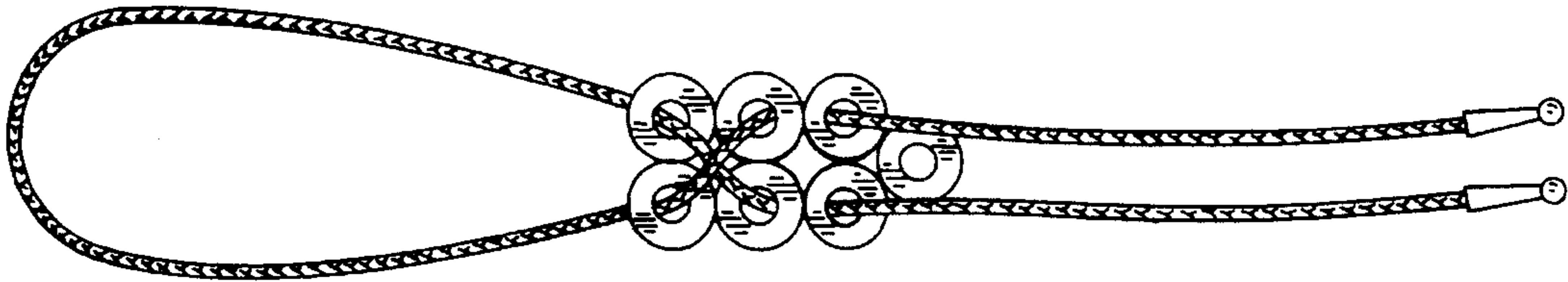

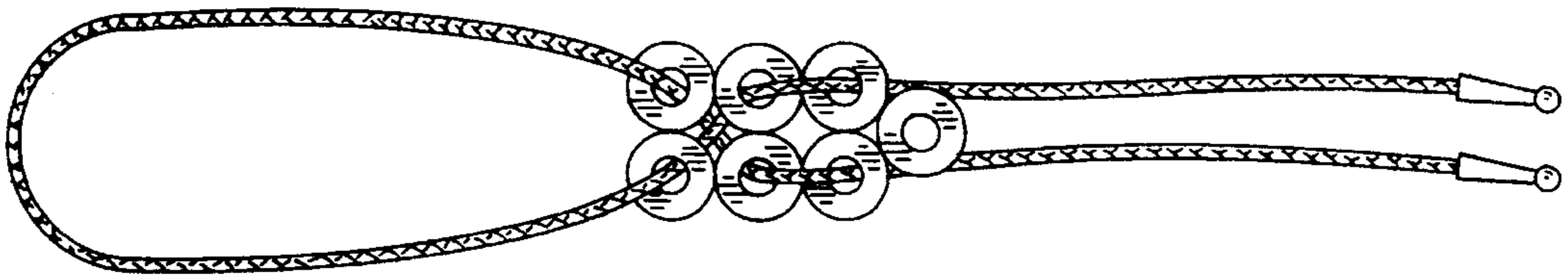

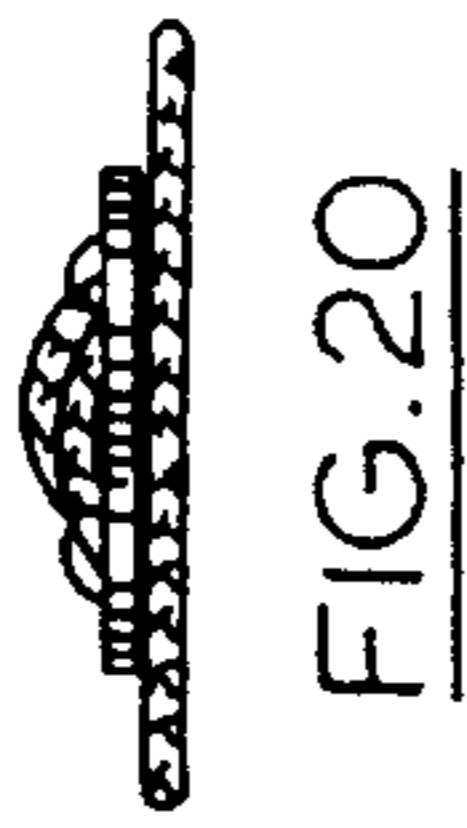

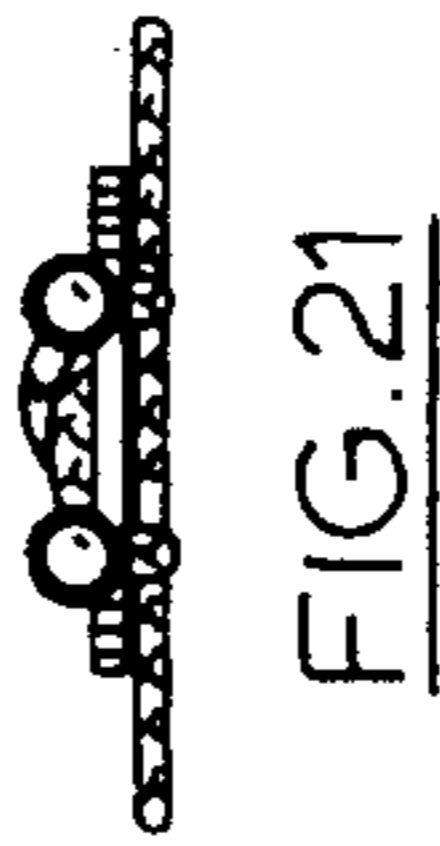
