[57] **CLAIM**

The ornamental design for a massage chair, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a massage chair showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a perspective view of the massage chair;
FIG. 8 is a left side elevational view showing the massage chair when the footrest is extended;
FIG. 9 is a left side elevational view showing the massage chair when the backrest is inclined rearward;
FIG. 10 is a left side elevational view showing the massage chair when the backrest is folded forward; and,
FIG. 11 is a perspective view illustrating how an individual, shown in phantom, uses the massage chair.
The broken lines showing of a human form in FIG. 11 is for environmental purposes only and forms no part of the claimed design.

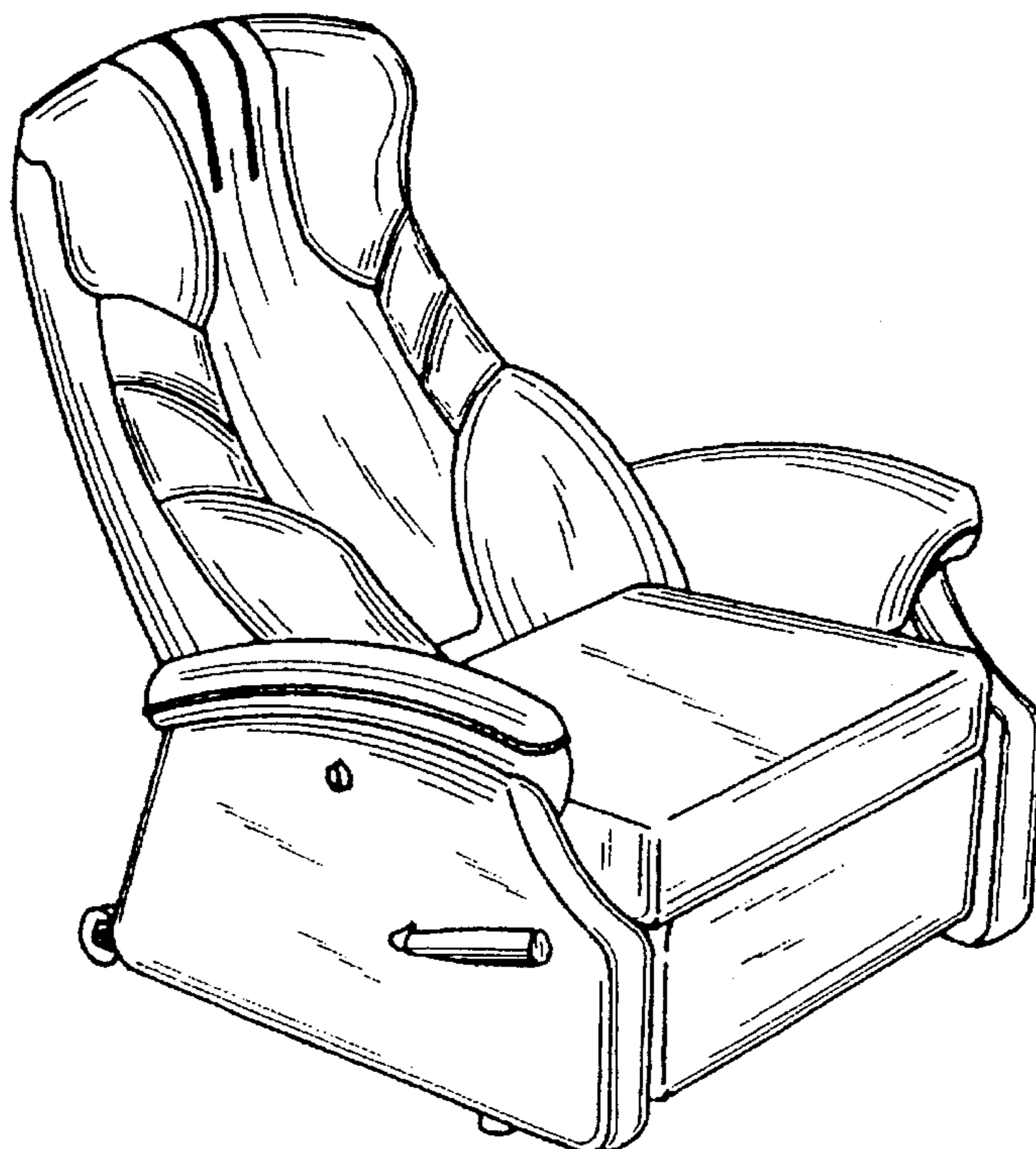

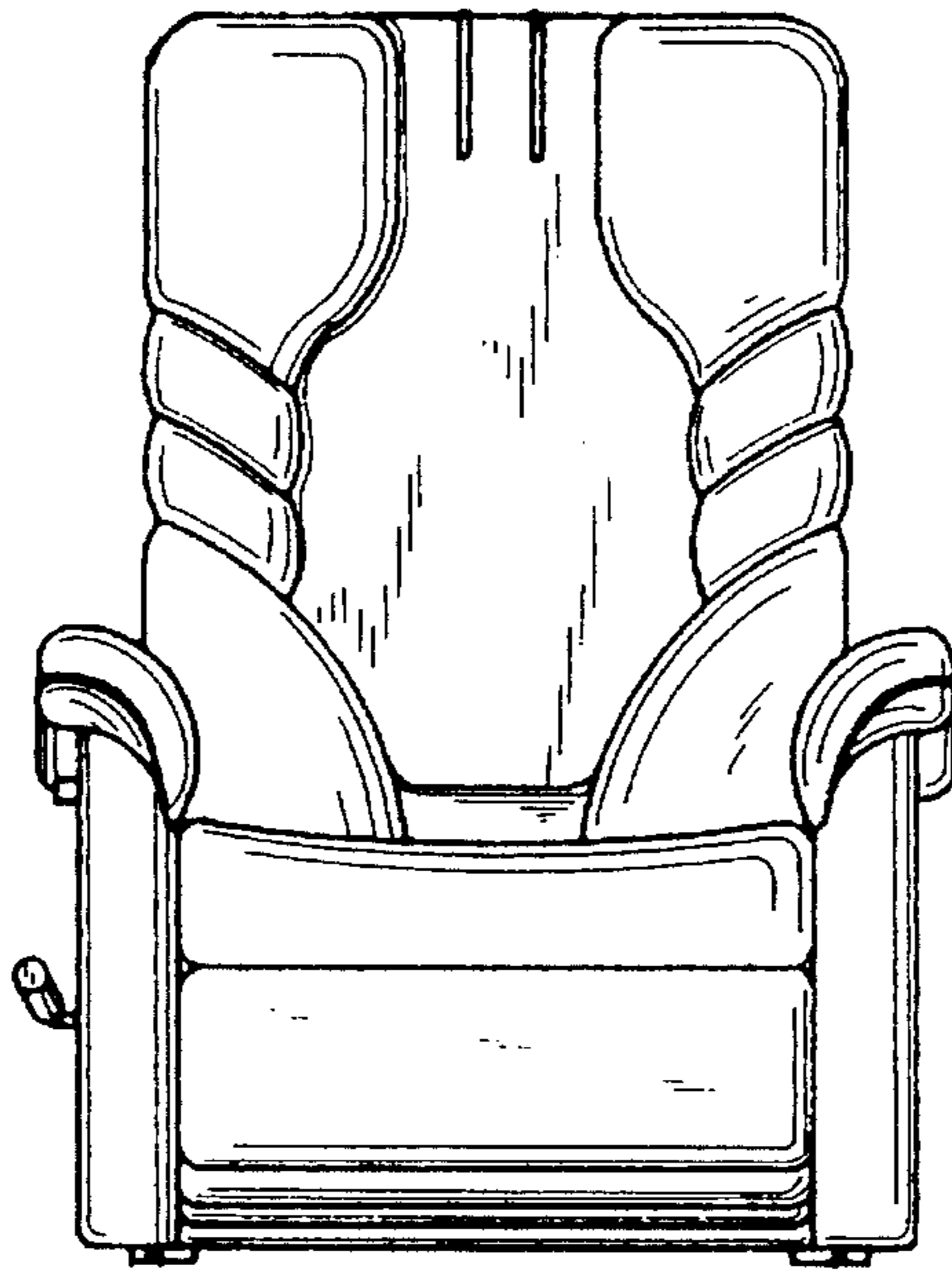

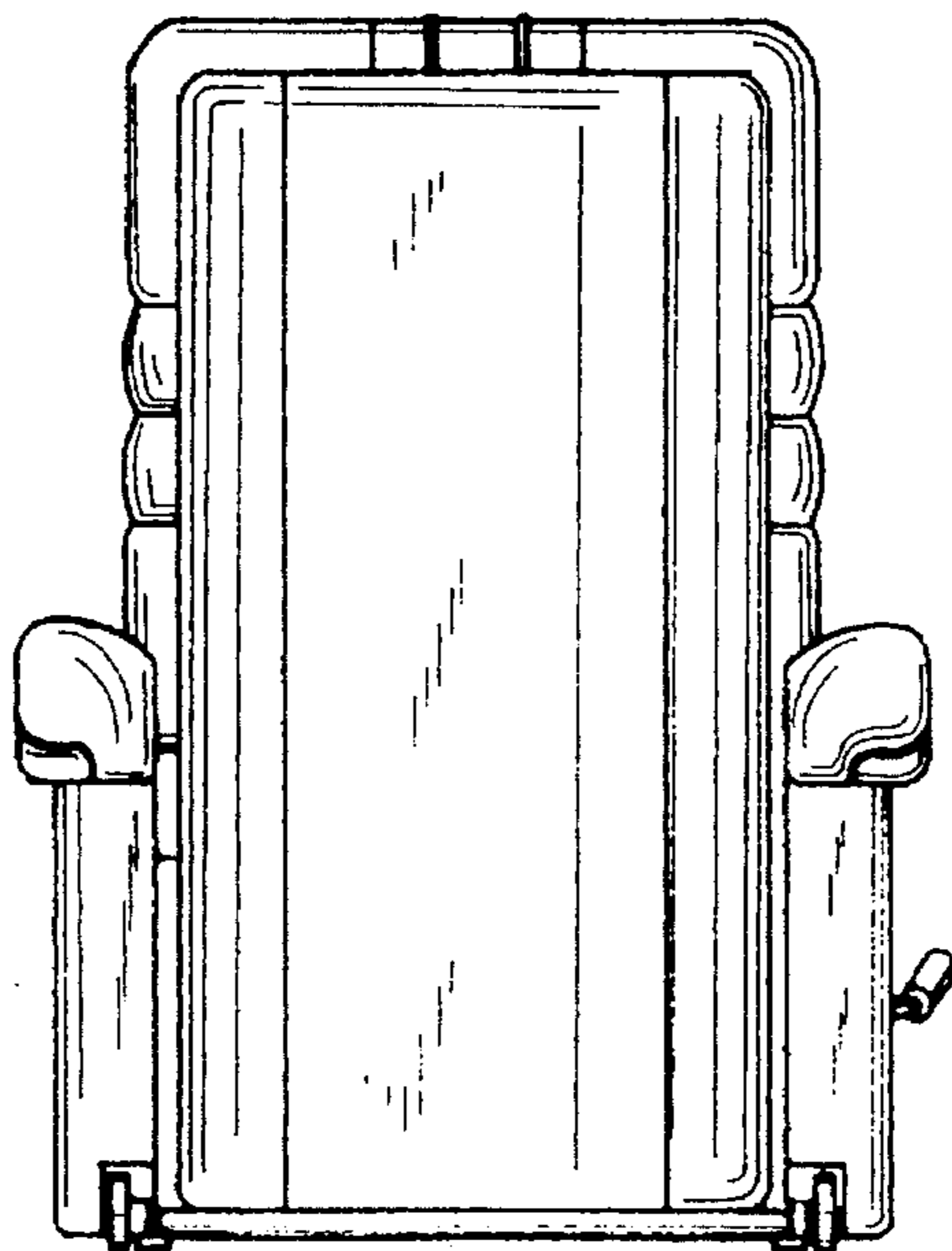

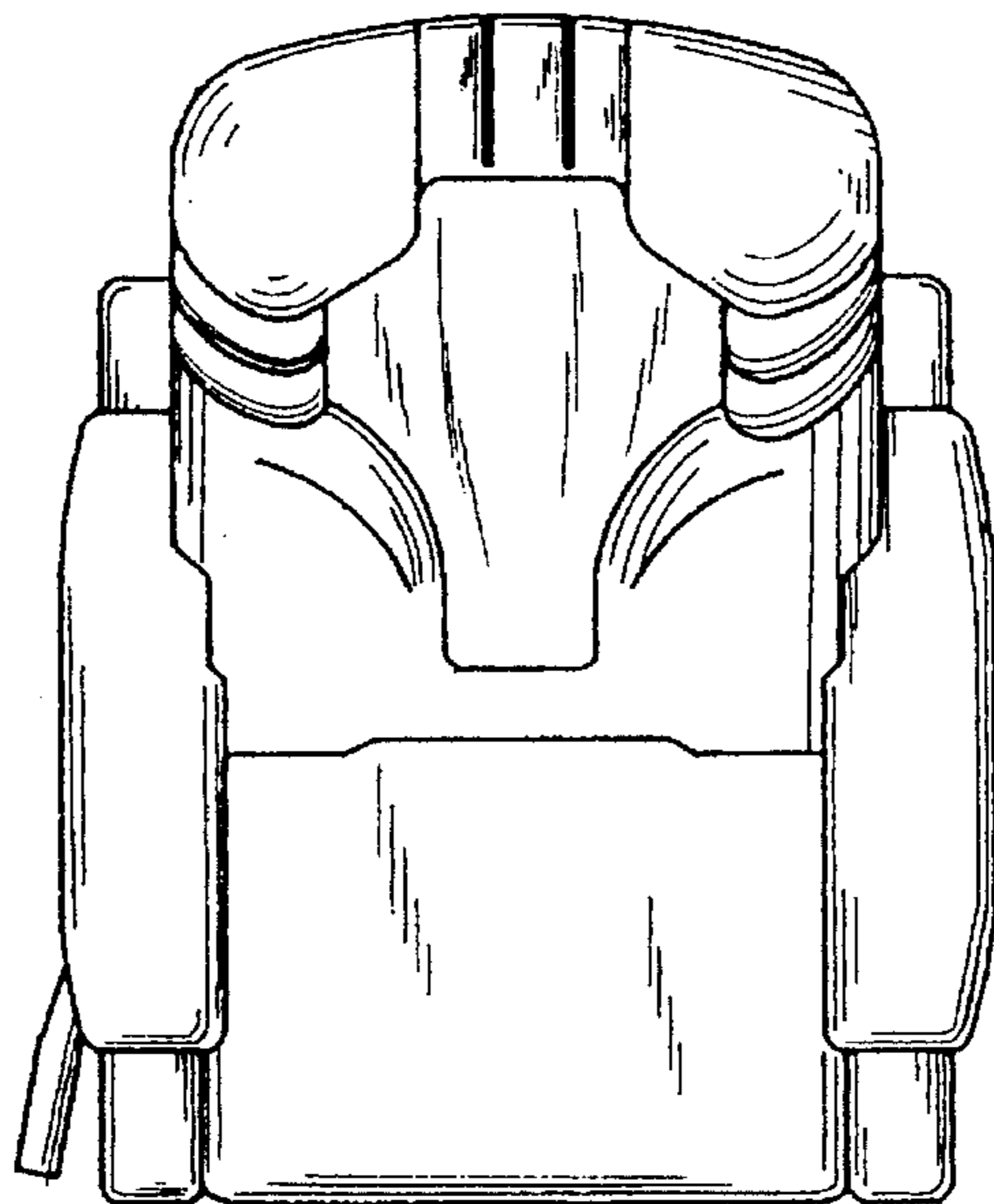

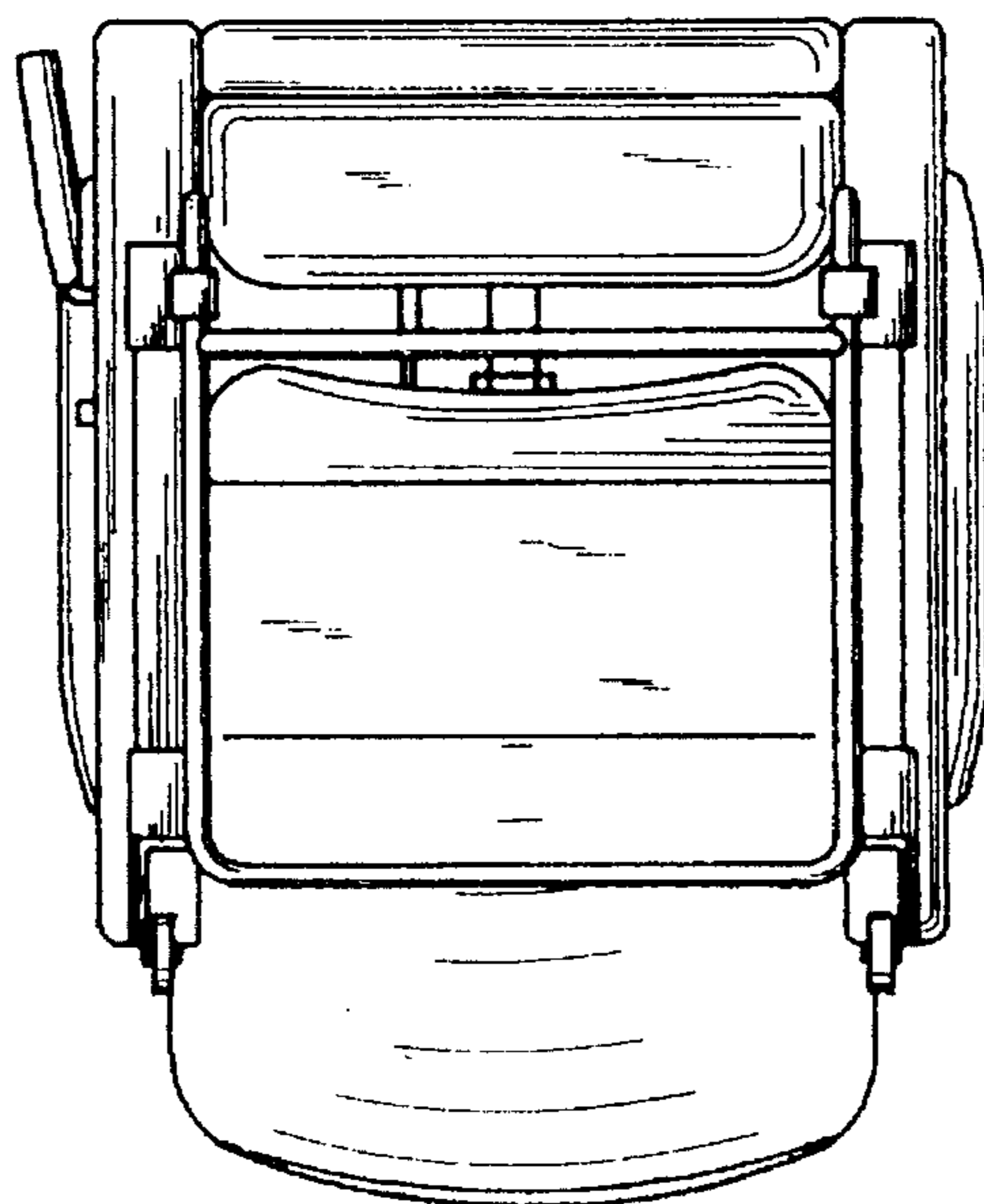

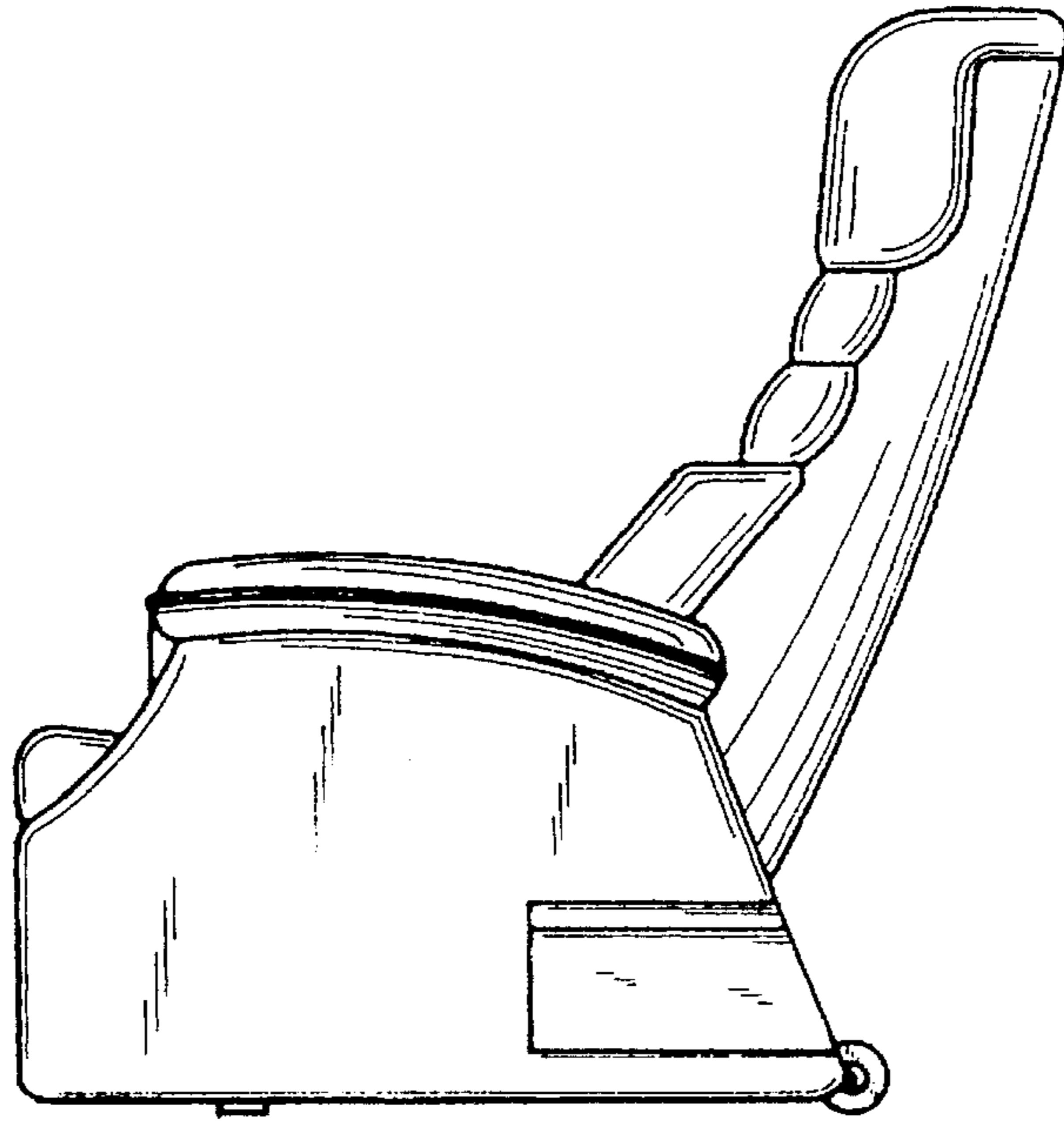

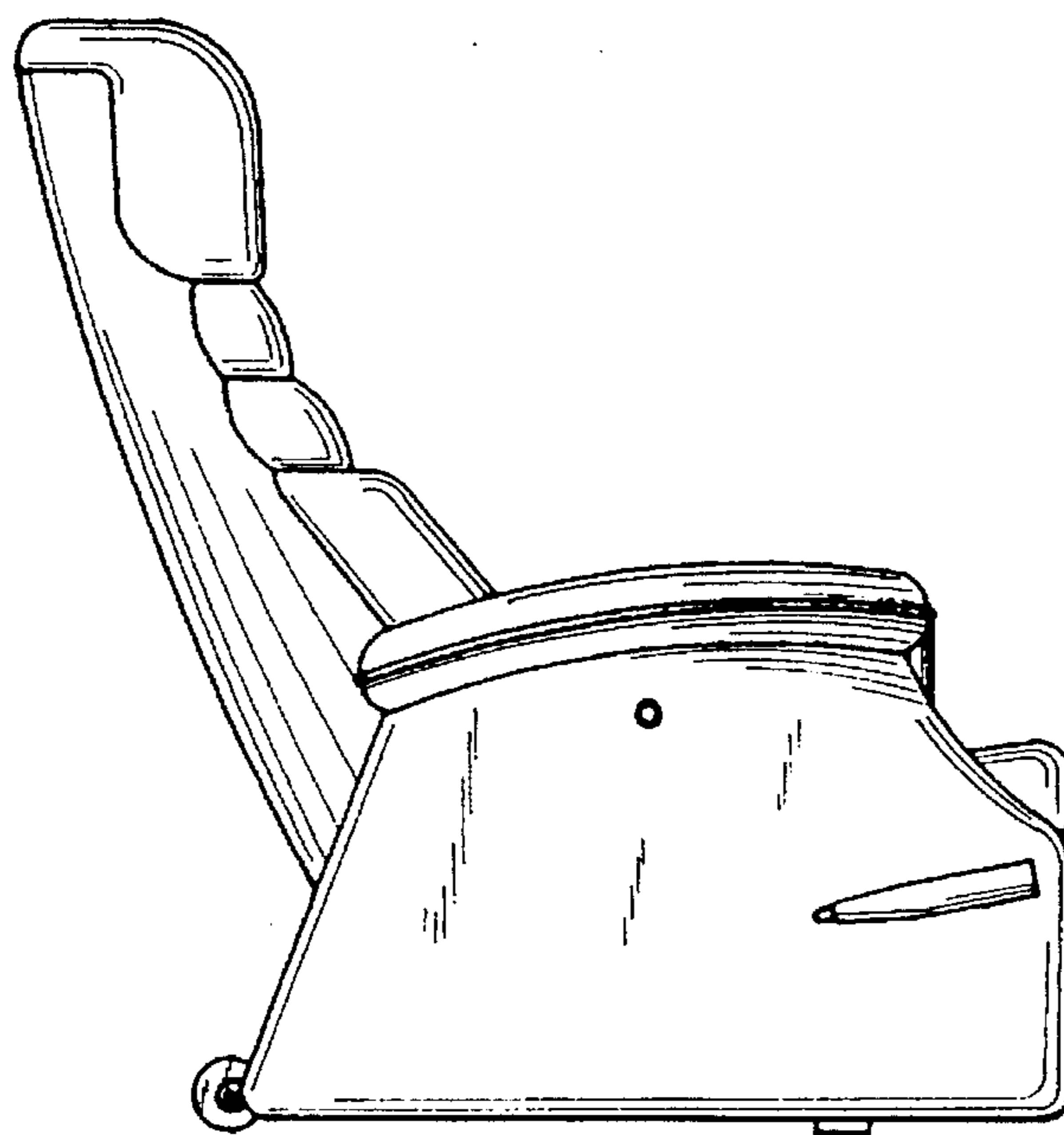

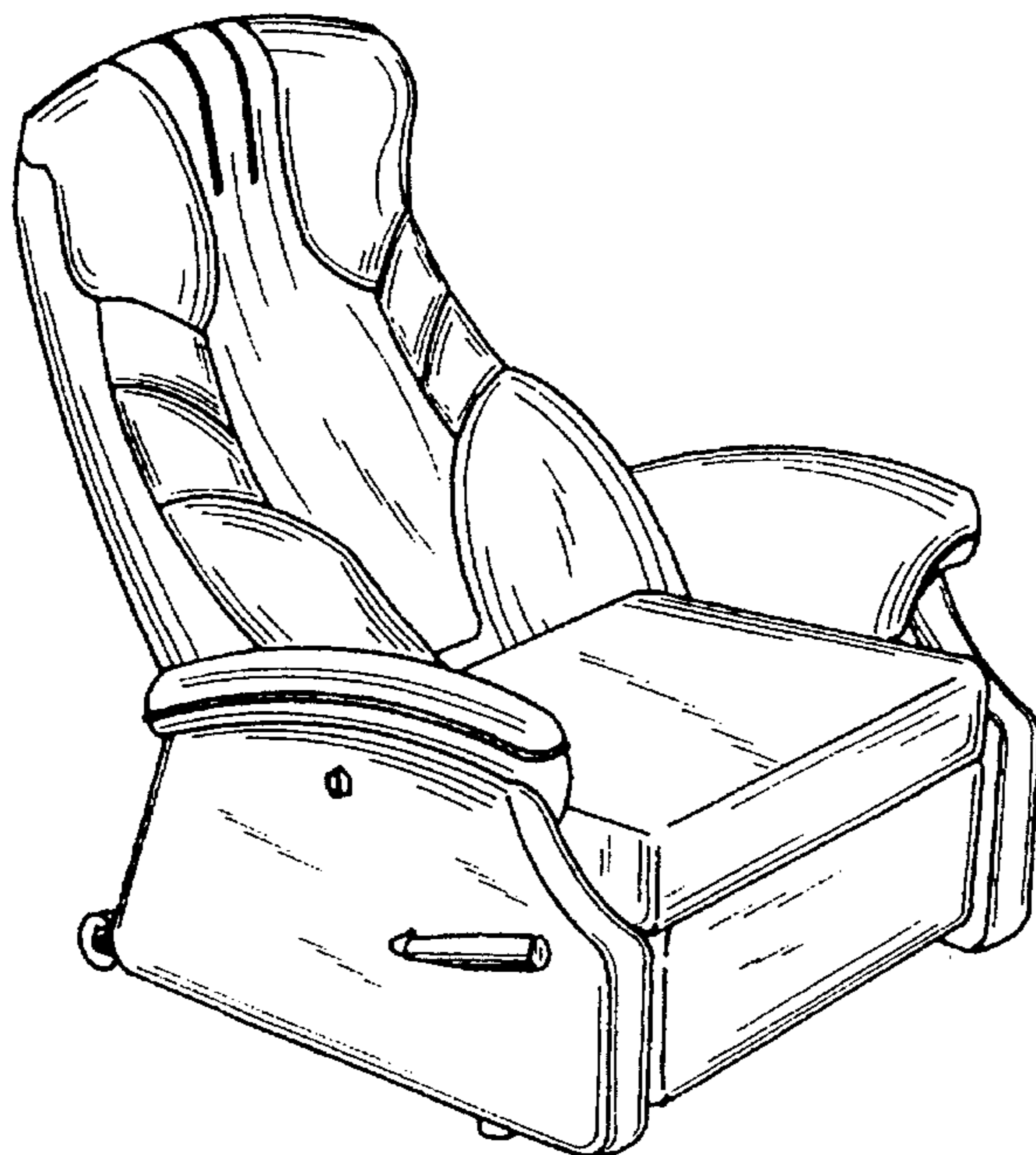

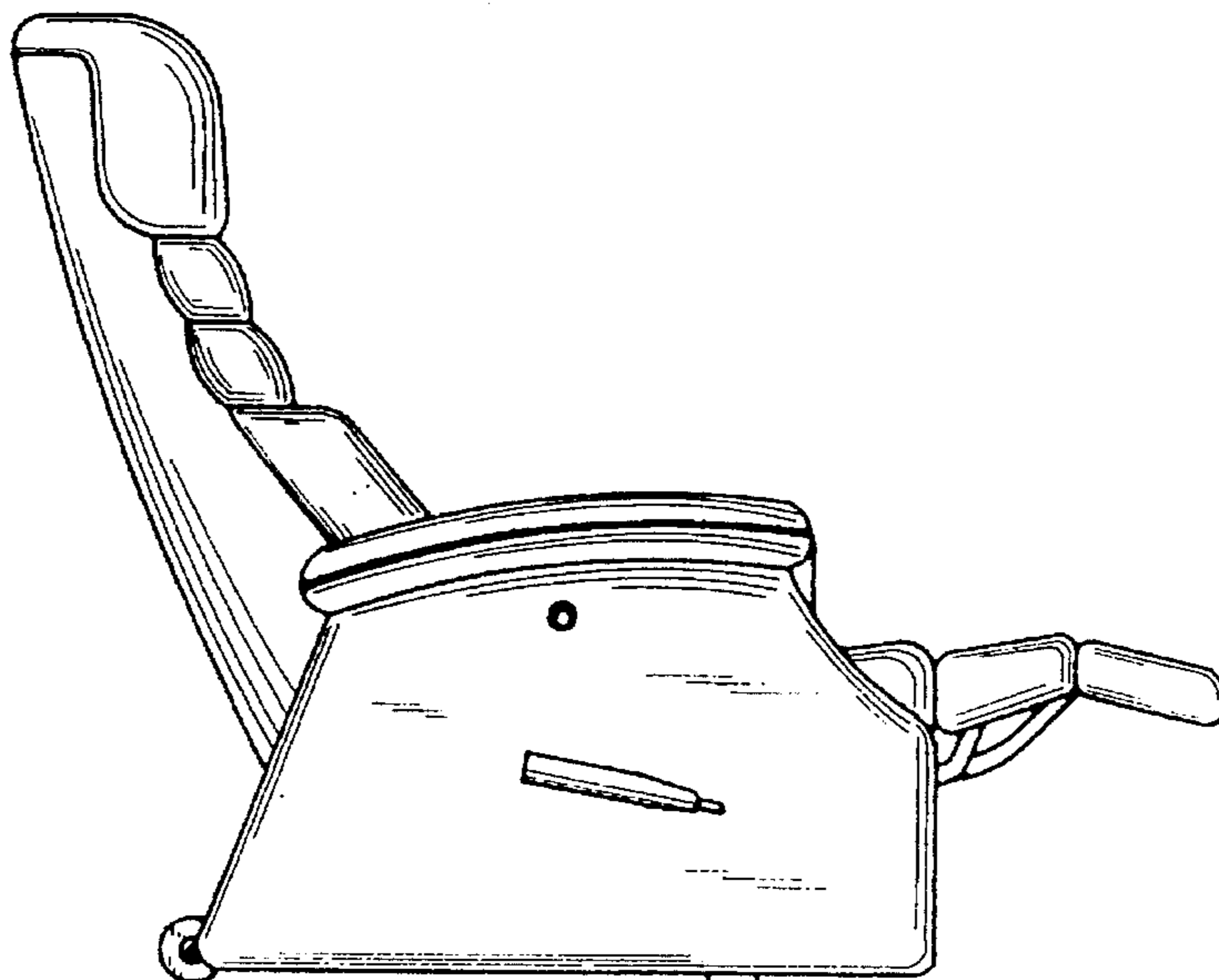

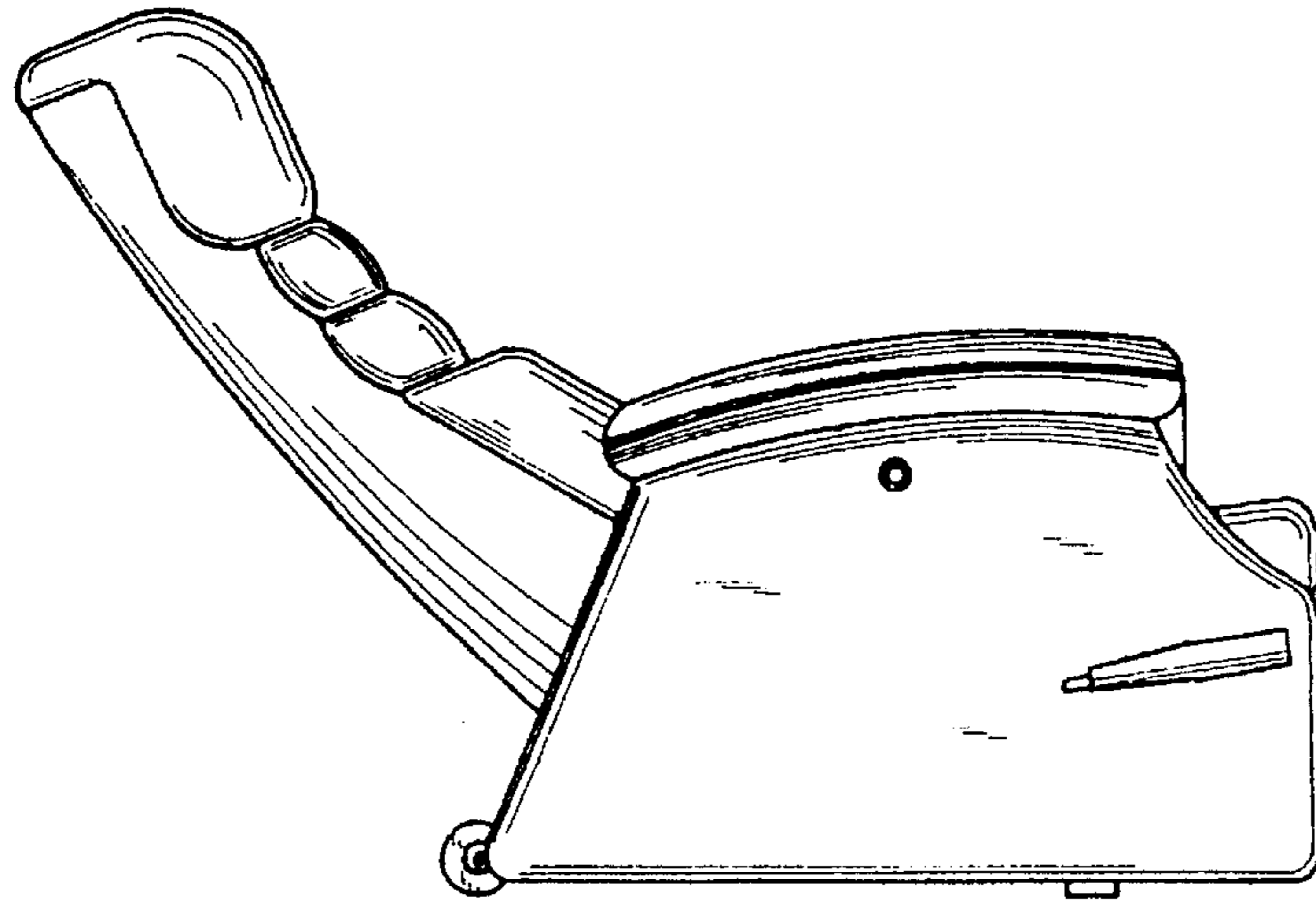
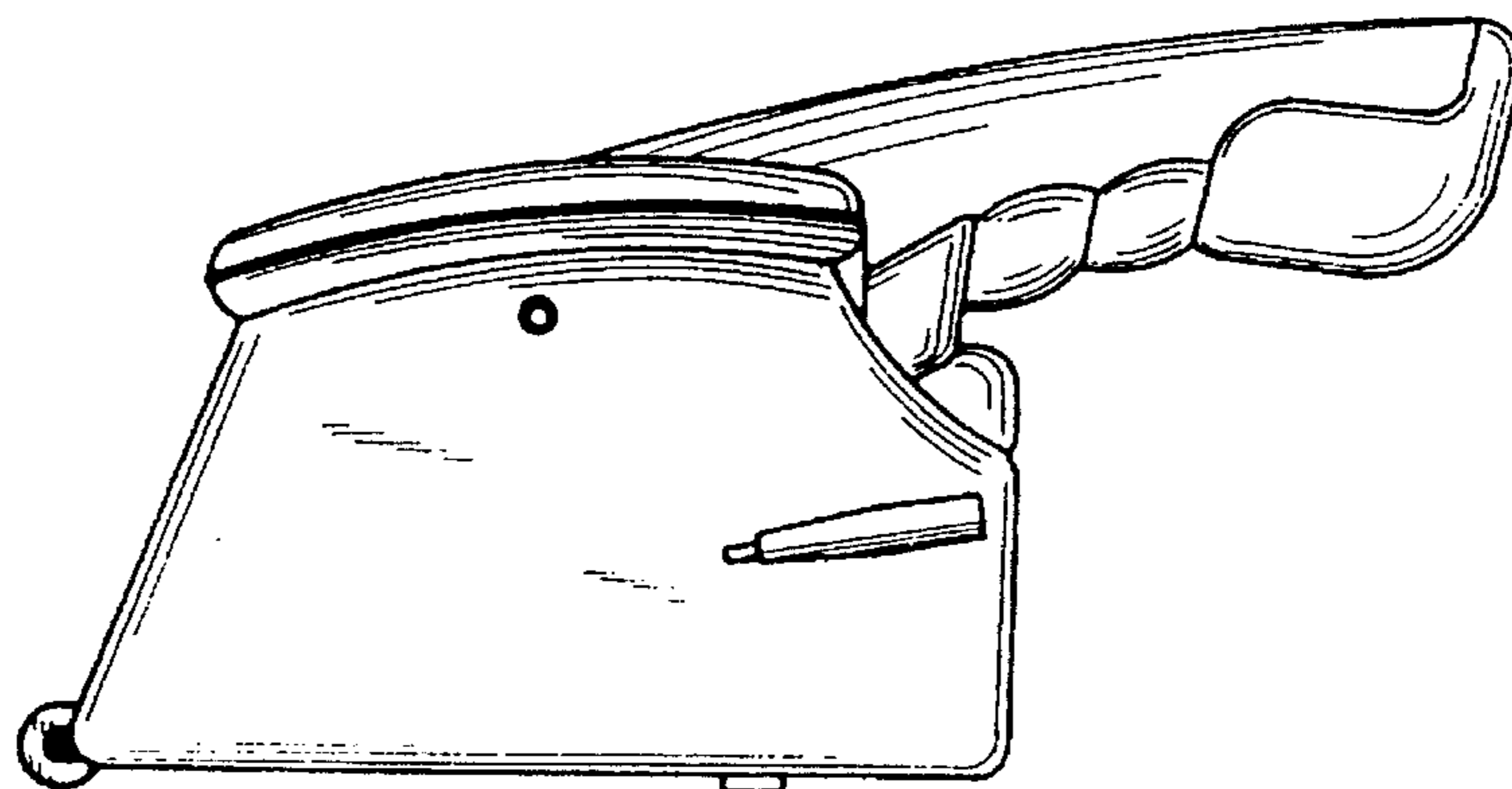

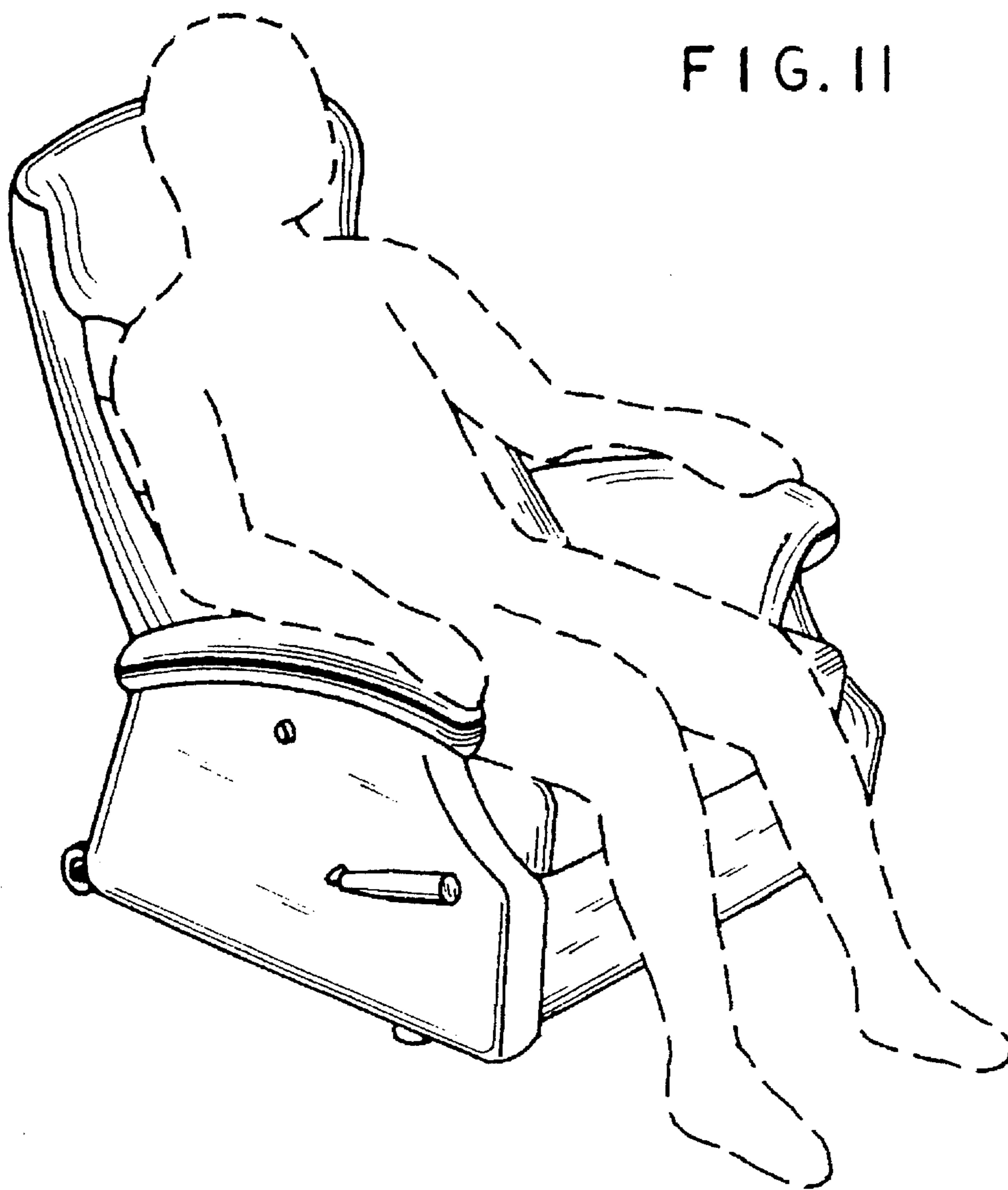
