FIG. 1 is a top plan view of a folding table showing the new design;
FIG. 2 is an end elevation thereof looking from the left of FIG. 3;
FIG. 3 is a front elevation thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a rear elevation thereof;
FIG. 6 is a top plan view thereof with the table folded;
FIG. 7 is a front elevation thereof with the table folded;
FIG. 8 is an end elevation thereof with the table folded, looking from the right of FIG. 7;
FIG. 9 is a bottom view thereof with the table folded; and,
FIG. 10 is a rear elevation thereof with the table folded.
The end elevations looking from the right of FIG. 1 and the left of FIG. 7 are mirror images of FIG. 2 and 8, respectively.

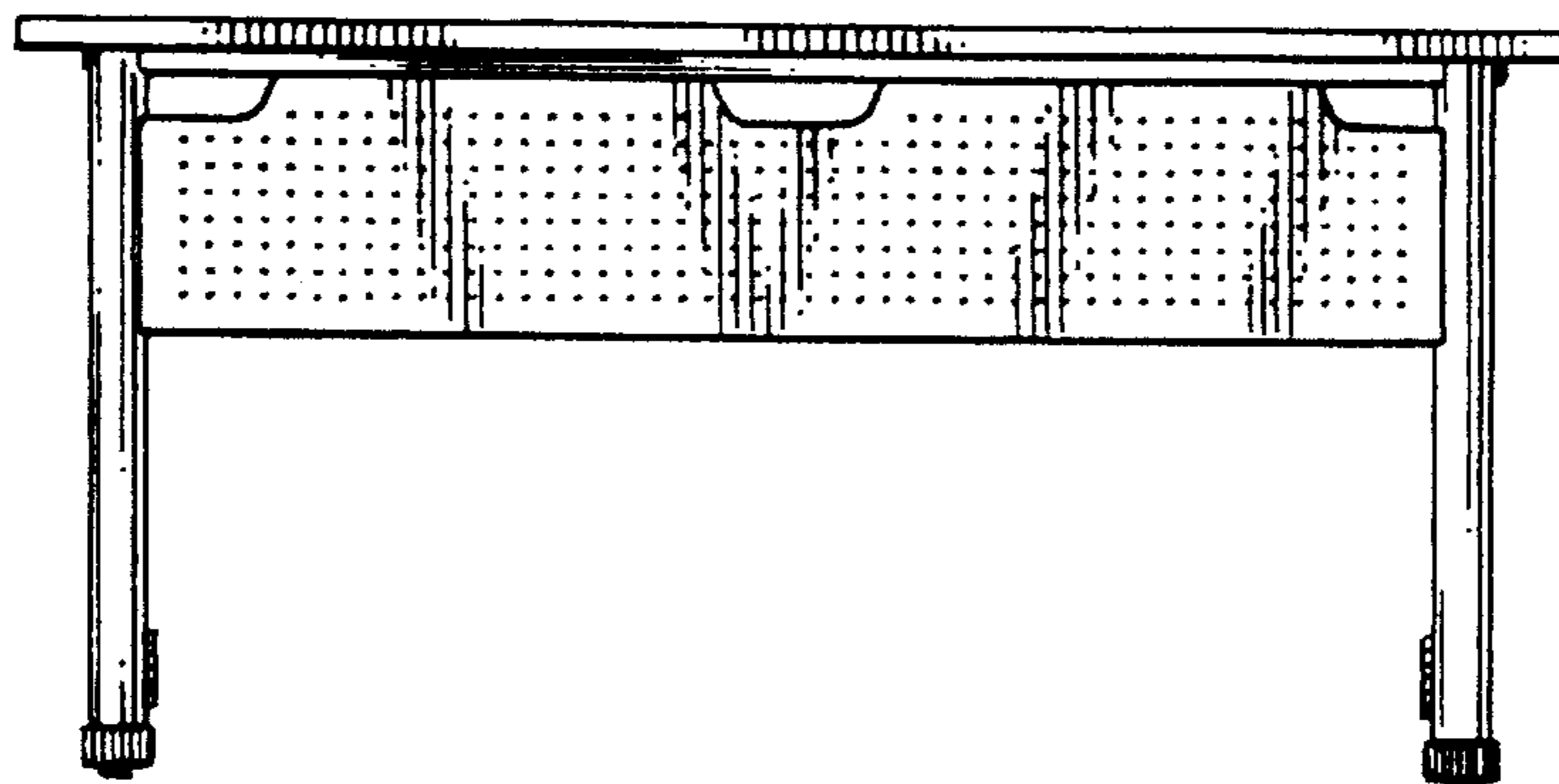
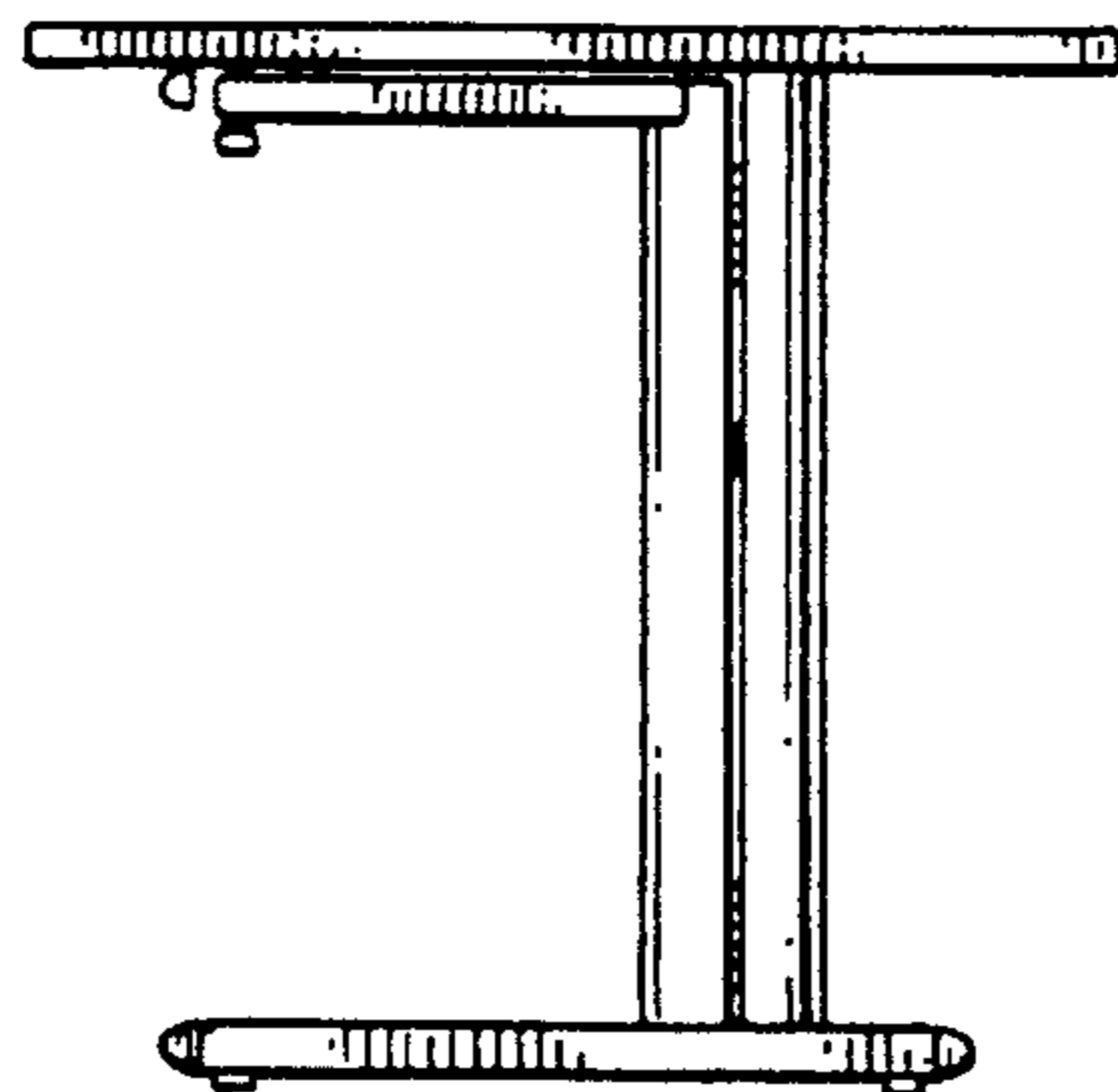

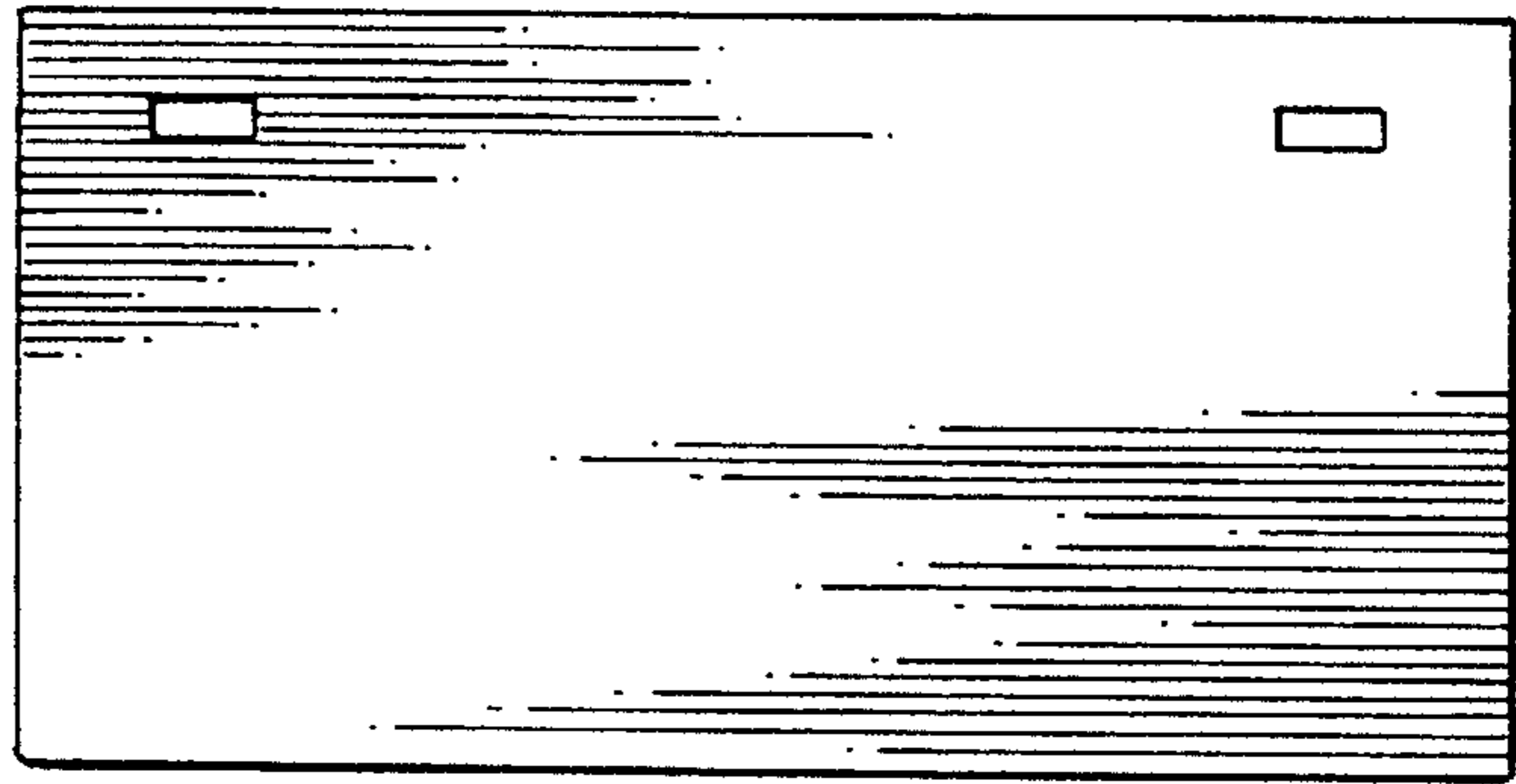

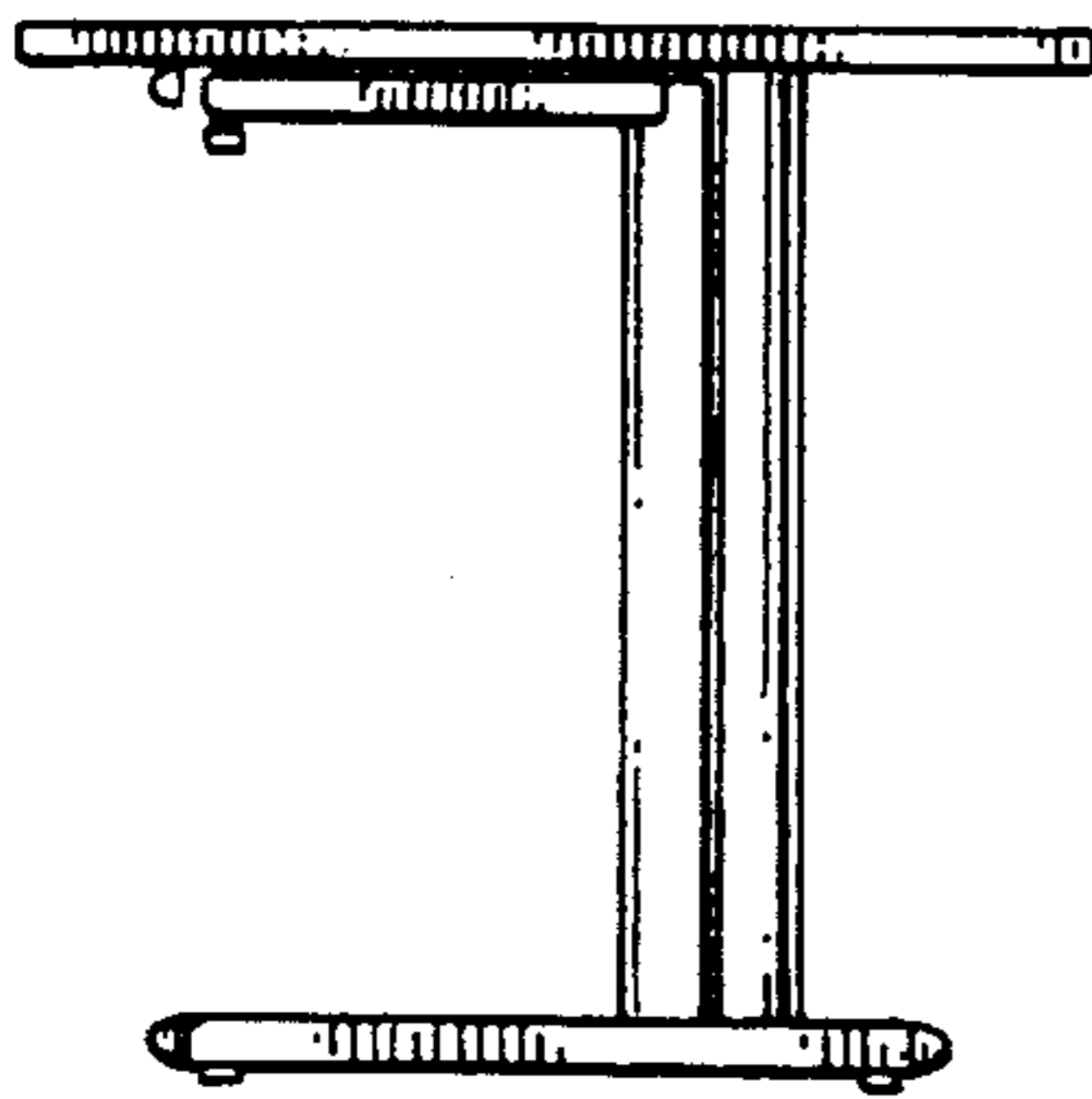

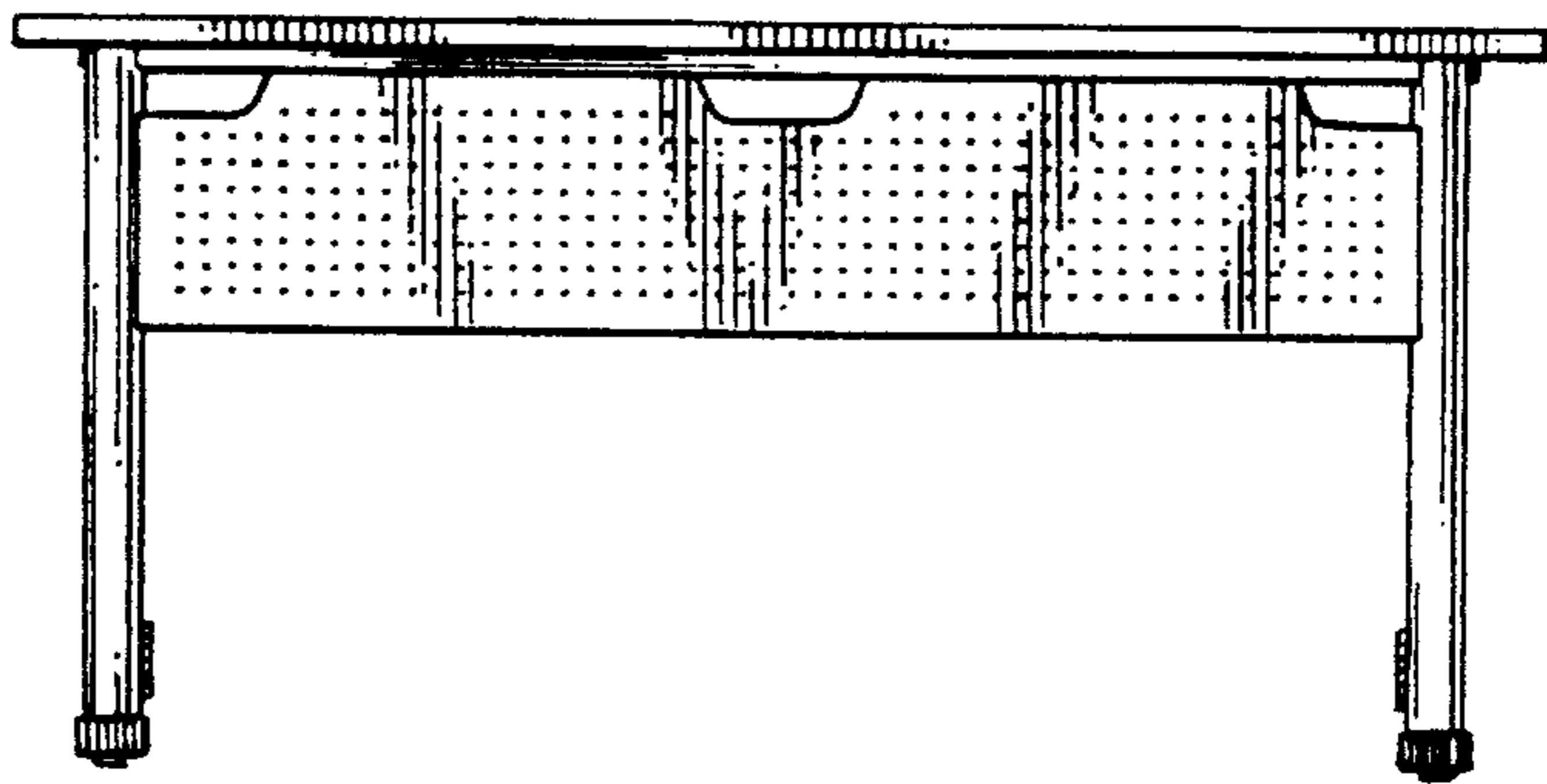

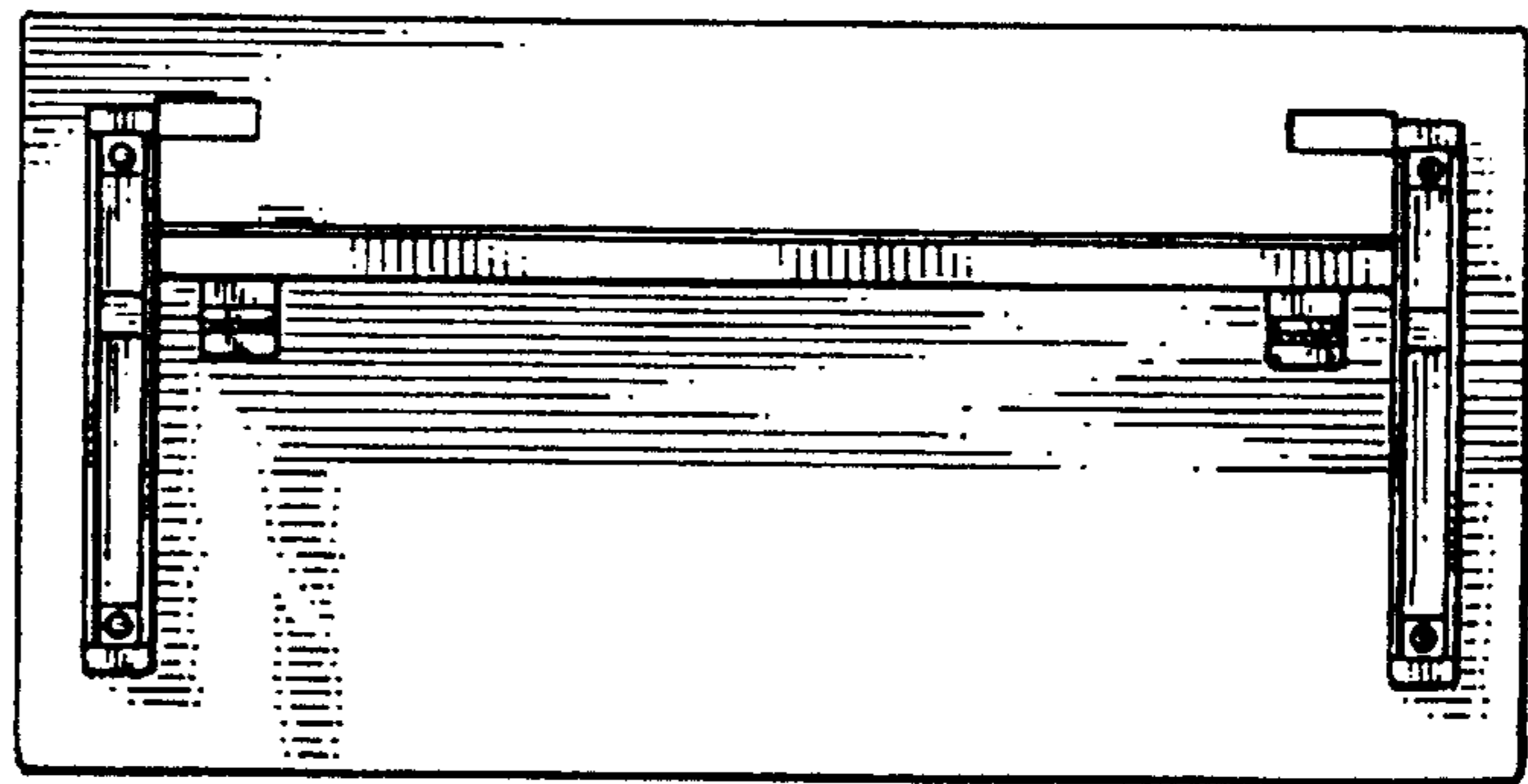
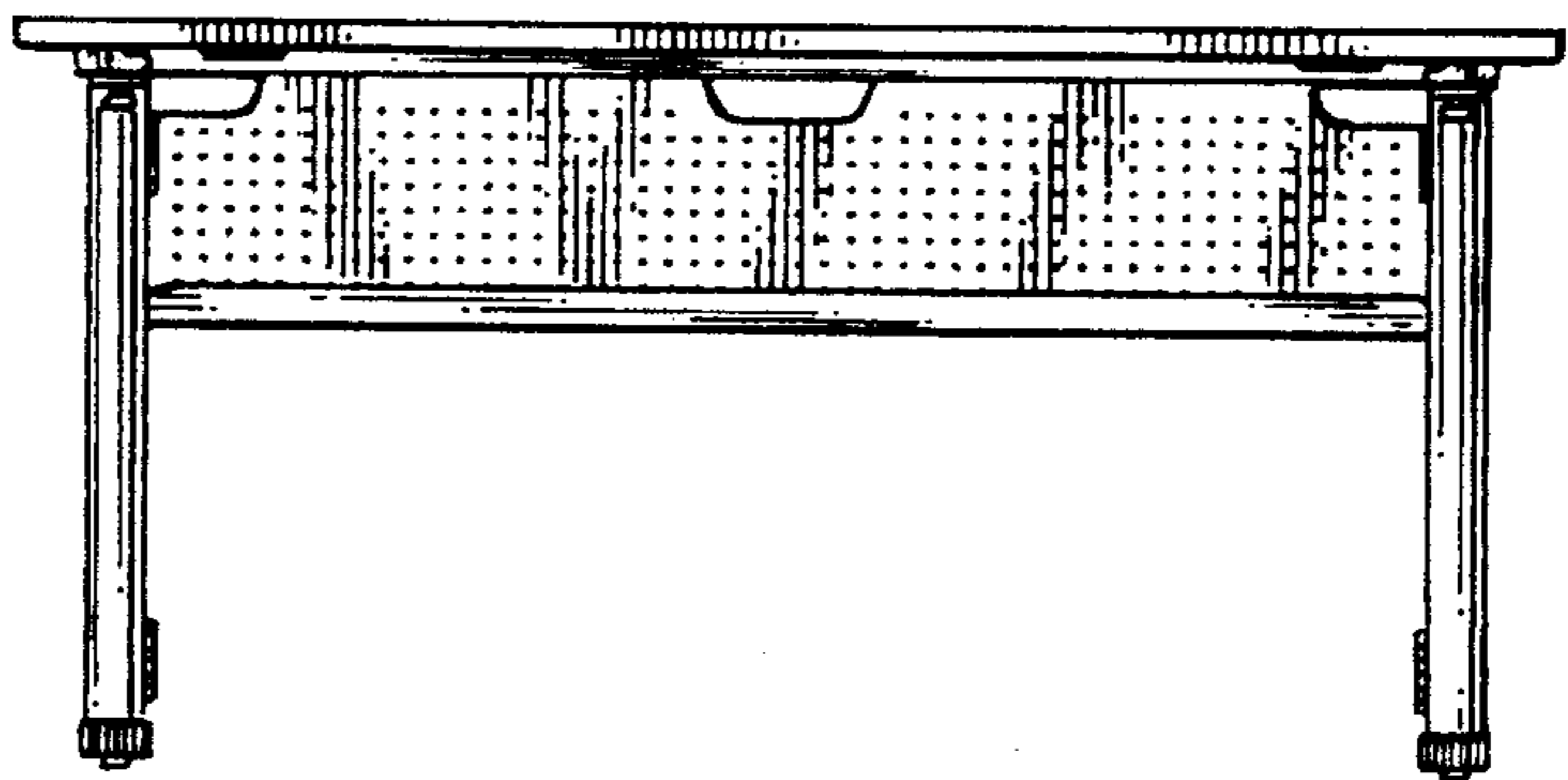

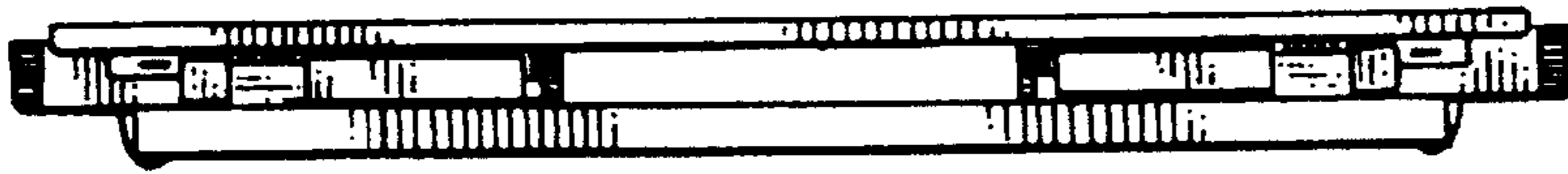

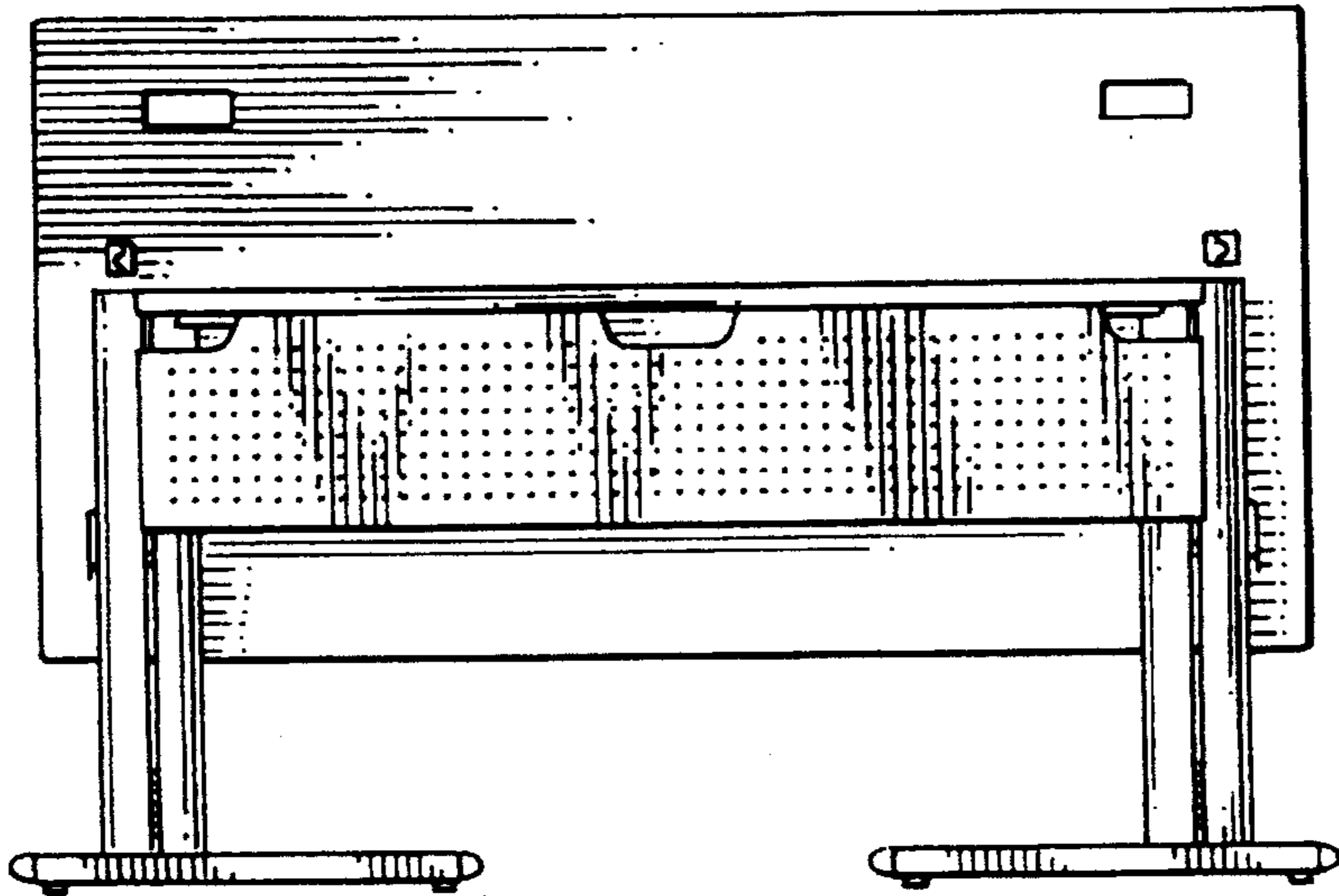

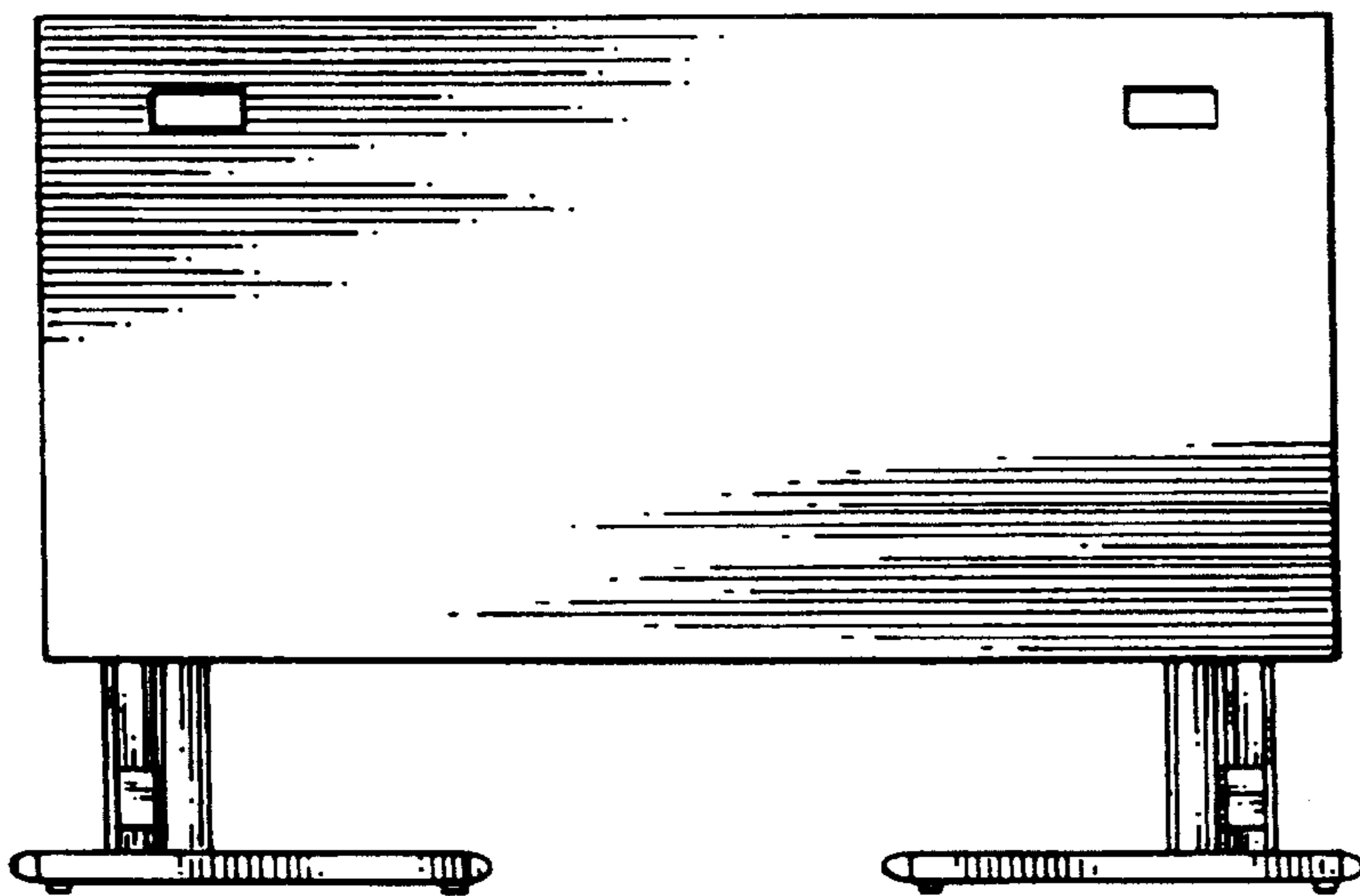
