[57] **CLAIM**

The ornamental design for a reusable beverage can grip, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a reusable beverage can grip showing my new design; FIG. 2 is a right side elevation view thereof, the opposite side being a mirror image; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a cross-sectional view taken along line 7—7 of FIG. 2; and, FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 2.

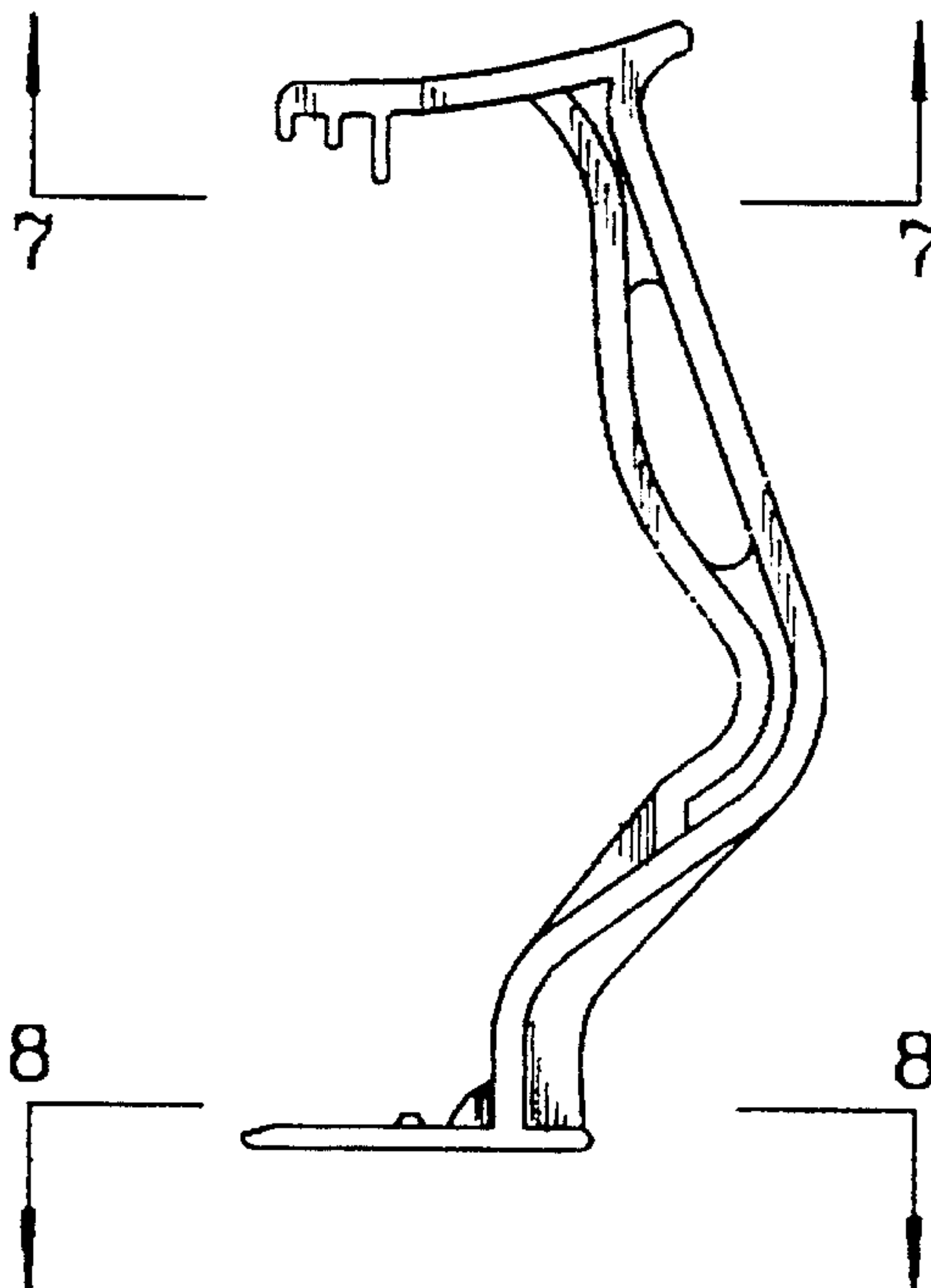
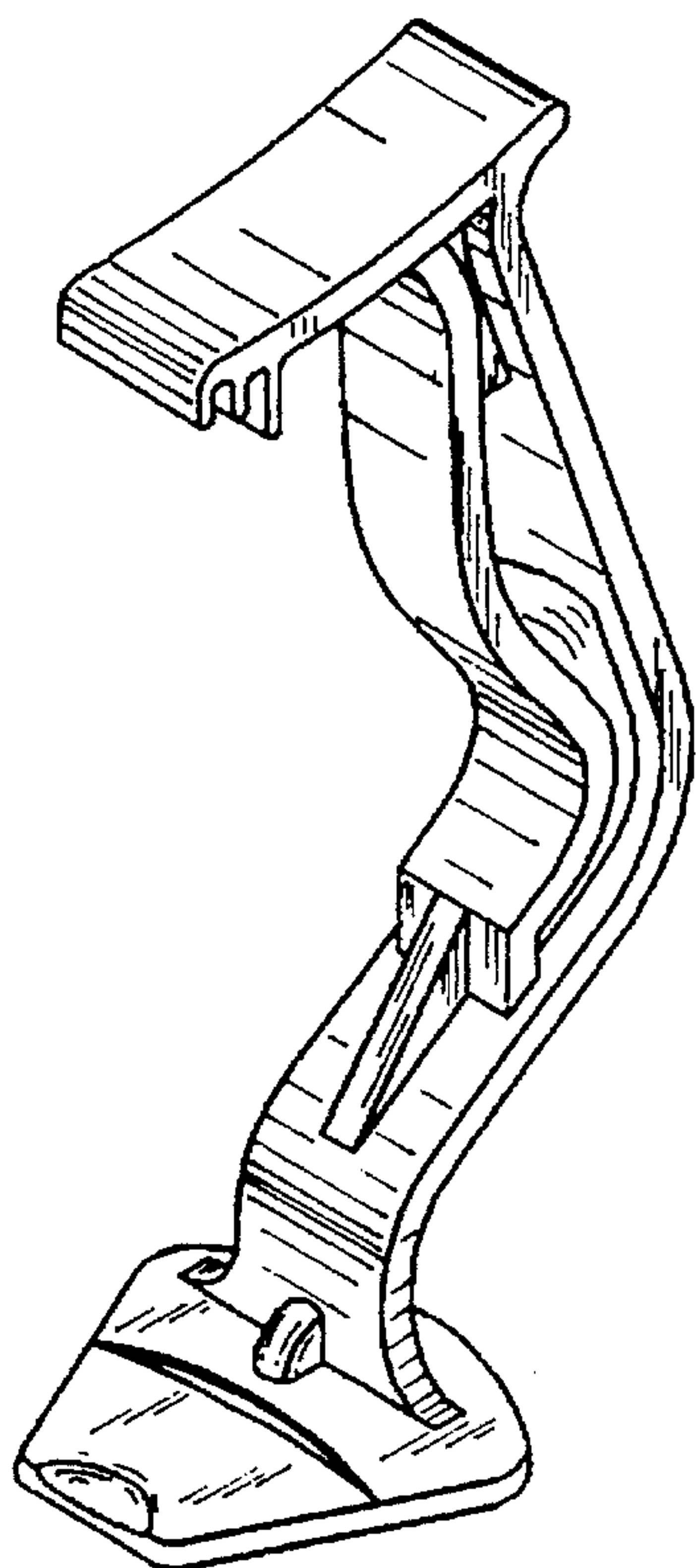

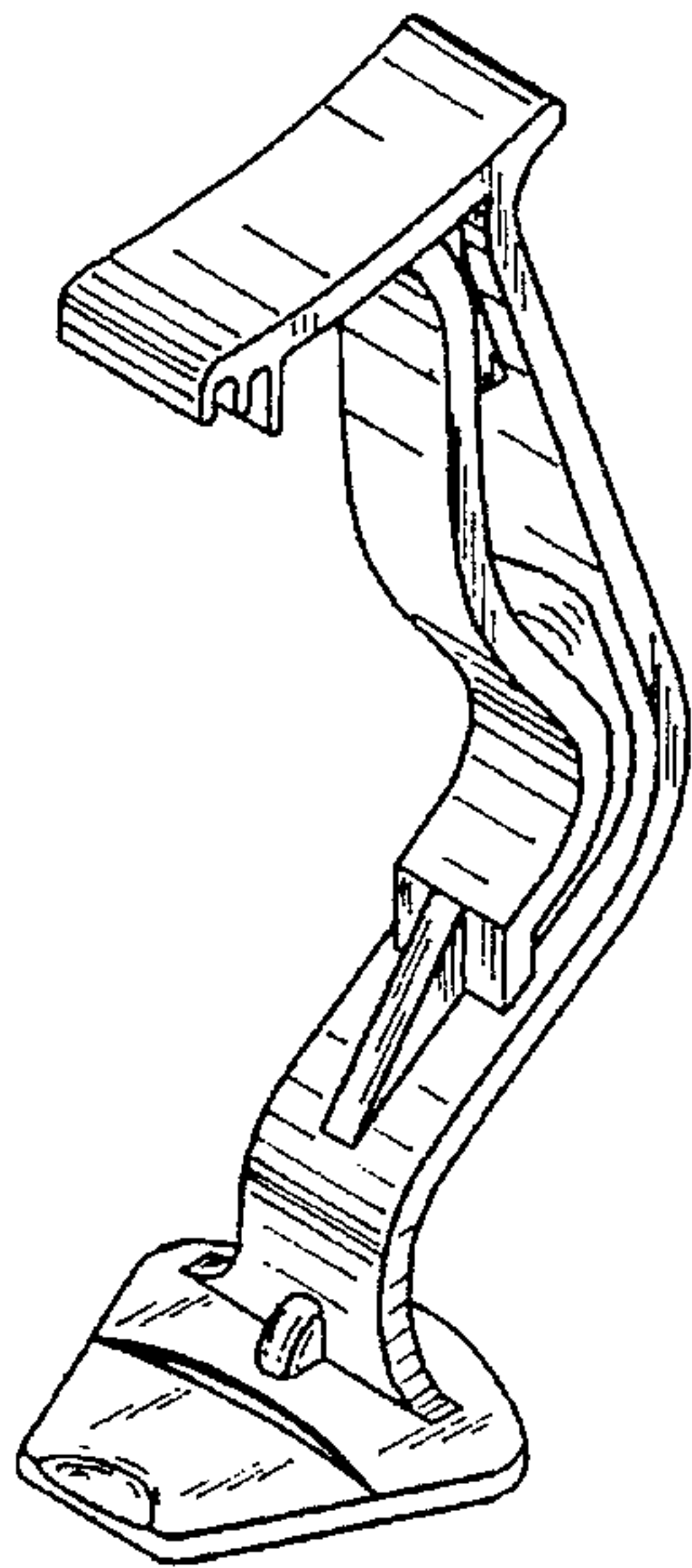

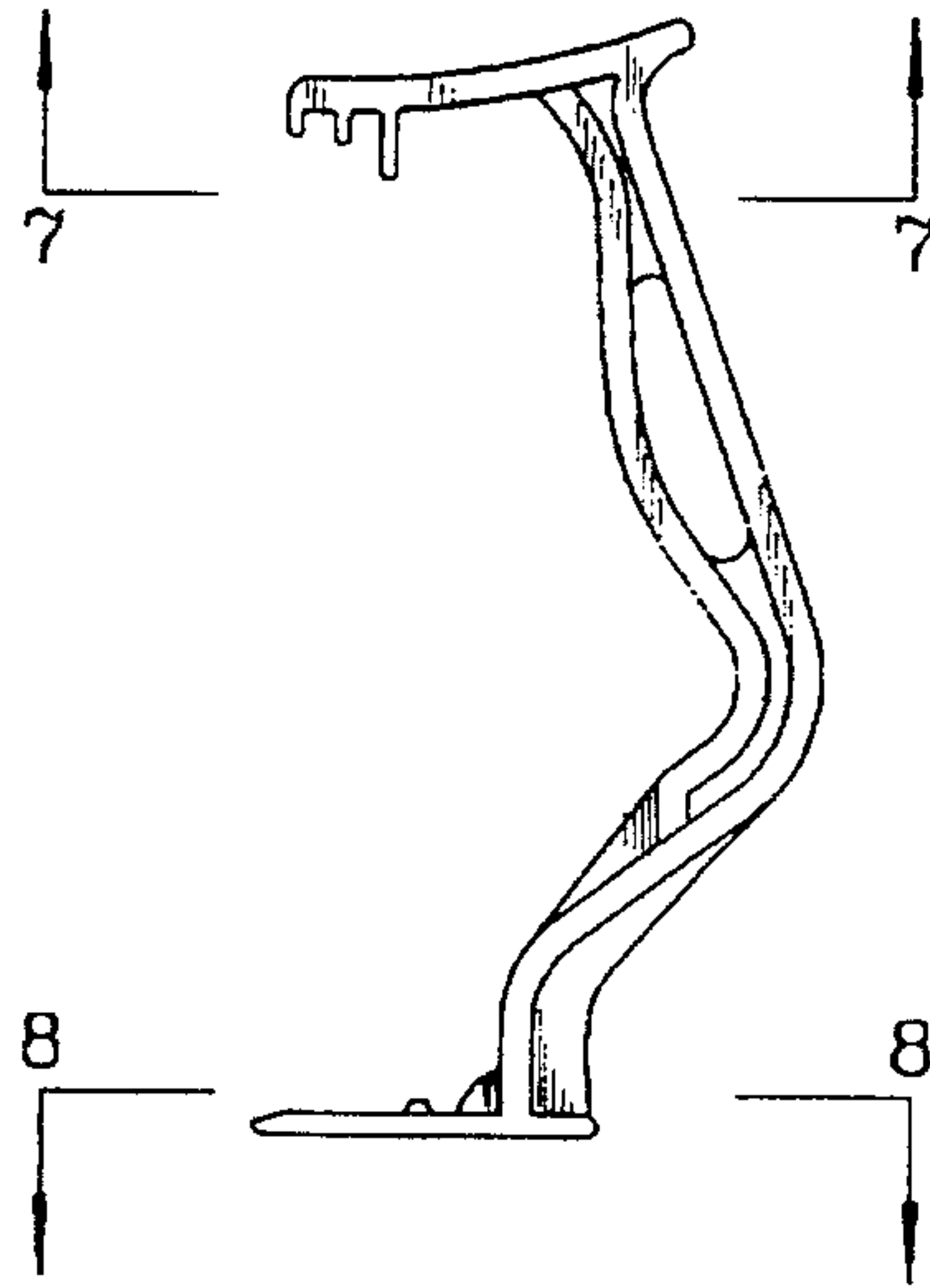

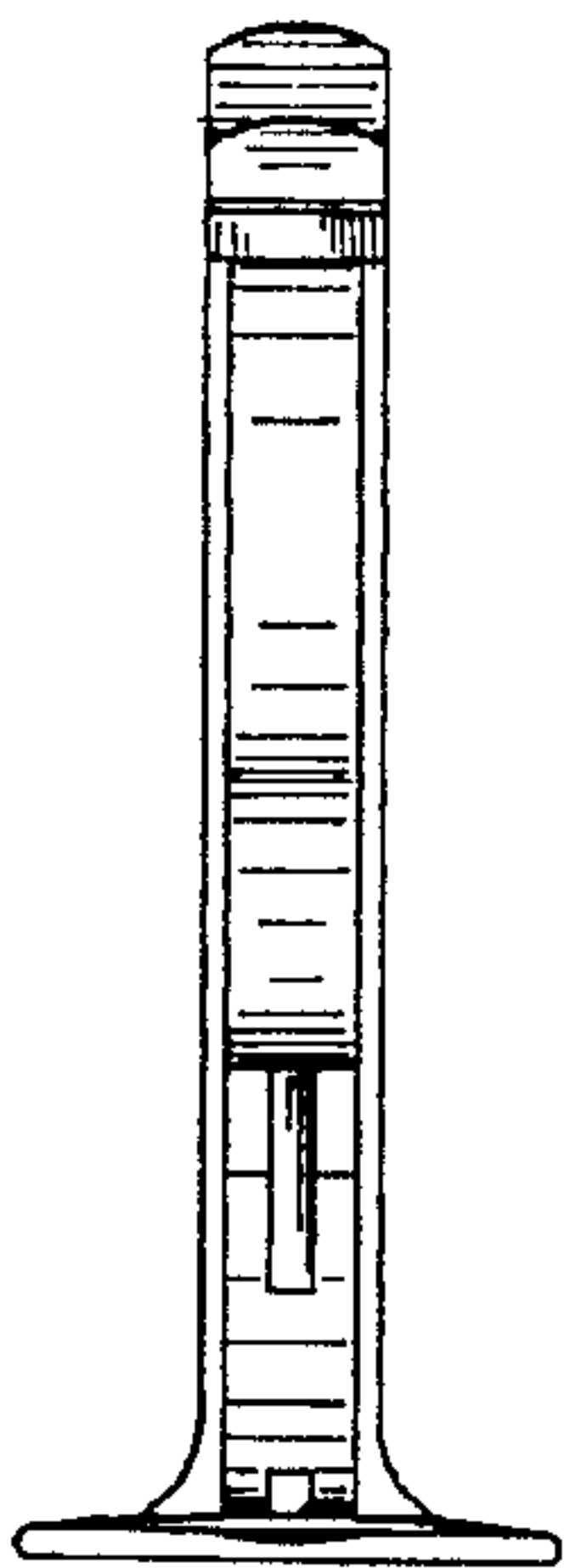

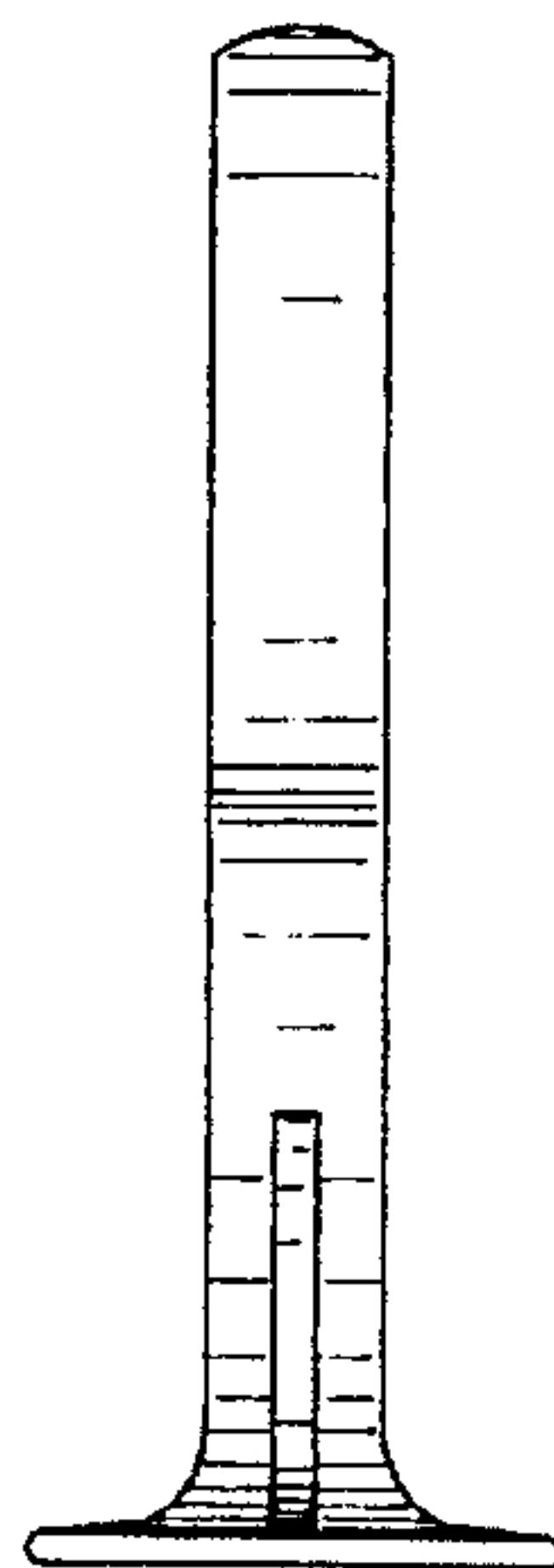

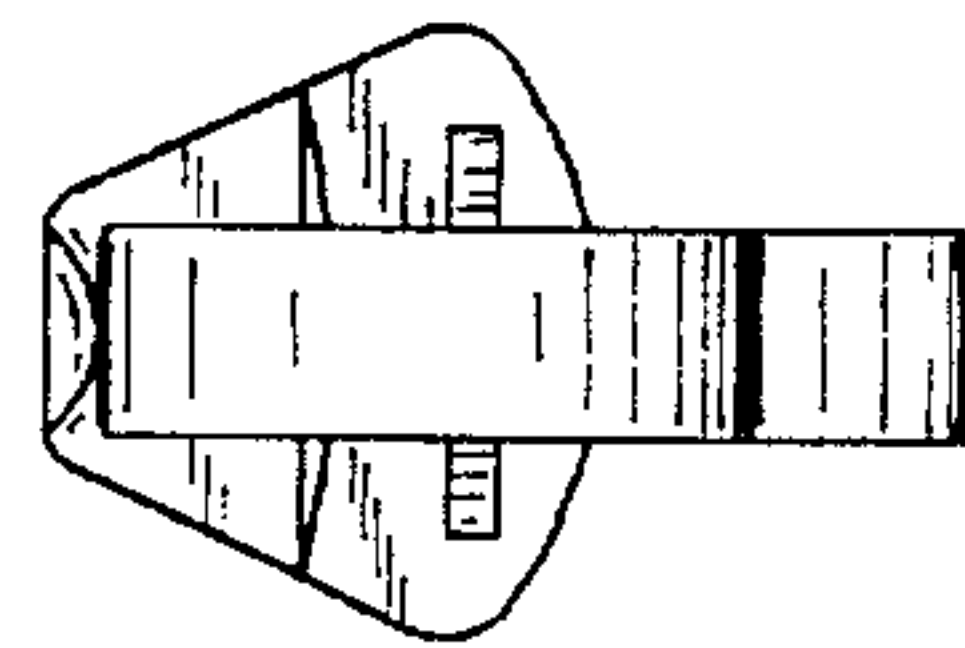

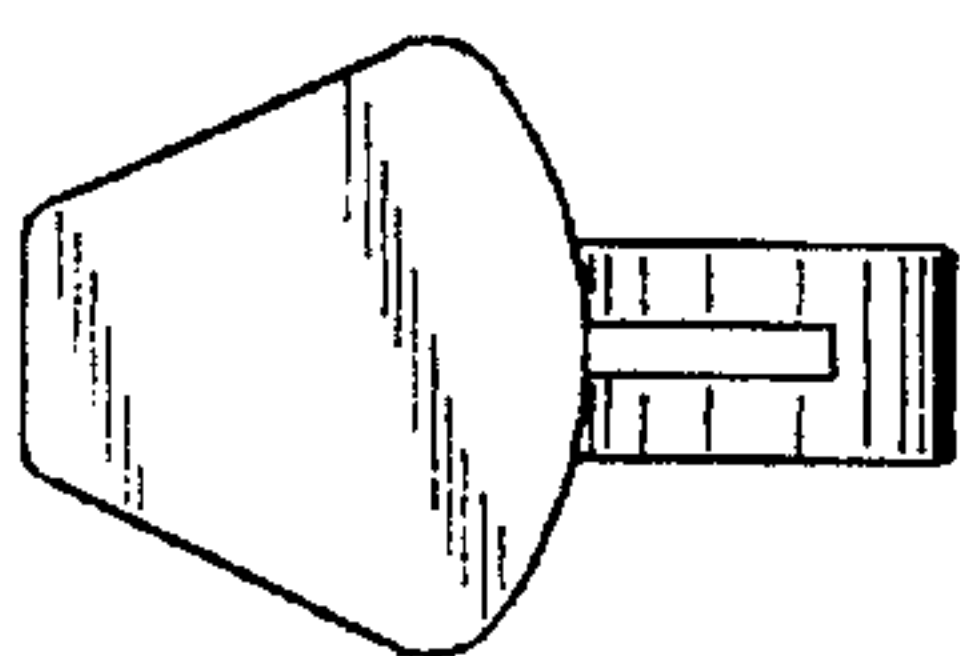

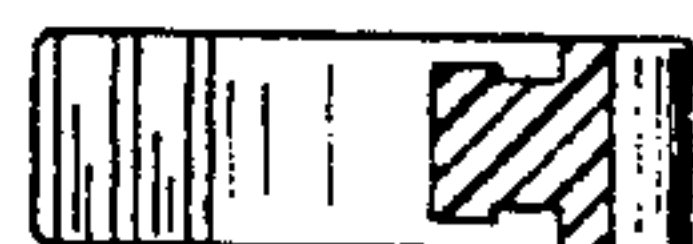
