[57] CLAIM

The ornamental design for a beverage container lid, as shown and described.

DESCRIPTION

FIG. 1 is an top right front perspective view of a beverage container lid showing my new design. The broken lines shown on the beverage container lid and the broken lines showing a type of container on which the beverage container lid may be placed are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

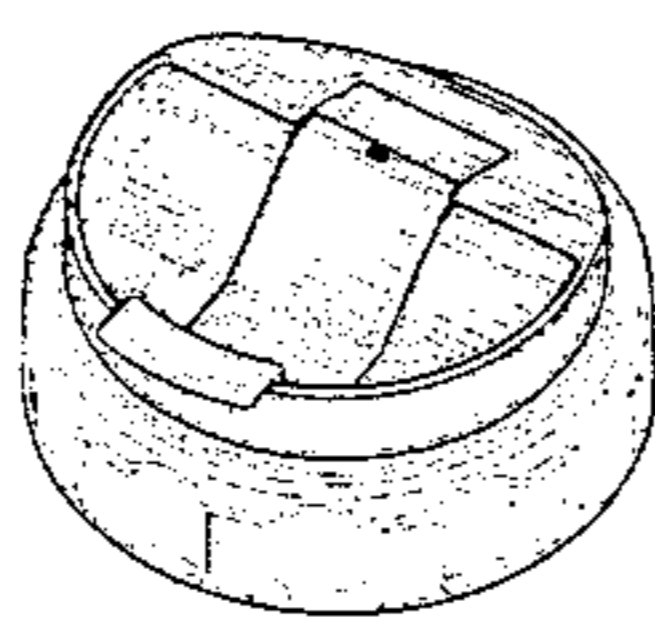
FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right side elevational view thereof; the left side elevational view being a mirror image;

FIG. 6 is a front elevational view thereof; and,

FIG. 7 is a top right front perspective view showing the tab portion of the beverage container lid in an open position.

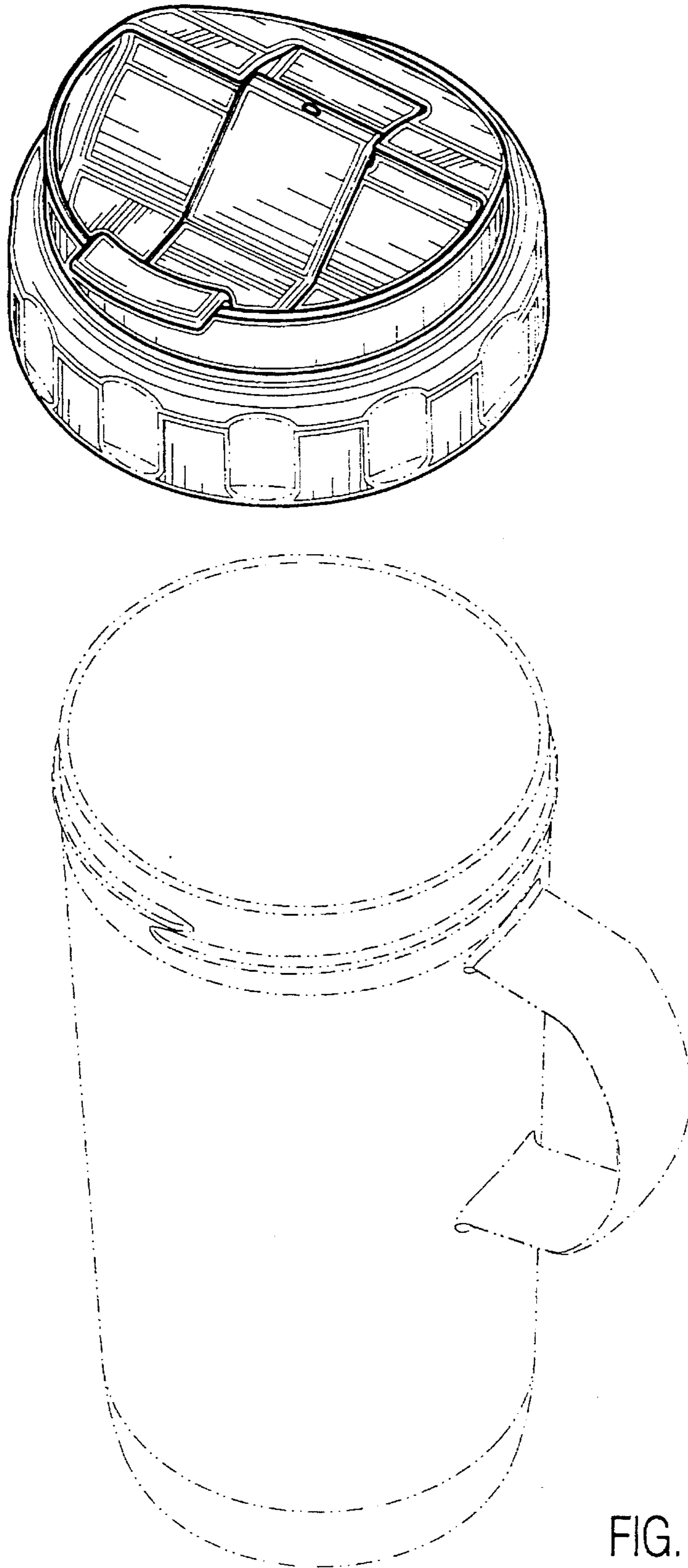

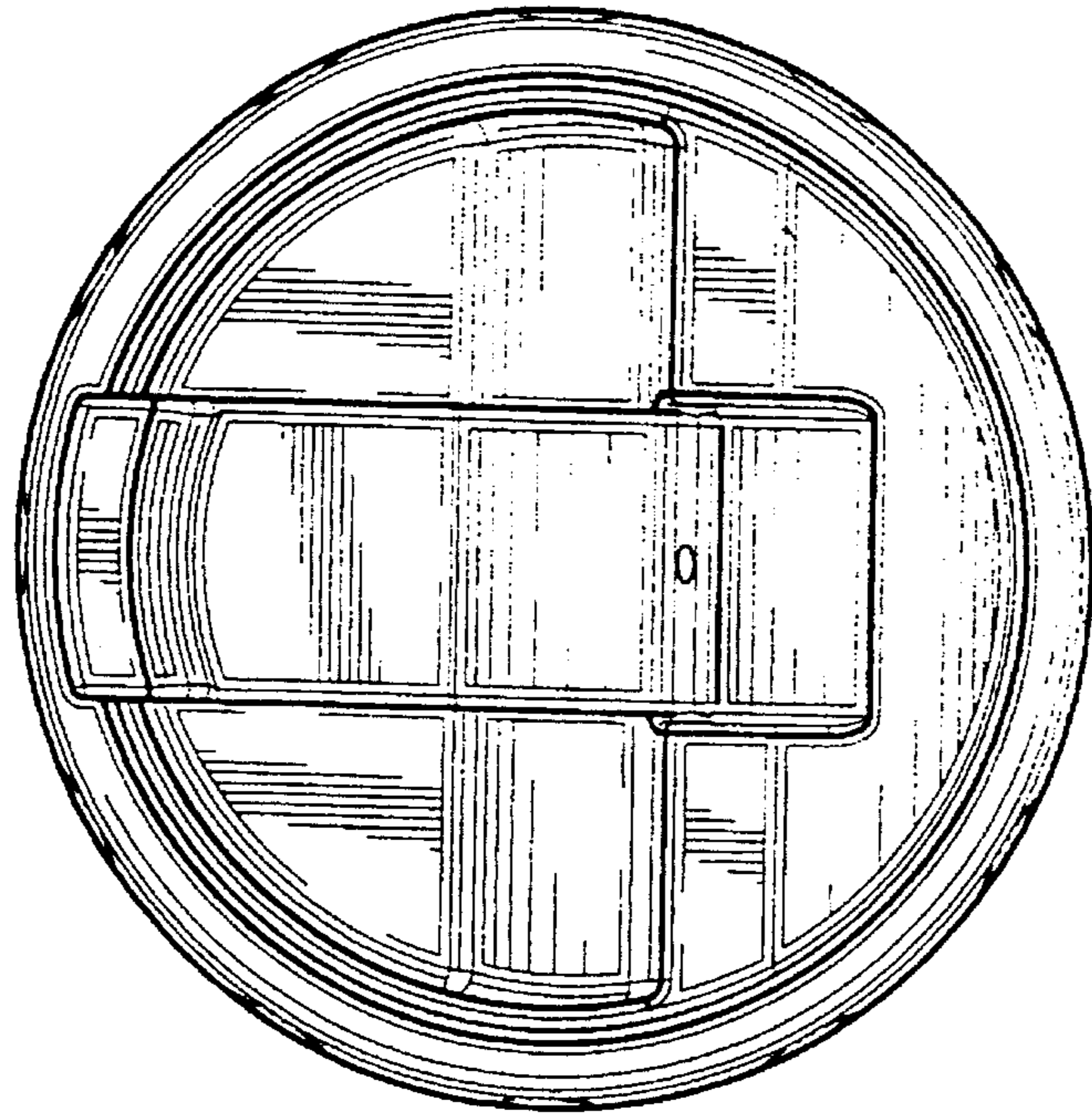

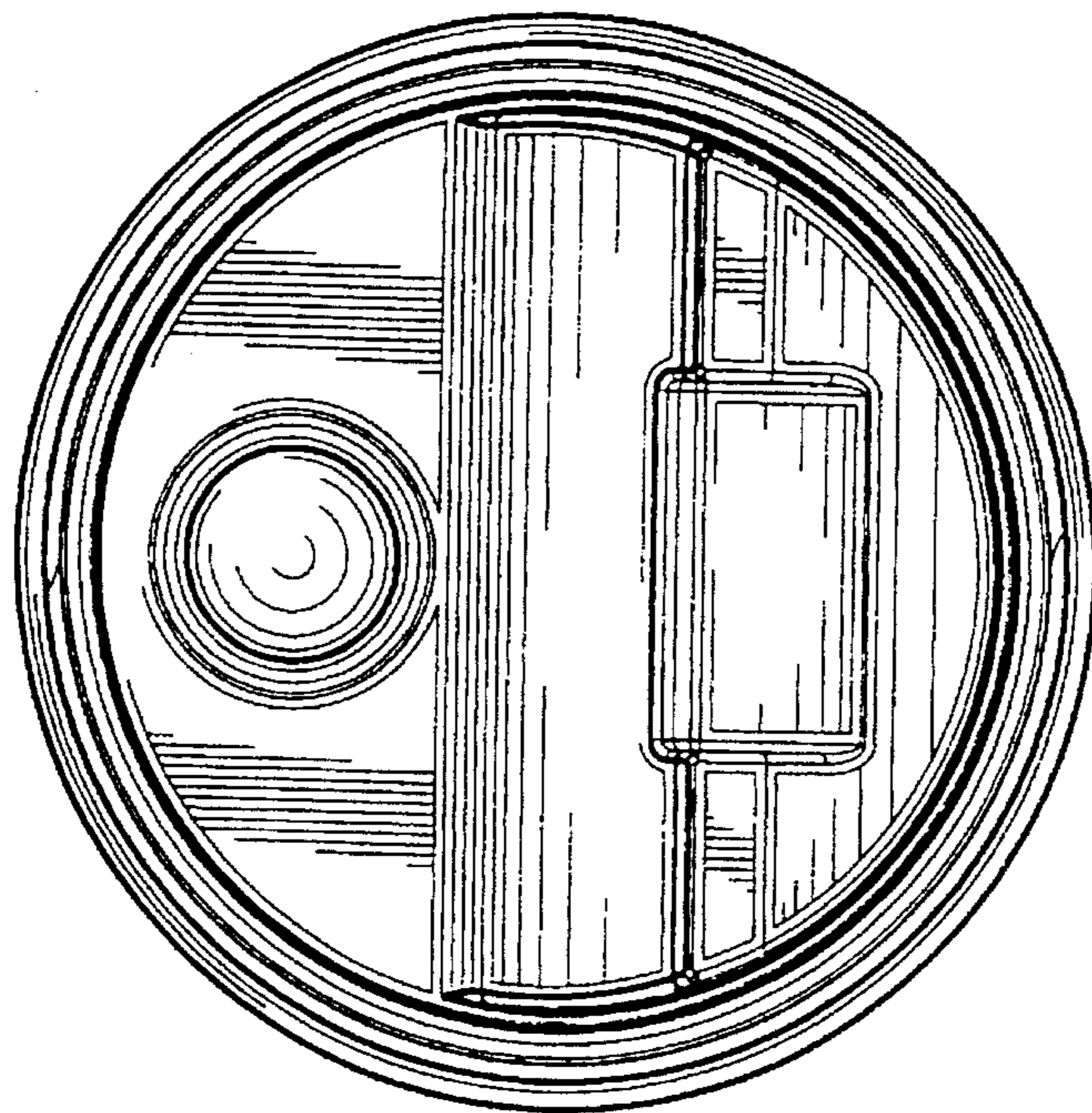

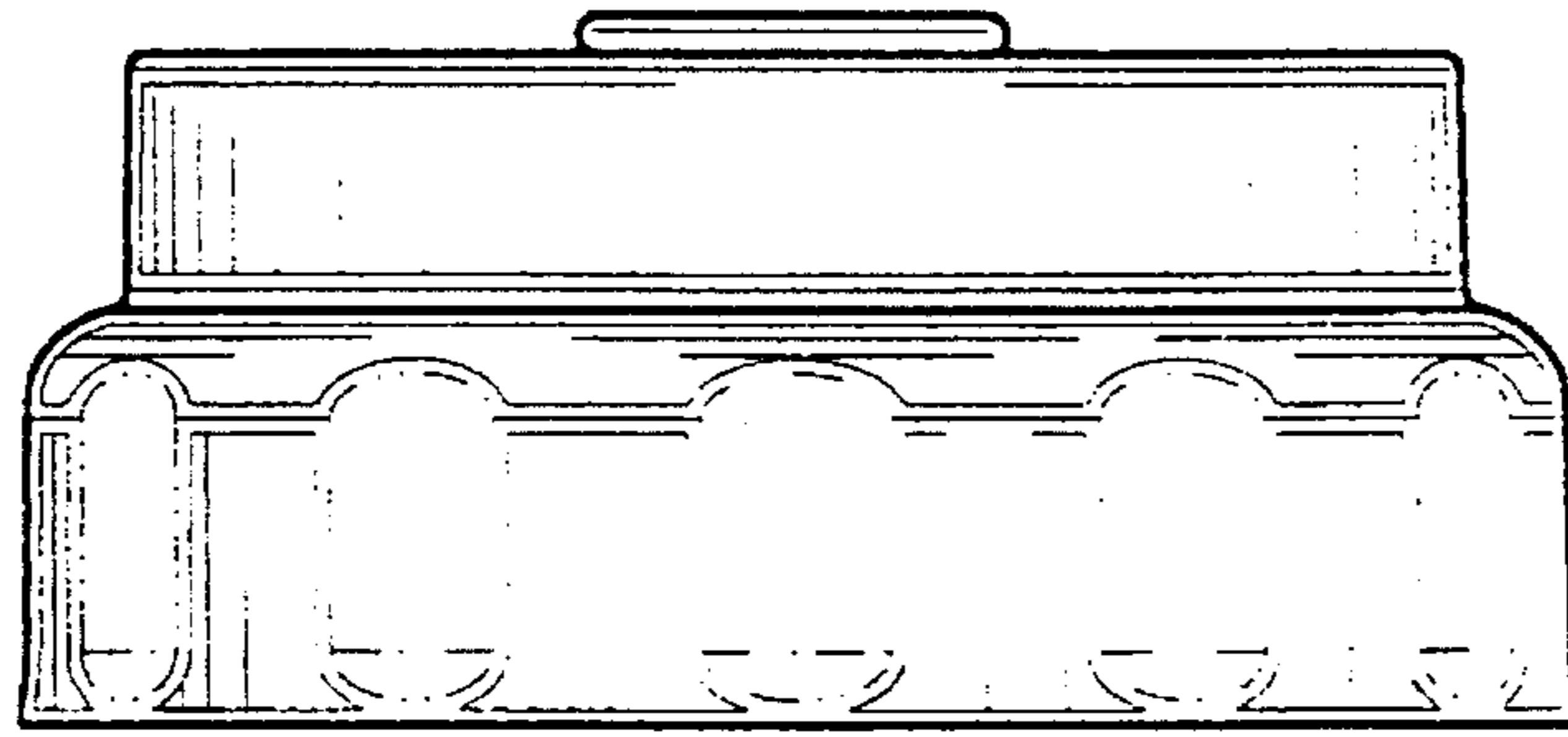

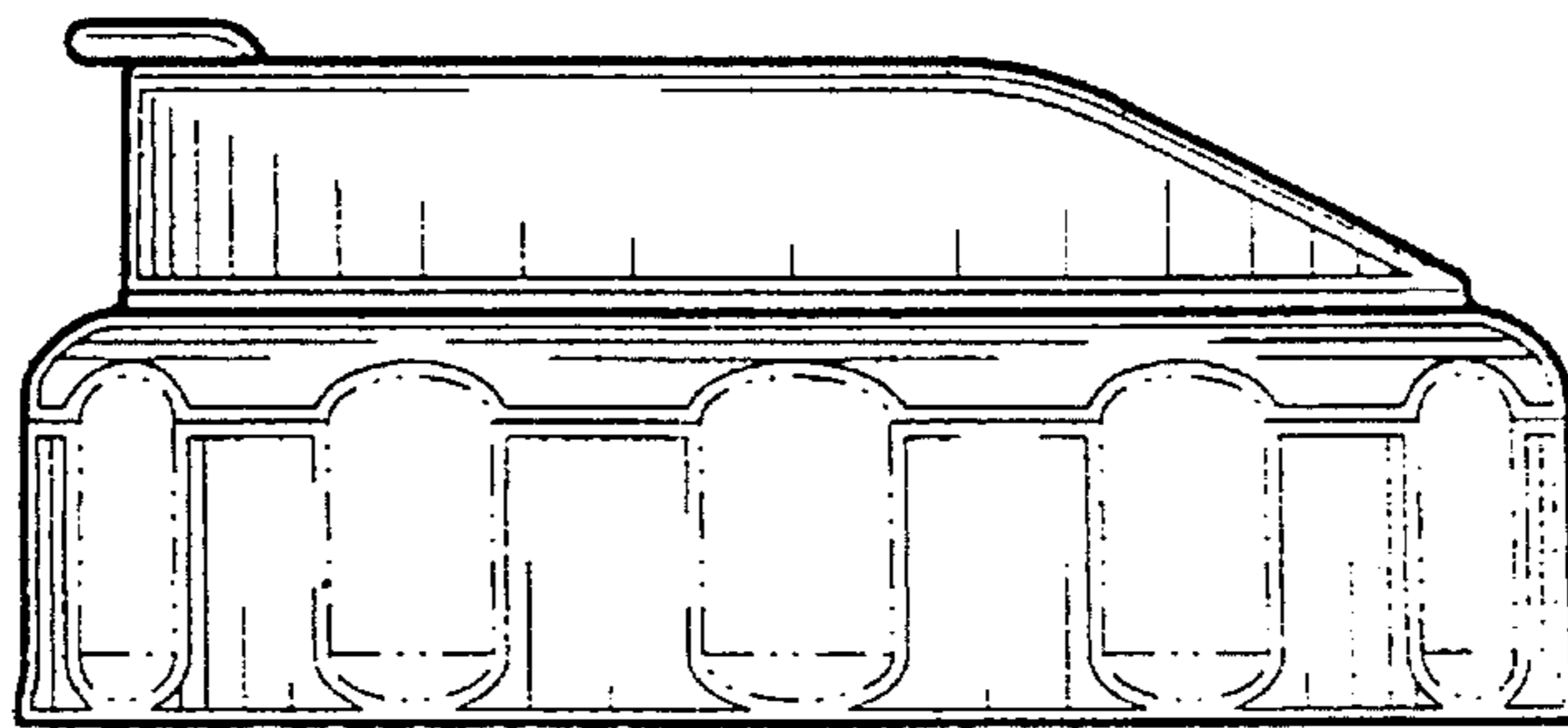

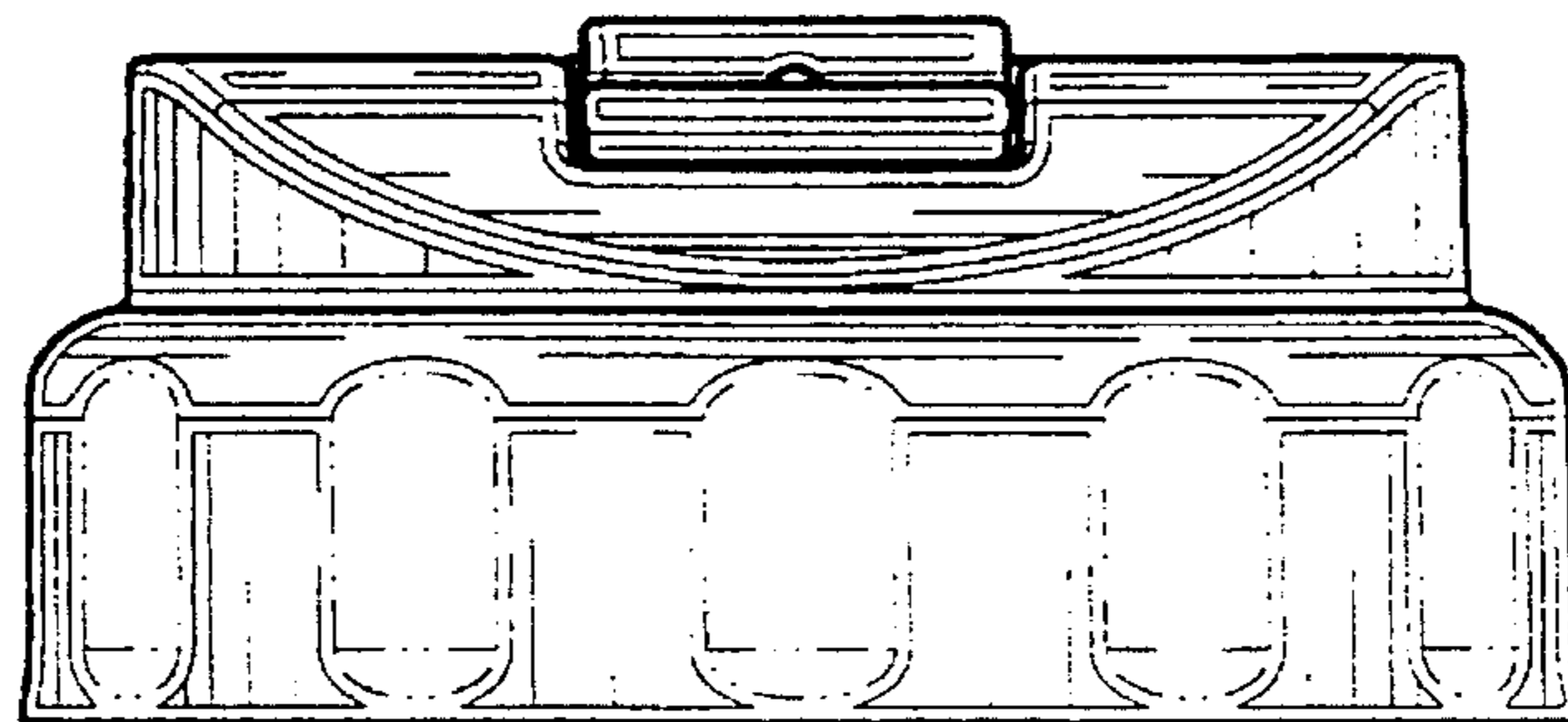

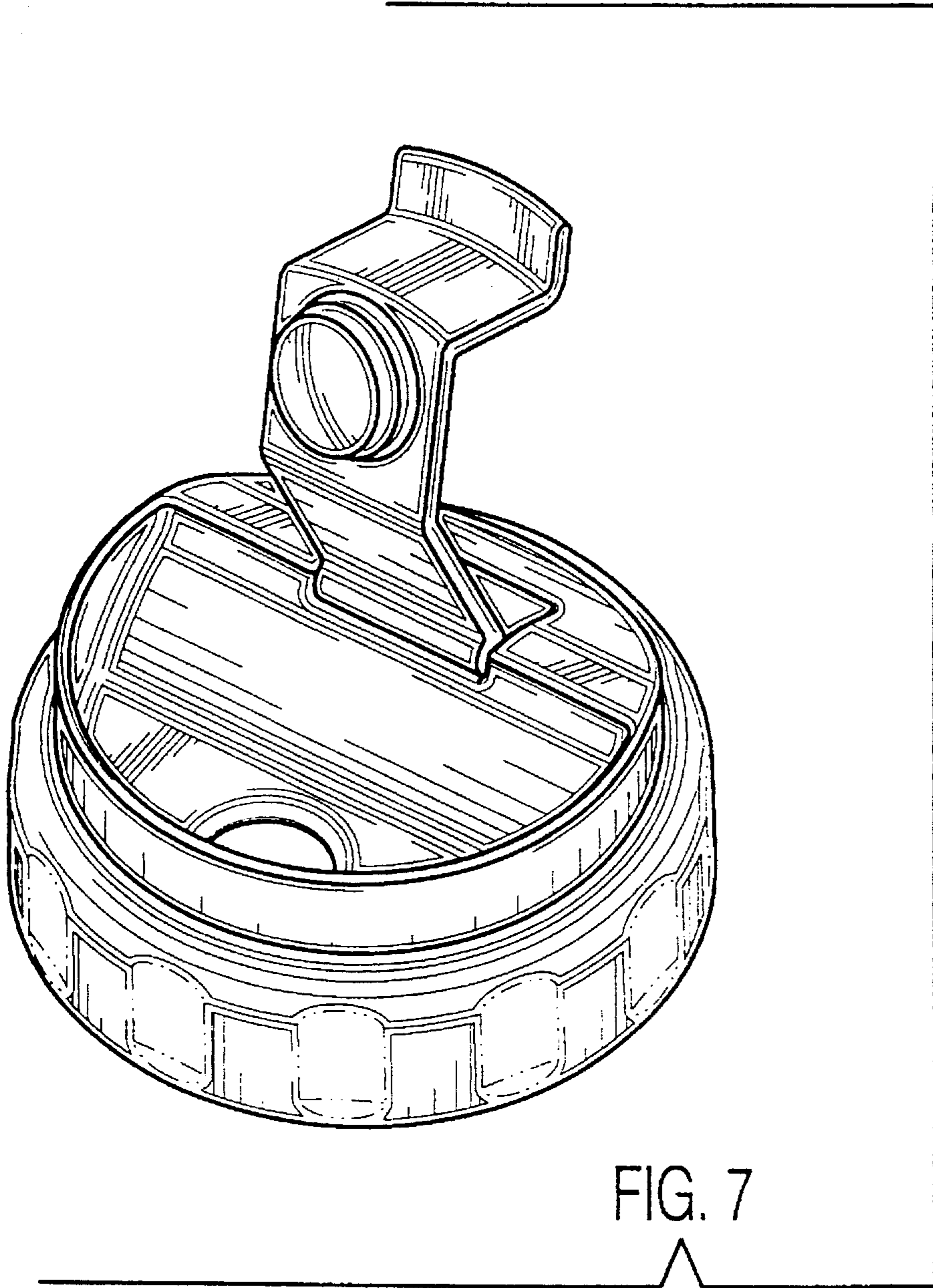
