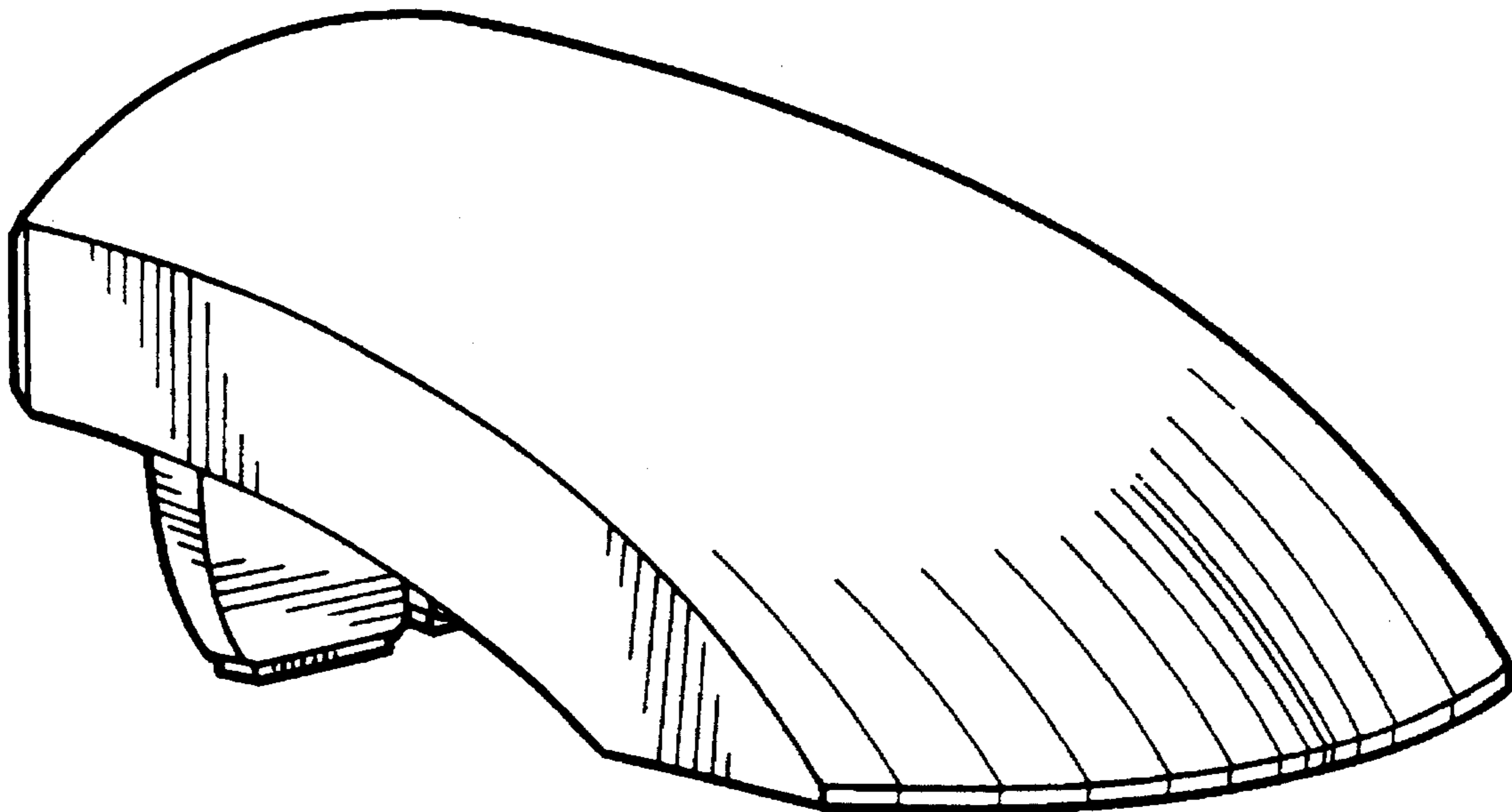
[57] **CLAIM**

The ornamental design for a computer mouse, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and left side view of a computer mouse showing our new design;  
FIG. 2 is a left side view thereof, the right side view being a mirror image;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a front elevational view thereof; and,  
FIG. 6 is a rear view thereof.

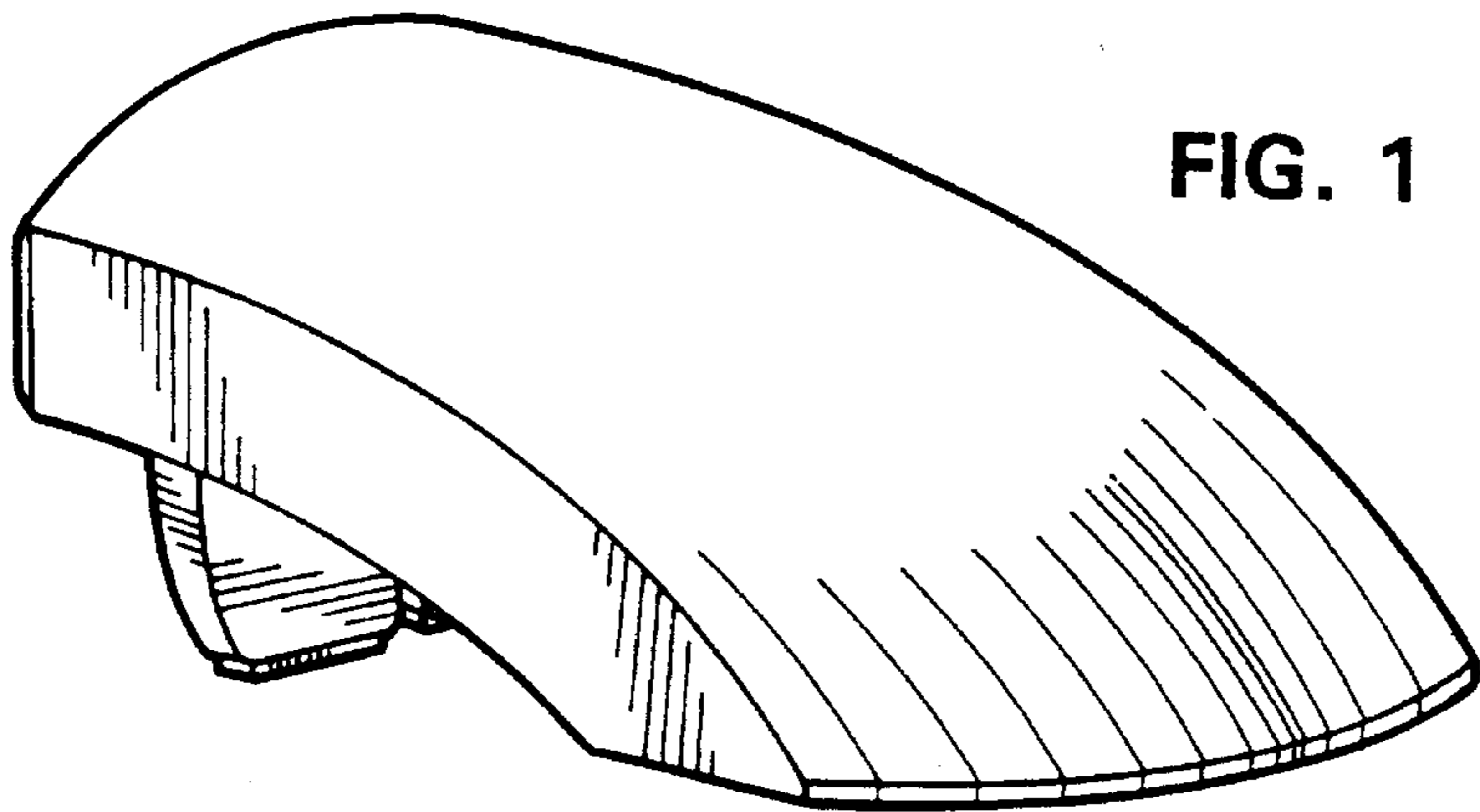

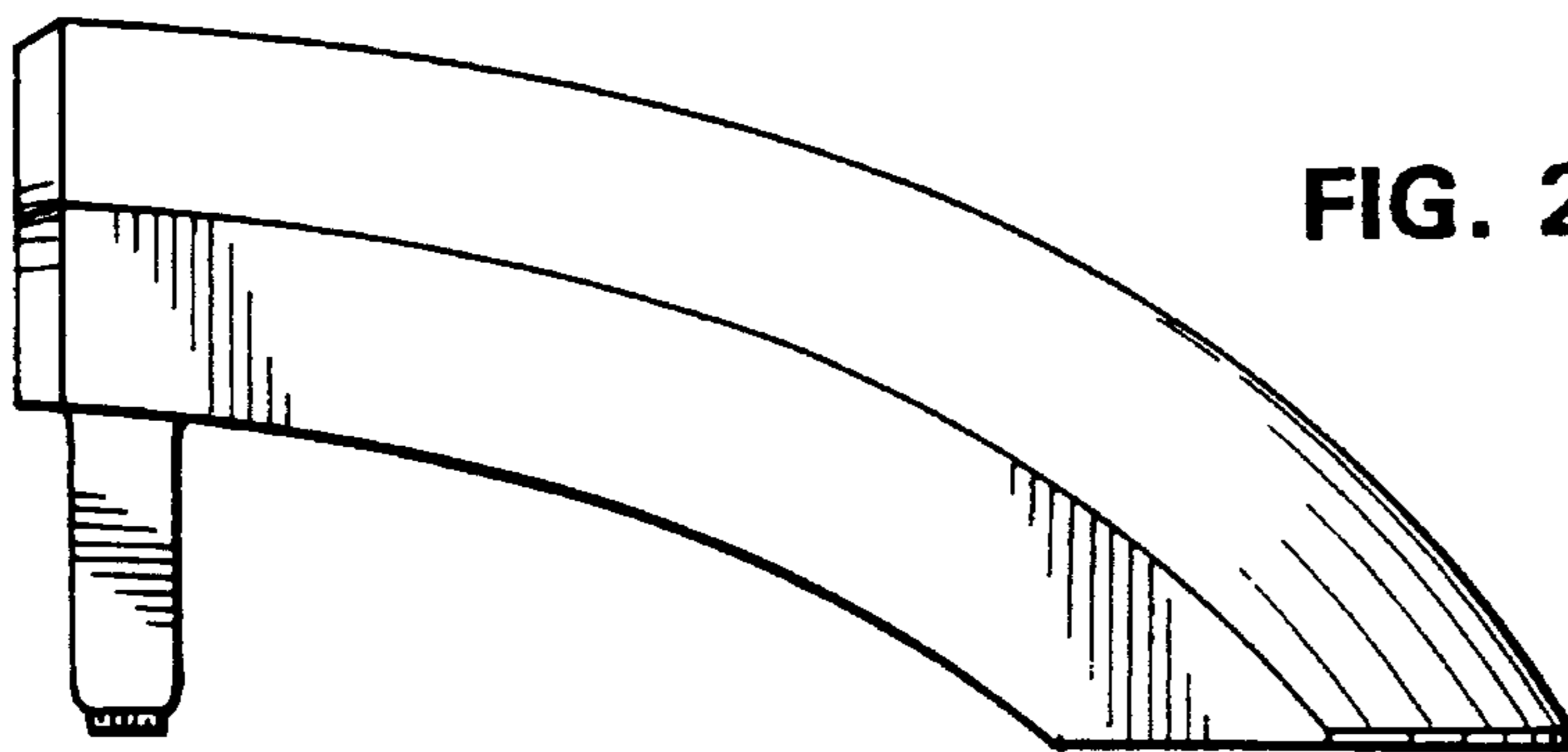

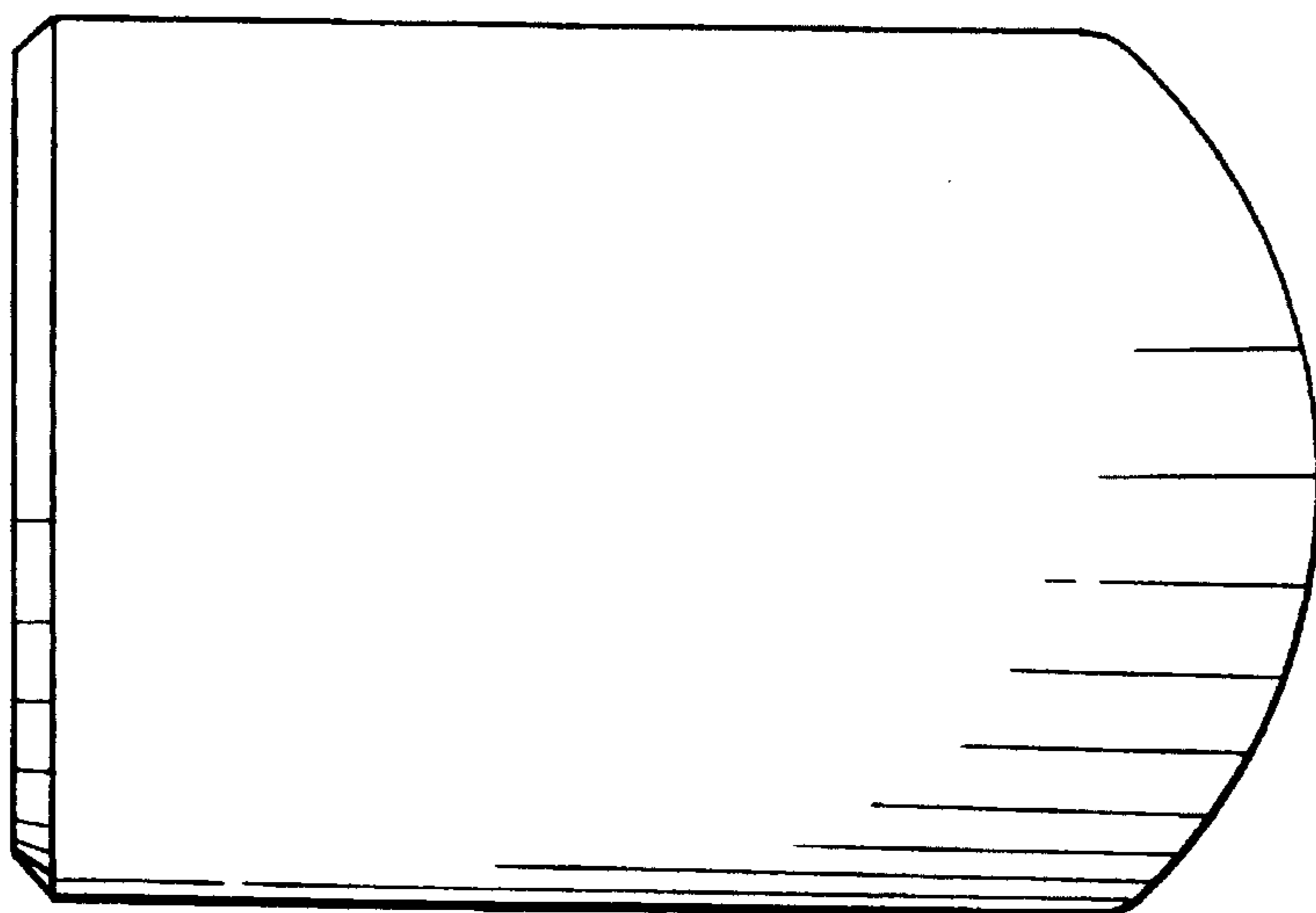

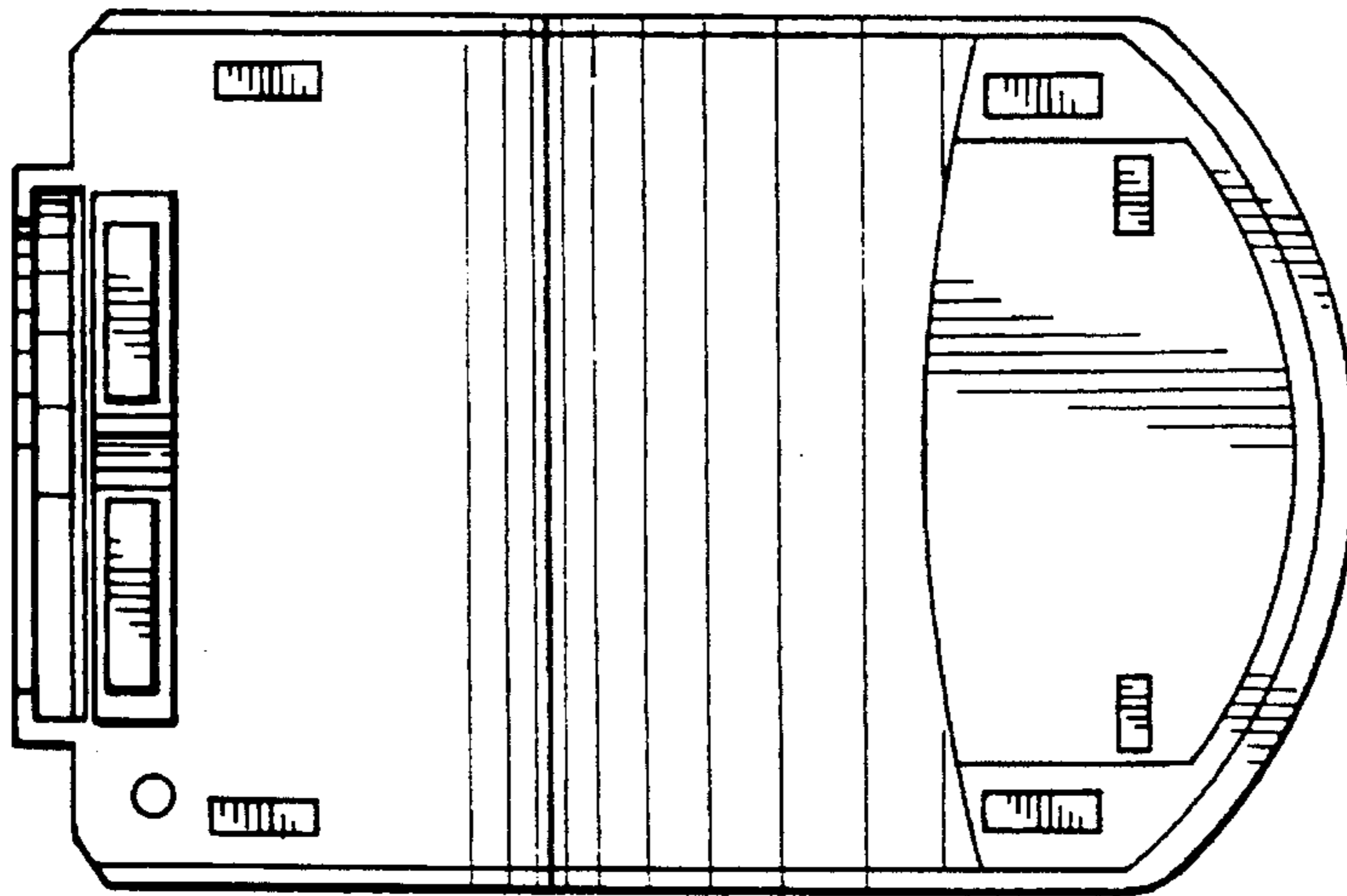

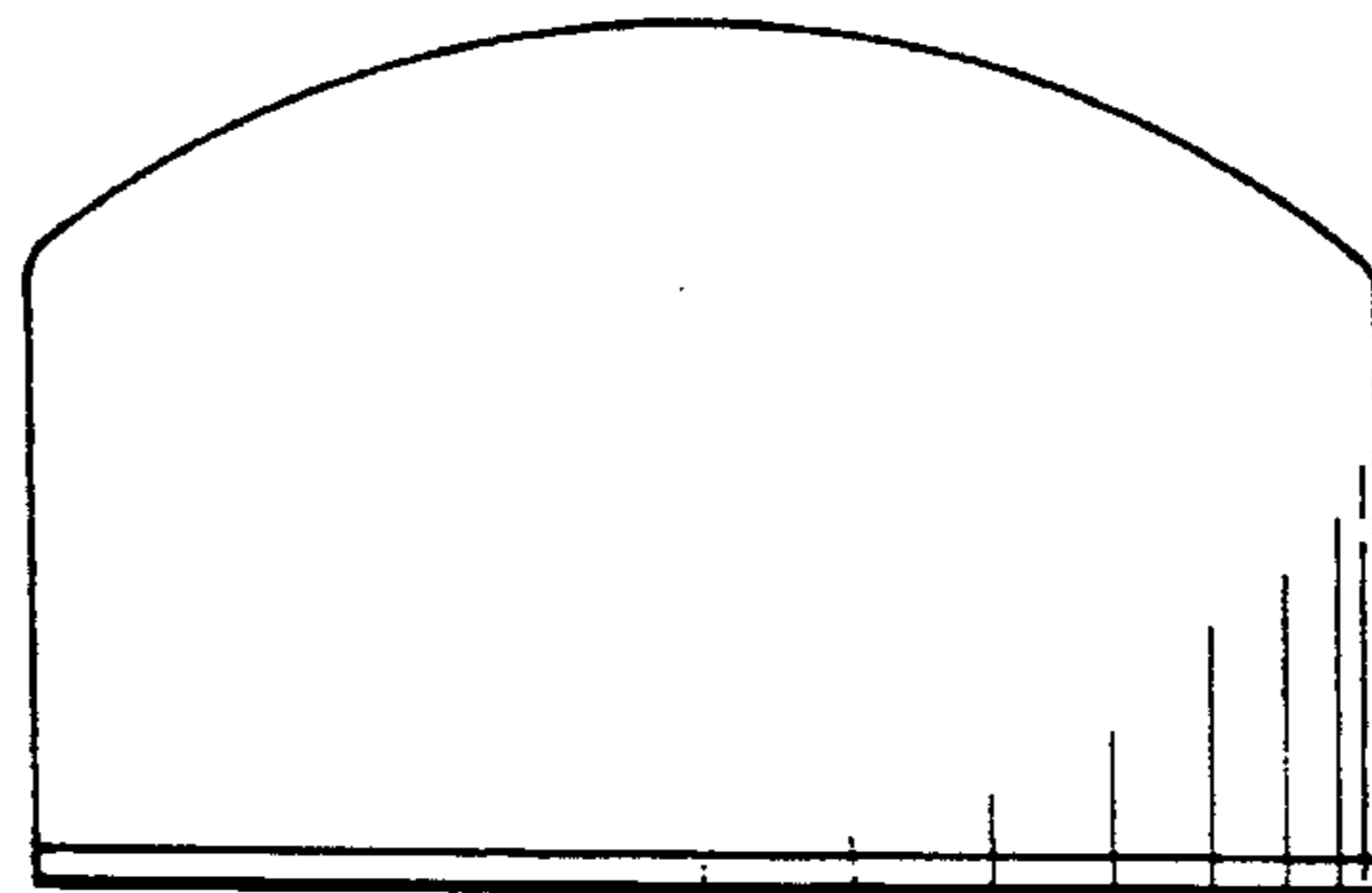

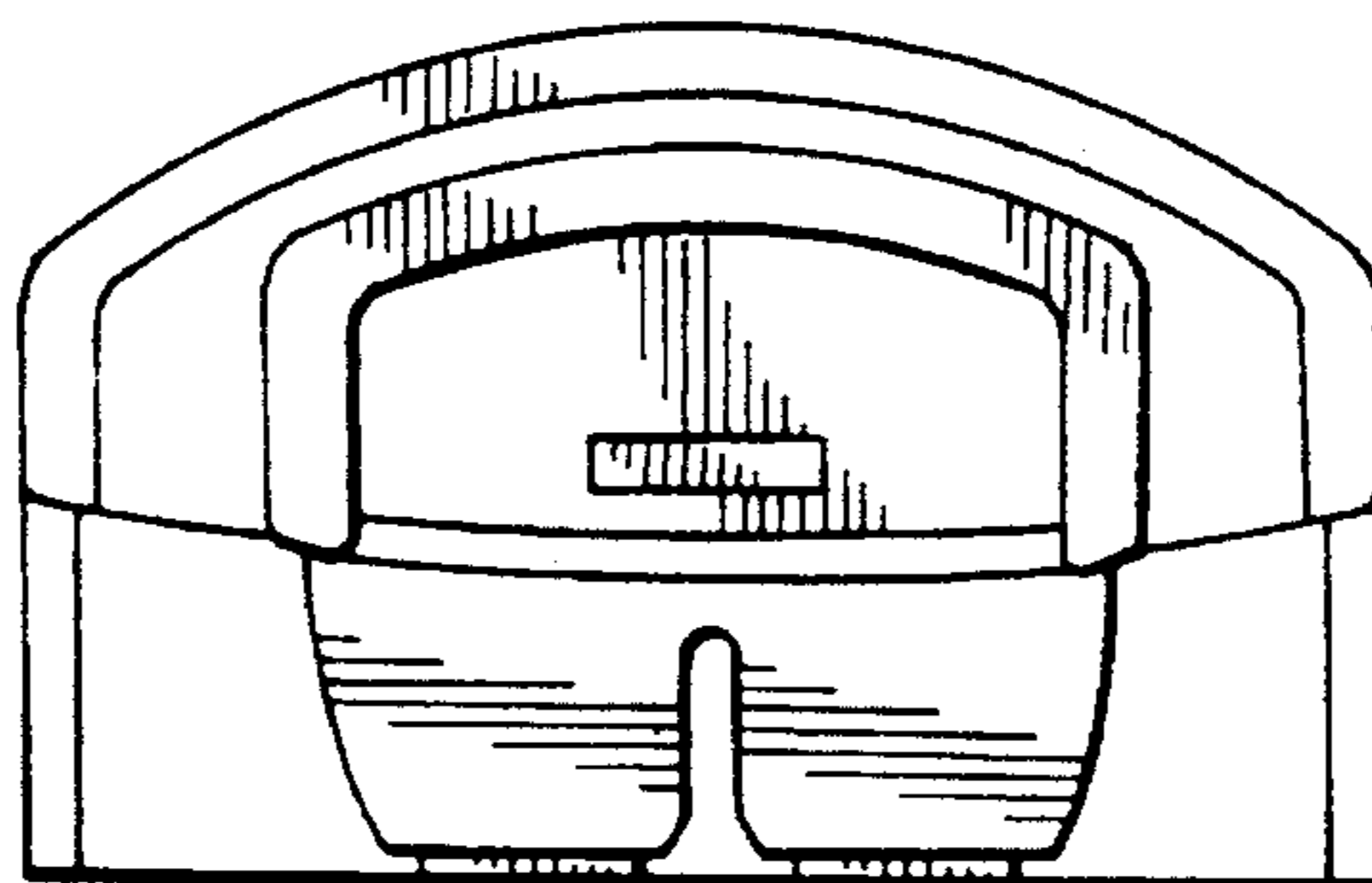
