CLAIM

The ornamental design for a sanitary fabric telephone handset cover, as shown and described.

DESCRIPTION

FIG. 1 is an upper and left perspective view of a sanitary fabric telephone handset cover showing our new design, exploded from a telephone handset for attachment thereto, the telephone handset, shown in broken line to illustrate the environment thereof;

FIG. 2 is a left side elevational view thereof, the right side being a mirror image of the left side shown;


FIG. 3 is a top elevational view thereof;

FIG. 4 is a bottom elevational view thereof;

FIG. 5 is a back plan view thereof; and,

FIG. 6 is a front plan view thereof.











