The ornamental design for a flexi-grab paper clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a flexi-grab paper clip

showing my new design;

FIG. 2 is a side elevational view;

FIG. 3 is a side elevational view of the side opposite that shown in FIG. 2;

FIG. 4 is an end elevational view;

FIG. 5 is an end elevational view of the end opposite that shown in FIG. 4;

FIG. 6 is a top plan view;

FIG. 7 is a perspective view of a second embodiment of my new design;

FIG. 8 is a side elevational view of FIG. 7;

FIG. 9 is a side elevational view of the side opposite that shown in FIG. 8;

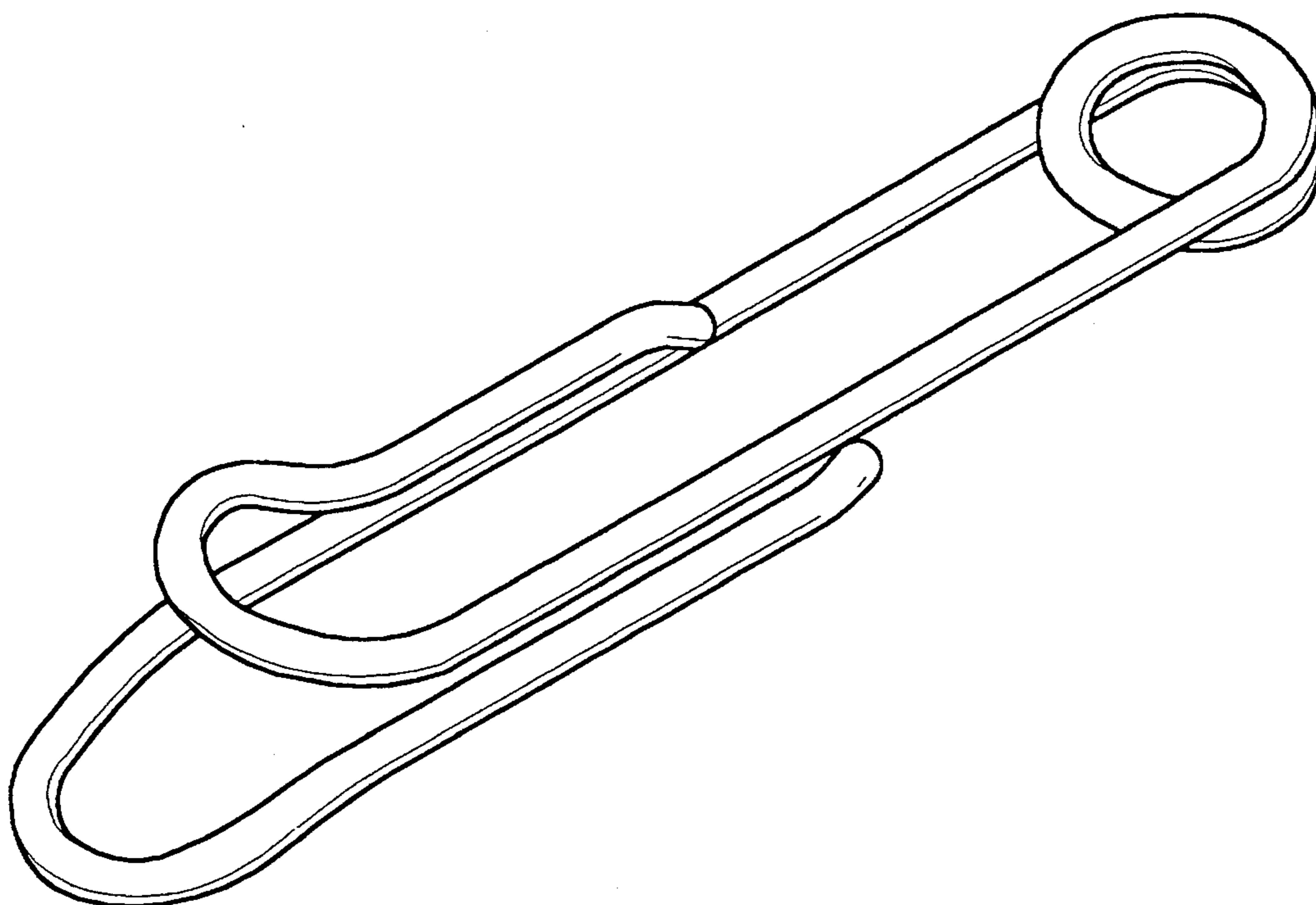
FIG. 10 is an end elevational view;

FIG. 11 is an end elevational view of the end not shown in FIG. 10;

FIG. 12 is a top plan view of FIG. 7, the fragmentary showing of paper being for illustrative purposes only and forming no part of the claimed design; and,

FIG. 13 is an enlarged fragmentary side elevational view of the center section of both embodiments.

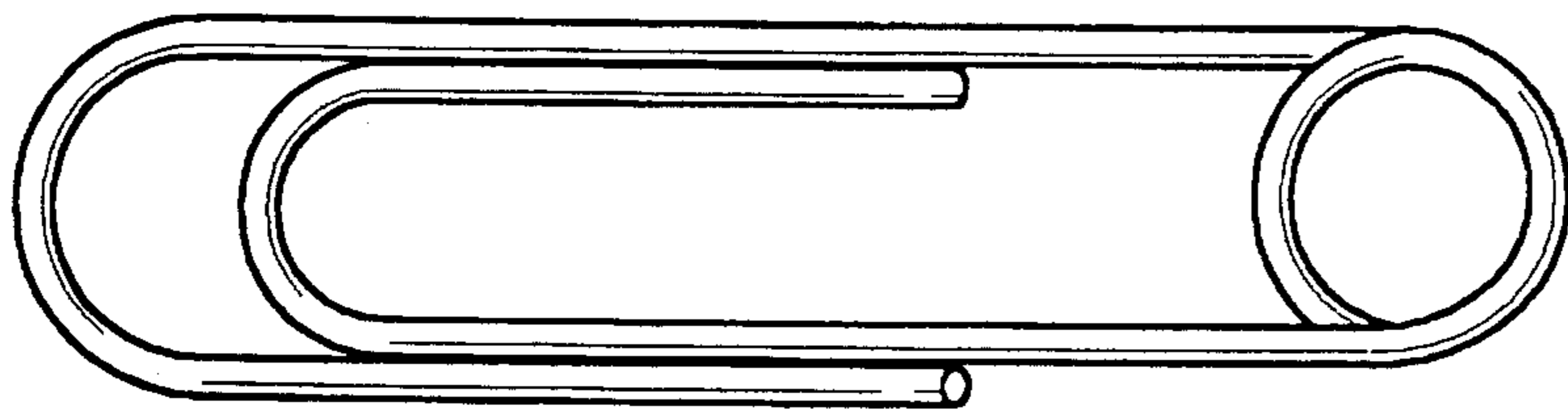

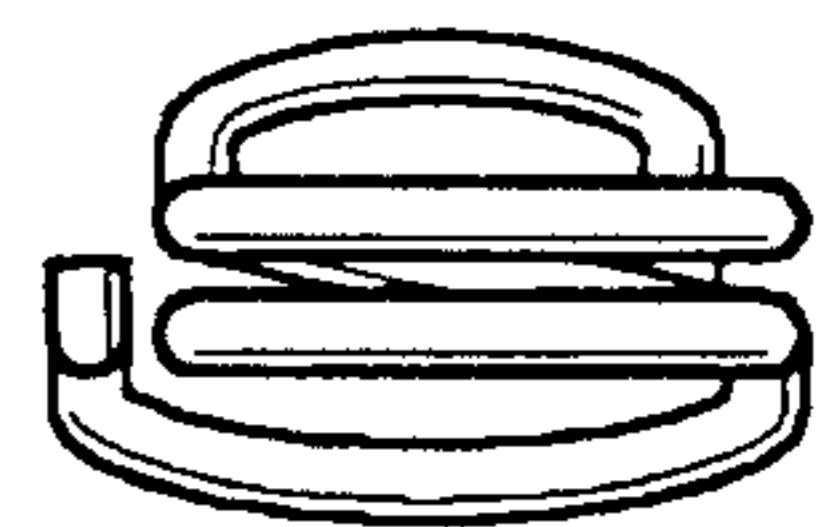

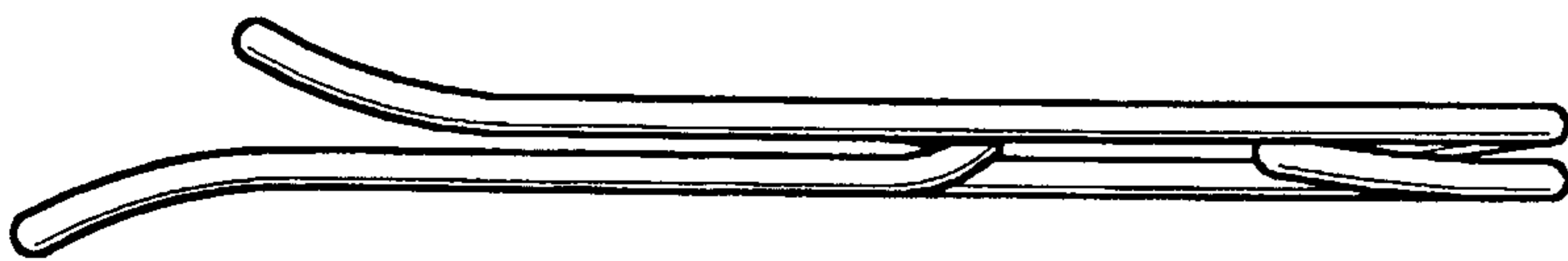

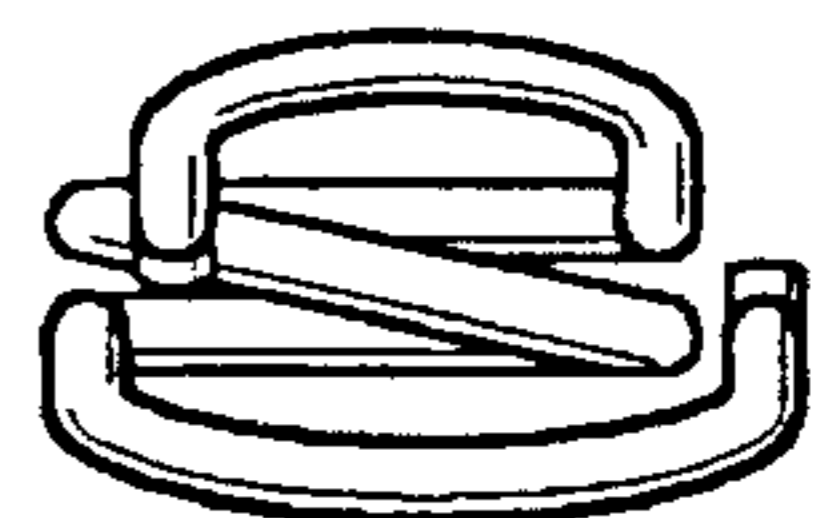

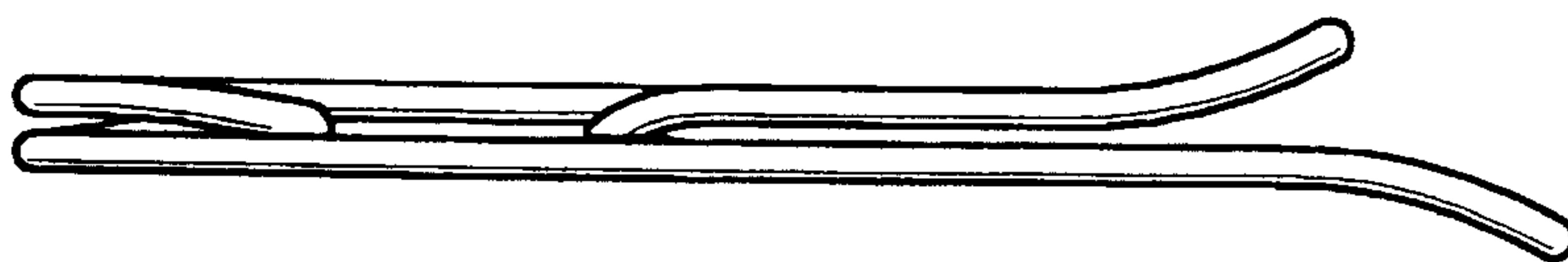

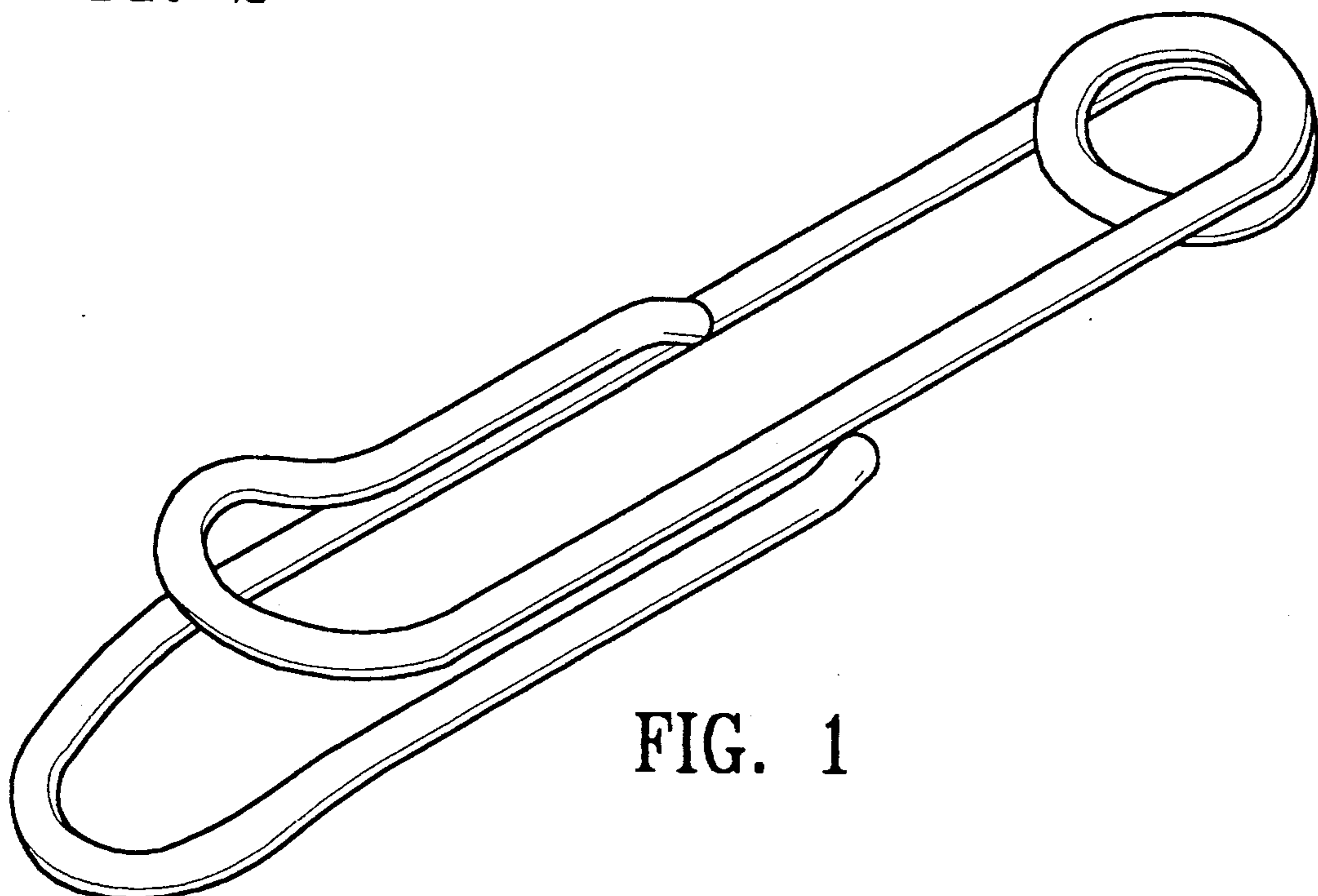

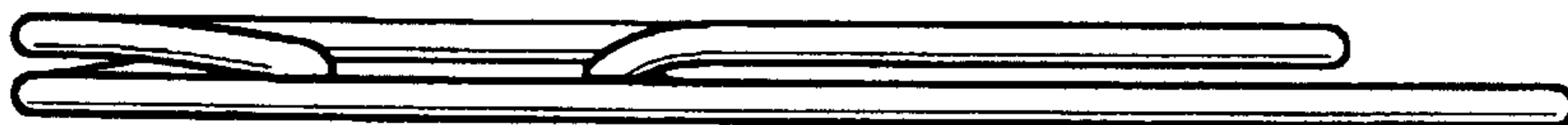

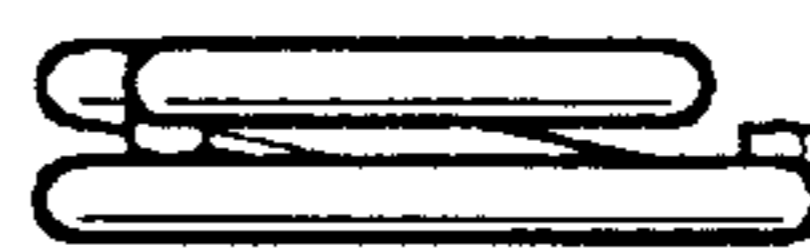

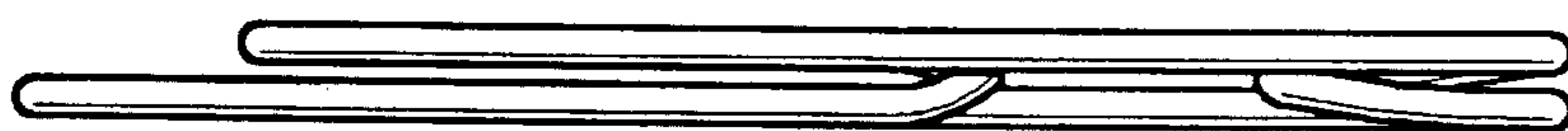

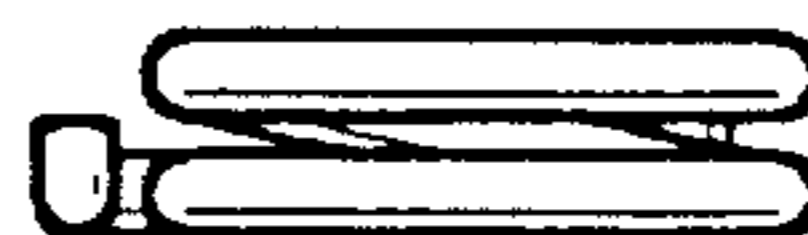

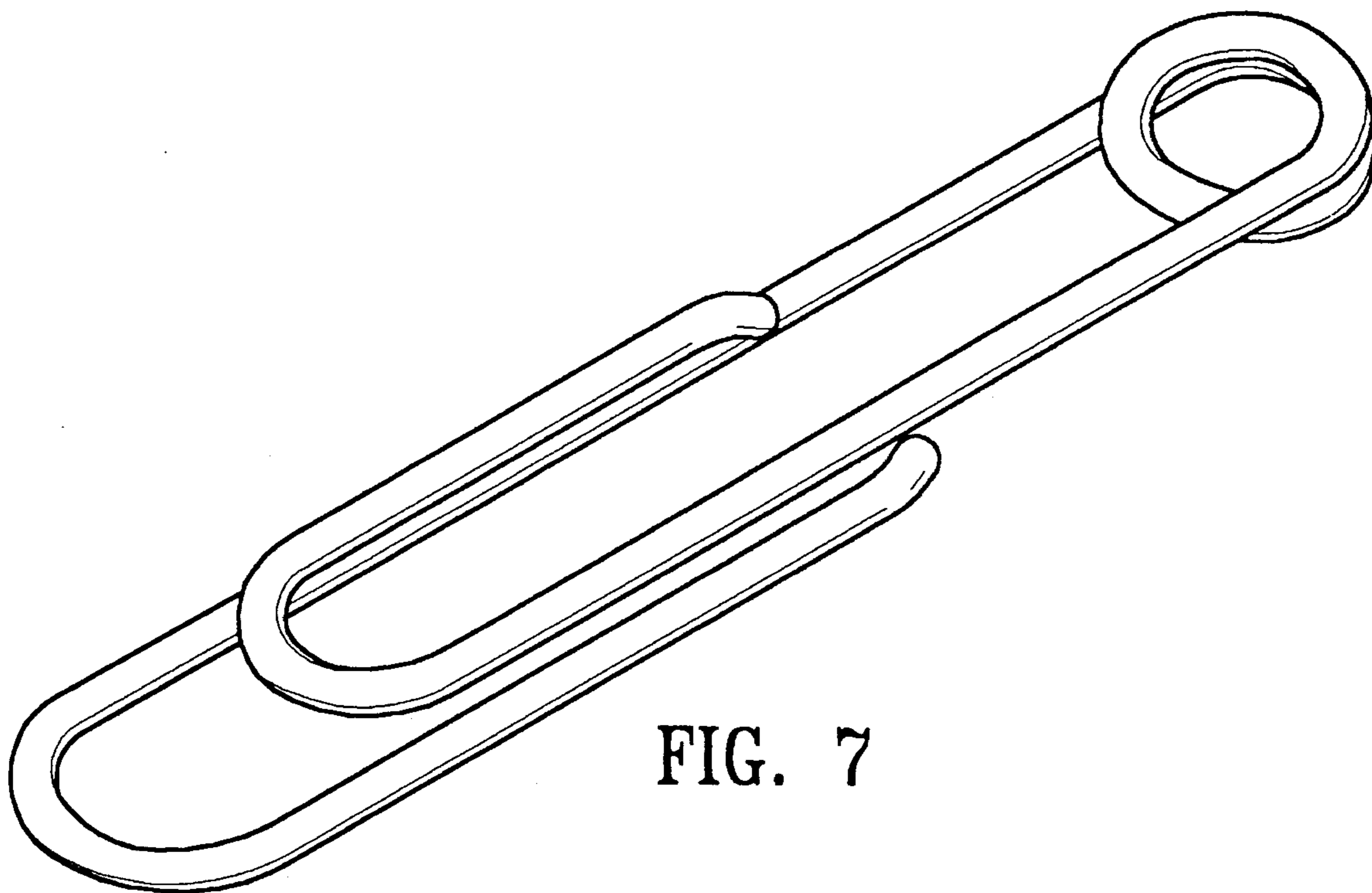

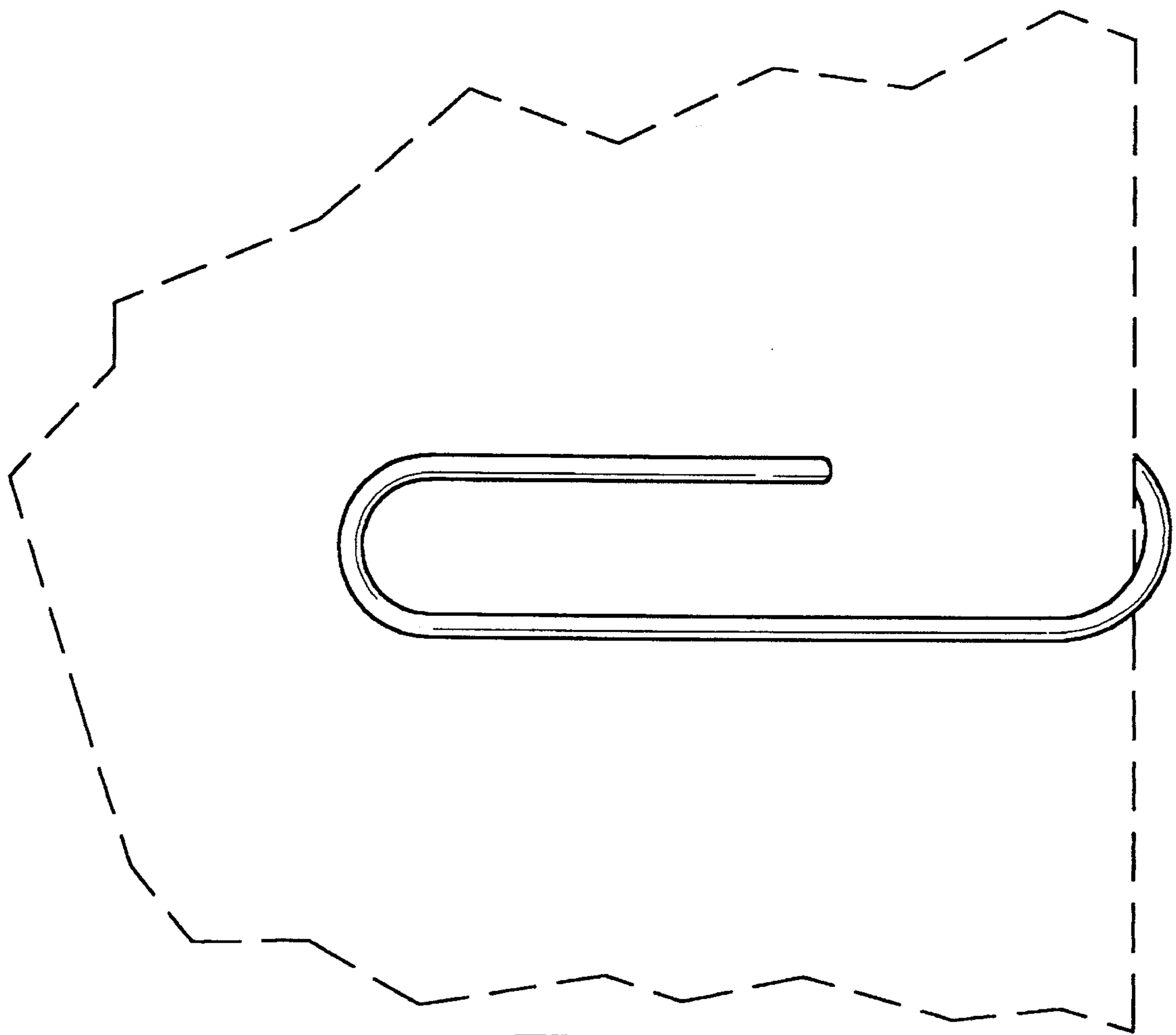

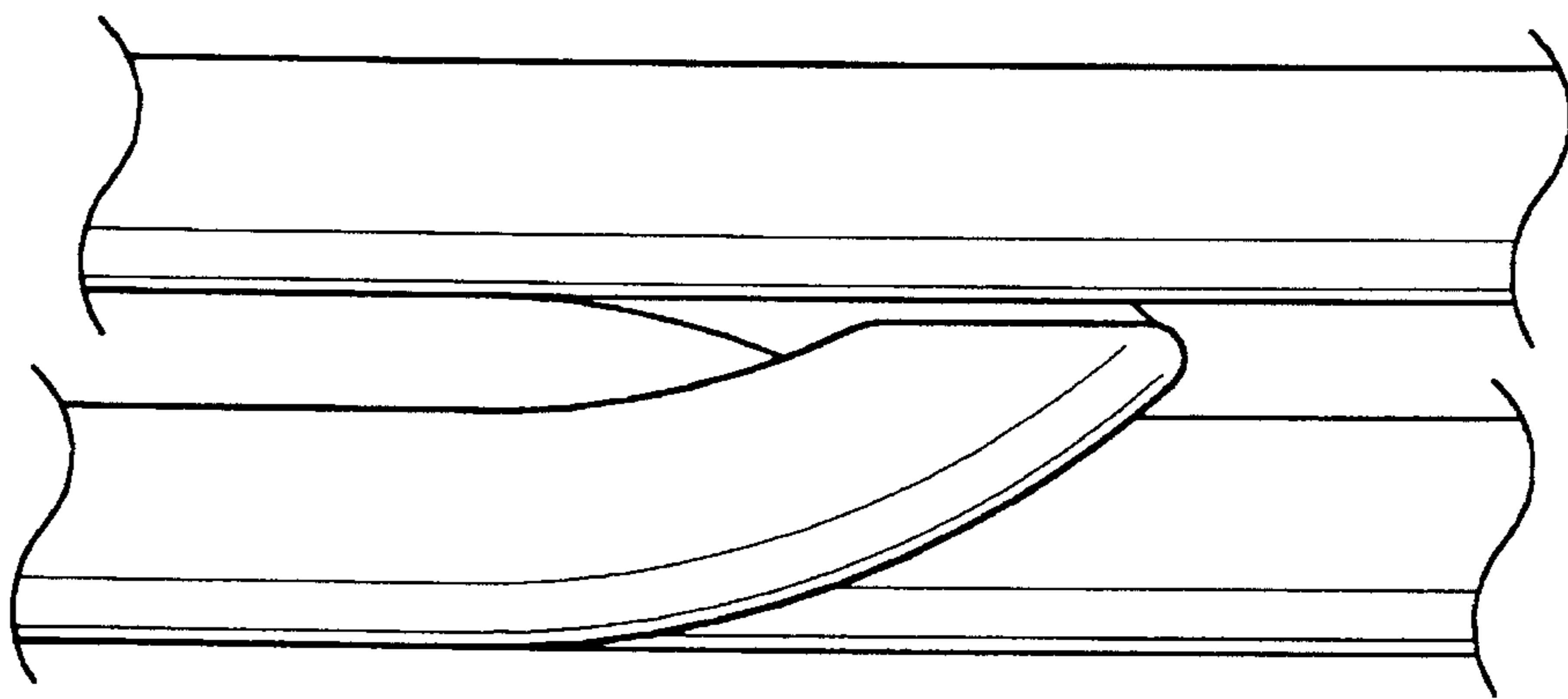
