FIG. 17 is a side view thereof;

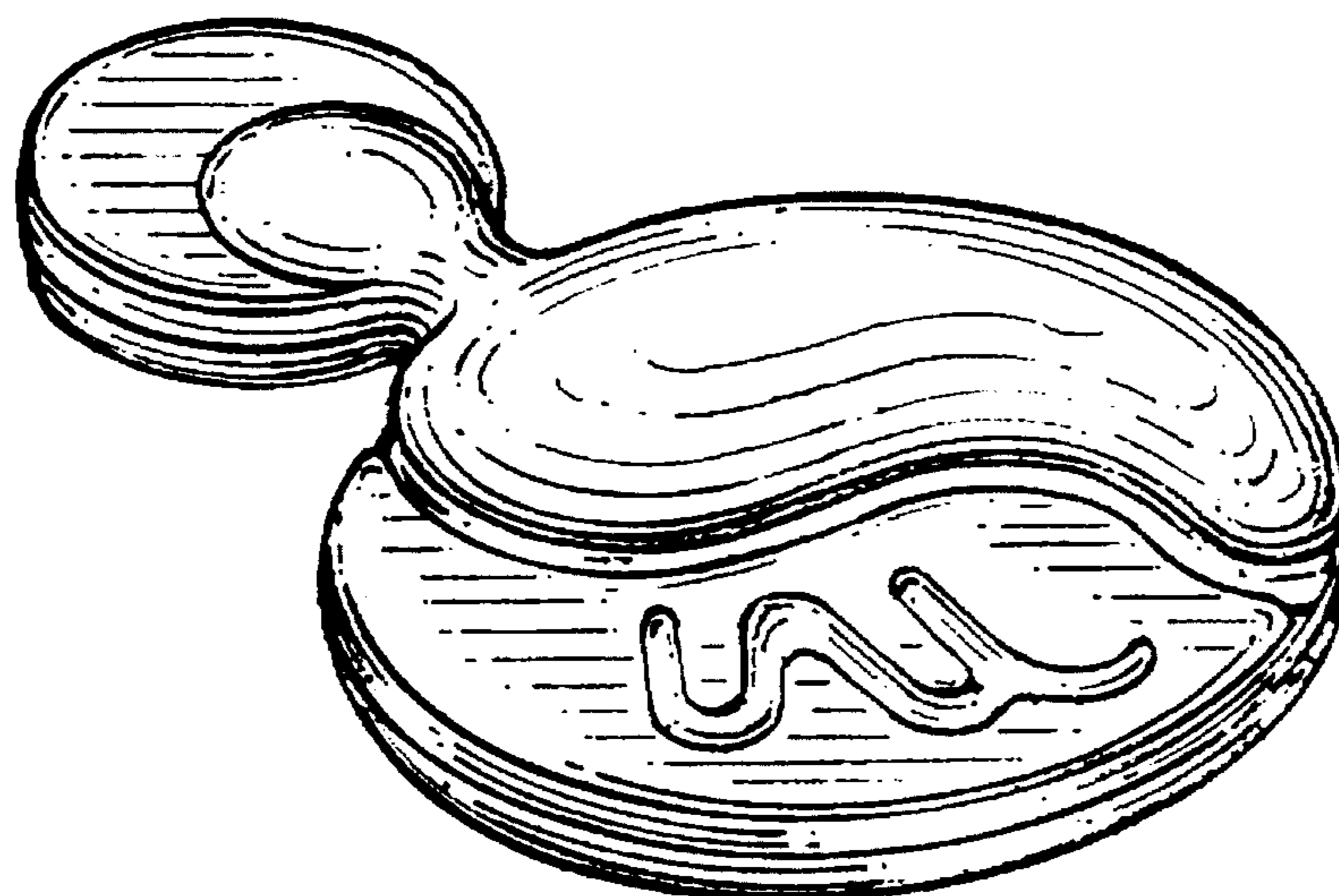
FIG. 18 is bottom plan view thereof;

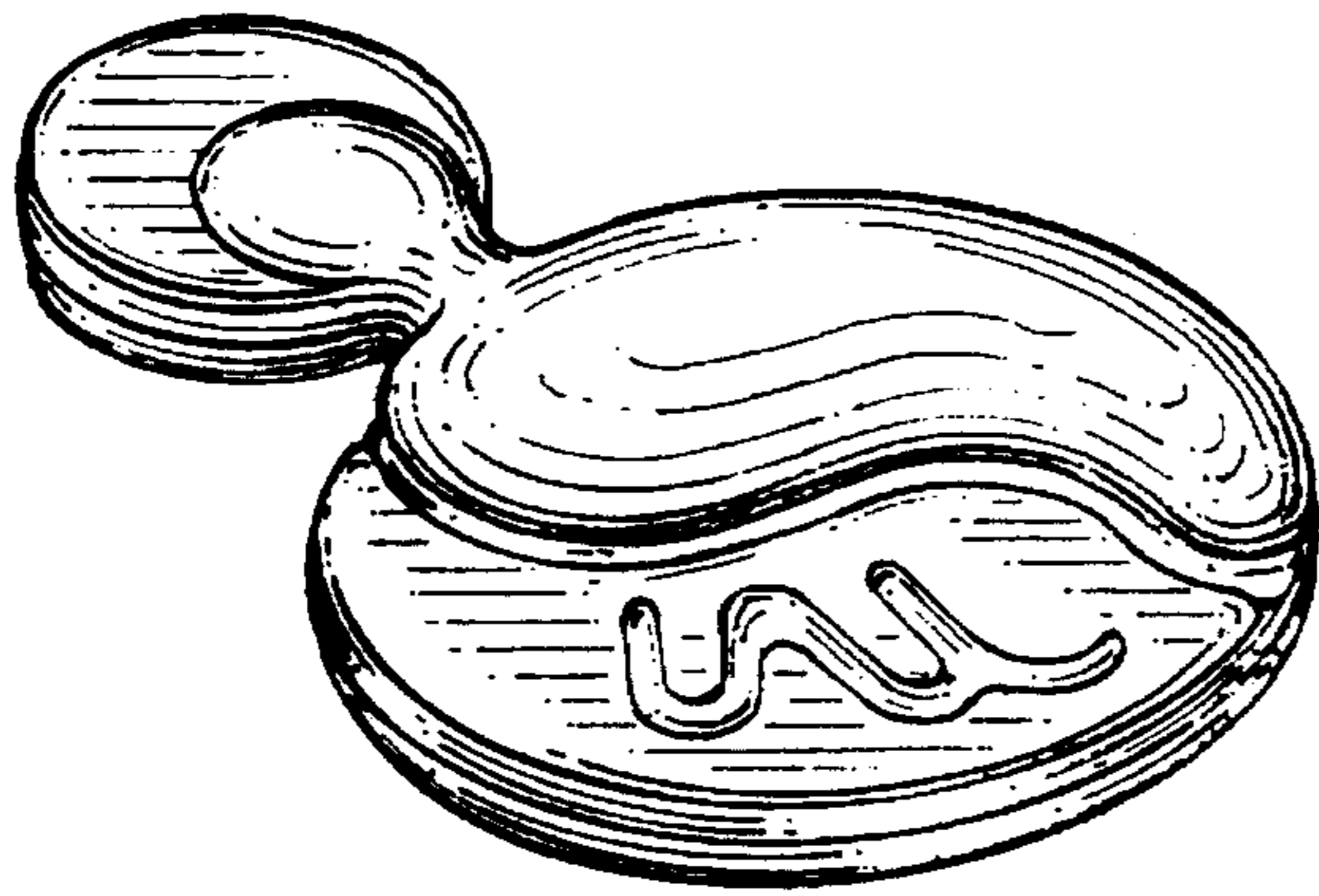

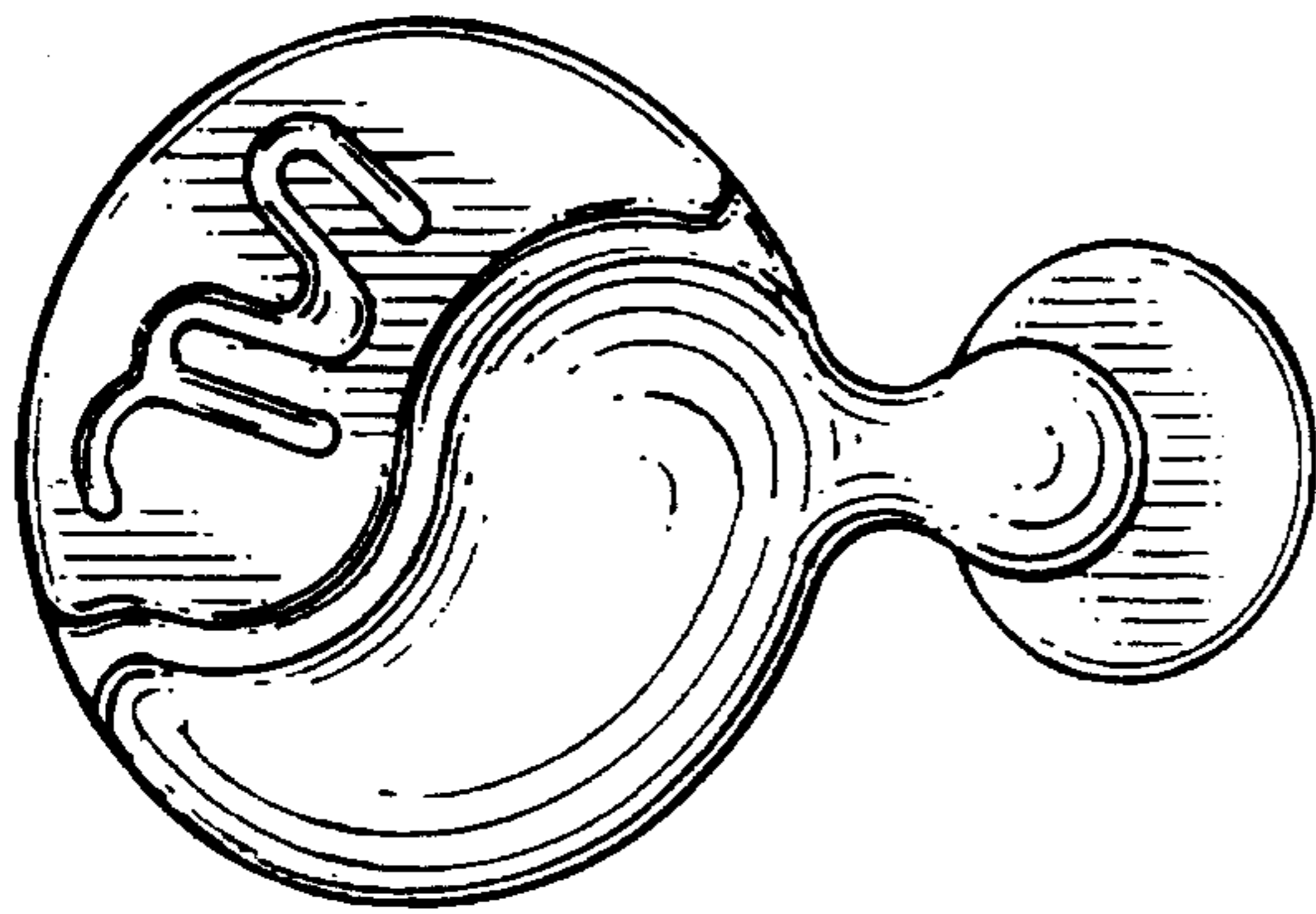

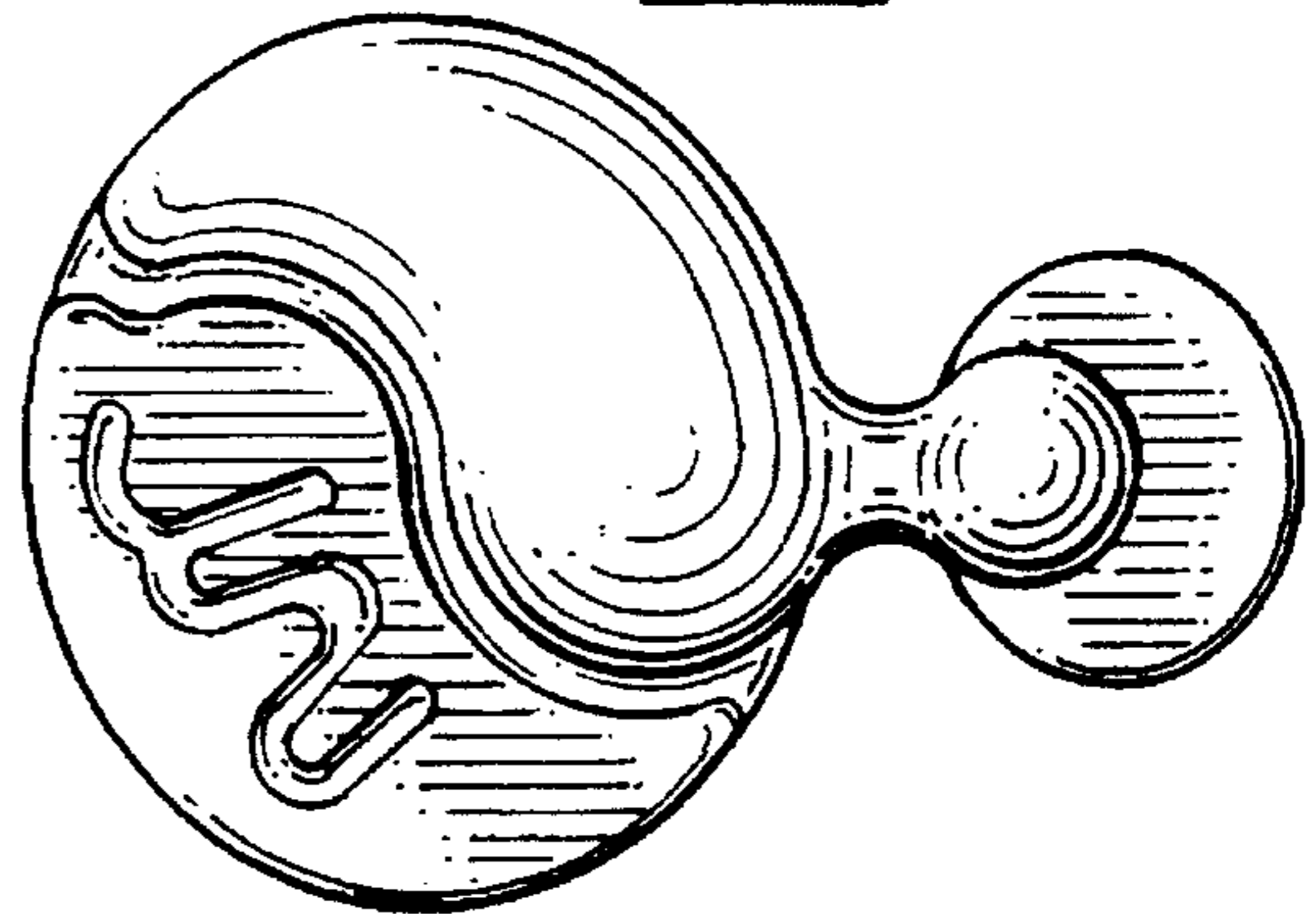

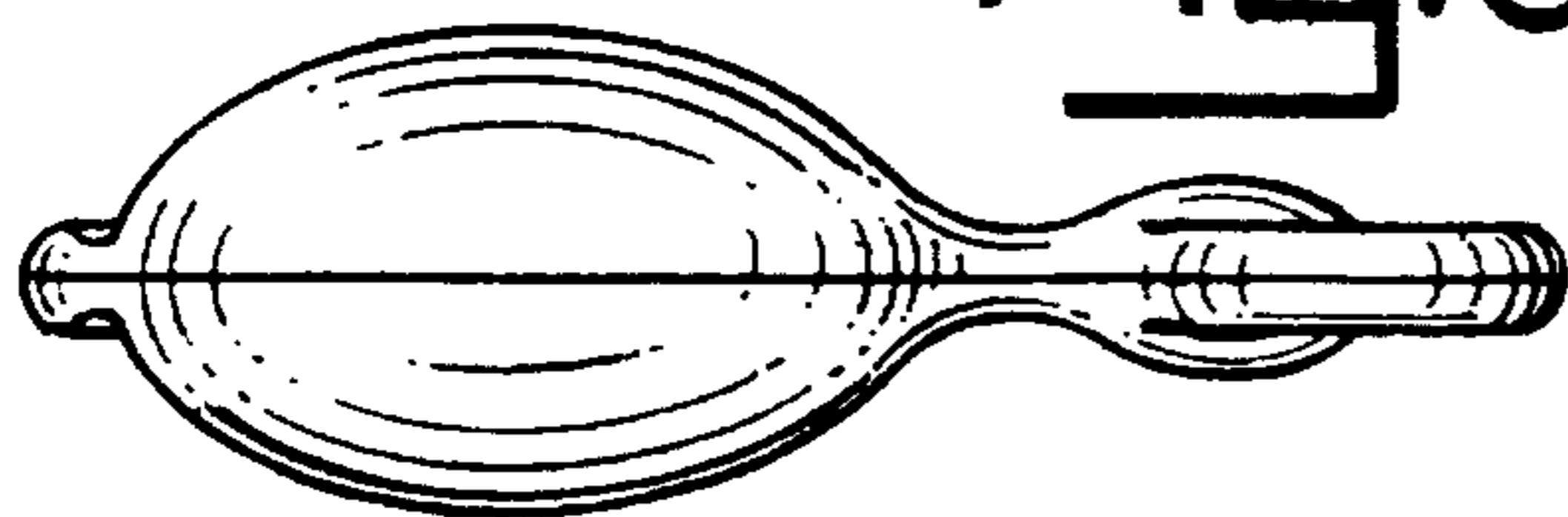

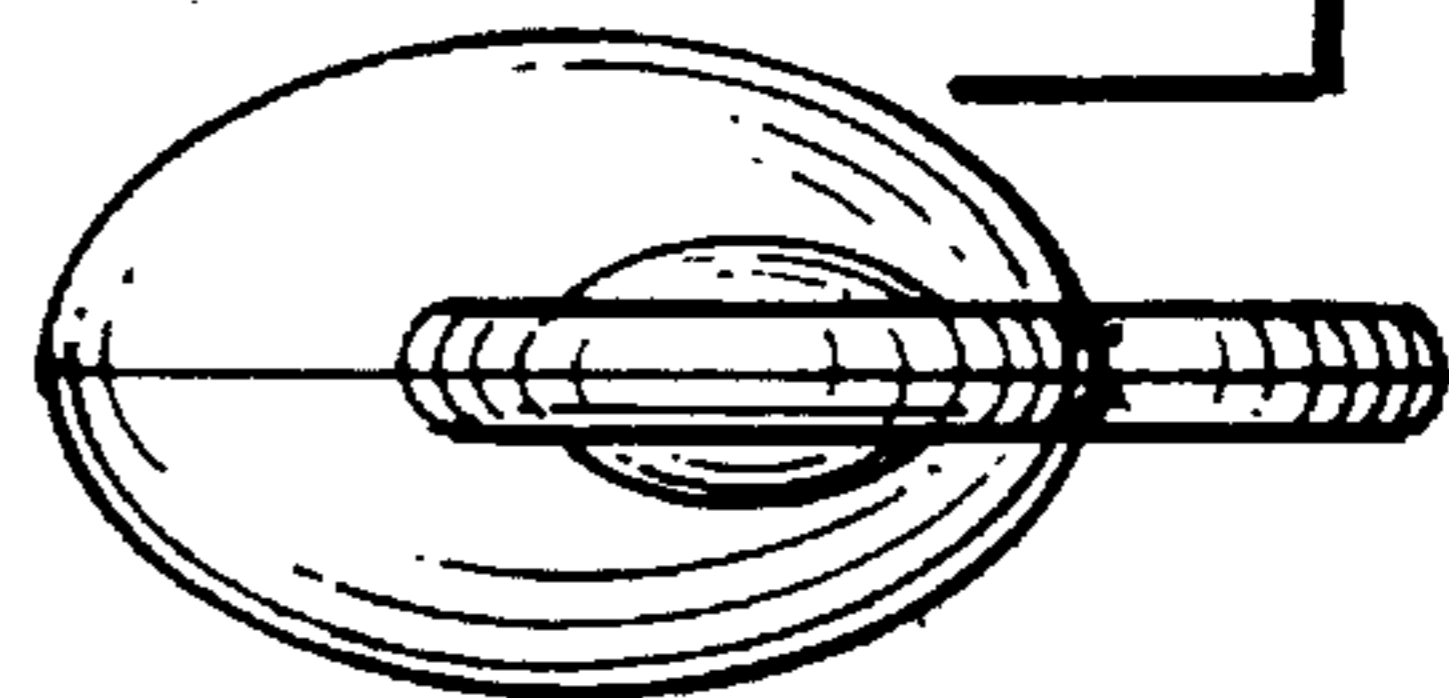

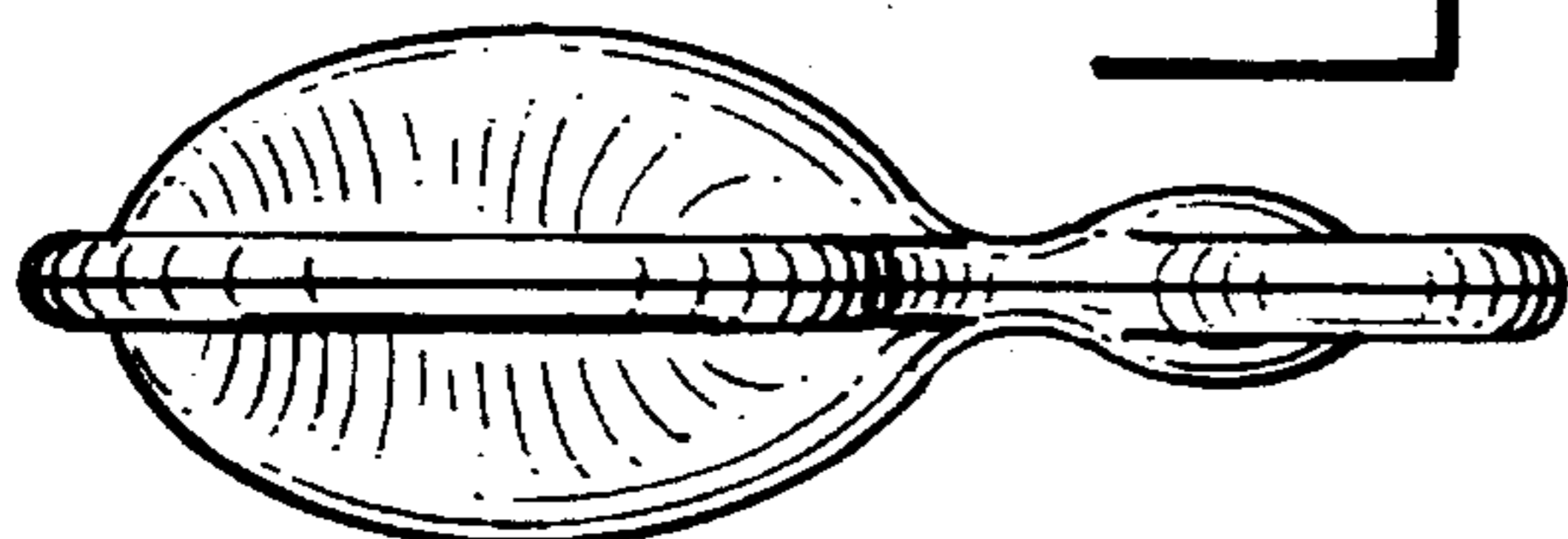
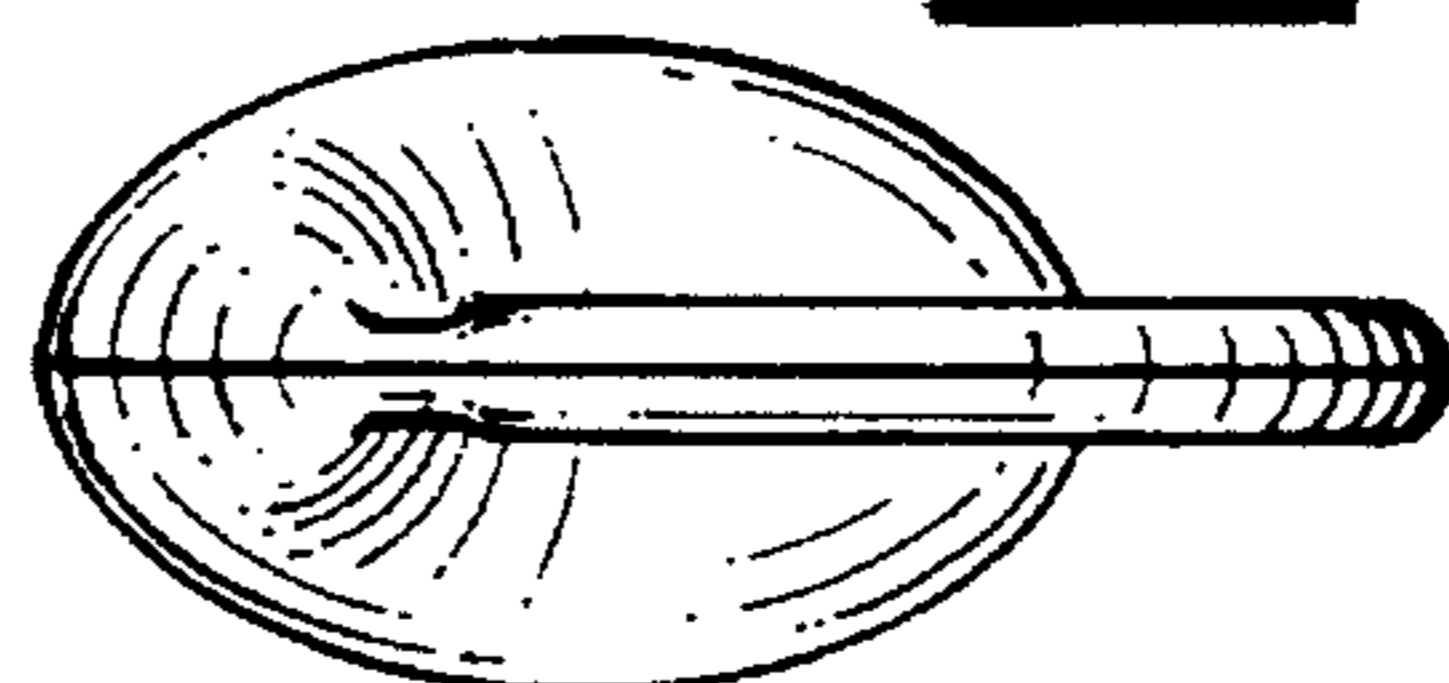

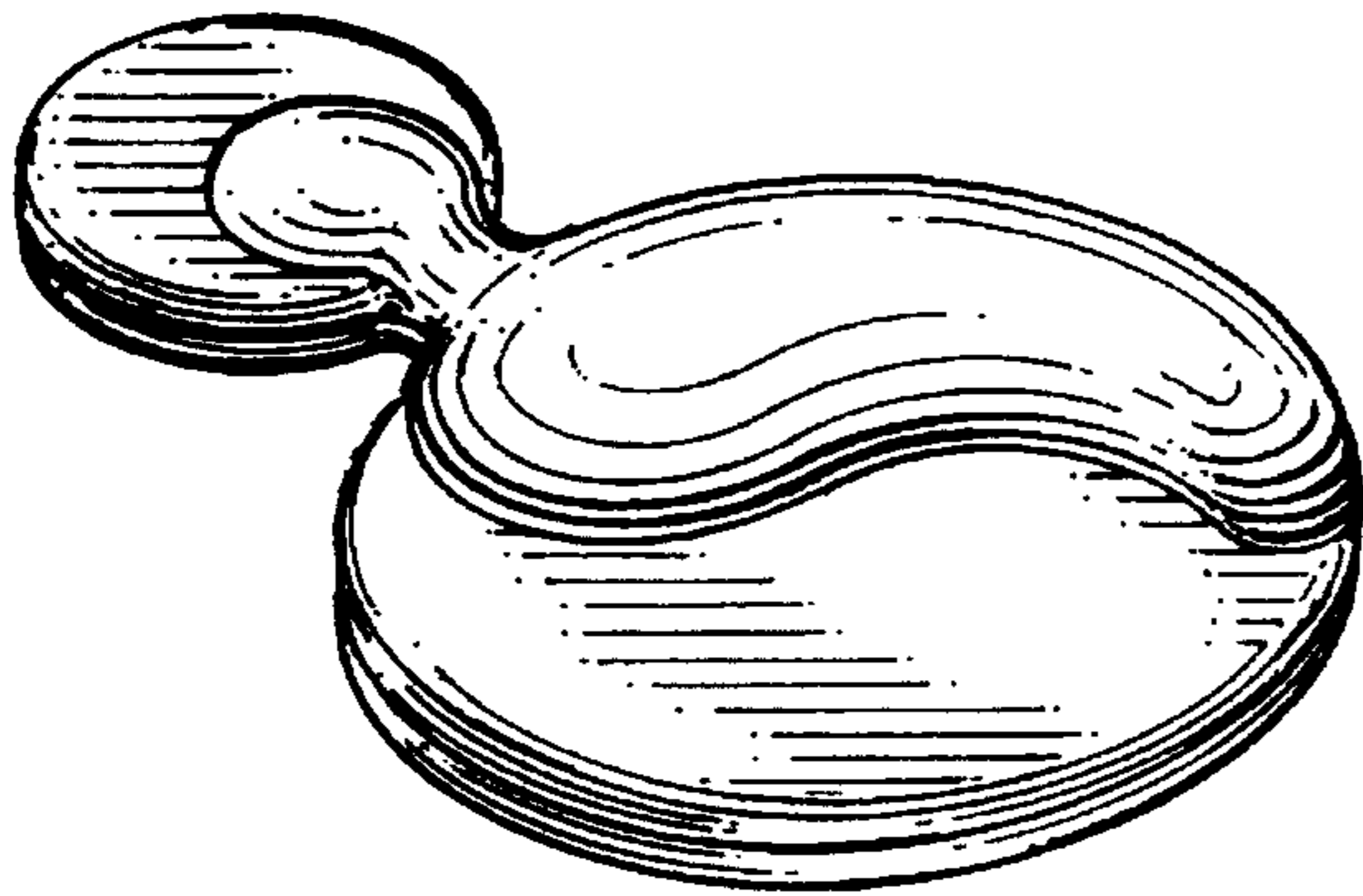

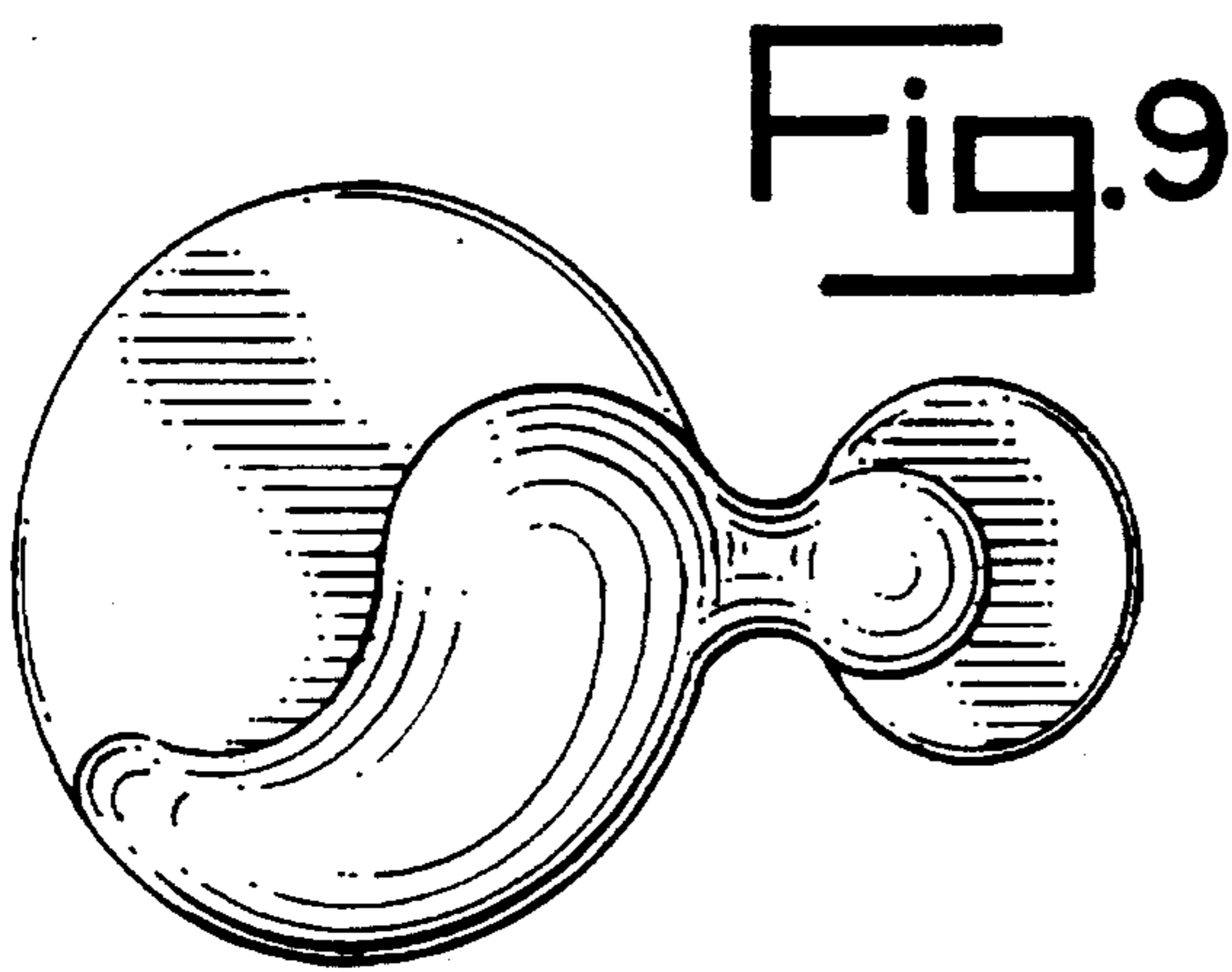

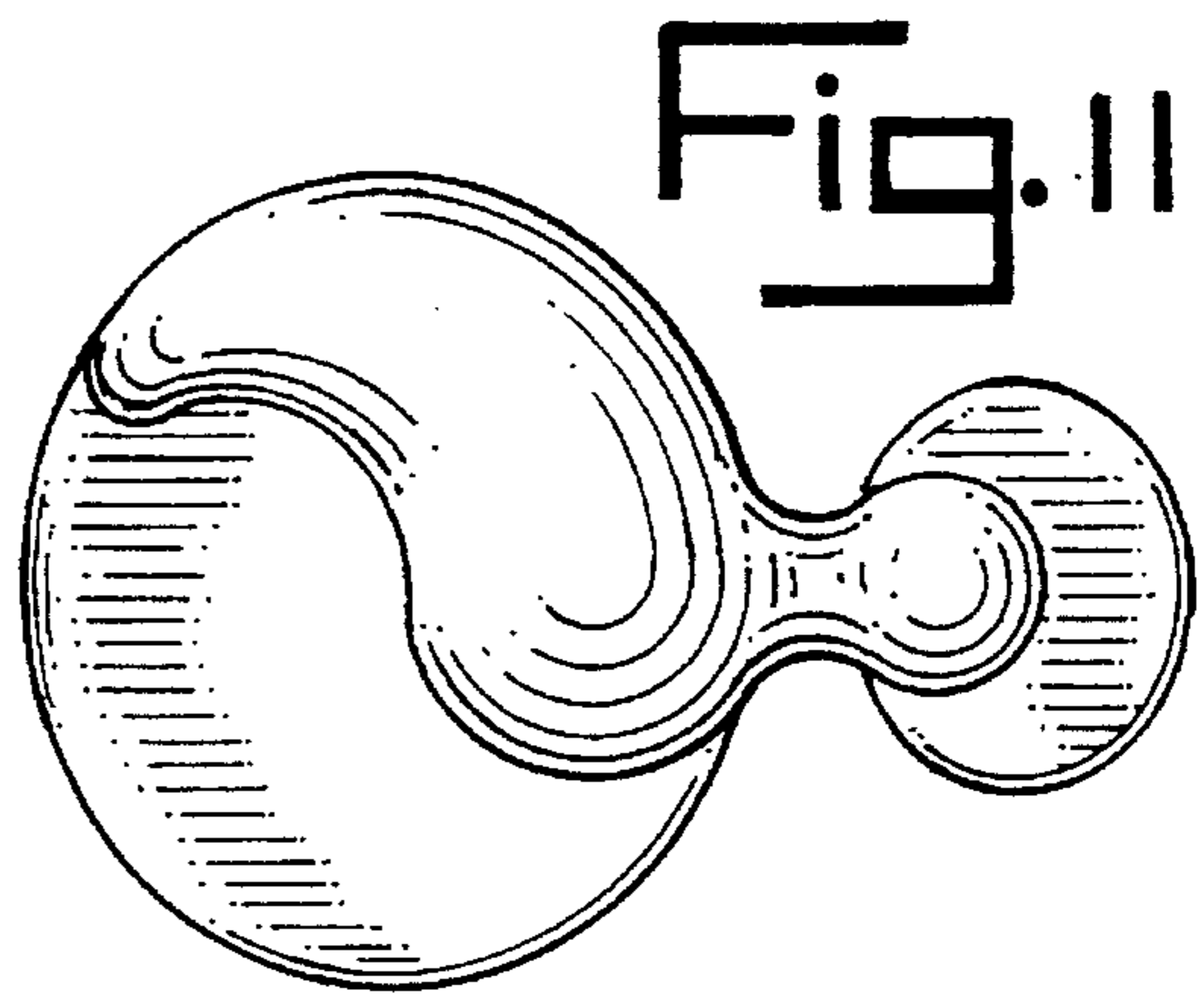

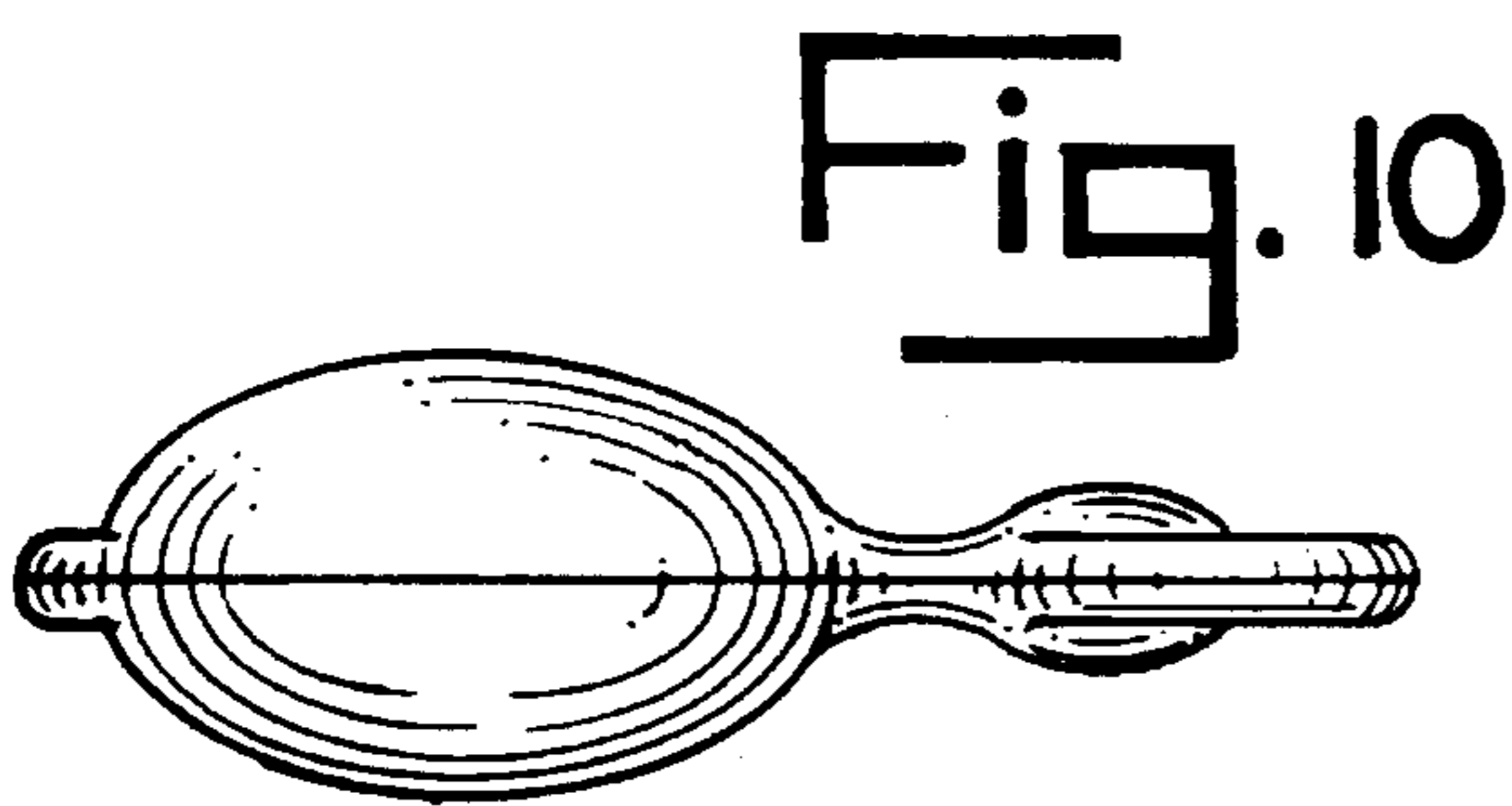

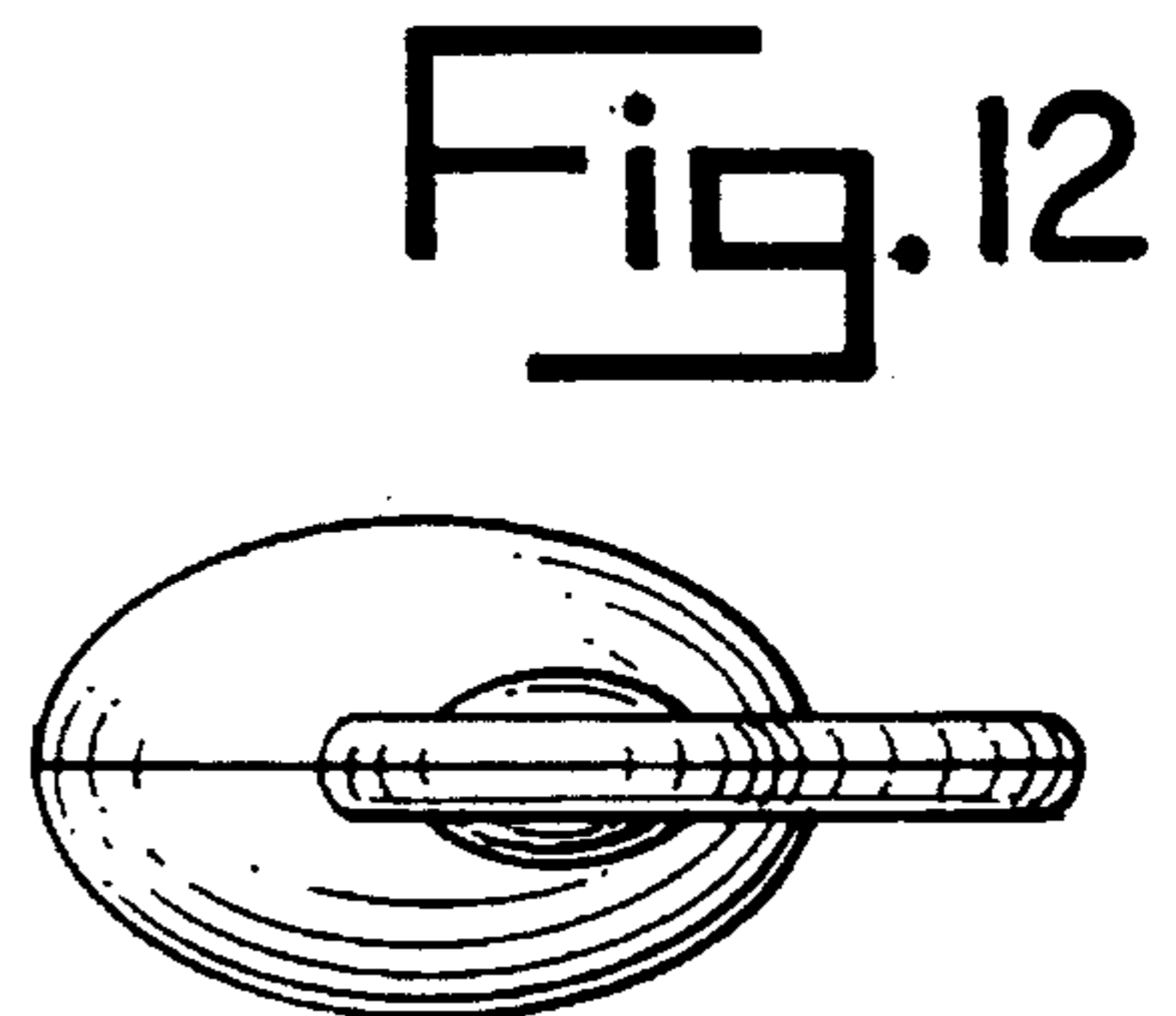

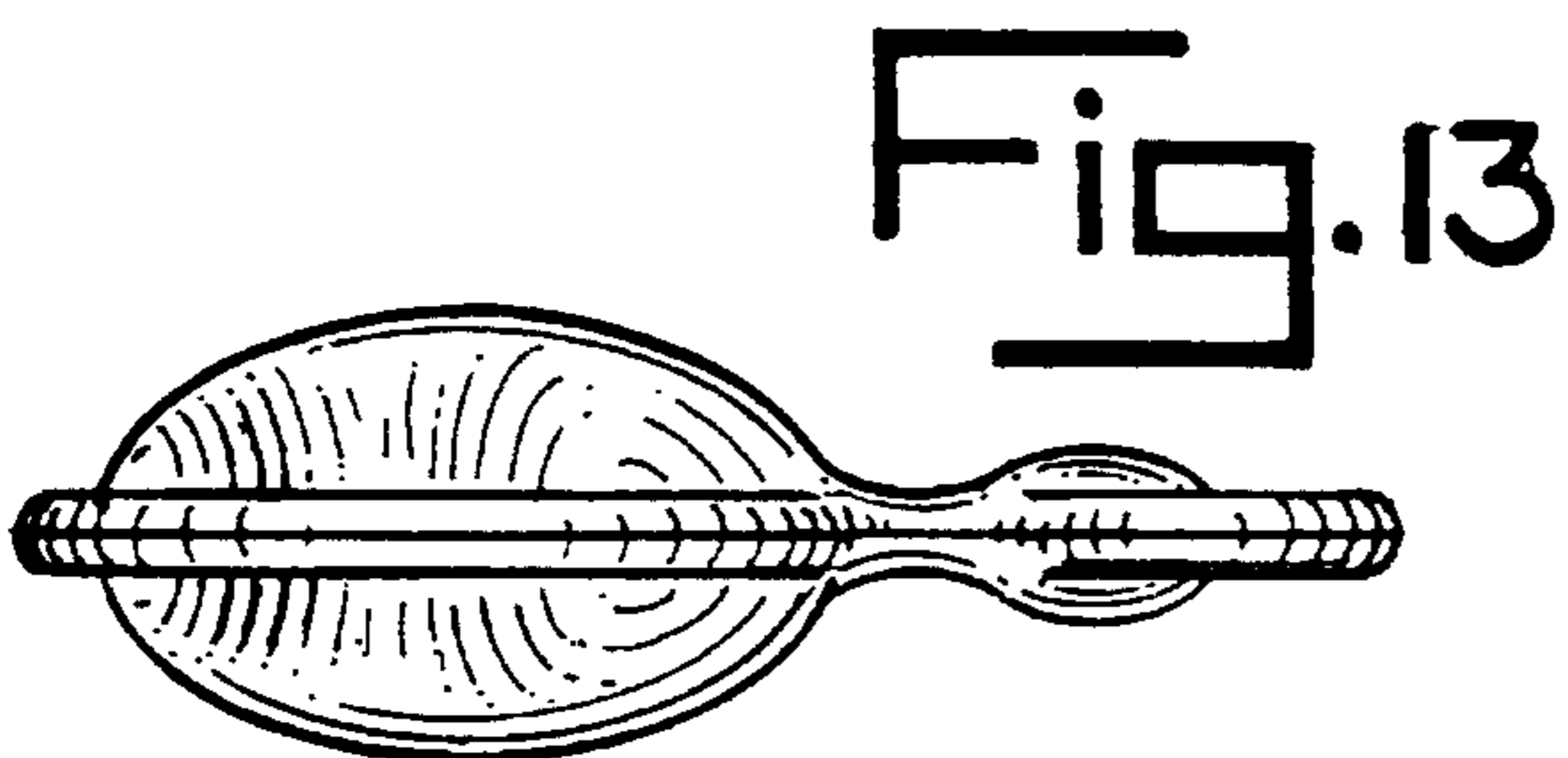

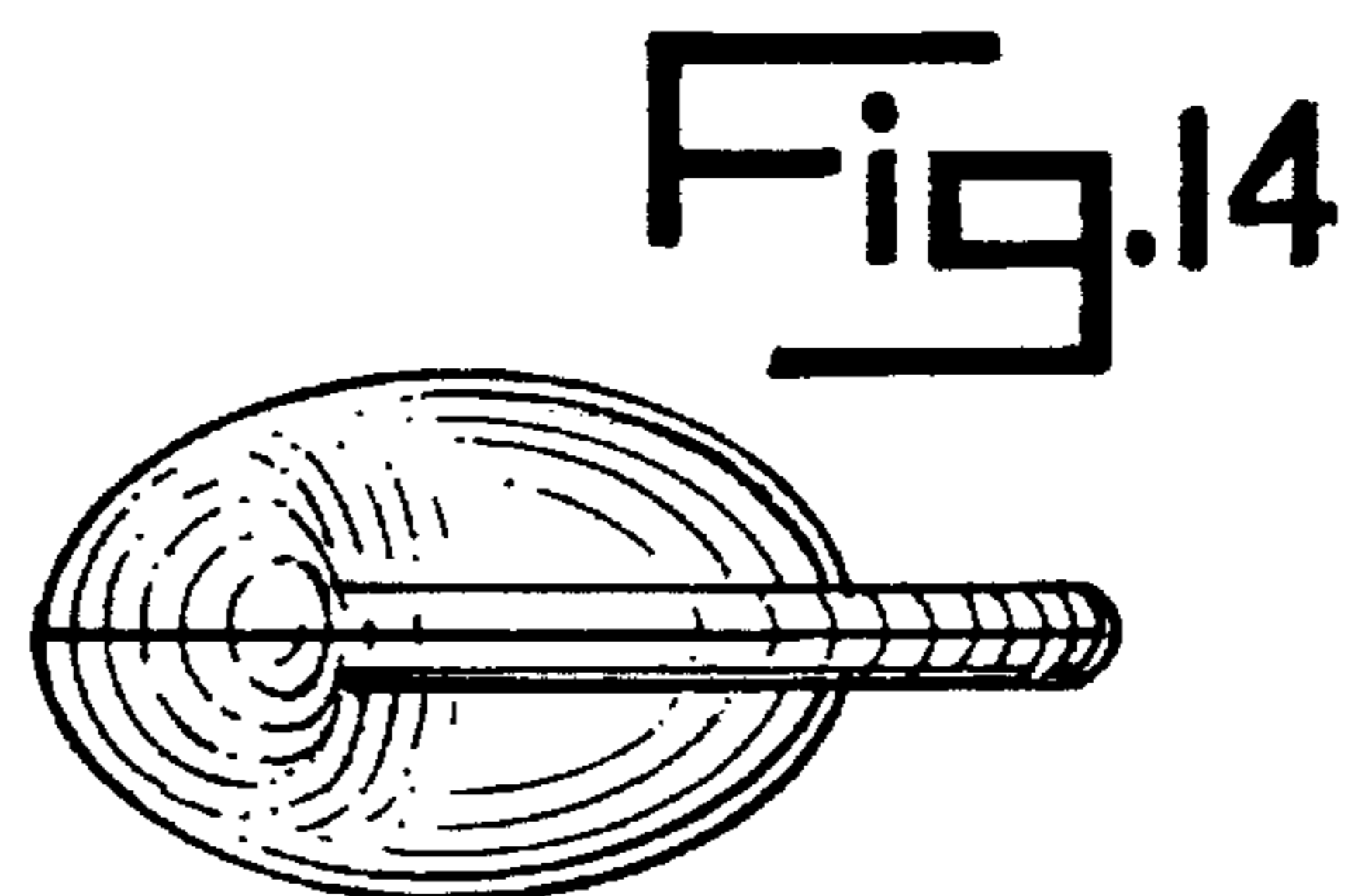

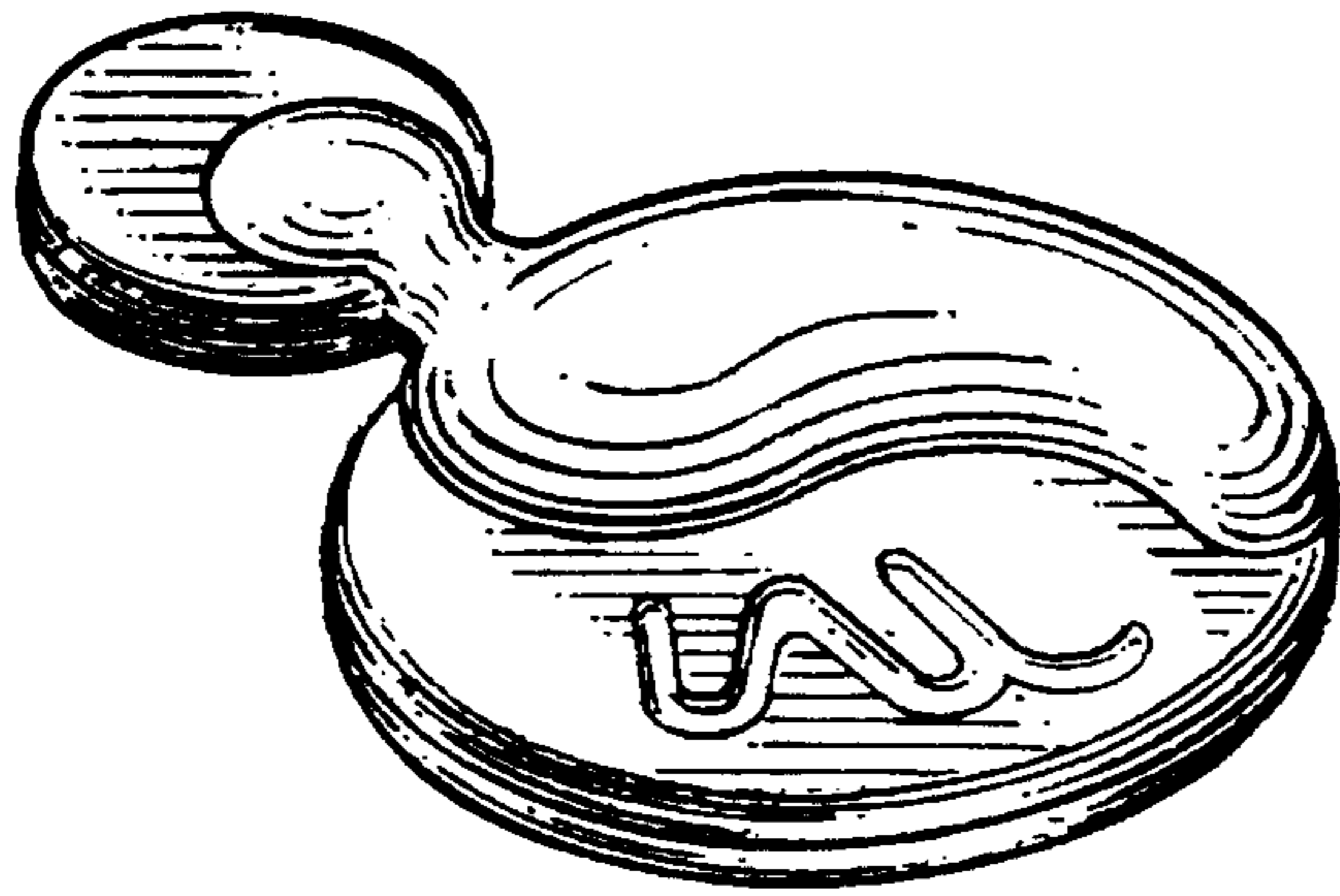

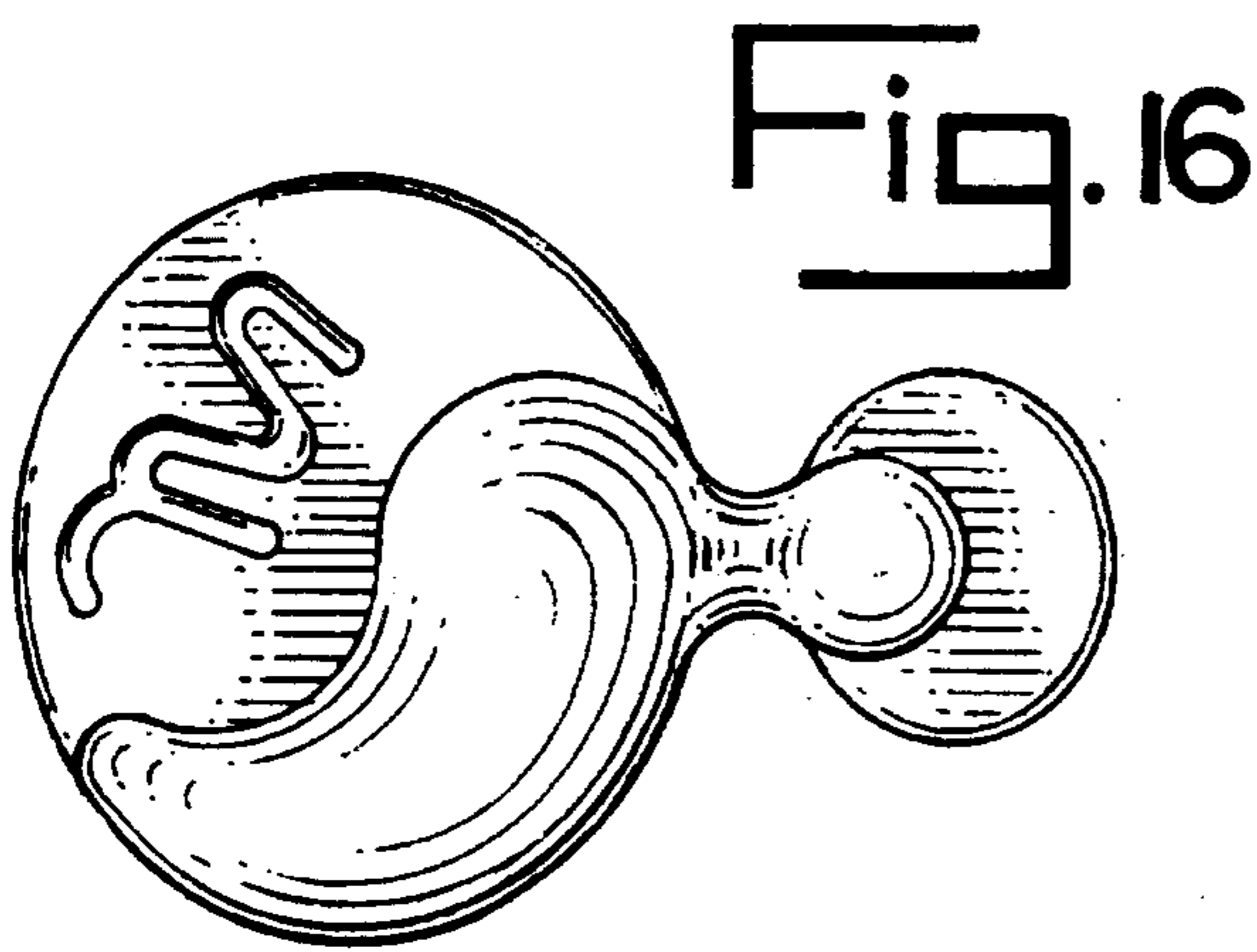

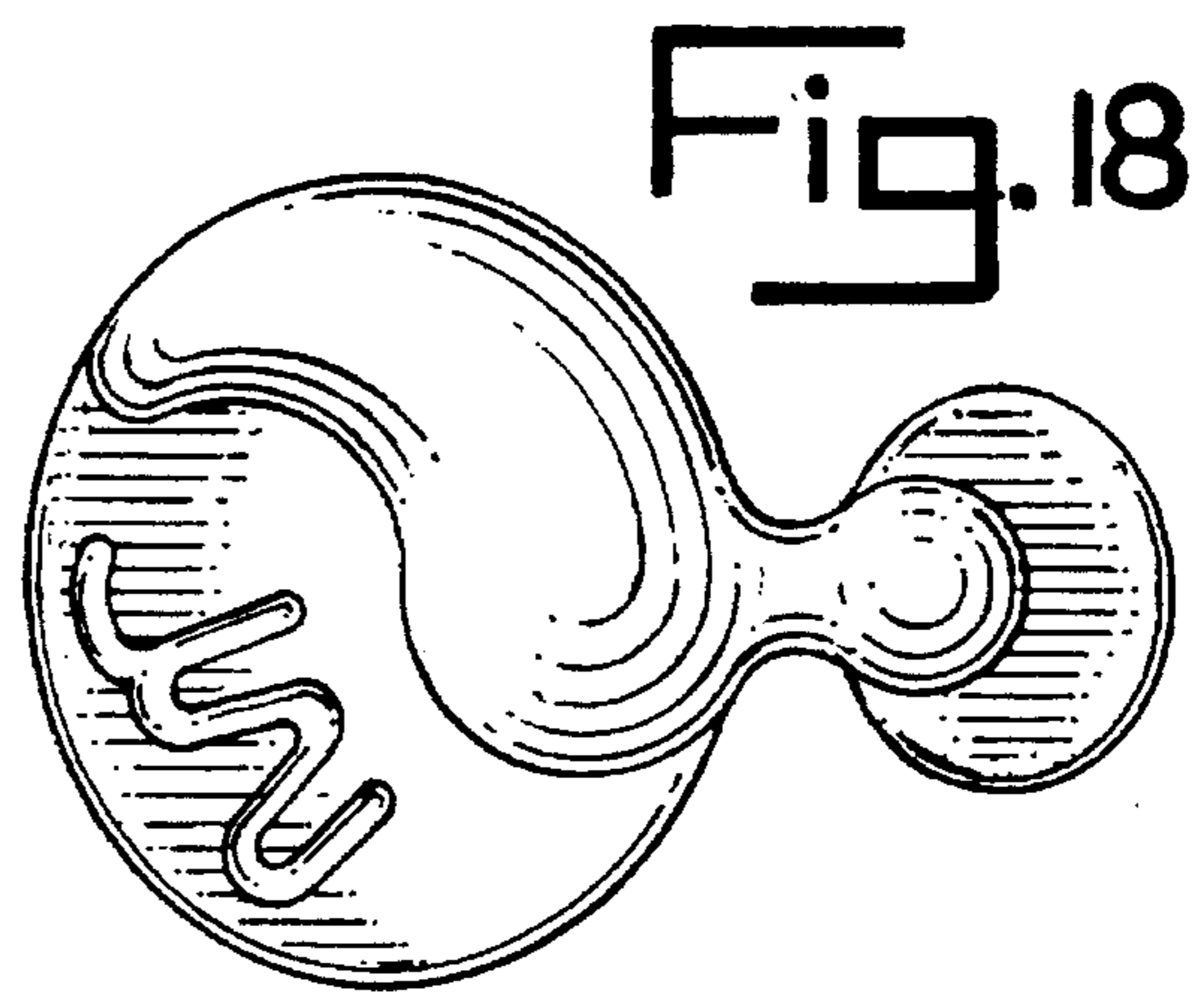

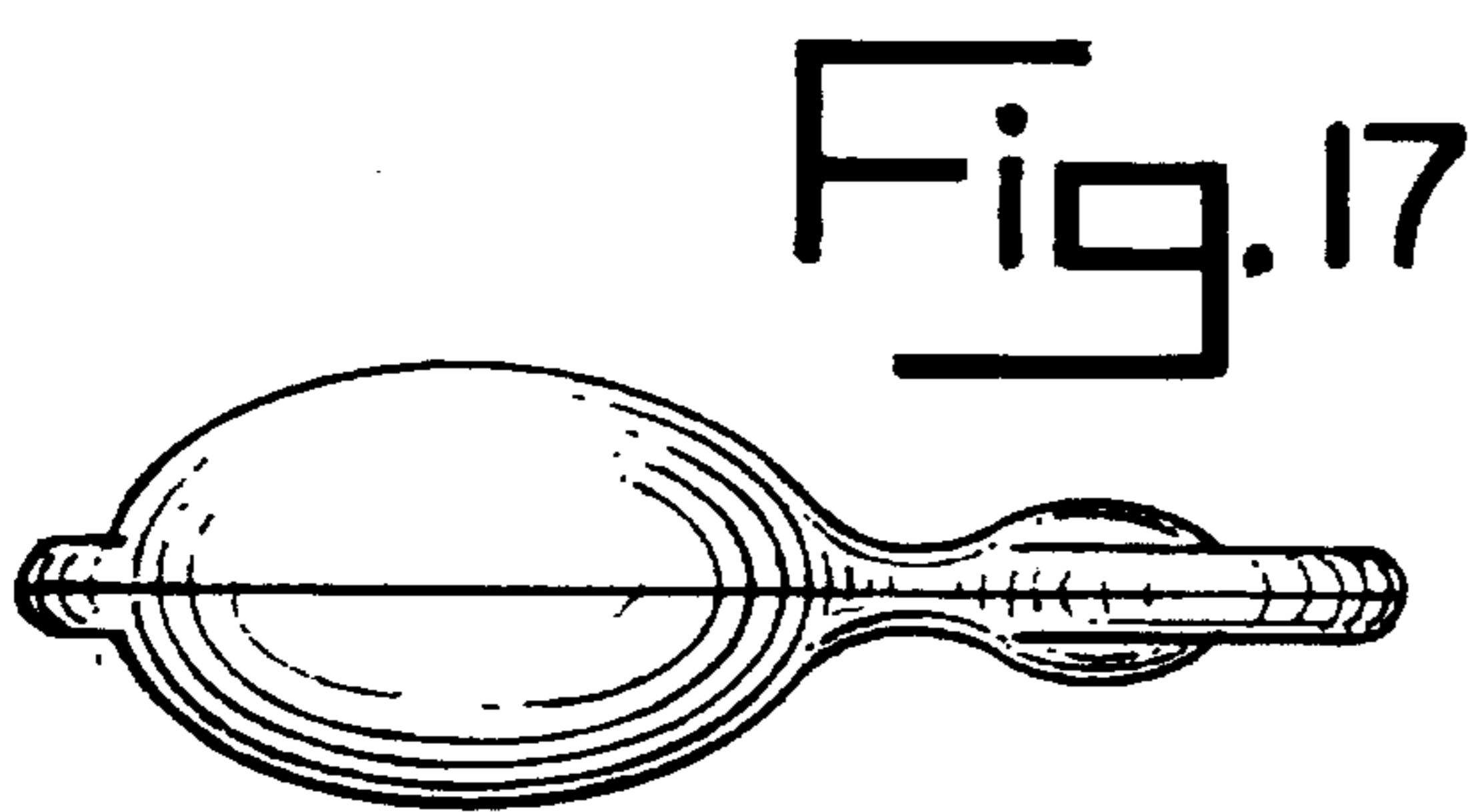

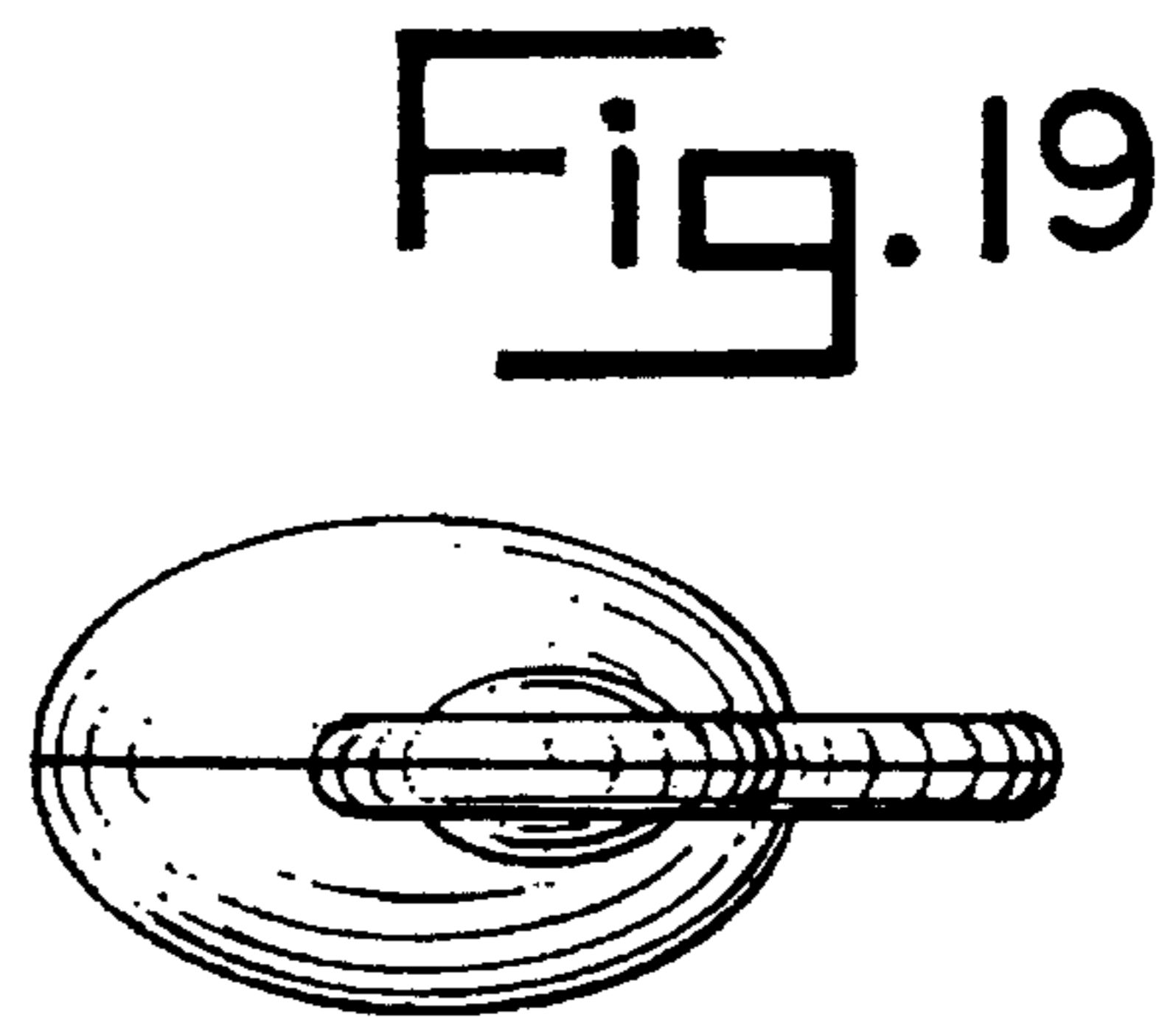

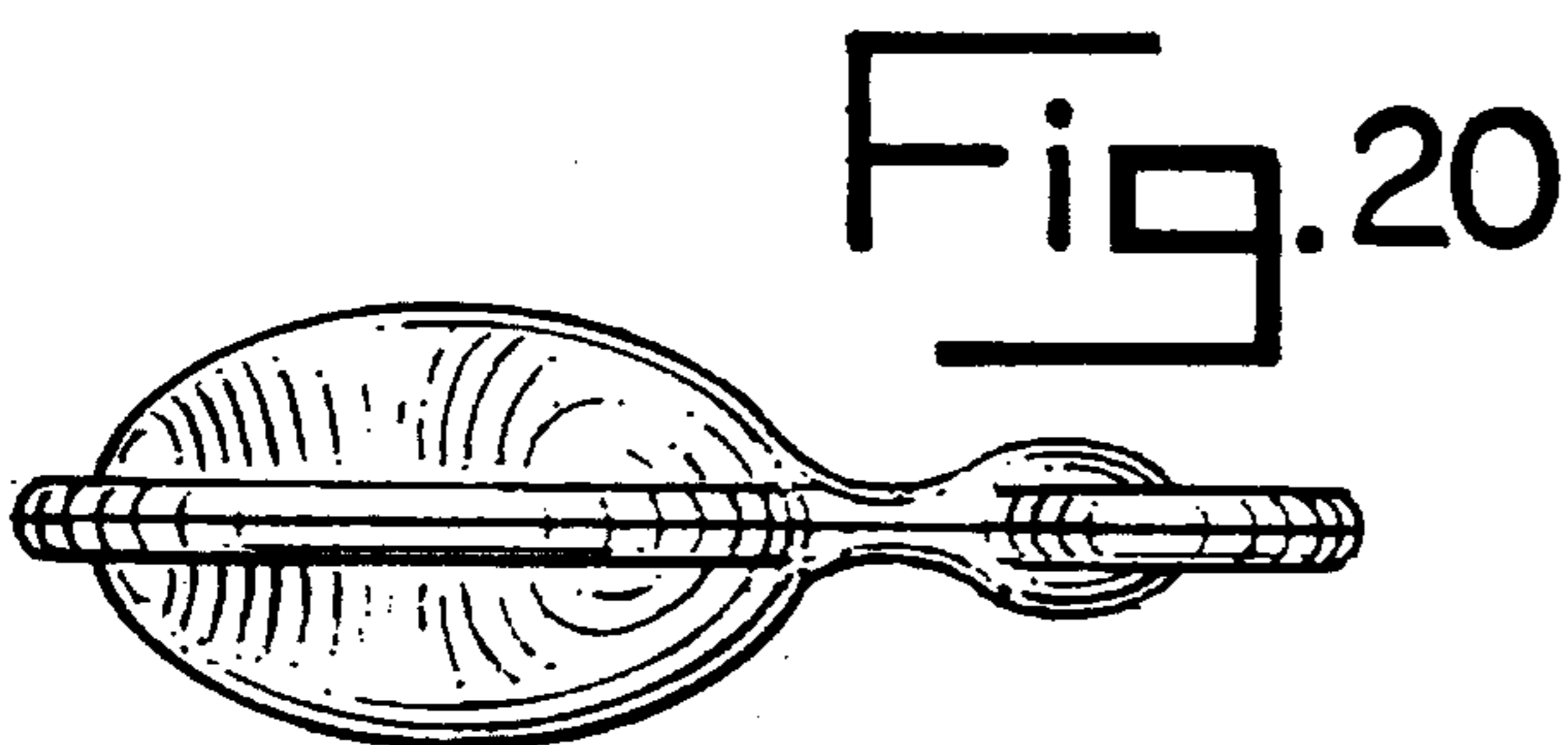

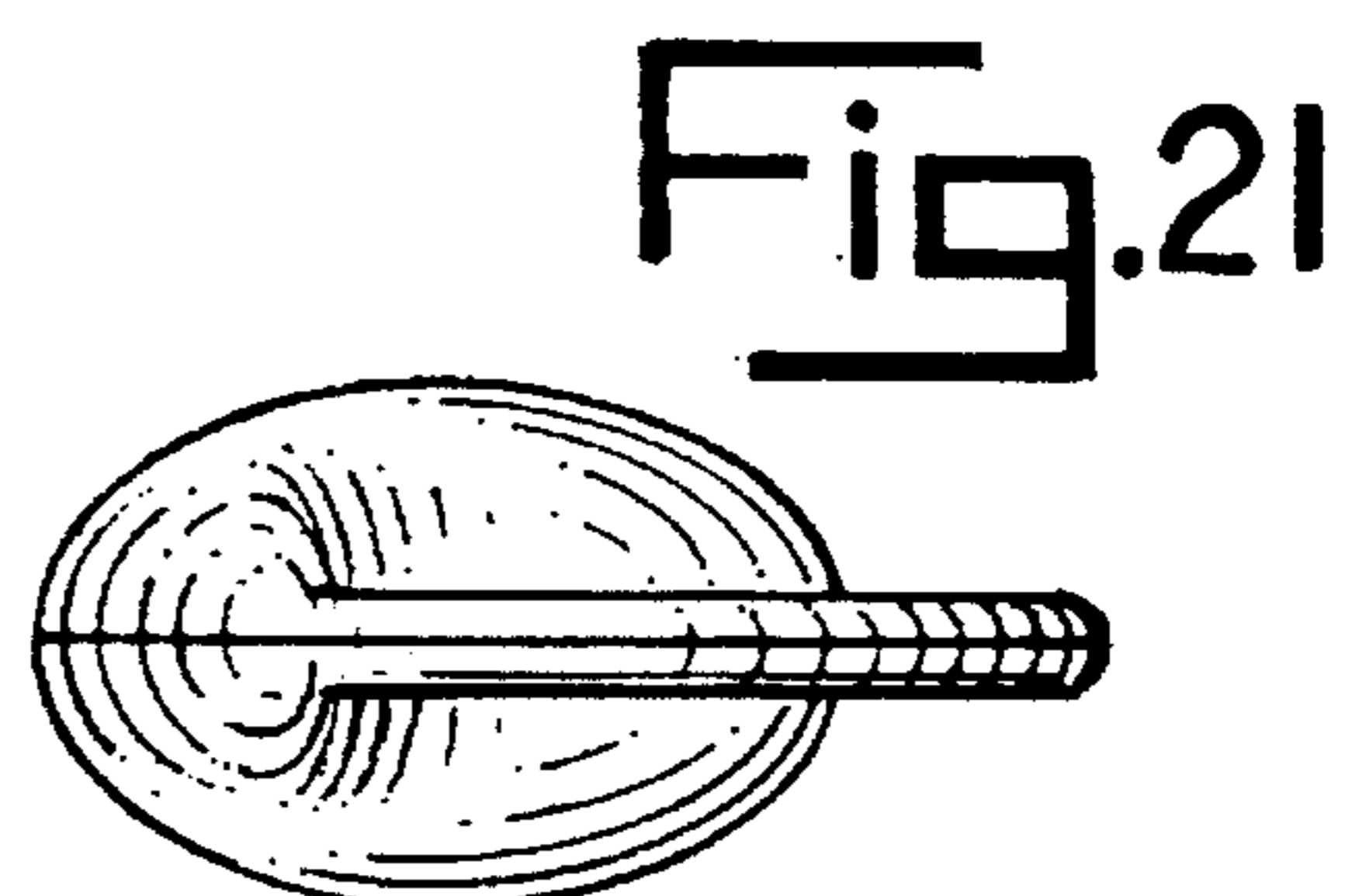
