[57] **CLAIM**

The ornamental design for a garment for covering an animal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the garment for covering an animal;

FIG. 2 is a side perspective view thereof, the opposite side being a mirror image of the side shown;

FIG. 3 is a top plan view thereof;

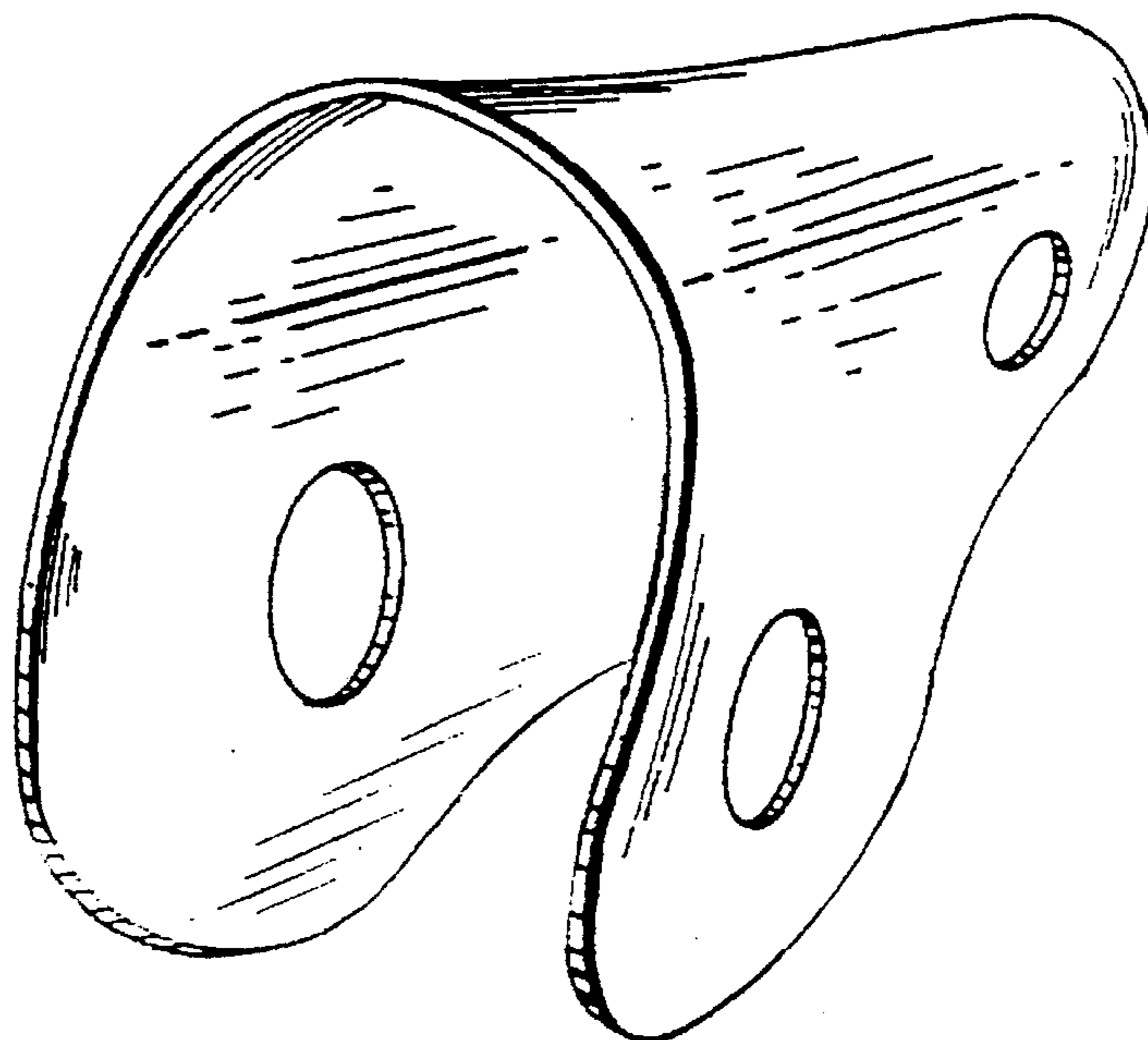
FIG. 4 is a front elevational view thereof;

FIG. 5 is an enlarged rear elevational view thereof; and,

FIG. 6 is a bottom plan view thereof.

The dashed lines illustrate conventional stitching.

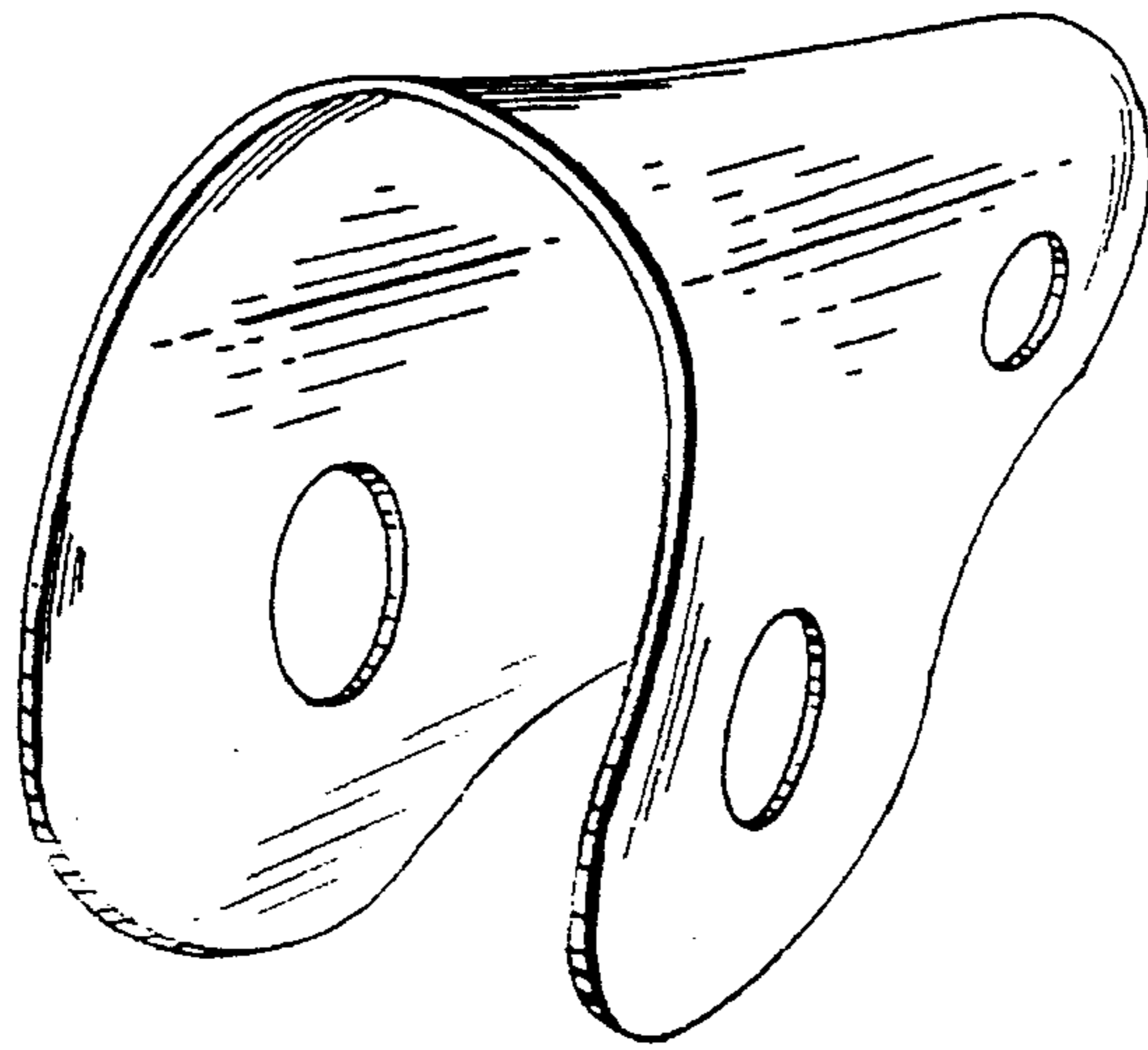

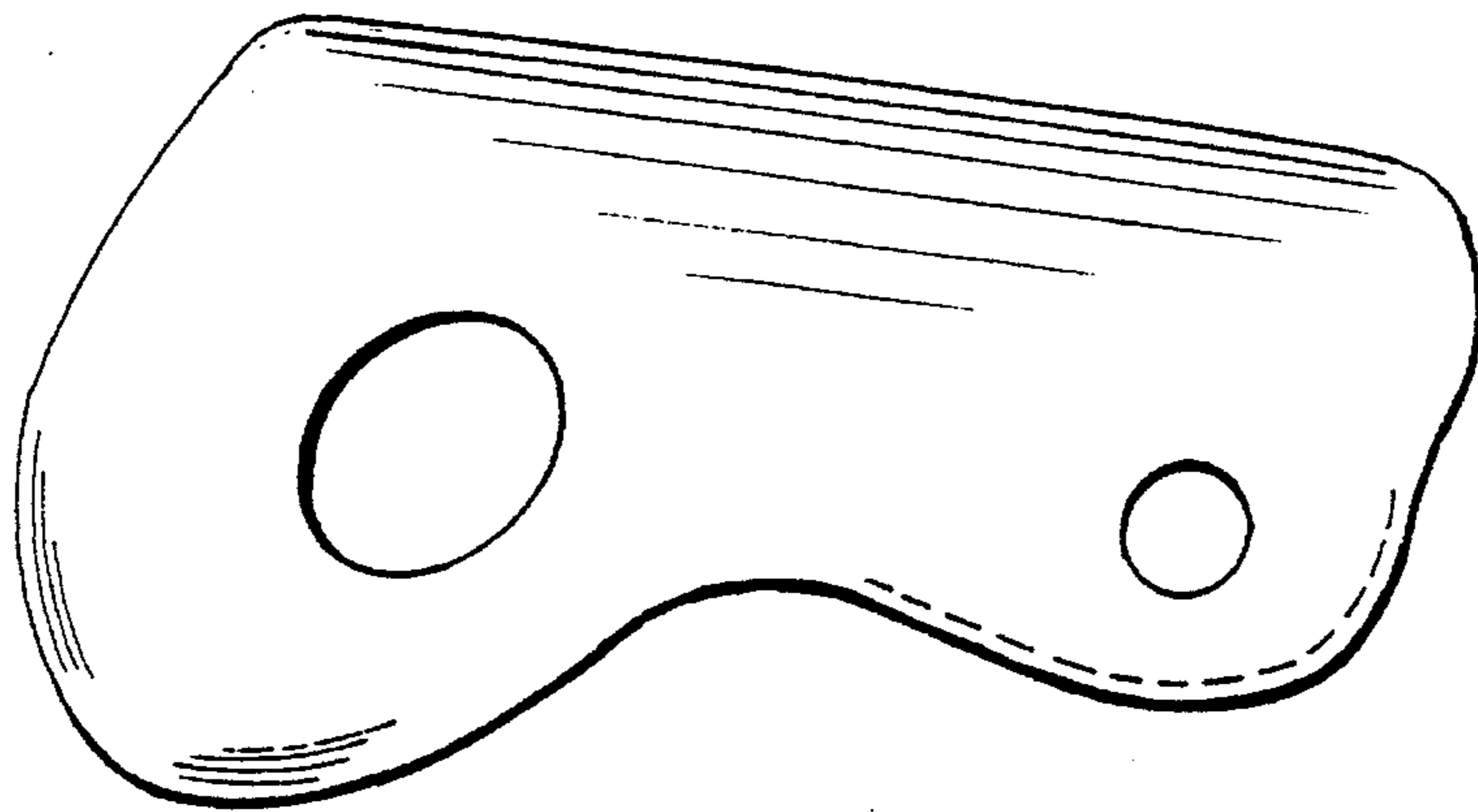

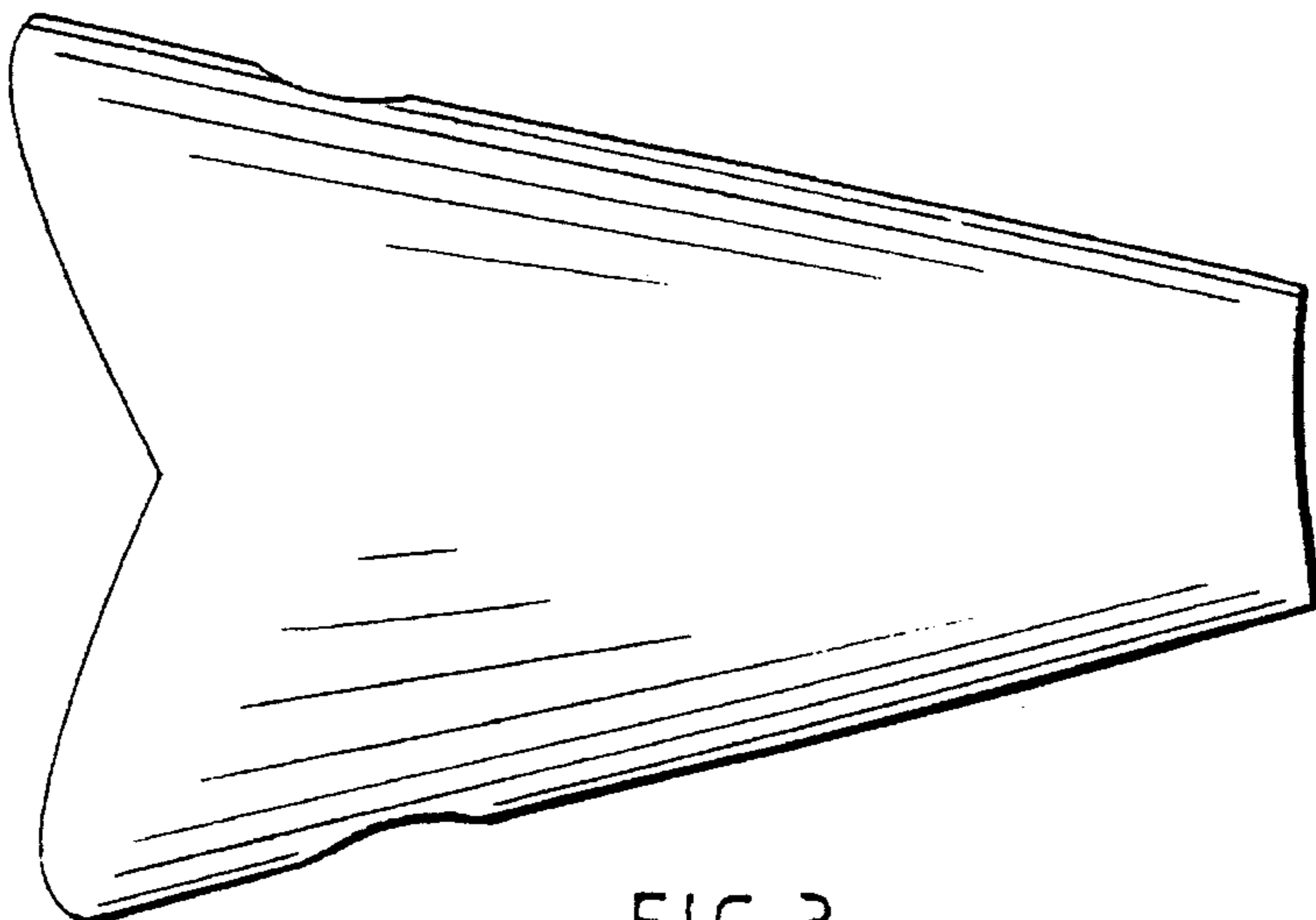

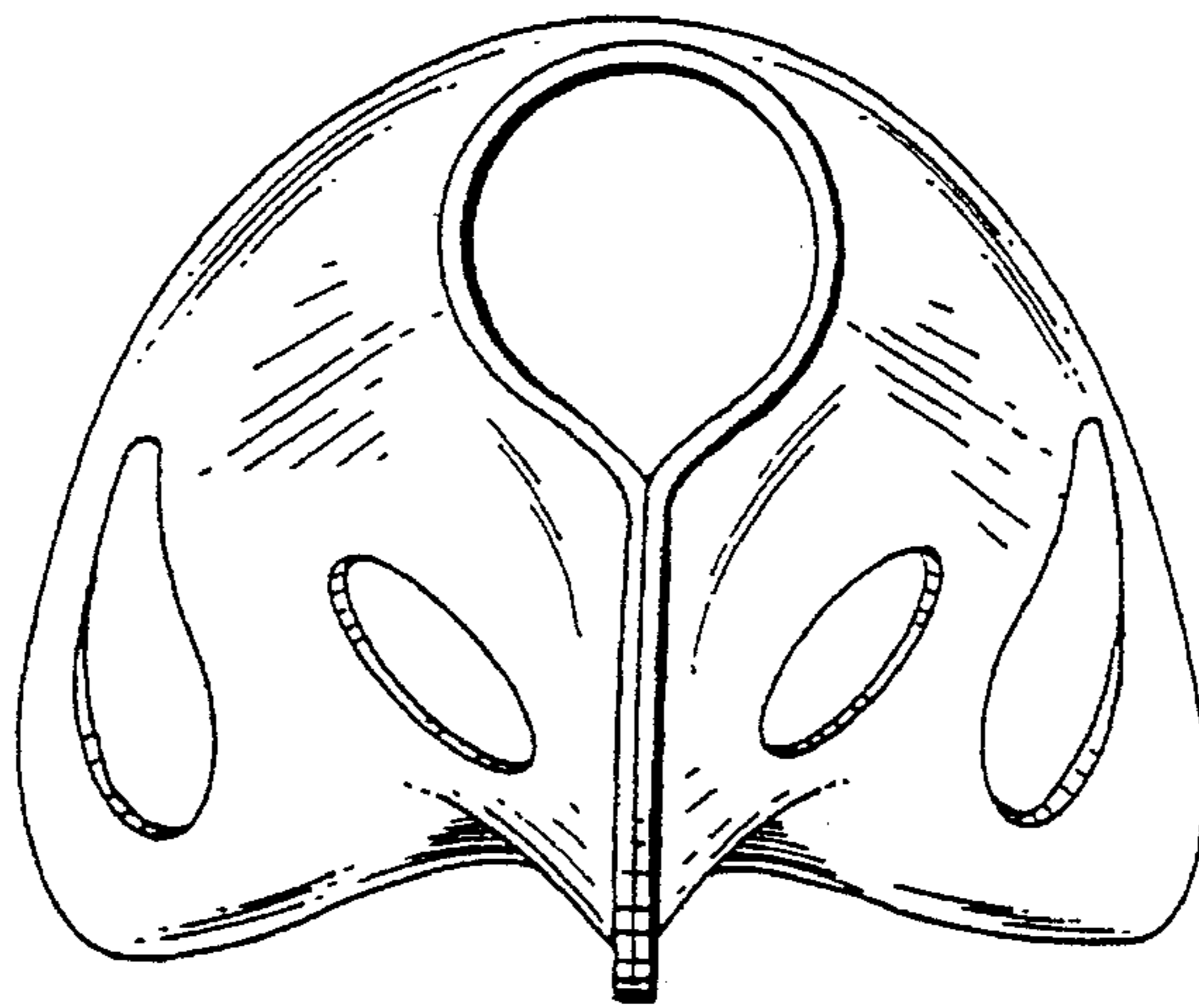

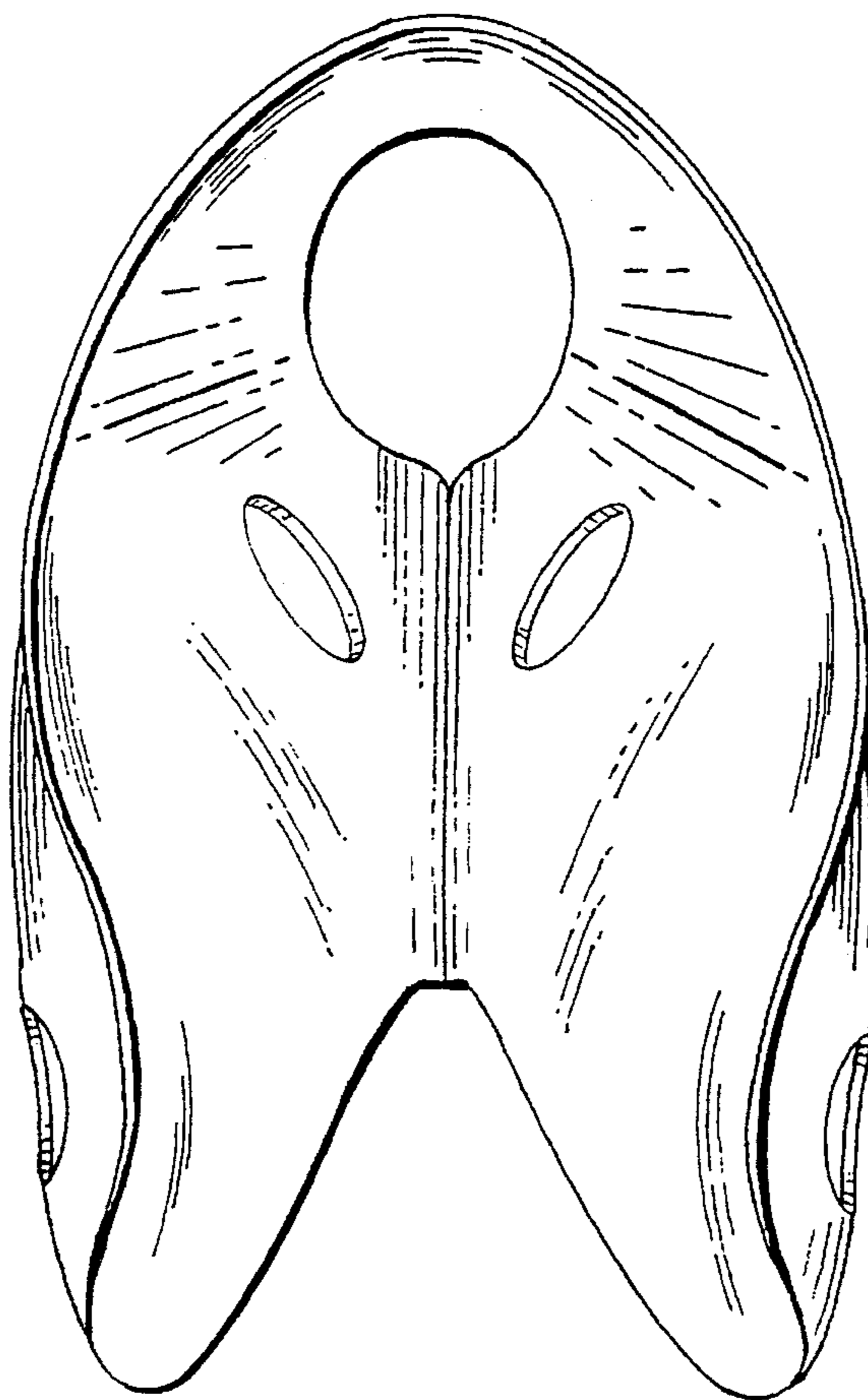

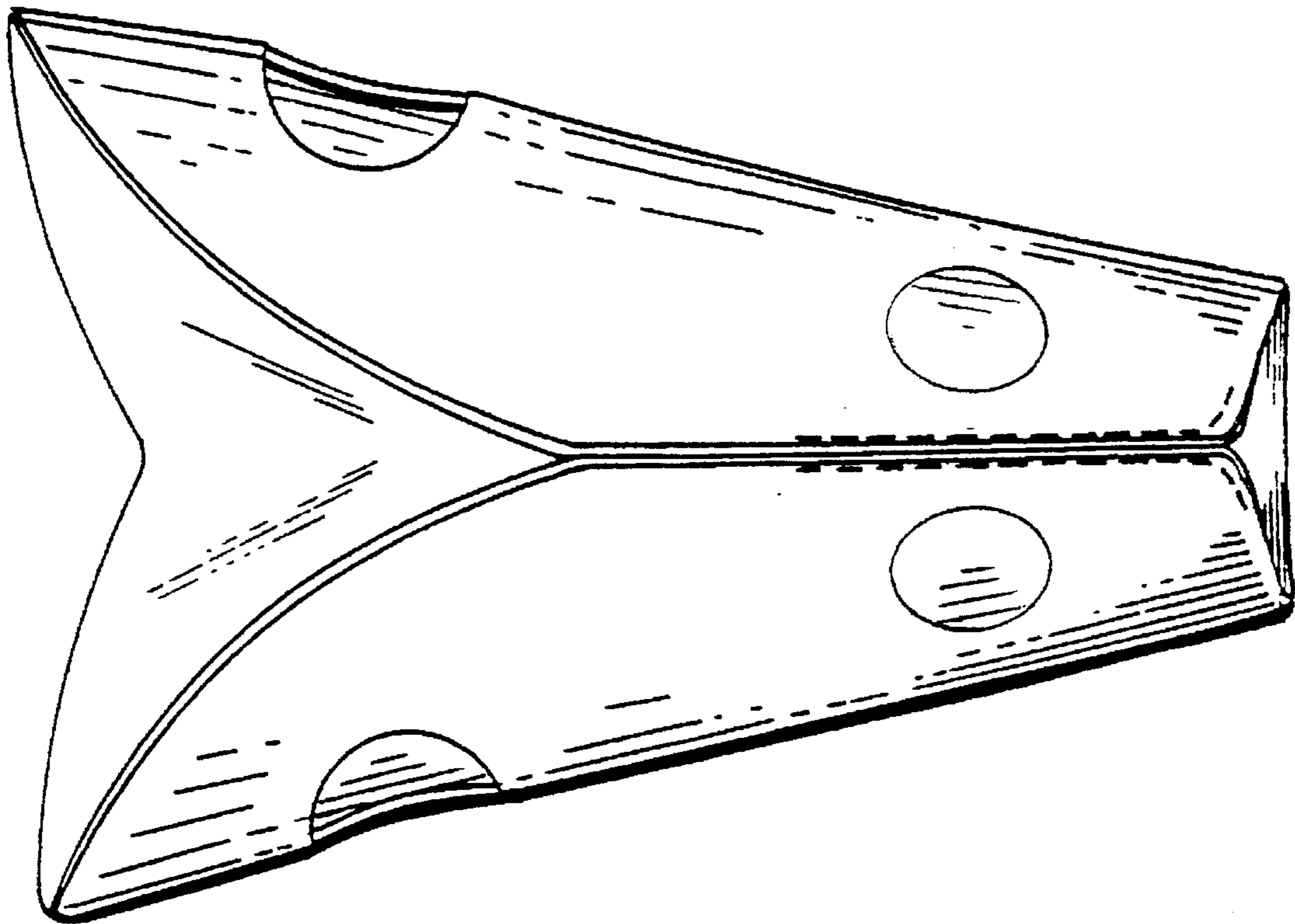
