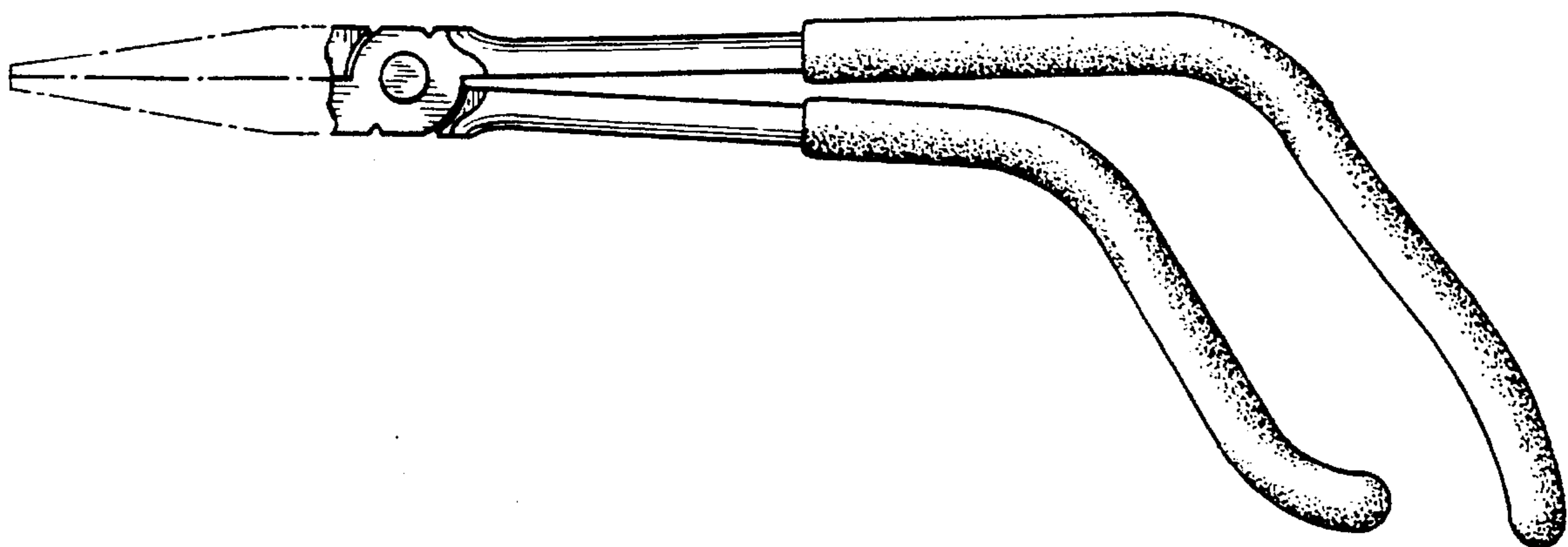
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a right side elevational view of a tool handle, incorporating our new design;
 FIG. 2 is a side elevational view of the other side thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a front elevational view thereof; and,
 FIG. 6 is a rear elevational view thereof.
 The broken line showings of the jaws are for illustrative purposes only and form no part of the claimed design.

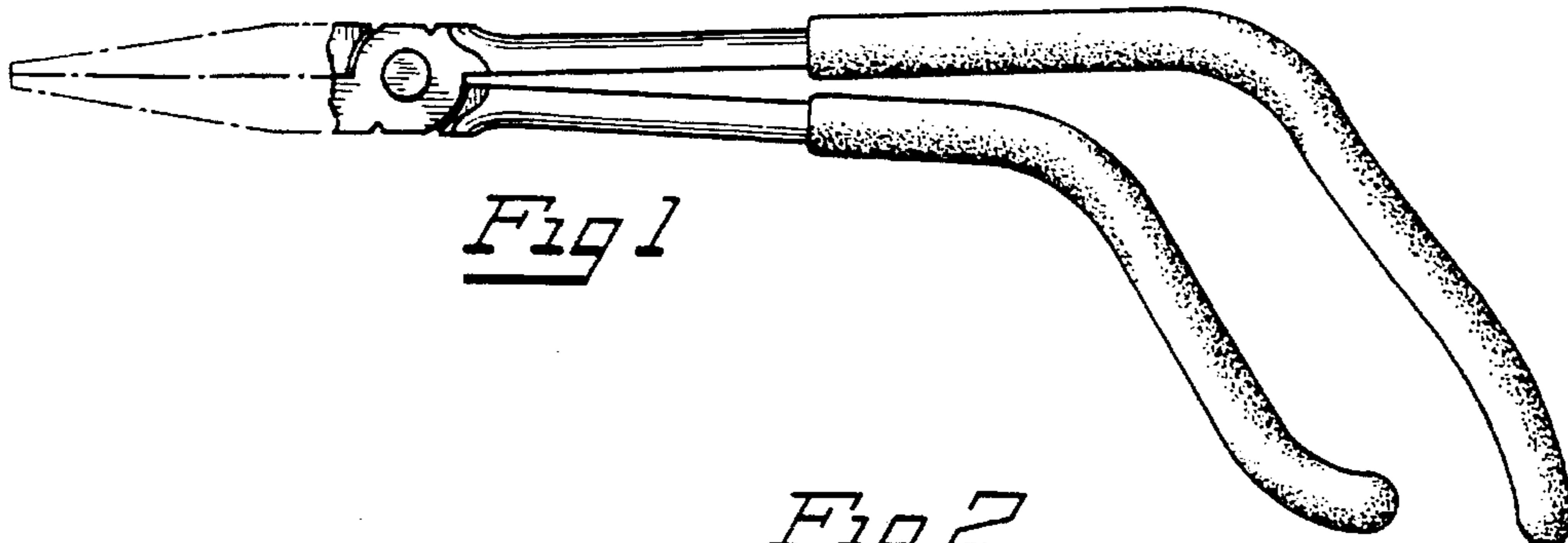

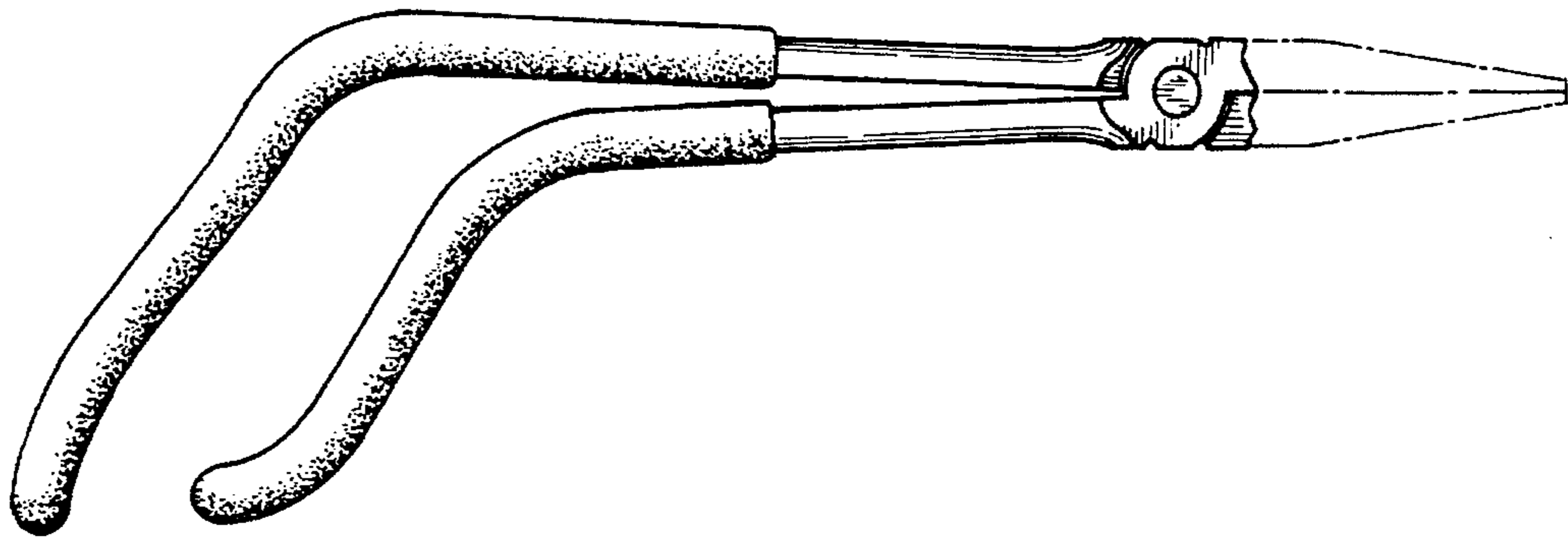
