[57] CLAIM

The ornamental design for a print cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a print cartridge showing our new design;

FIG. 2 is a left side elevation view of our new design;

FIG. 3 is a right side elevation view of our new design;

FIG. 4 is a rear elevation view of our new design;

FIG. 5 is a front elevation view of our new design;

FIG. 6 is a top plan view of our new design;

FIG. 7 is a bottom plan view of our new design;

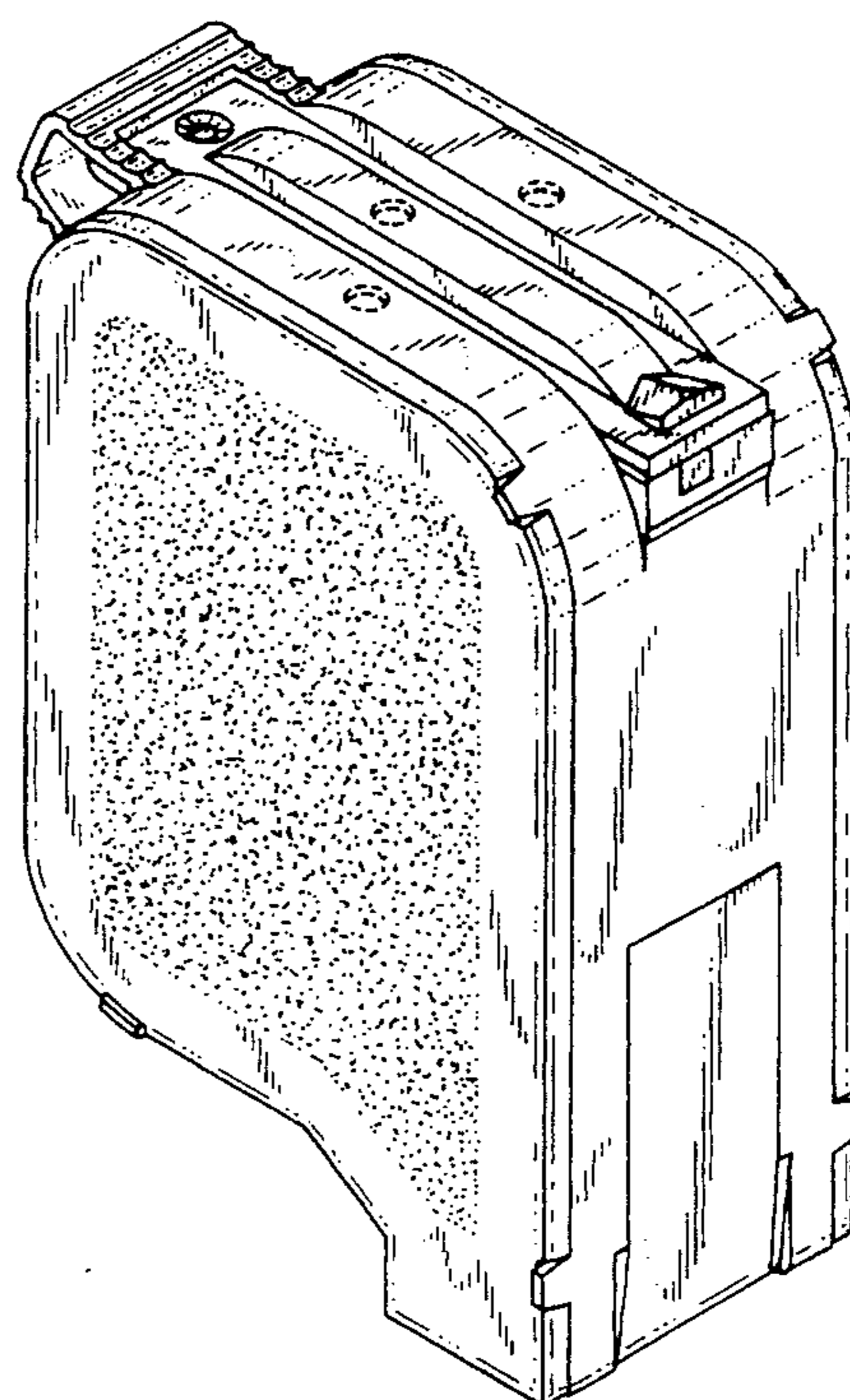
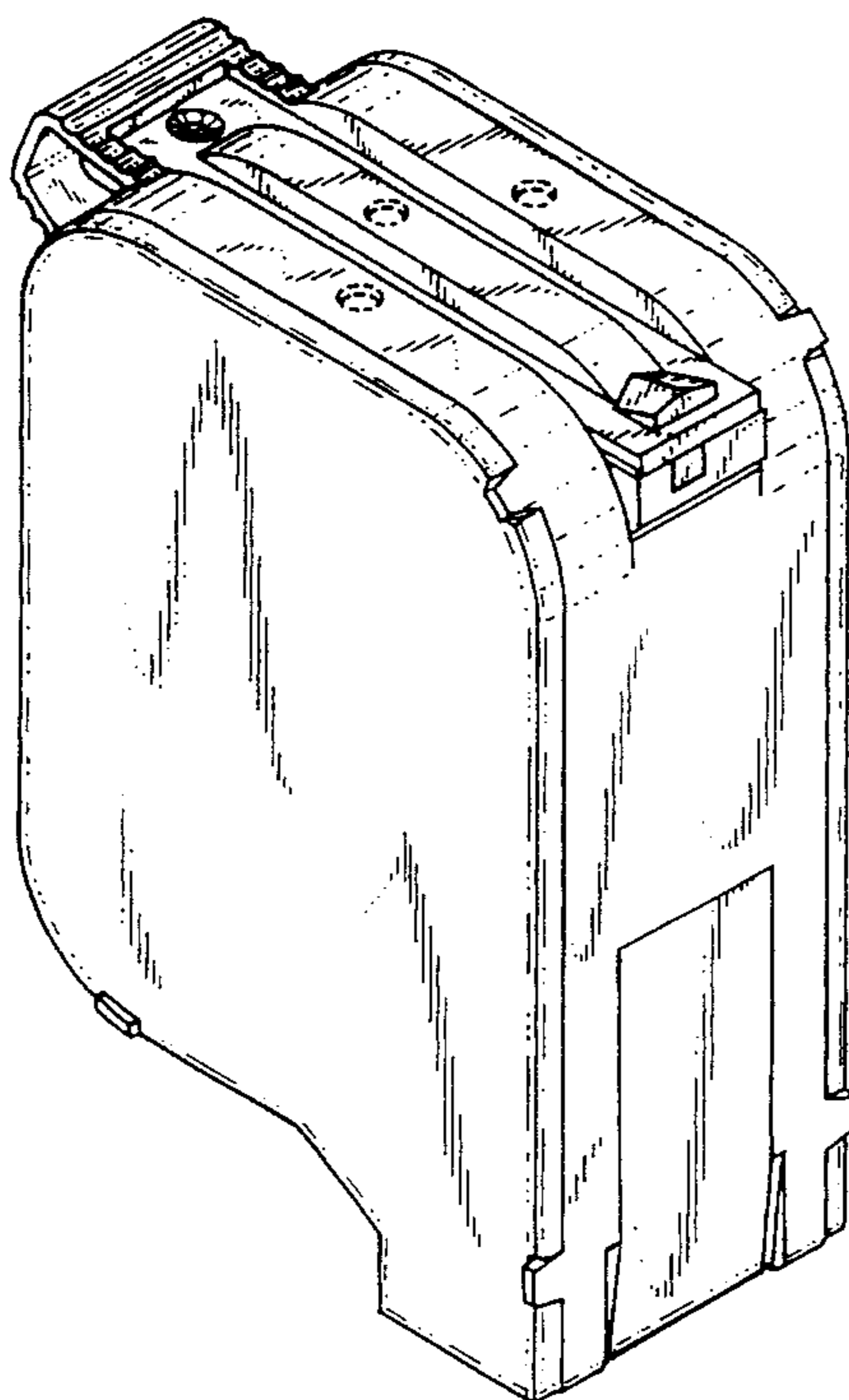
FIG. 8 is a top, front, and left side perspective view of print cartridge showing an alternative embodiment of our new design; the top, bottom, front and rear views are identical to those of the first embodiment;

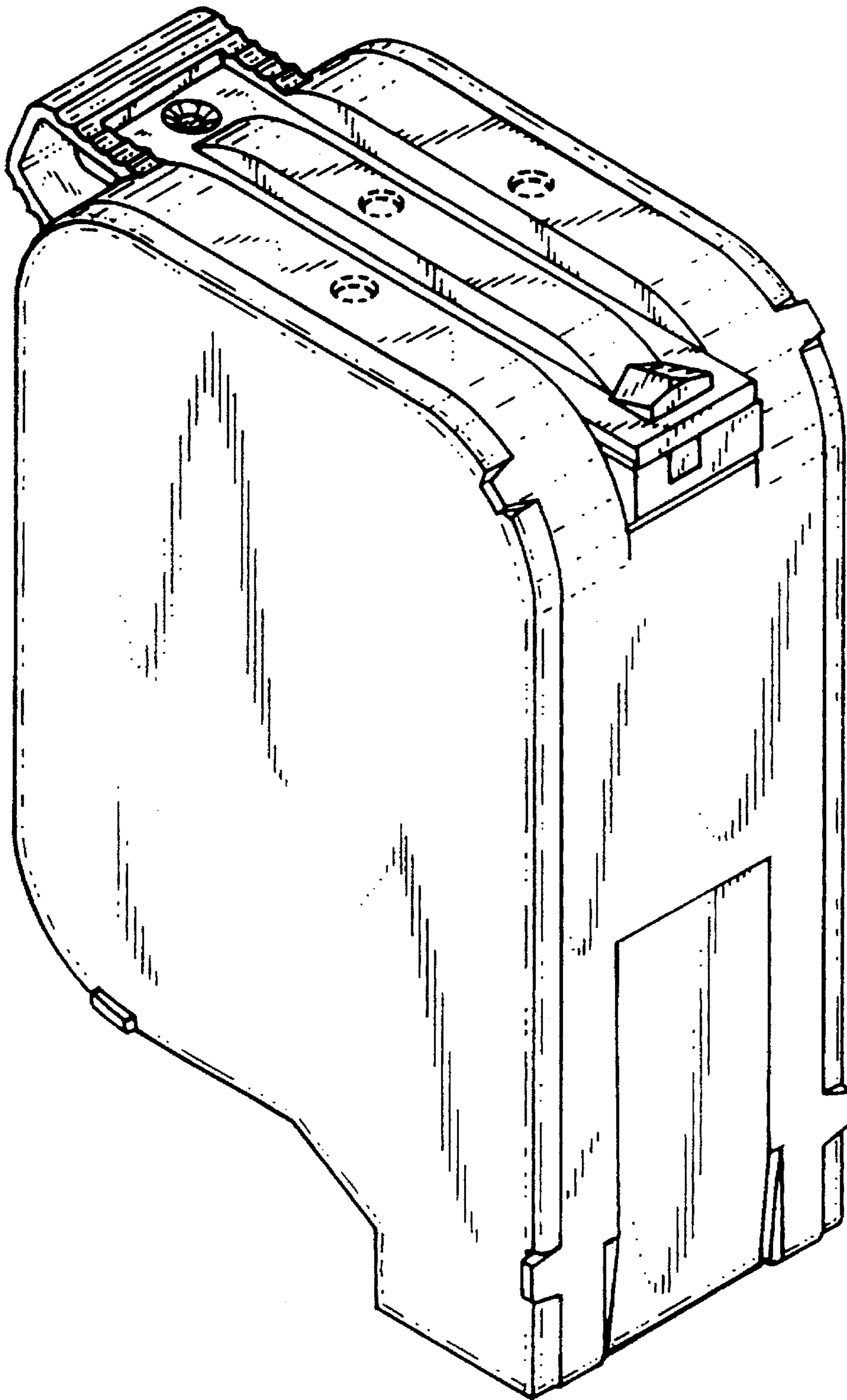

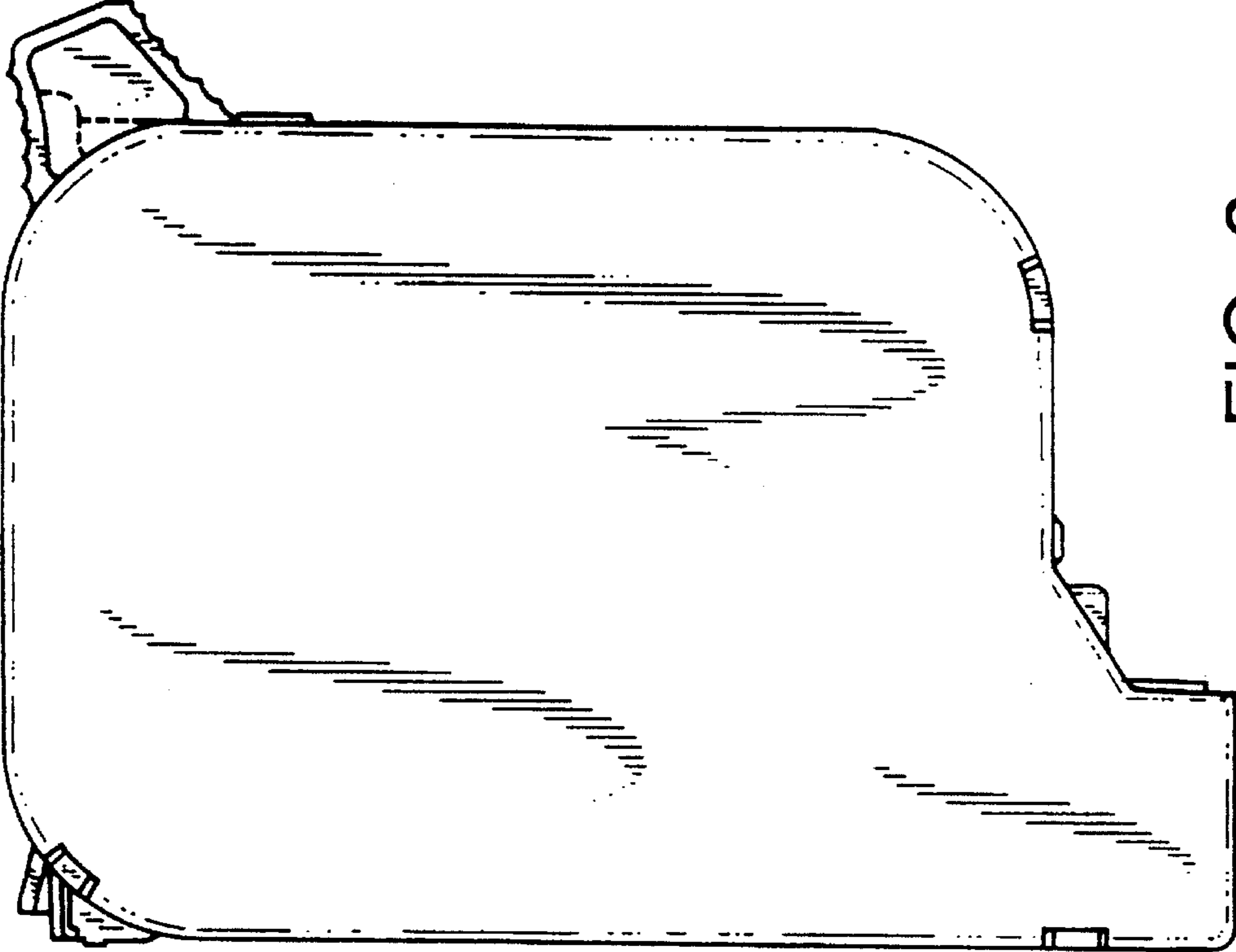

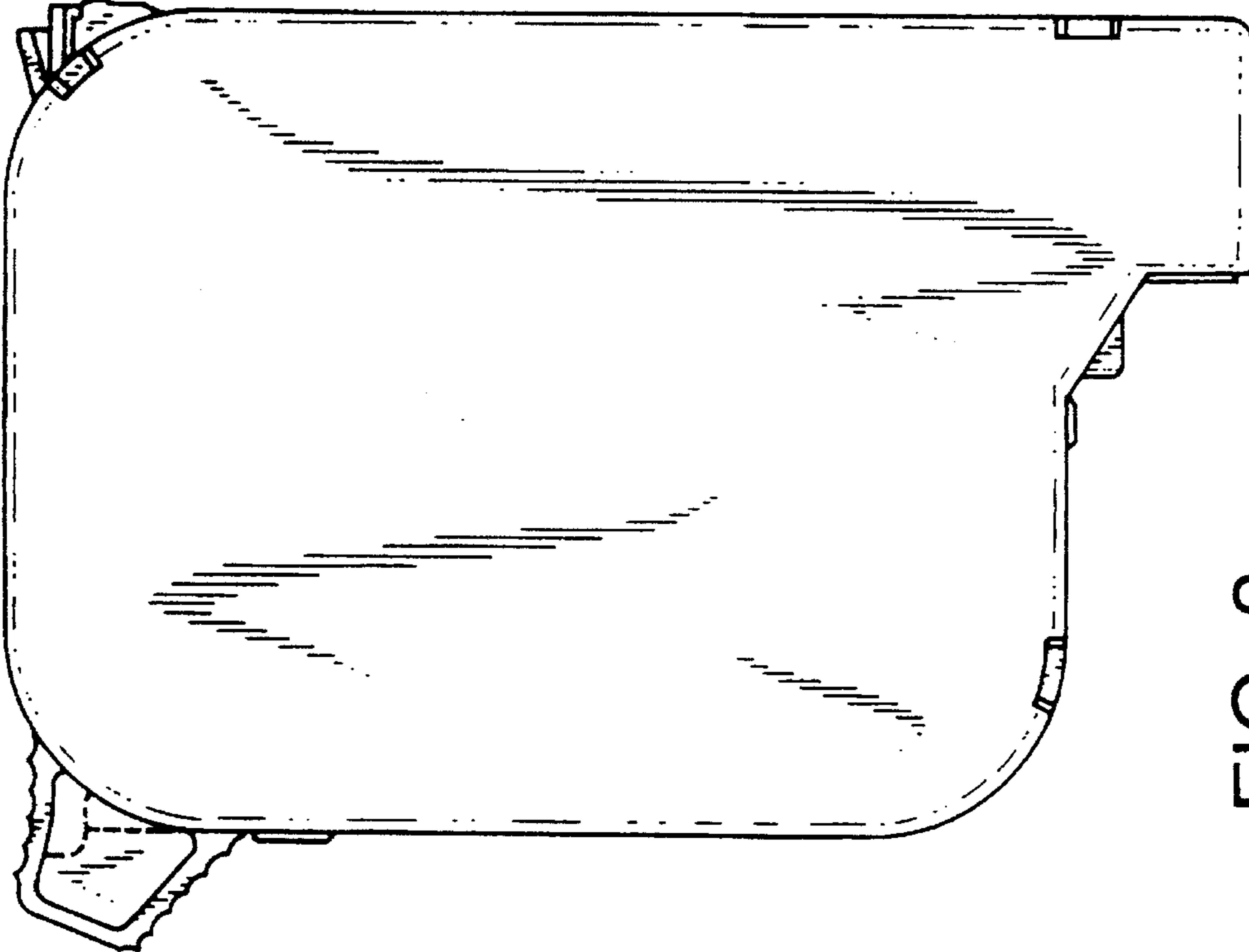

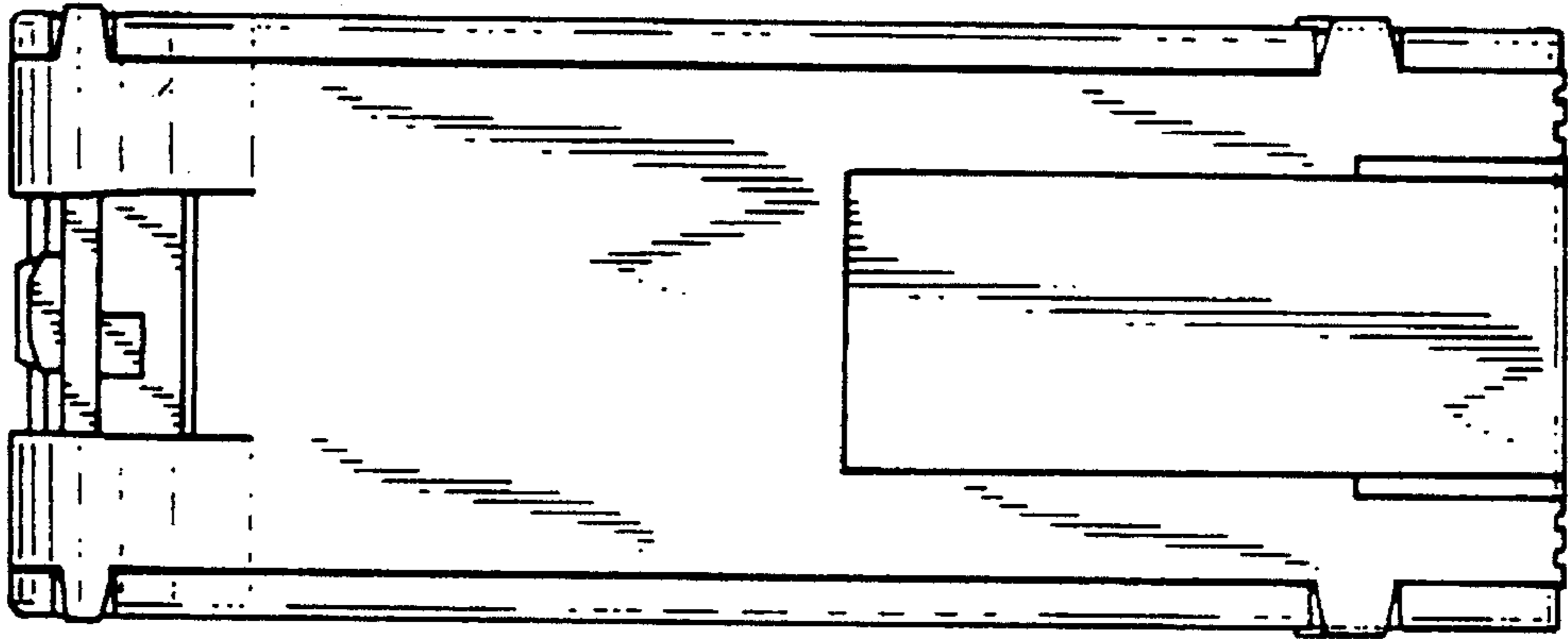
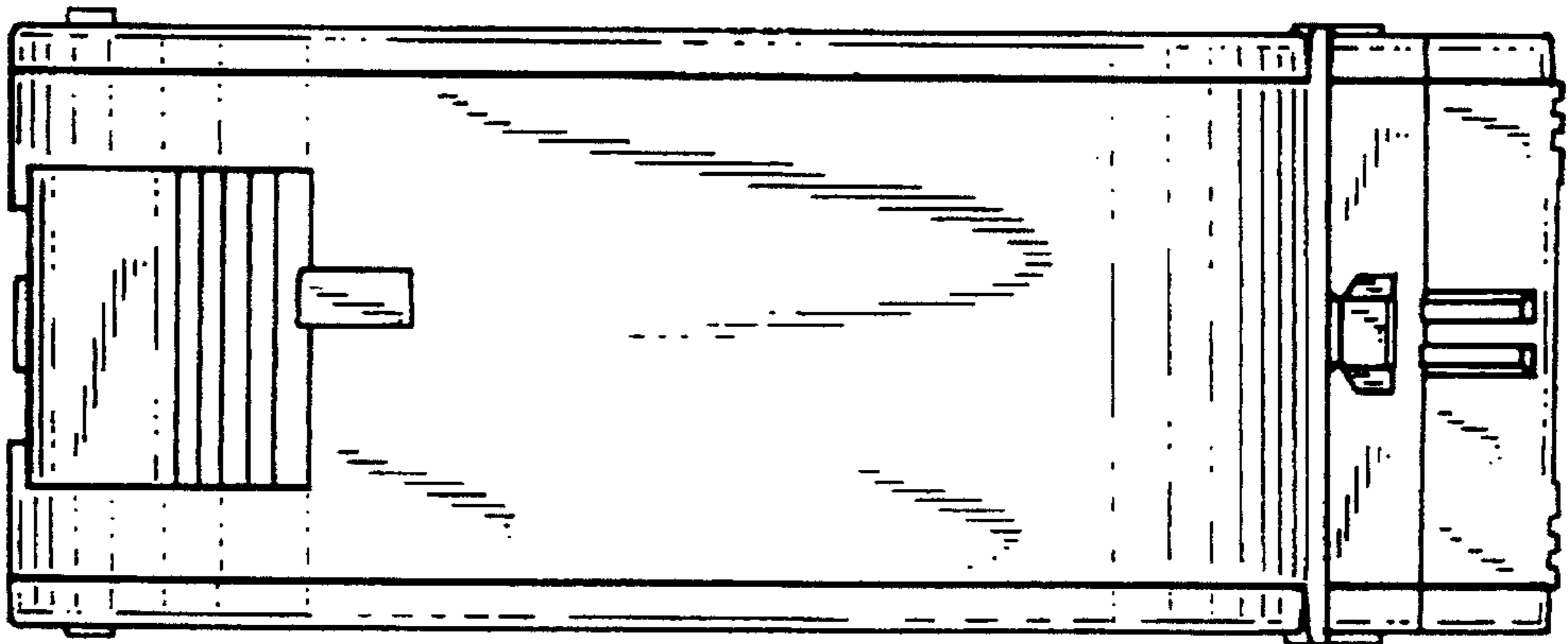

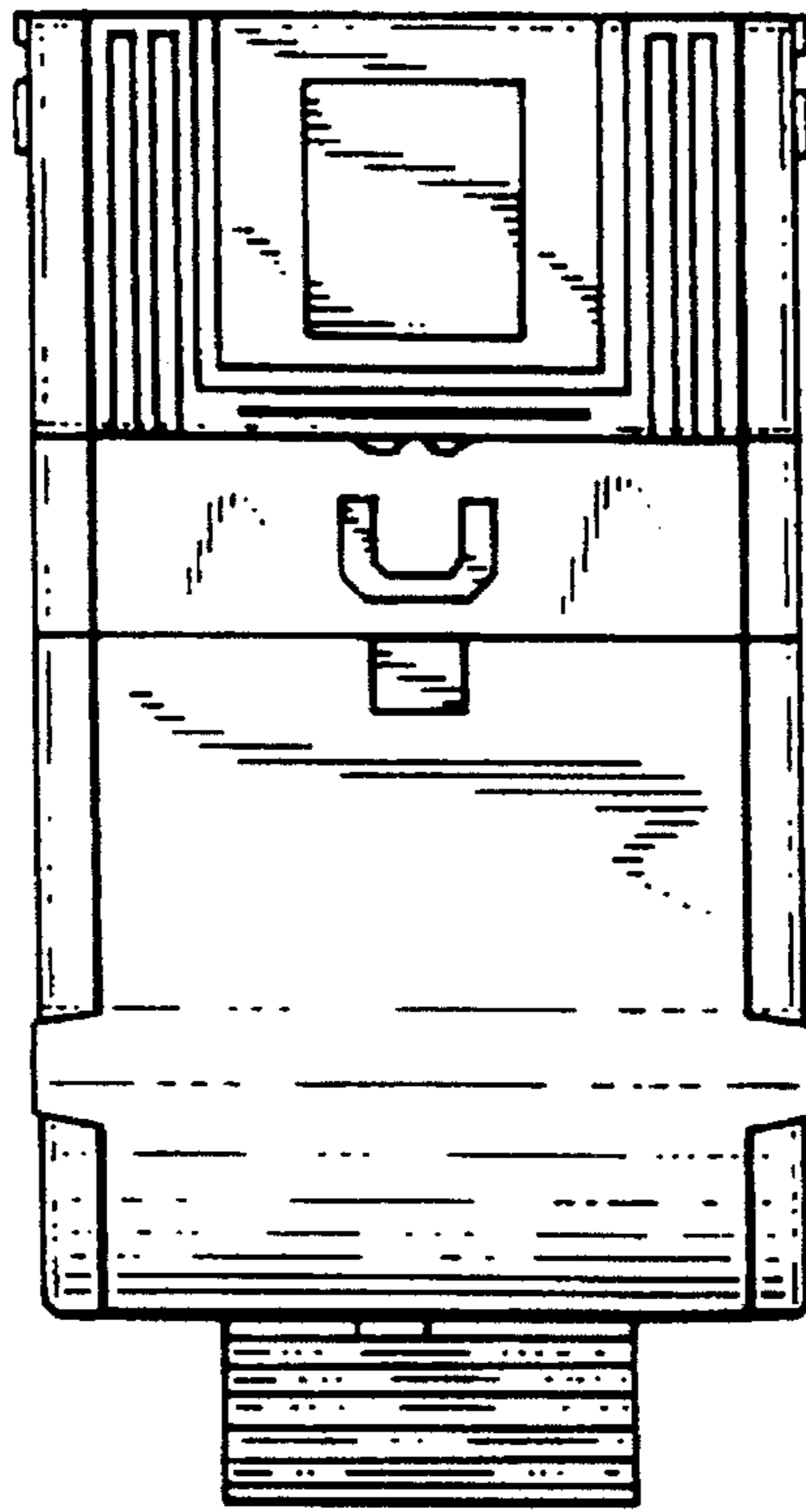

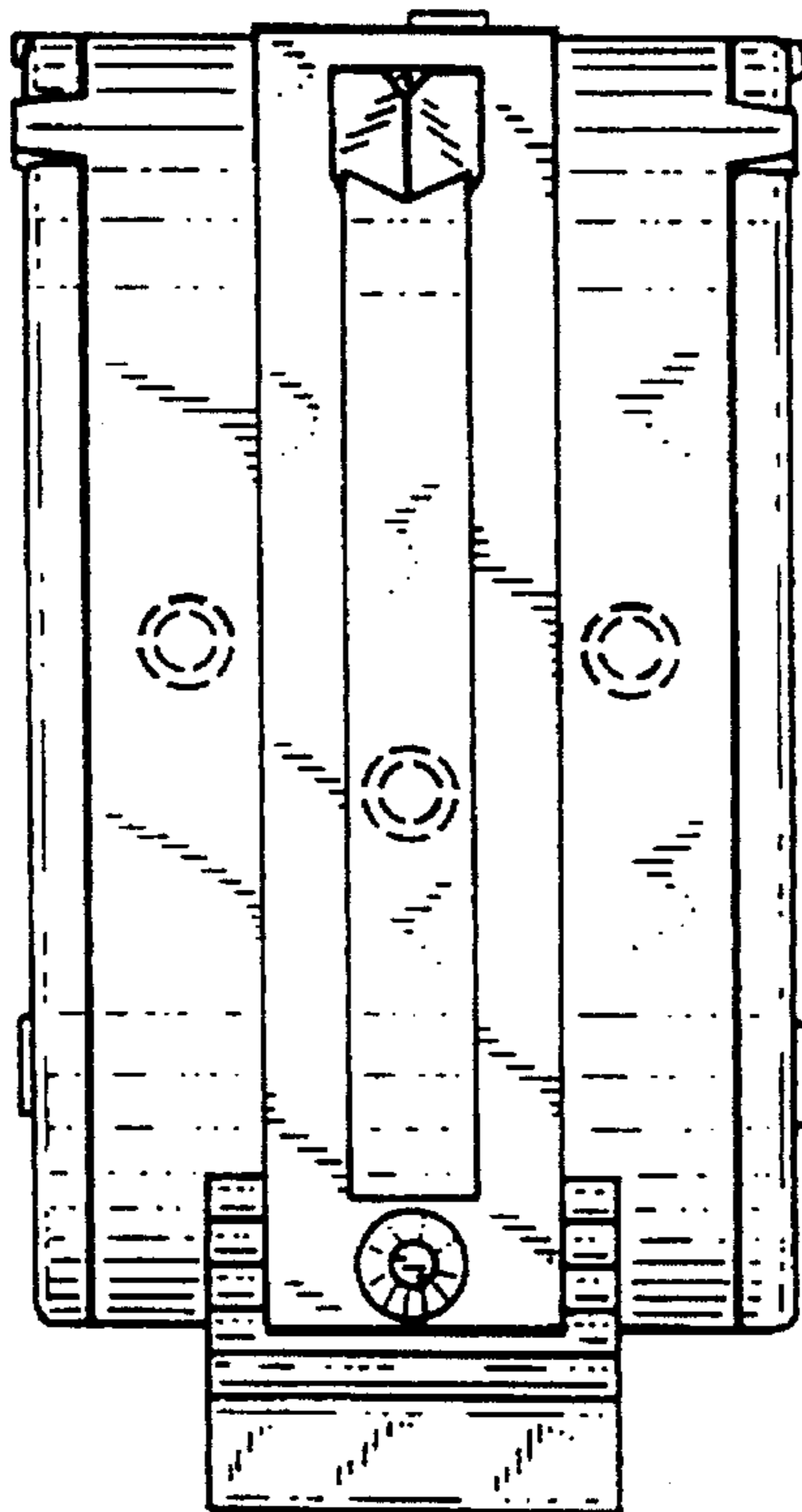

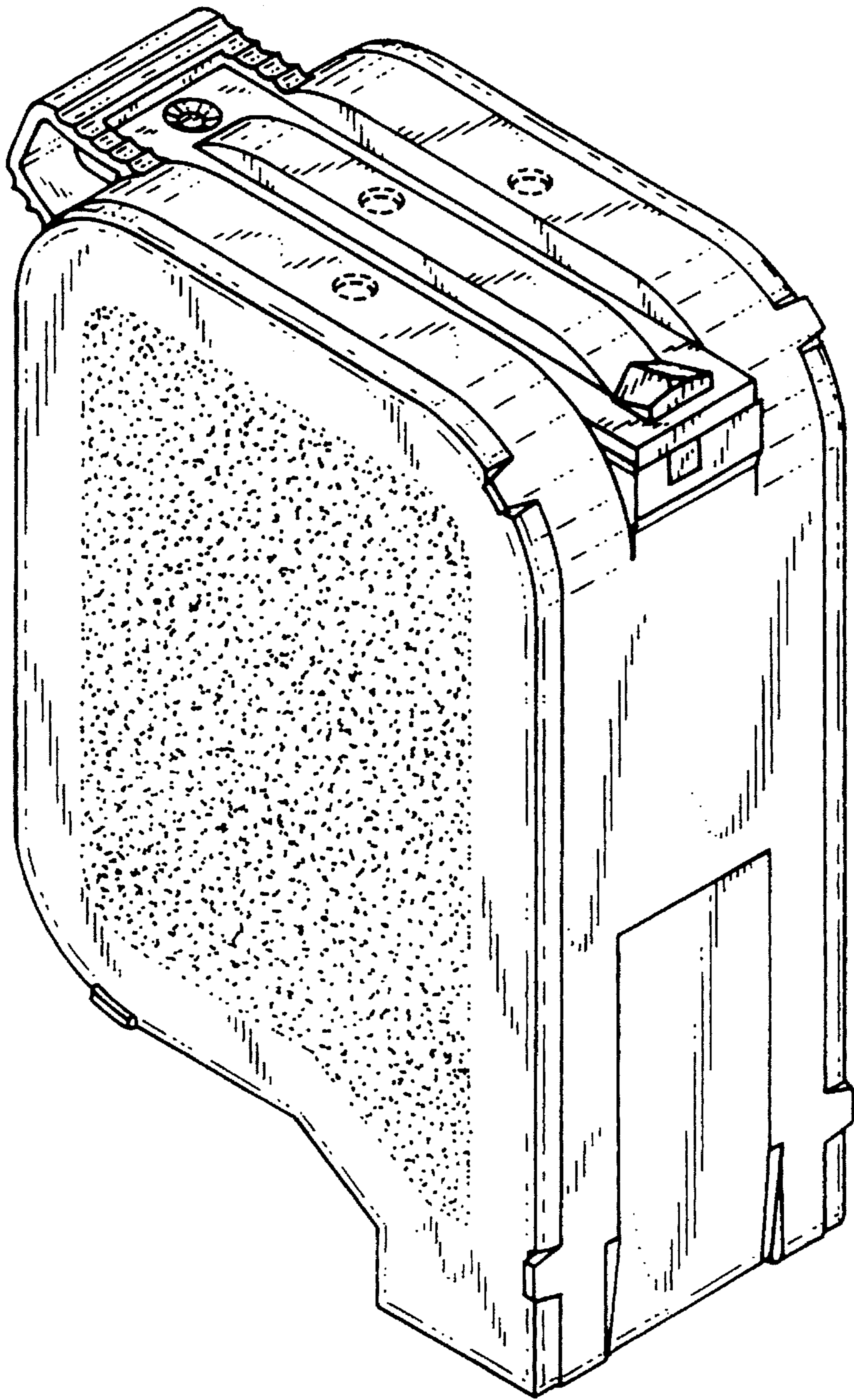

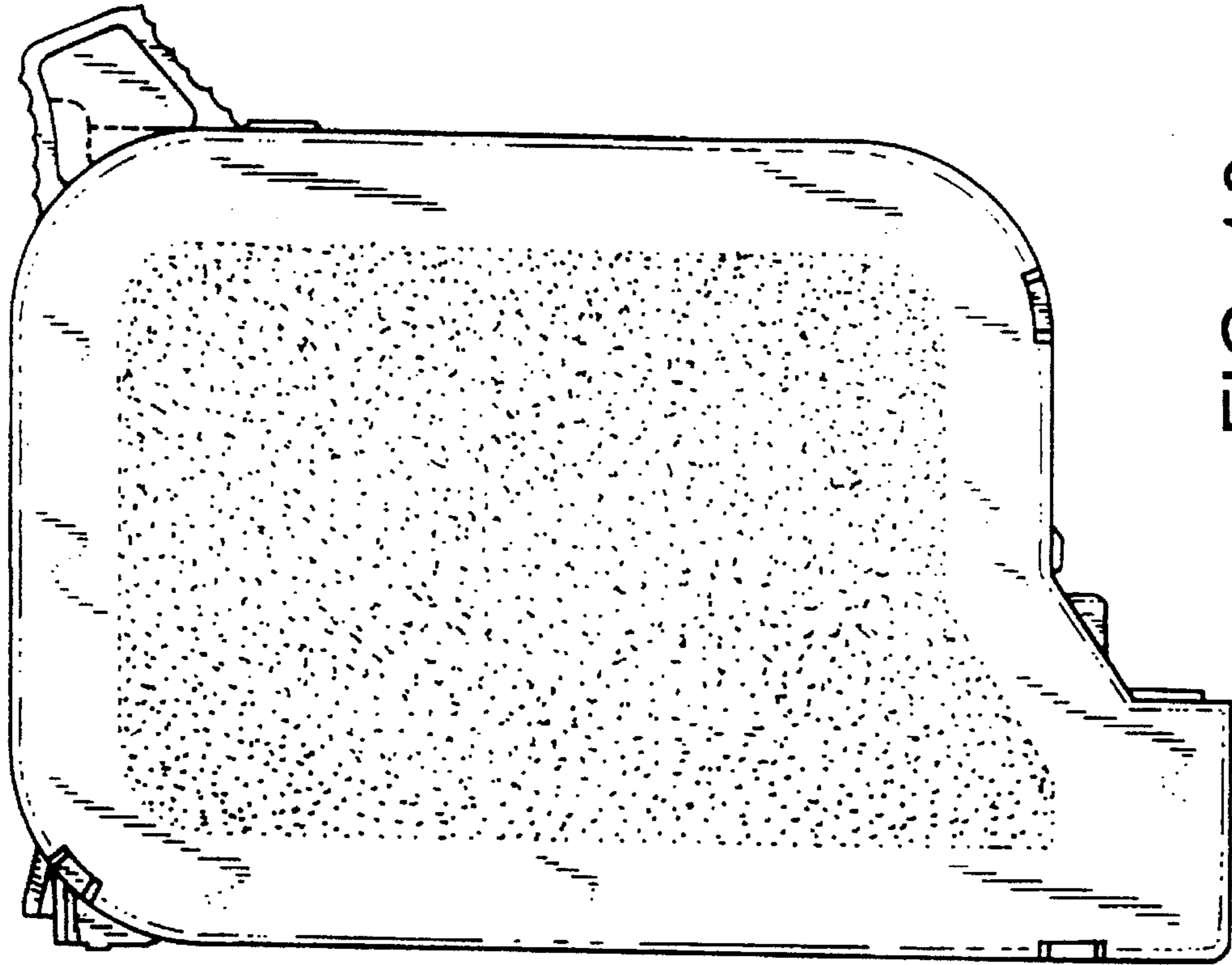

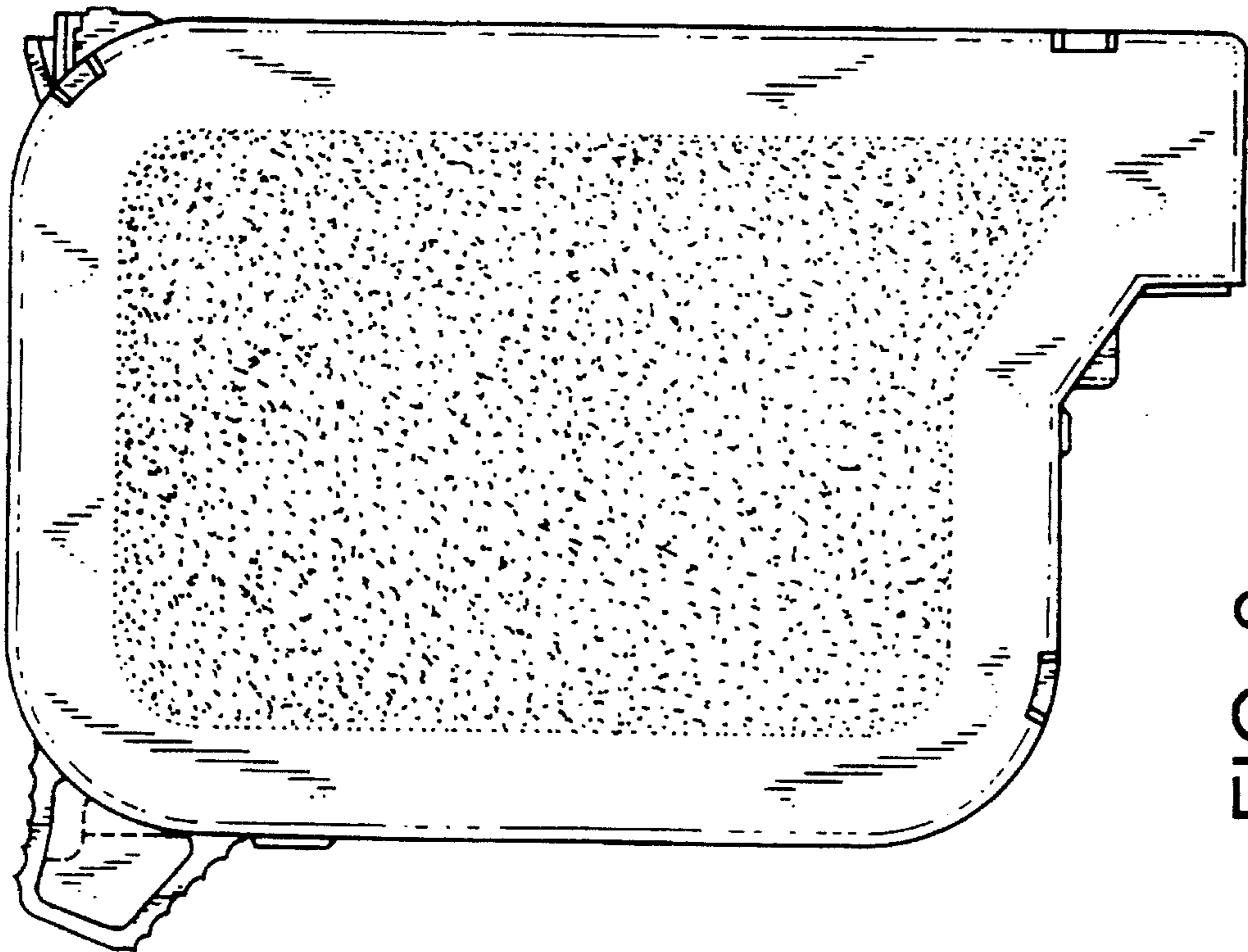
