[57] **CLAIM**

The ornamental design for a combined razor handle and holder therefor as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined razor handle and holder therefor as seen from the top, front and right side; FIG. 2 is a perspective view as seen from the bottom, front and right side thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof, the left side elevational being a mirror image; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof.

The broken line showing of the razor cartridge is for illustrative purposes only and forms no part of the claimed design.

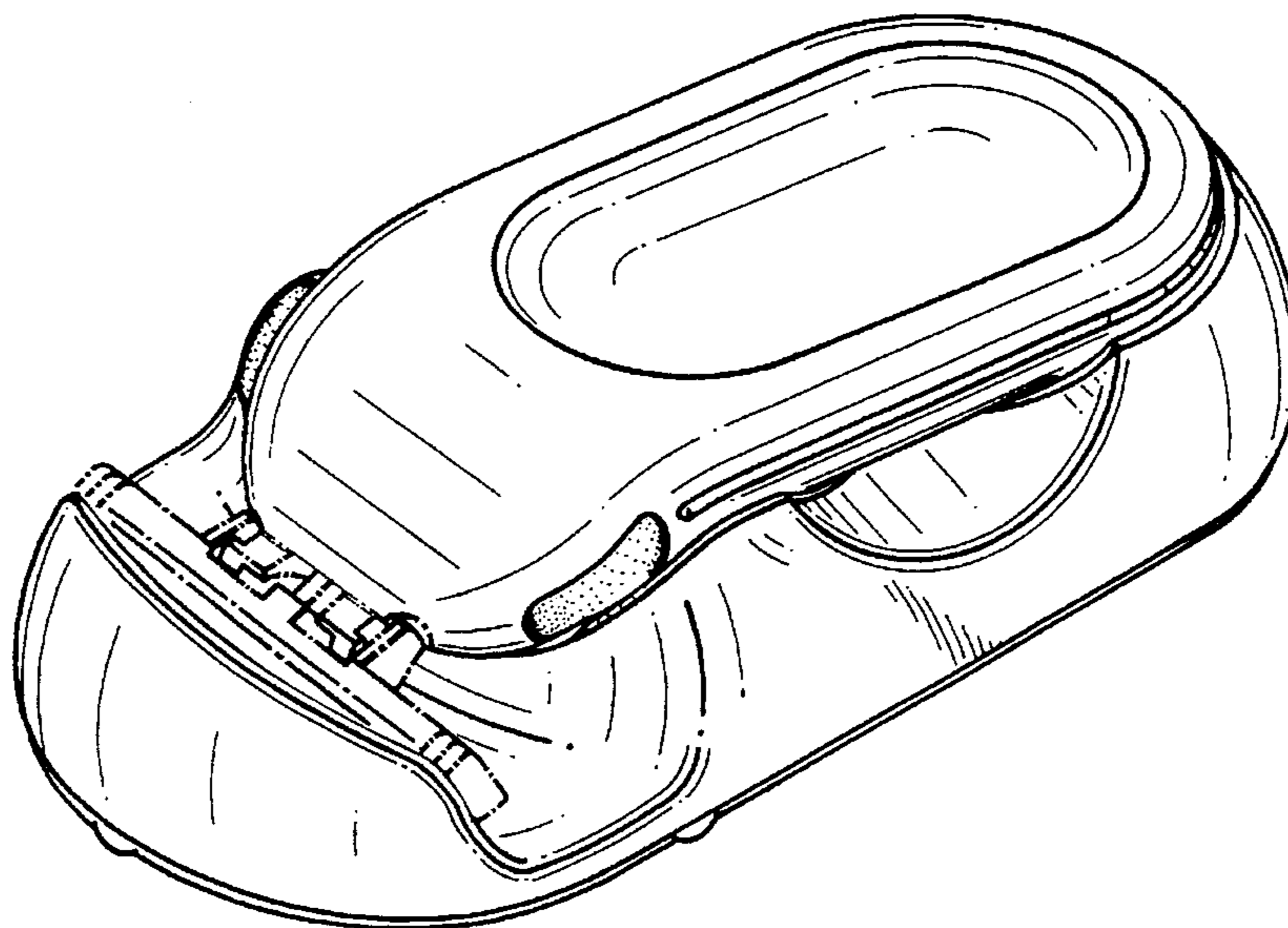

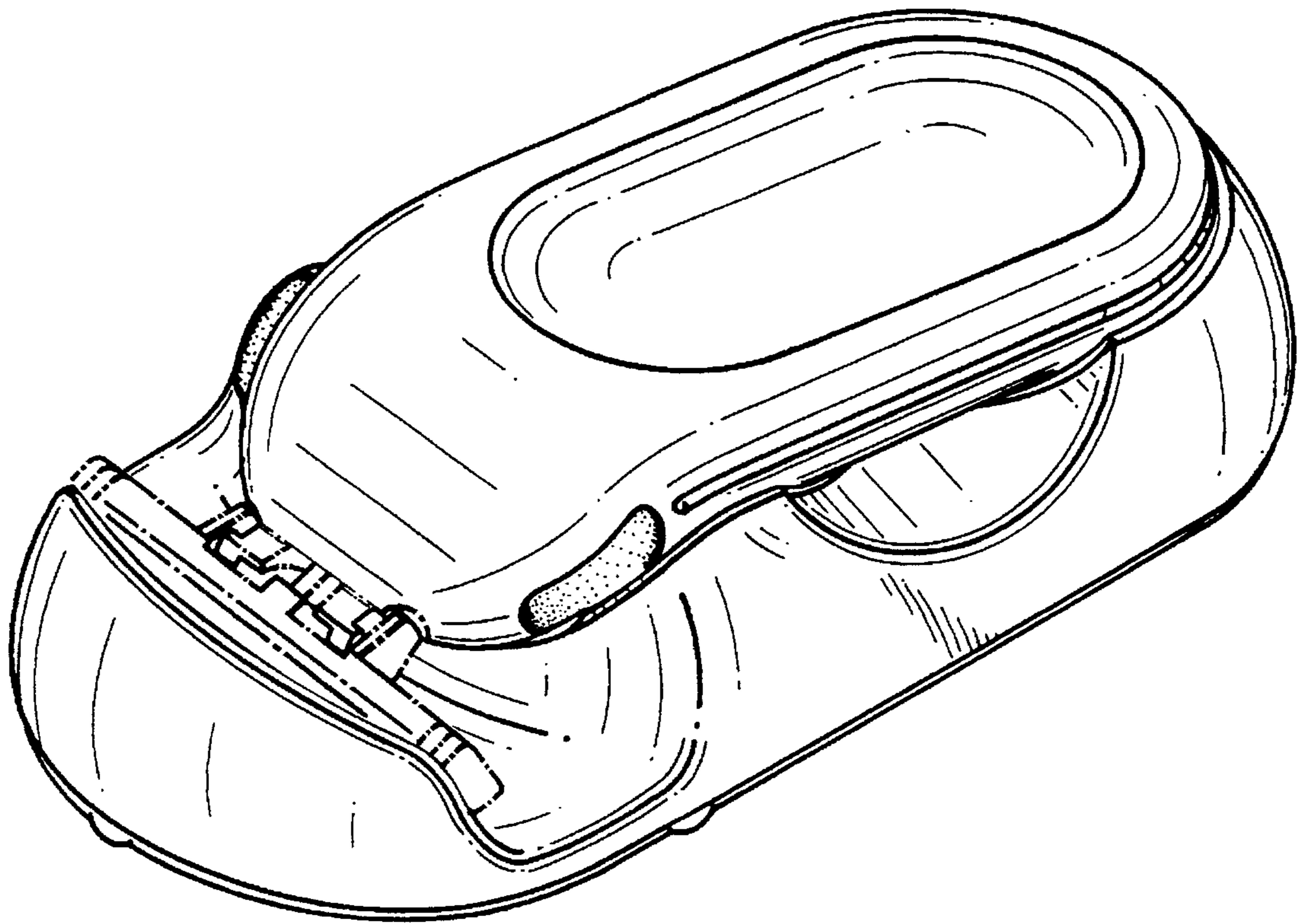

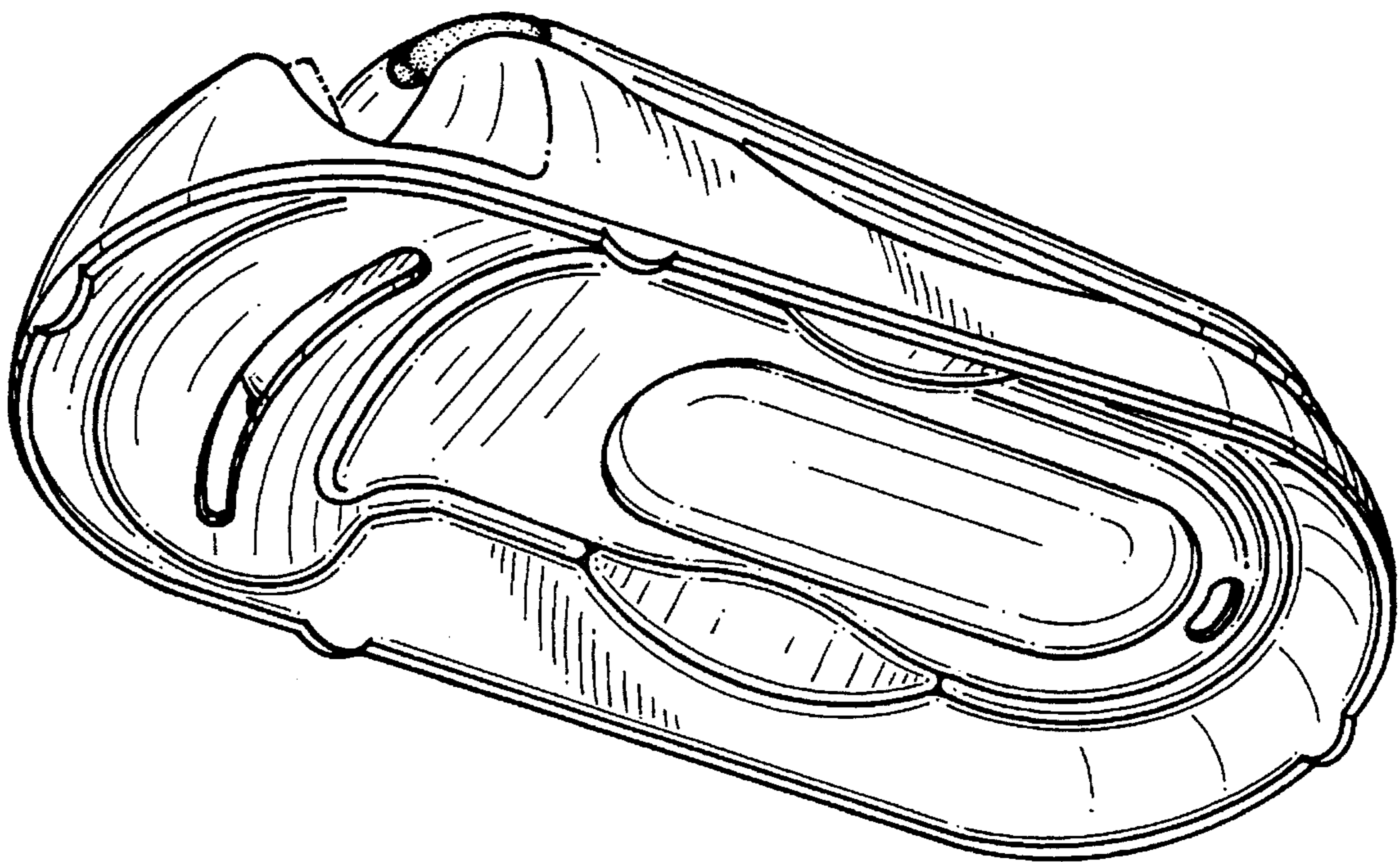

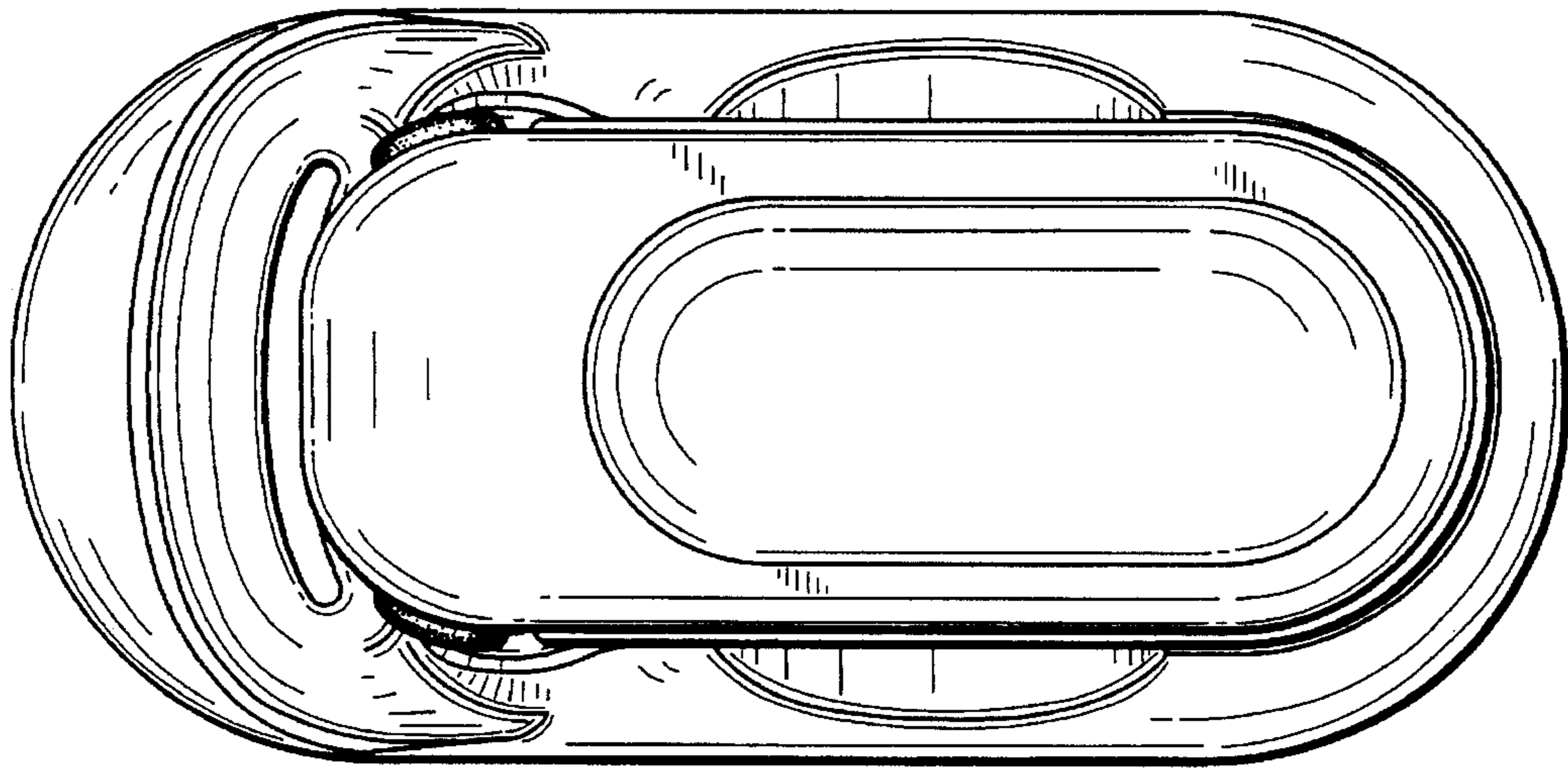

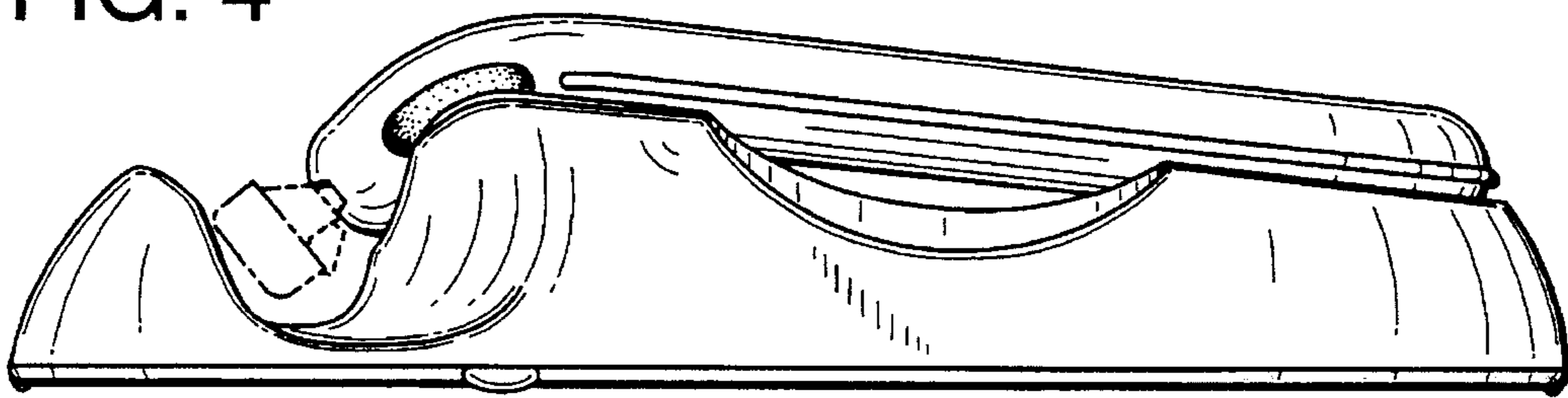

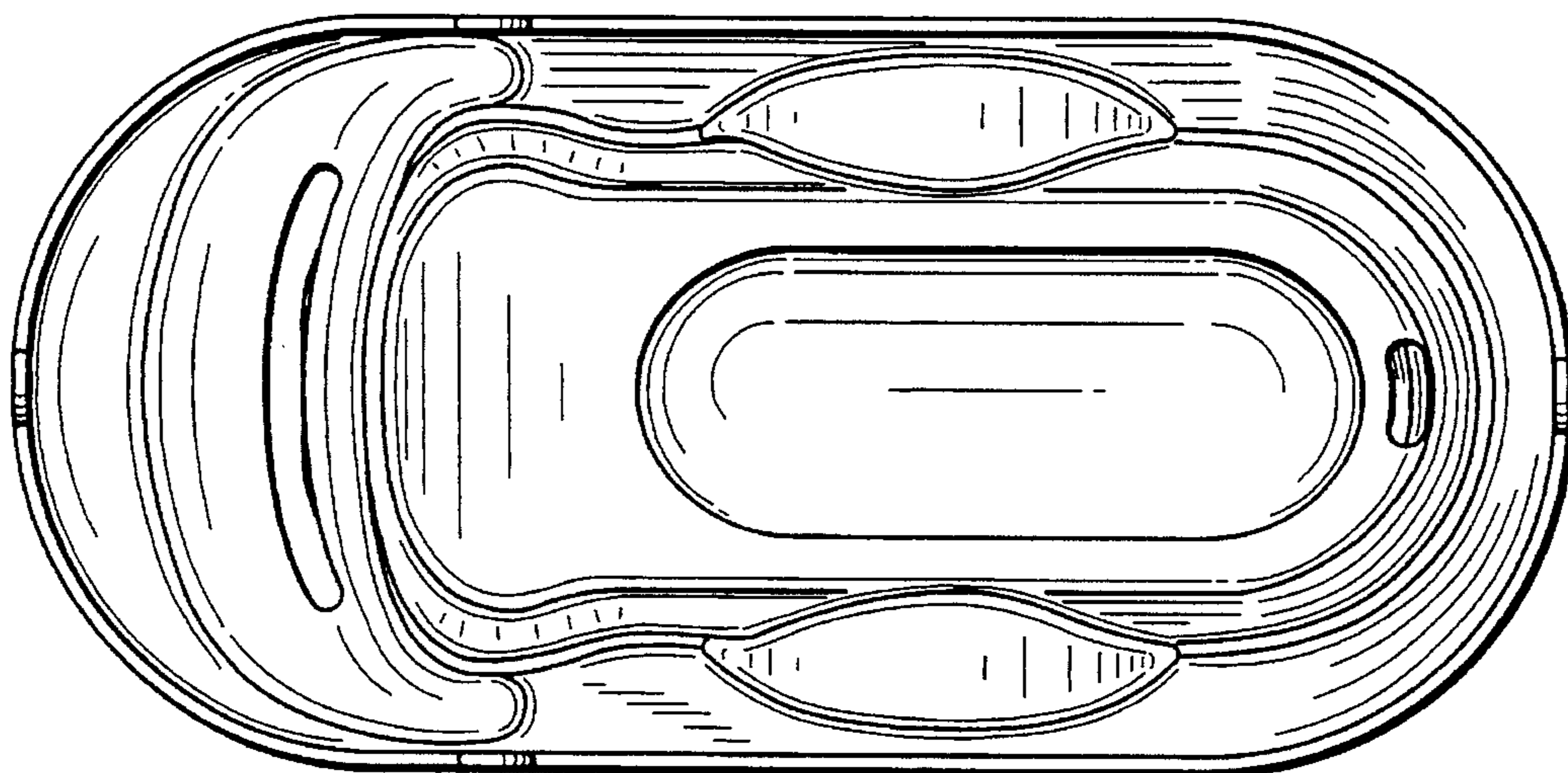

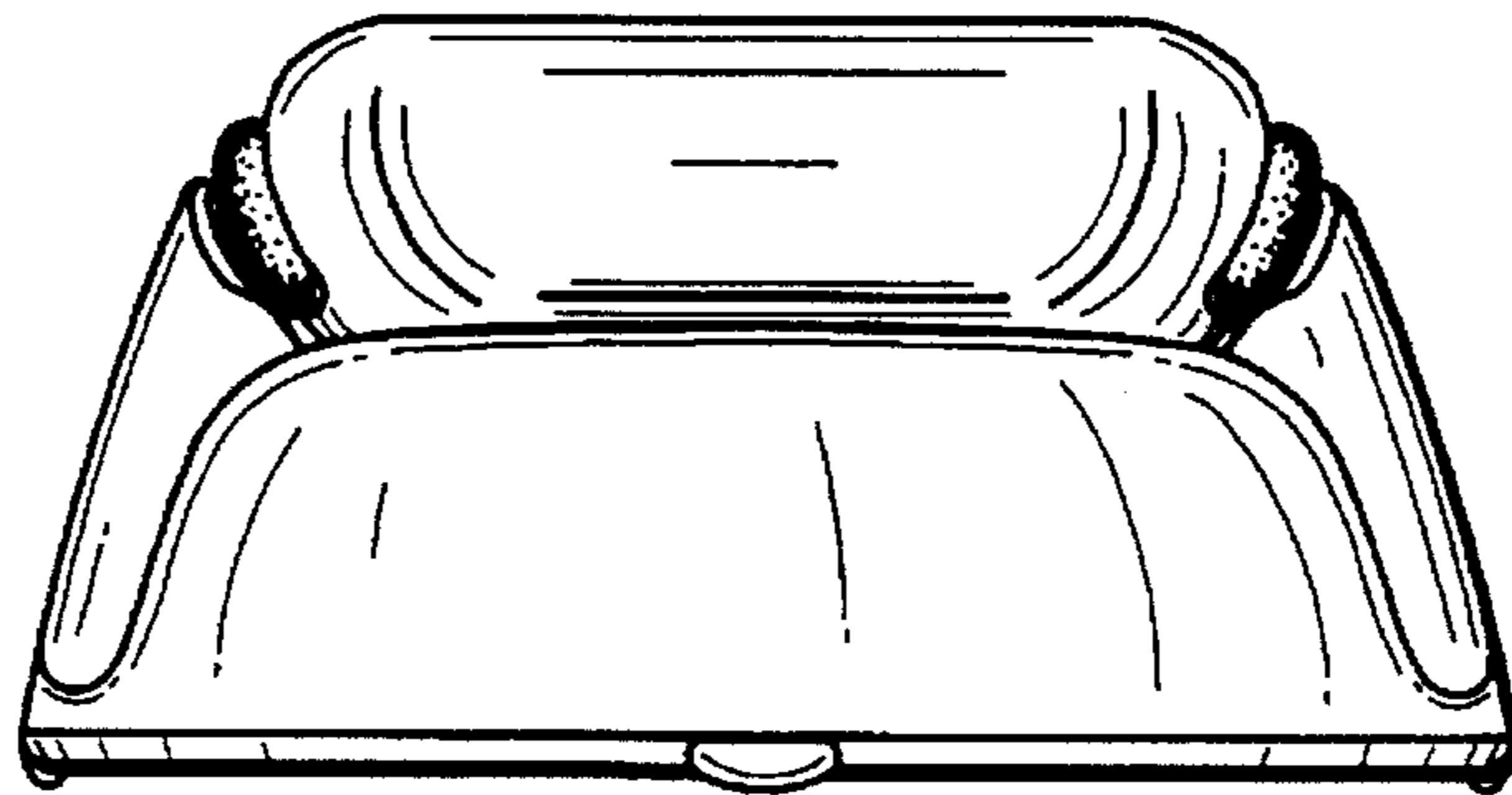
