DESCRIPTION

FIG. 8 is a right side elevational view of the second embodiment;

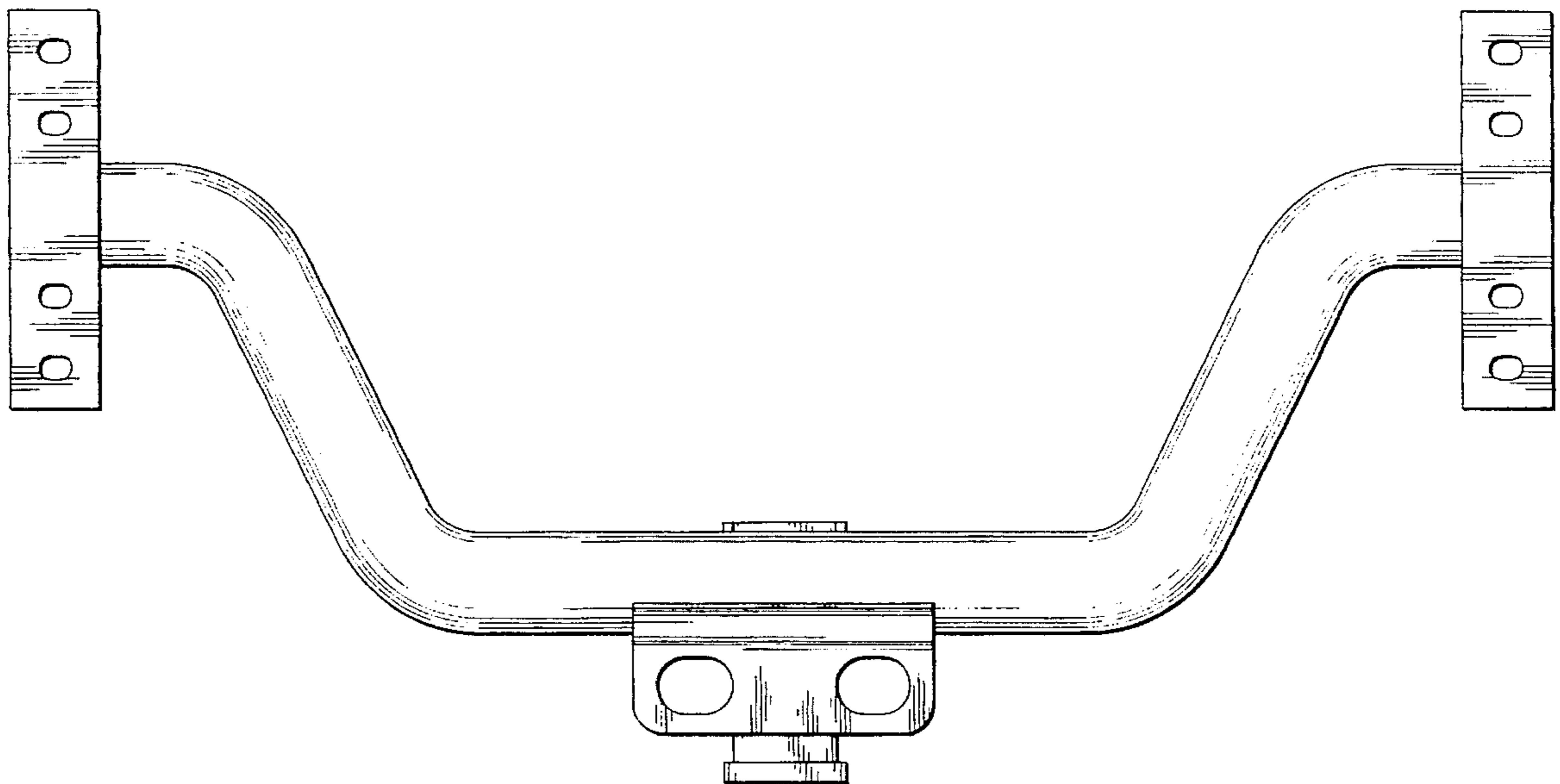
FIG. 9 is a top plan view of the second embodiment;

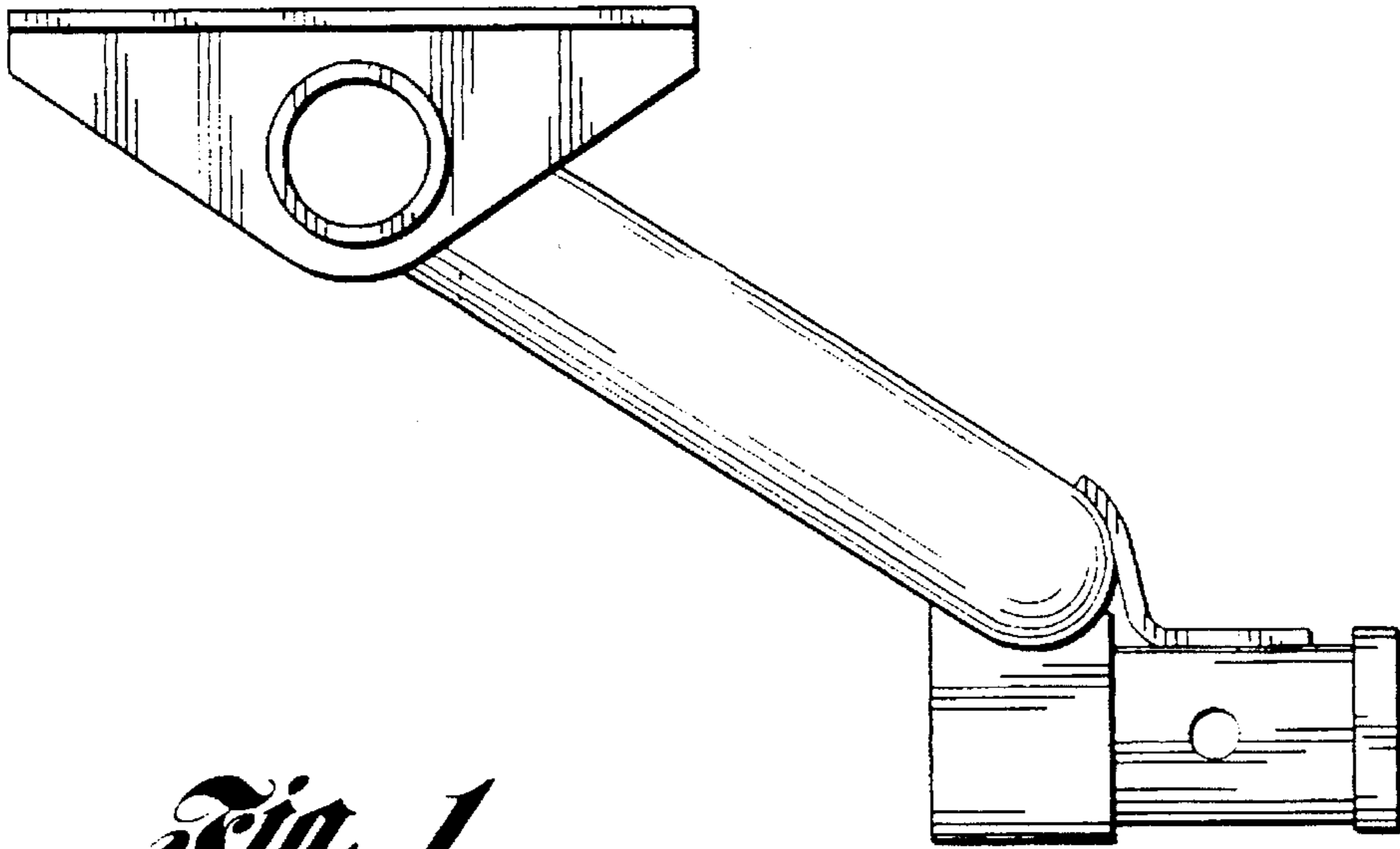

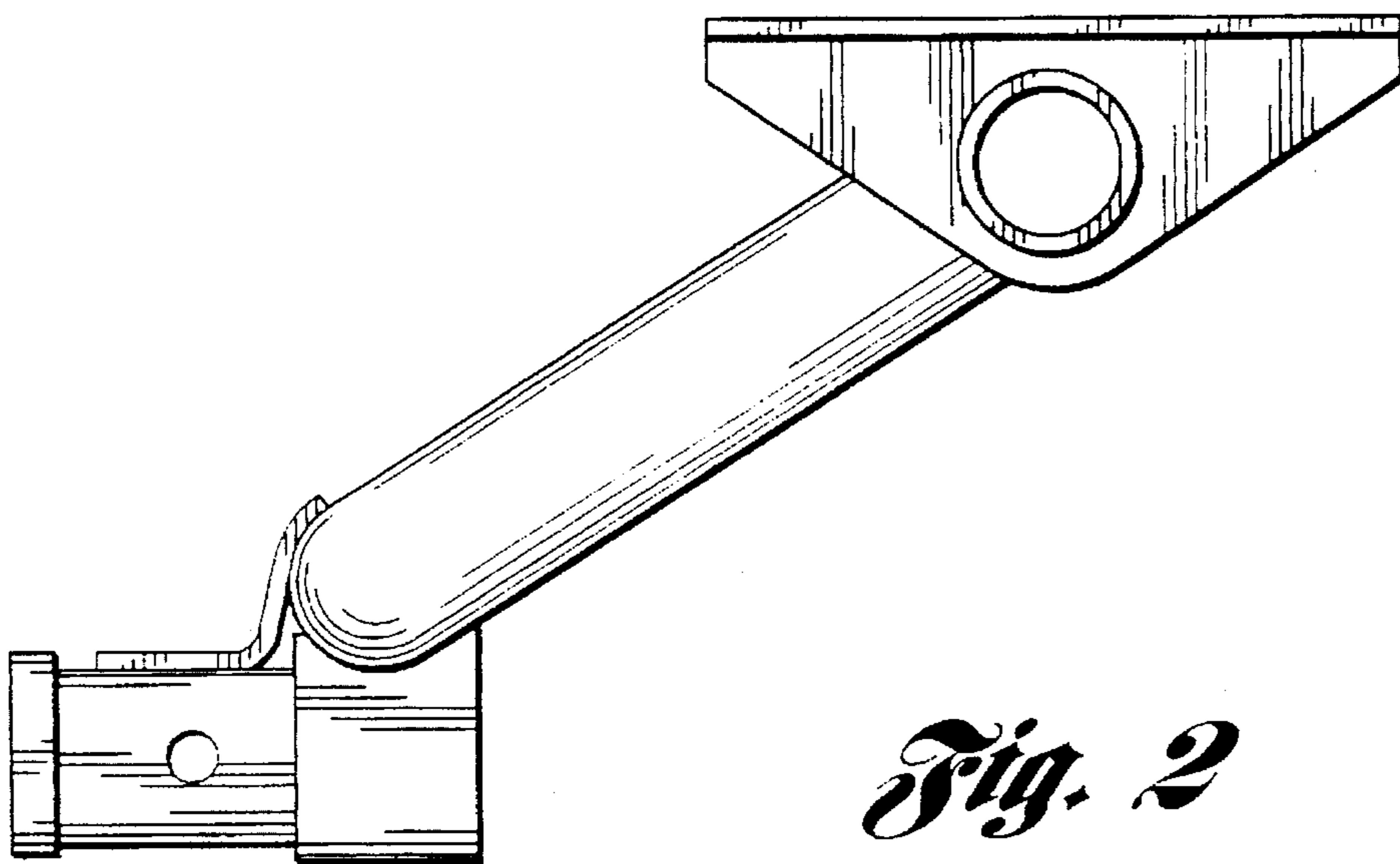

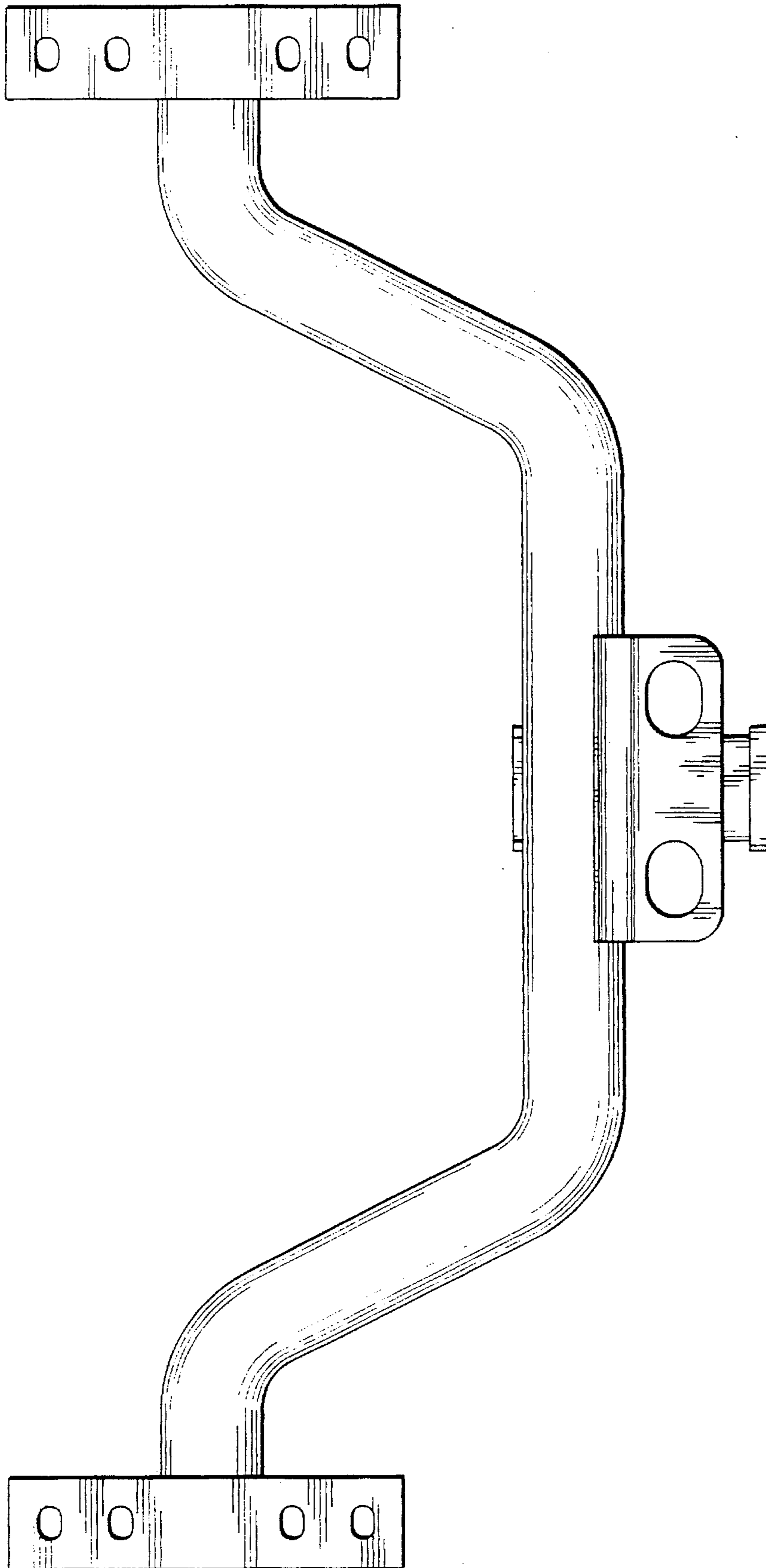

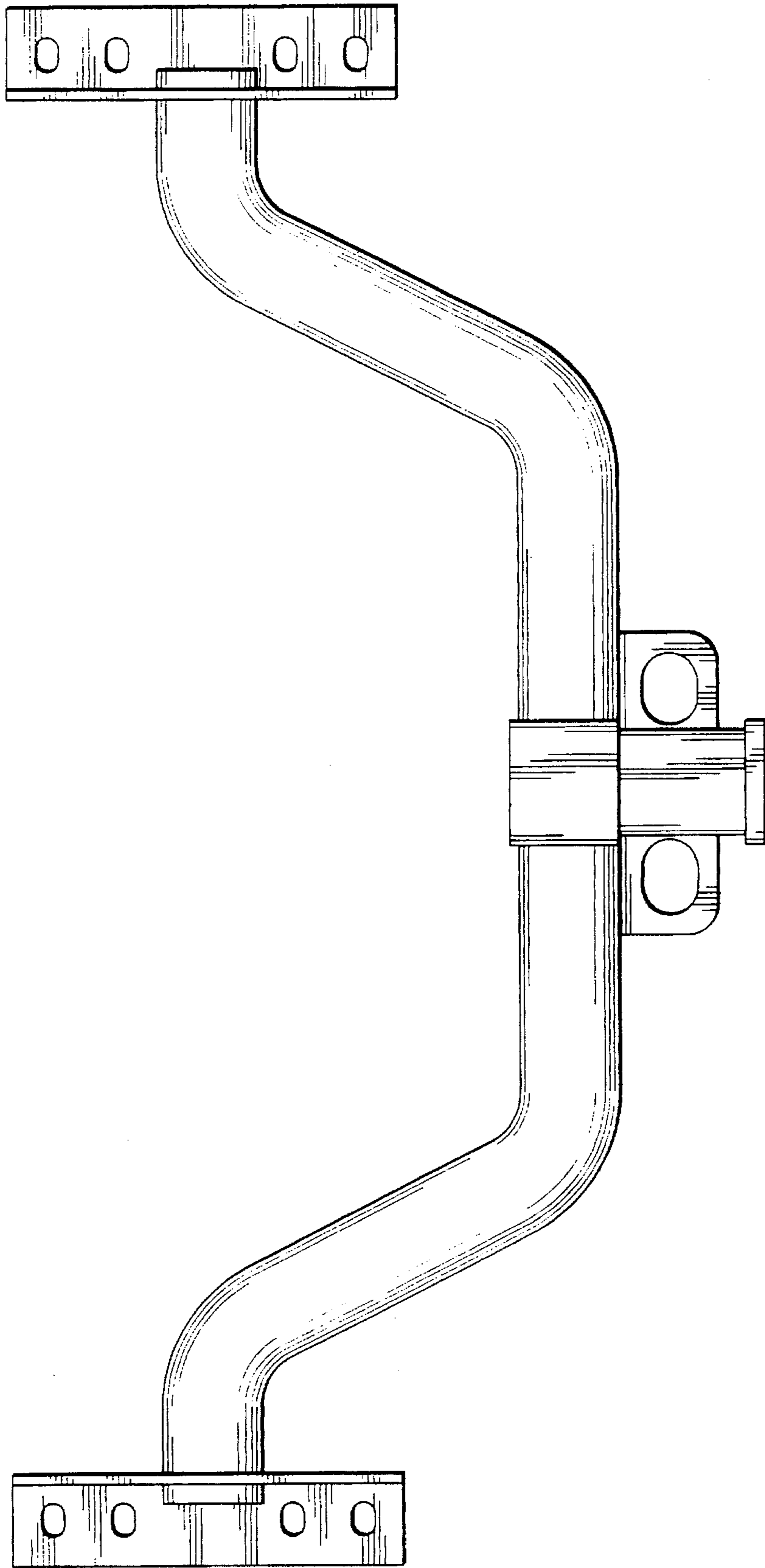
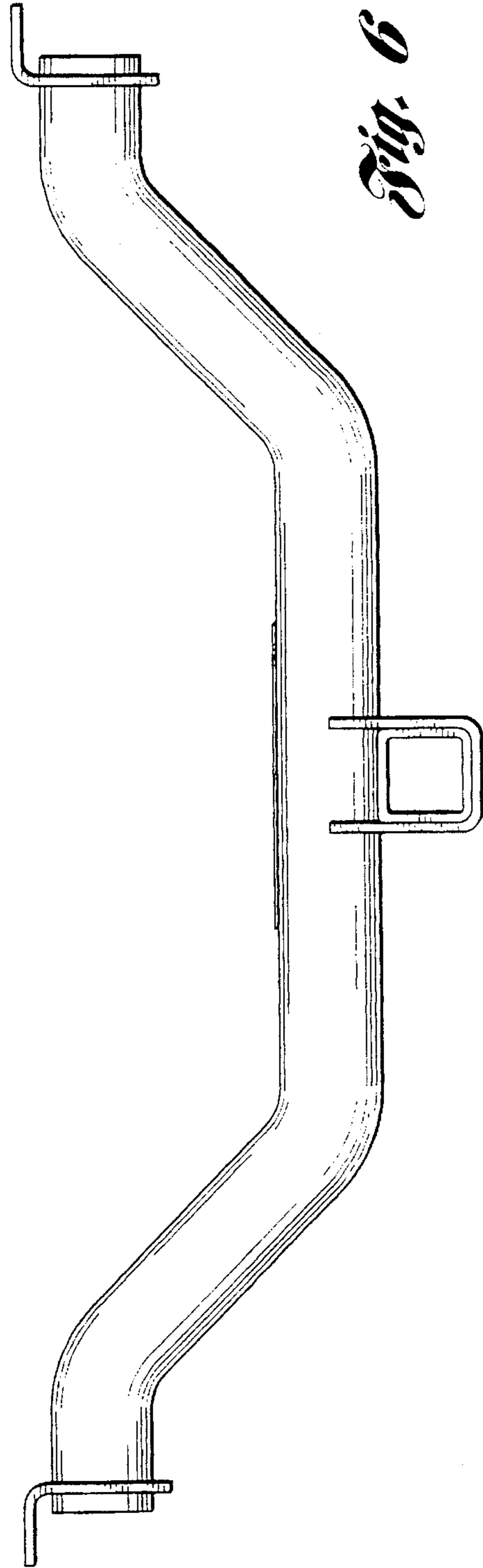
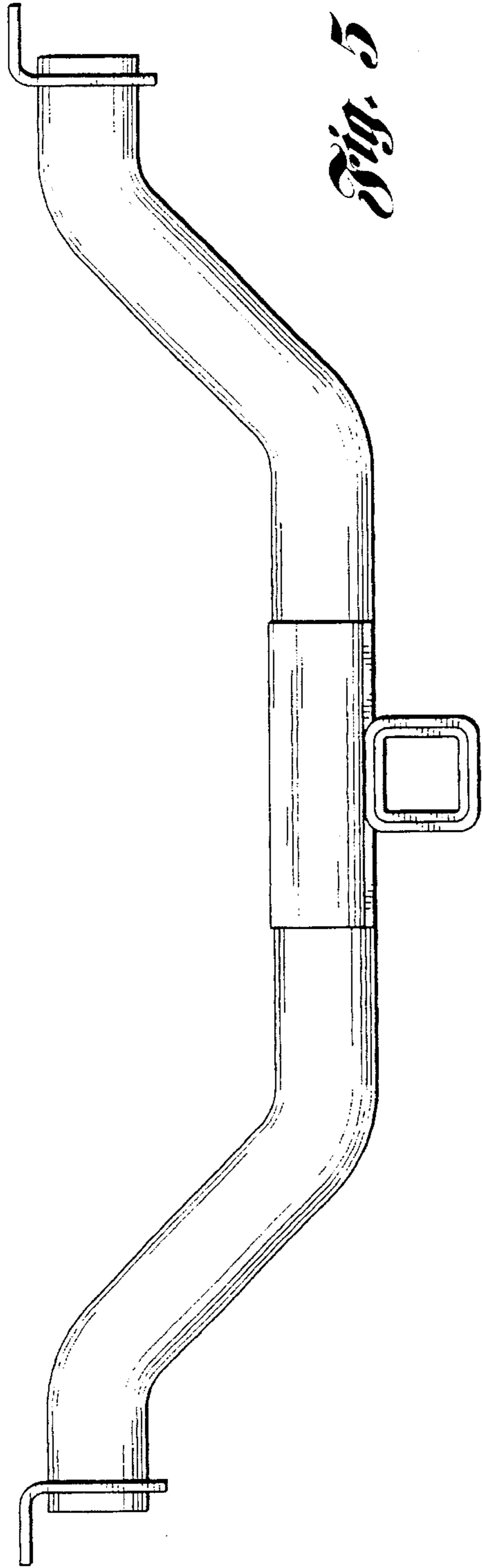

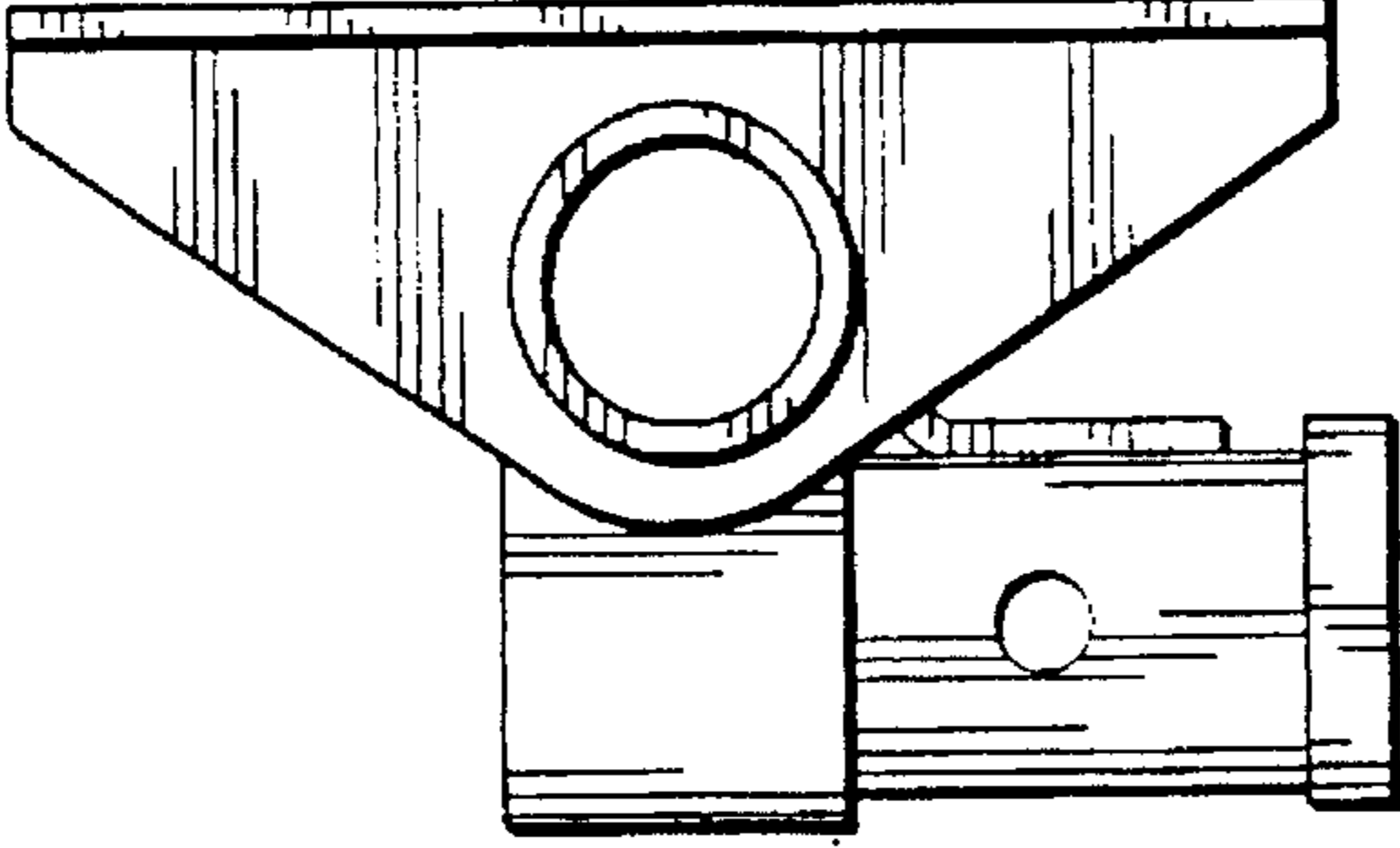

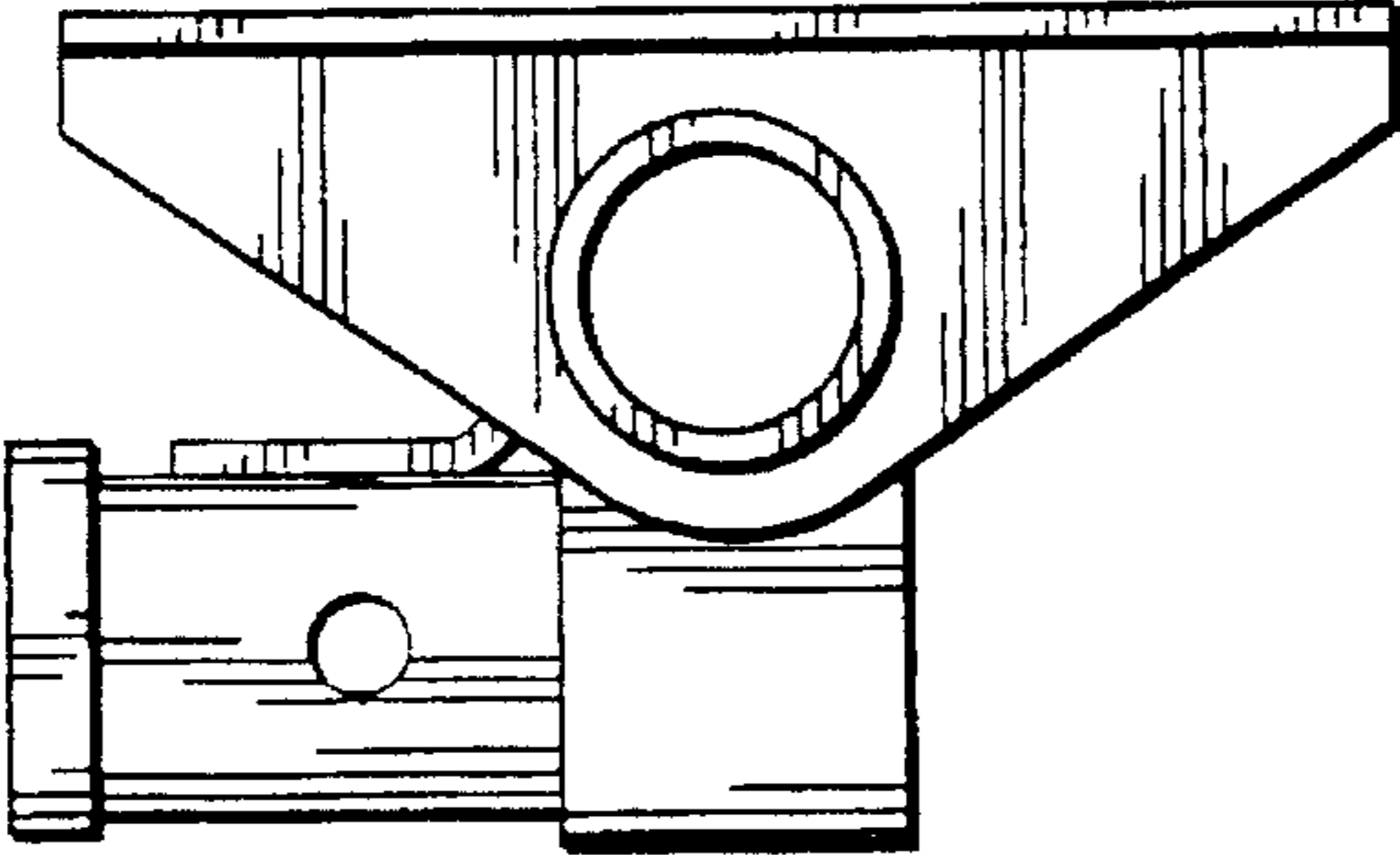

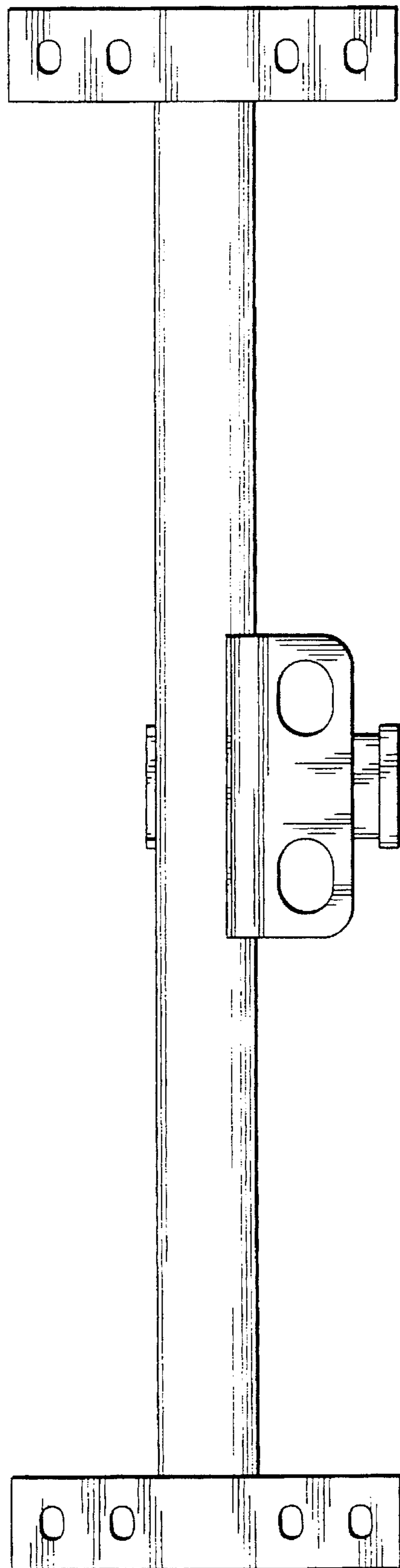

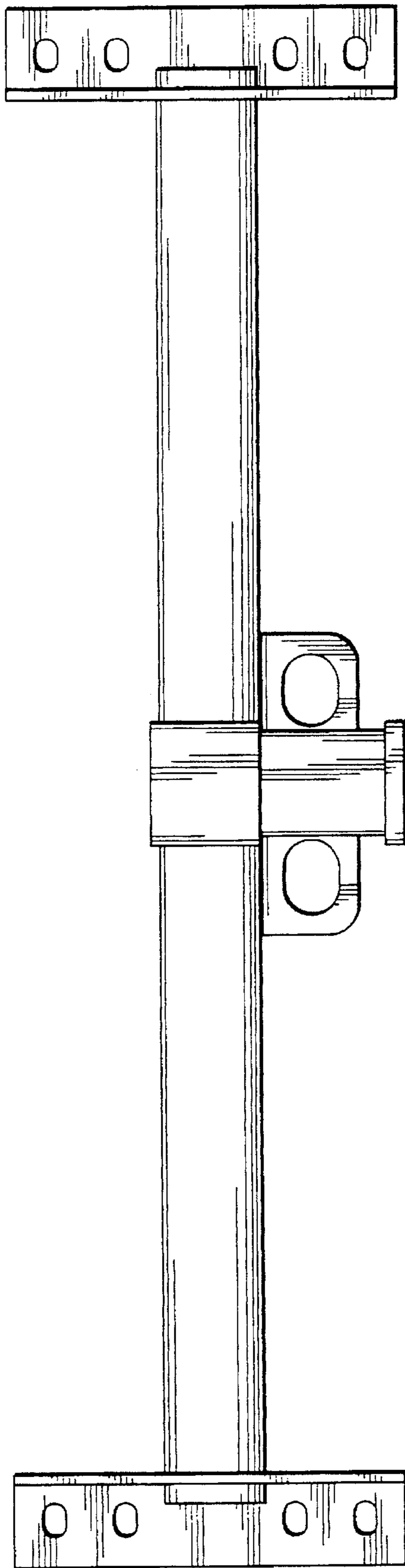

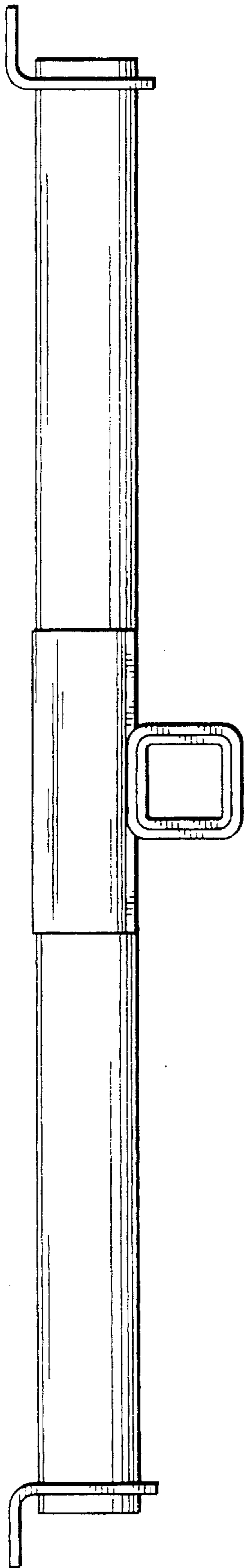

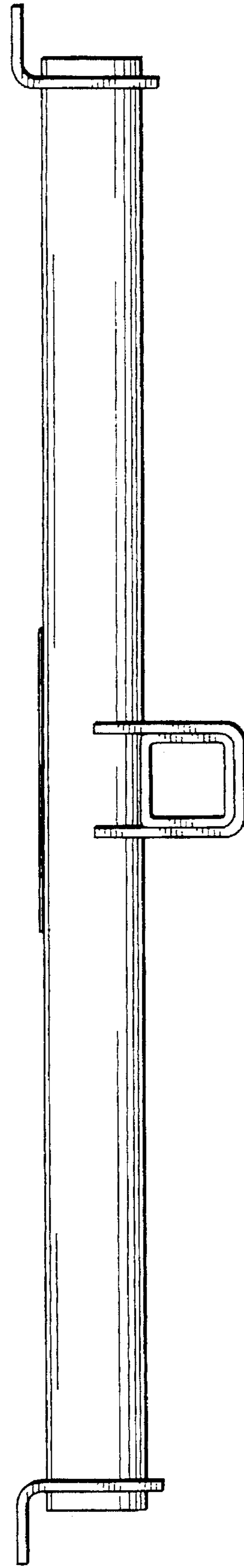
