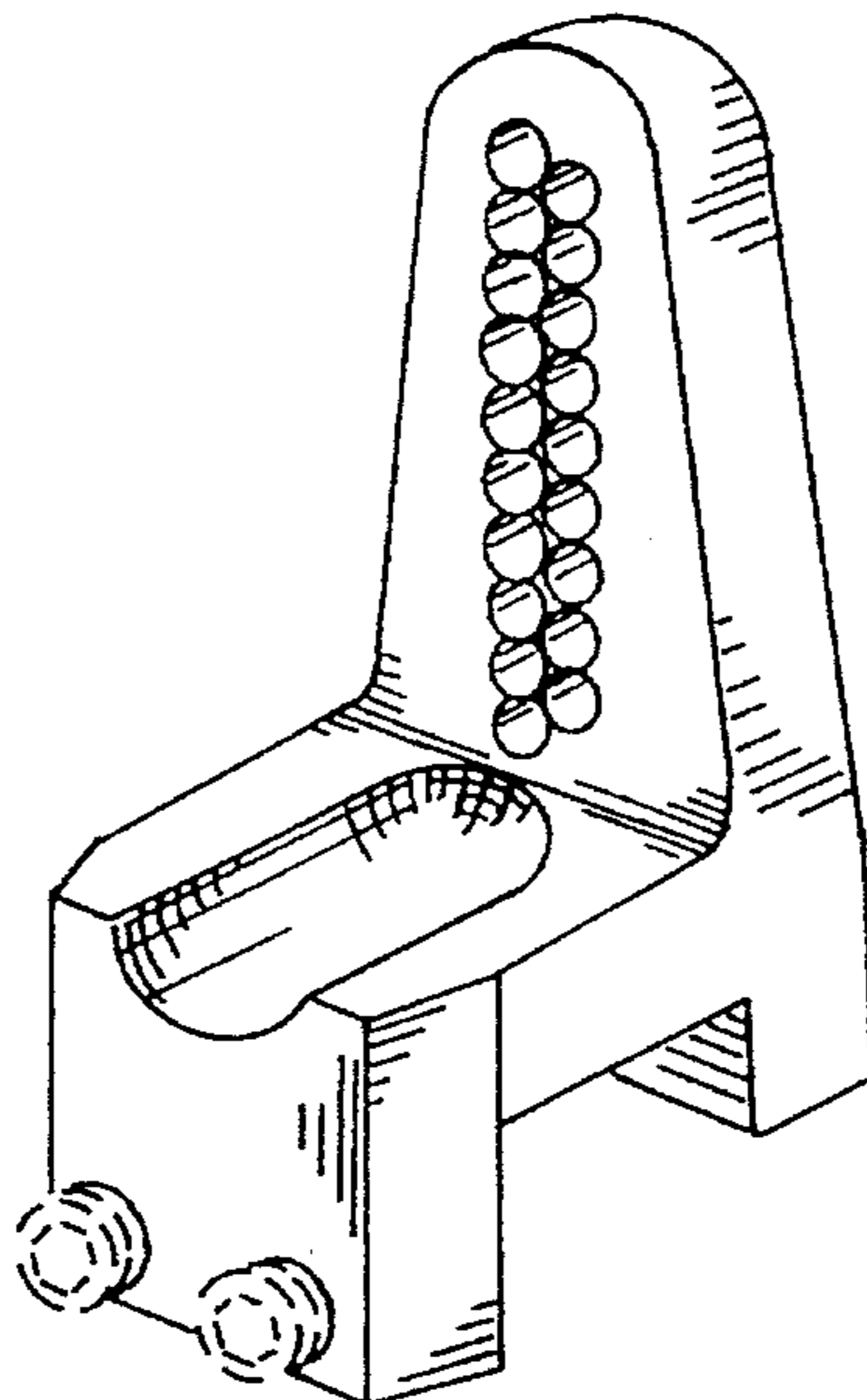
The ornamental design for an external fixation clamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an external fixation clamp; FIG. 2 is an end view thereof; FIG. 3 is an end view thereof of the end opposite the end shown in FIG. 2; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a side elevational view thereof; and, FIG. 7 is a side elevational view thereof of the side opposite the side shown in FIG. 6.

The broken line showing of the set screws in FIGS. 1-7 is for illustrative purposes only and forms no part of the claimed design.

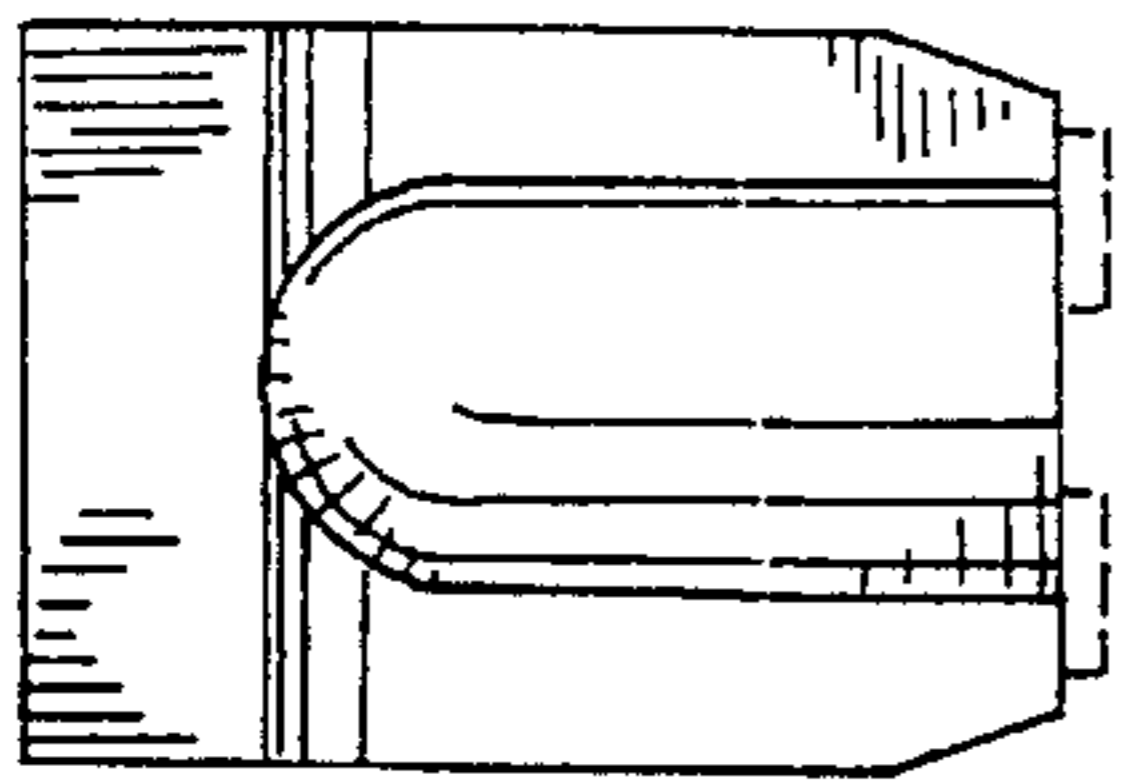

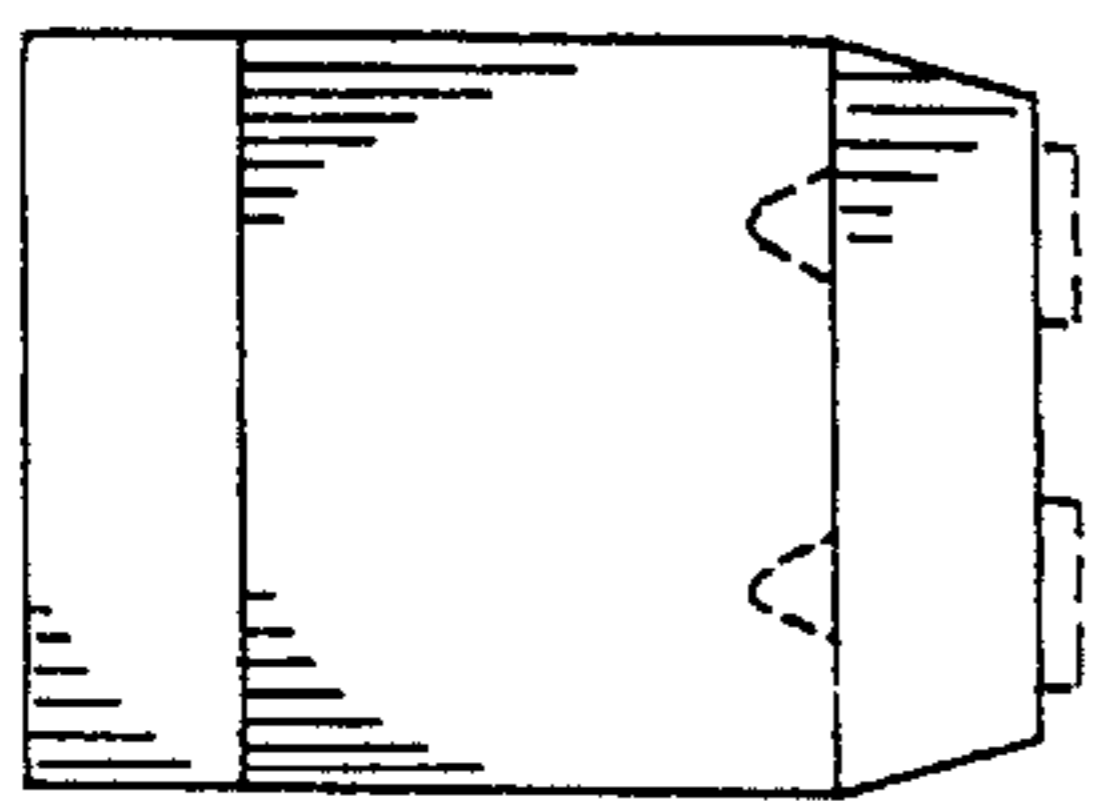

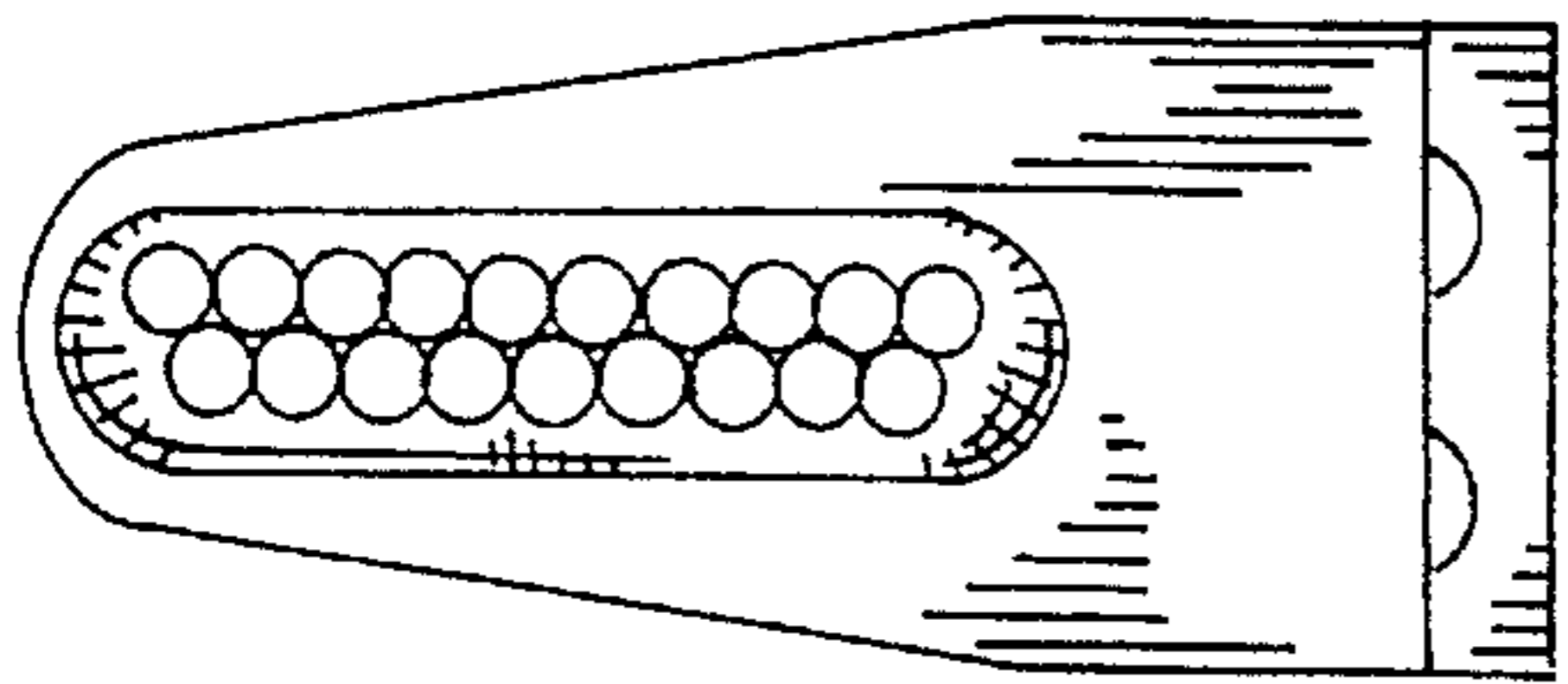

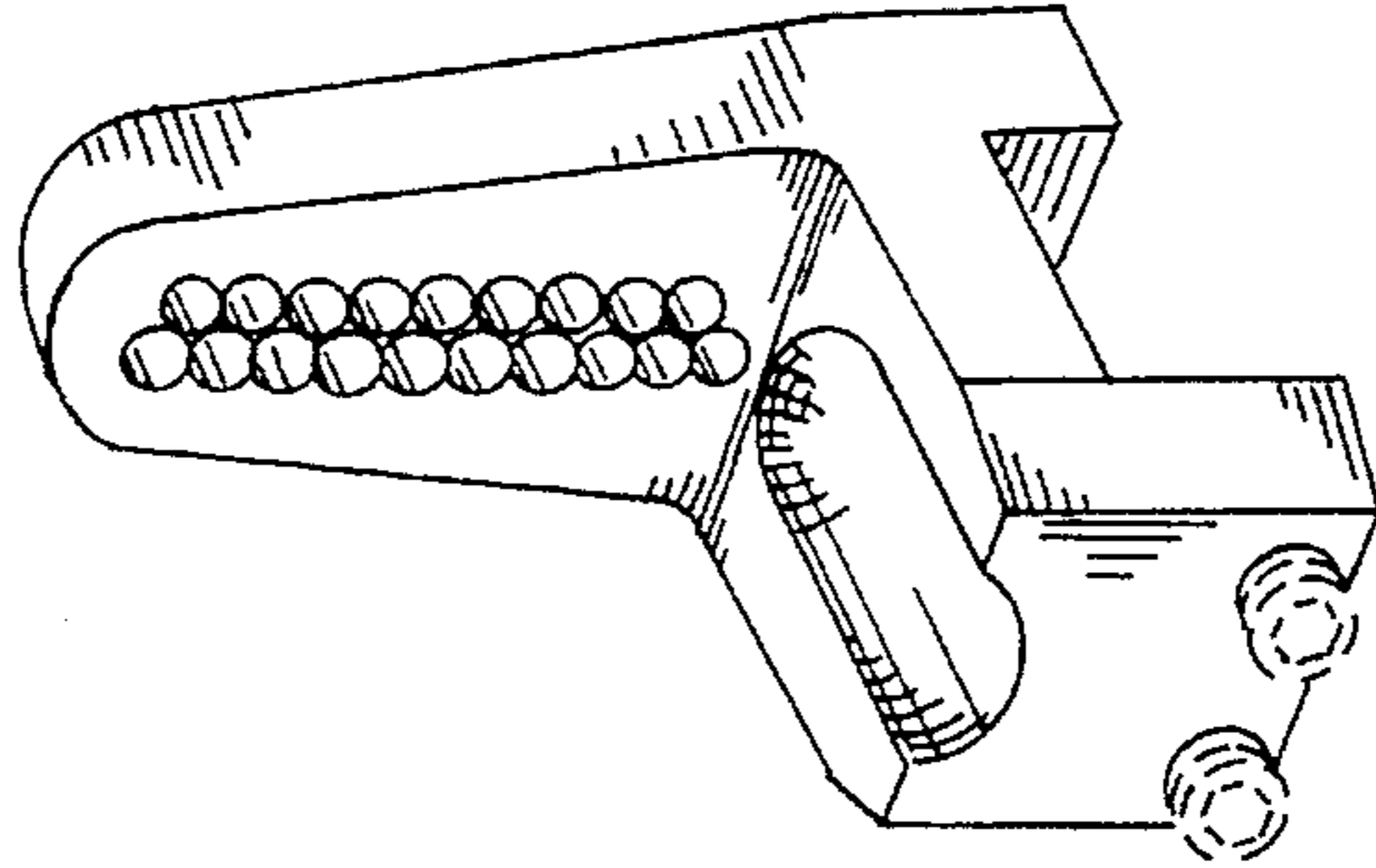

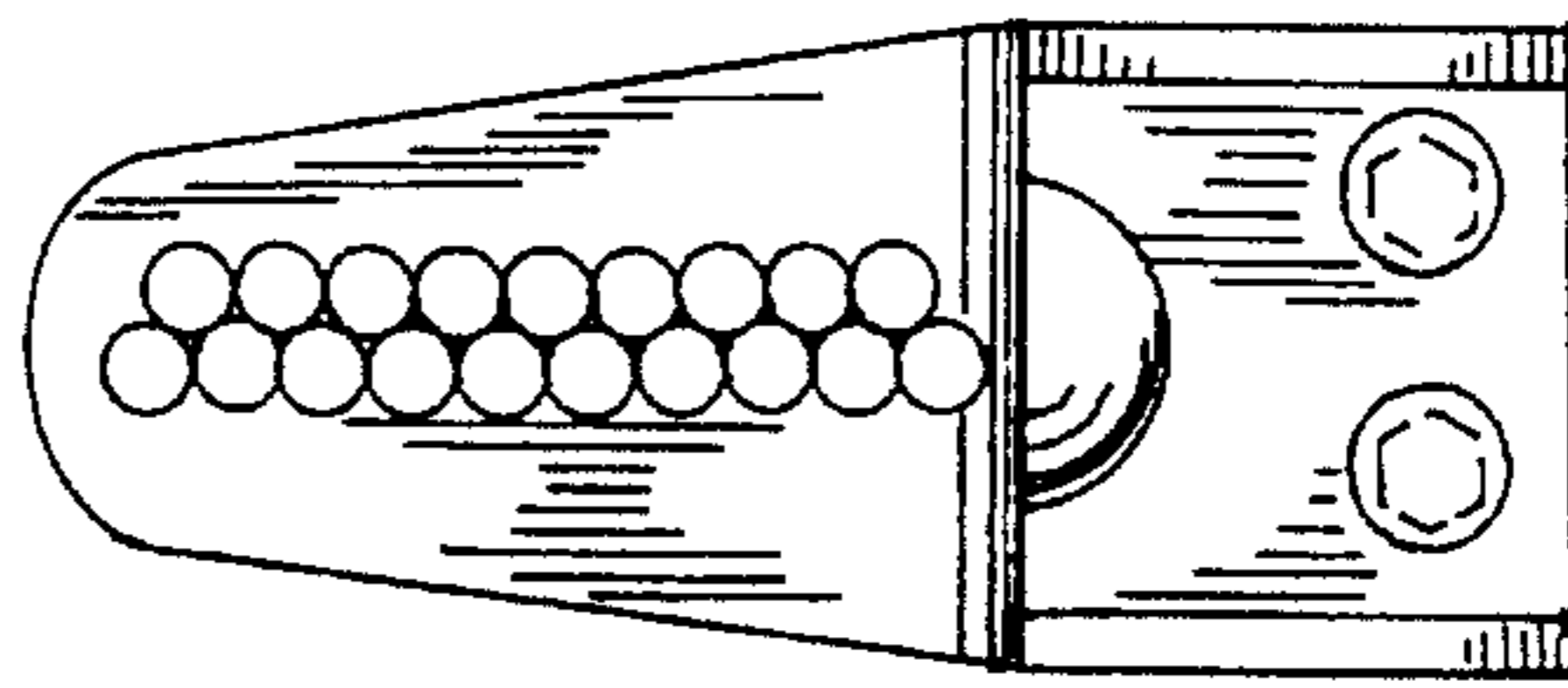

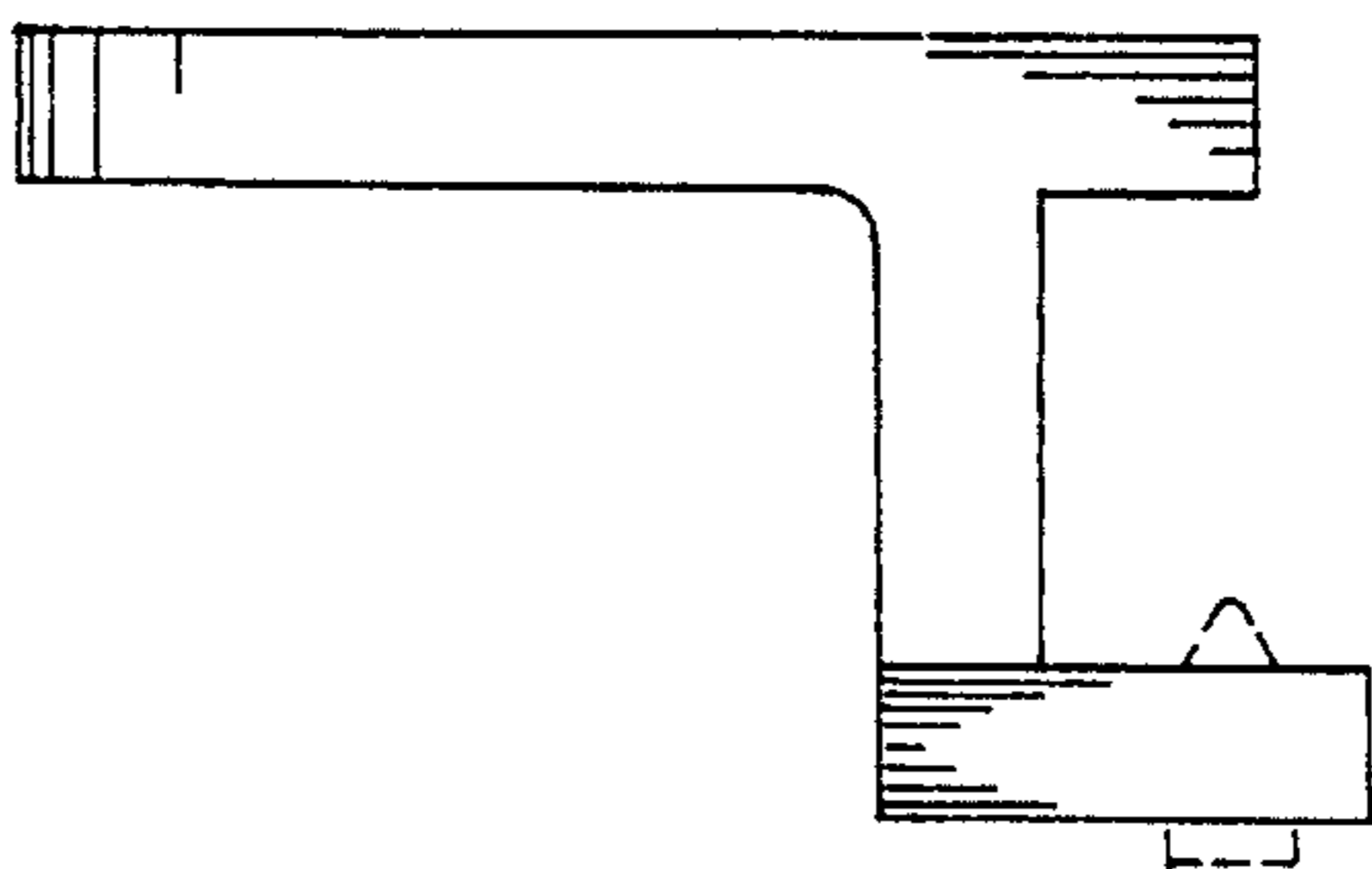

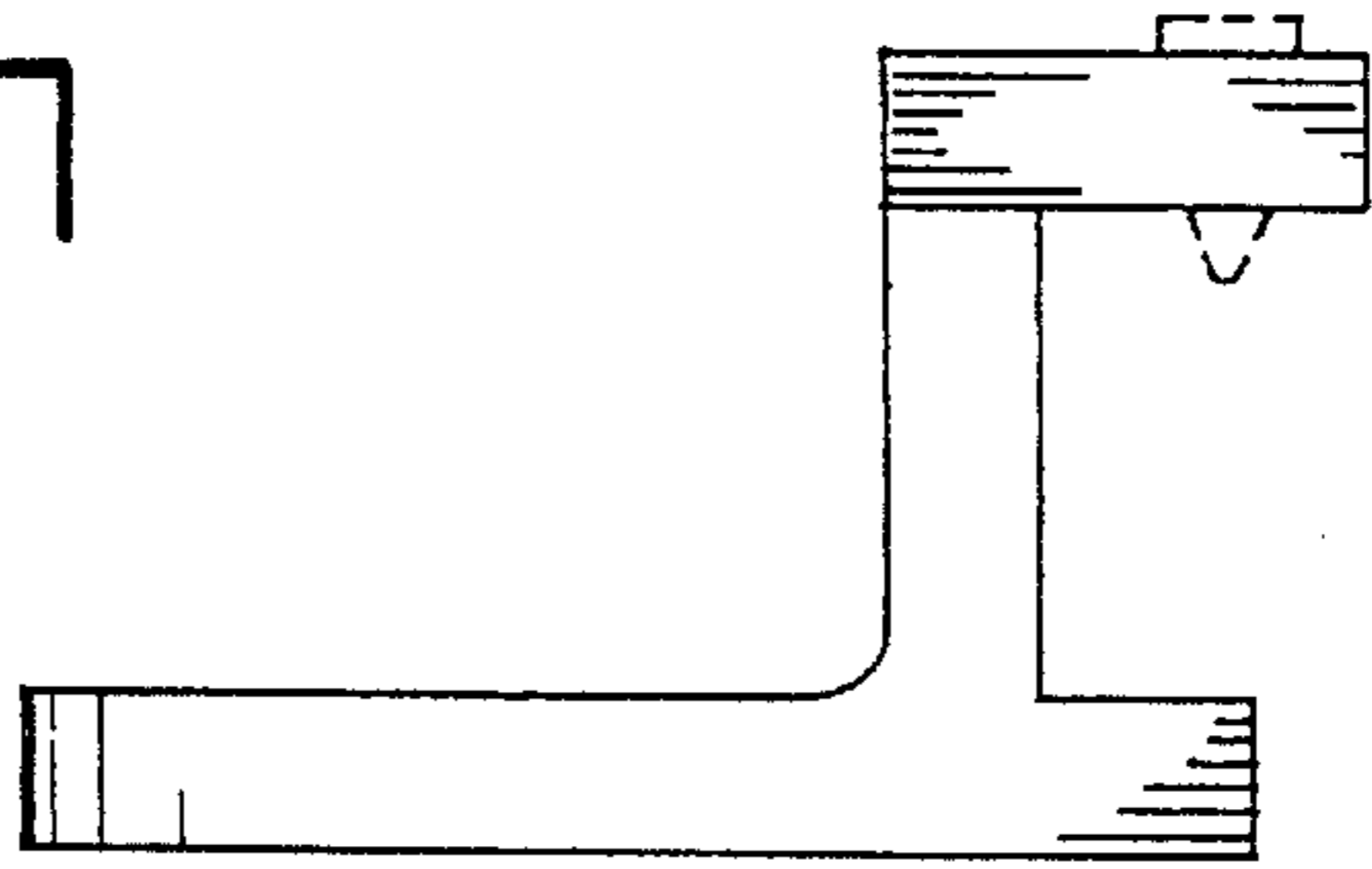
