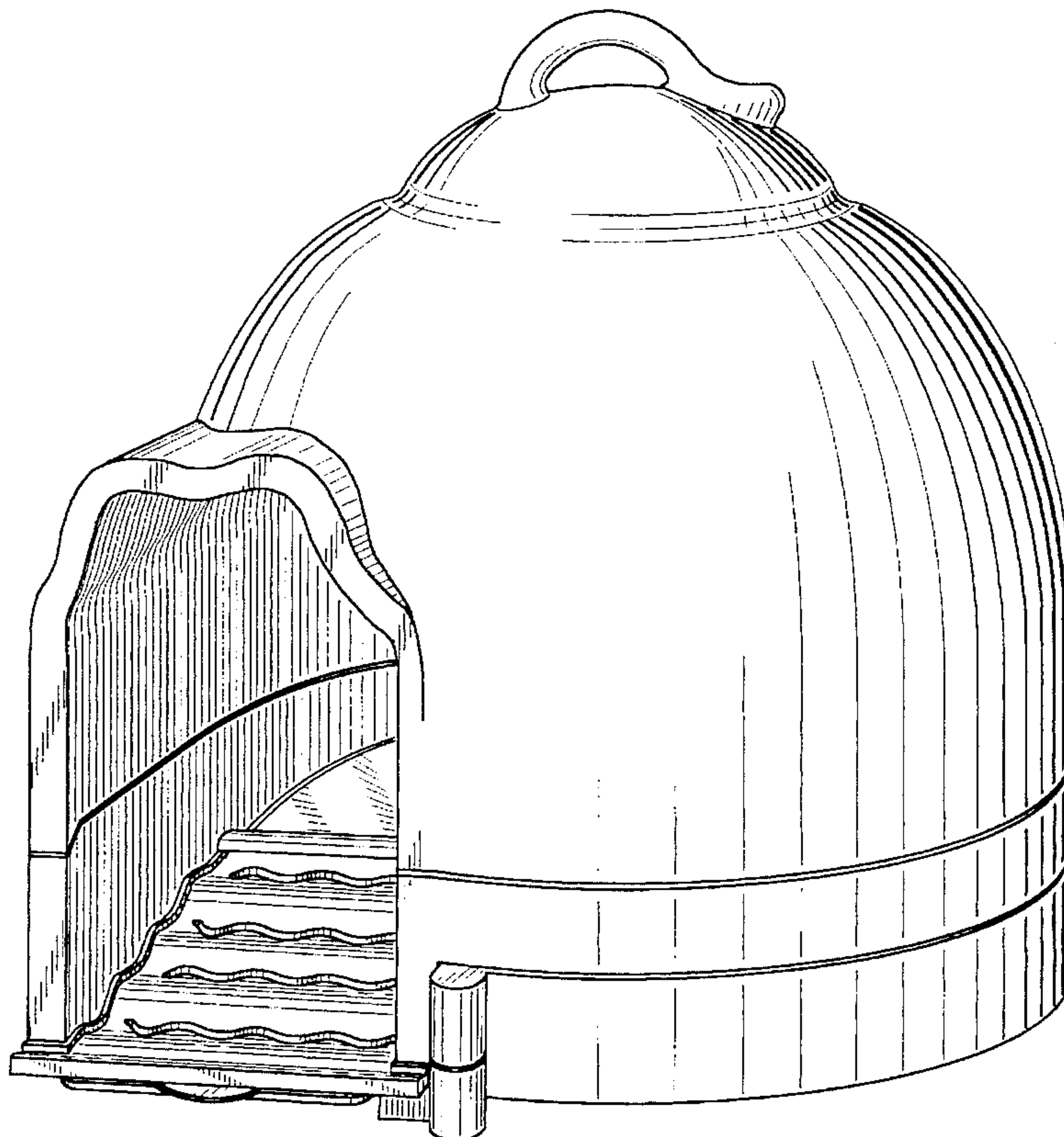

DESCRIPTION

FIG. 1 is a perspective view of the front and right side of the design for the domed cat litter box, illustrating the design for the entrance, ramp, and dome;

FIG. 2 is a plan view of the front of the design;

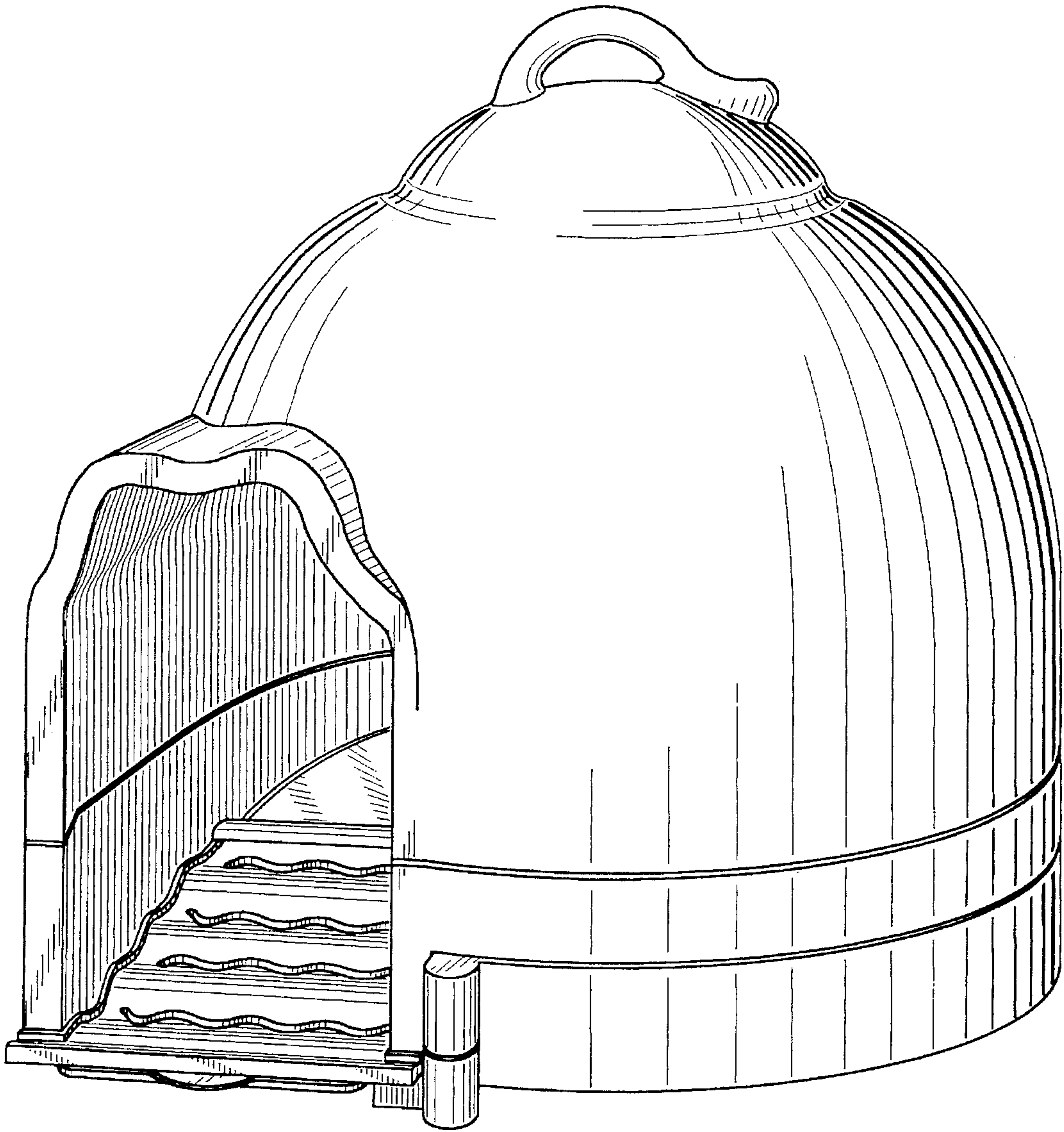

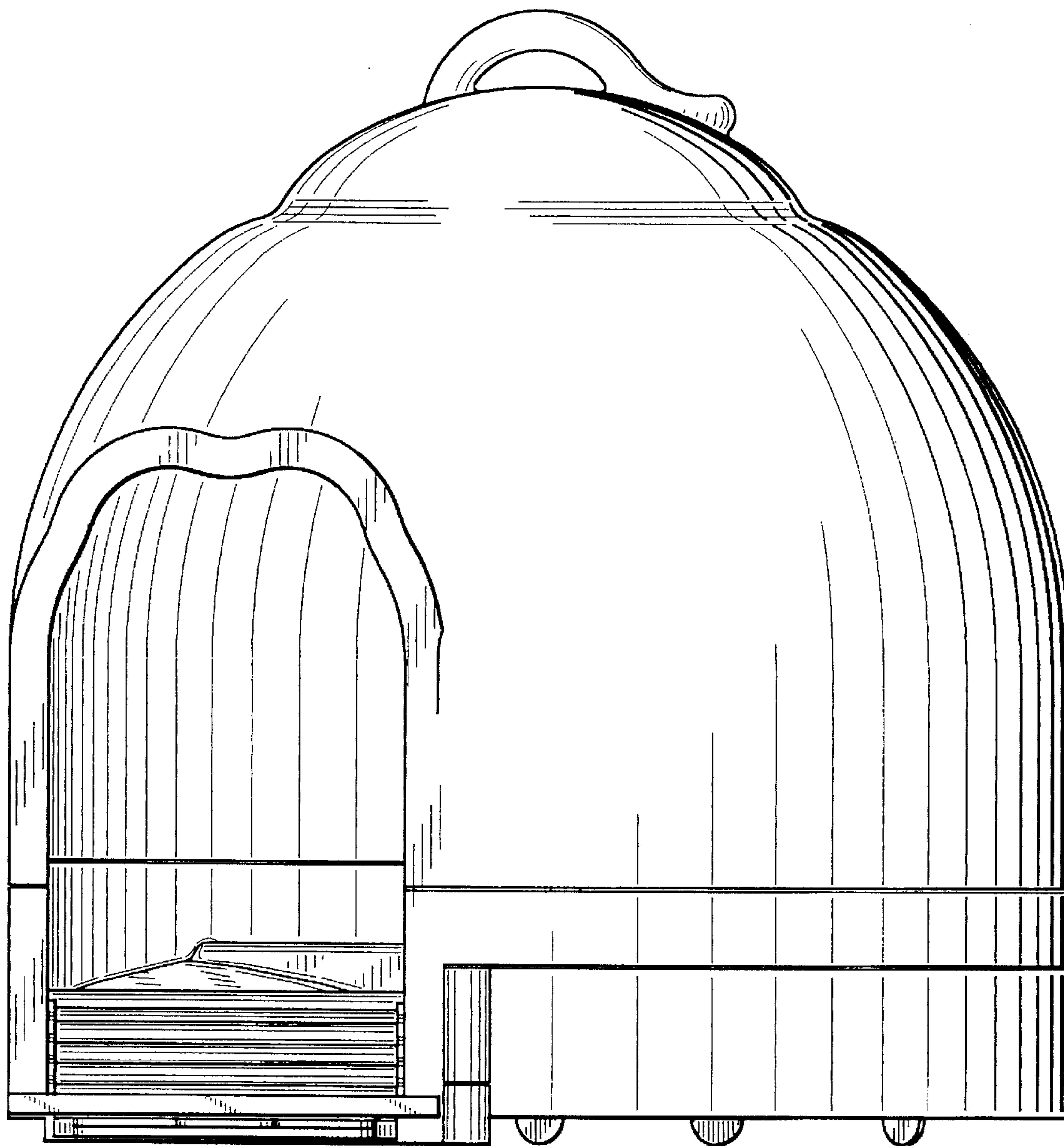

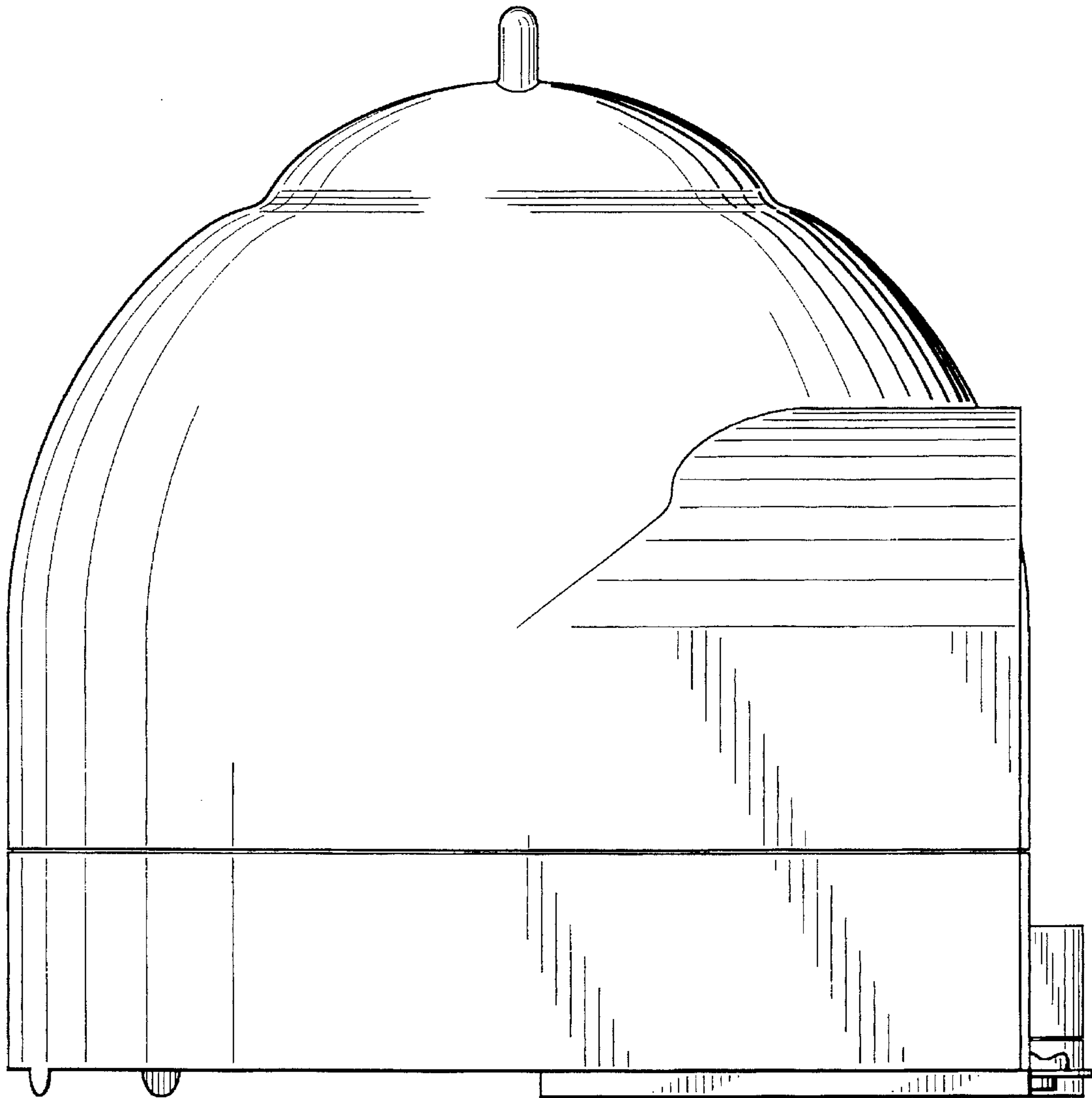

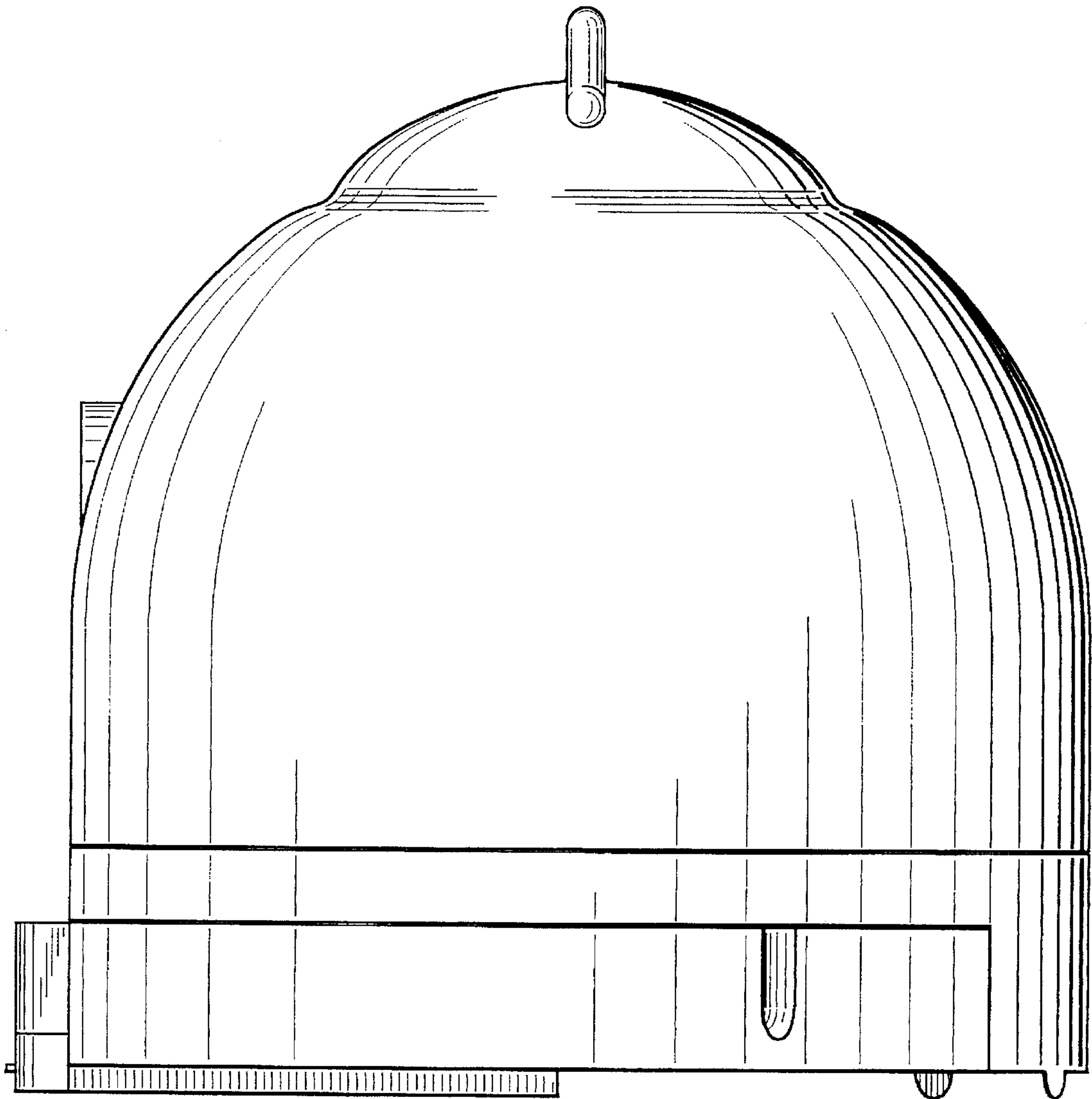

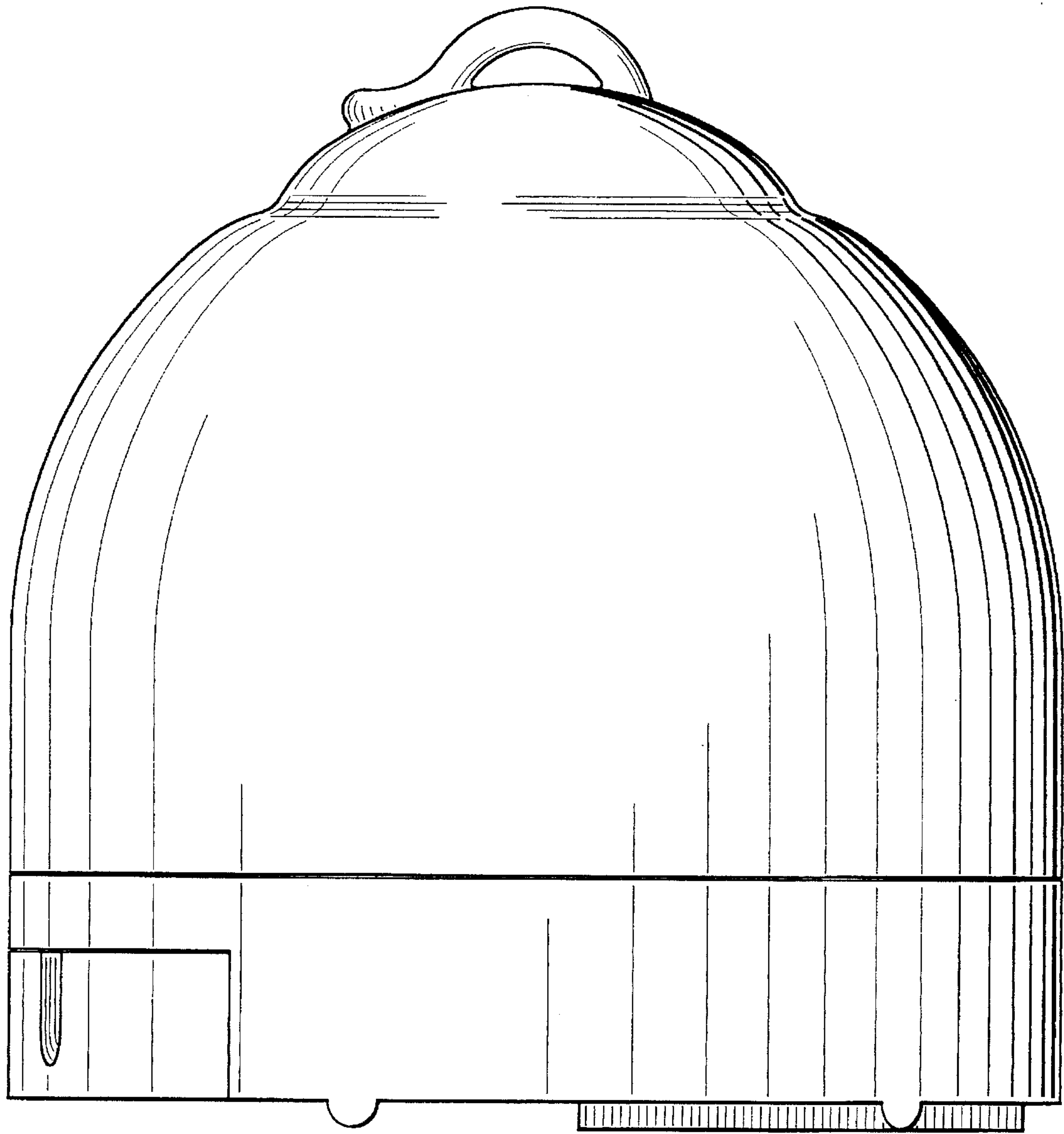

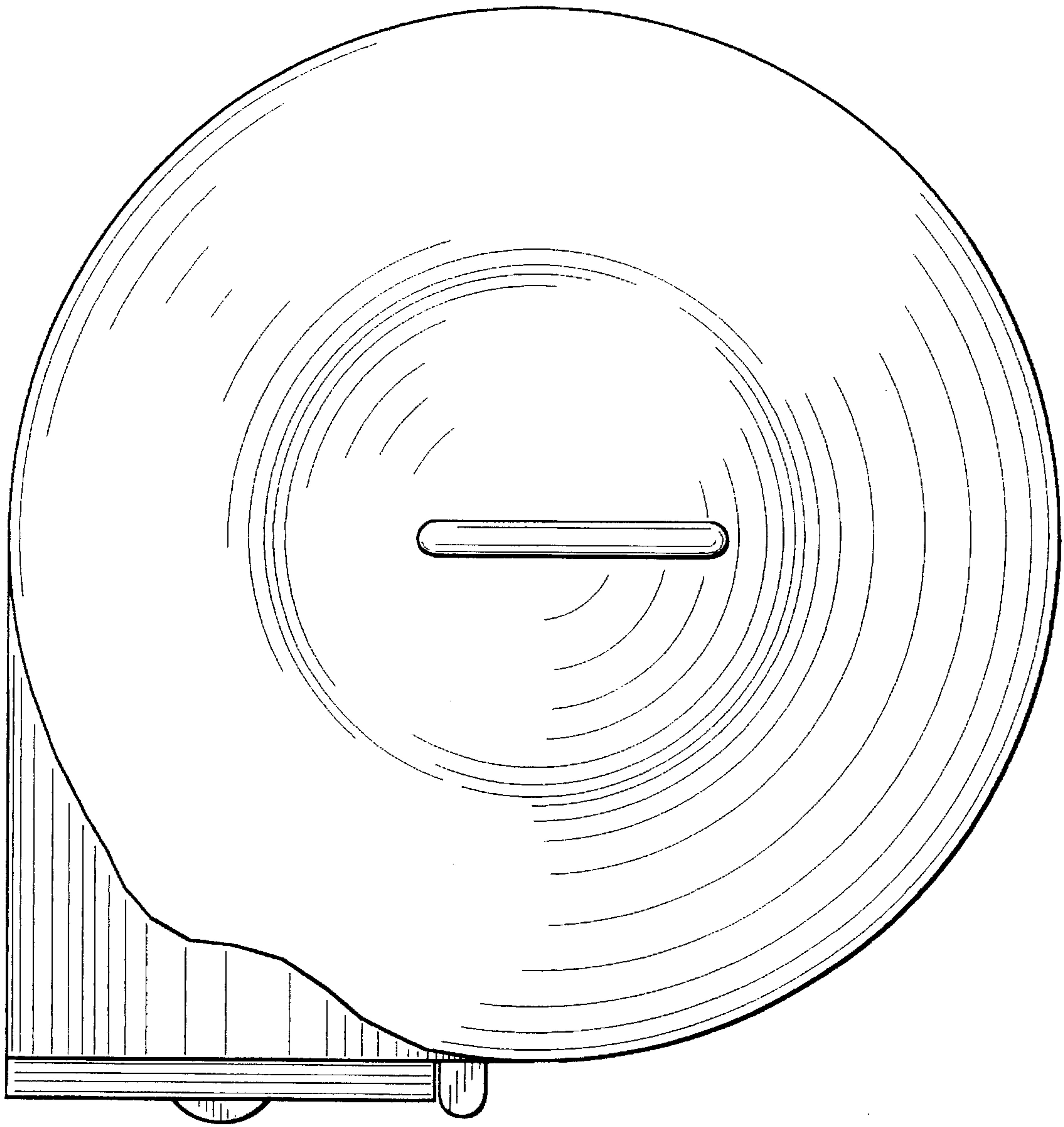

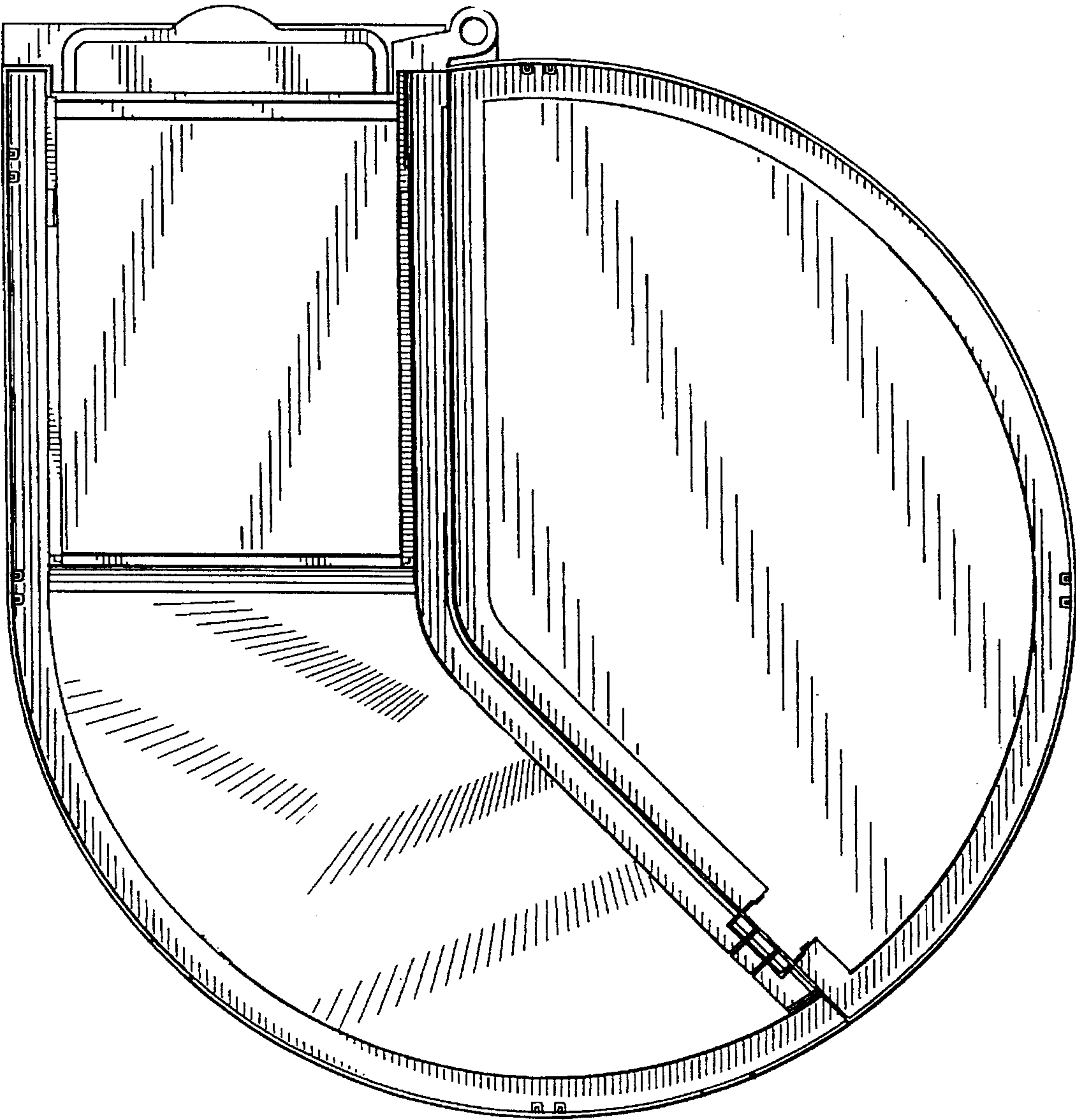
