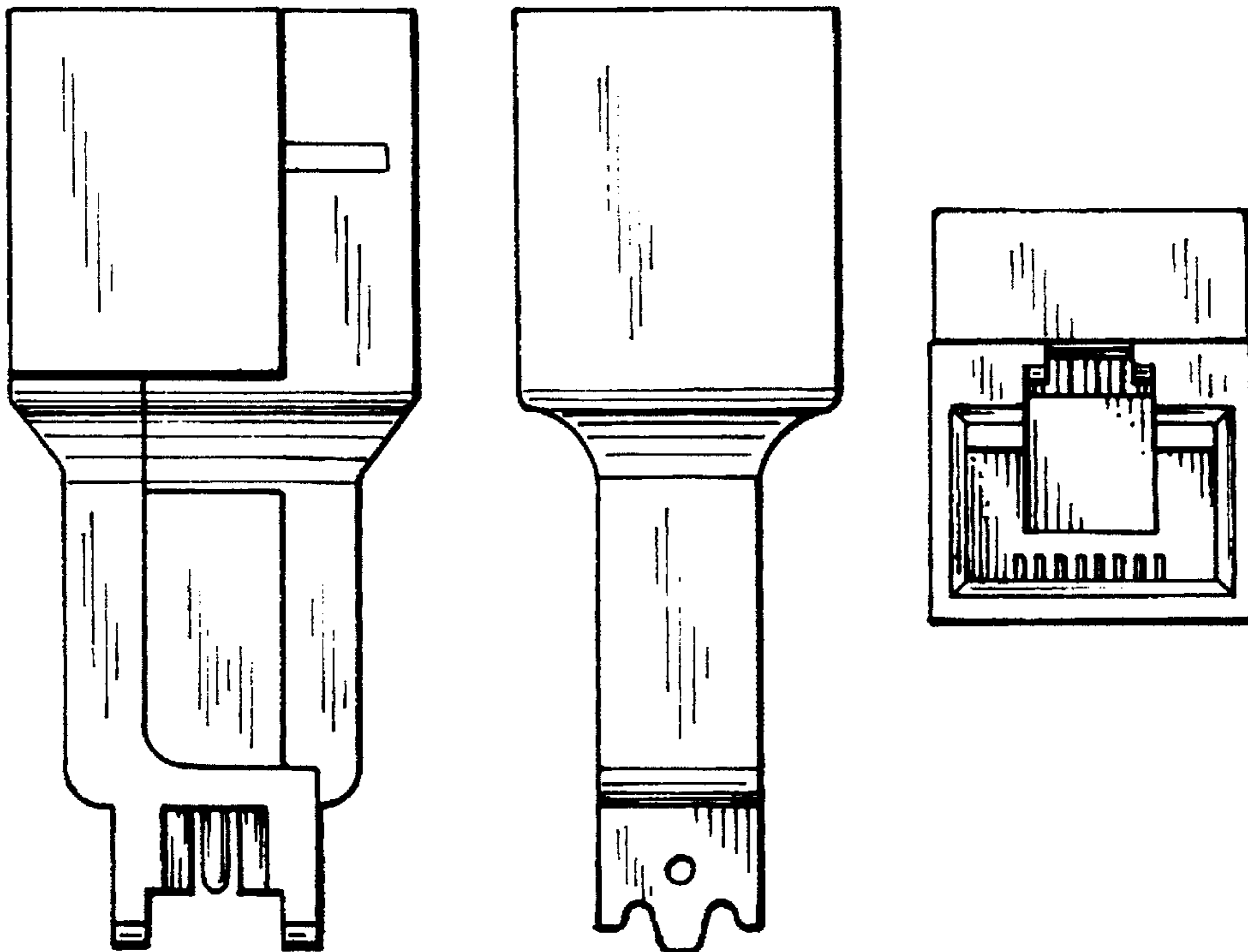
[57] **CLAIM**

The ornamental design for a telecommunications block test adapter, as shown and described.

**DESCRIPTION**

FIG. 1 shows a right side elevation view of a first embodiment of my new design with the left side elevation view being a mirror image thereof;

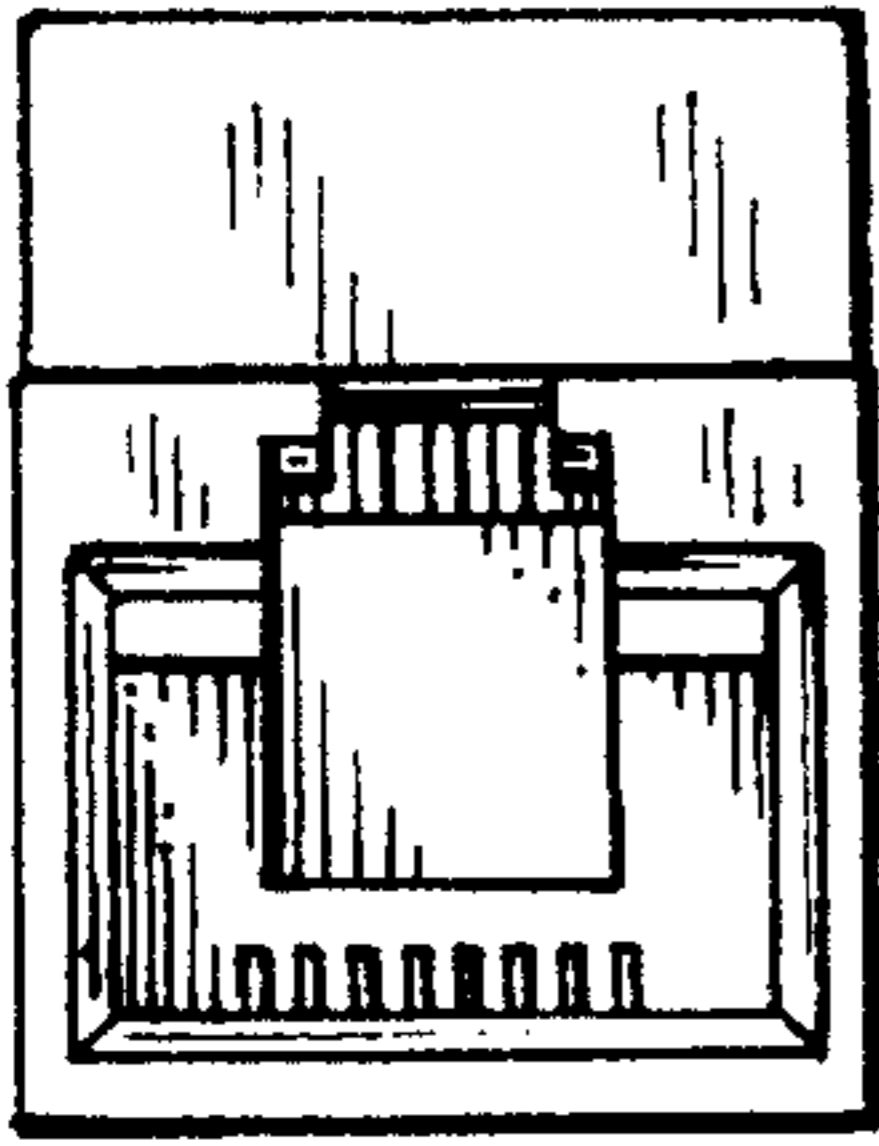

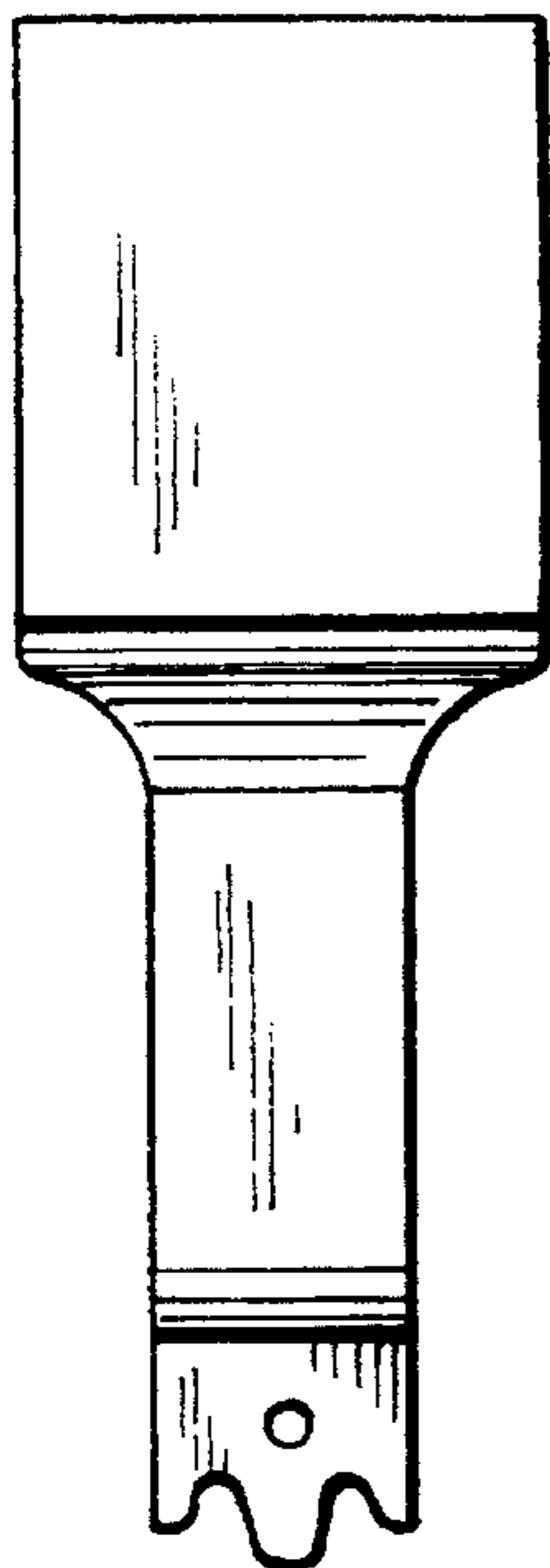

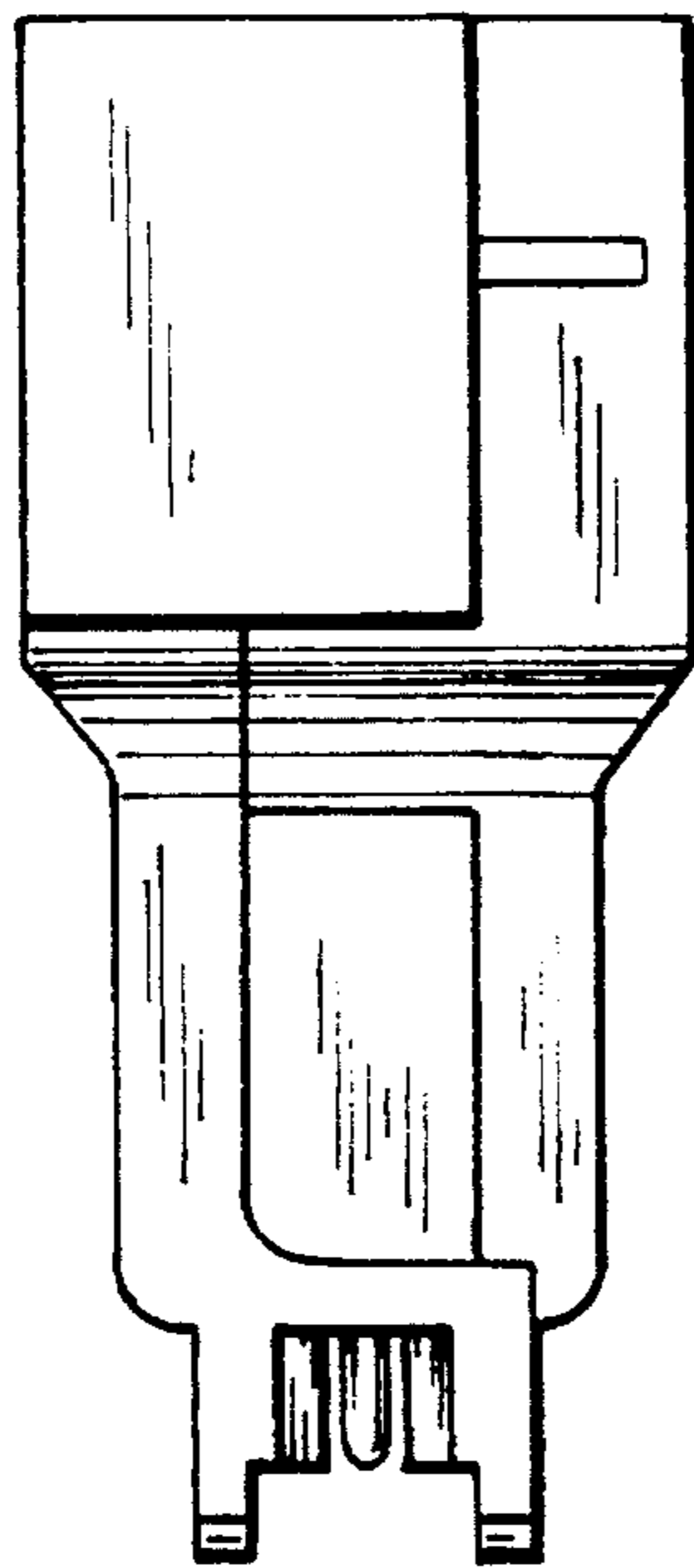

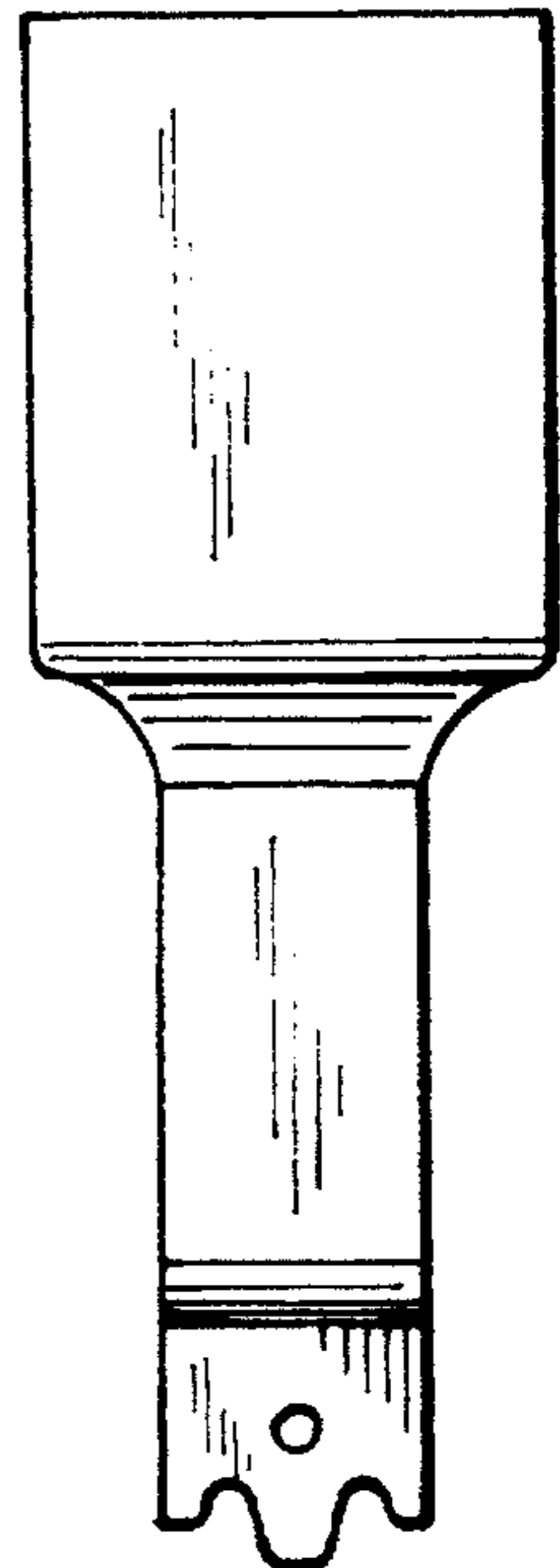

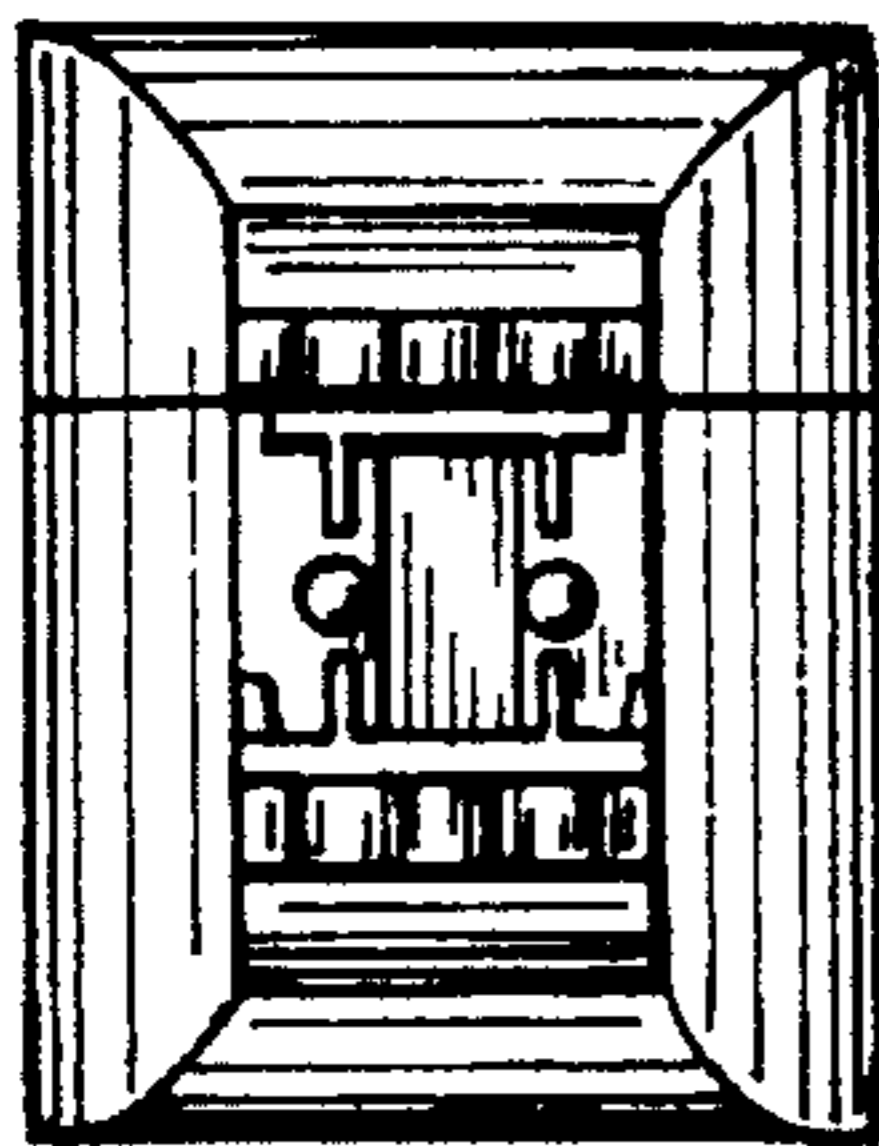

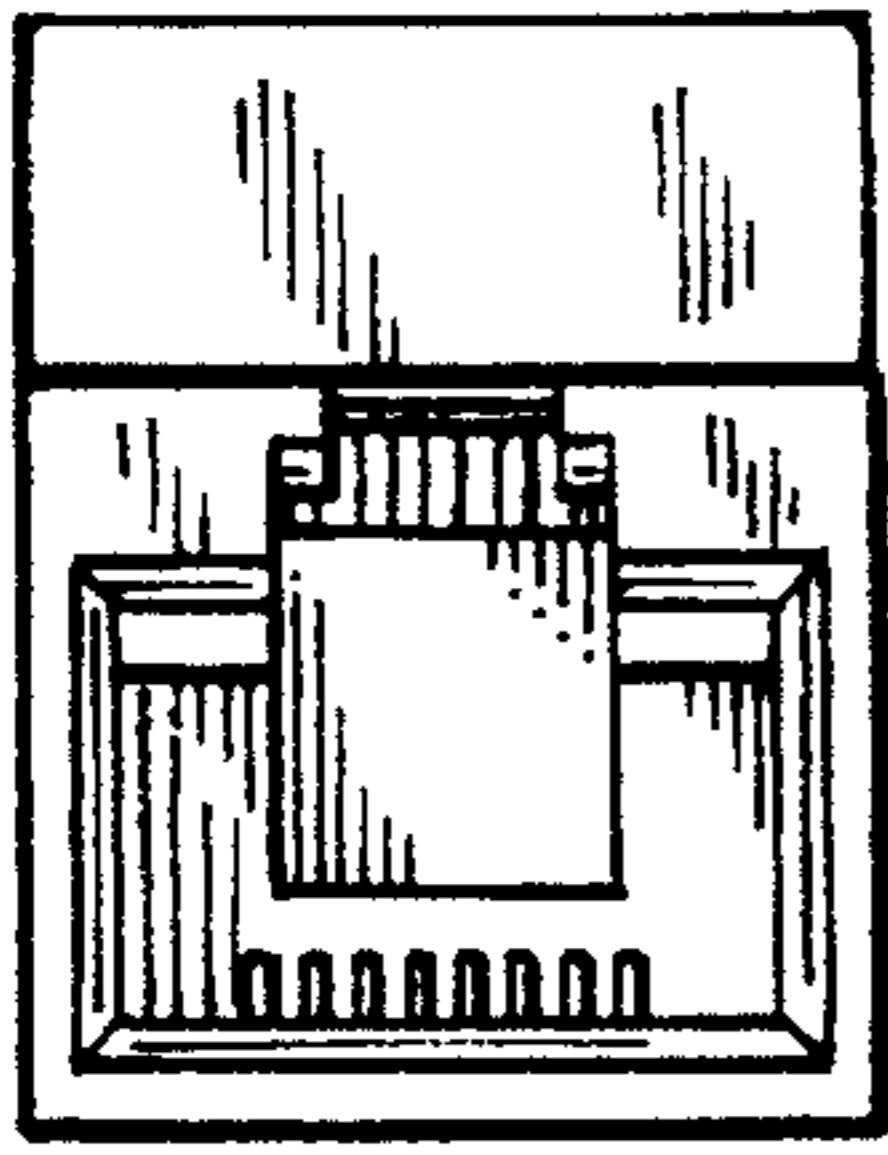

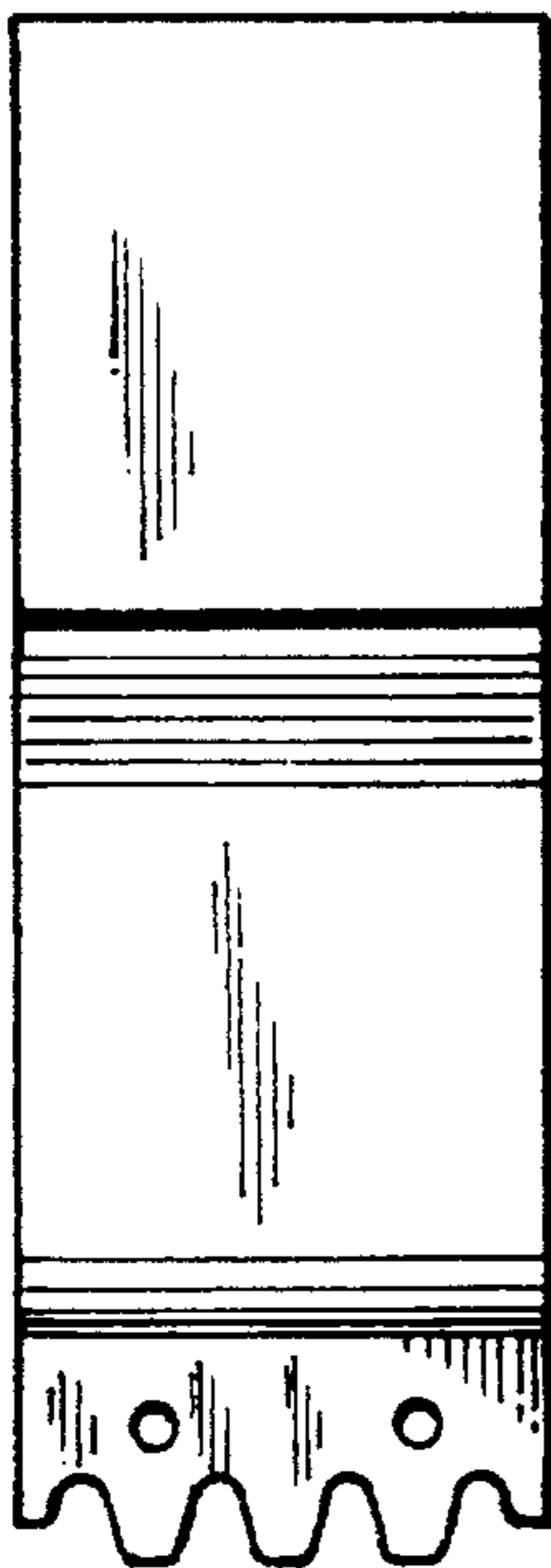

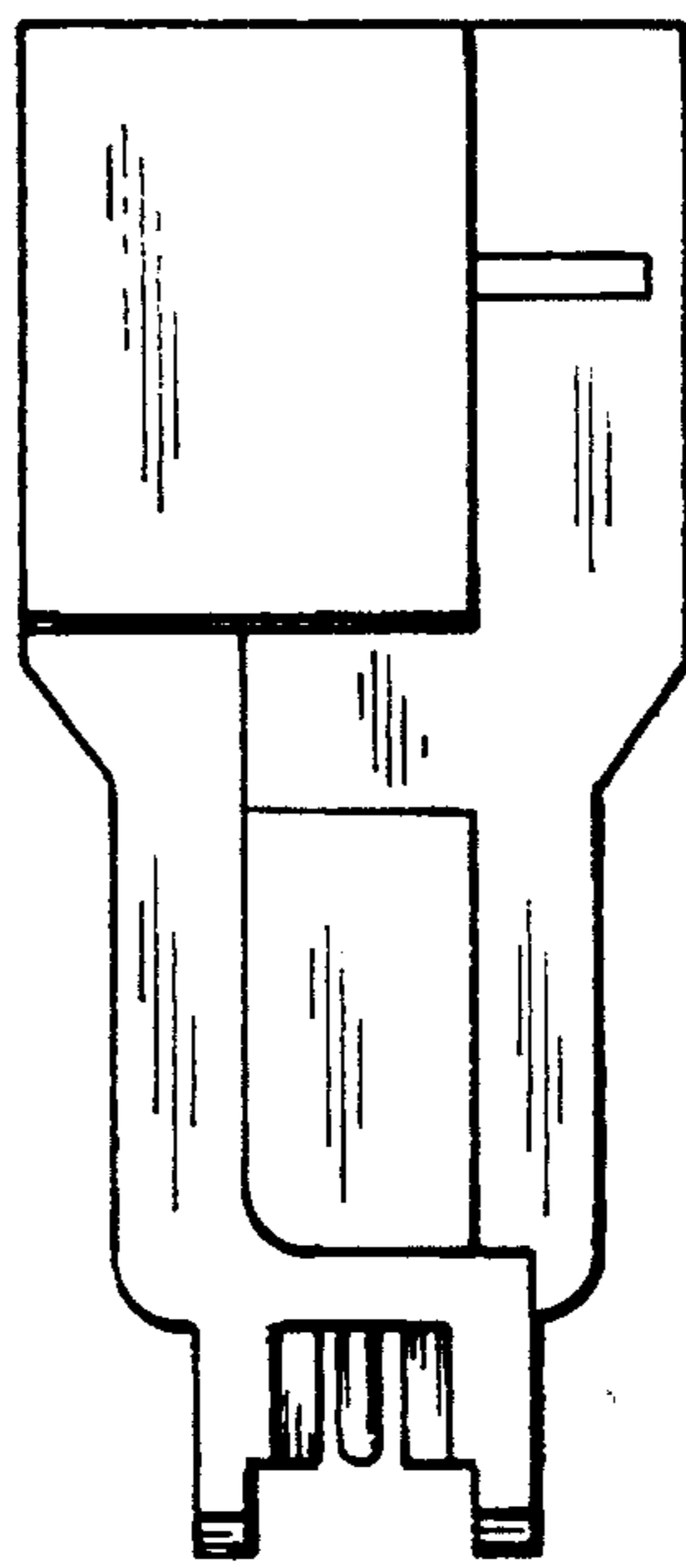

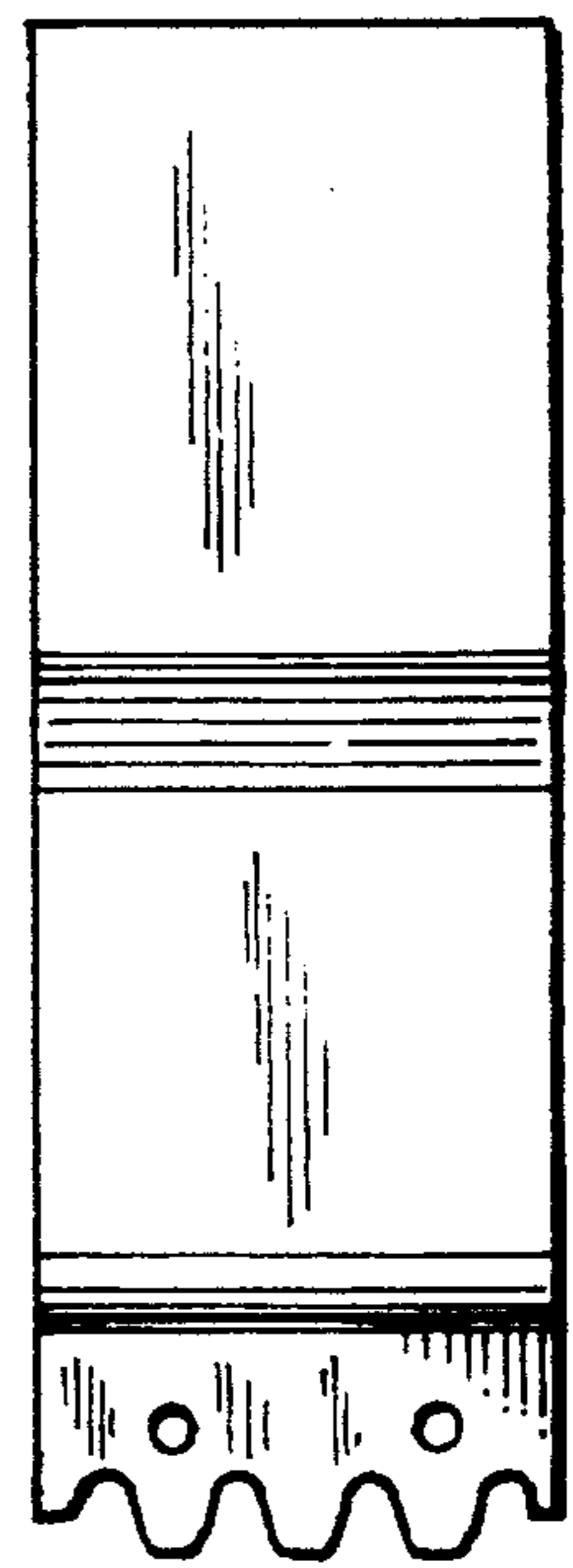

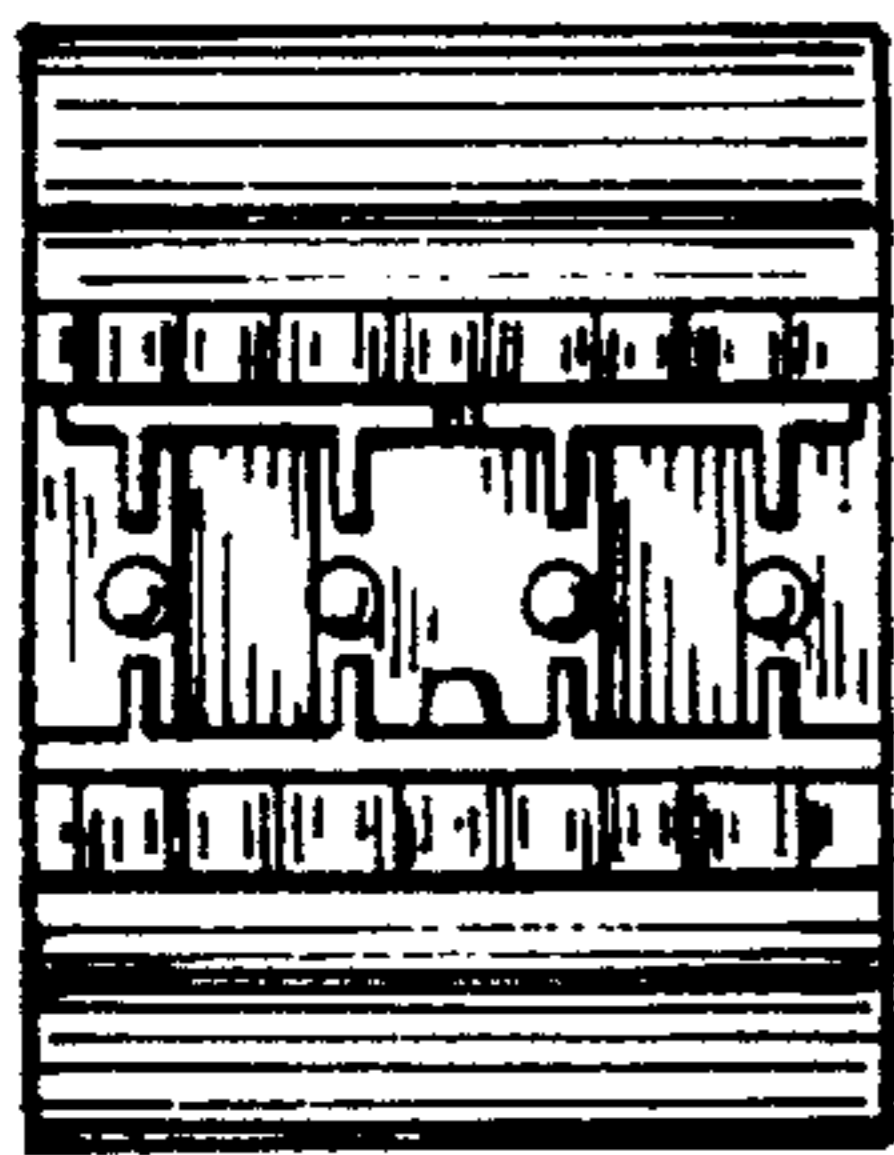

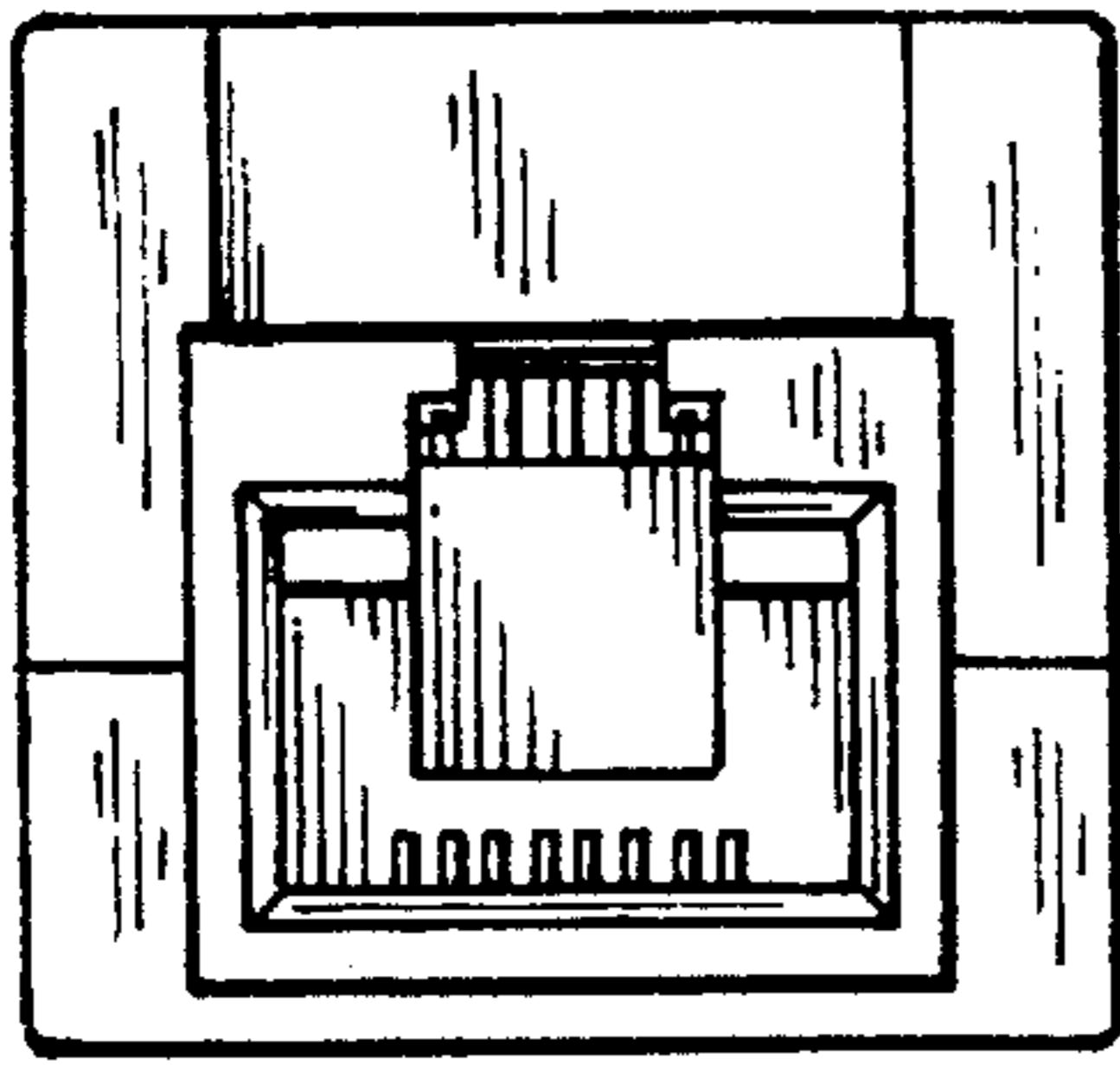

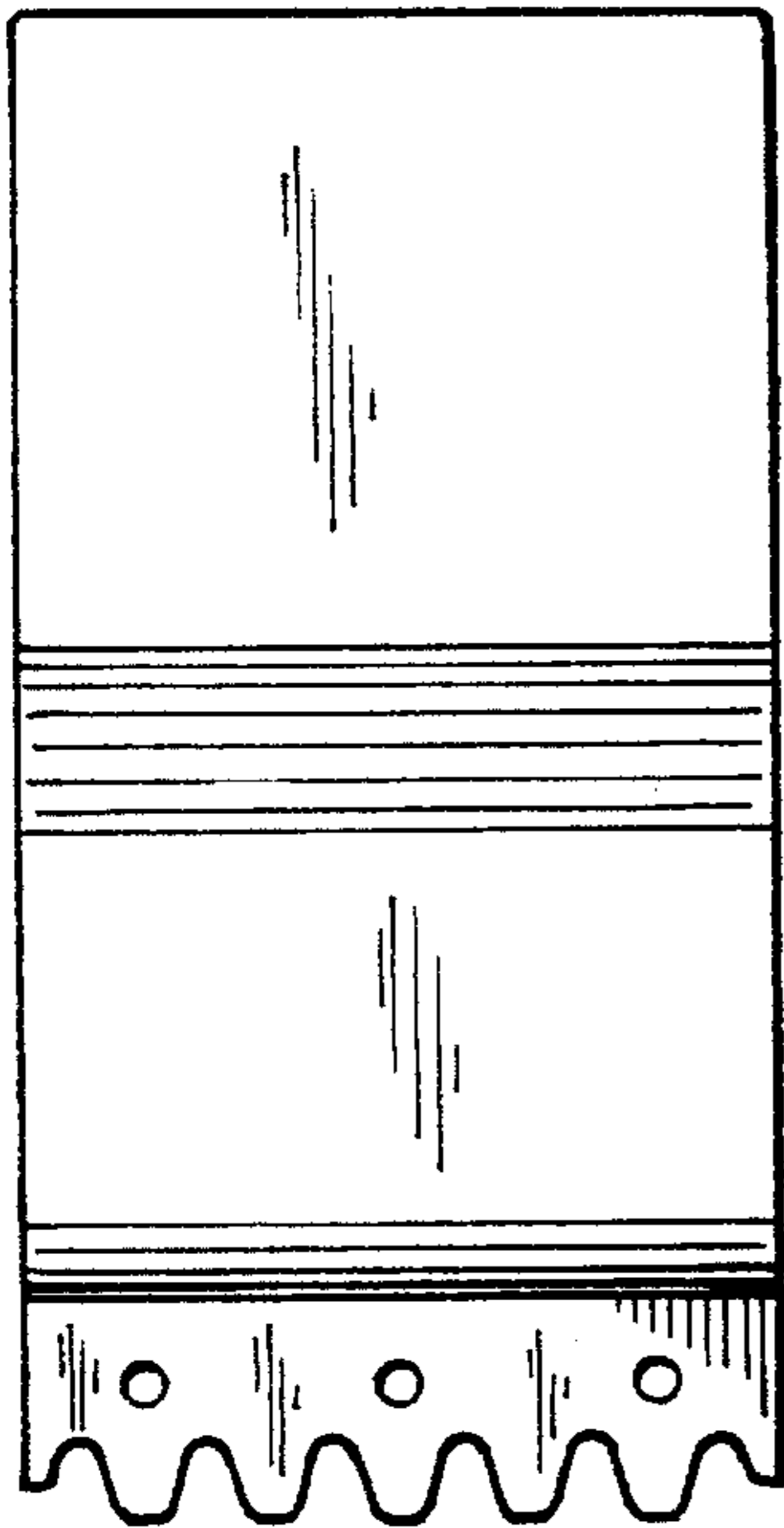

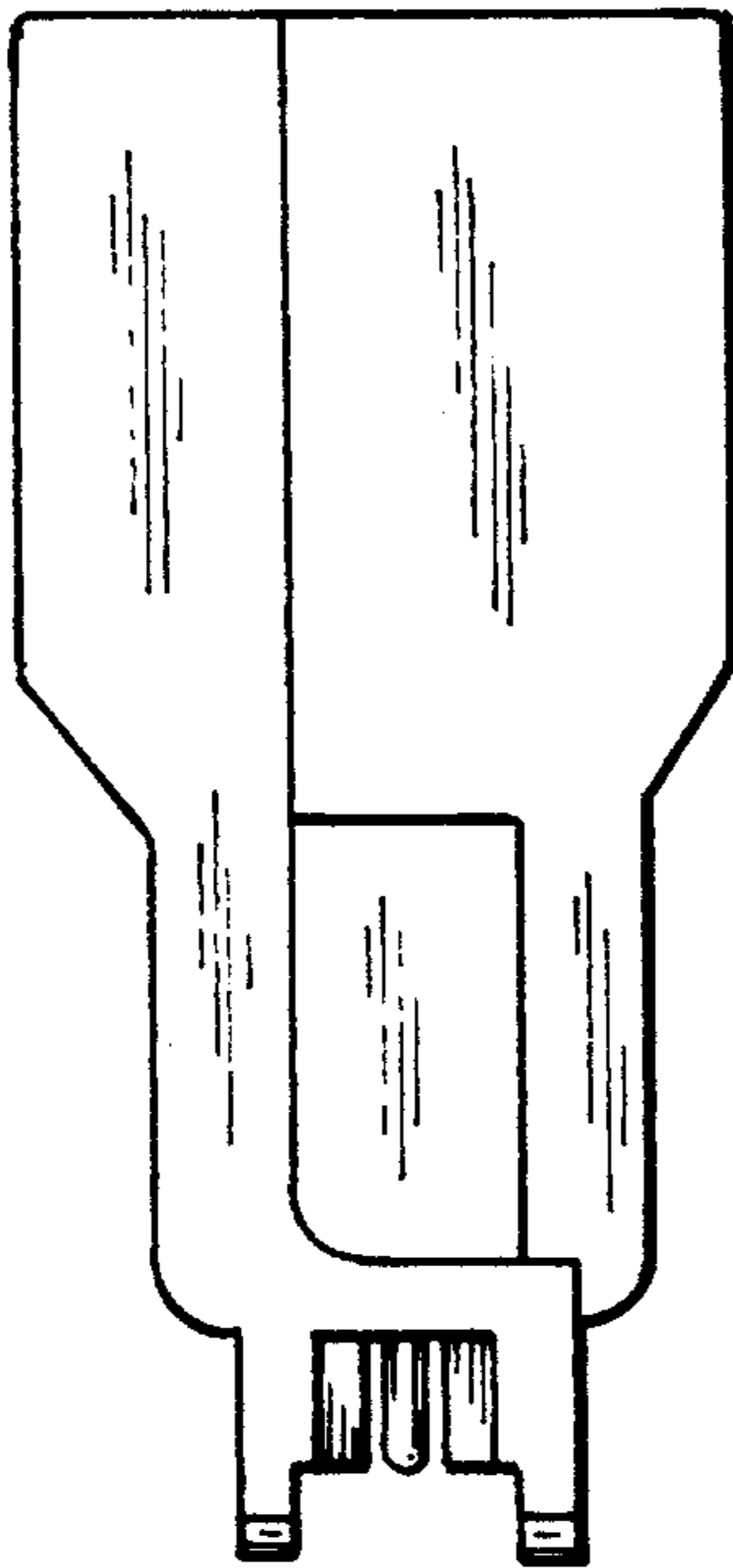

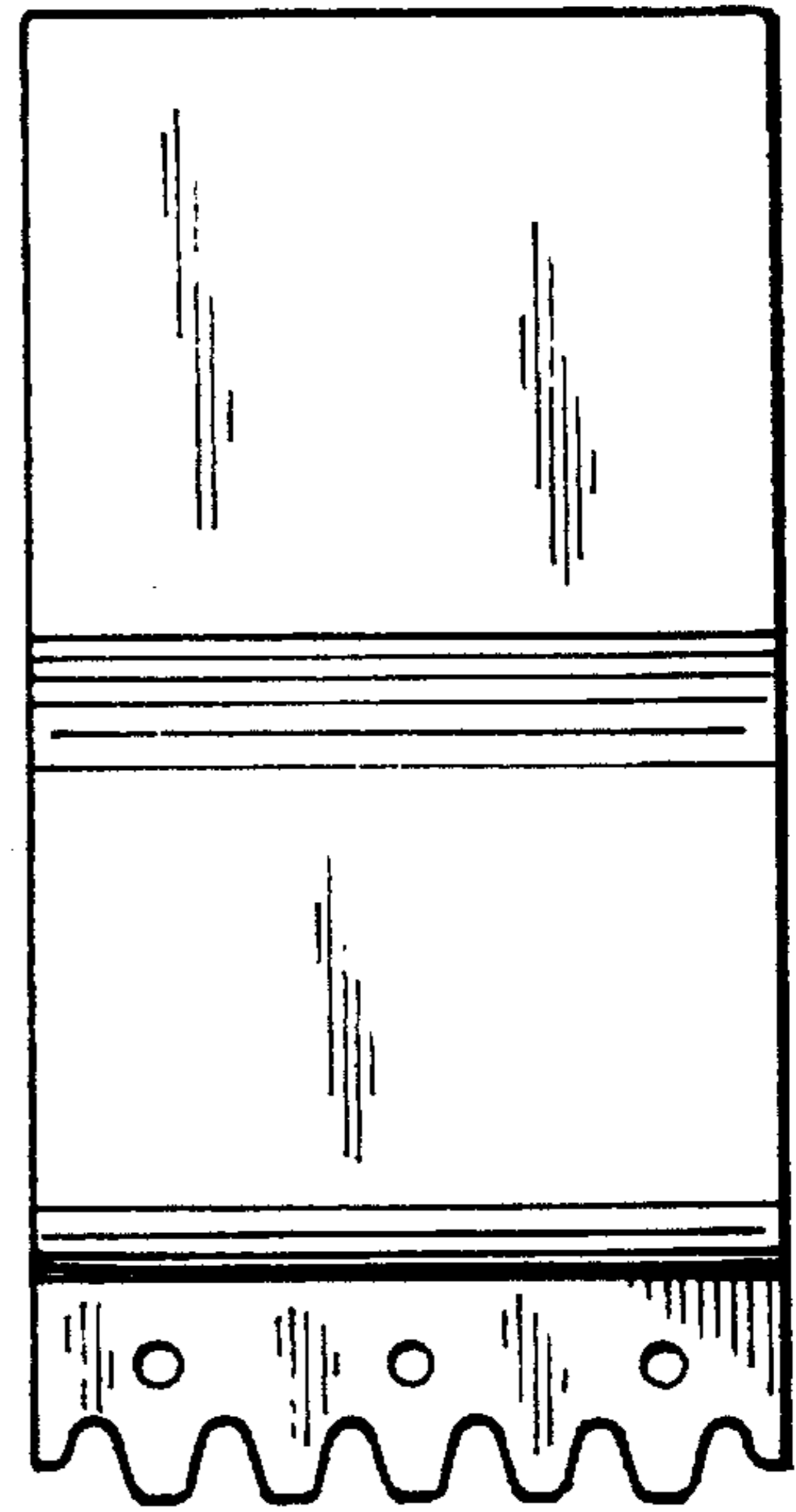

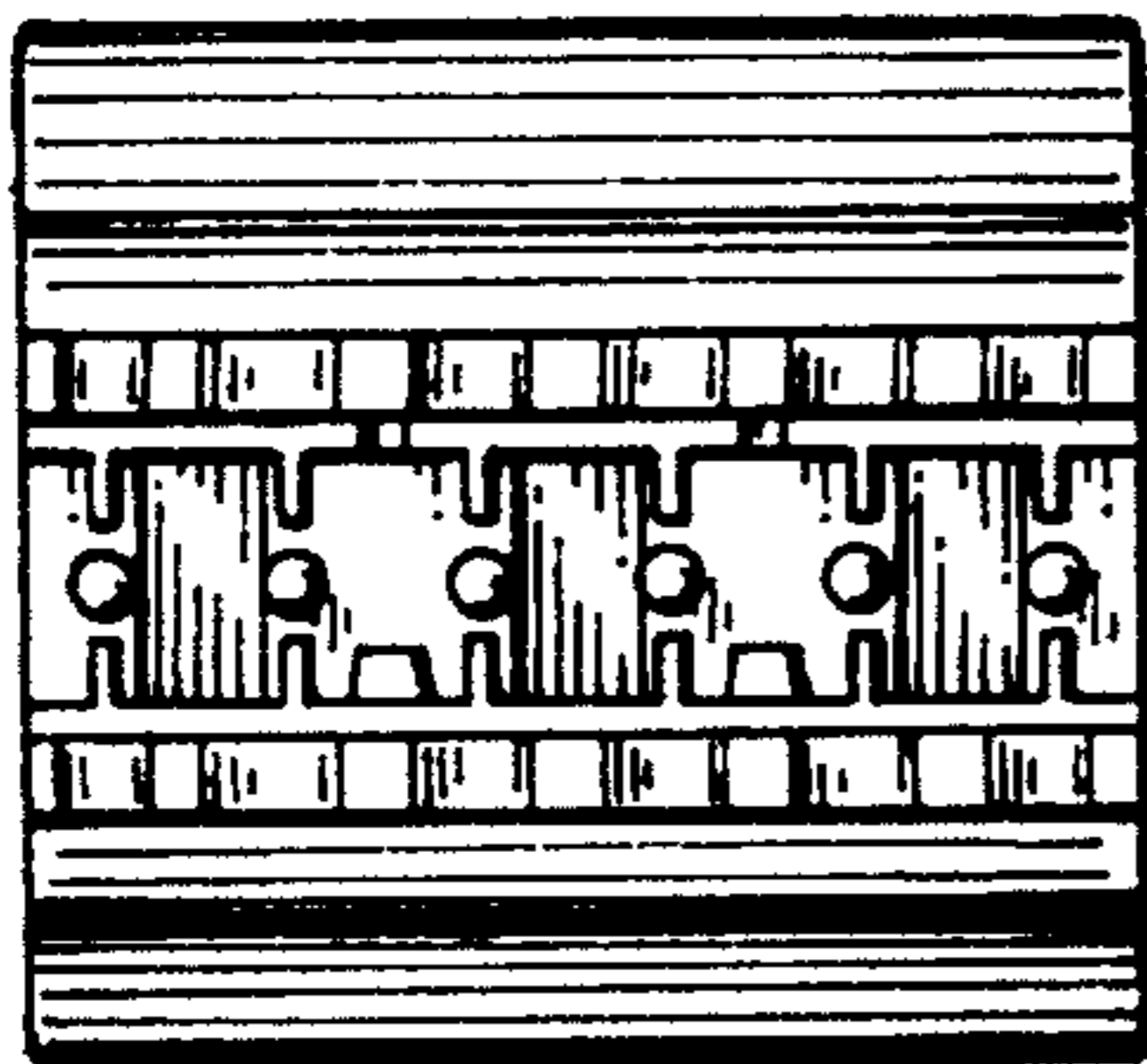

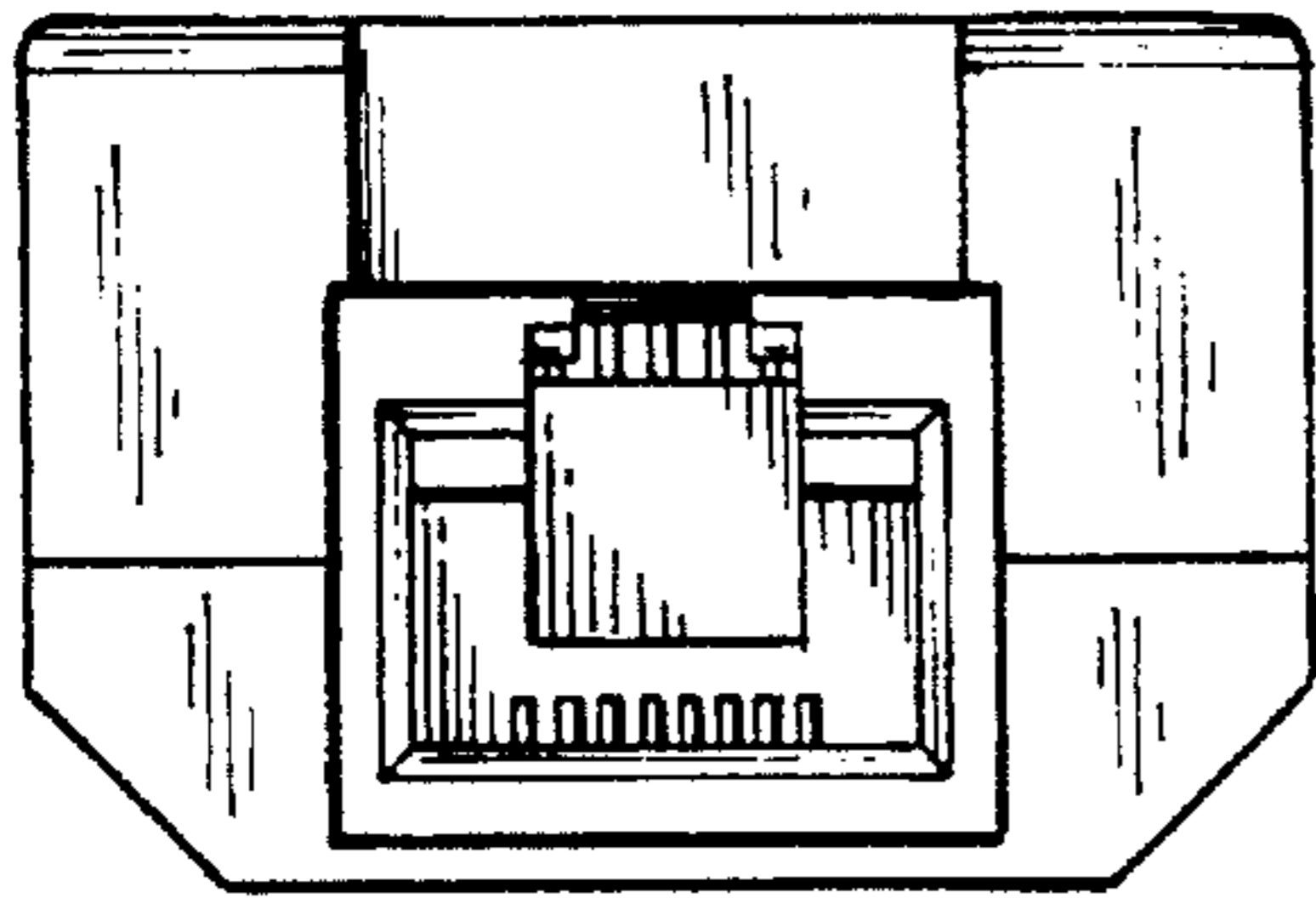

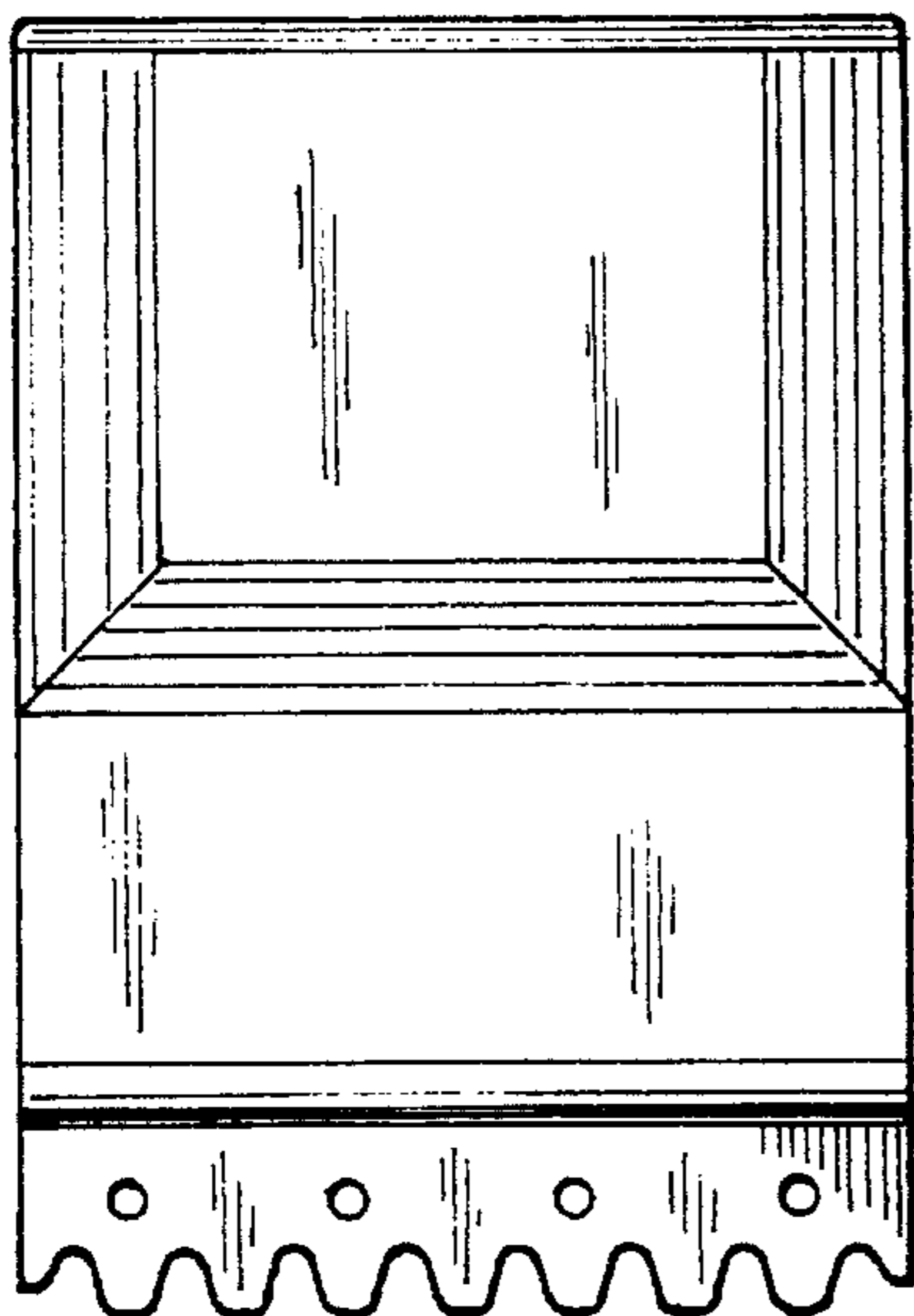

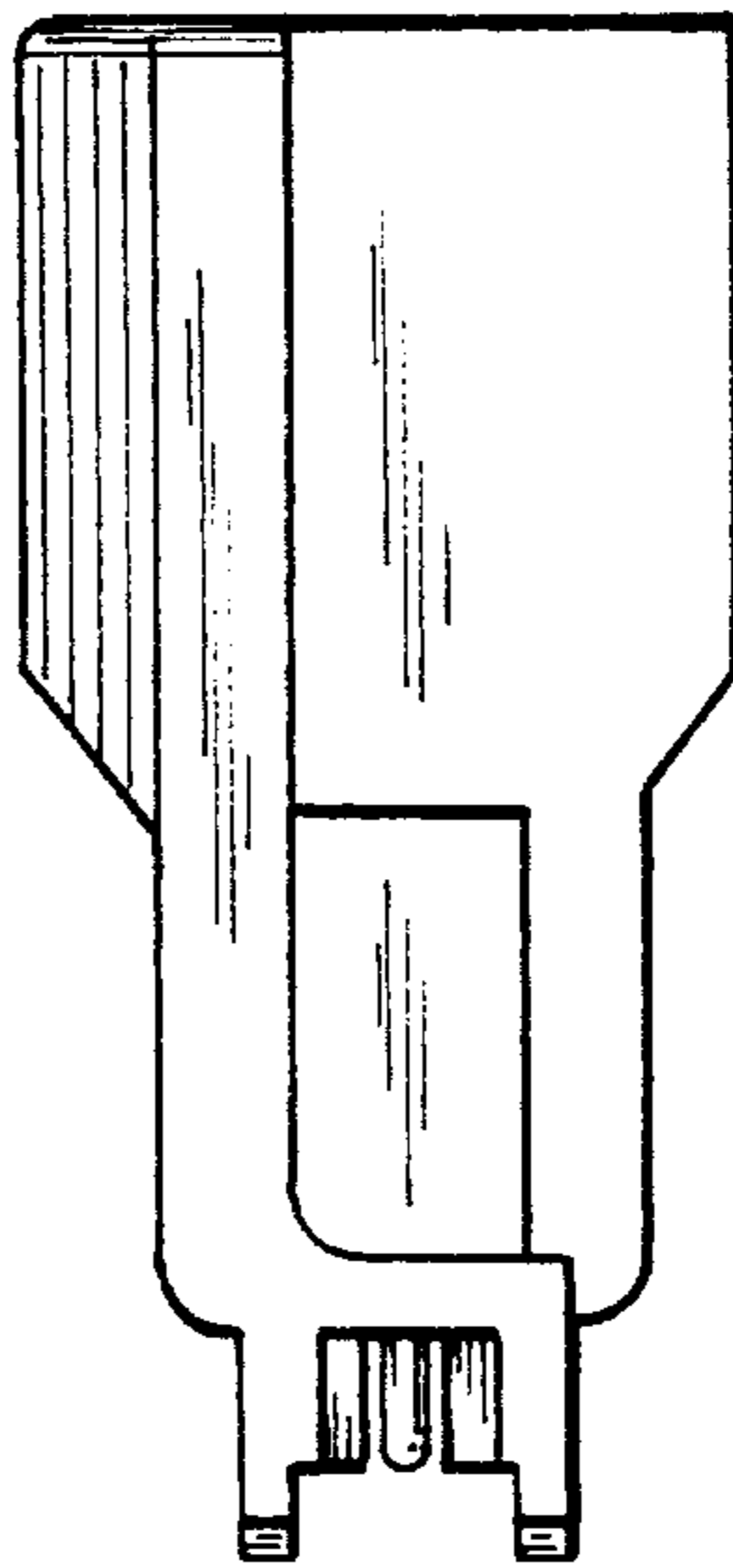

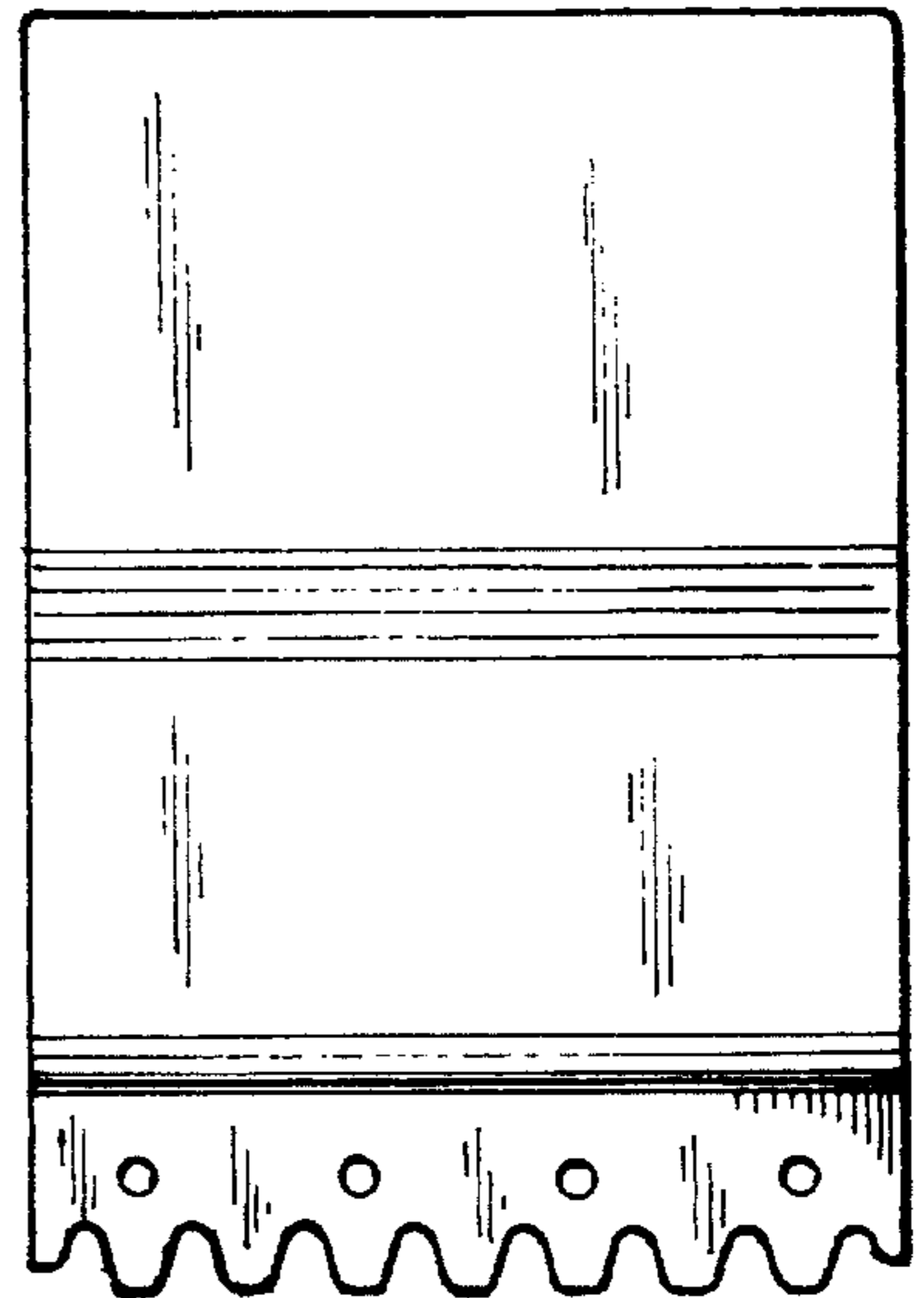

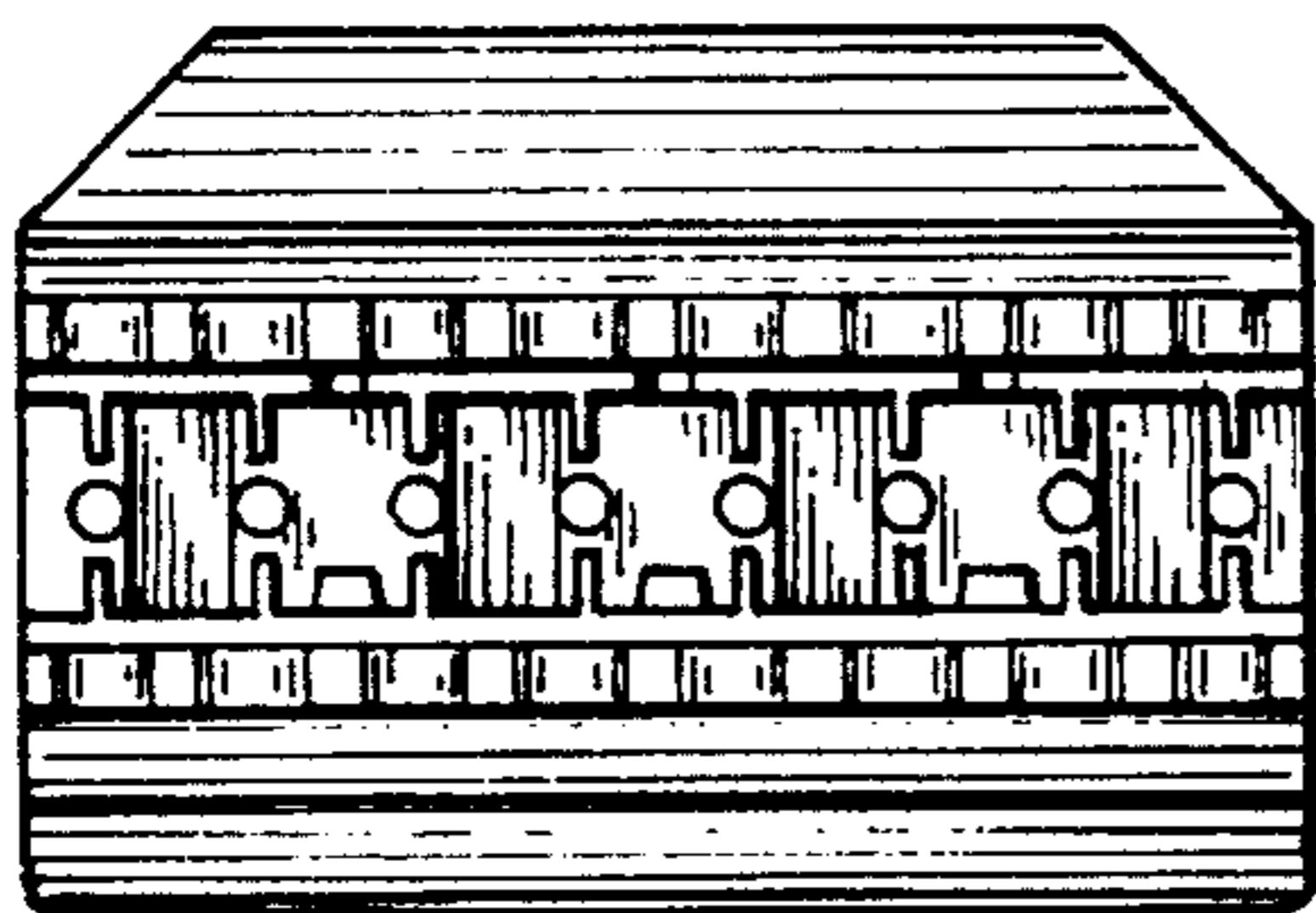
