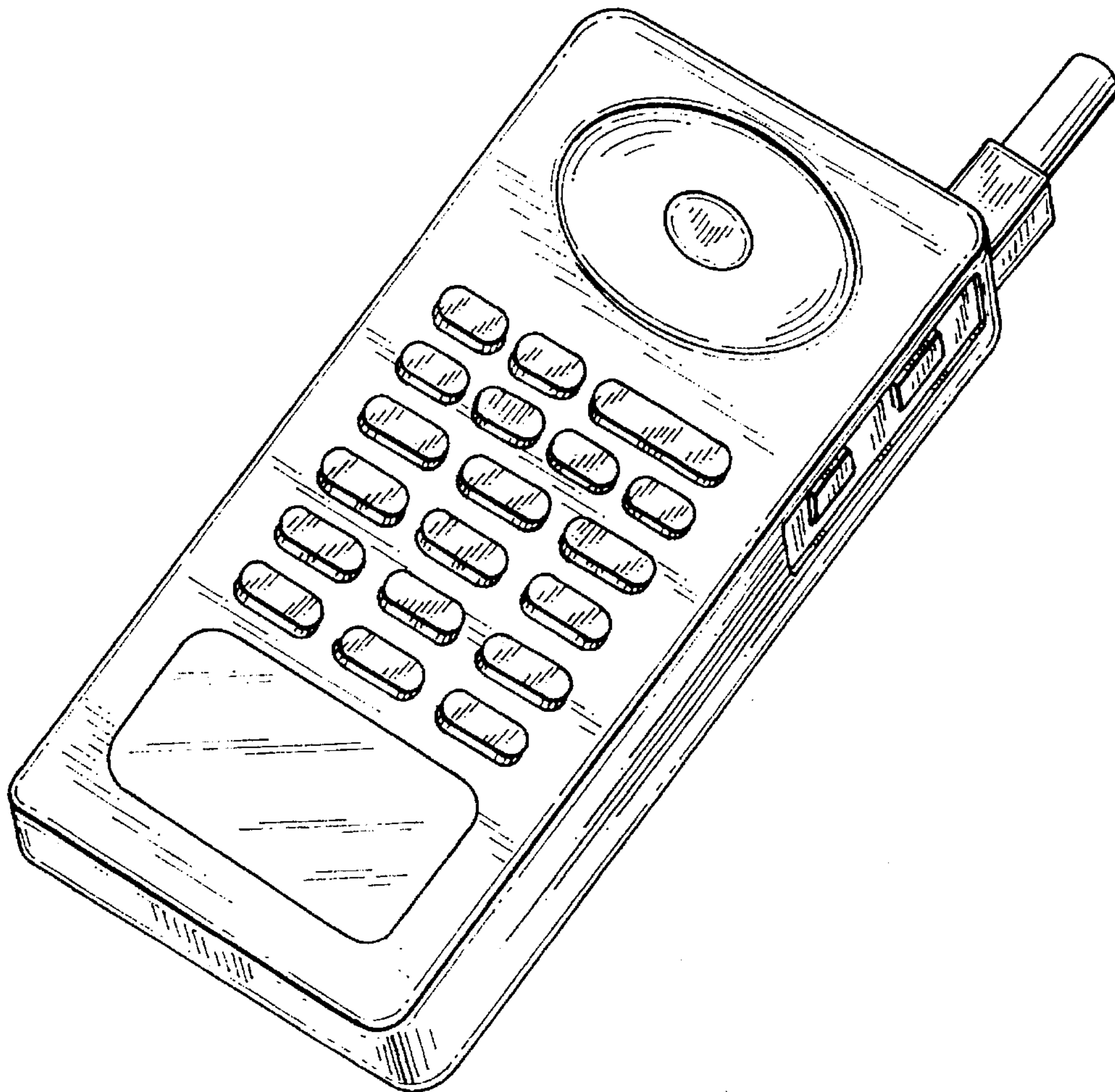
[57] **CLAIM**

The ornamental design for a cellular telephone with display below earphone and dial pad, and described.

**DESCRIPTION**

FIG. 1 is a front view of the cellular telephone with display below earphone and dial pad showing my new design; FIG. 2 is a side view thereof; FIG. 3 is another side view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a back view thereof; and, FIG. 7 is a perspective view thereof.

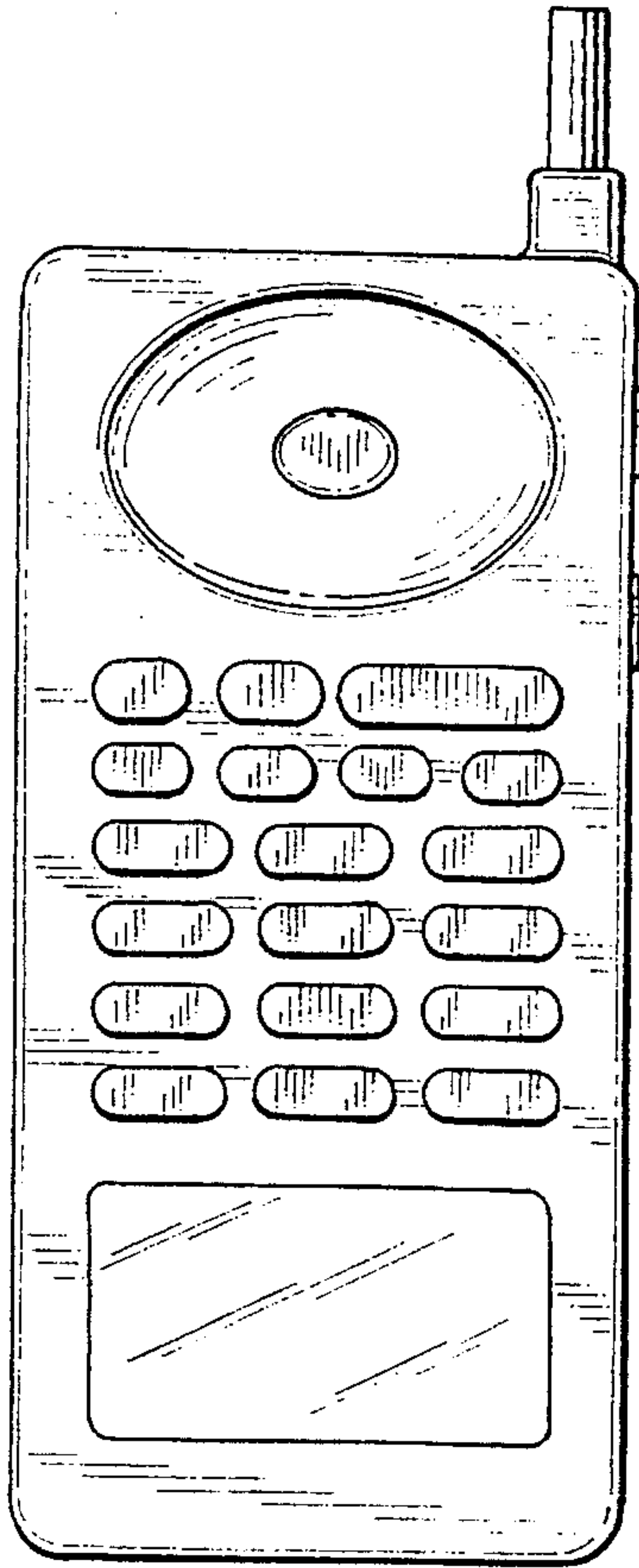

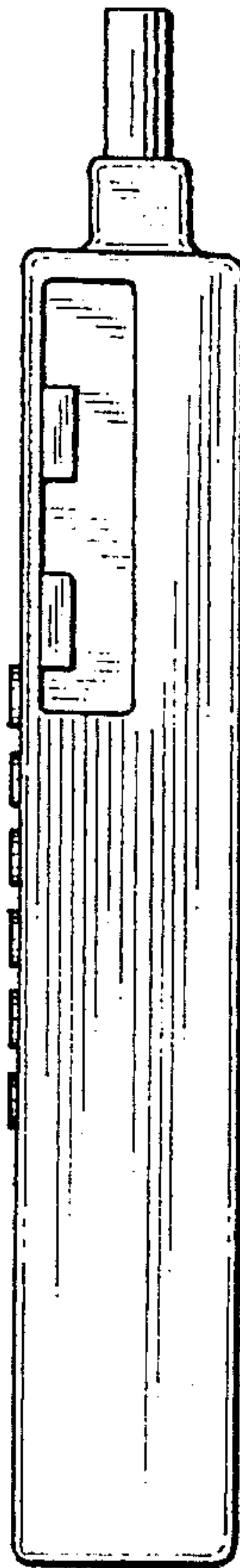

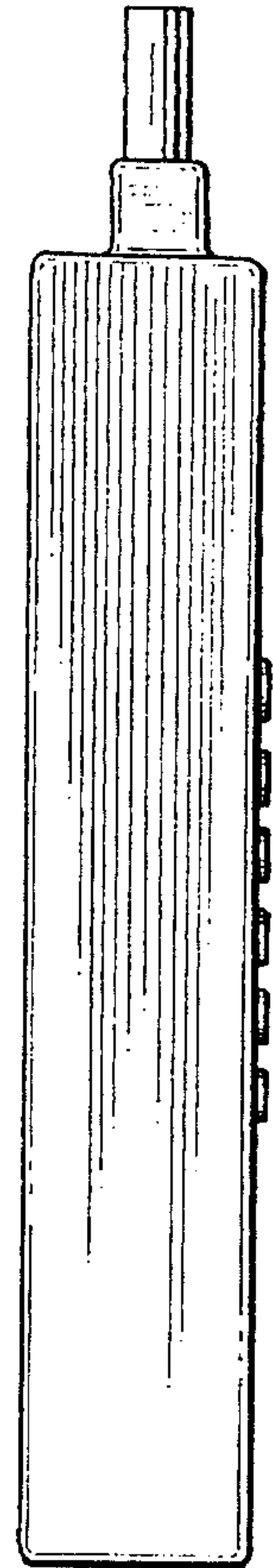

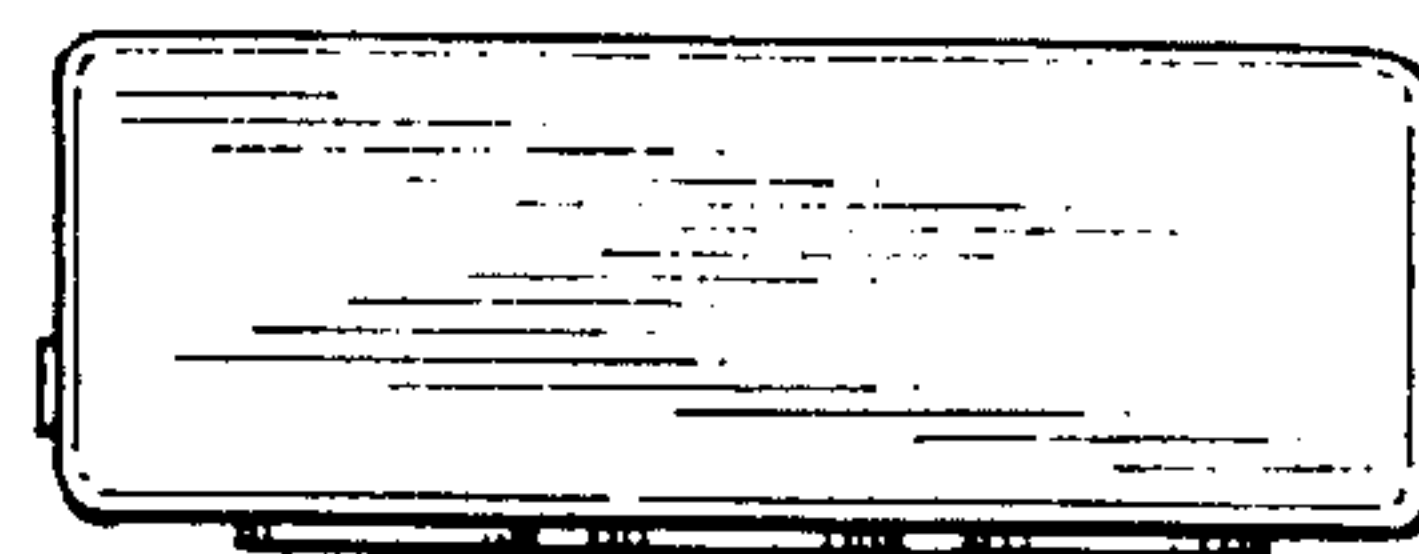

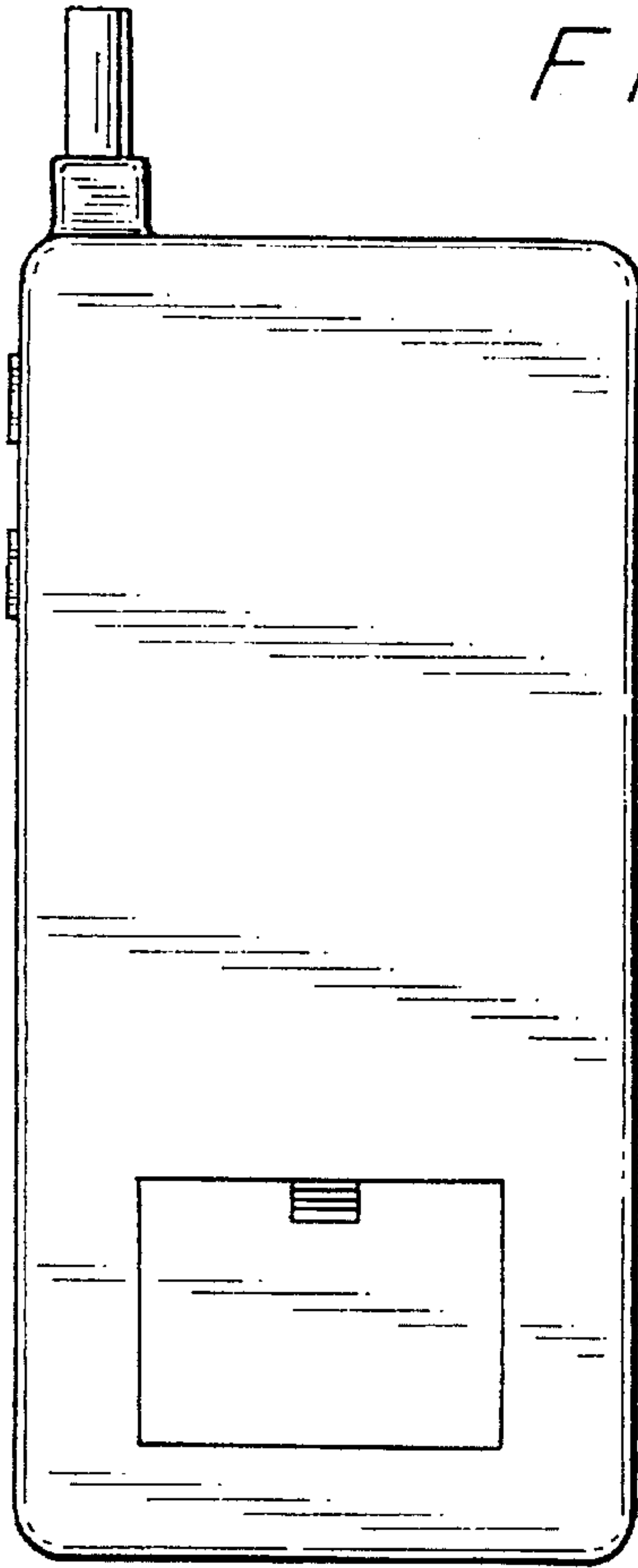
