FIG. 4 rear and side perspective view.

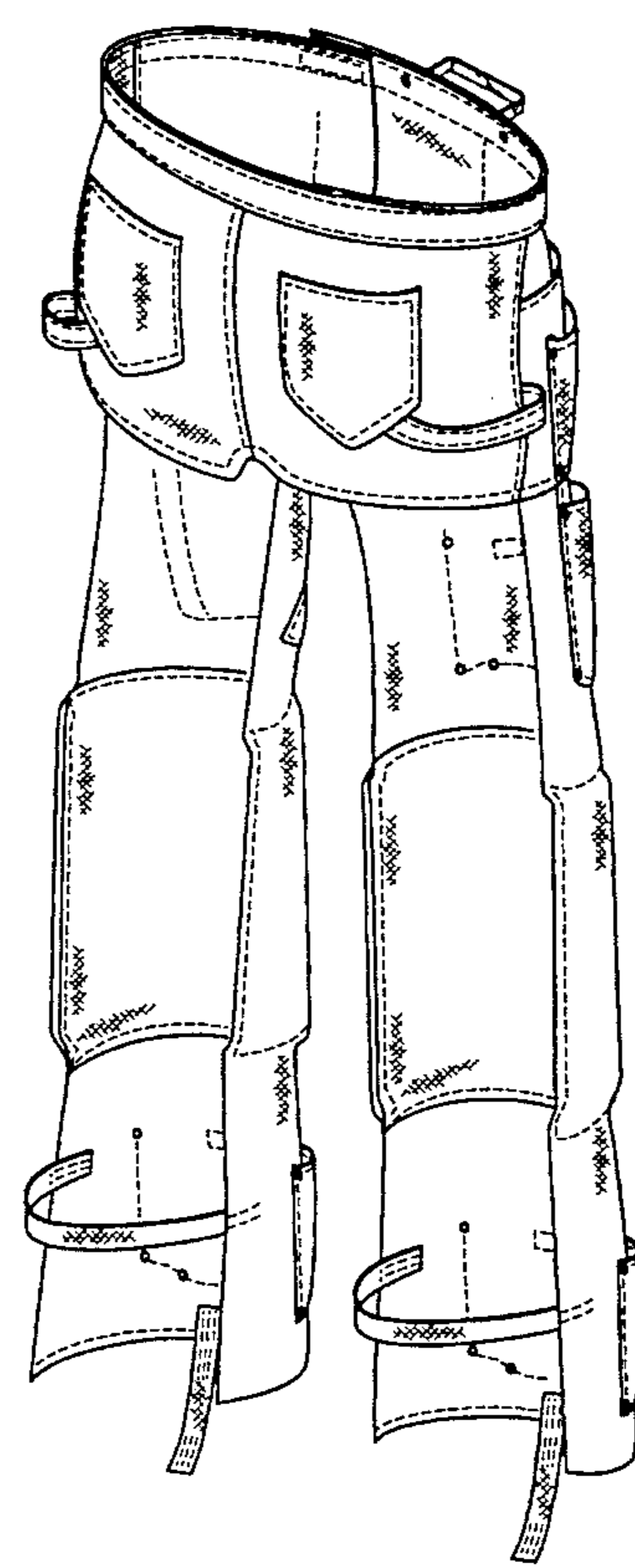
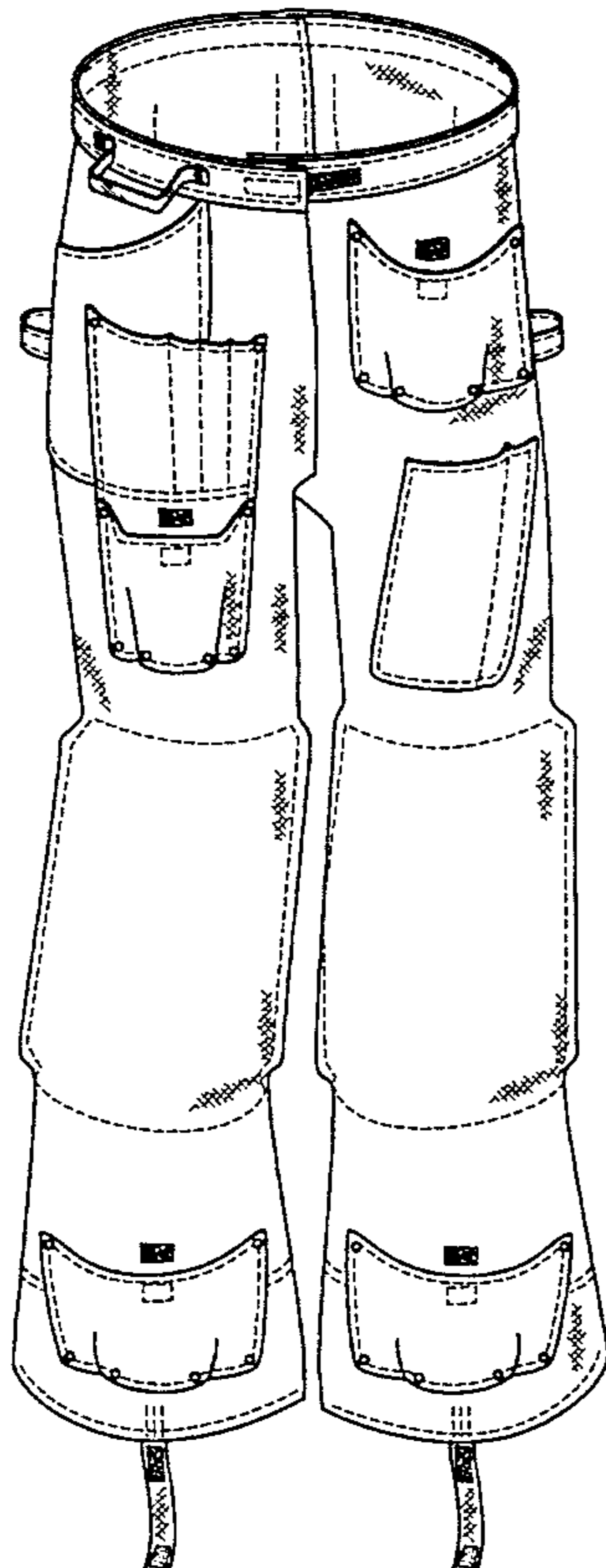
The broken lines shown throughout the views are understood to represent conventional stitching.

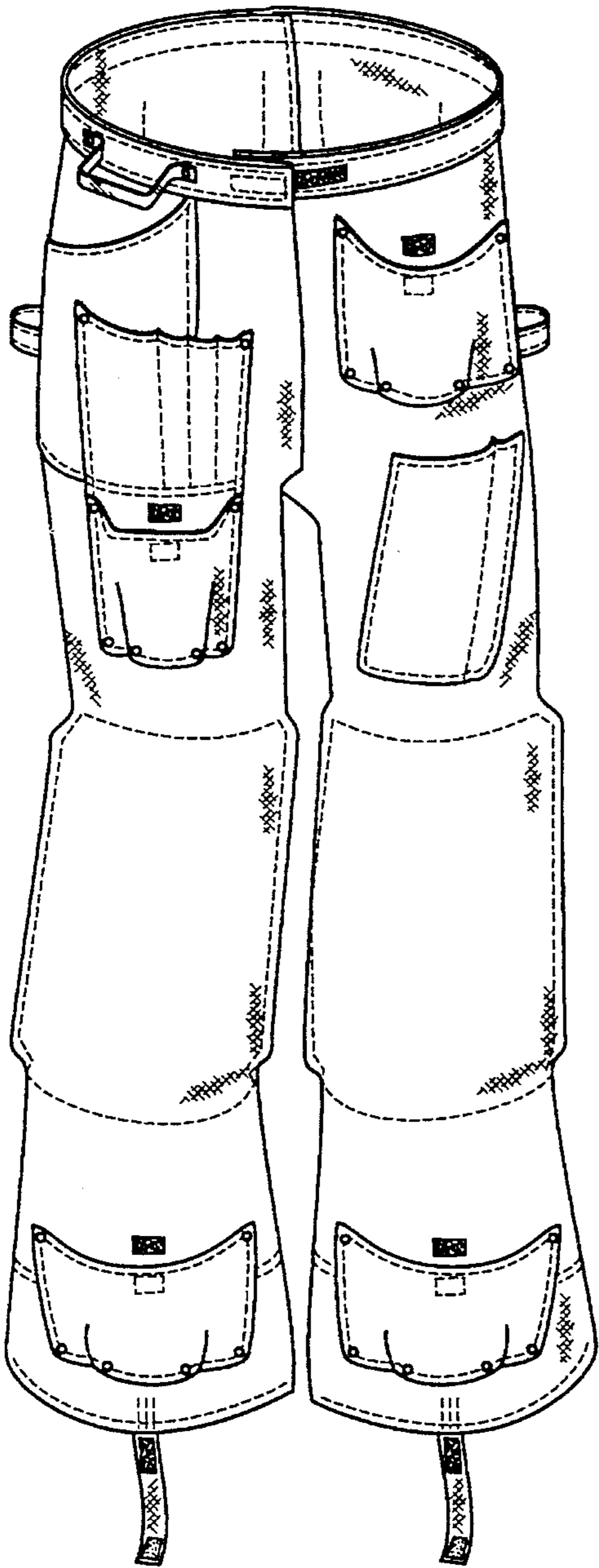

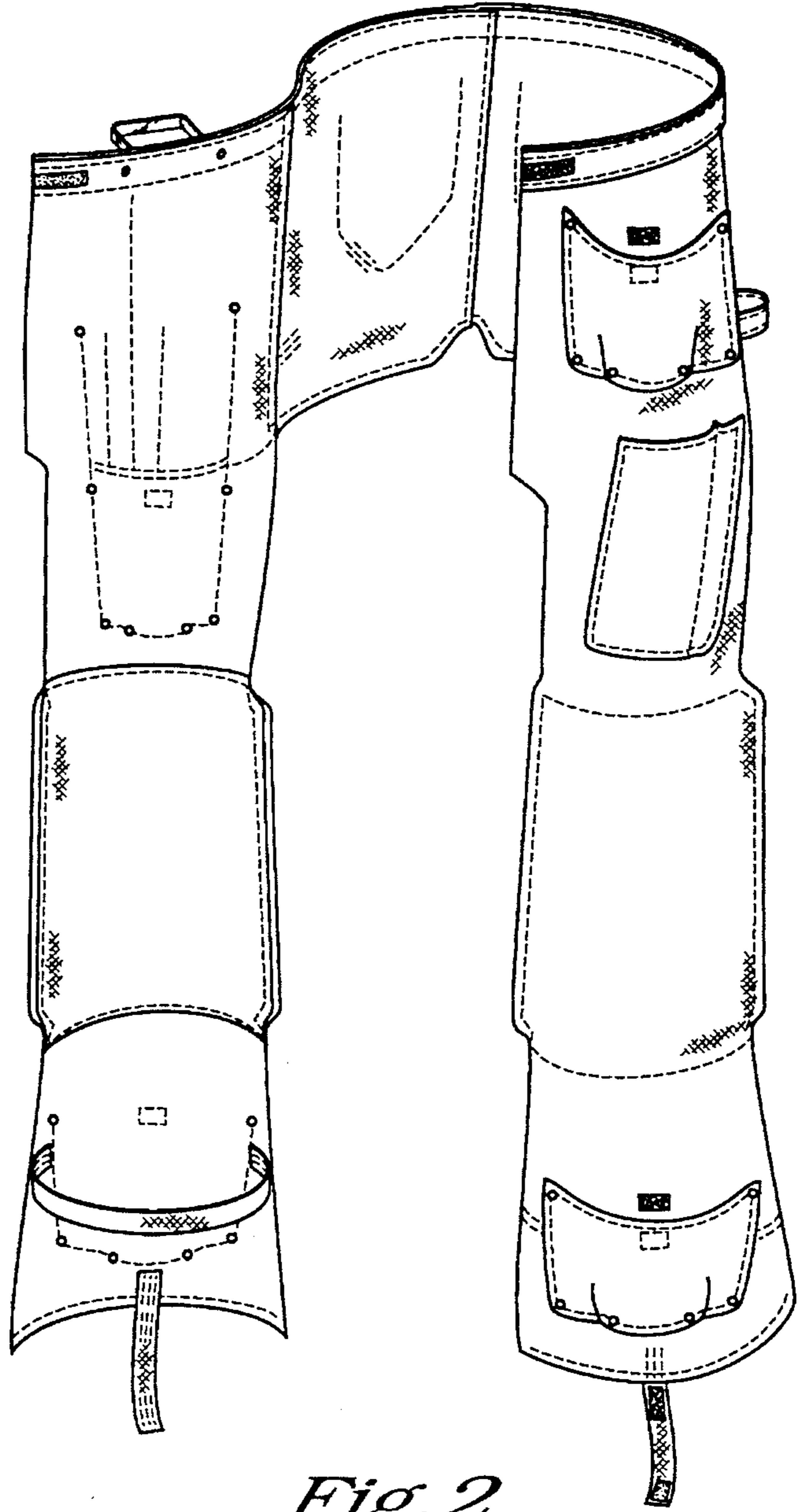

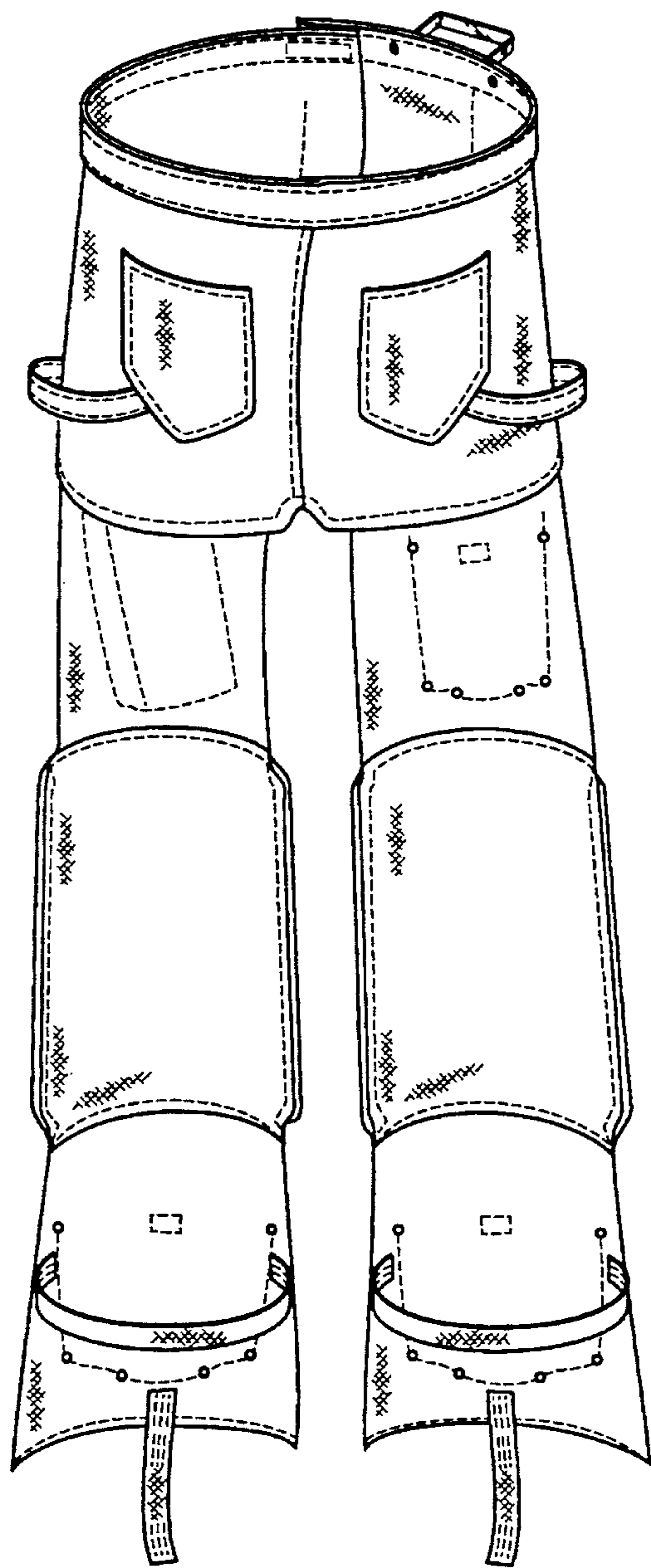

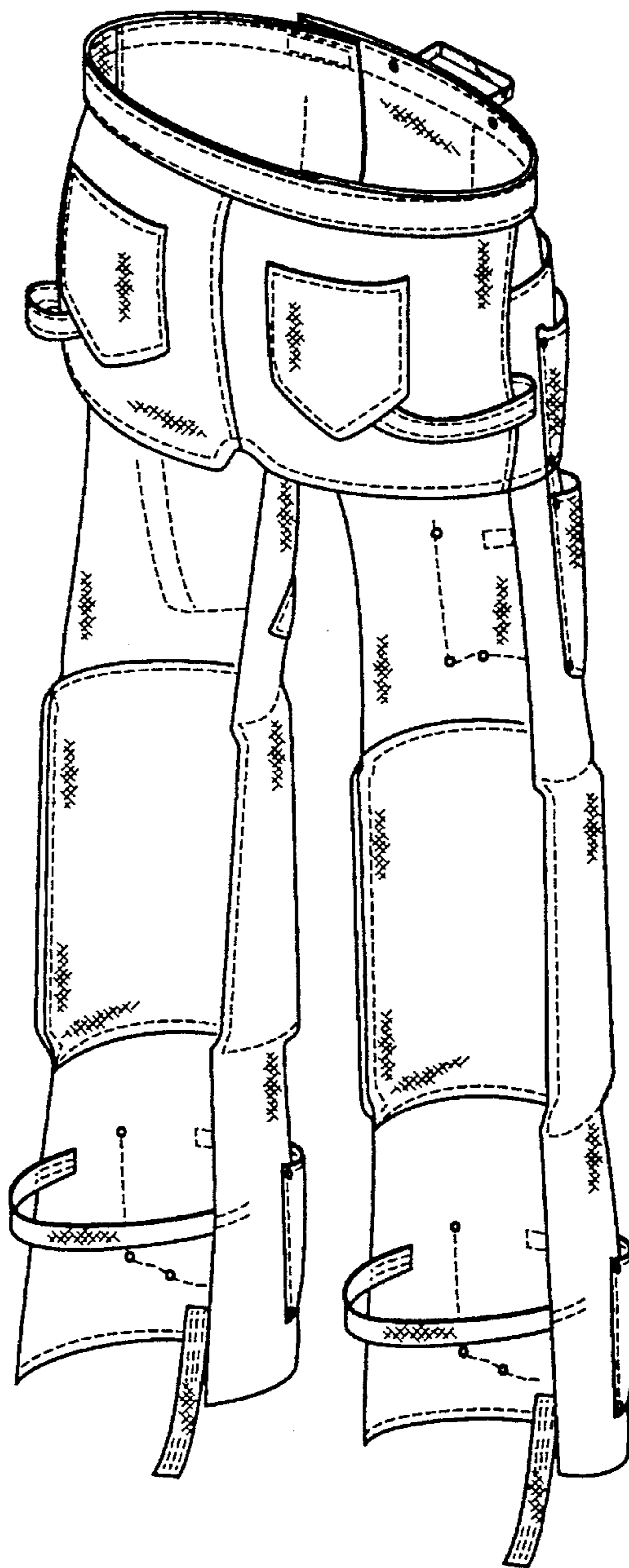
