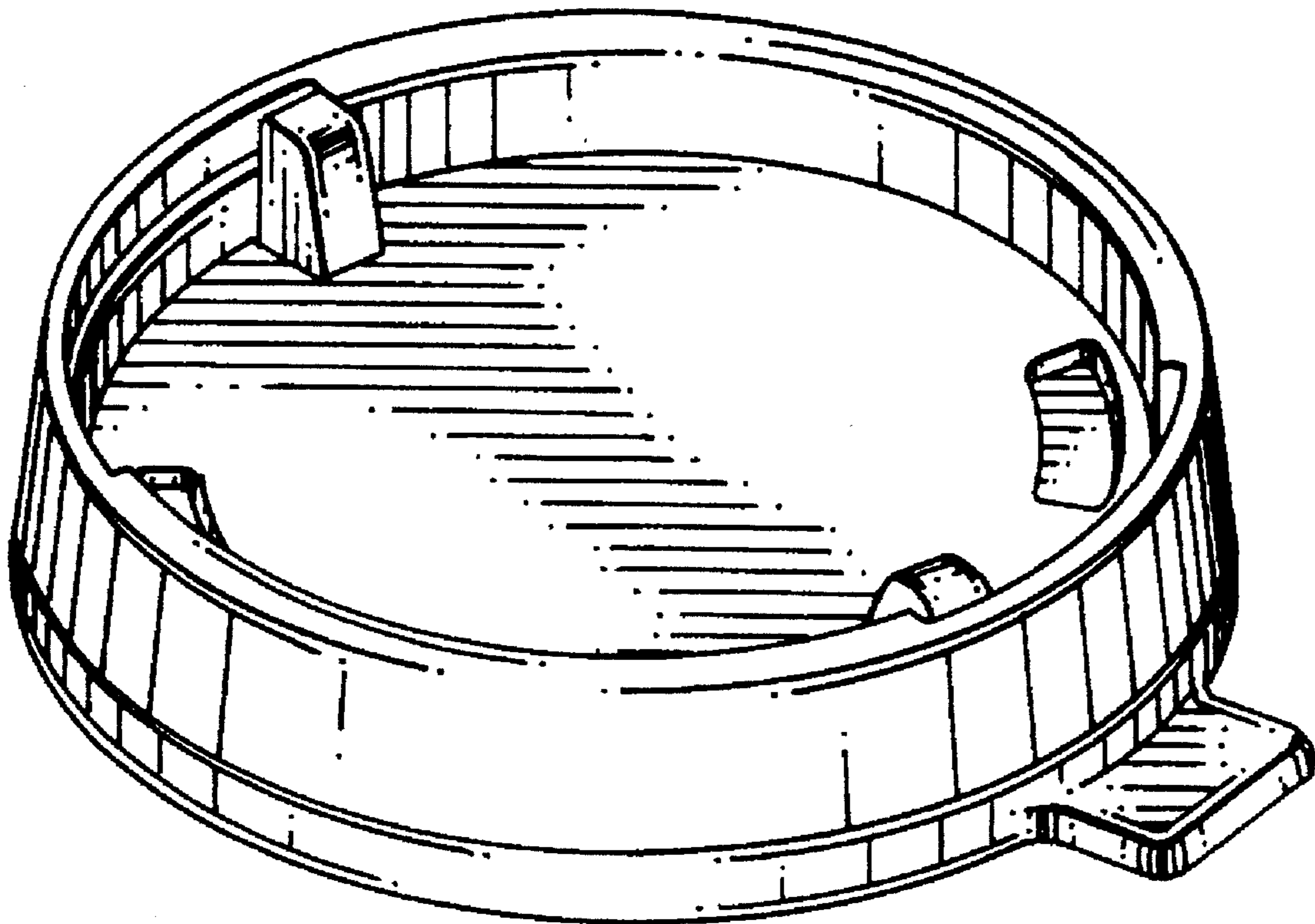
[57] **CLAIM**

The ornamental design for a lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lid showing our new design in a closed position;  
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a top plan view thereof of a lid showing our new design in an open position.

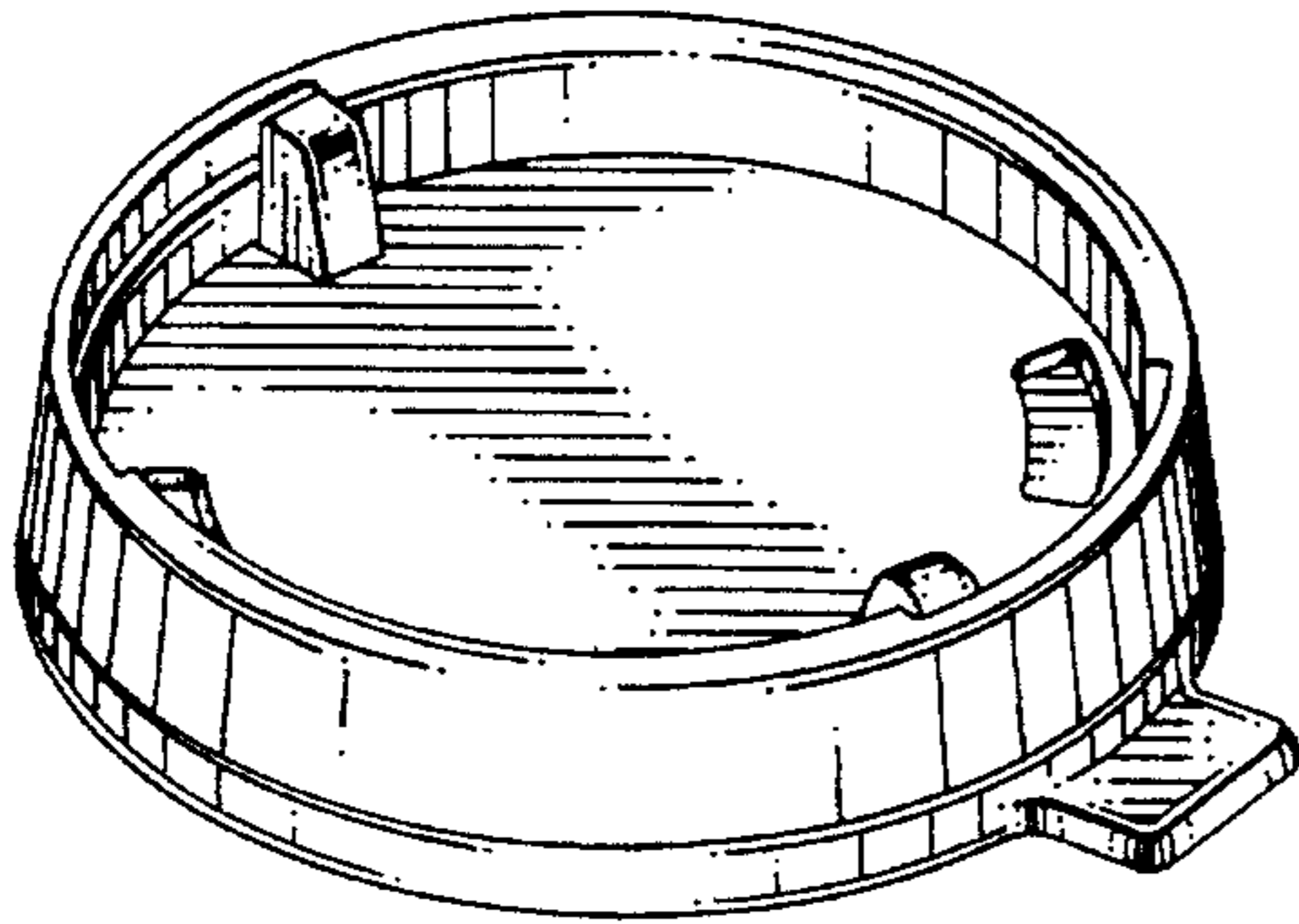

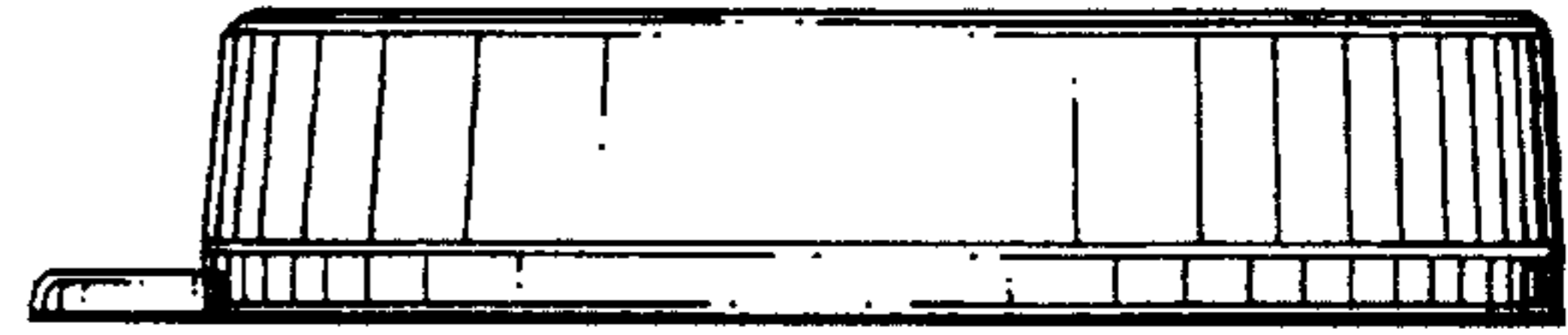

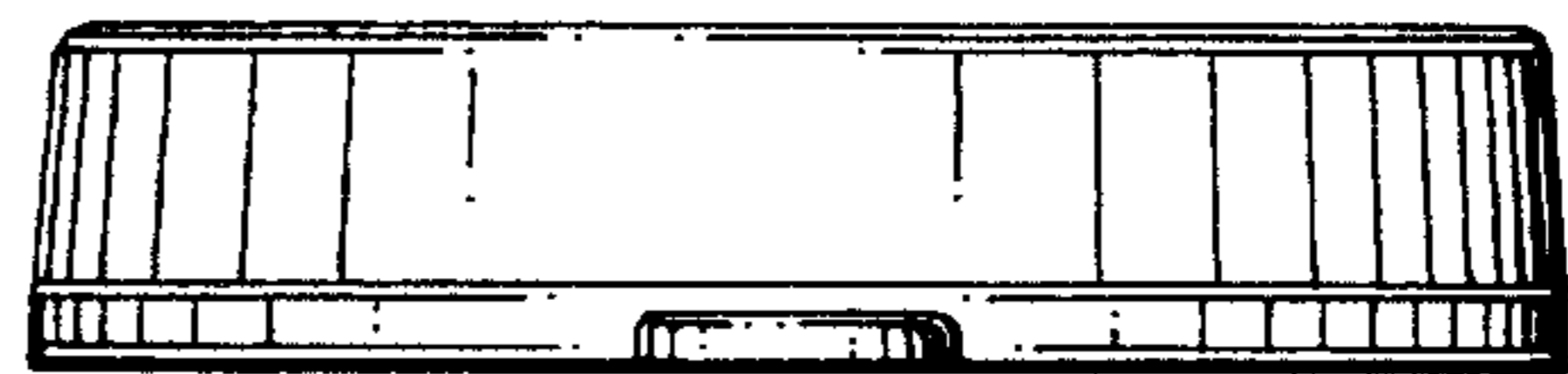

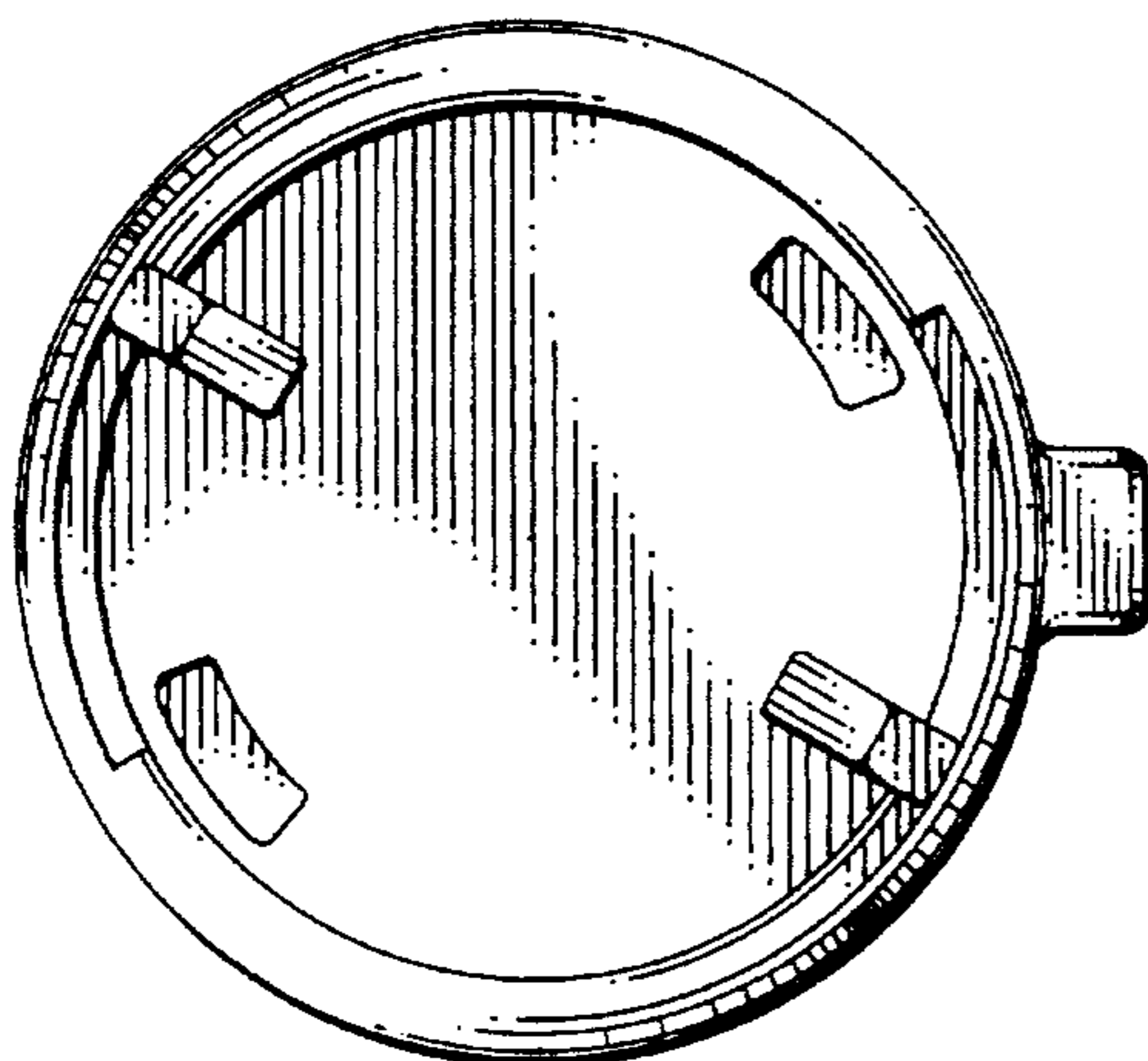

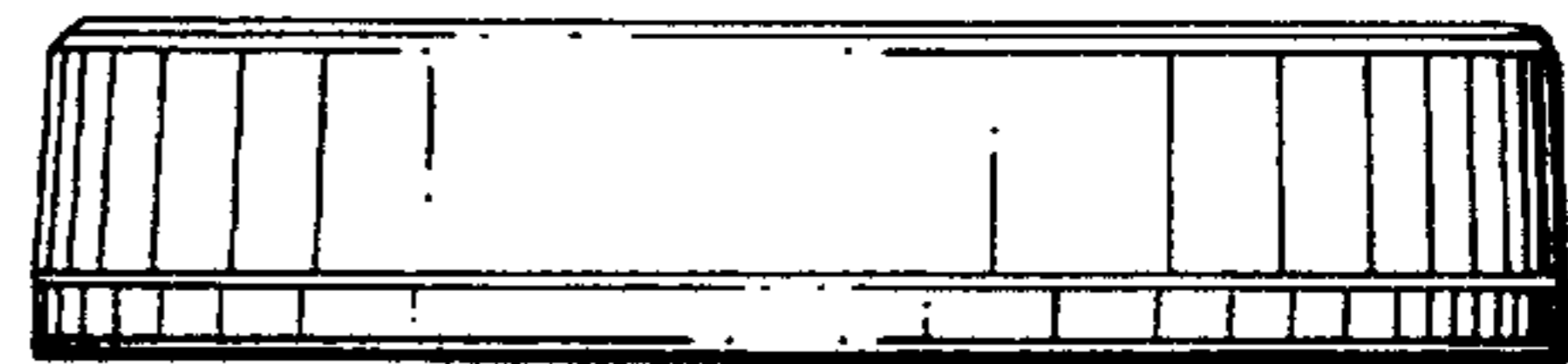

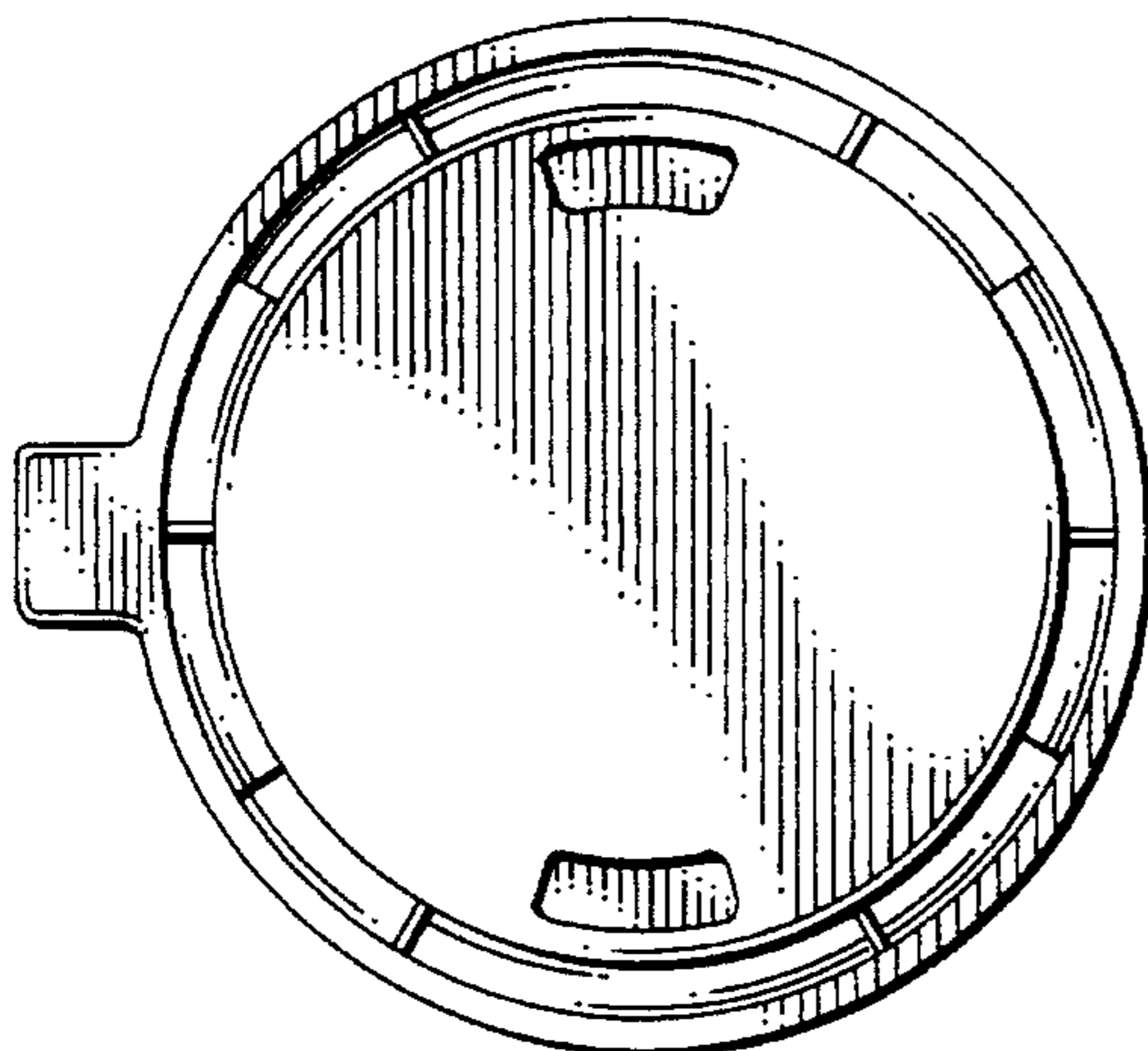

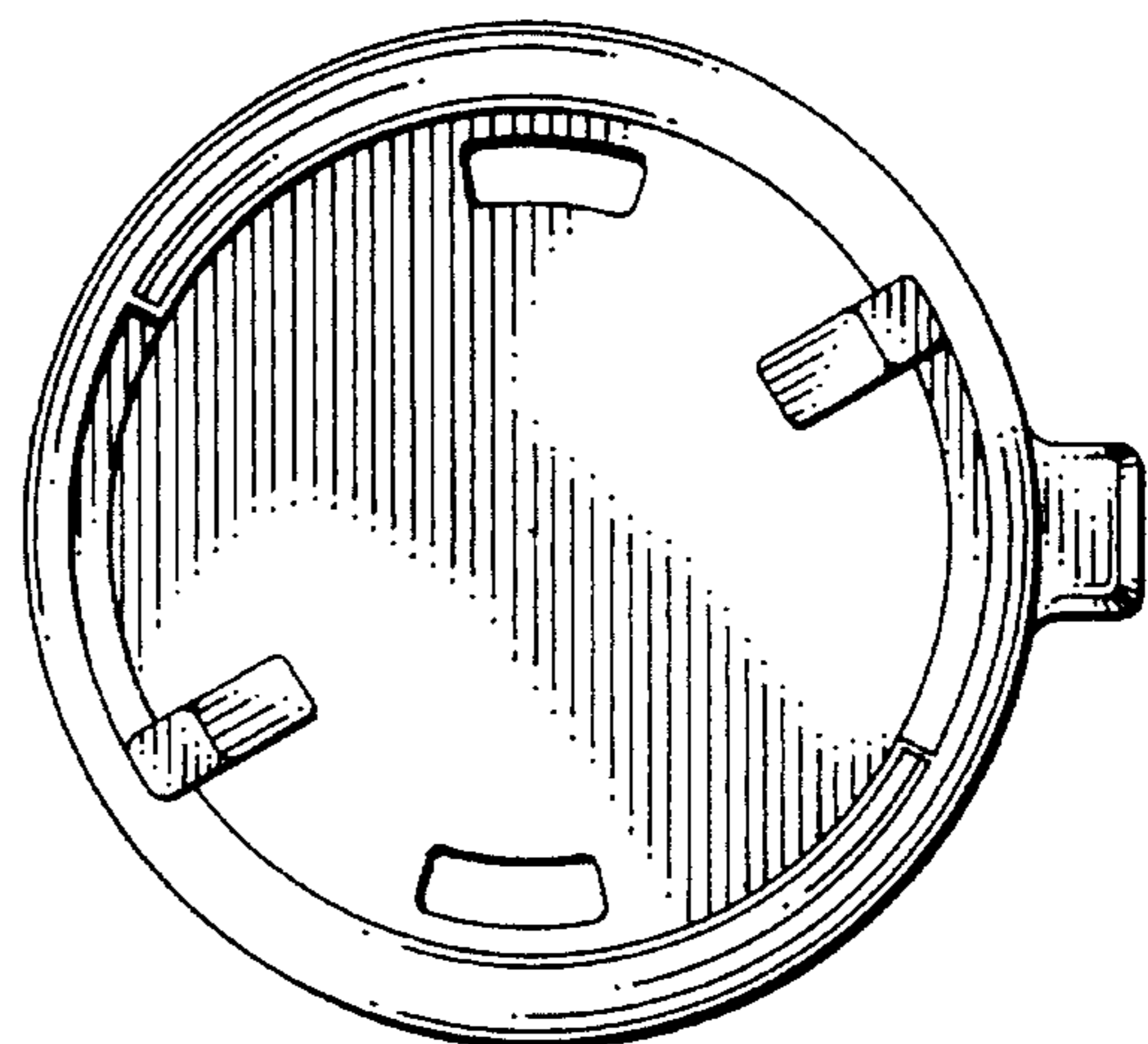
