The ornamental design for a mixing bowl, as shown and described.

DESCRIPTION

FIG. 1 is a top, end and side perspective view of a mixing bowl showing my new design;
 FIG. 2 is a left end elevation view thereof;
 FIG. 3 is a right end elevation view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a left side elevation view thereof;

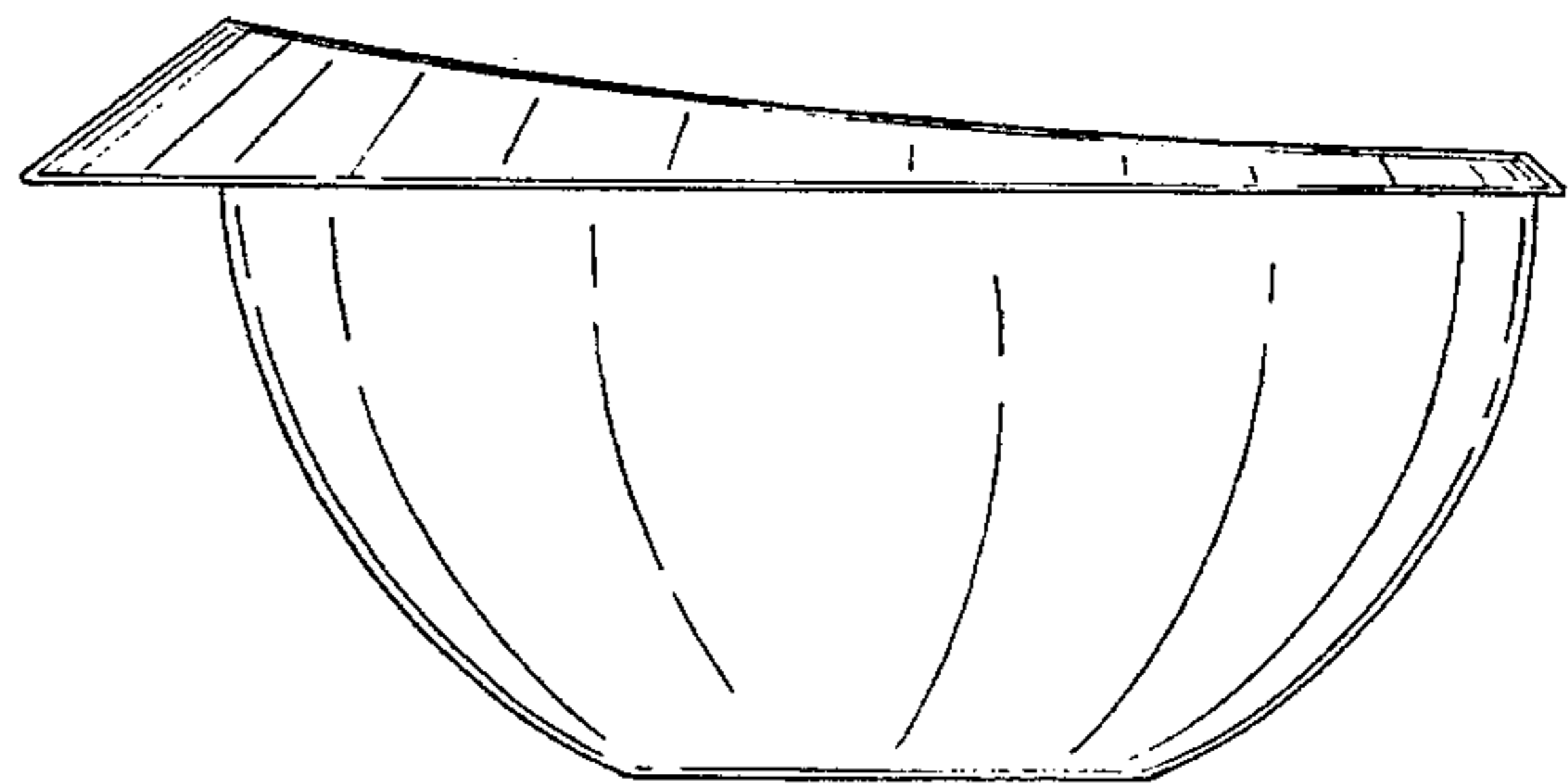
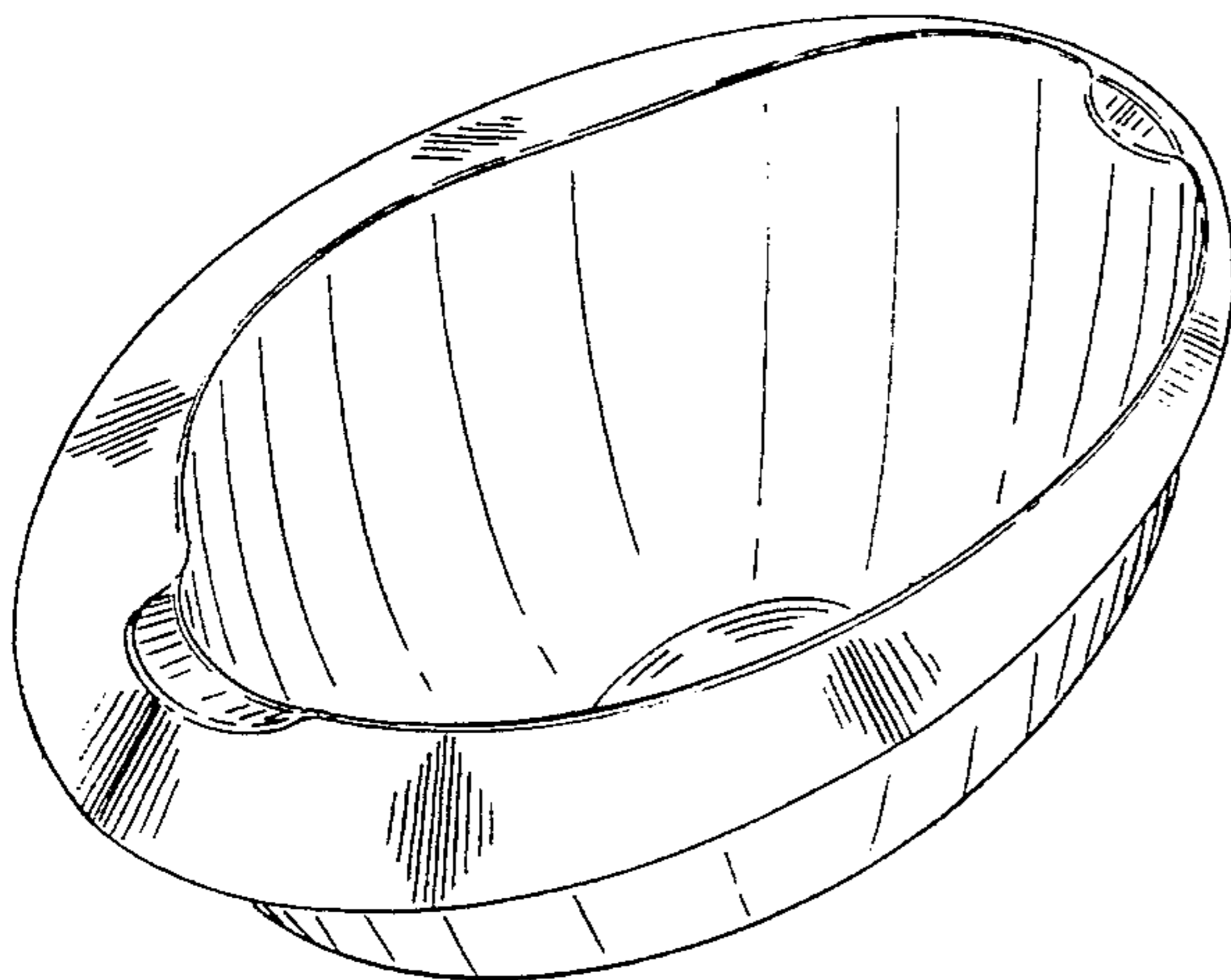

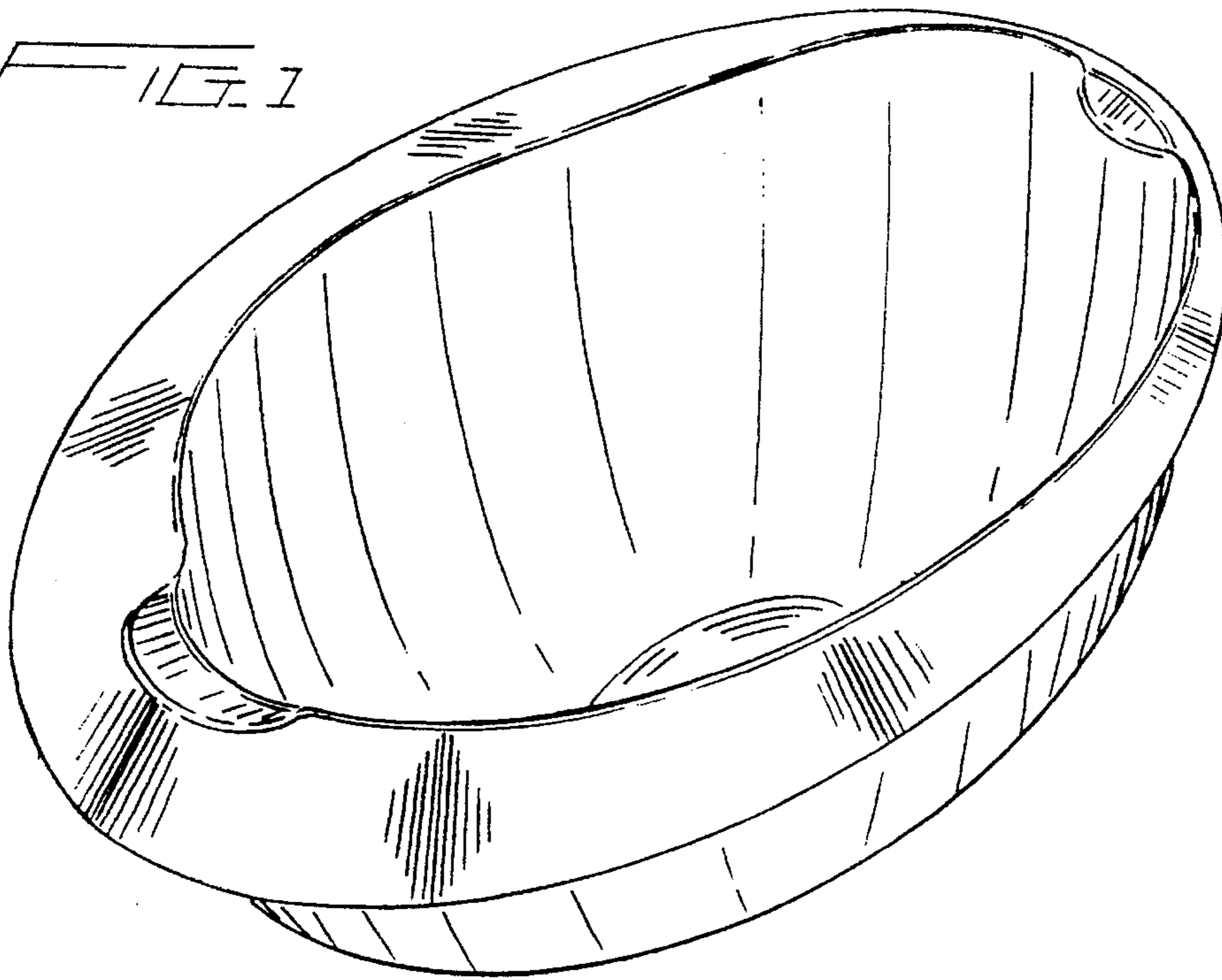

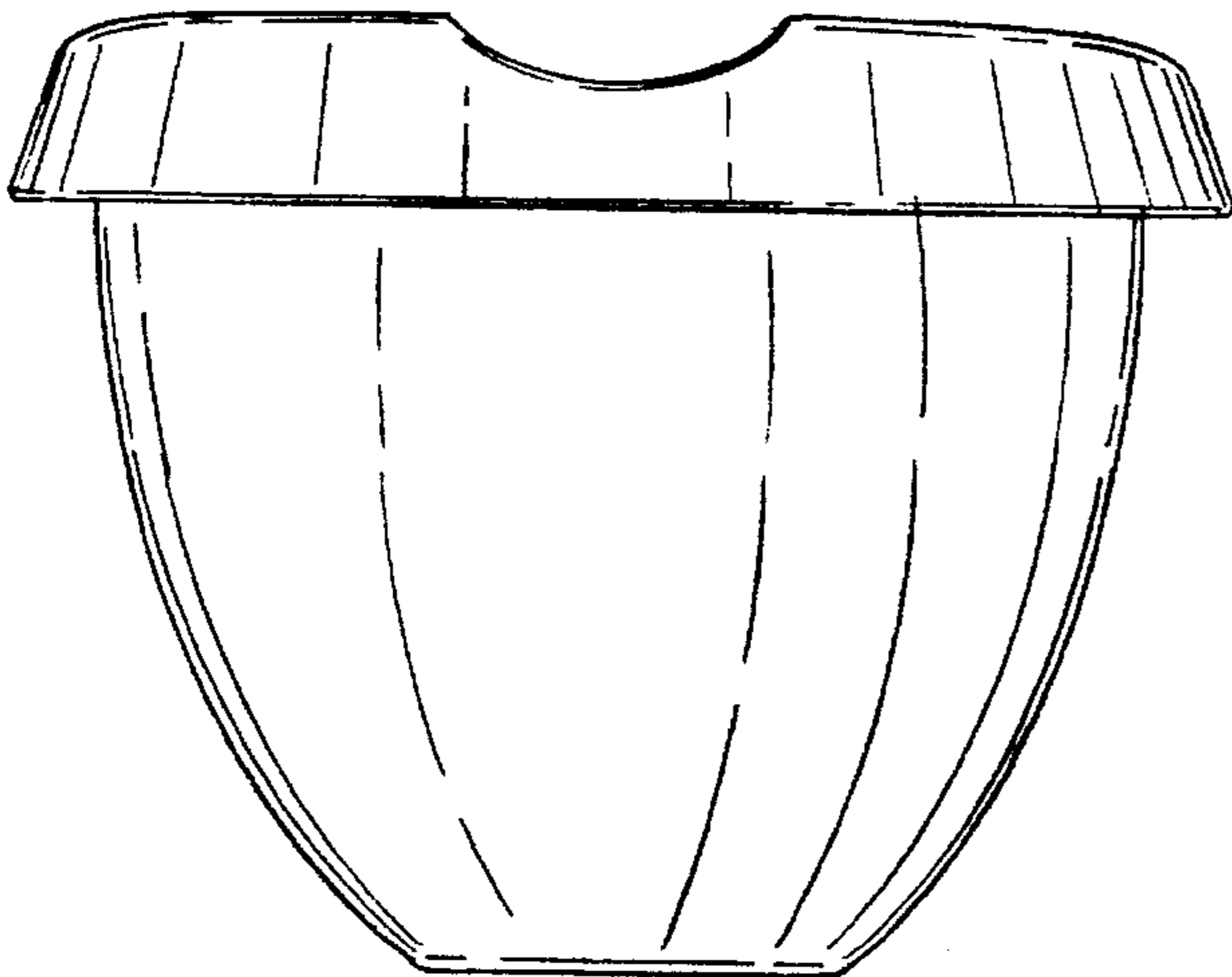
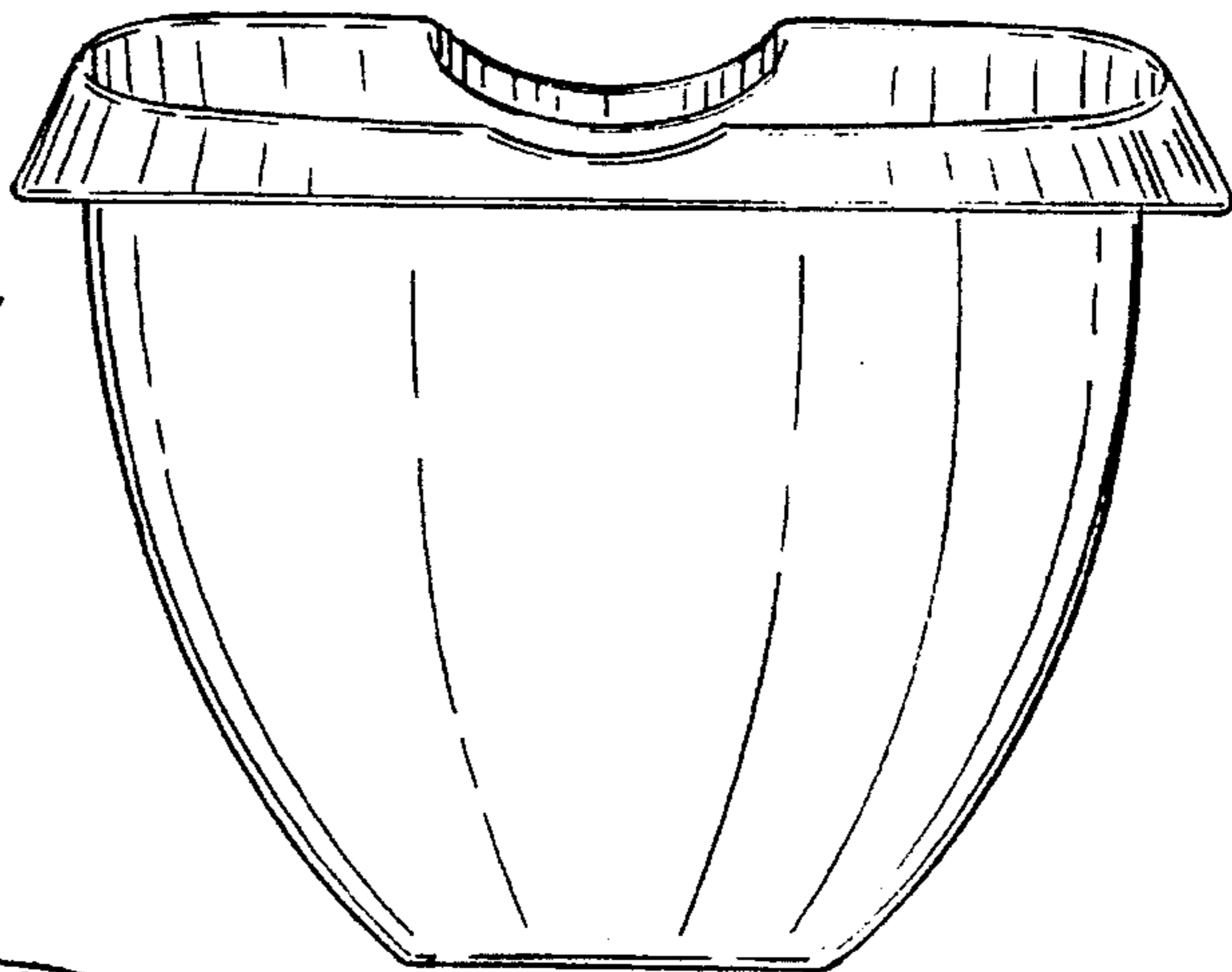

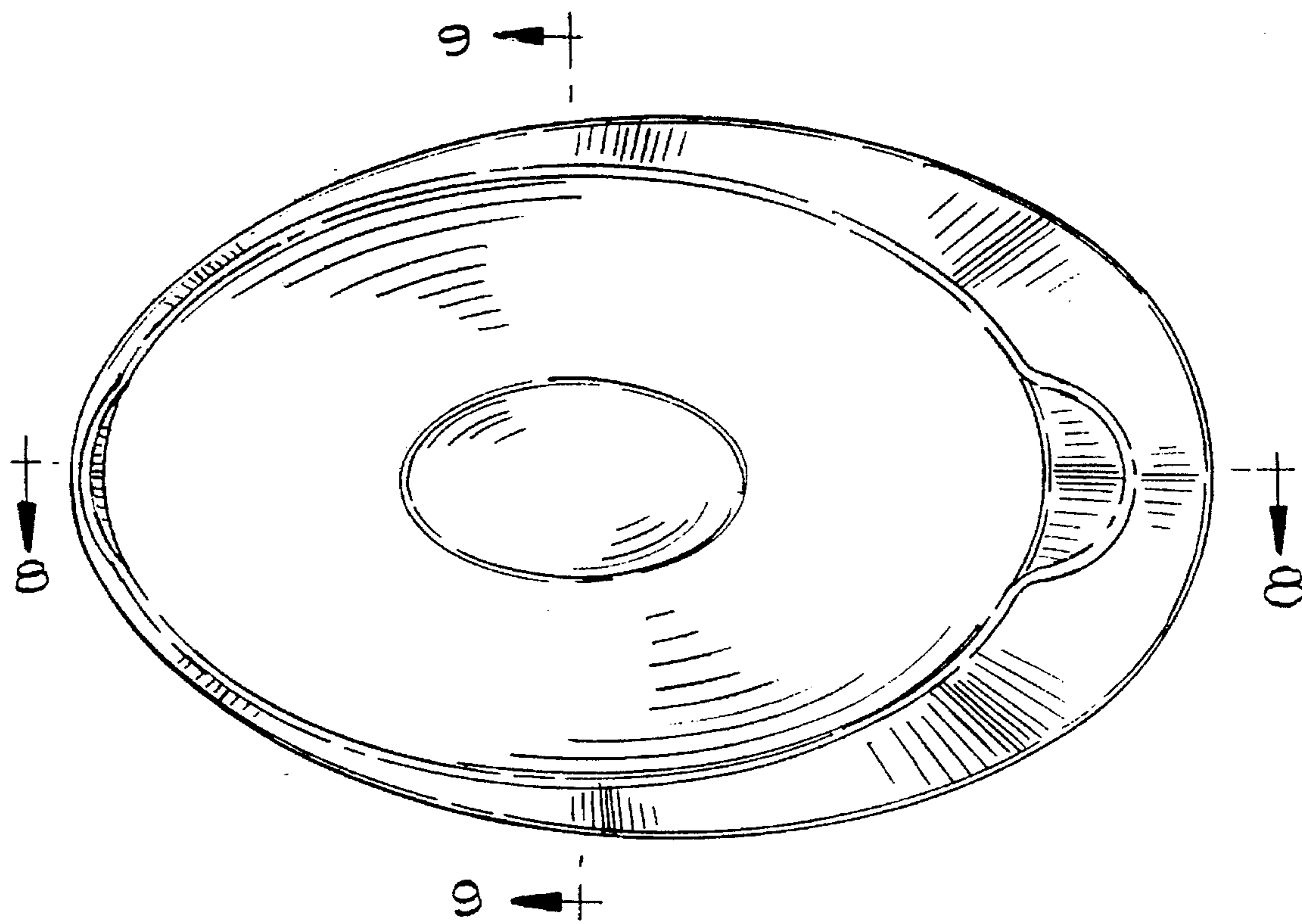

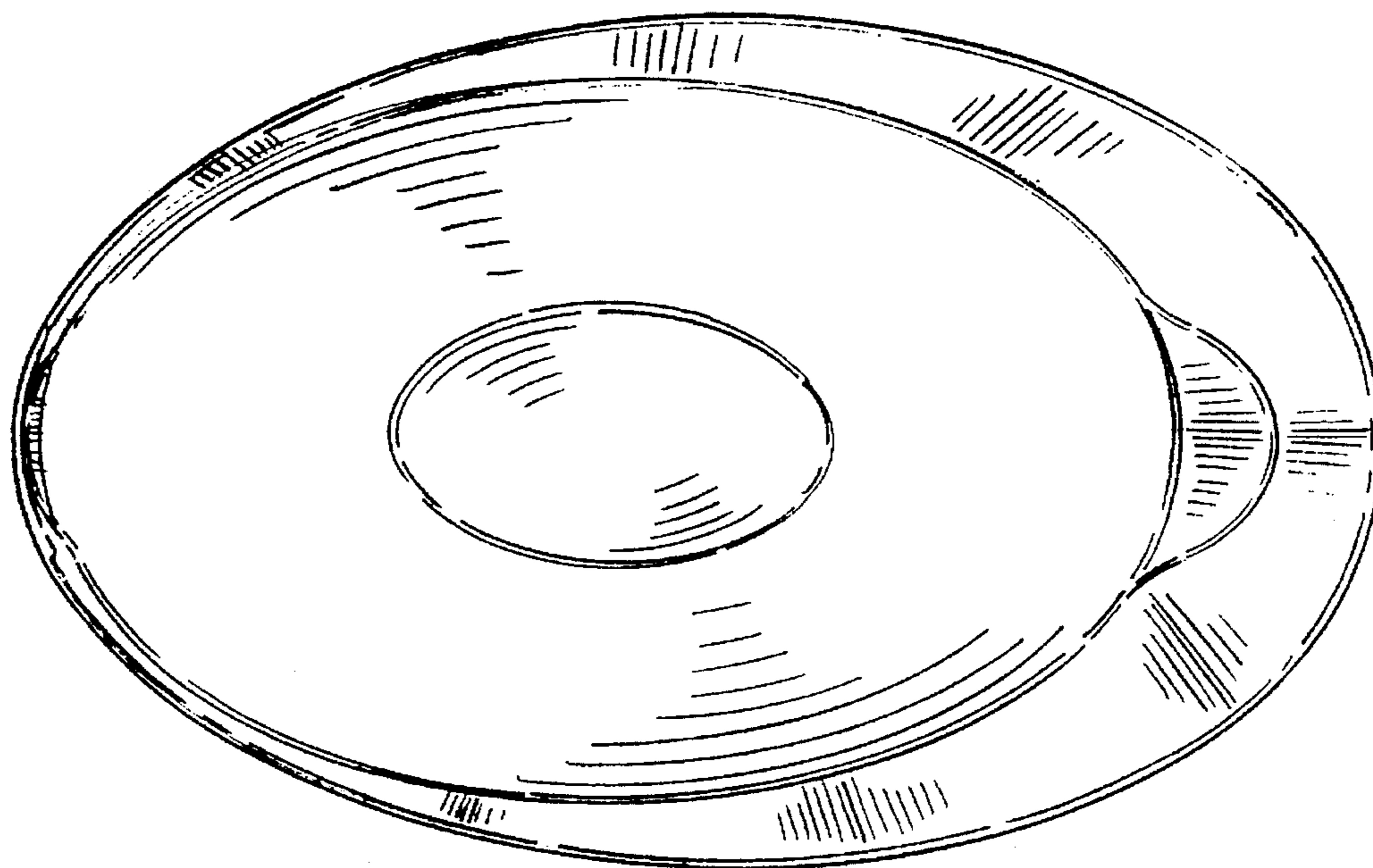

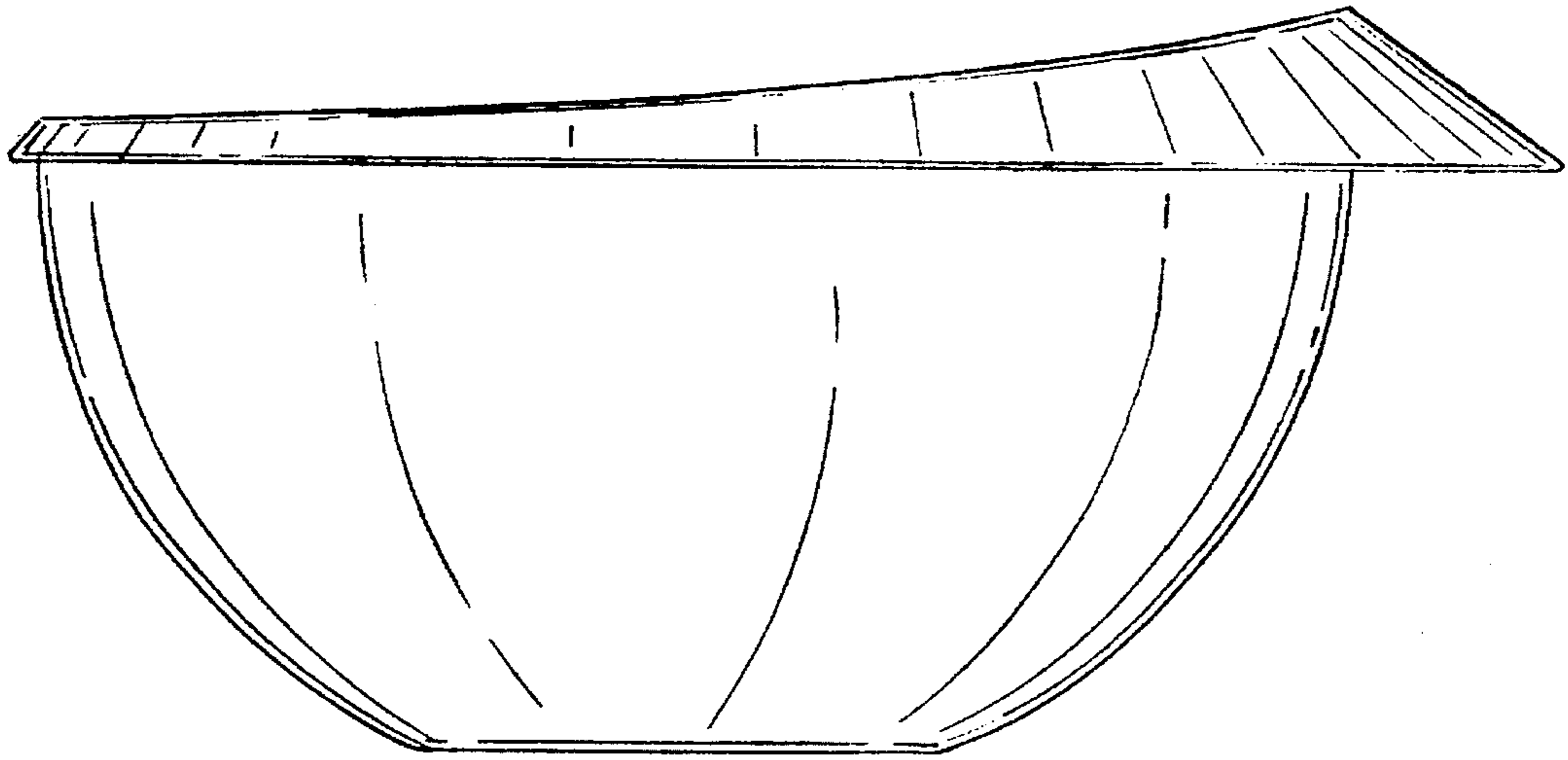

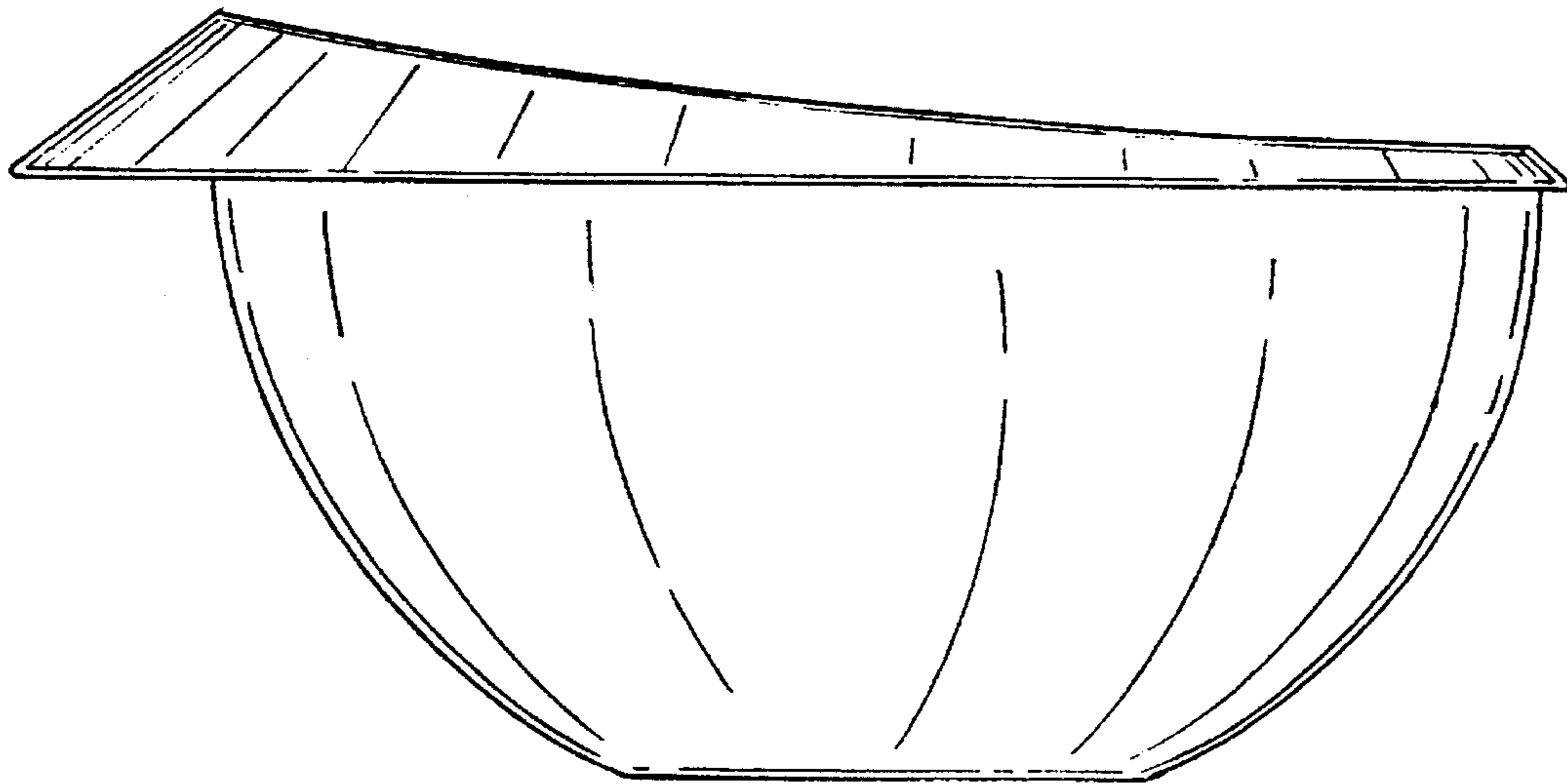

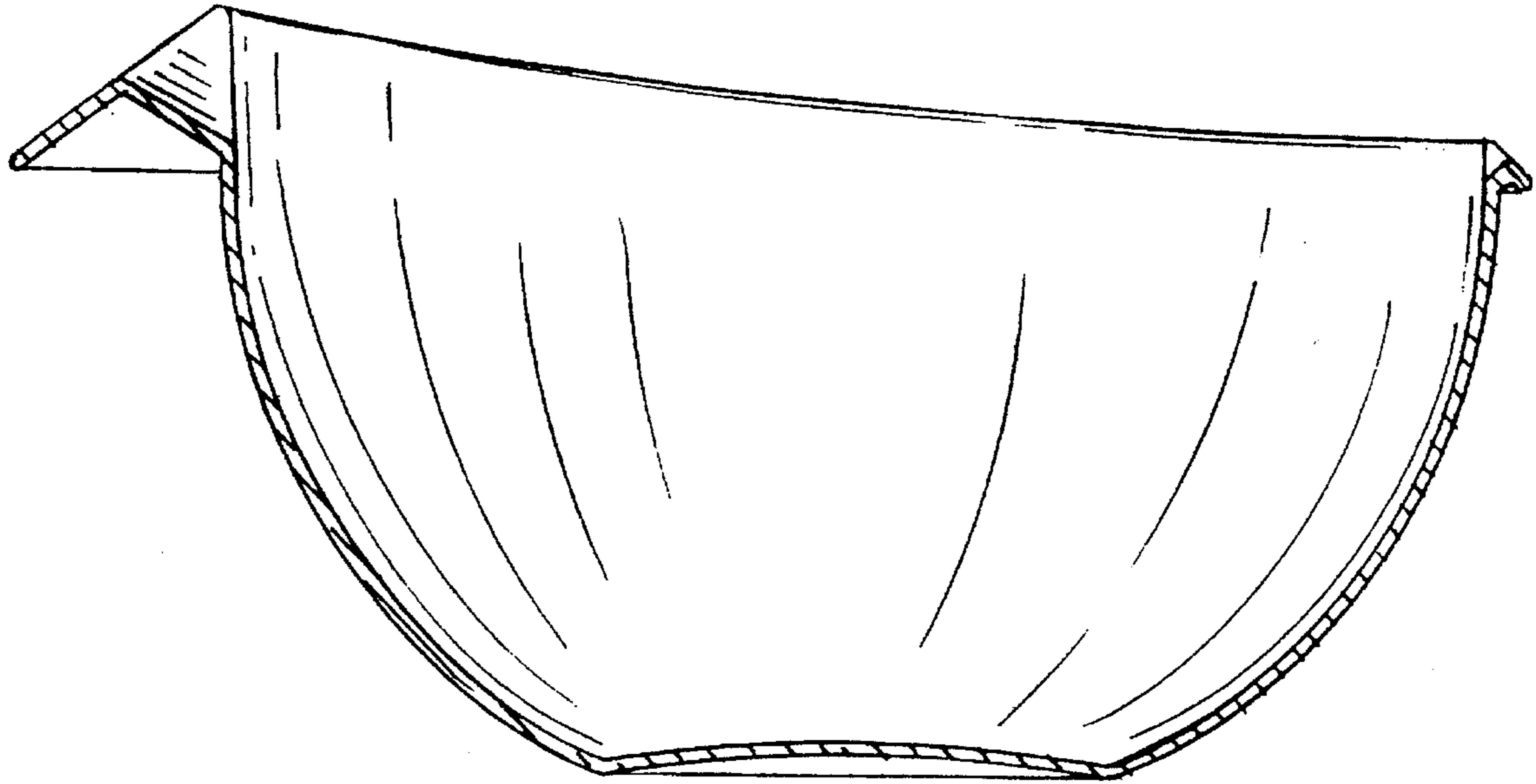

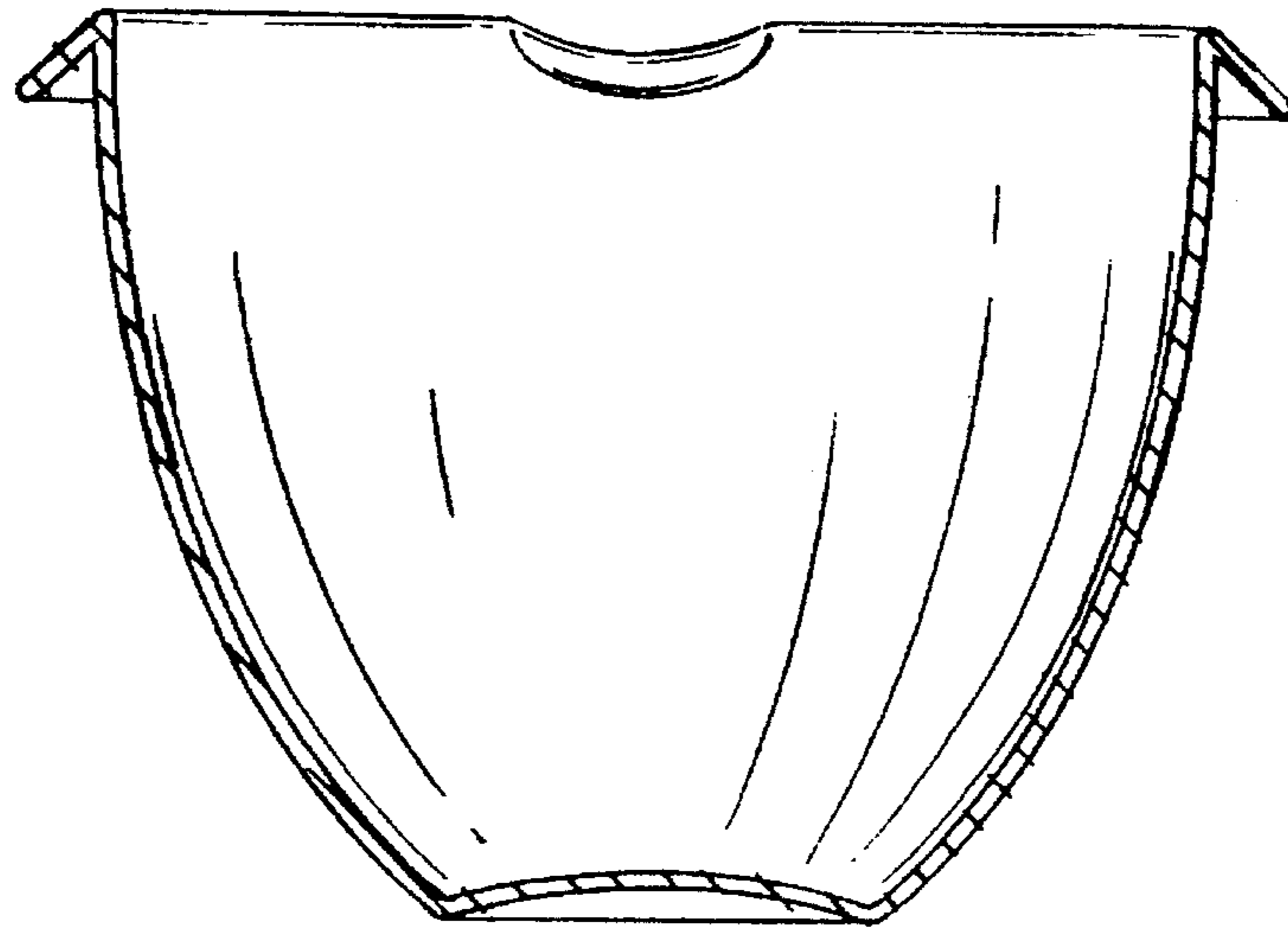
