**DESCRIPTION**

FIG. 16 is a perspective view of a fourth embodiment of the abutment according to the present invention;

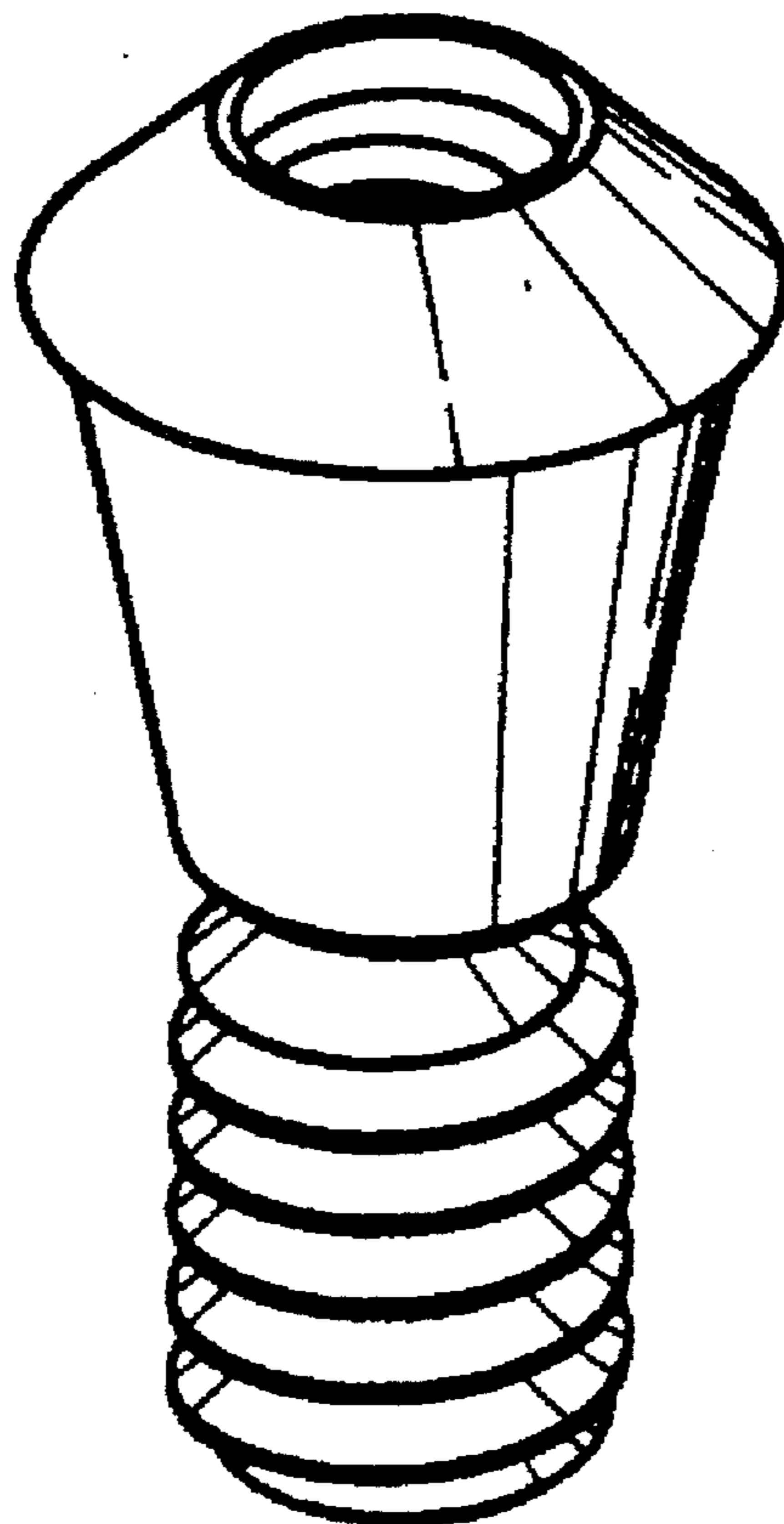
FIG. 17 is a bottom view of FIG. 16;

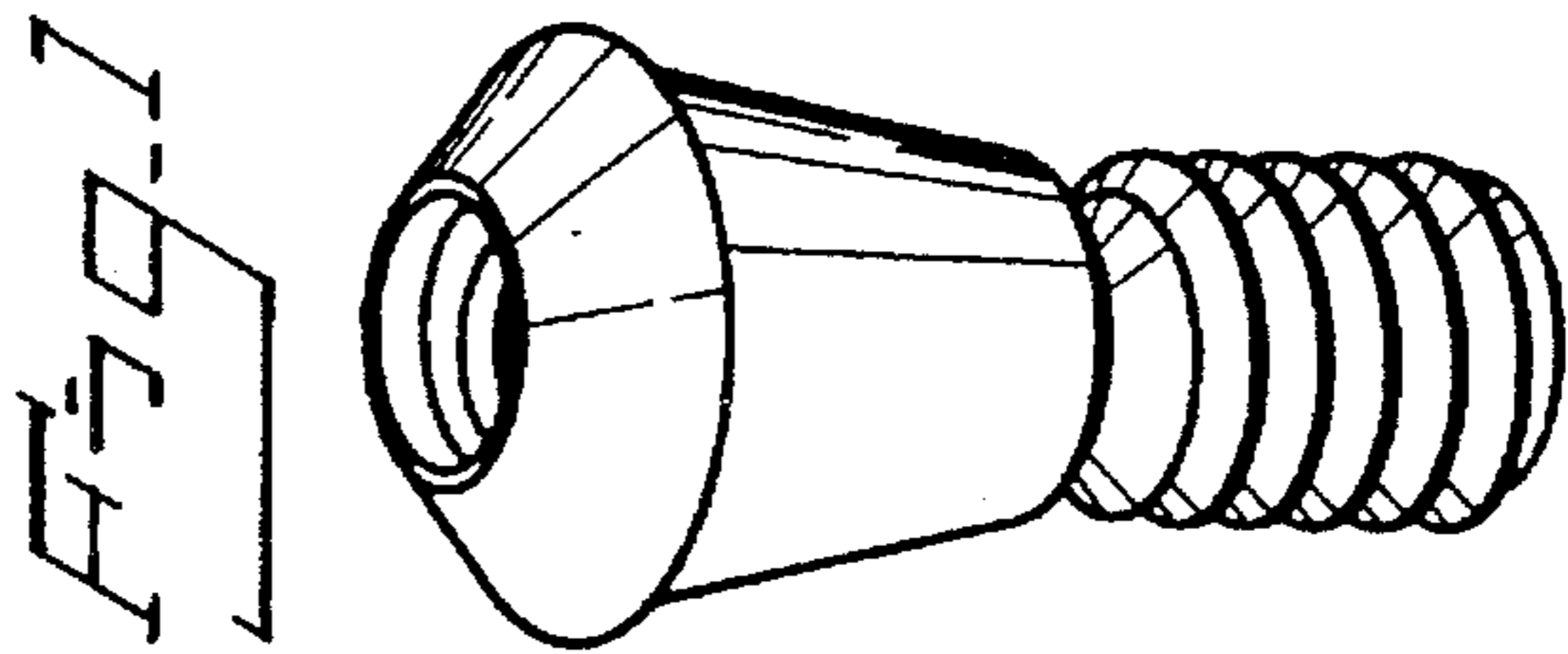
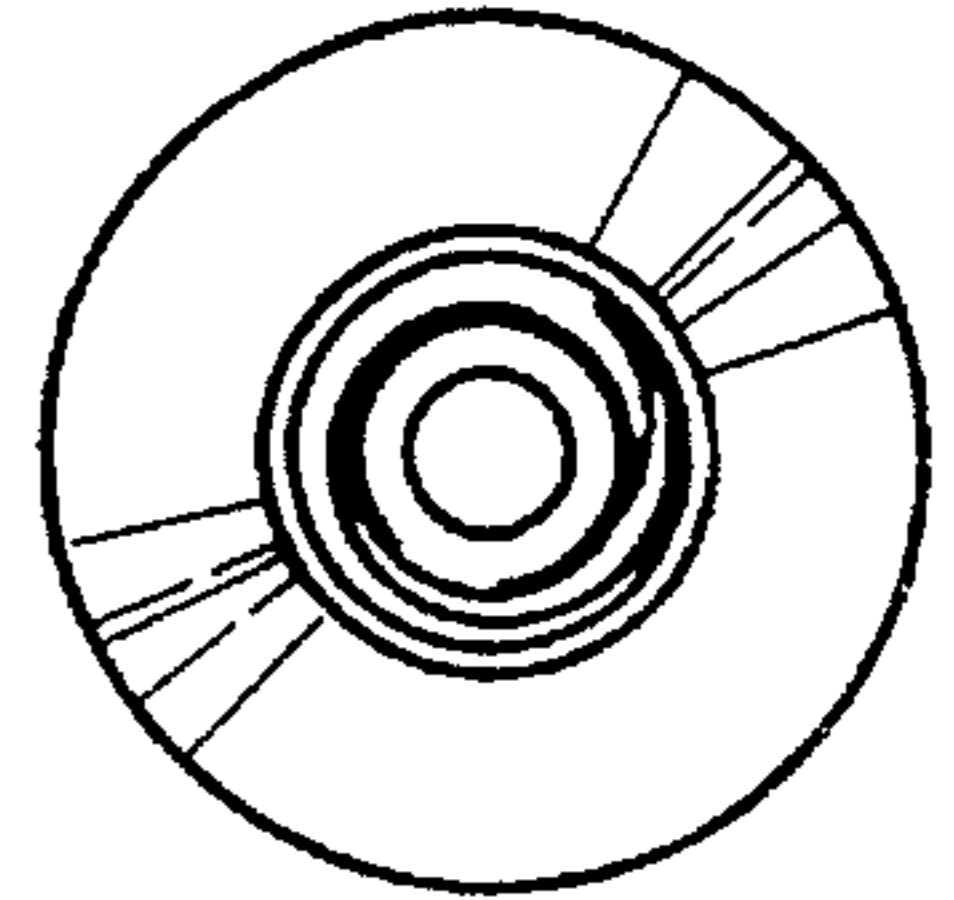
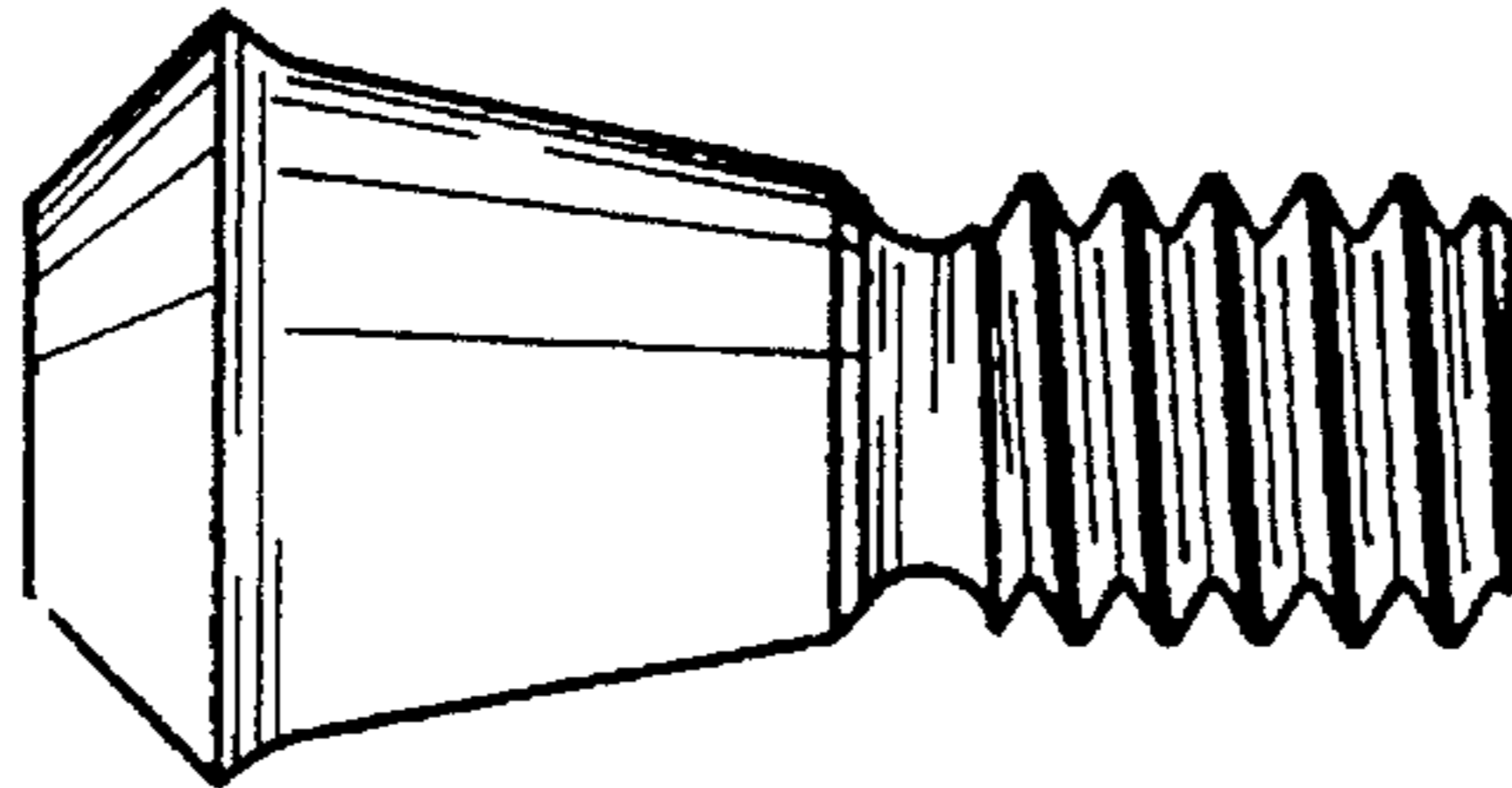
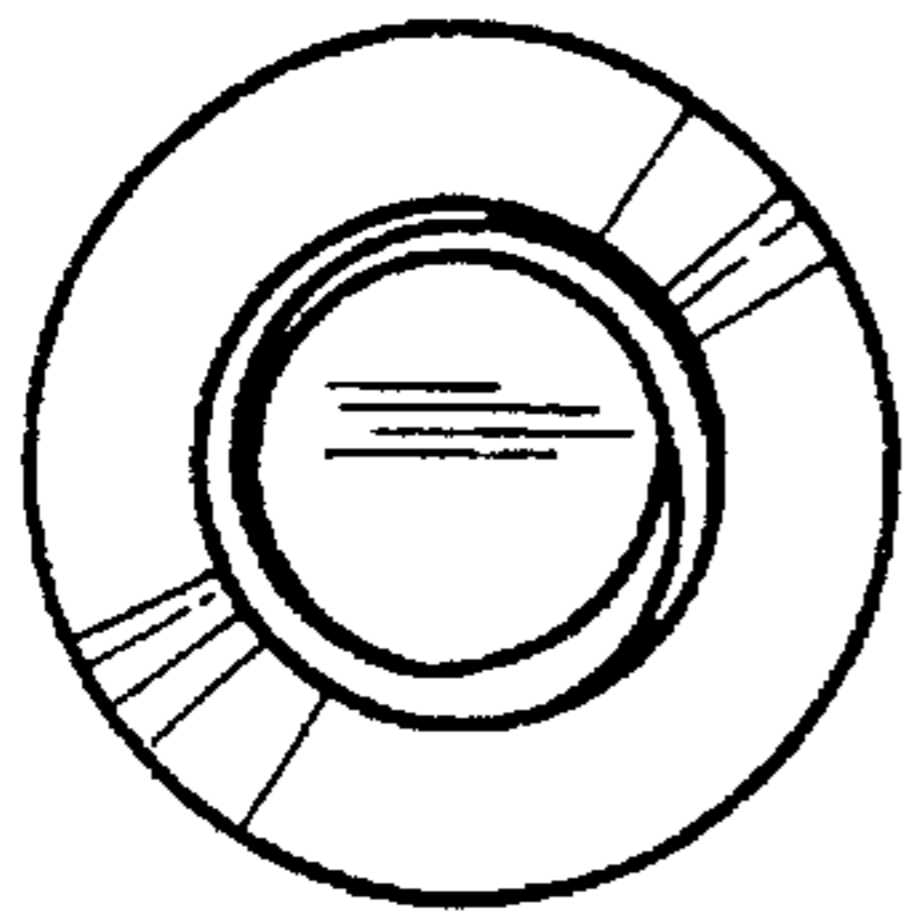
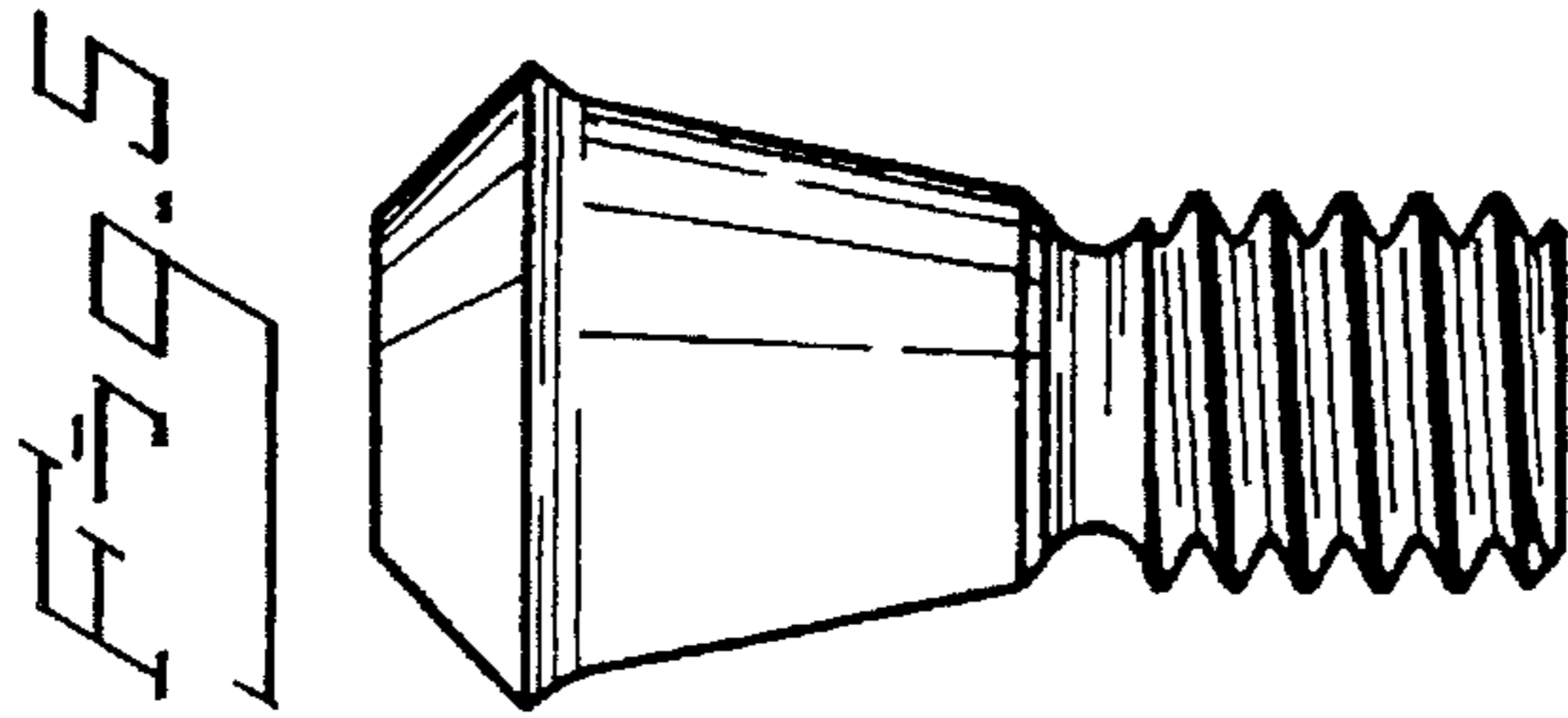

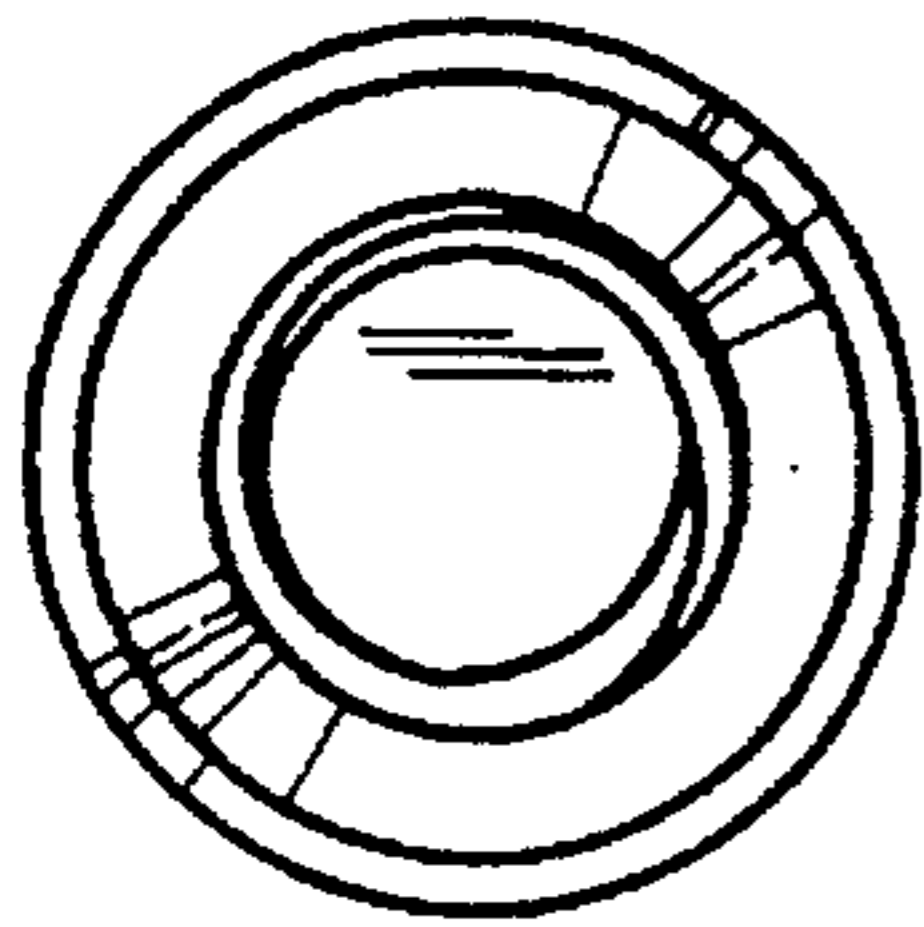
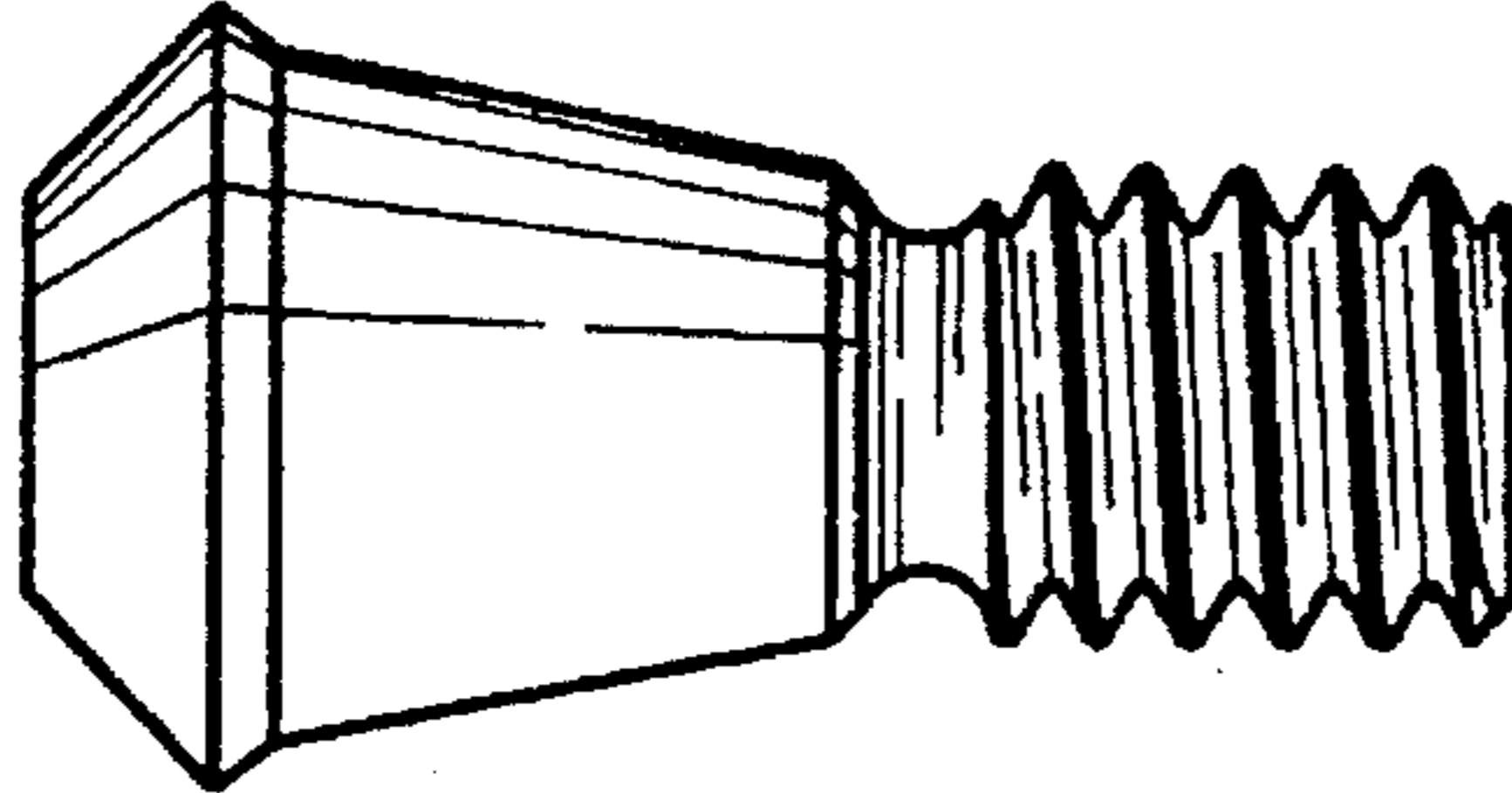

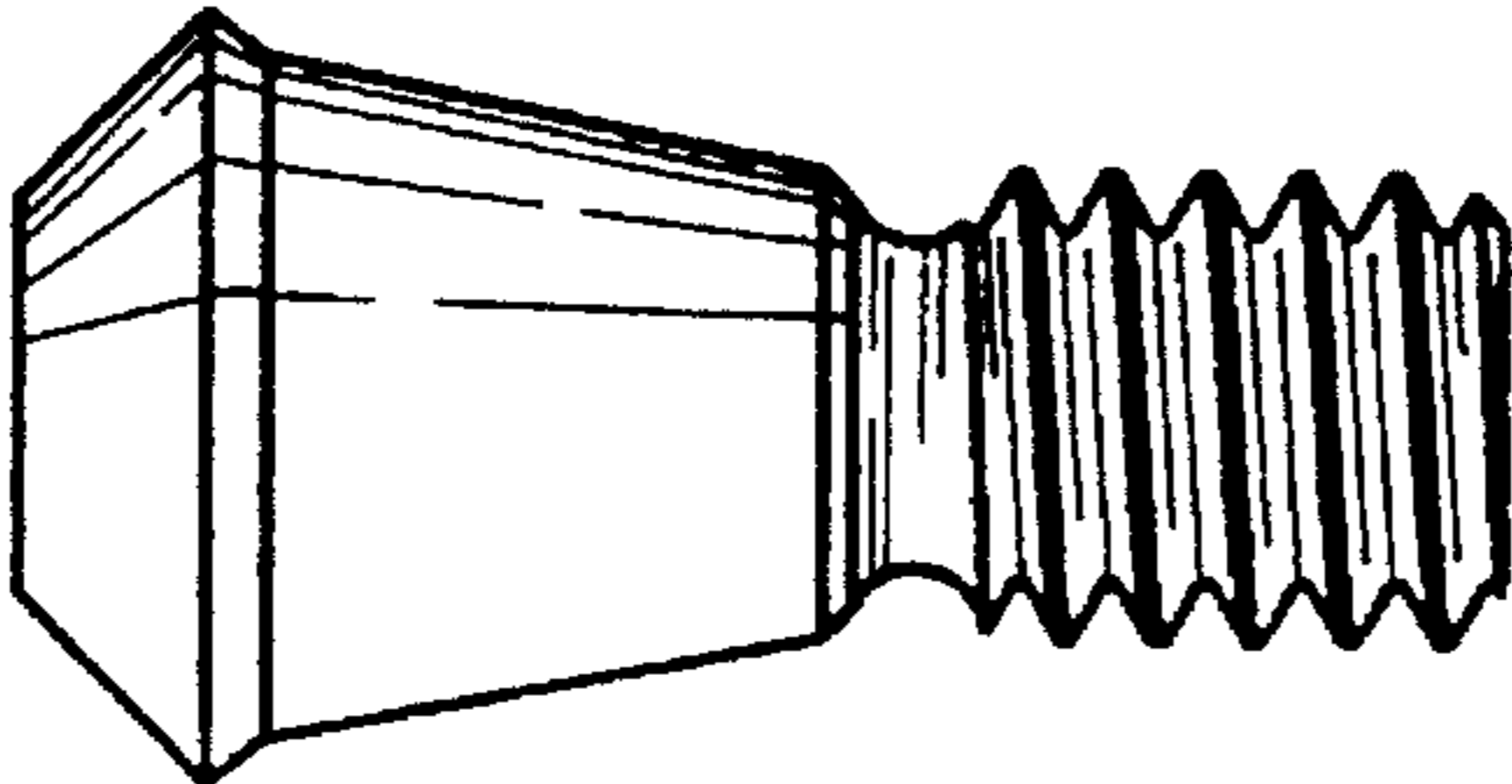

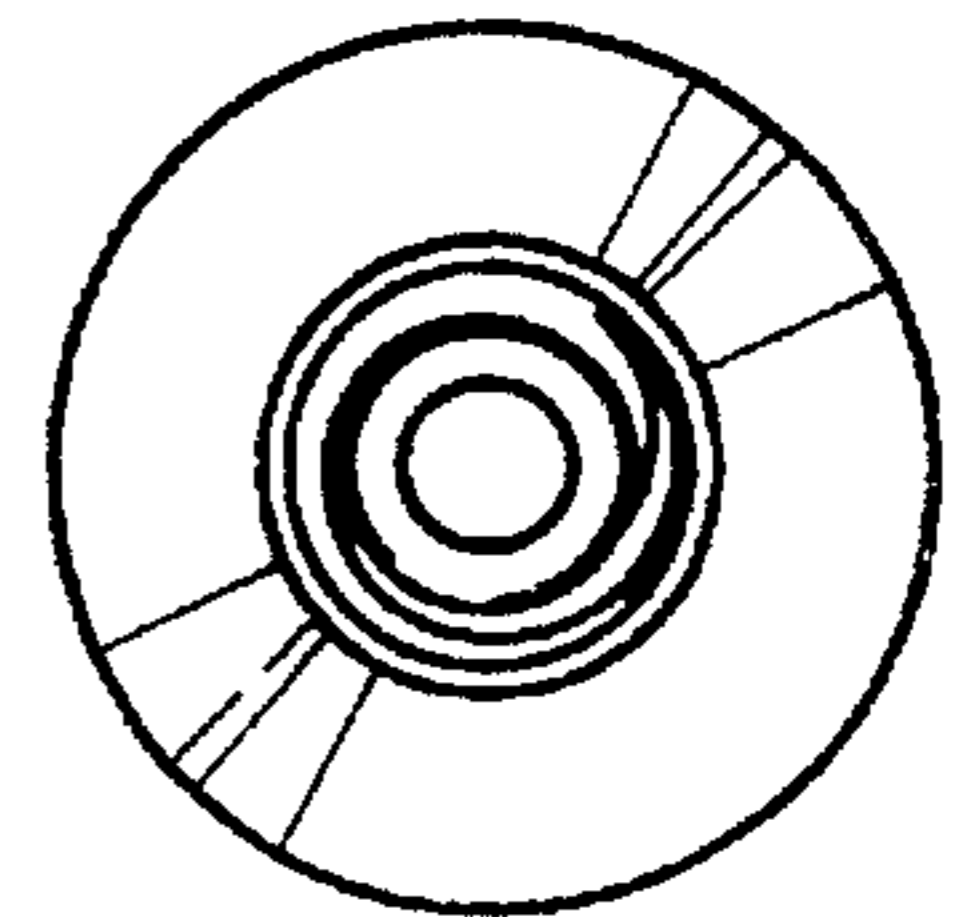

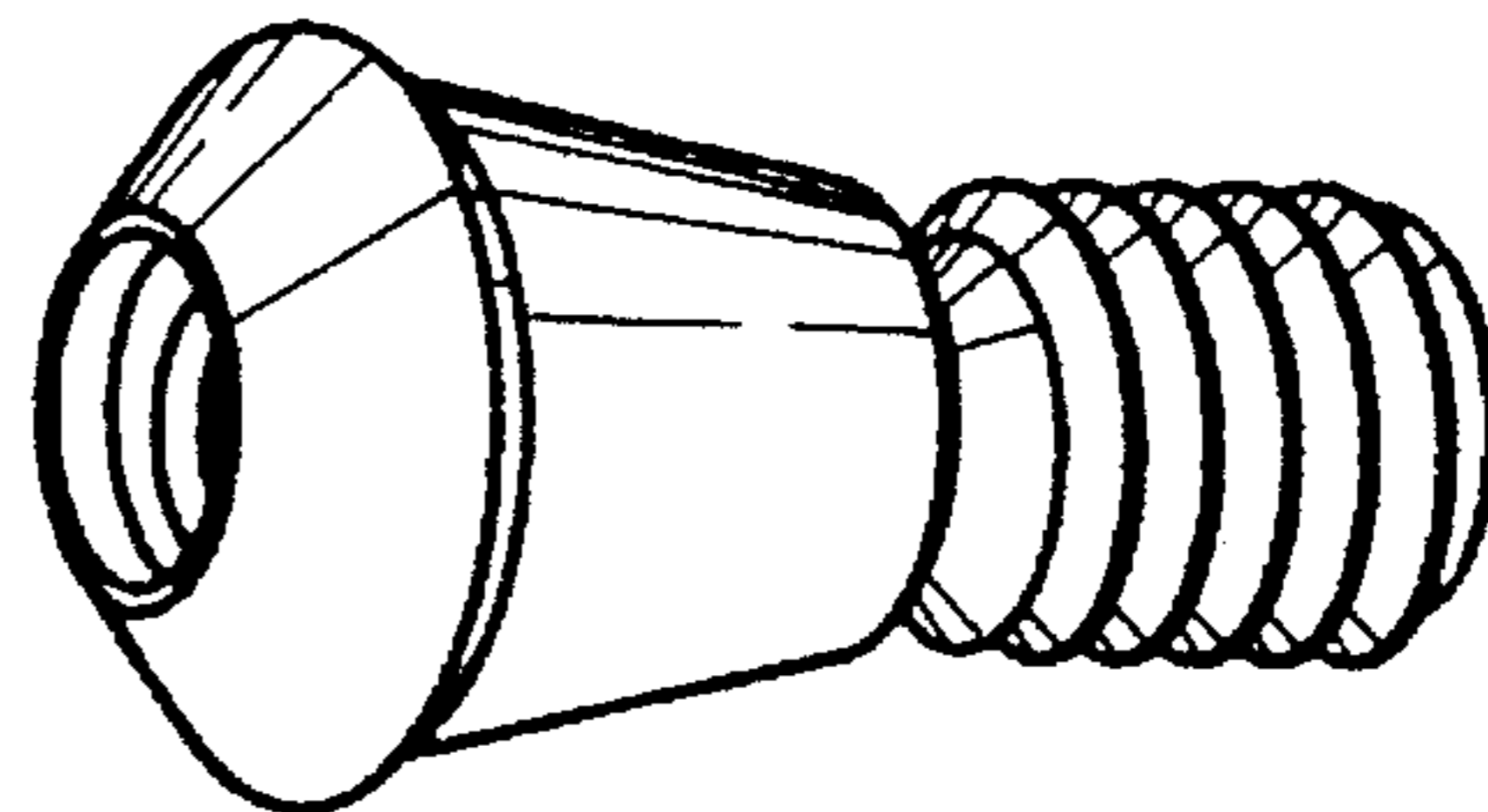

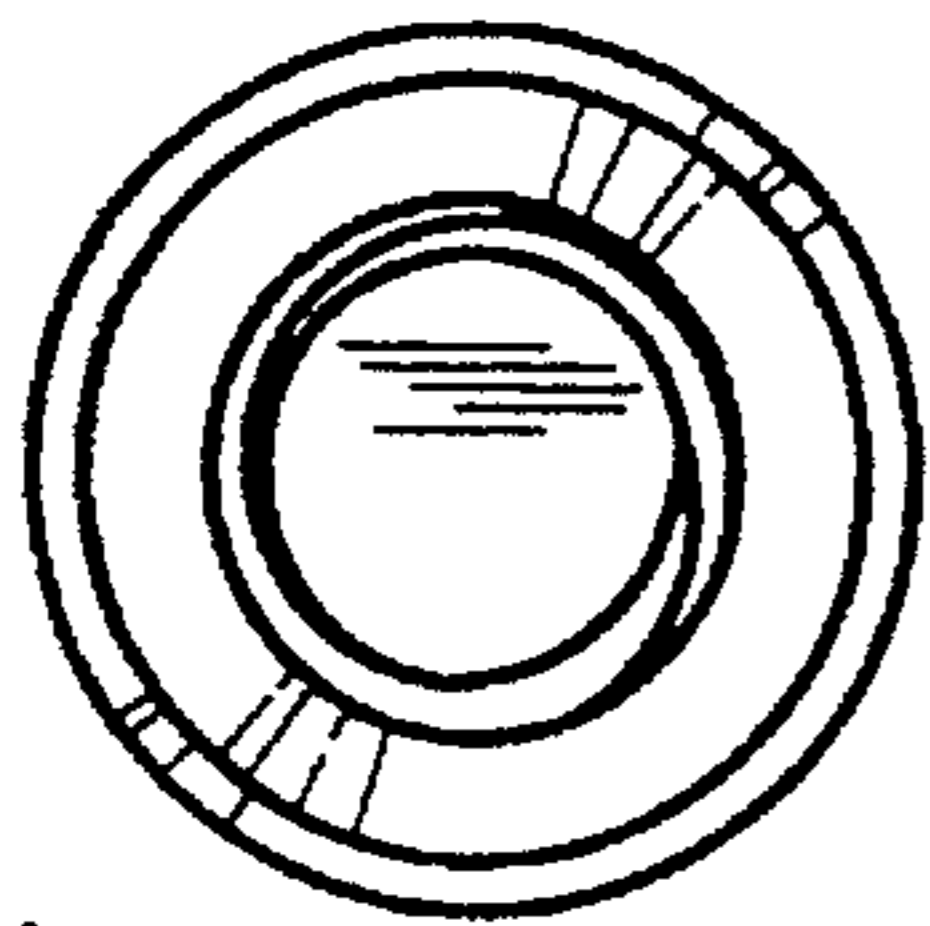
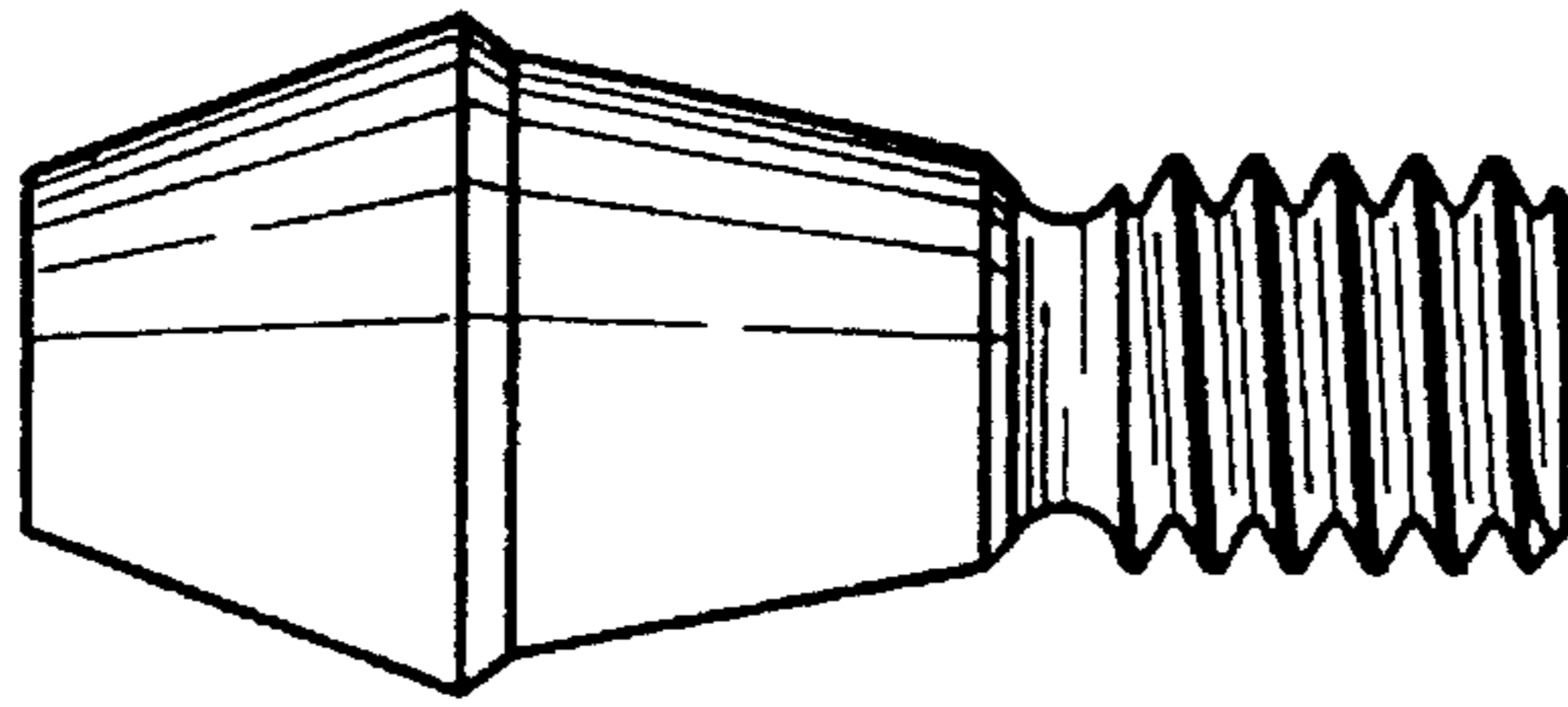

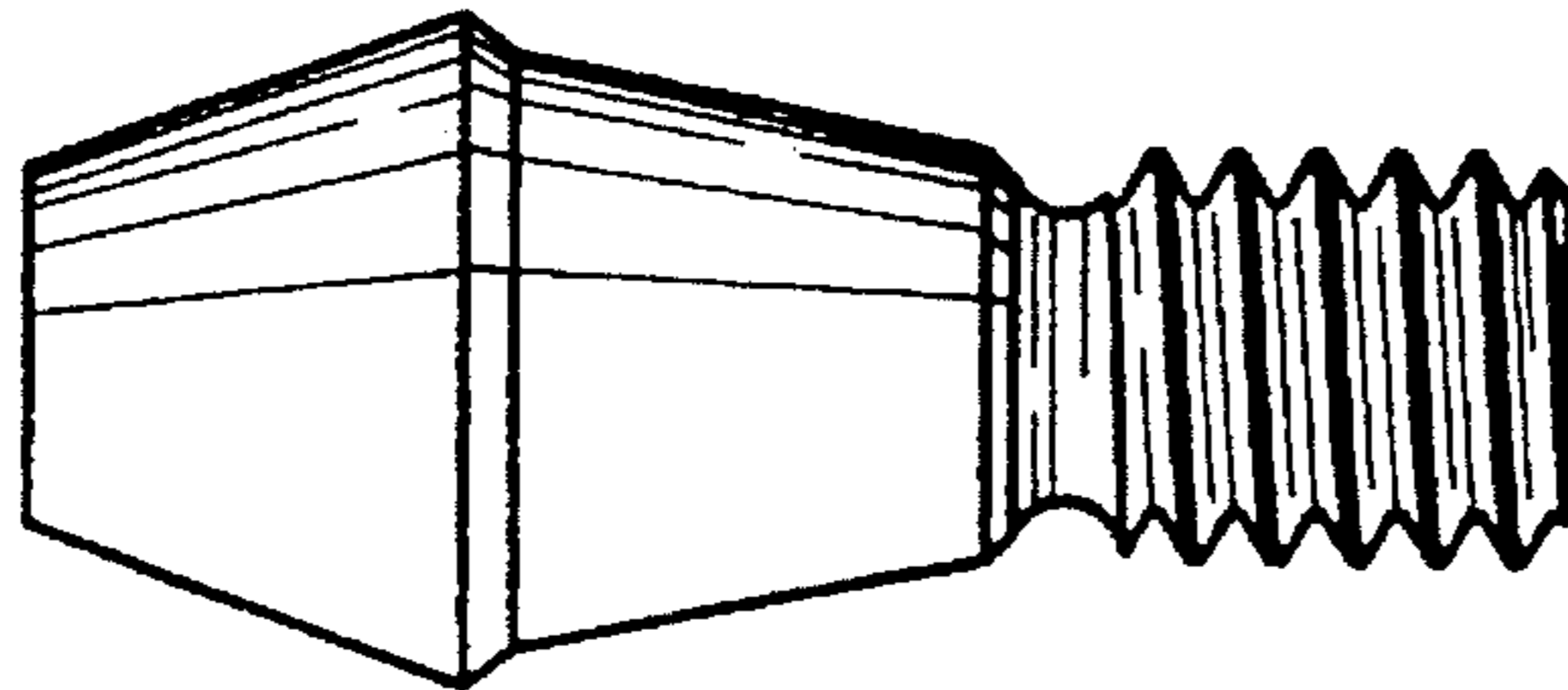

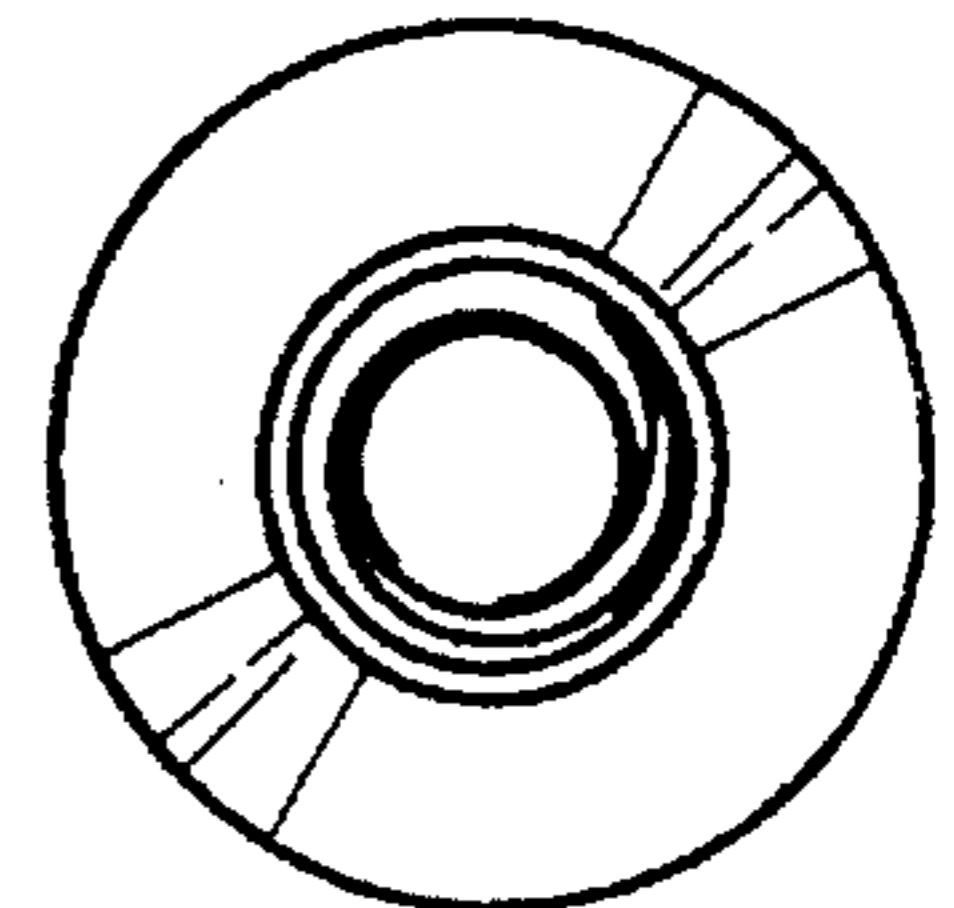

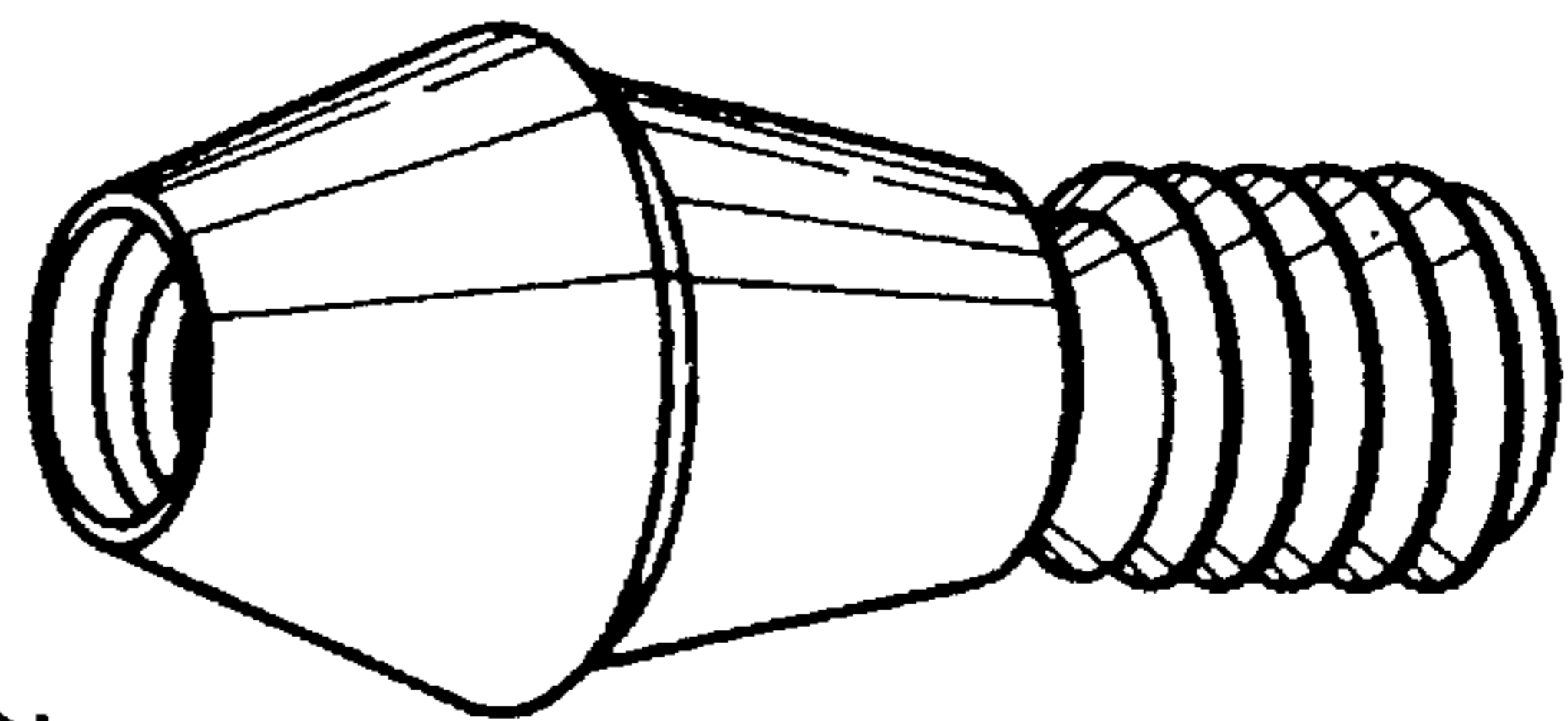

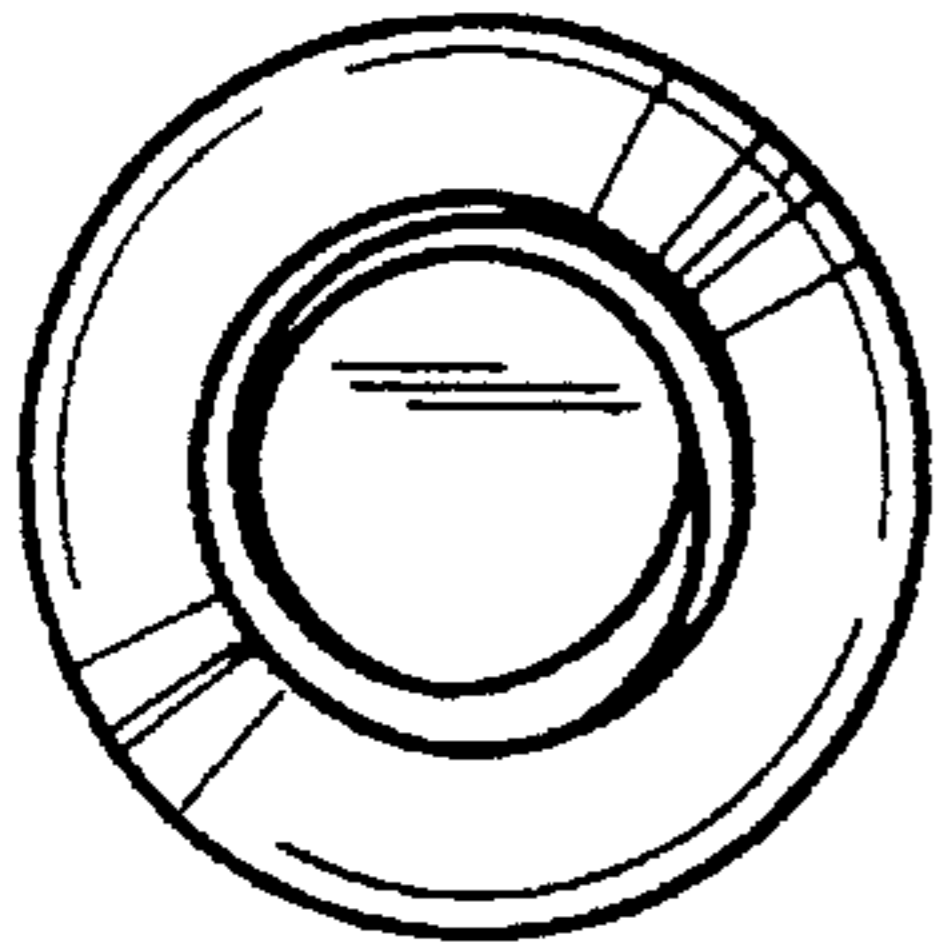
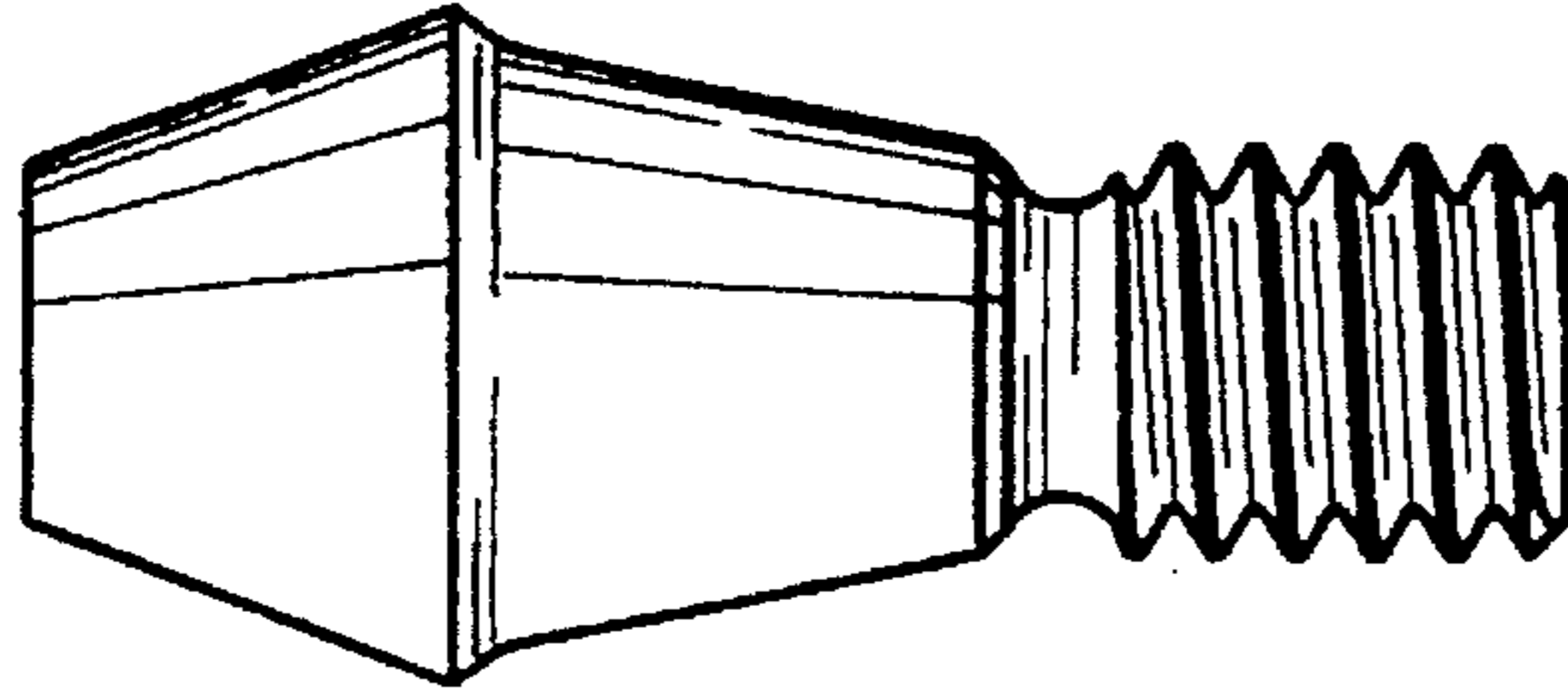

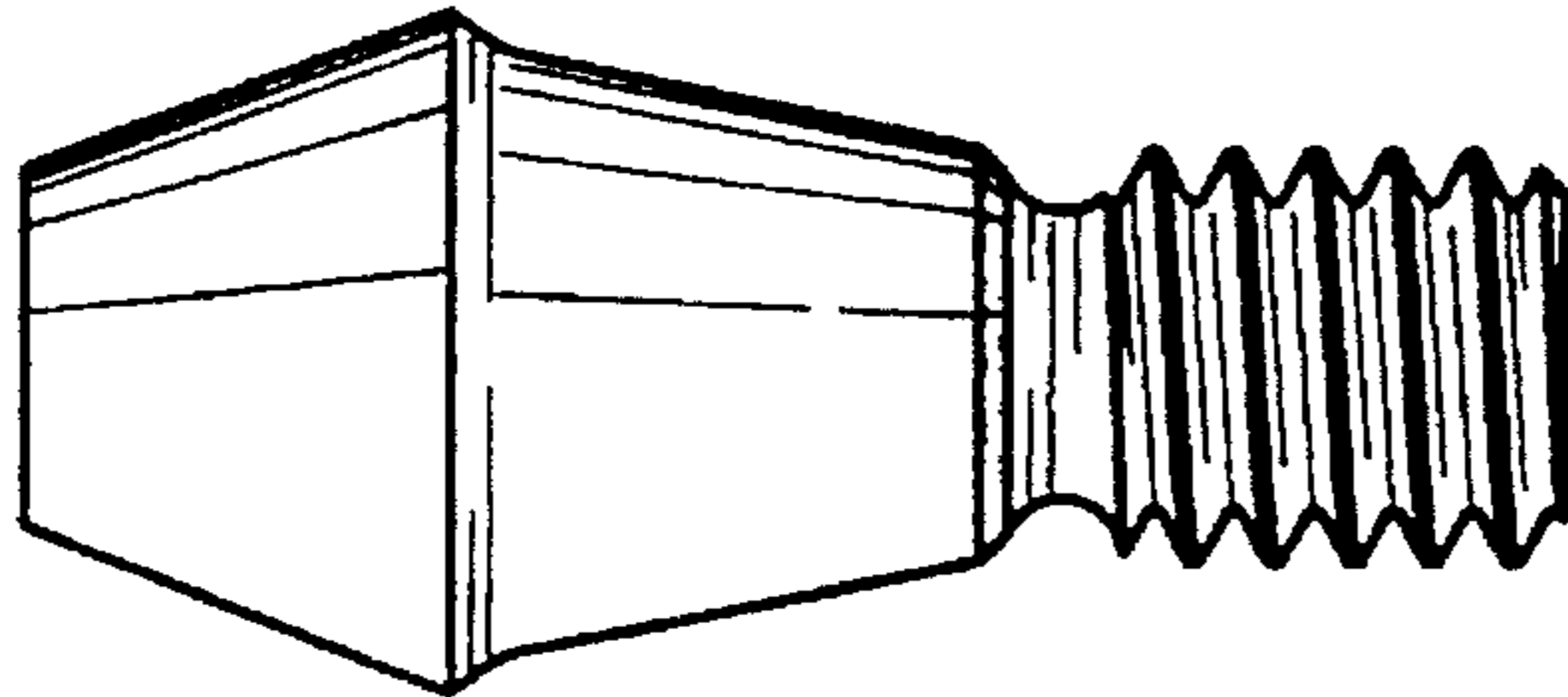

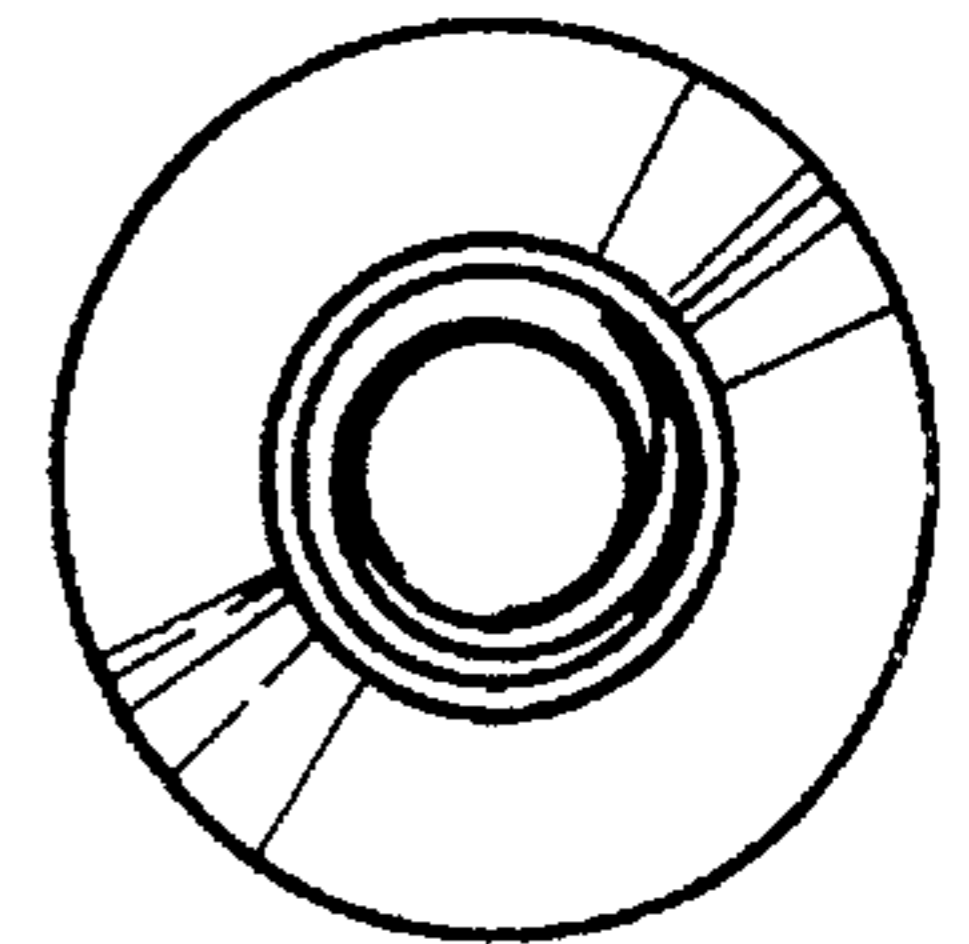

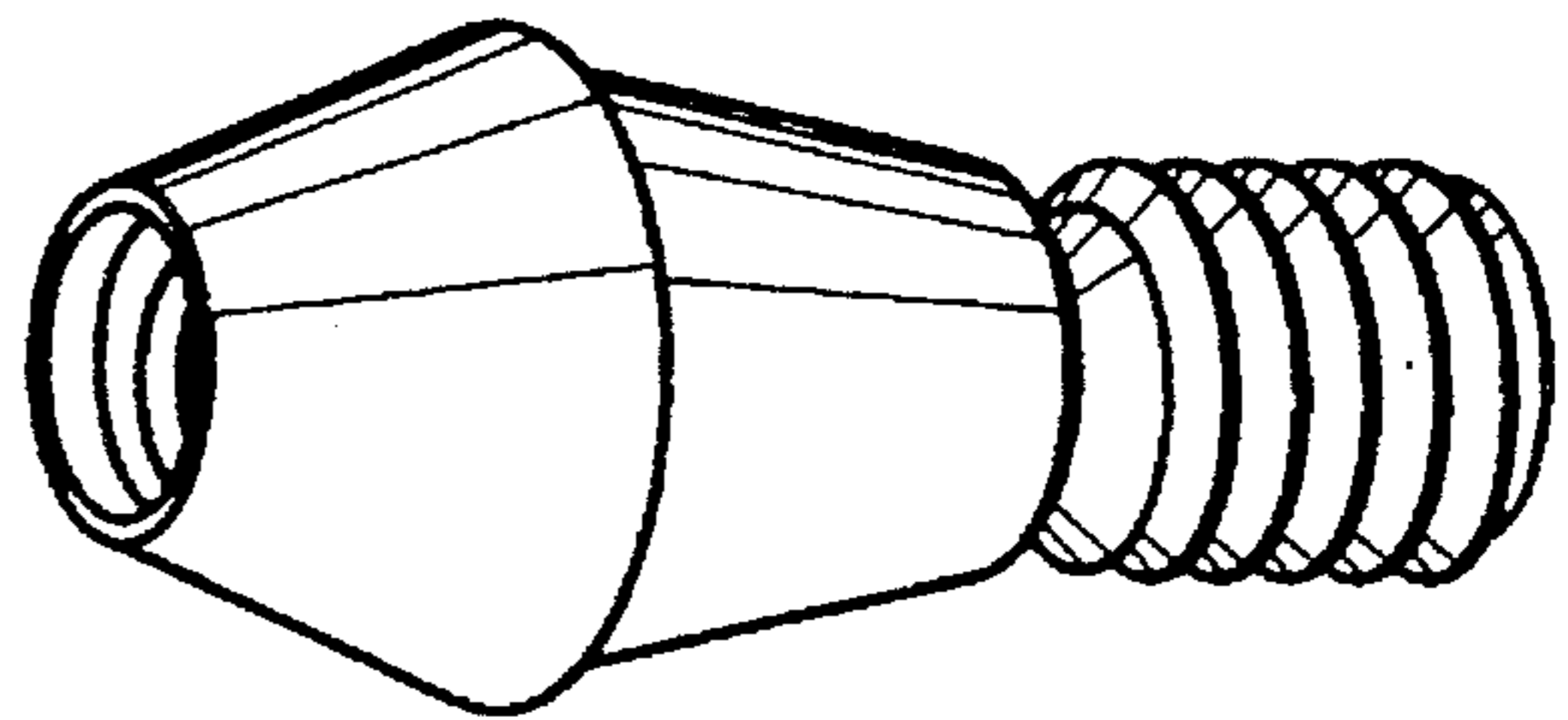
