[57] **CLAIM**

The ornamental design for a sweatband and eyeglass holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a sweatband and eyeglass holder showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a left end elevational view thereof; and, FIG. 7 is a right end elevational view thereof. The broken line showing of the eye glasses in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

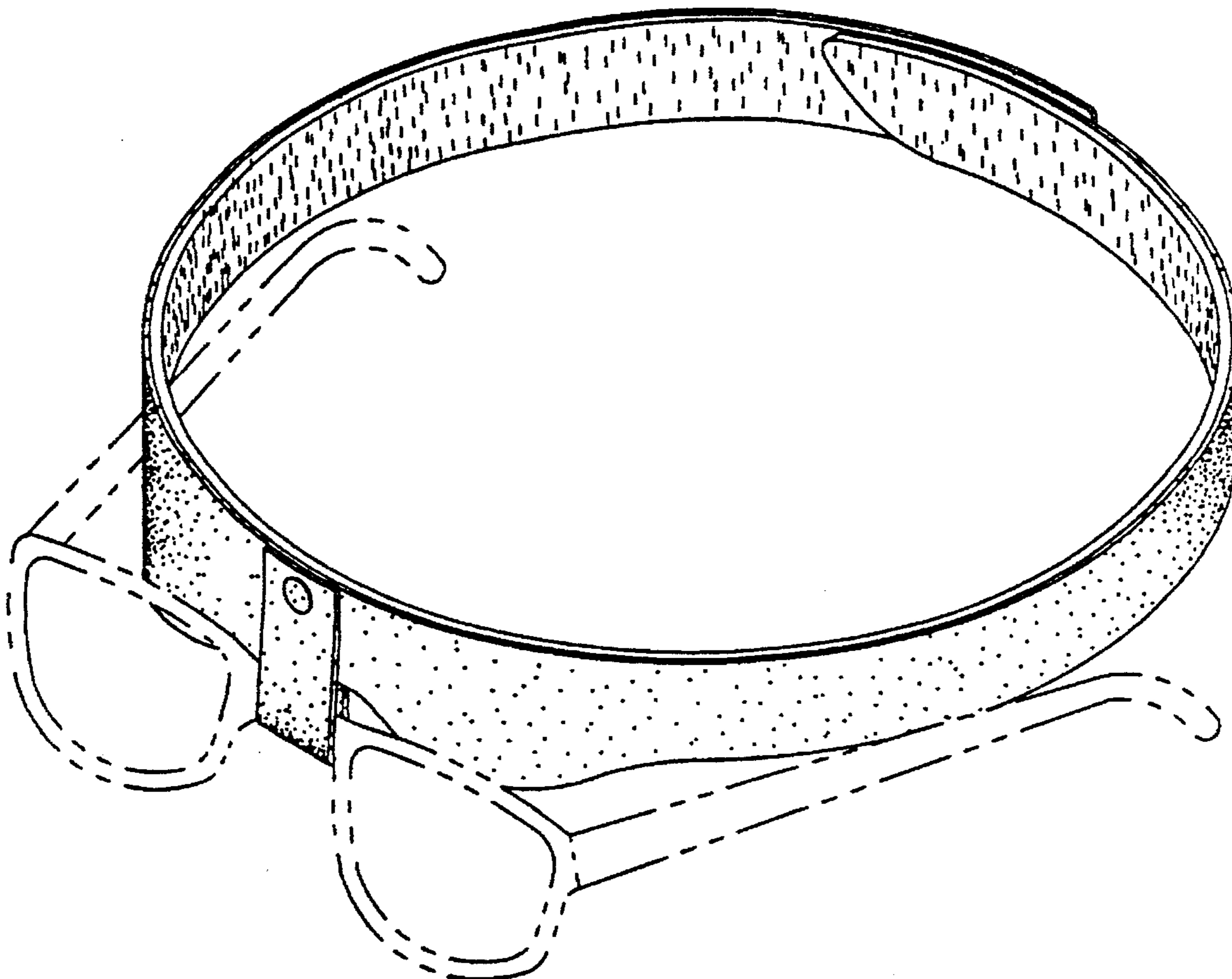

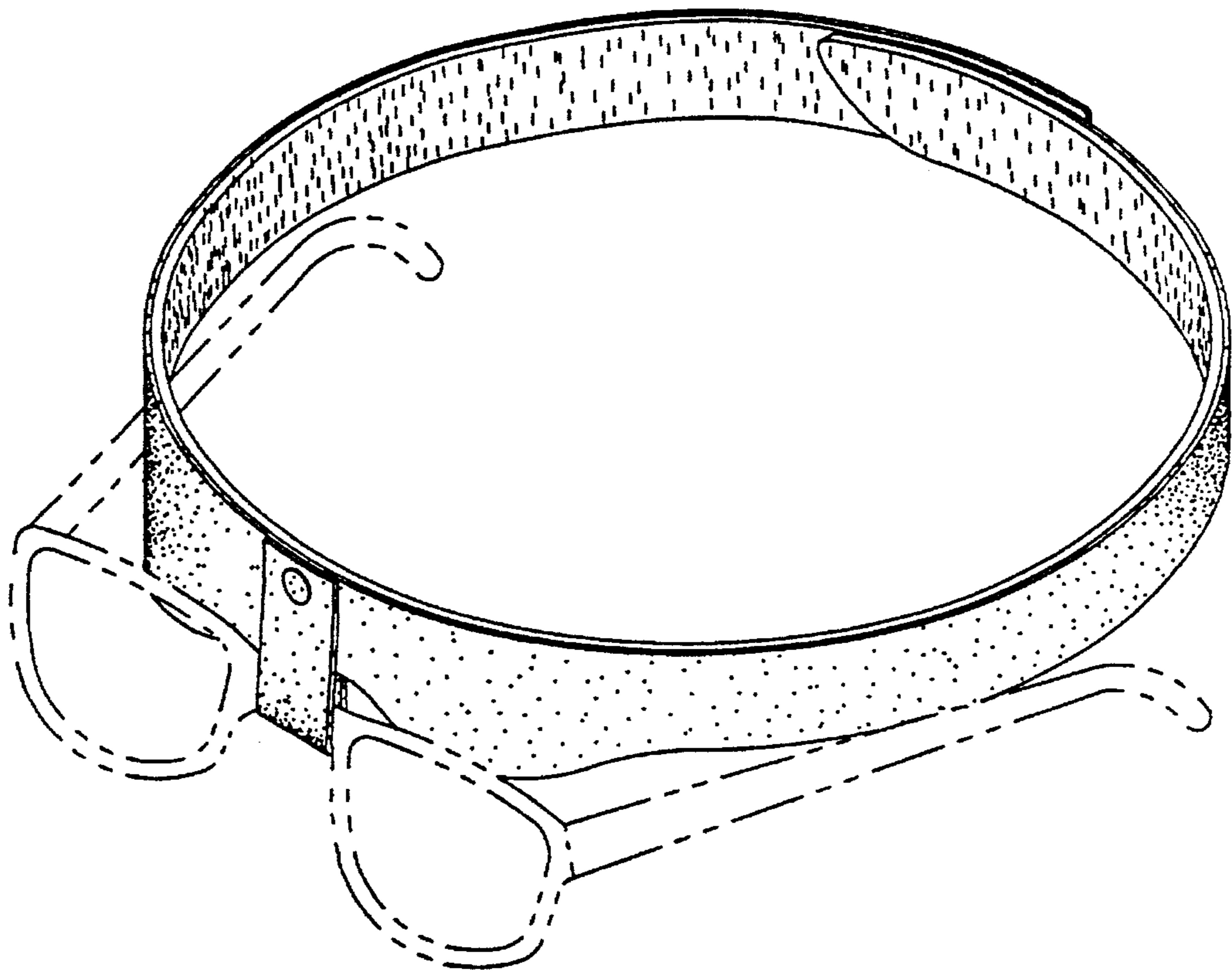

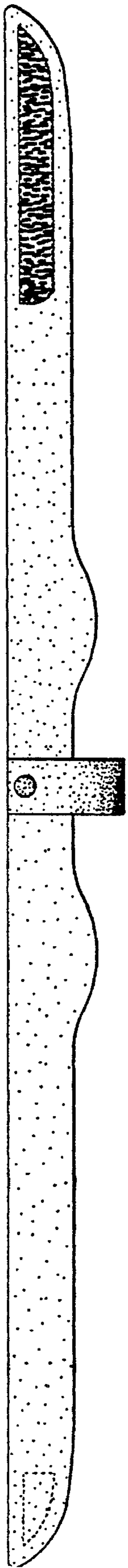

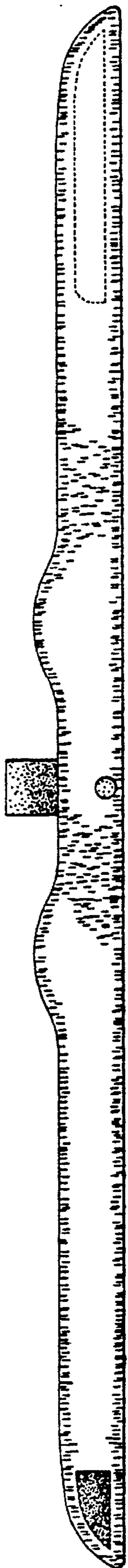
