## [57] CLAIM

The ornamental design for a footwear outsole, as shown and described.

## DESCRIPTION

FIG. 1 is a bottom plan view of a footwear outsole showing our new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof; the top surface being shown for illustrative purposes only and forming no part of the claimed design;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a bottom plan view of an alternate embodiment of the design shown in FIG. 1;

FIG. 7 is a left side elevational view of FIG. 6;

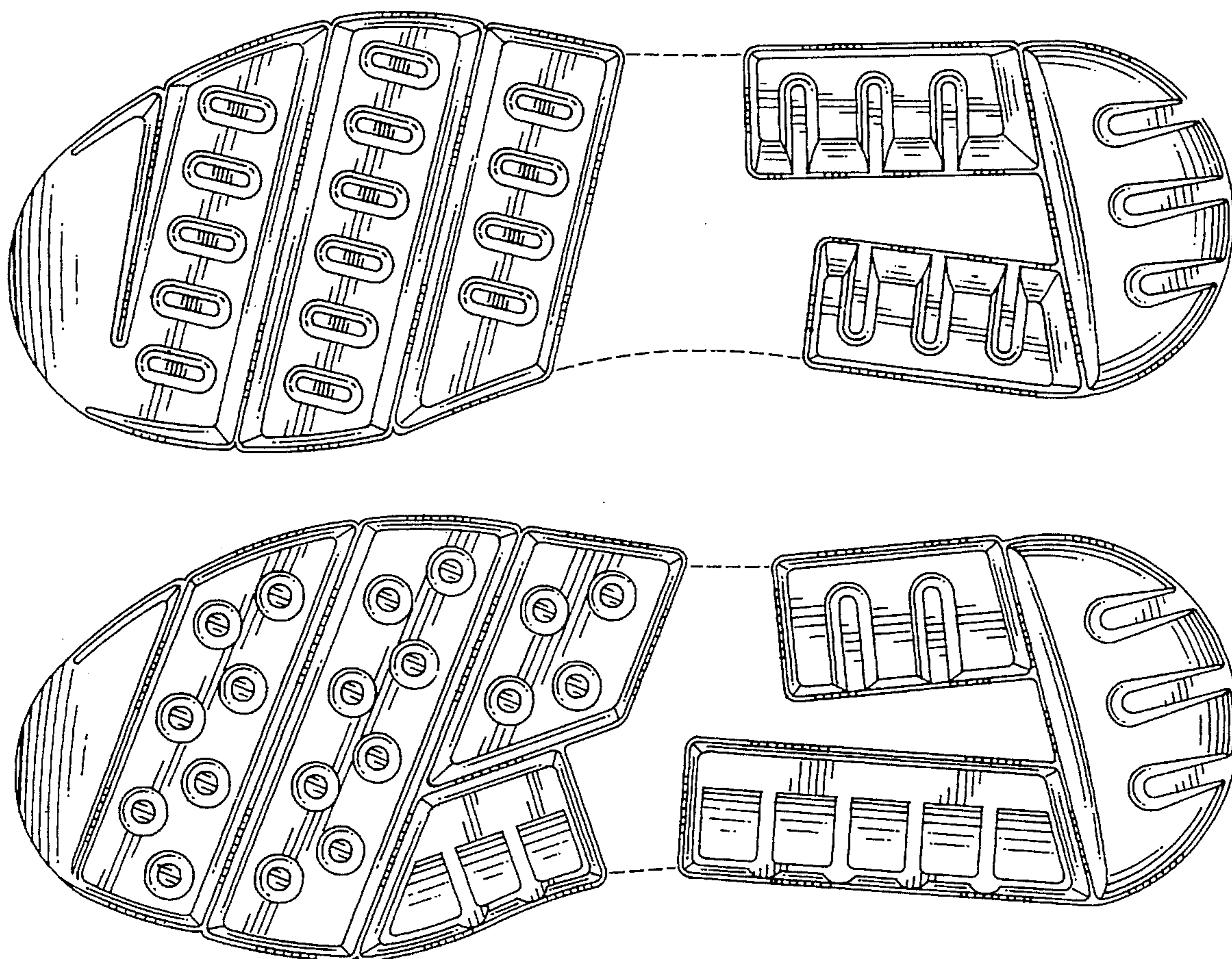
FIG. 8 is a right side elevational view of FIG. 6; the top surface being shown for illustrative purposes only and forming no part of the claimed design;

FIG. 9 is a rear elevational view of FIG. 6; and,

FIG. 10 is a front elevational view of FIG. 6.

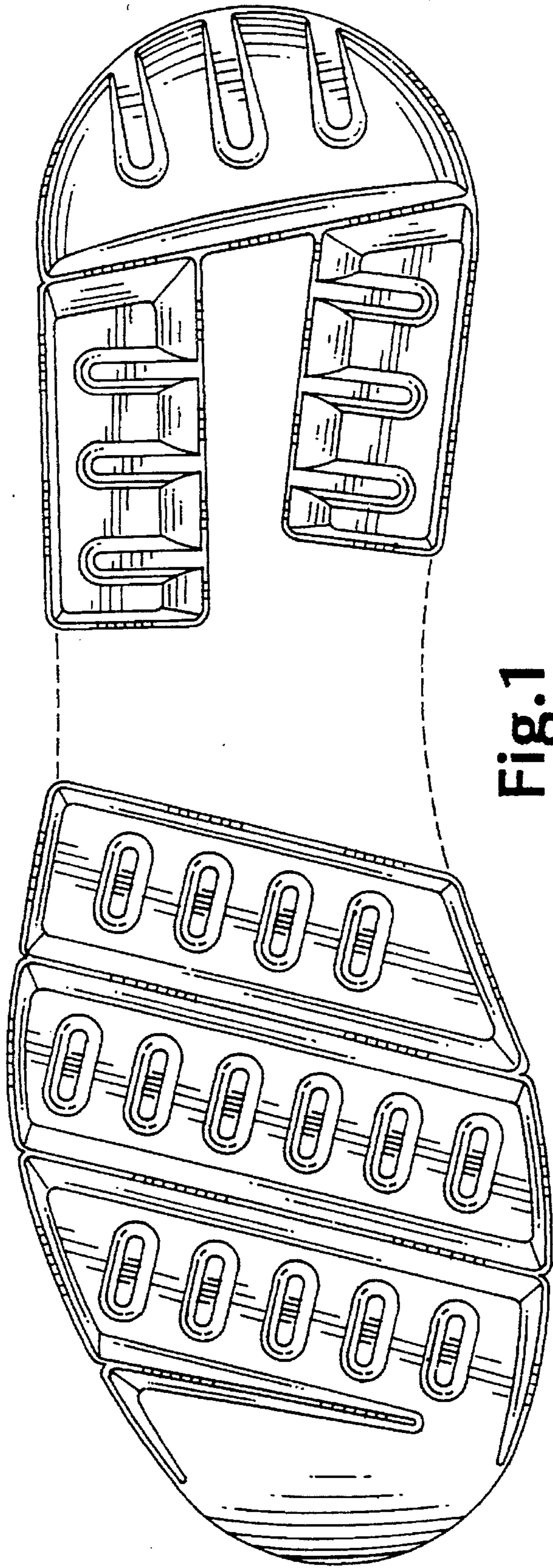

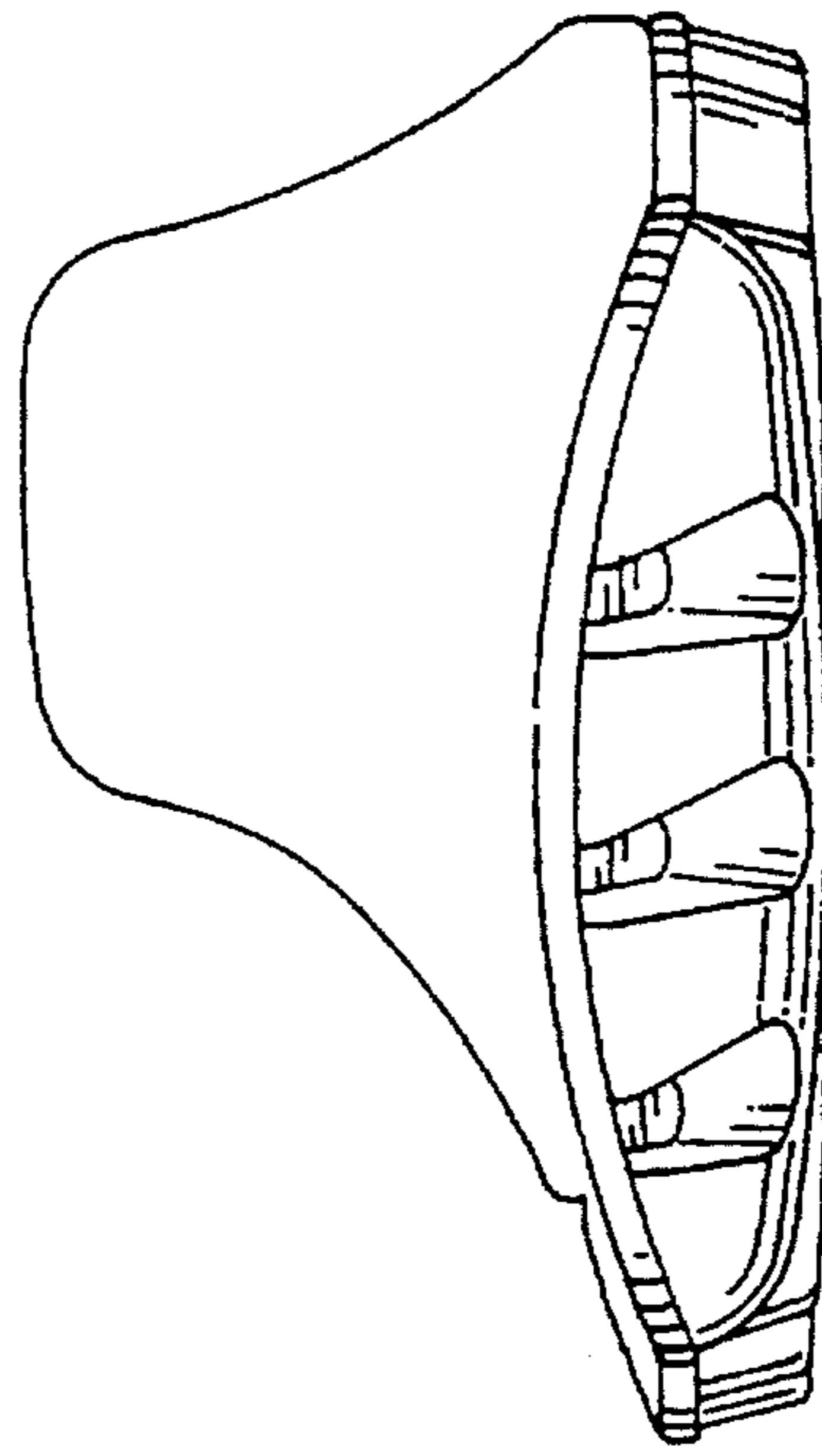

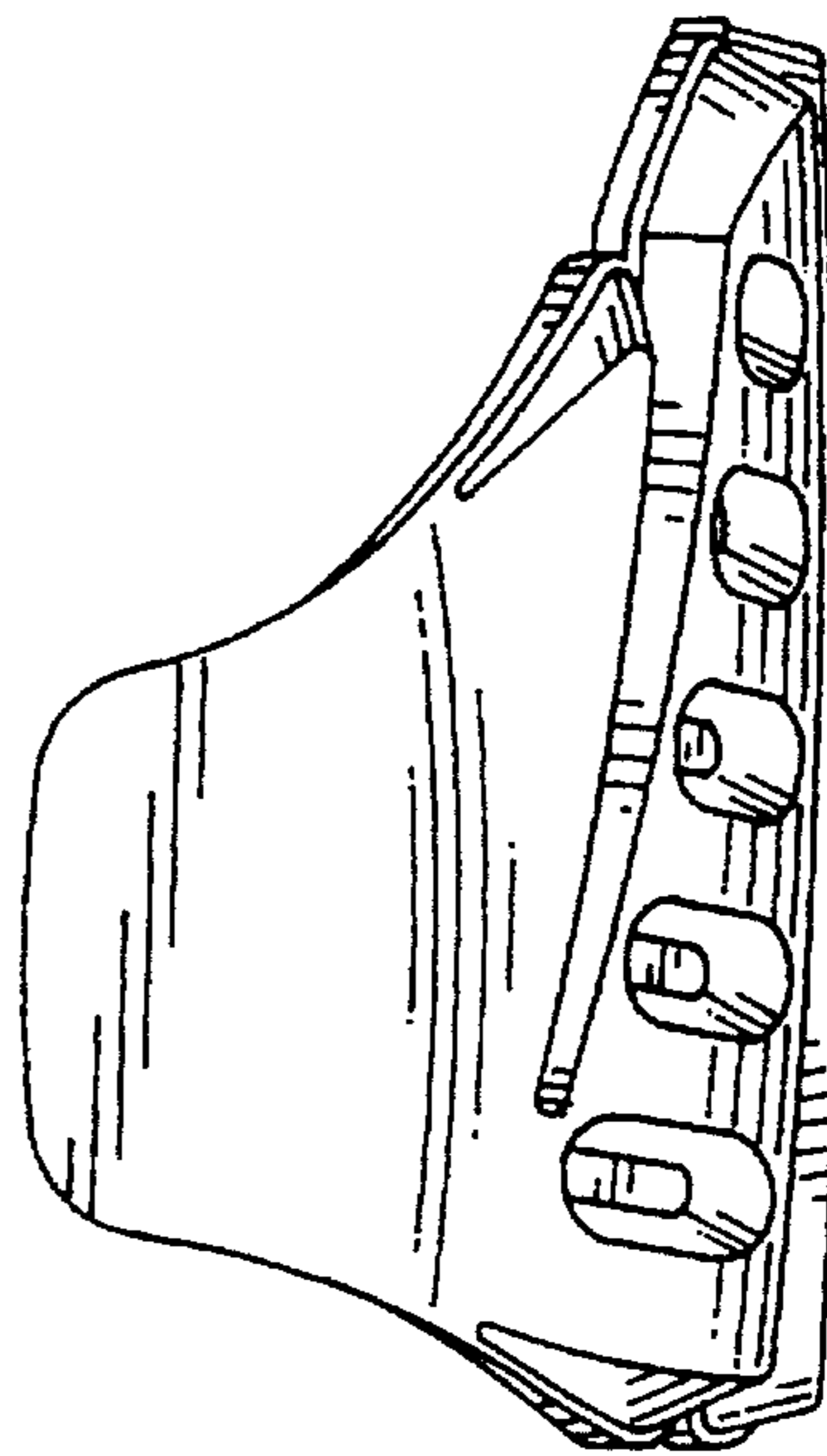

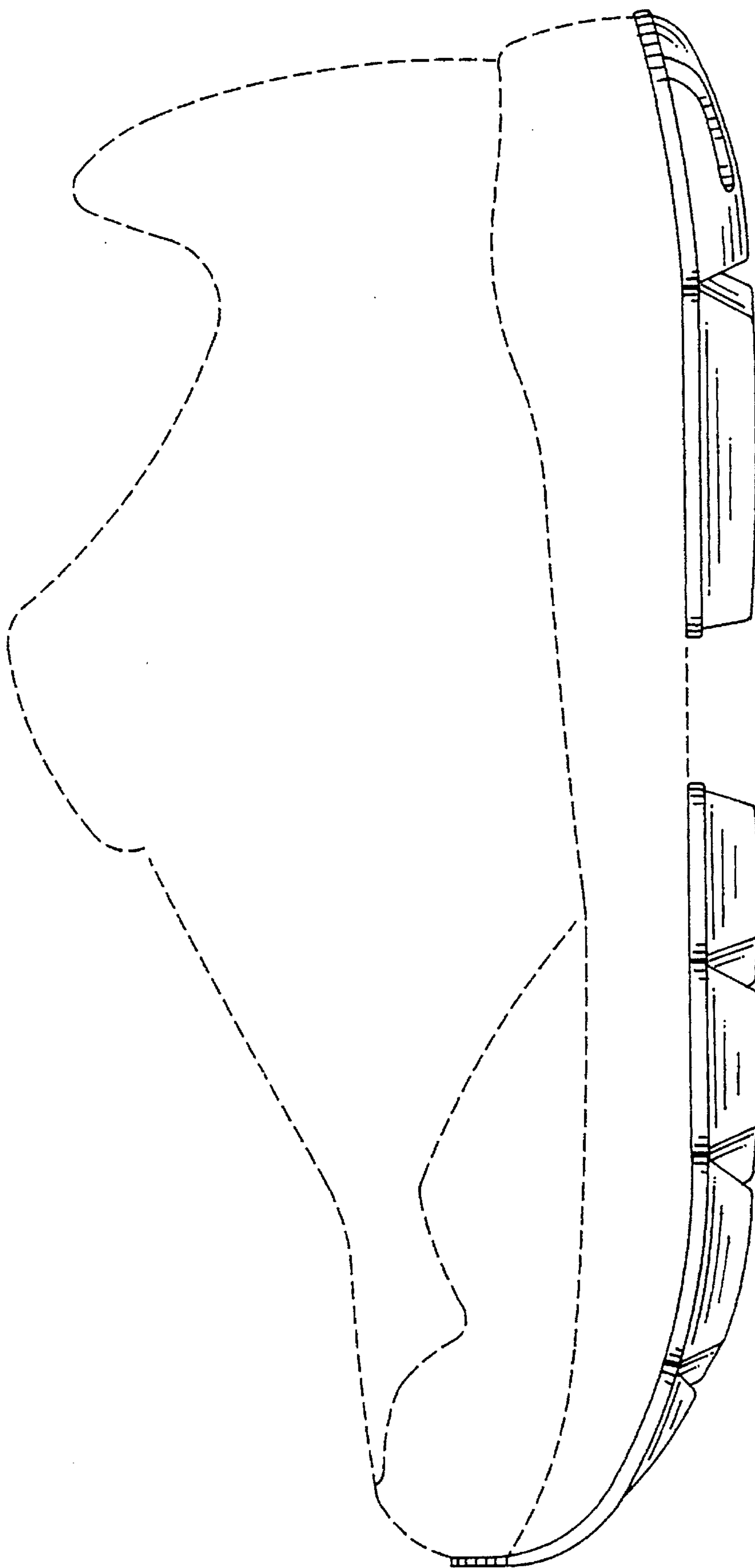

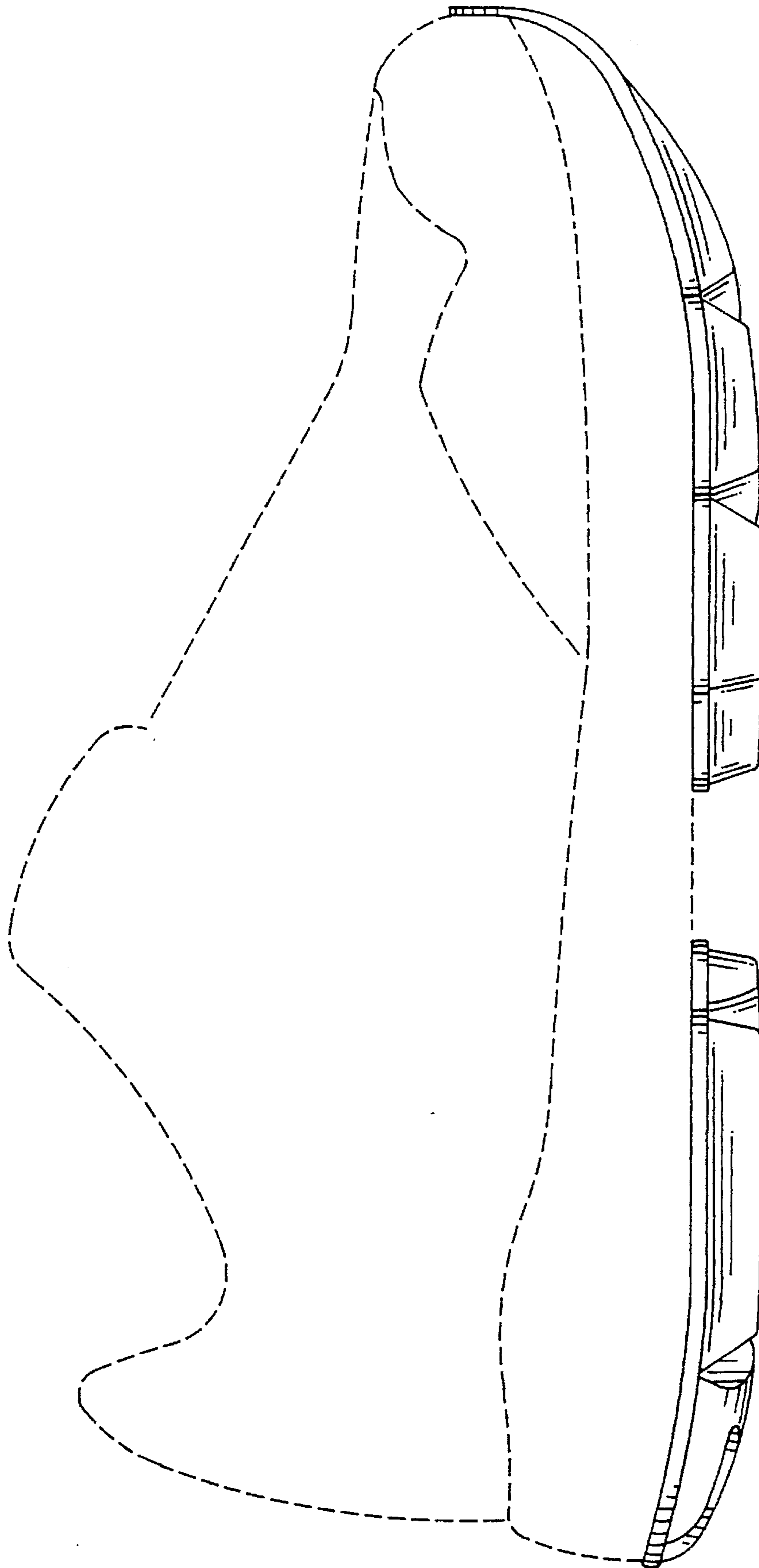

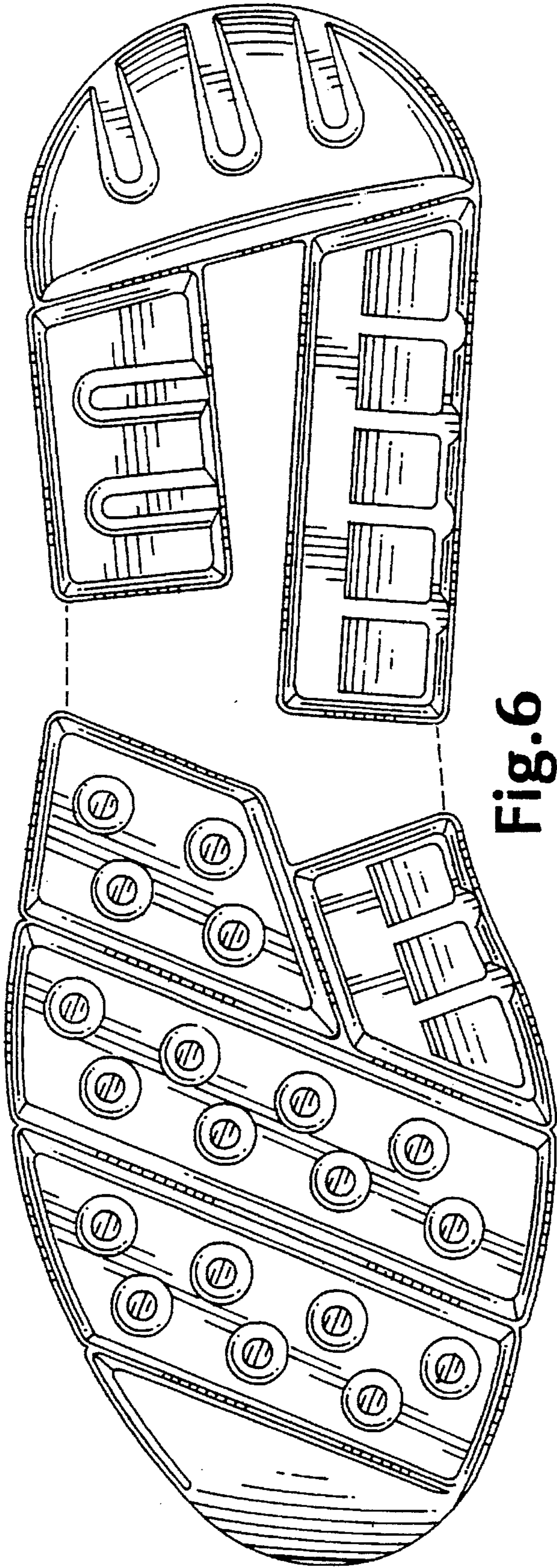

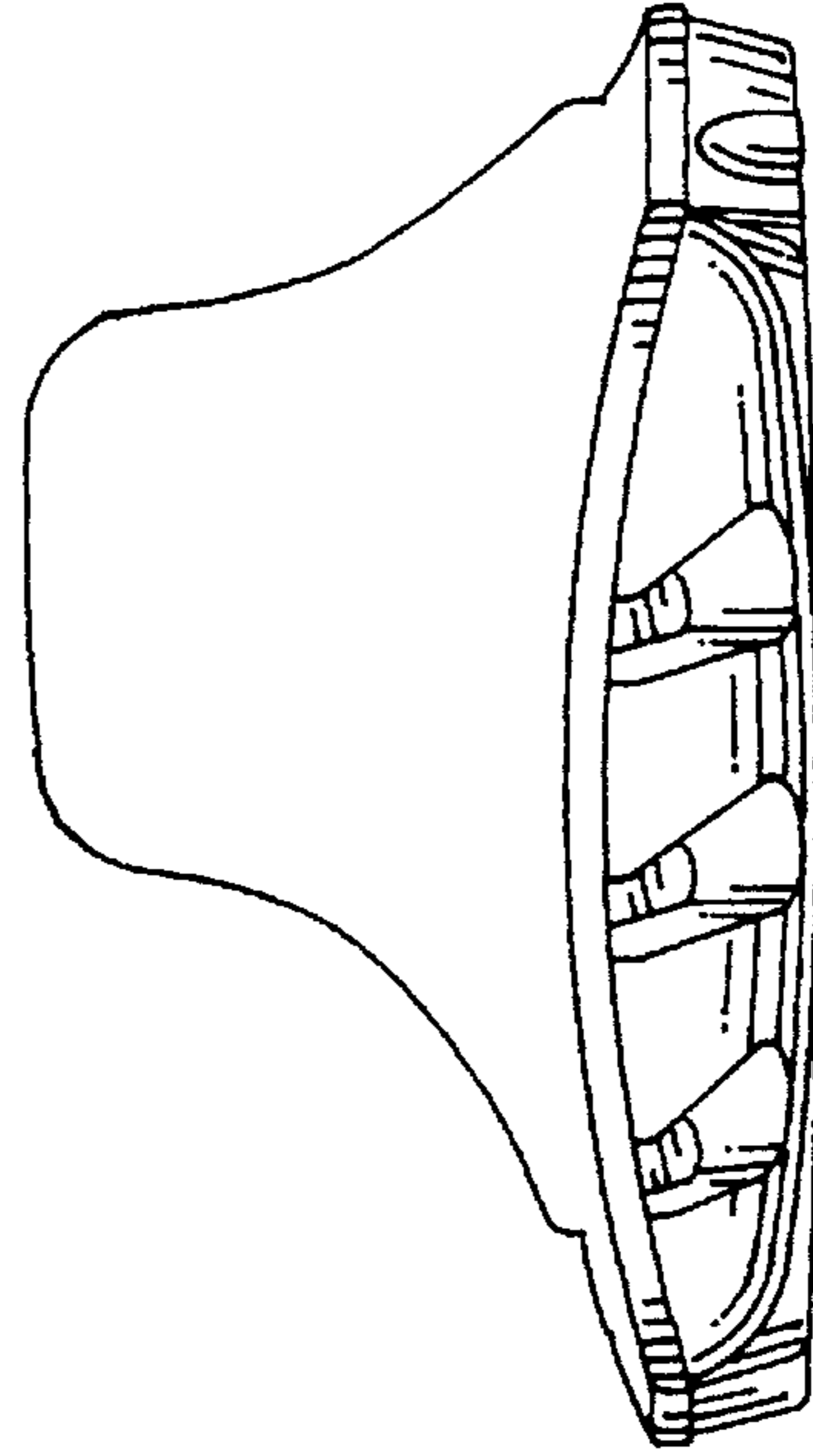

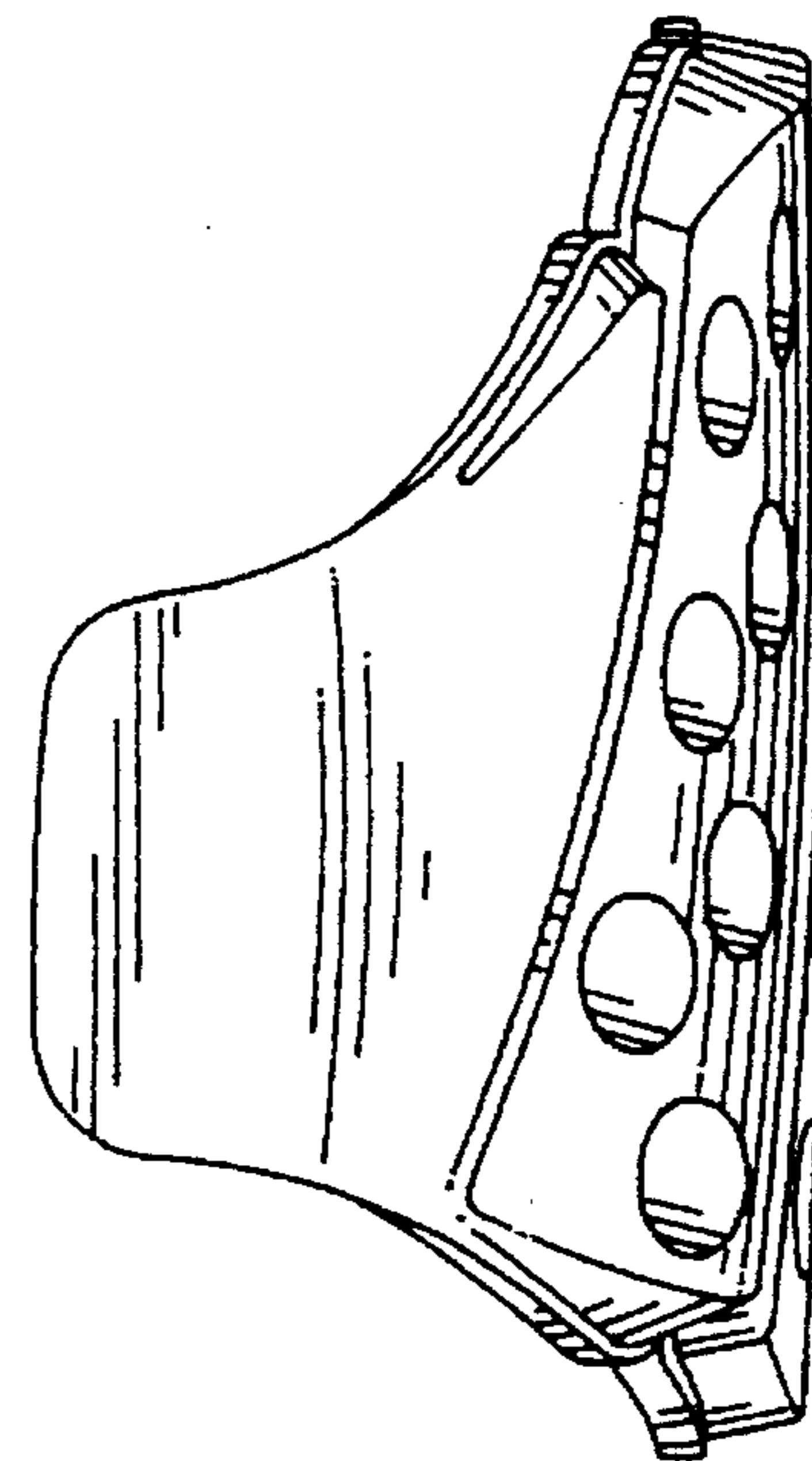

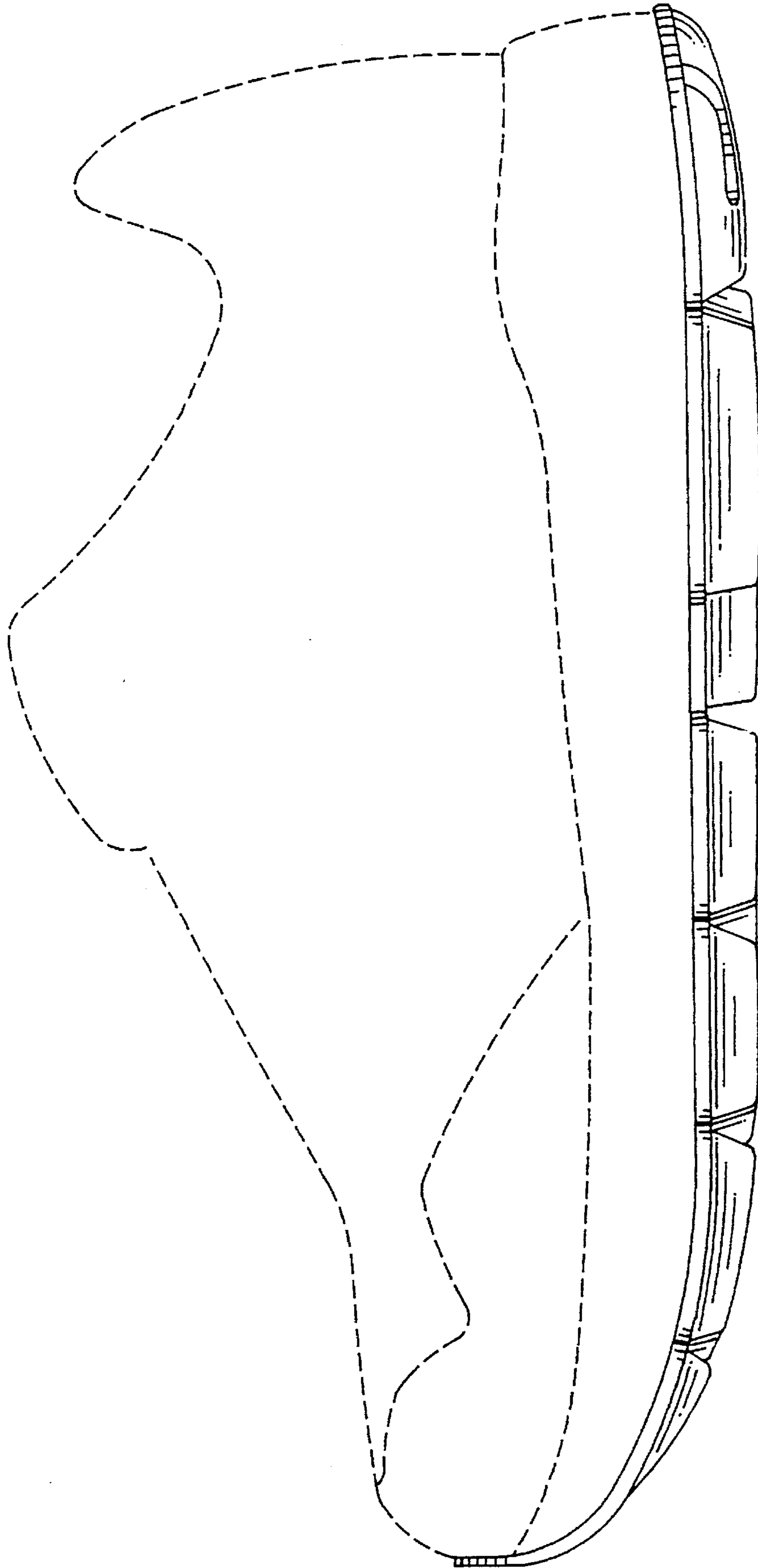

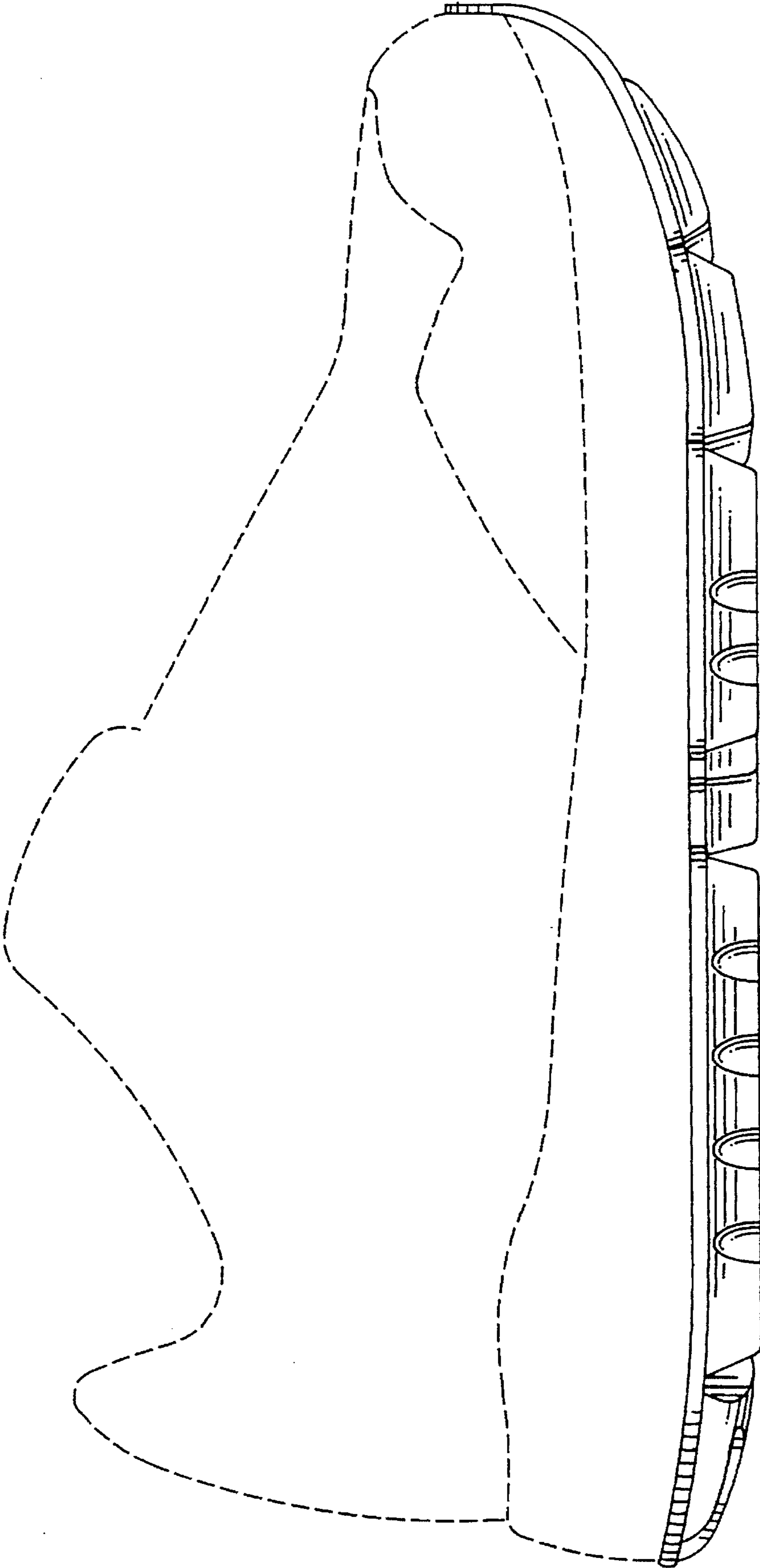
