FIG. 12 is a right side elevation view of the seat shown in FIG. 11, the left side elevation view being the mirror image thereof.

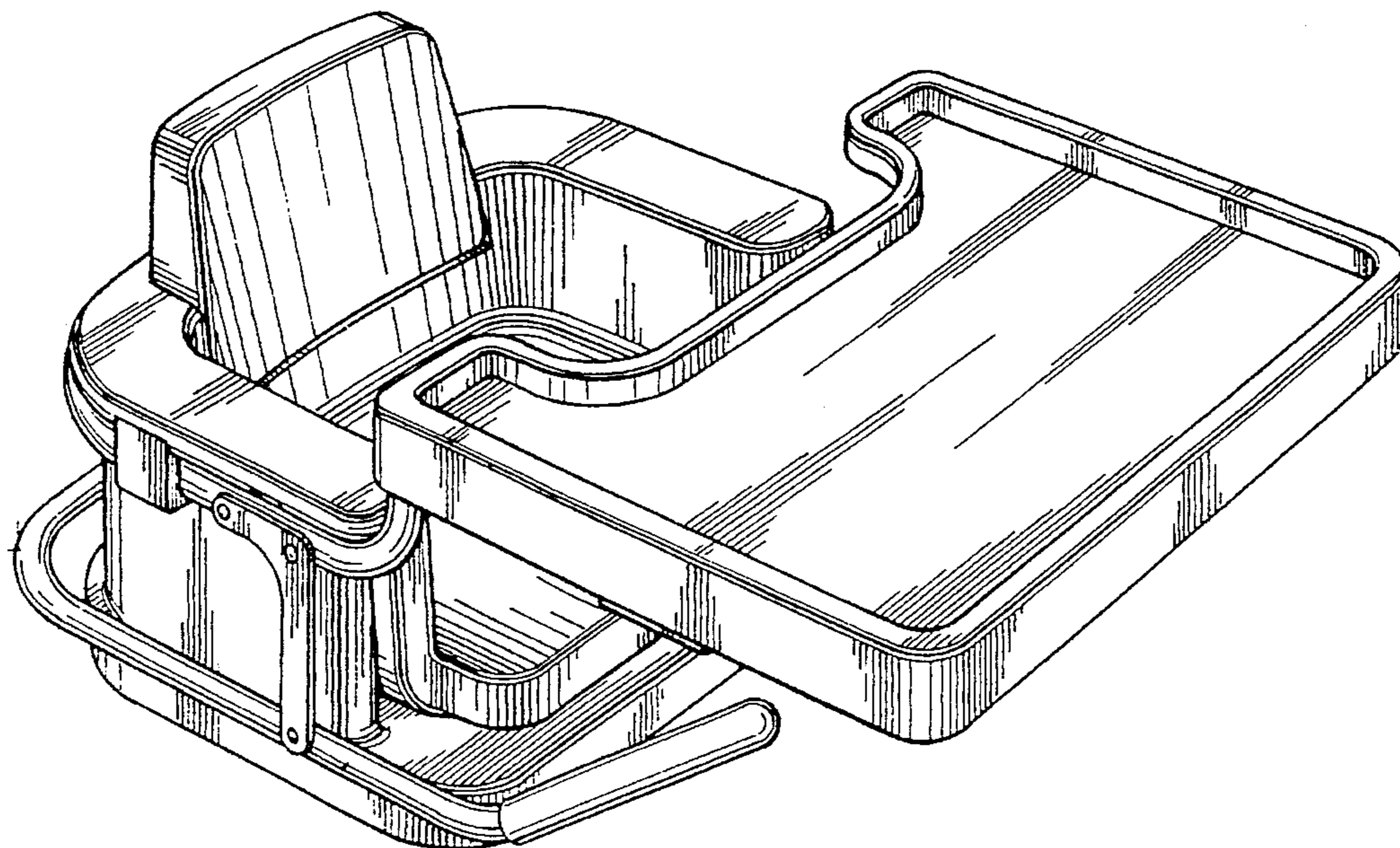

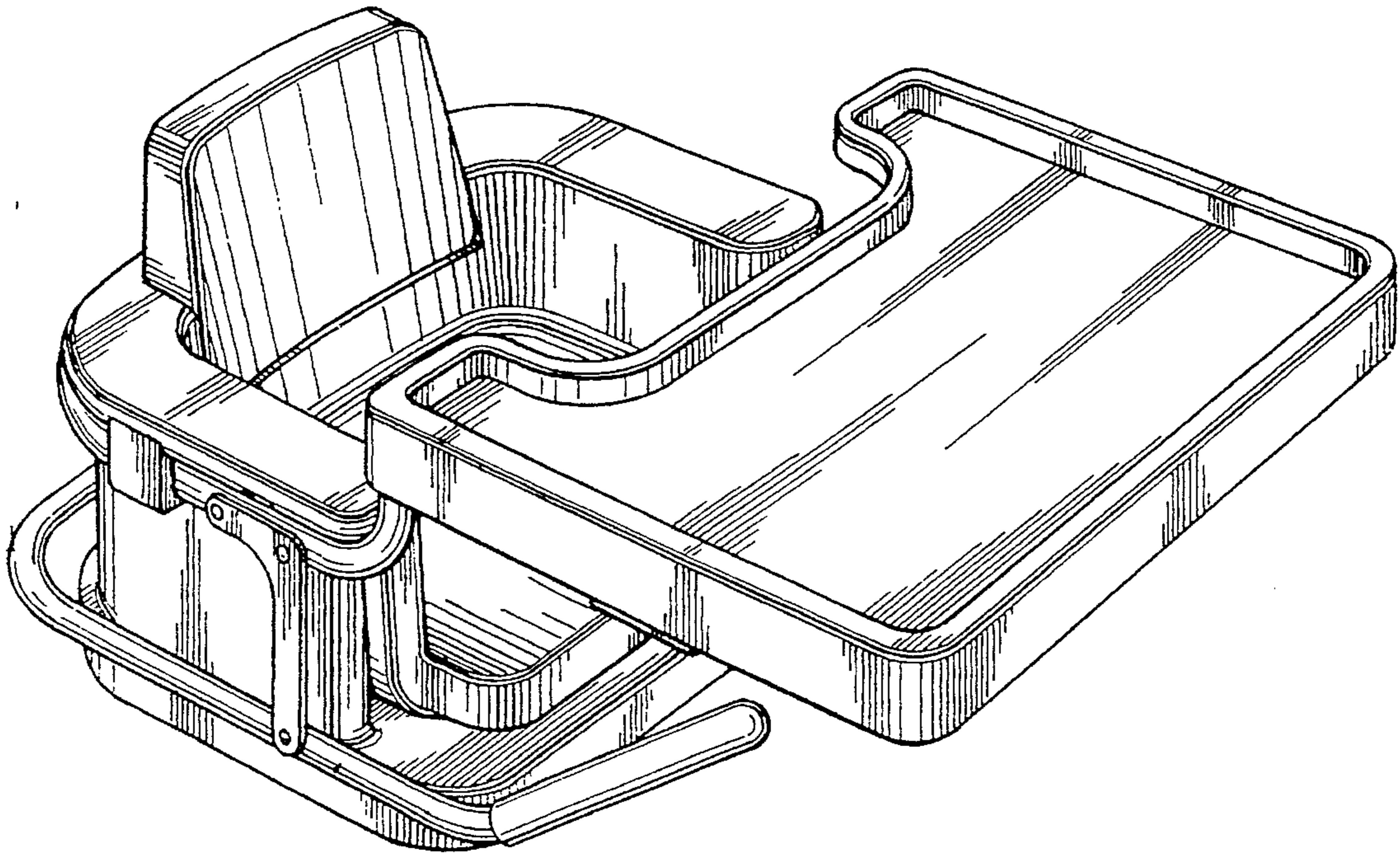

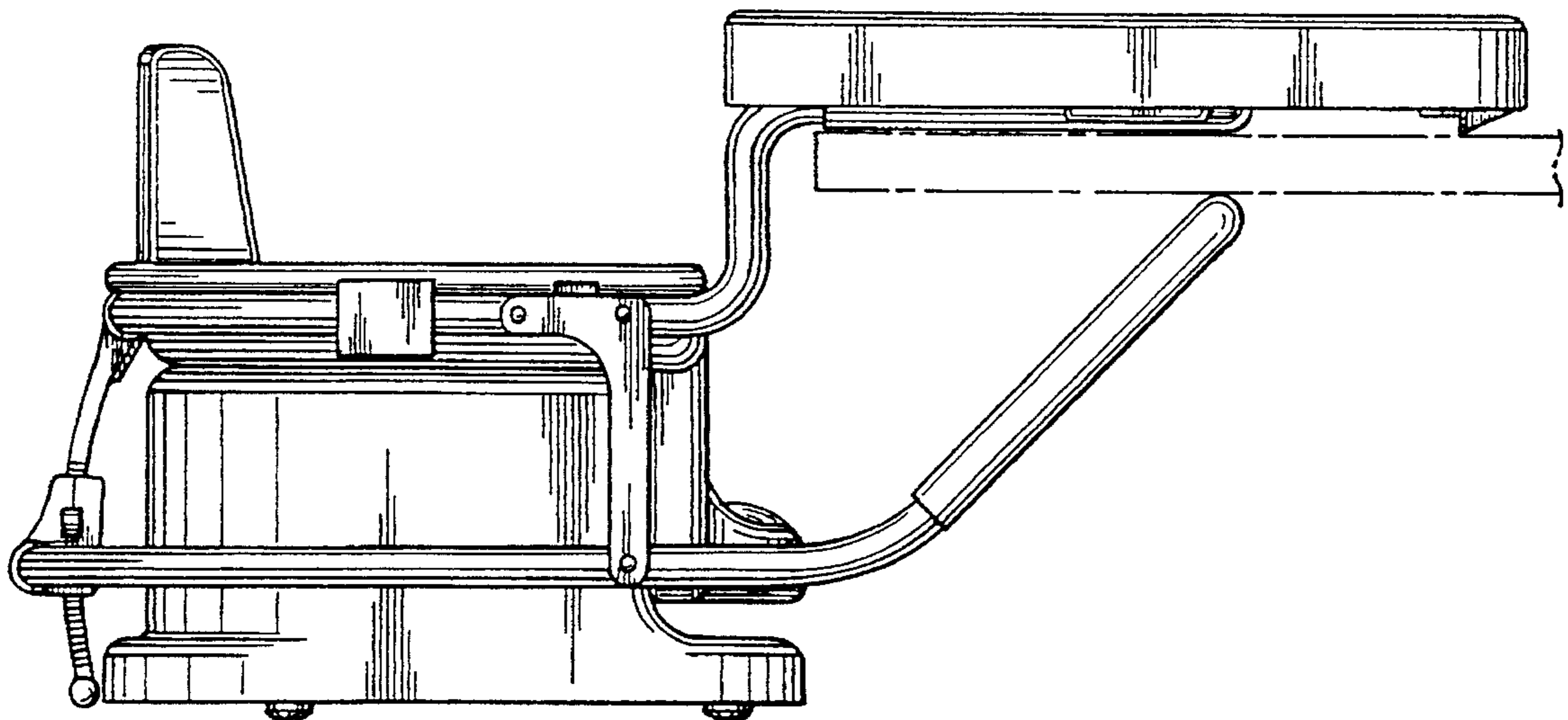

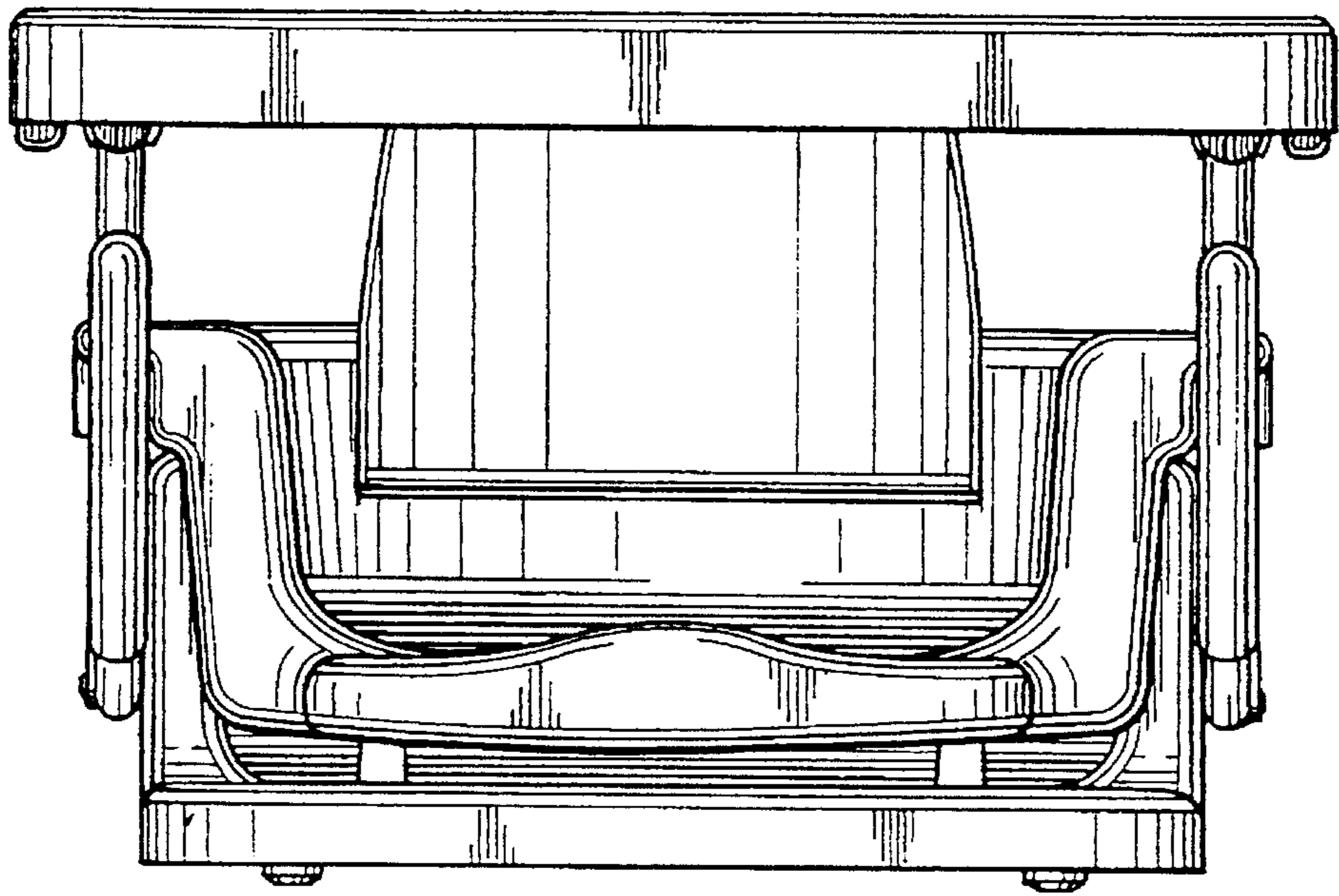

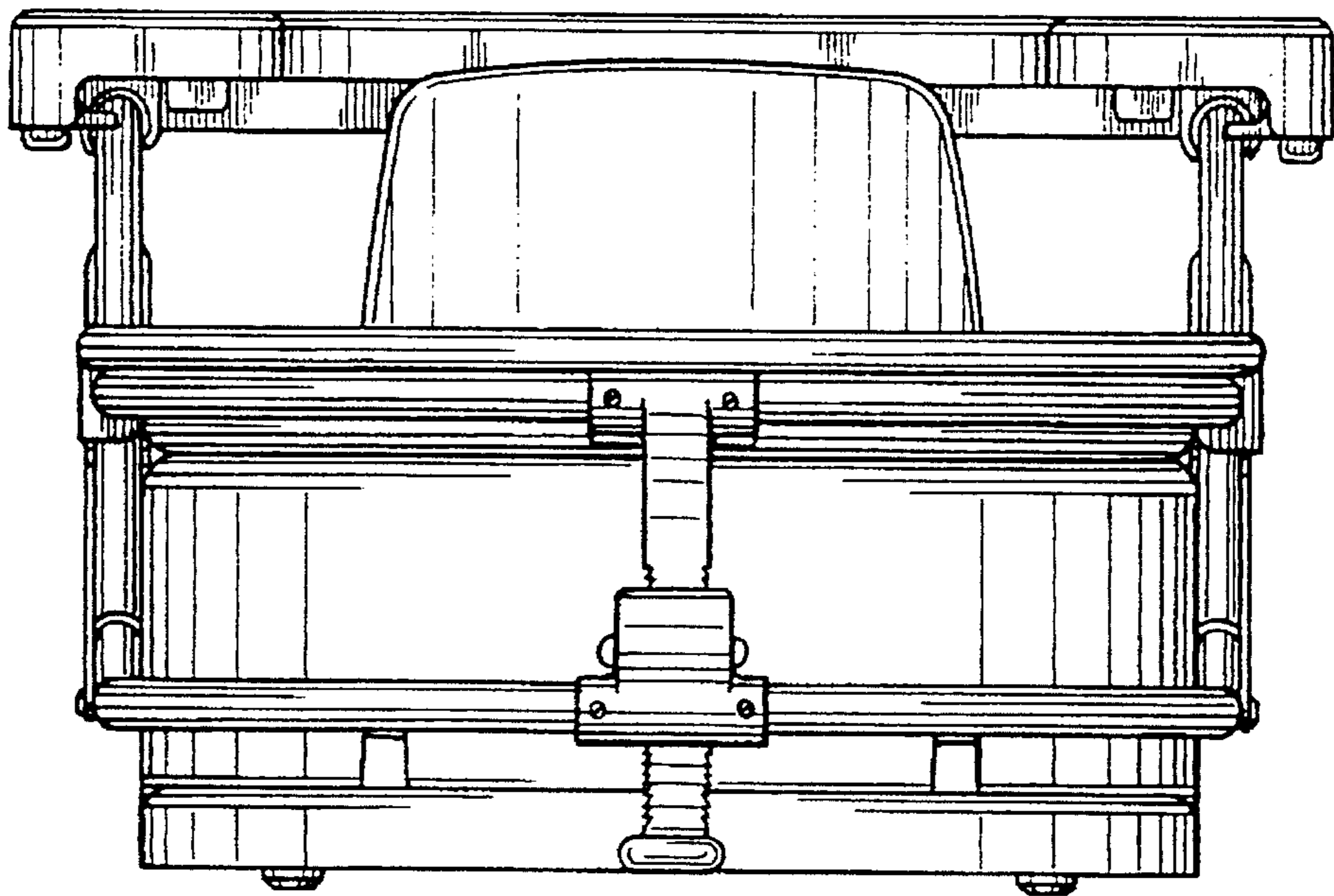

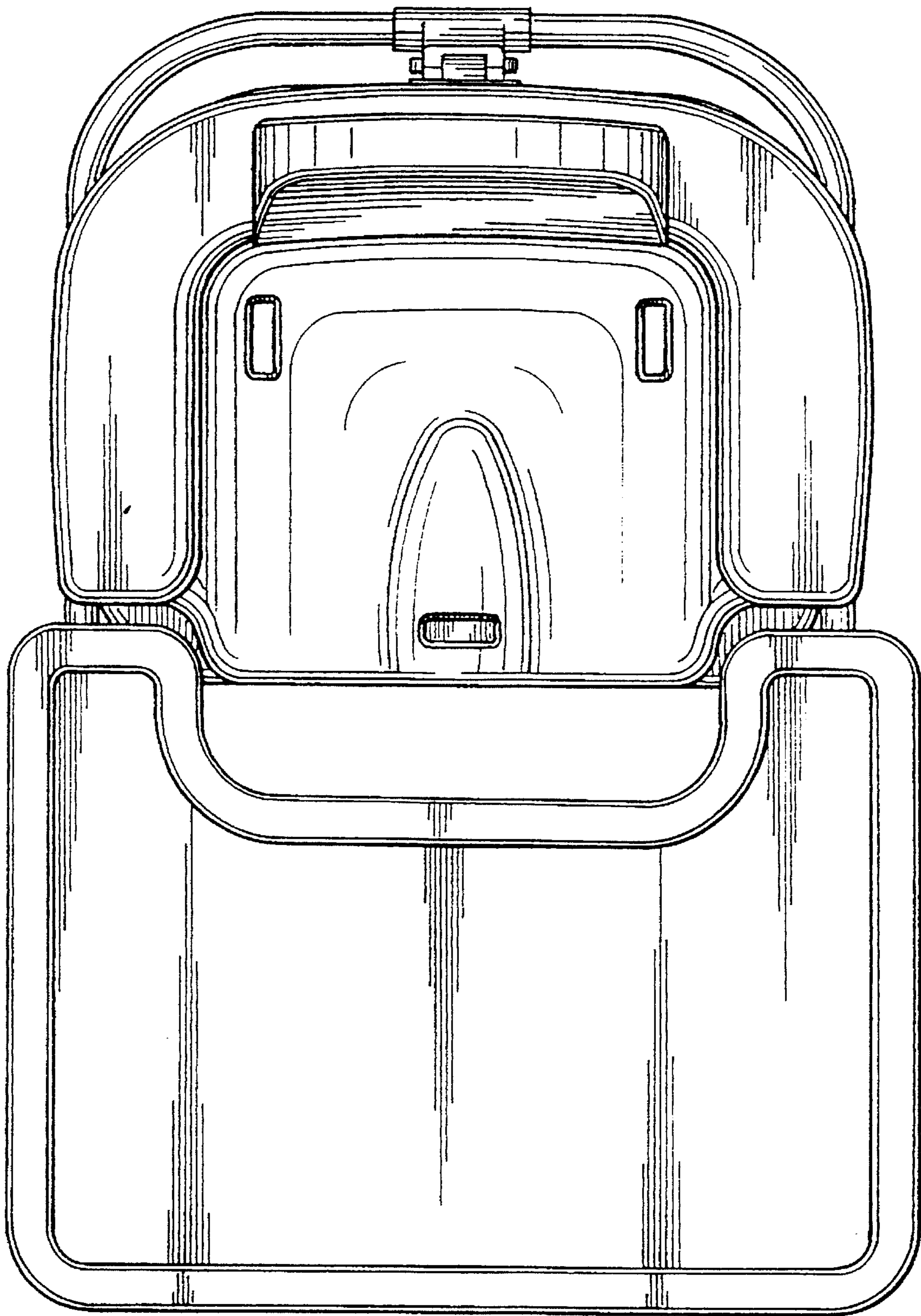

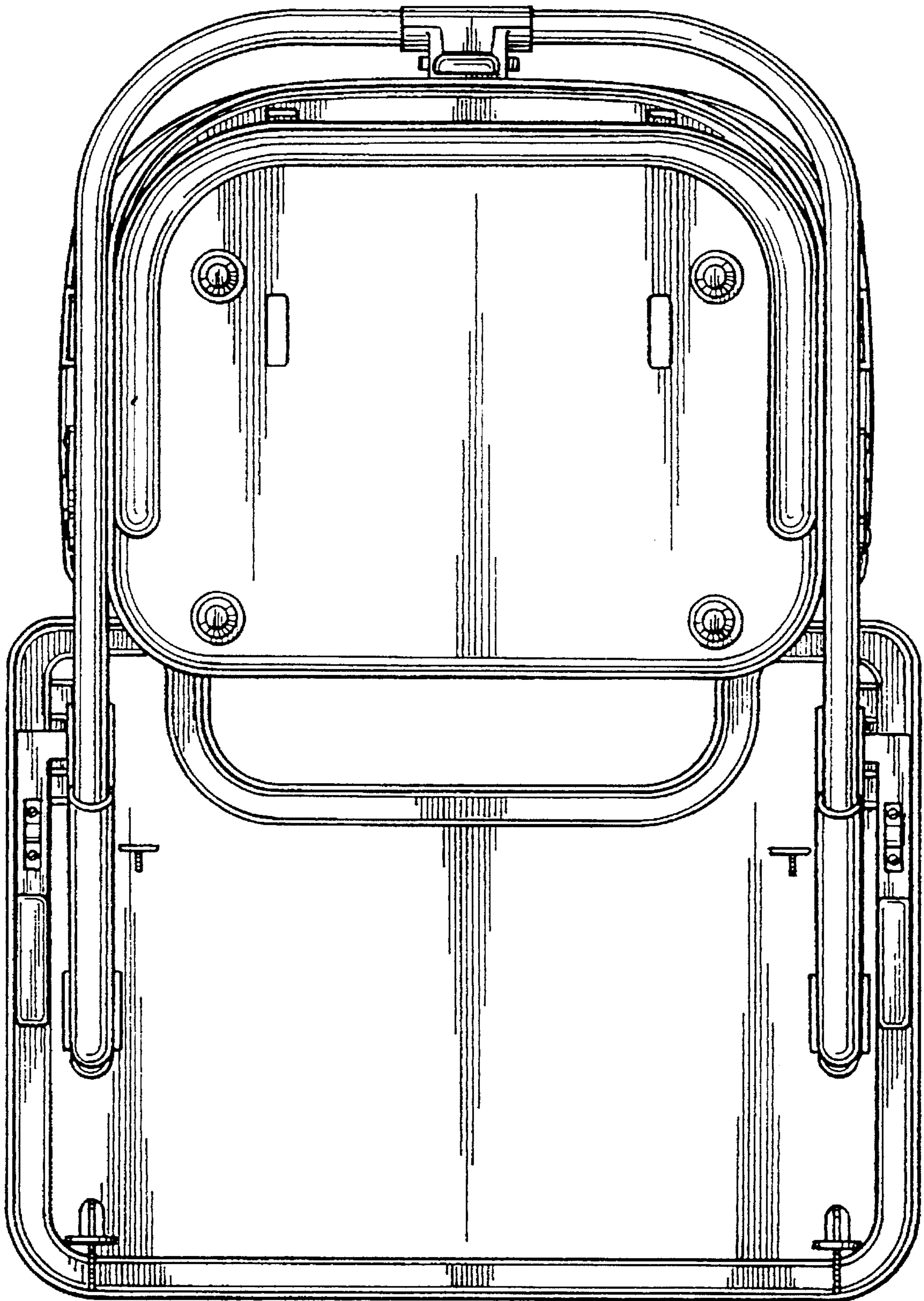

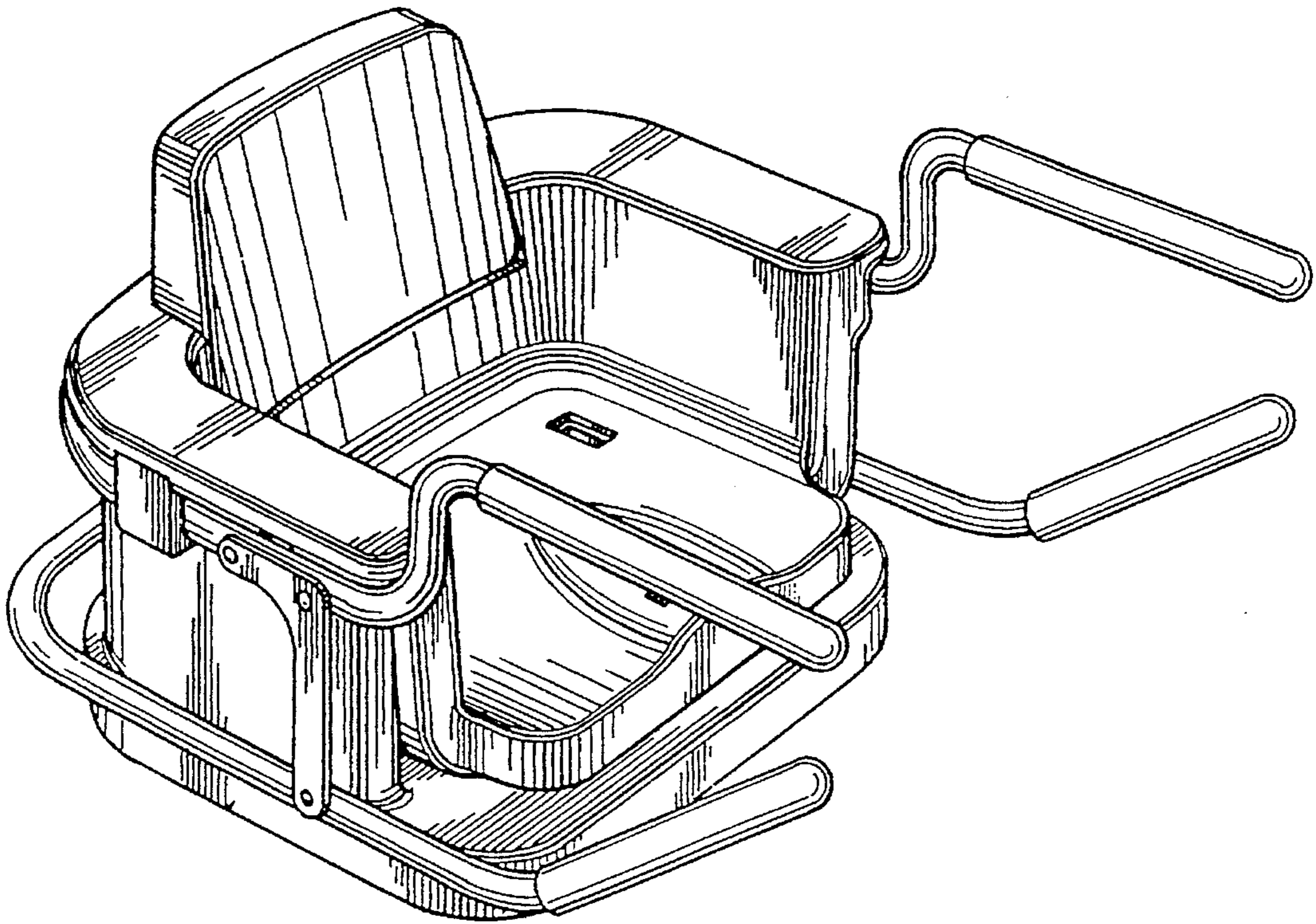

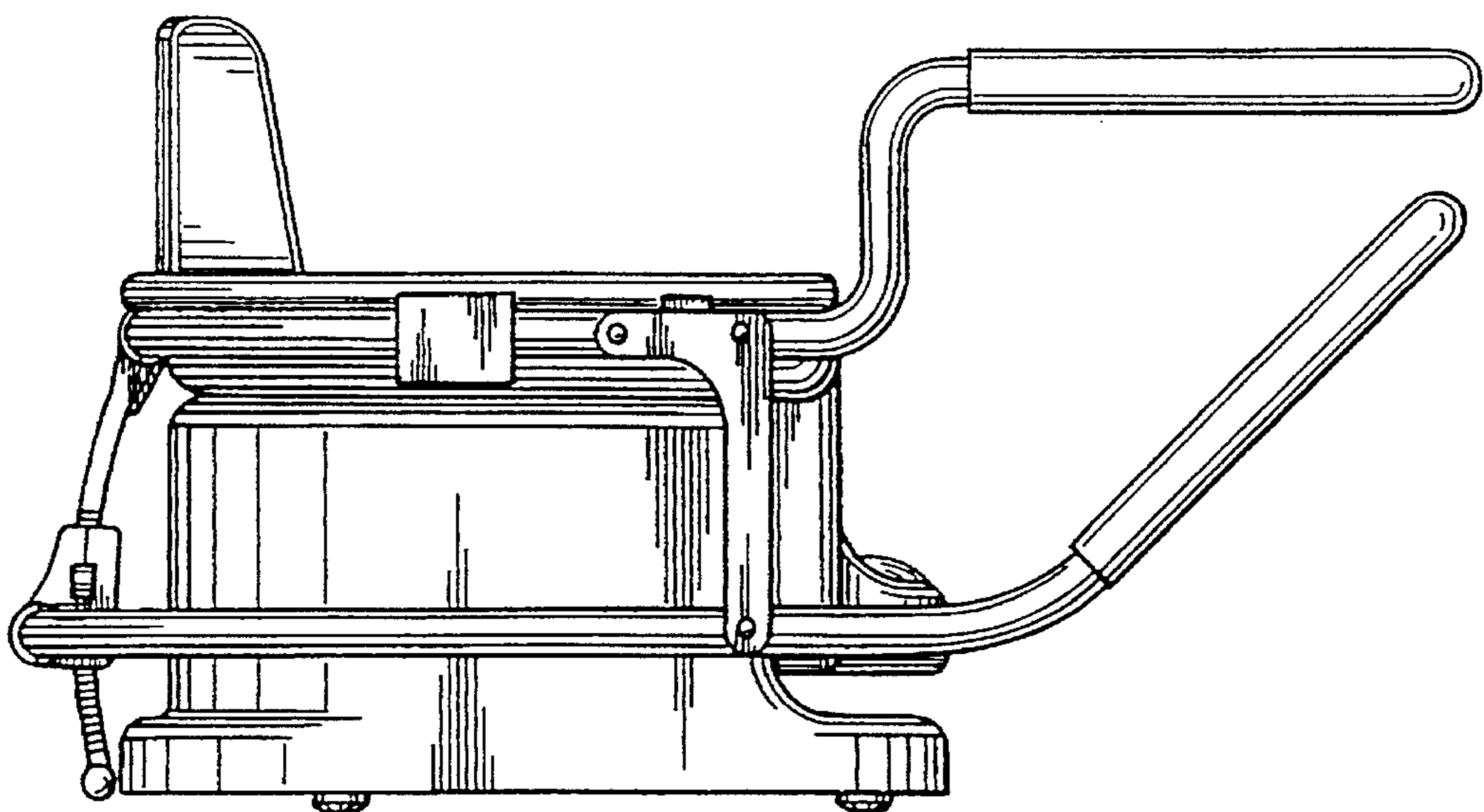

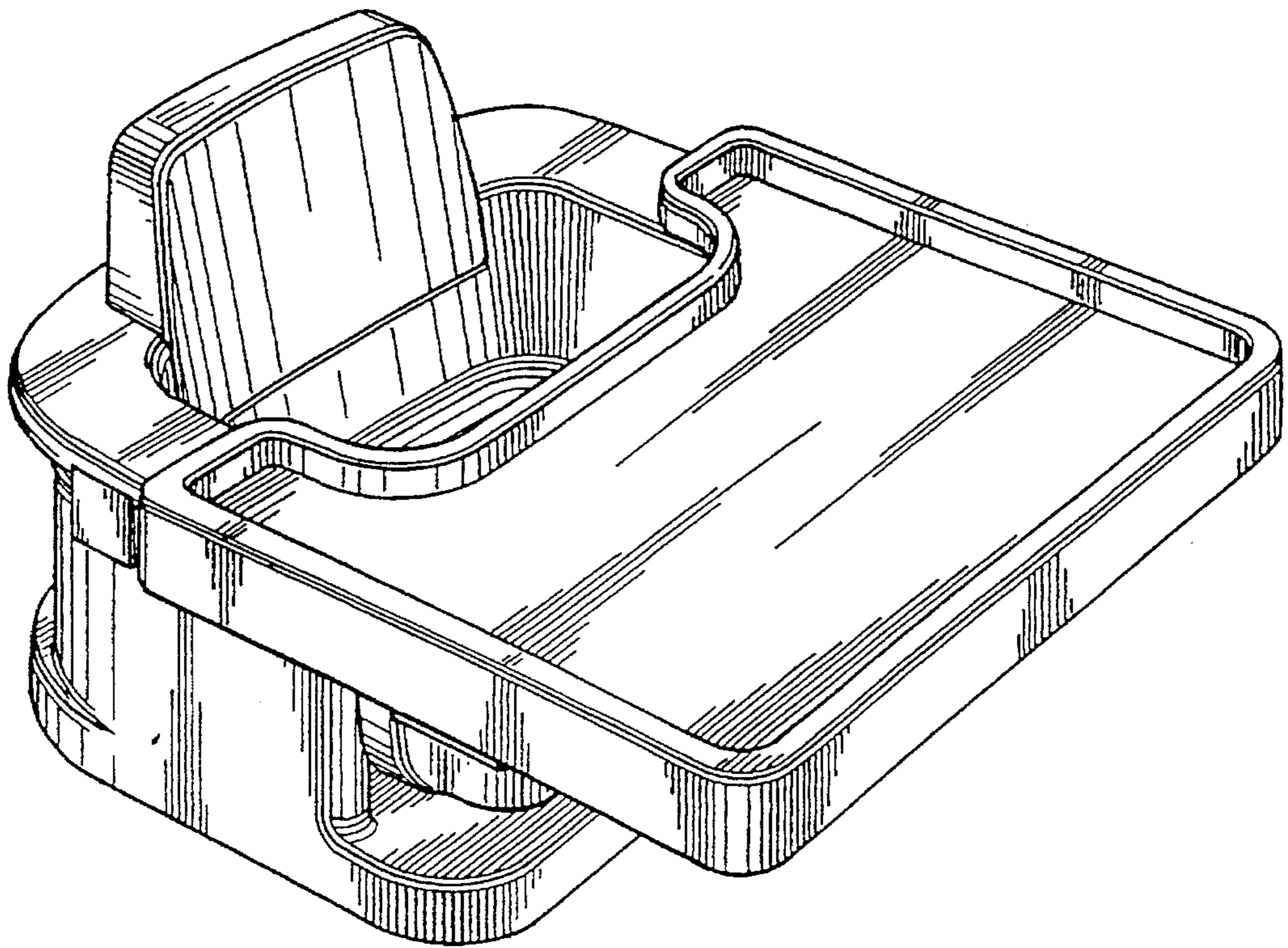

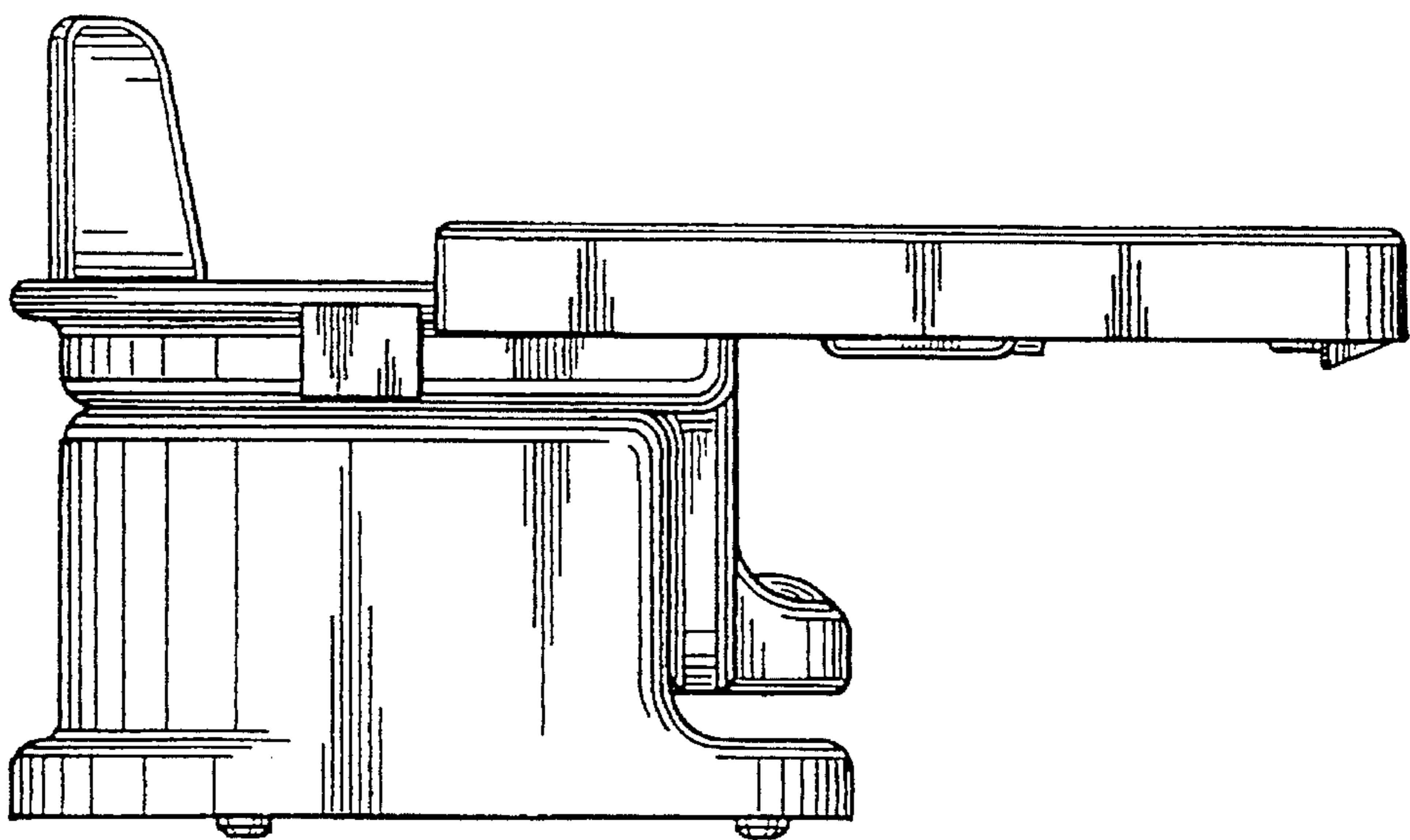

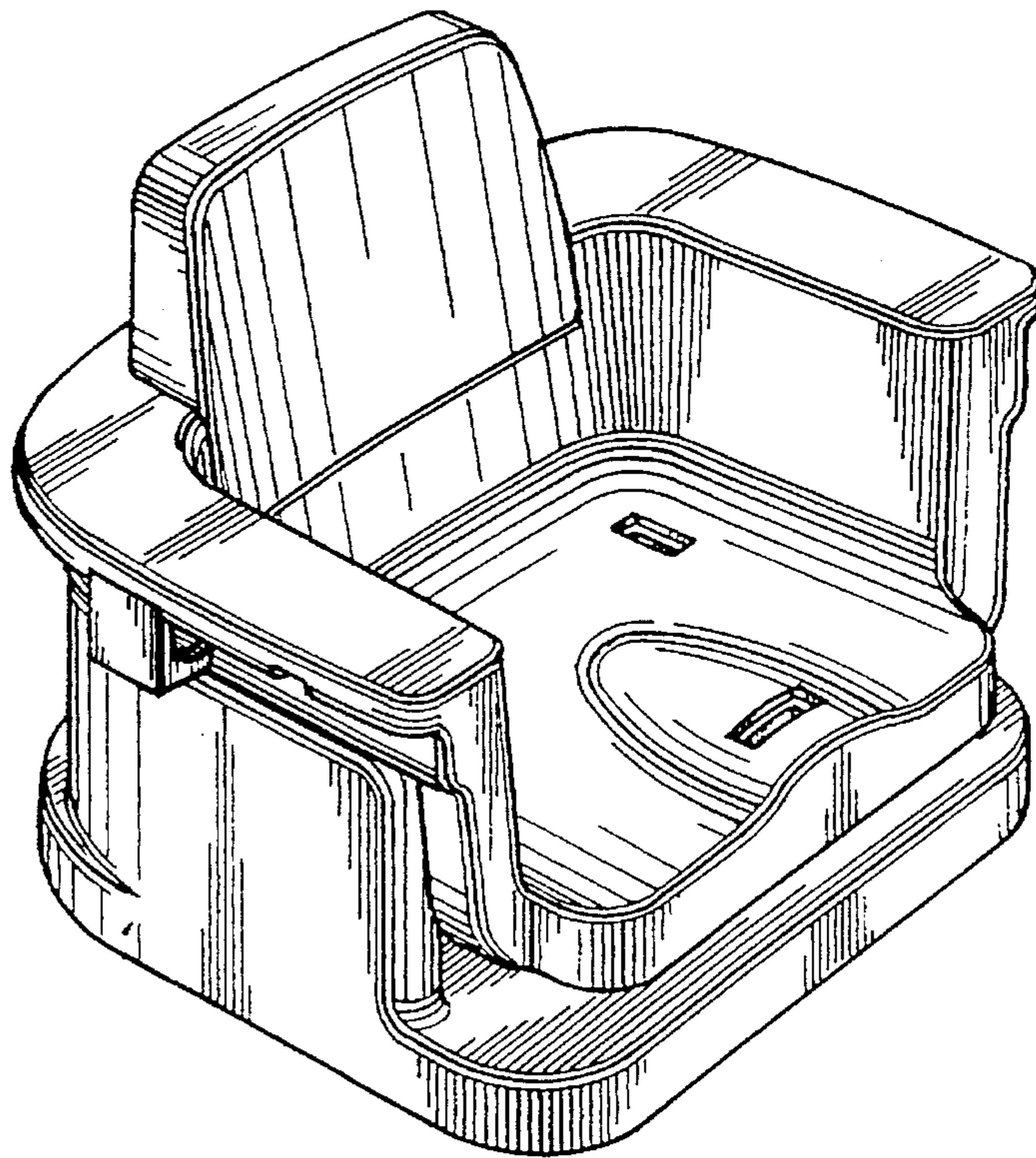

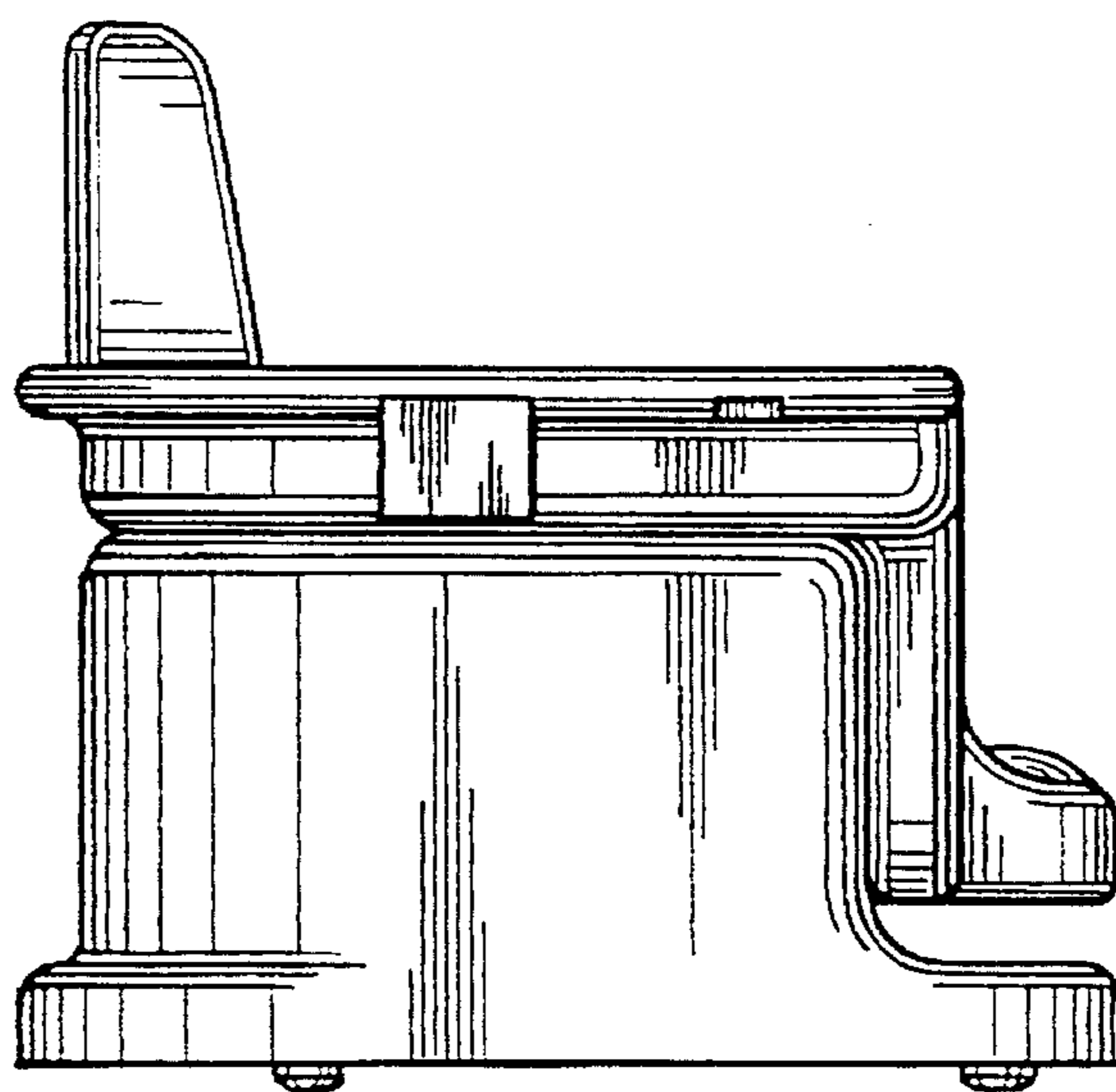
