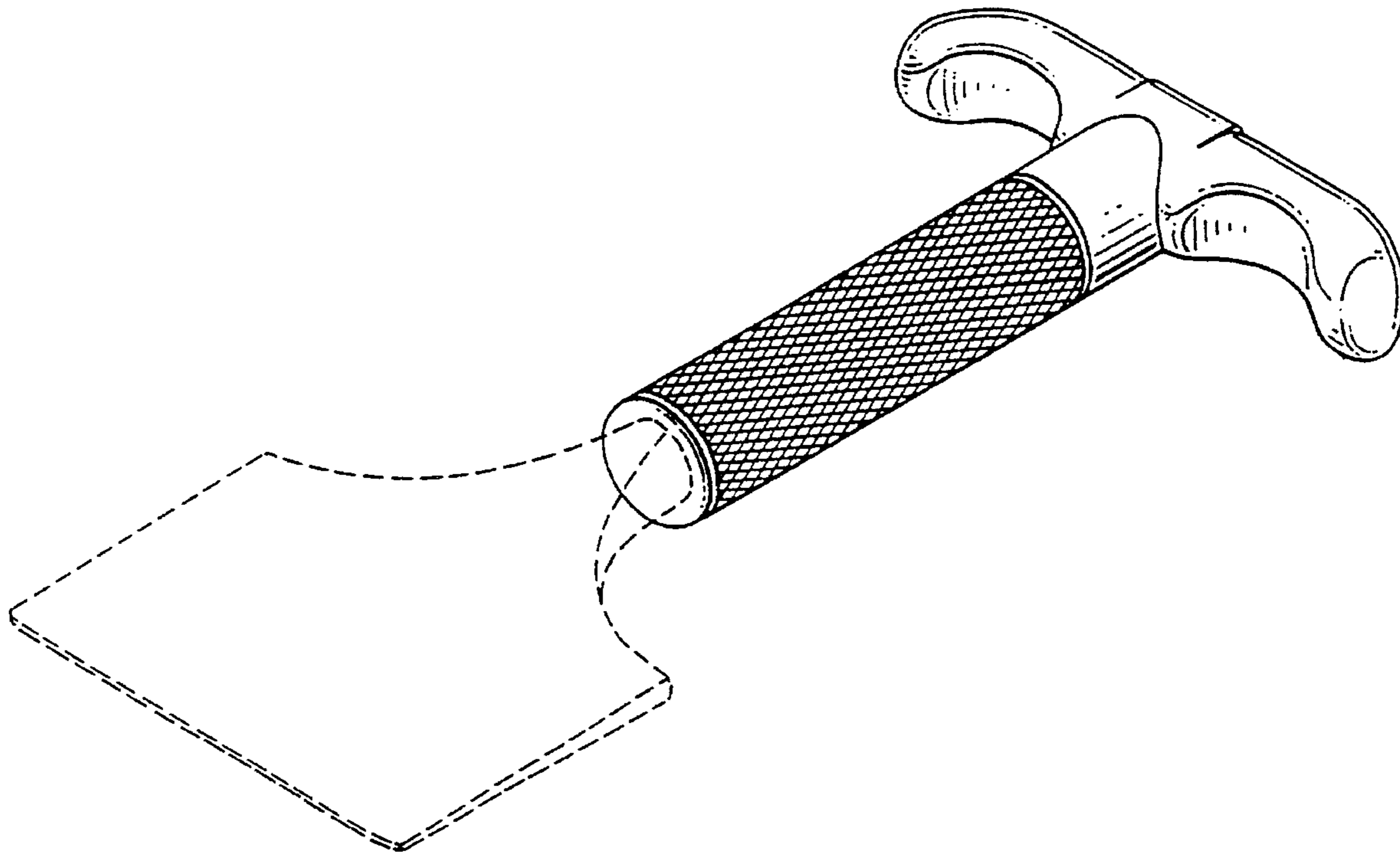
The ornamental design for a stair carpet tool handle, as shown and described.

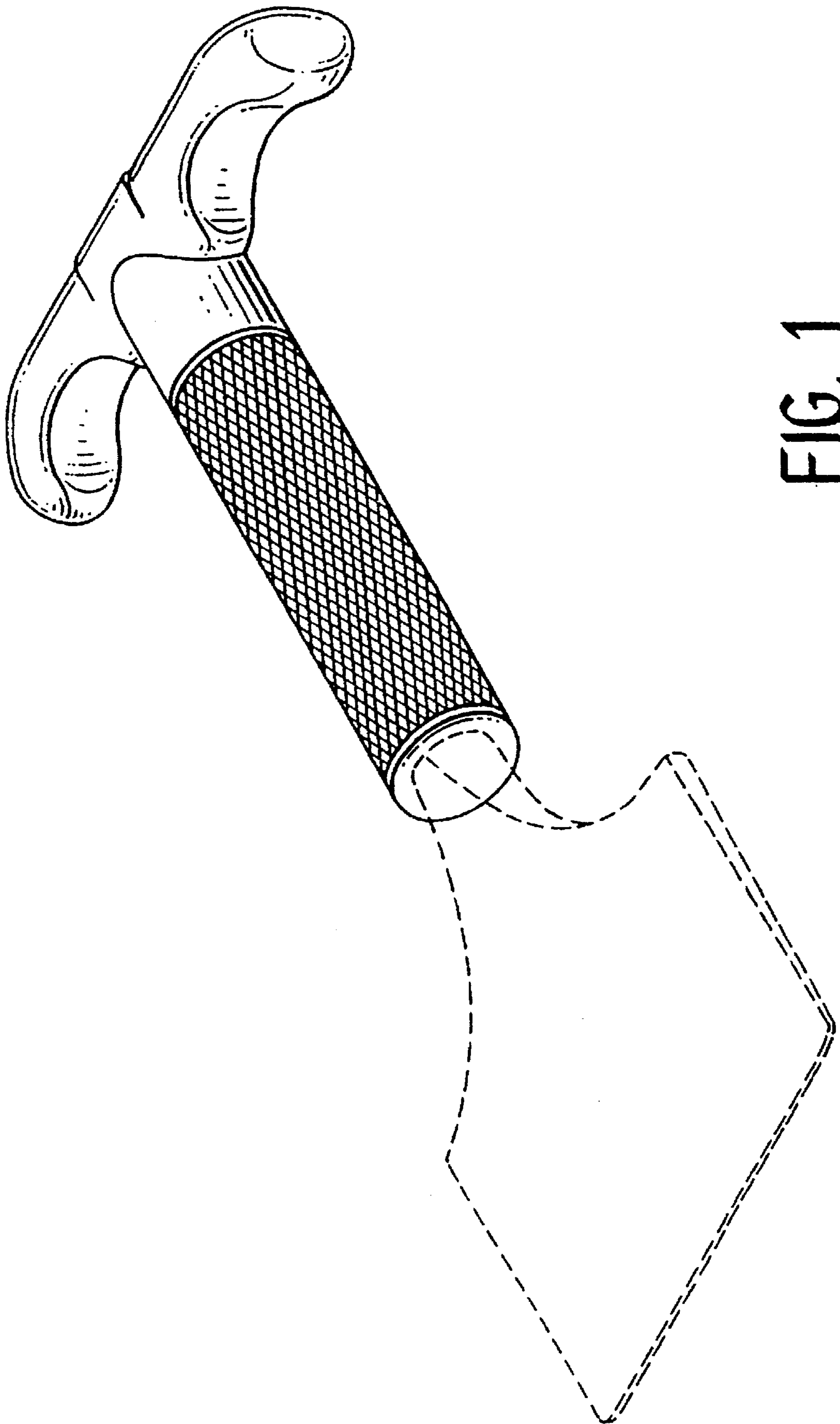
**DESCRIPTION**

FIG. 1 is a perspective view of a stair carpet tool handle showing my new design;  
FIG. 2 is a top plan view thereof;

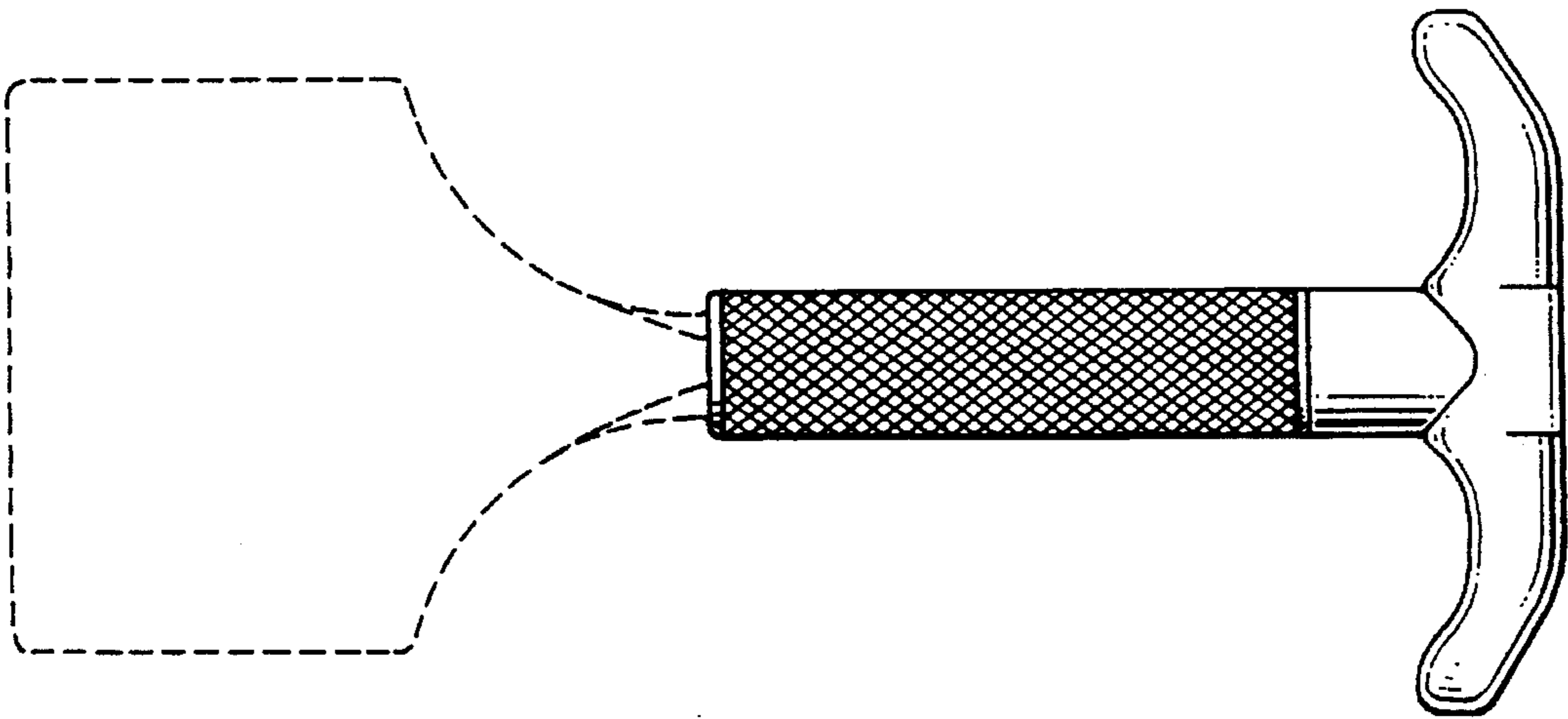

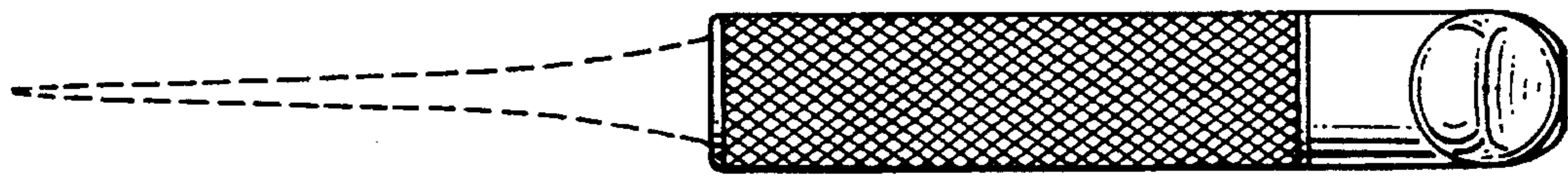

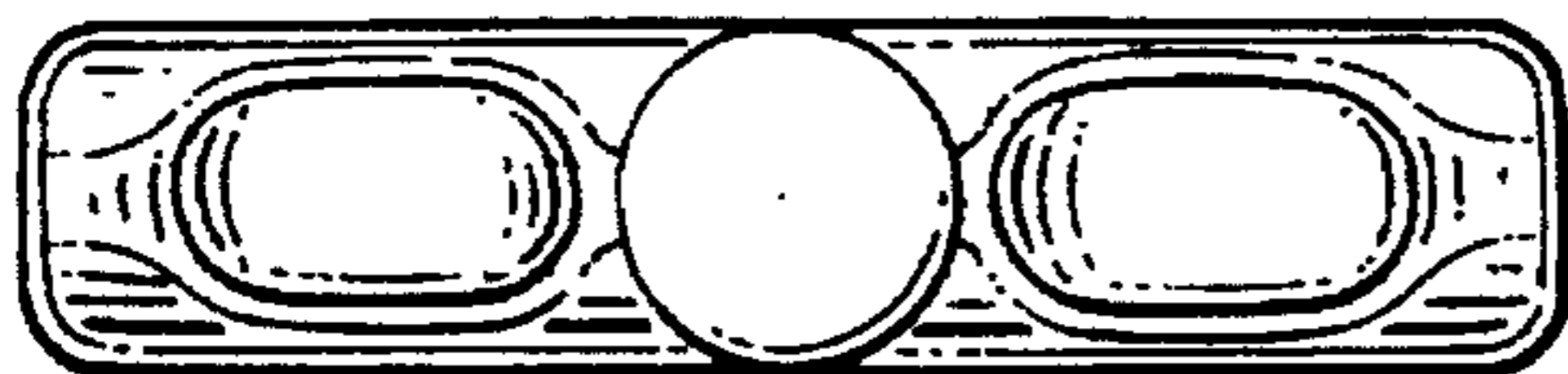
