The ornamental design for the wreath hanger, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of the wreath hanger of my invention;

FIG. 2 is a right side elevational view of the top most section of the wreath hanger illustrated in FIG. 1;

FIG. 3 is a front elevational view of the top most section of the wreath hanger illustrated in FIG. 1;

FIG. 4 is a rear elevational view of the top most section of the wreath hanger illustrated in FIG. 1;

FIG. 5 is a top view of the top most section of the wreath hanger illustrated in FIG. 2;

FIG. 6 is a bottom view of the top most section of the wreath hanger illustrated in FIG. 2;

FIG. 7 is a right-side elevational view of the middle section of the wreath hanger illustrated in FIG. 1;

FIG. 8 is a rear elevational view of the middle section of the wreath hanger illustrated in FIG. 1;

FIG. 9 is a front elevational view of the middle section of the wreath hanger illustrated in FIG. 1;

FIG. 10 is a top view of the middle section of the wreath hanger illustrated in FIG. 8;

FIG. 11 is a bottom view of the middle section of the wreath hanger illustrated in FIG. 8;

FIG. 12 is a left-side elevational view of the bottom-most section of the wreath hanger illustrated in FIG. 1;

FIG. 13 is a front elevational view of the bottom-most section of the wreath hanger illustrated in FIG. 1;

FIG. 14 is a rear elevational view of the bottom-most section of the wreath hanger illustrated in FIG. 1;

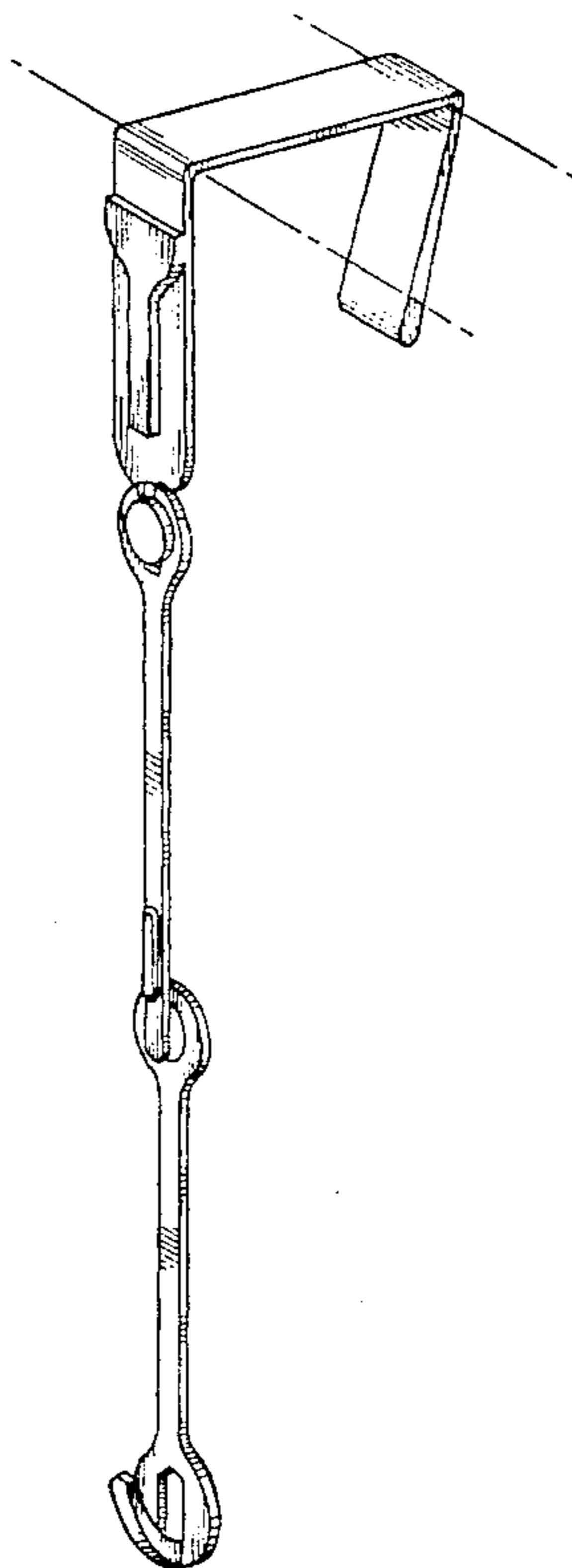
FIG. 15 is a top view of the bottom-most section of the wreath hanger illustrated in FIG. 12; and,

FIG. 16 is a bottom view of the bottom-most section of the wreath hanger illustrated in FIG. 12.

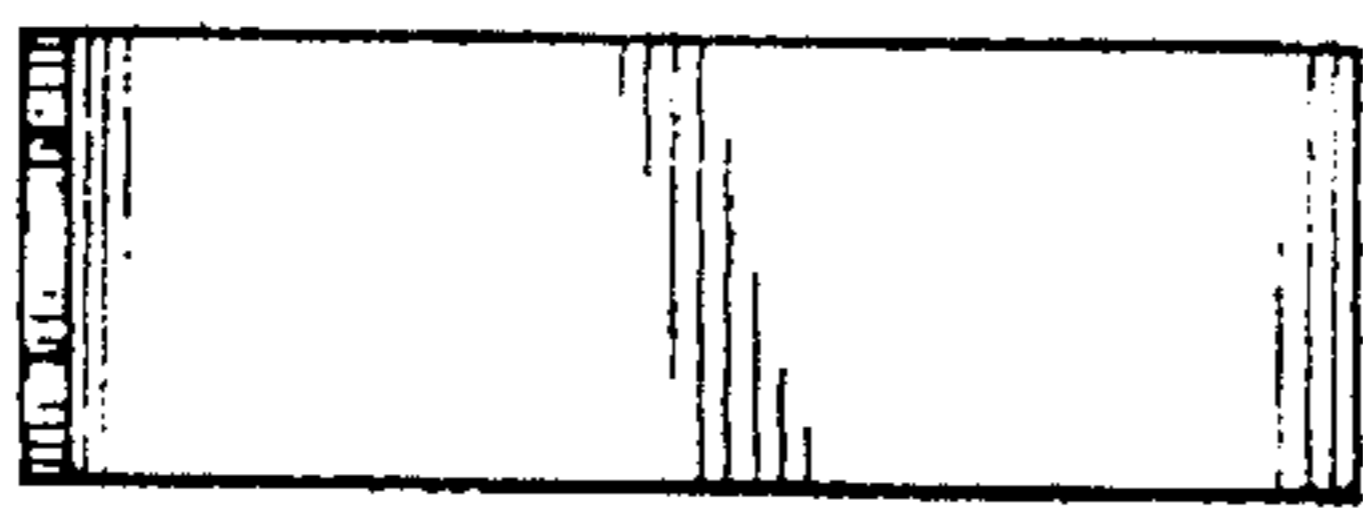
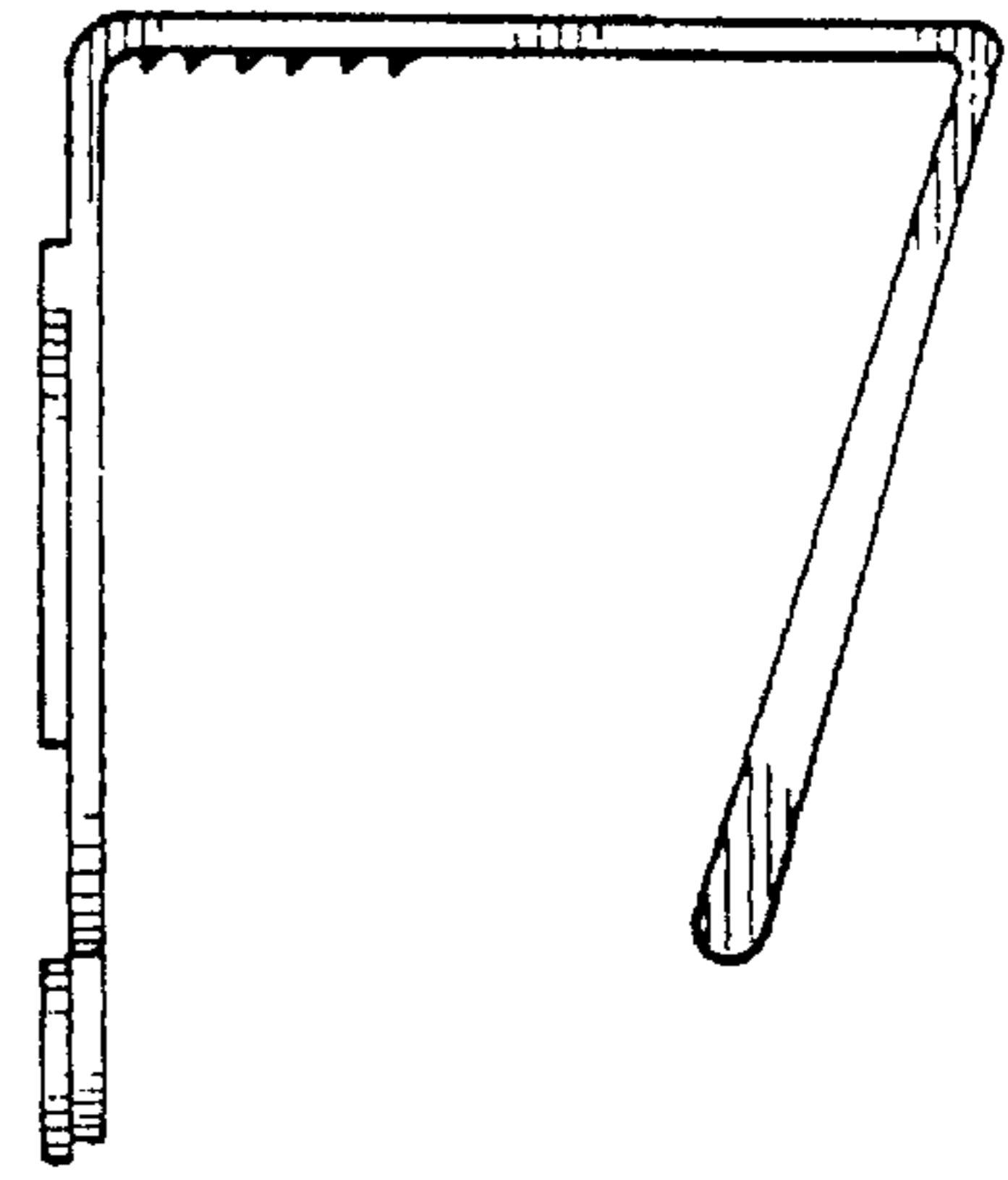
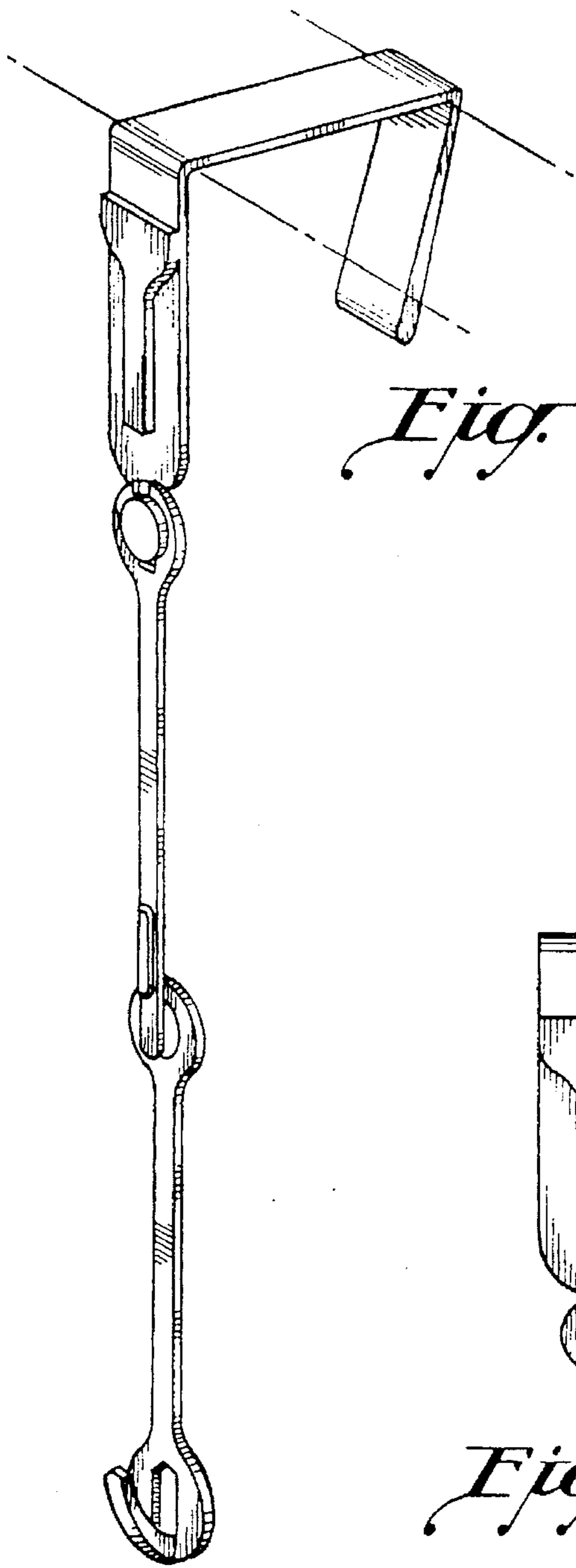
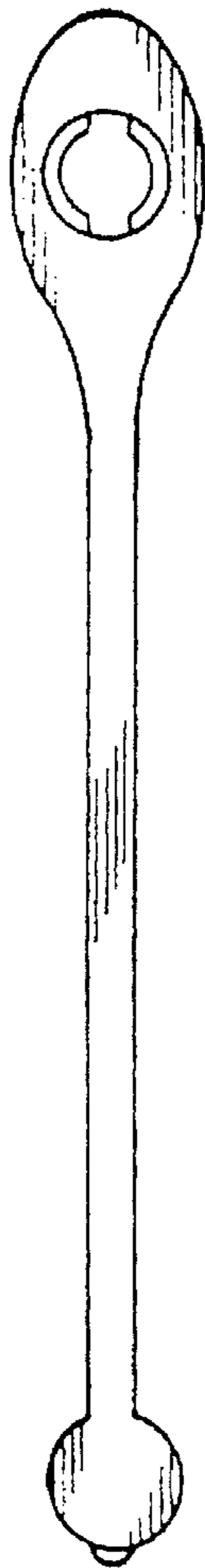

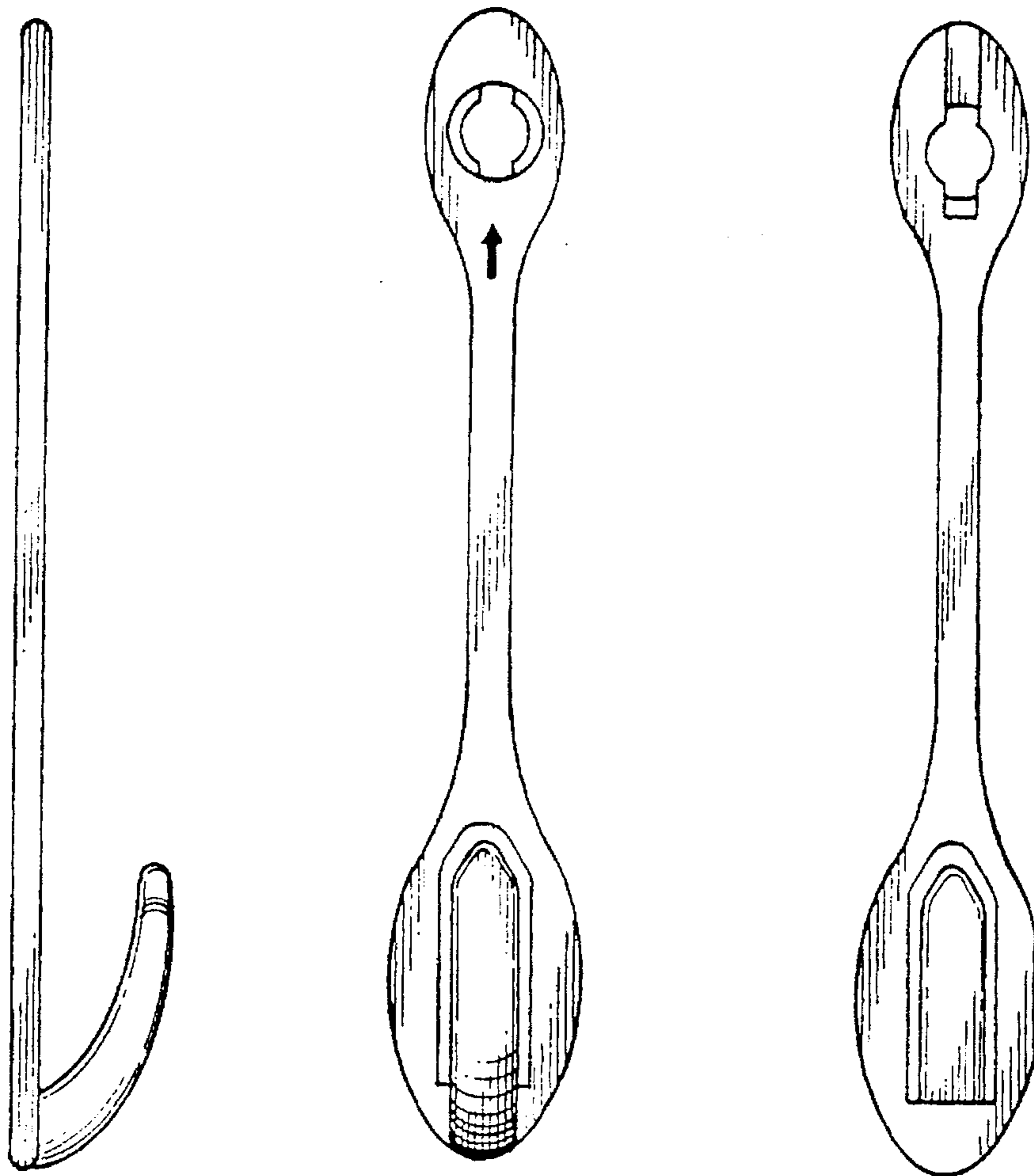

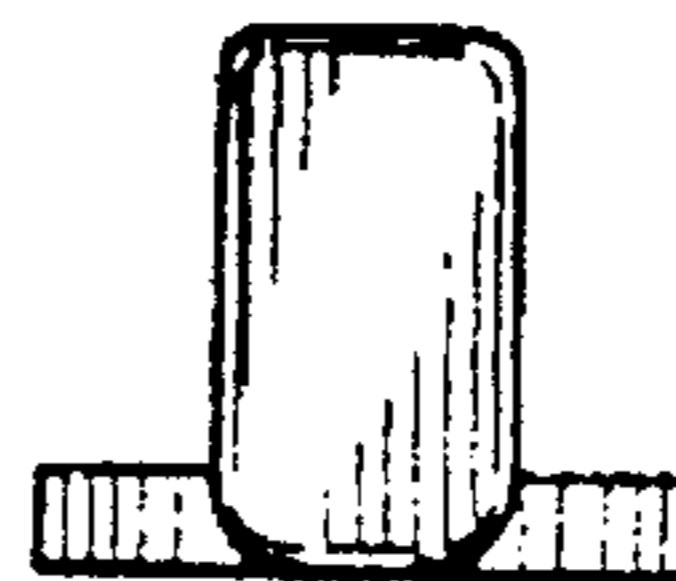
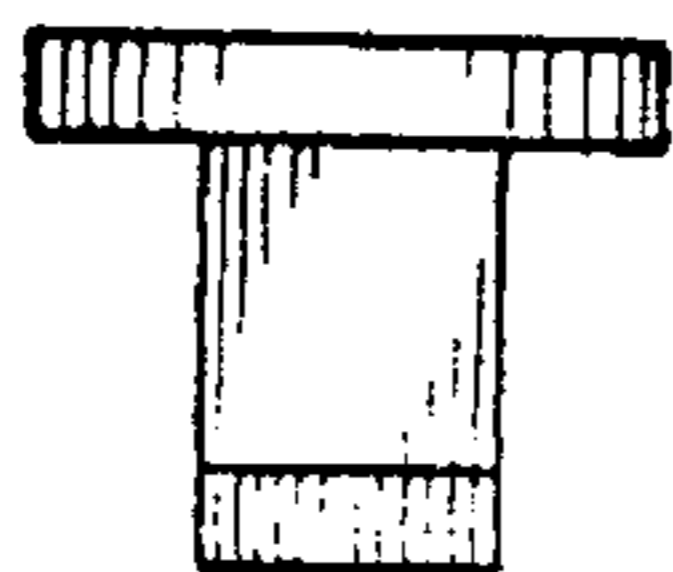
