DESCRIPTION

FIG. 17 is a rear perspective view of FIG. 16;

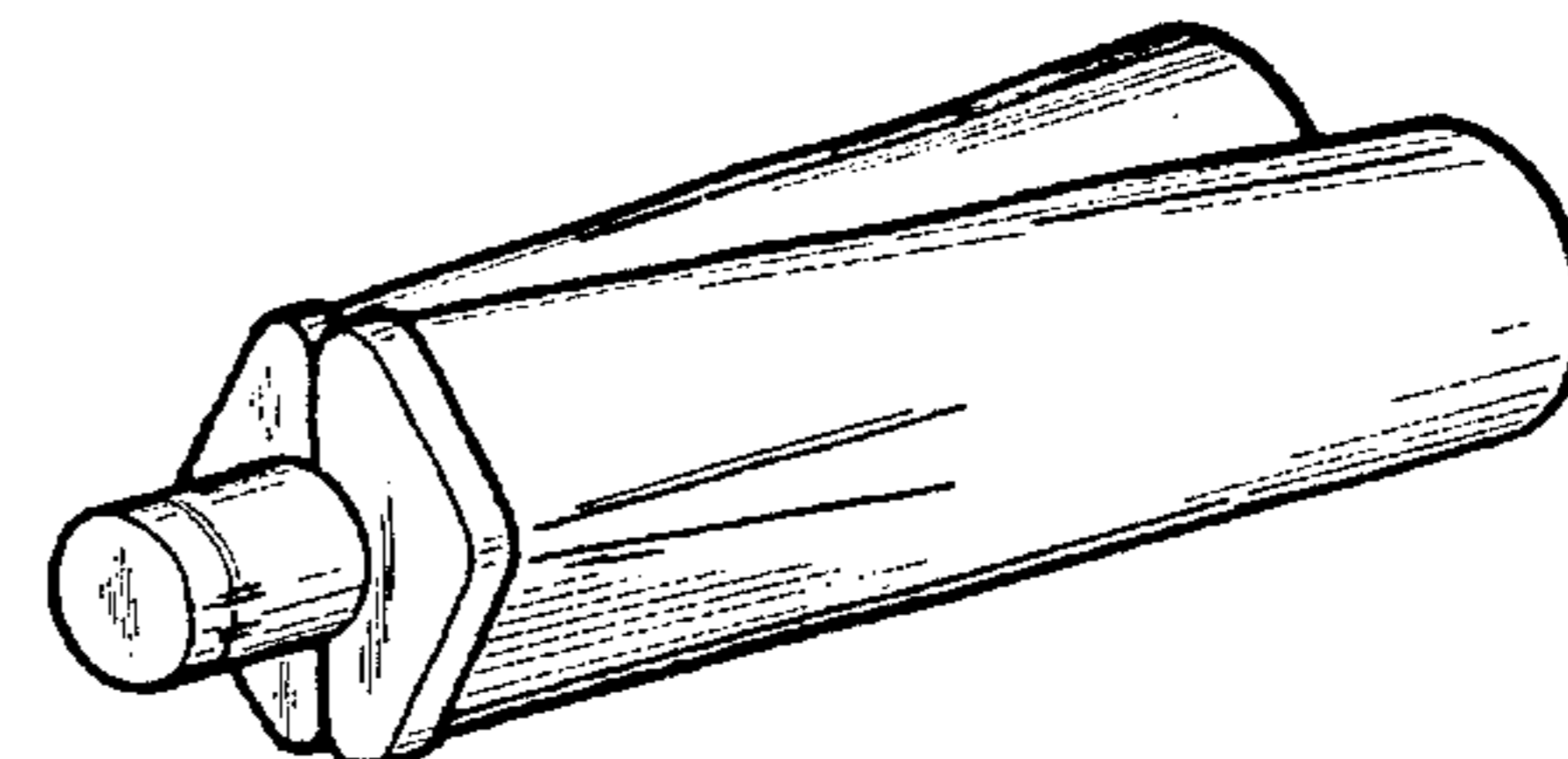
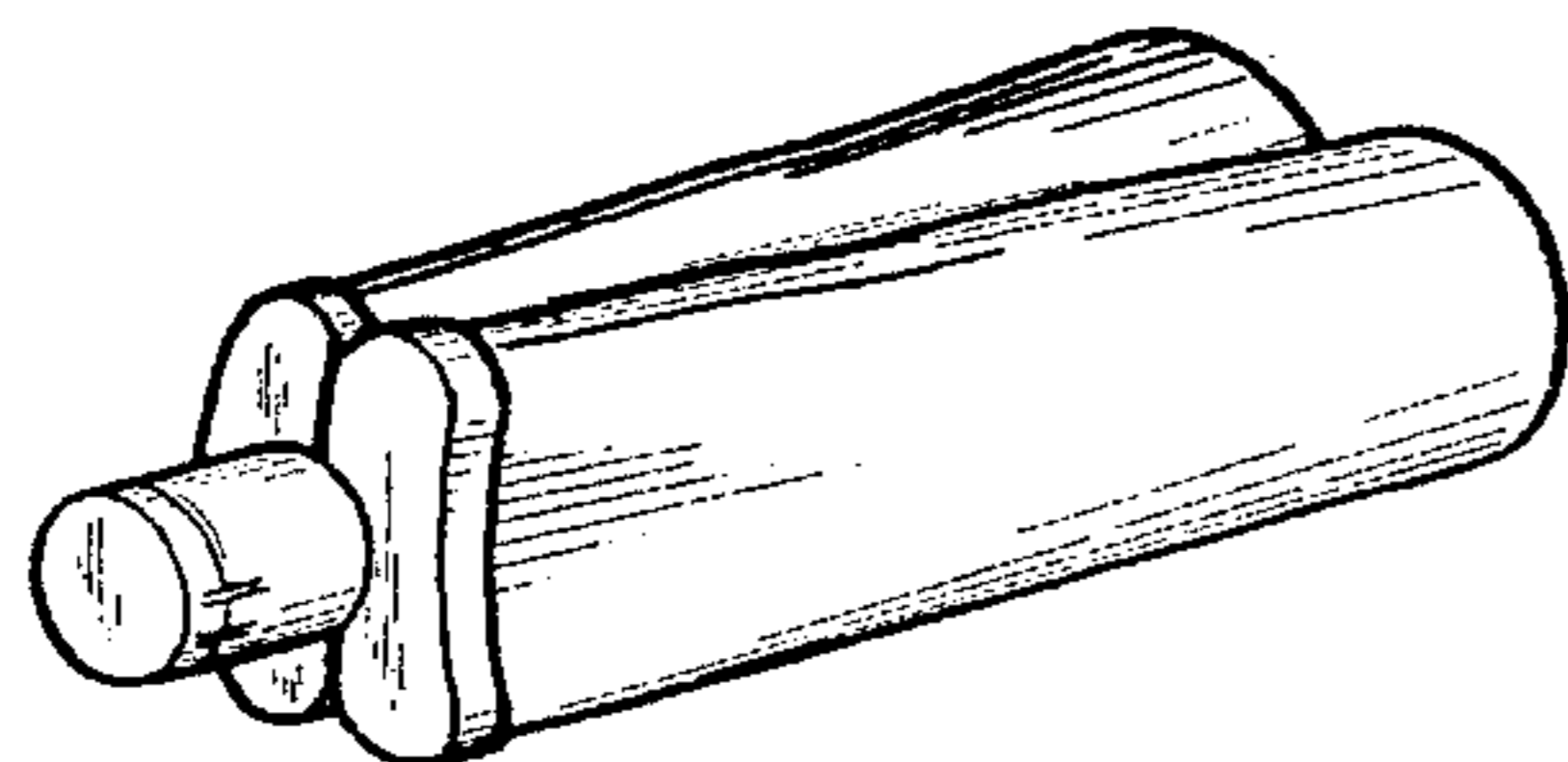
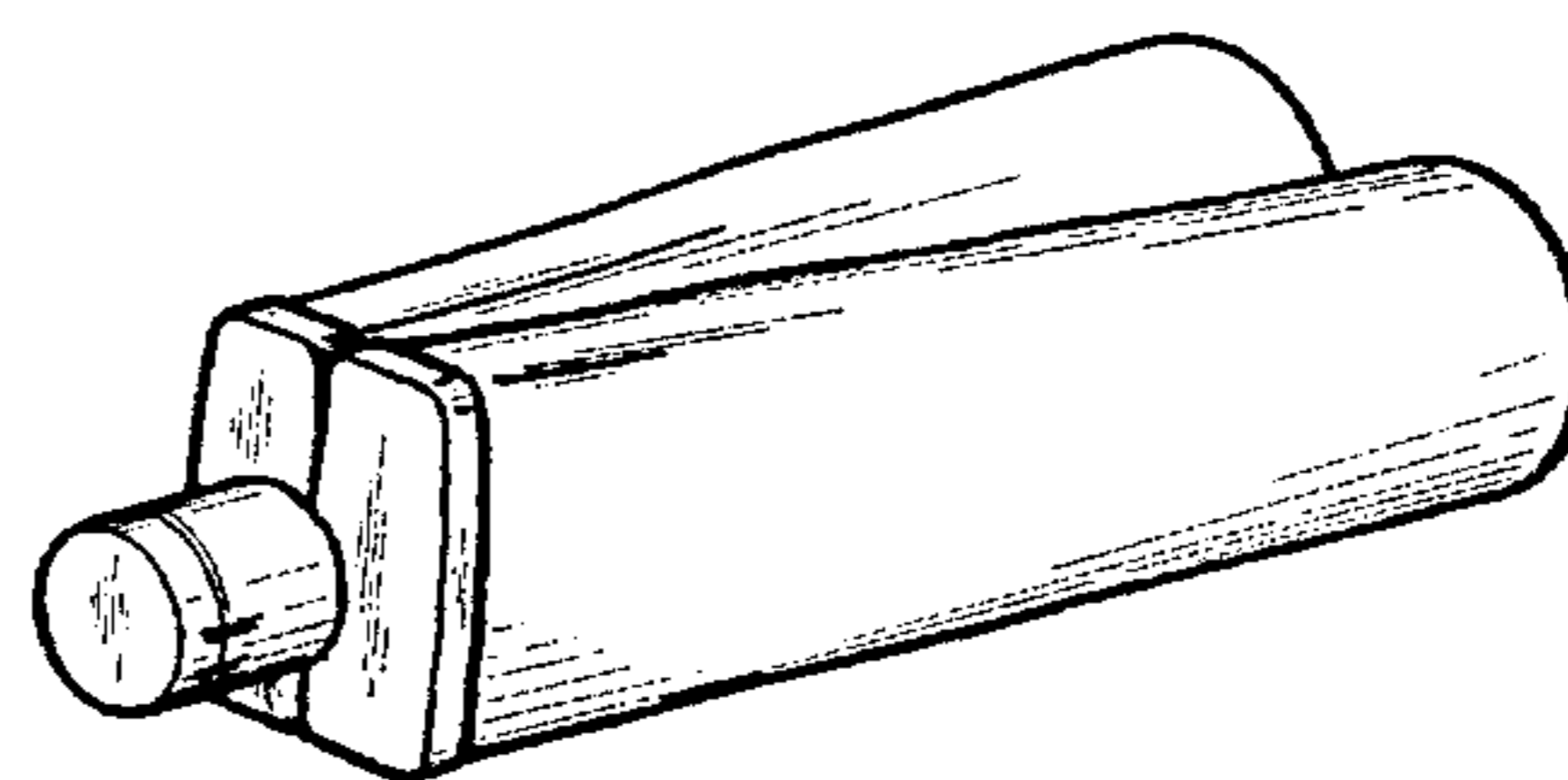
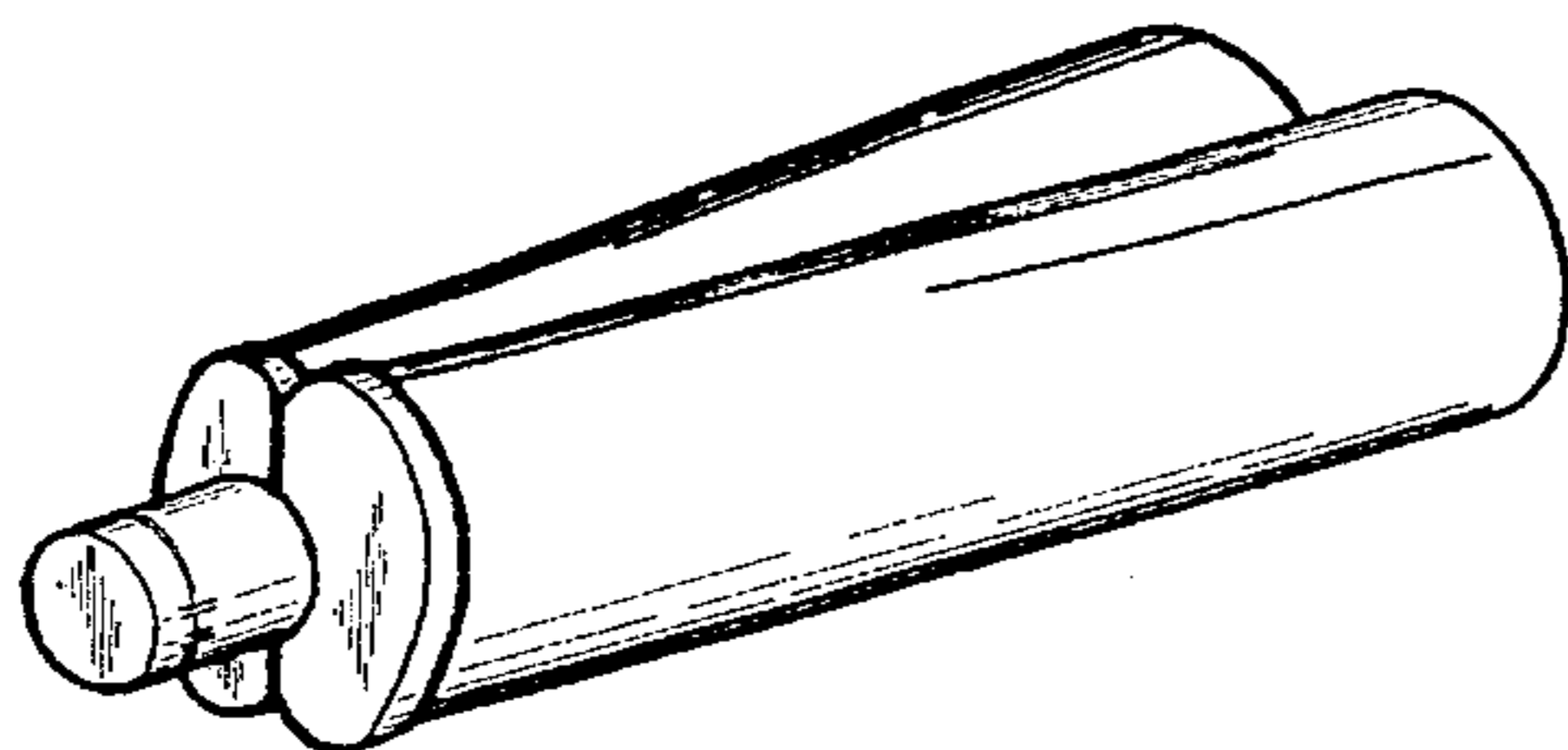


FIG. 18 is a front elevational view of FIG. 16;

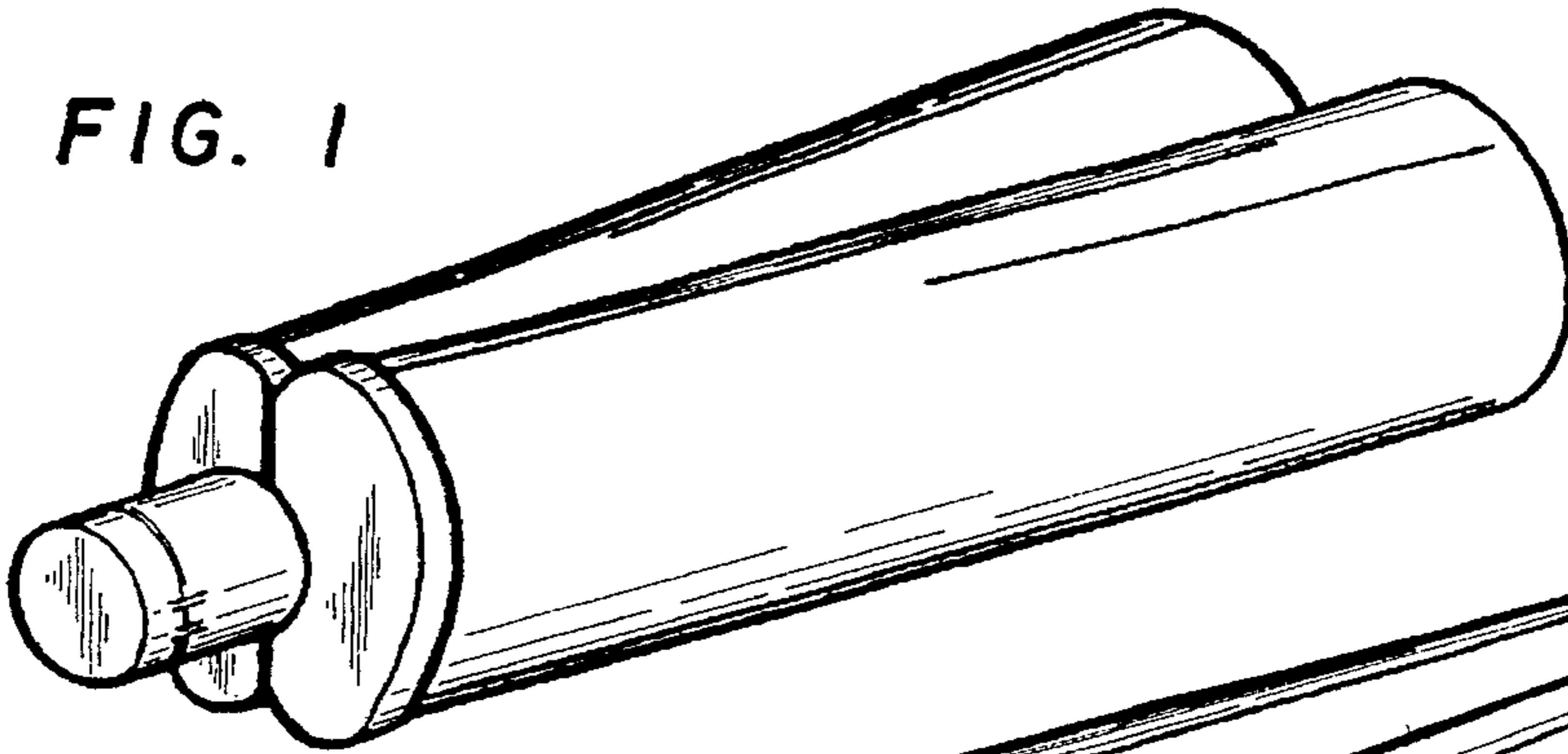

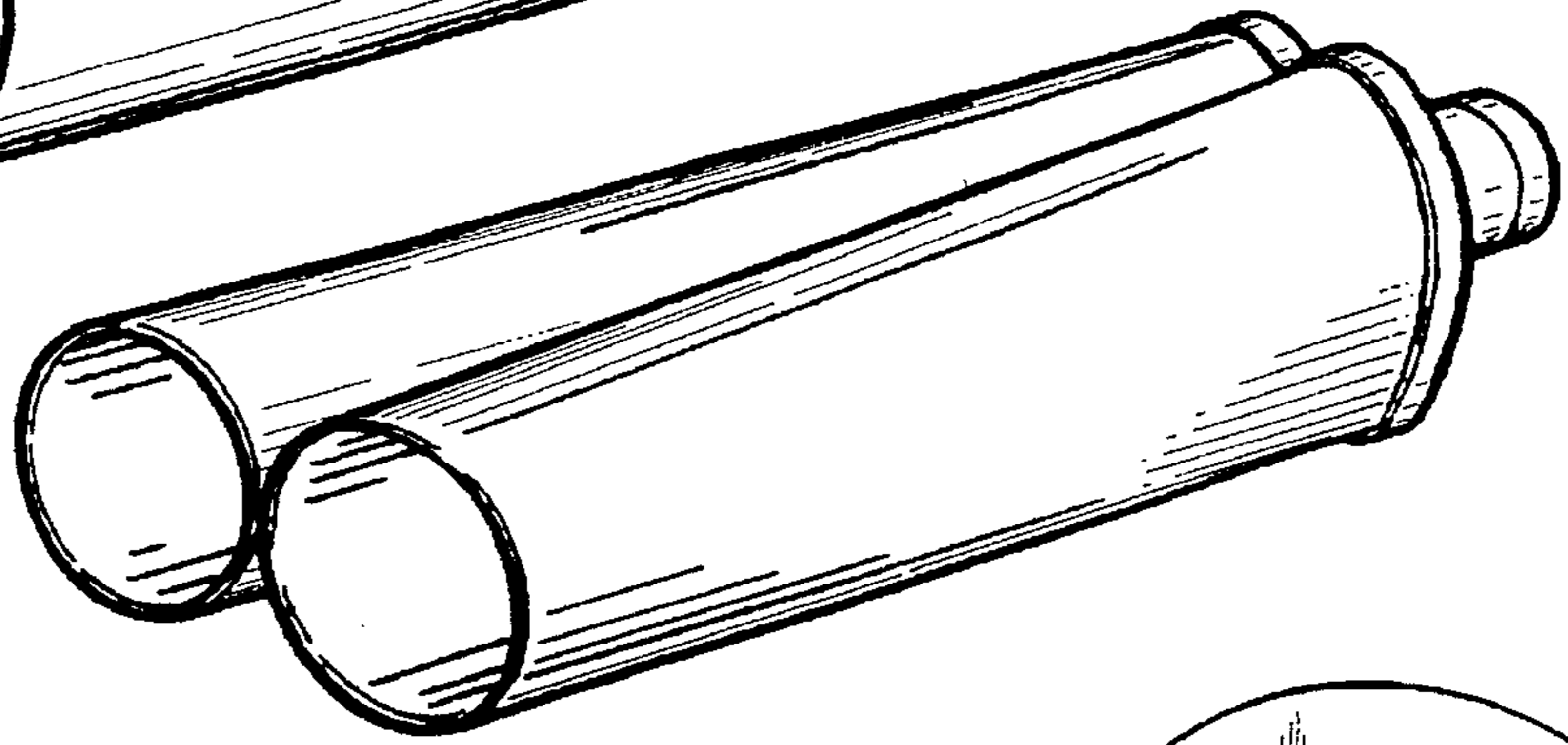

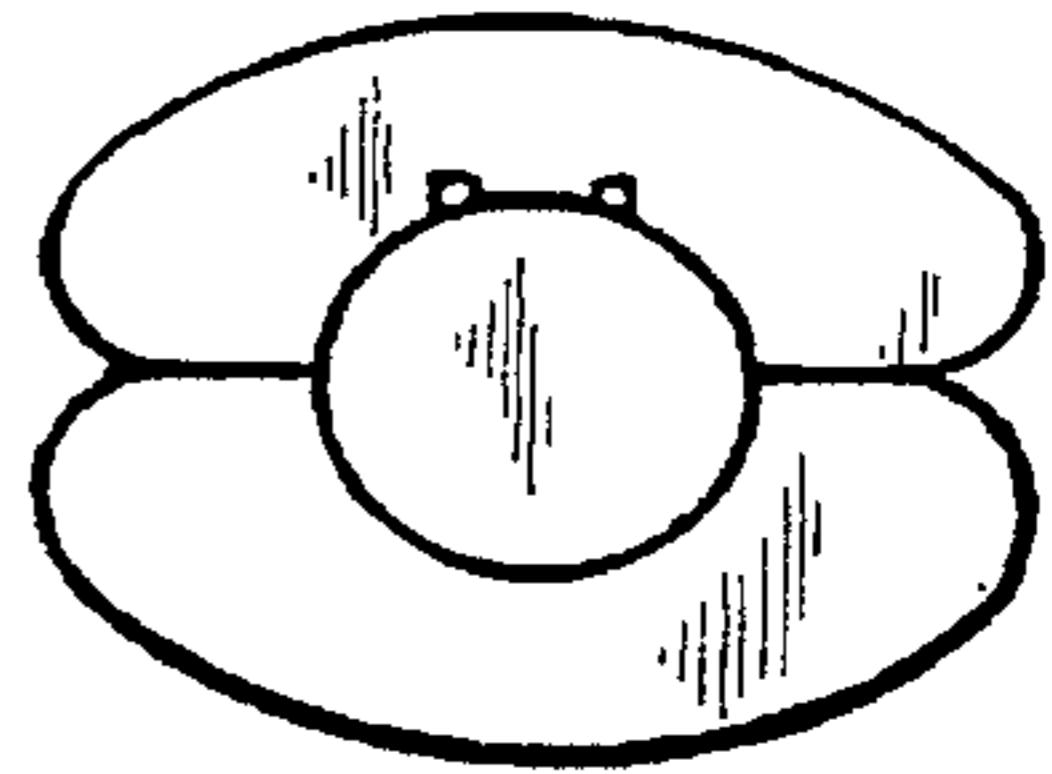
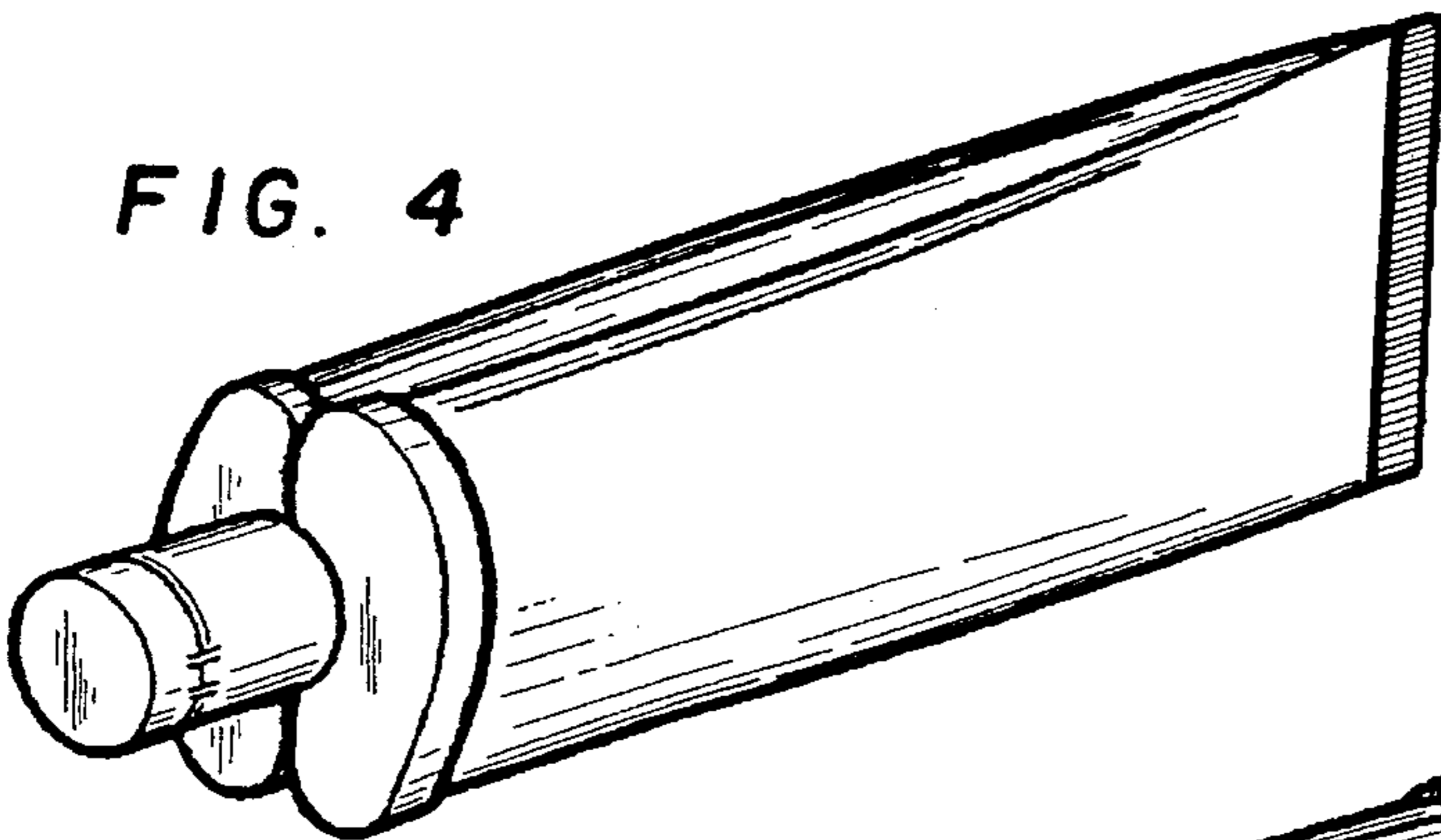

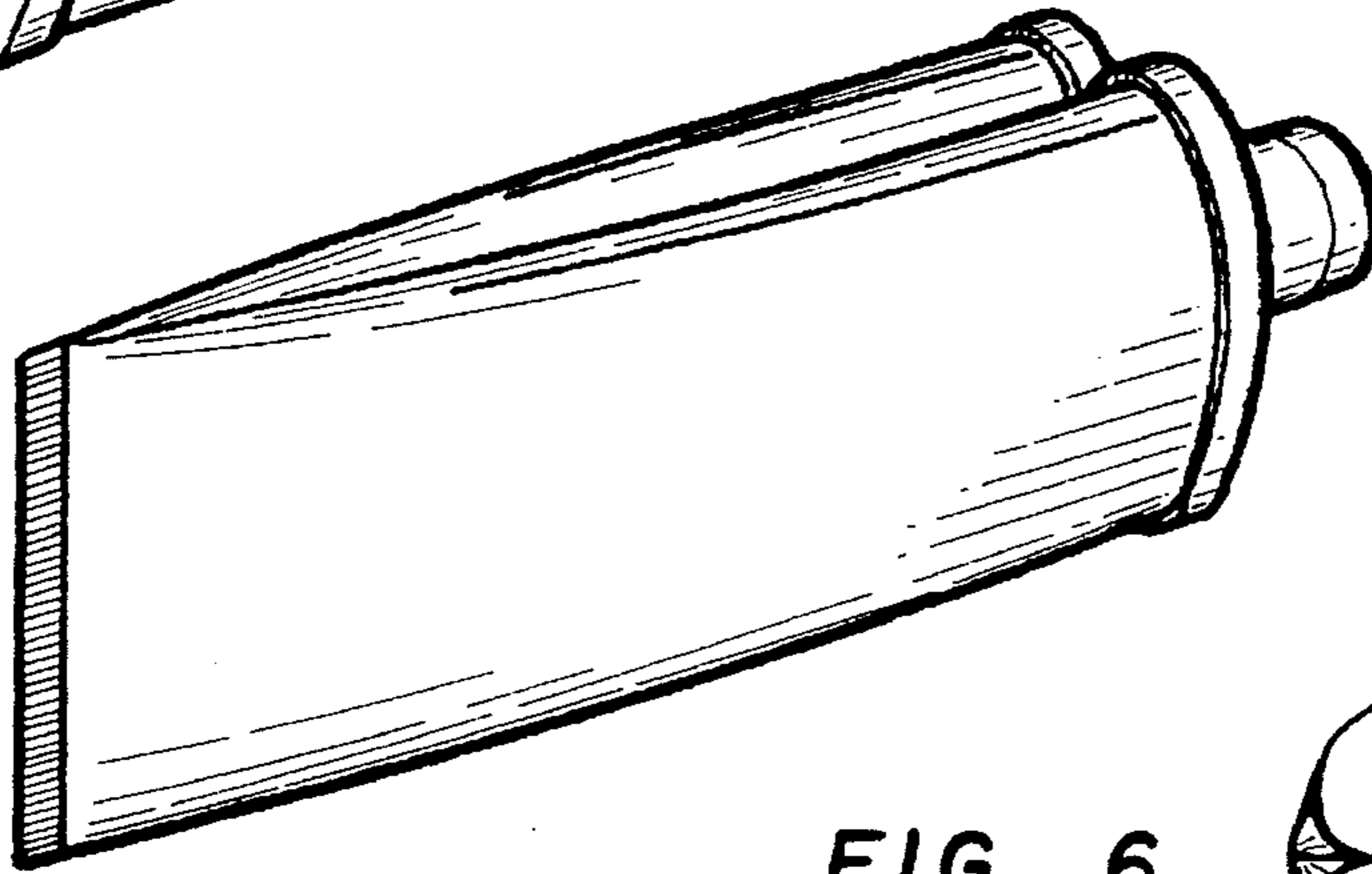

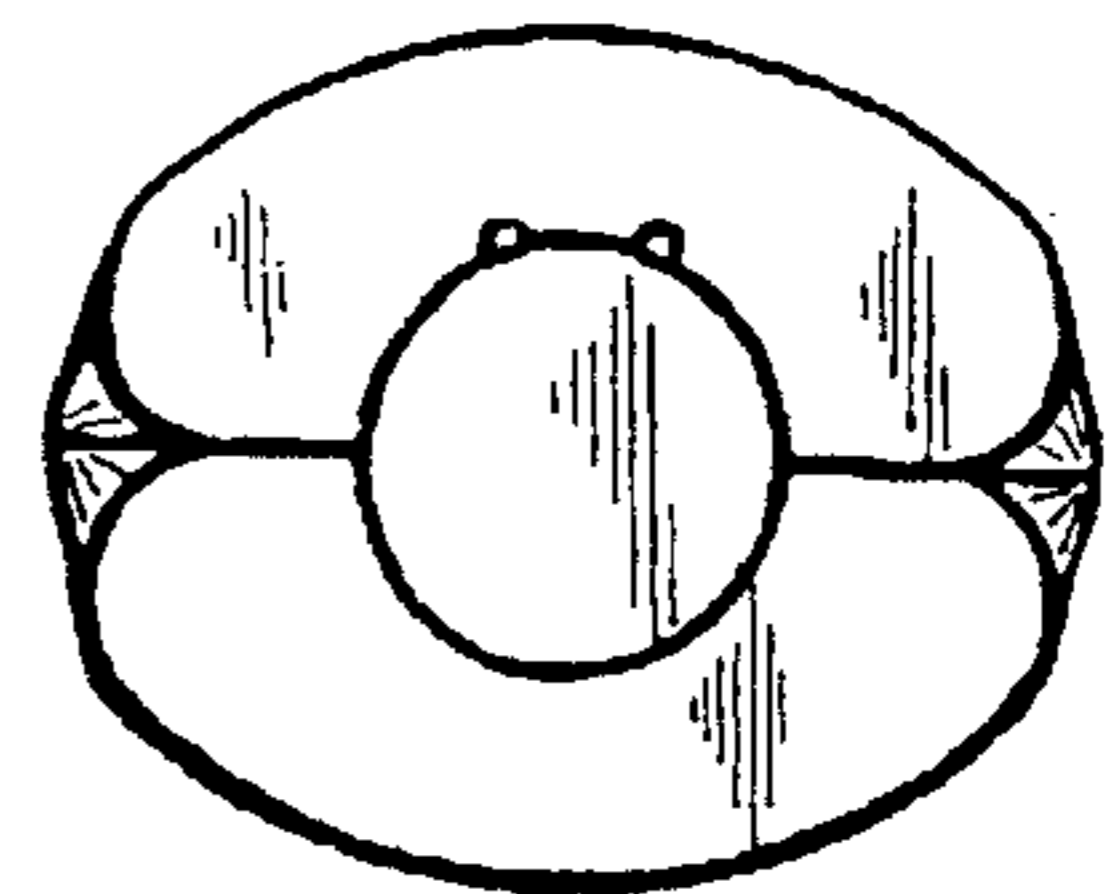

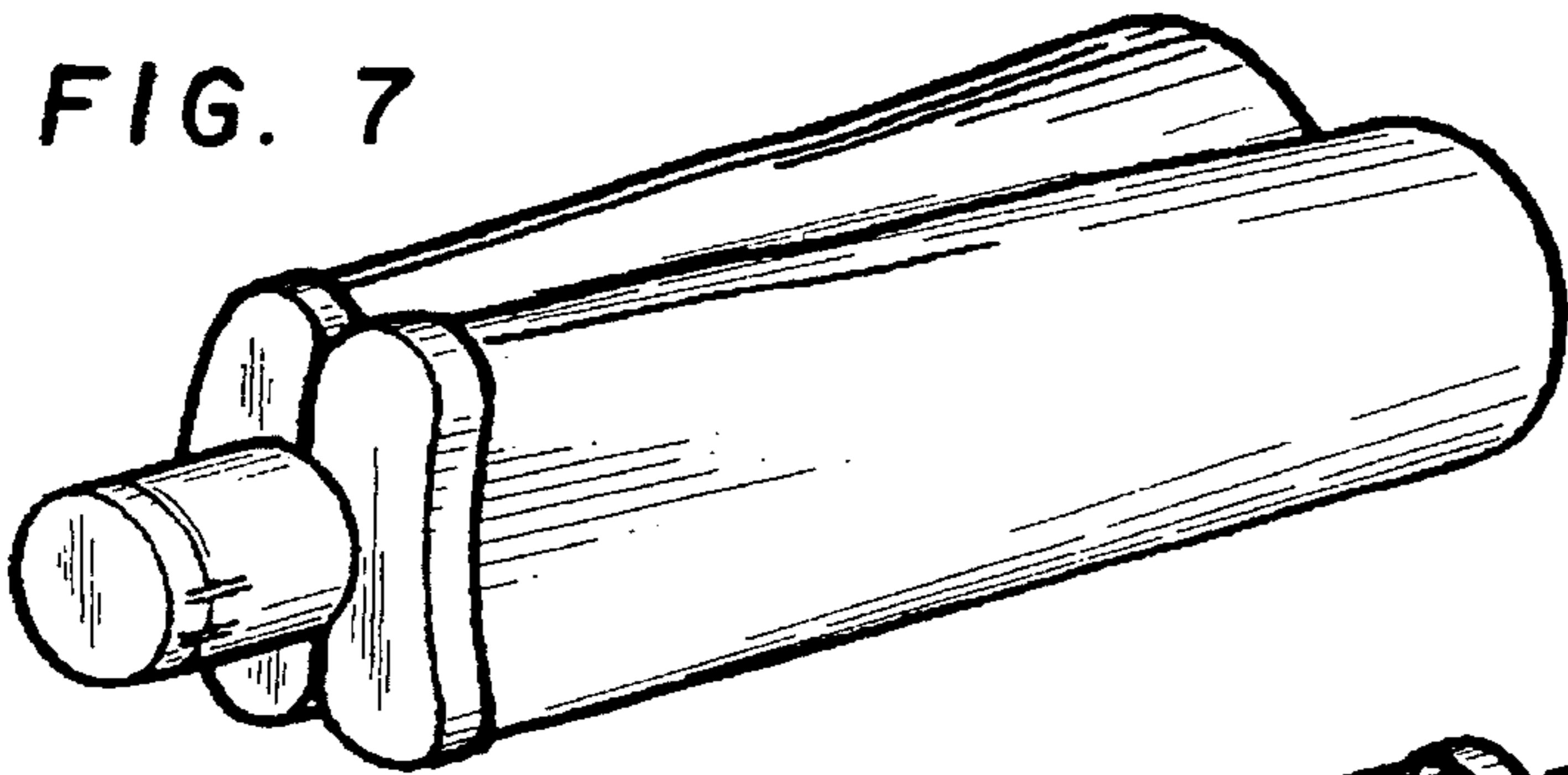

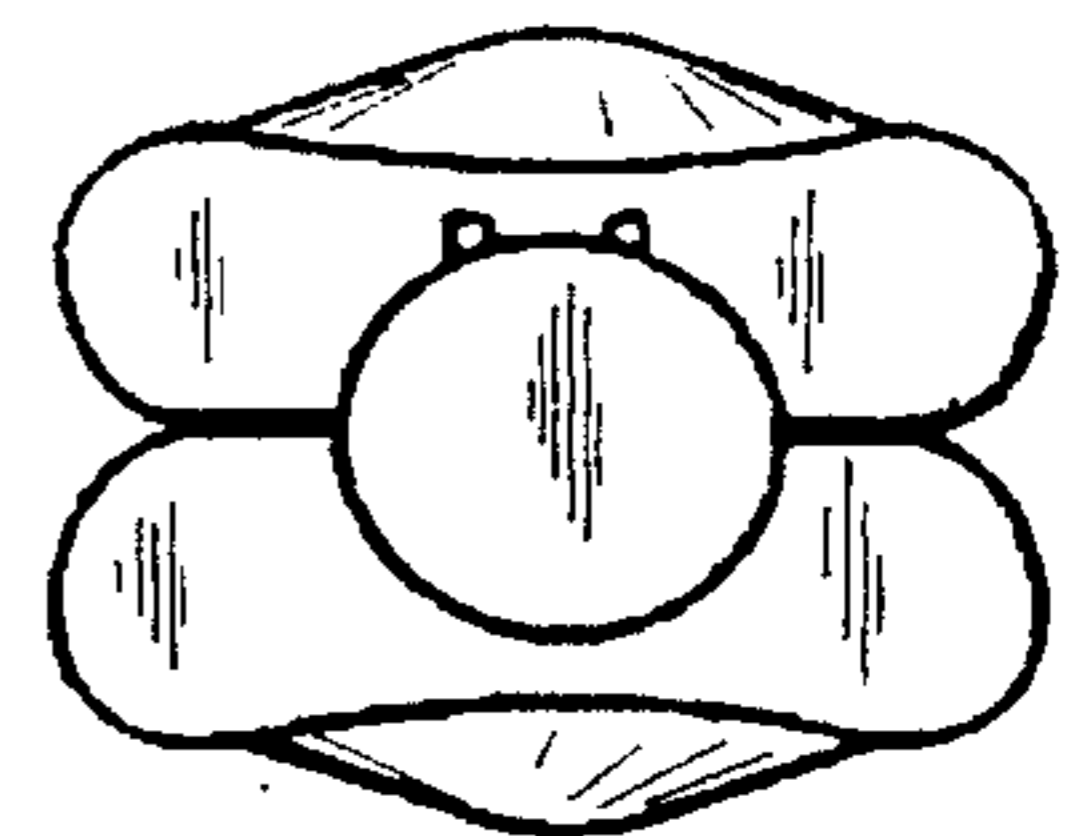
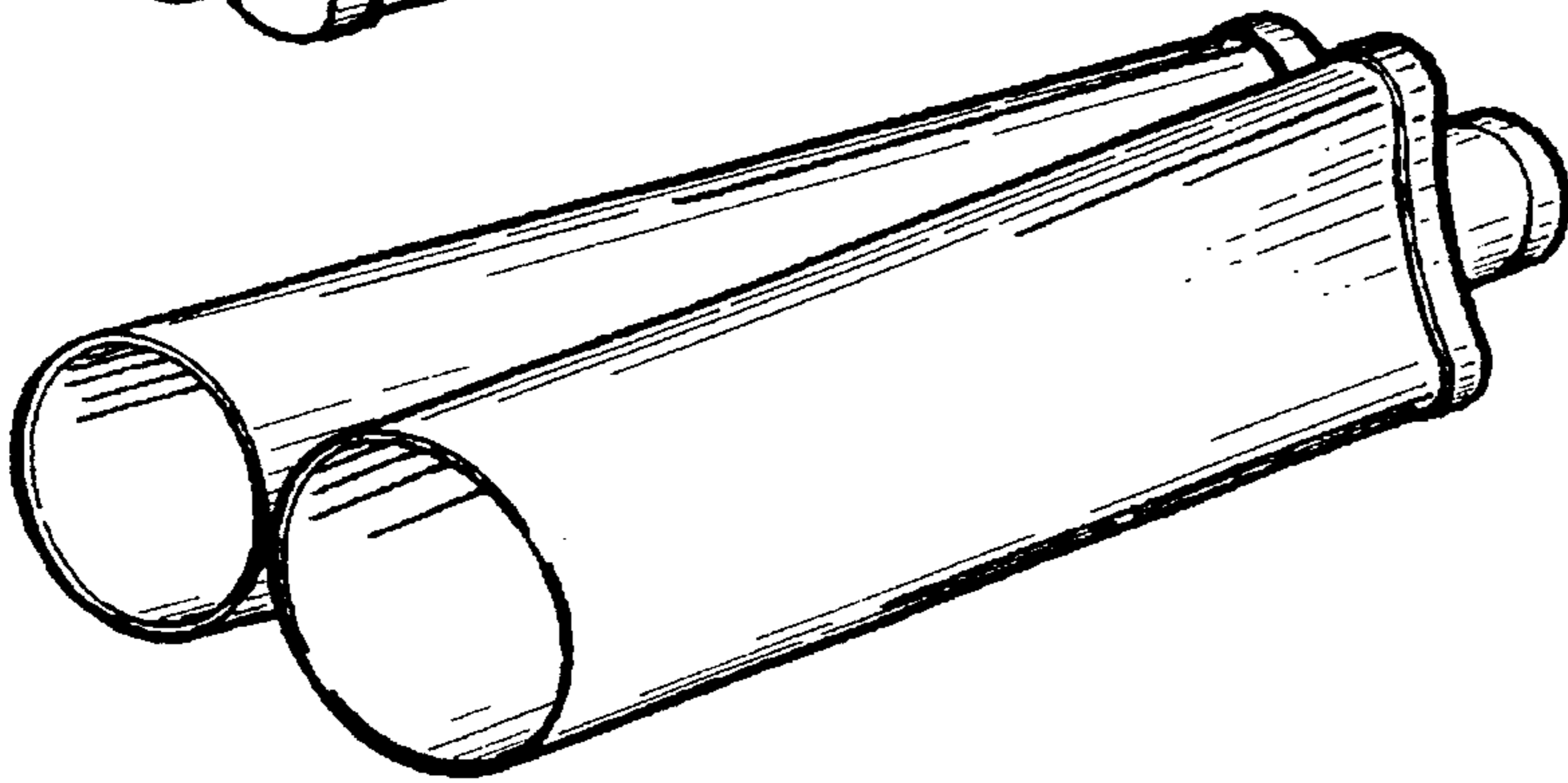

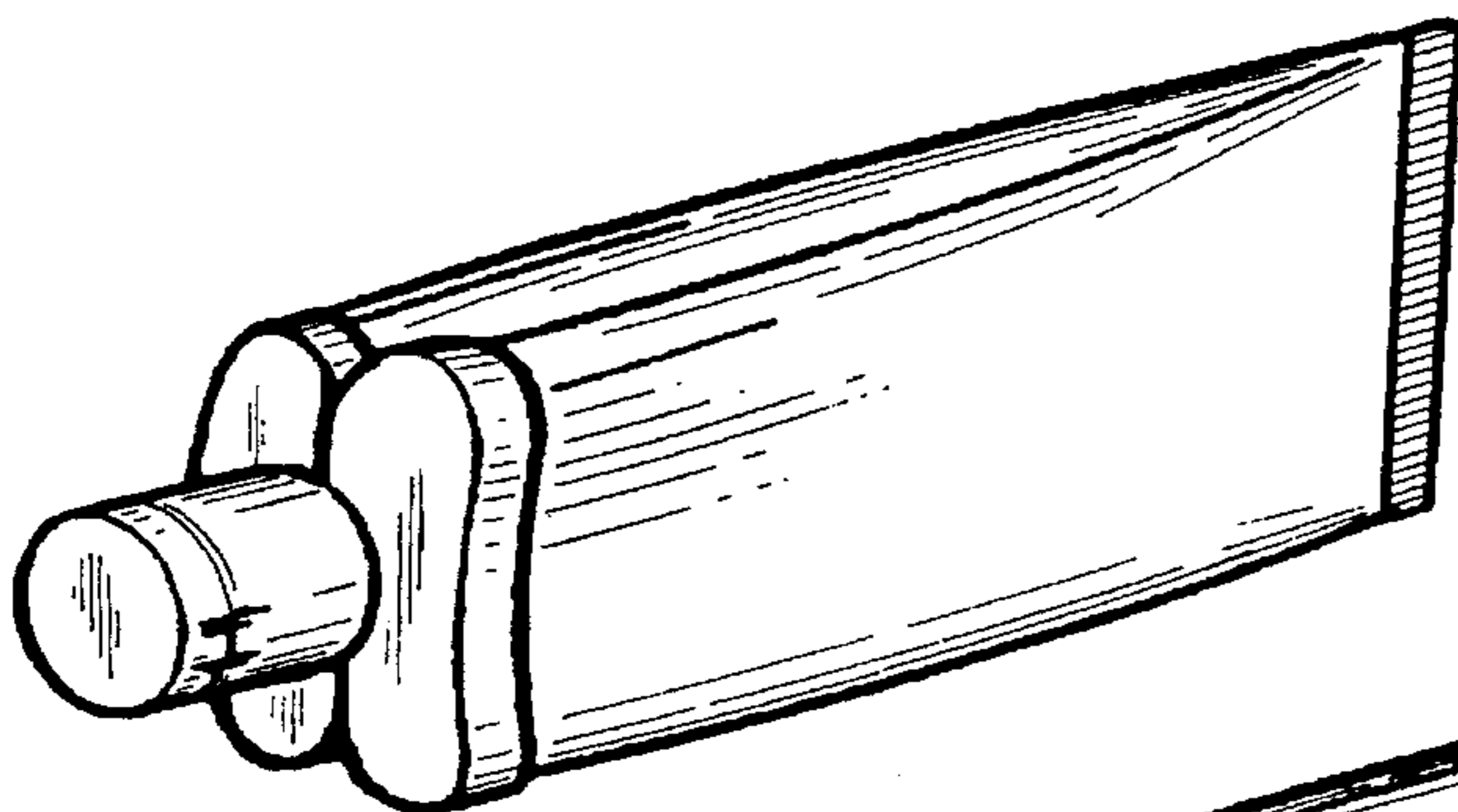

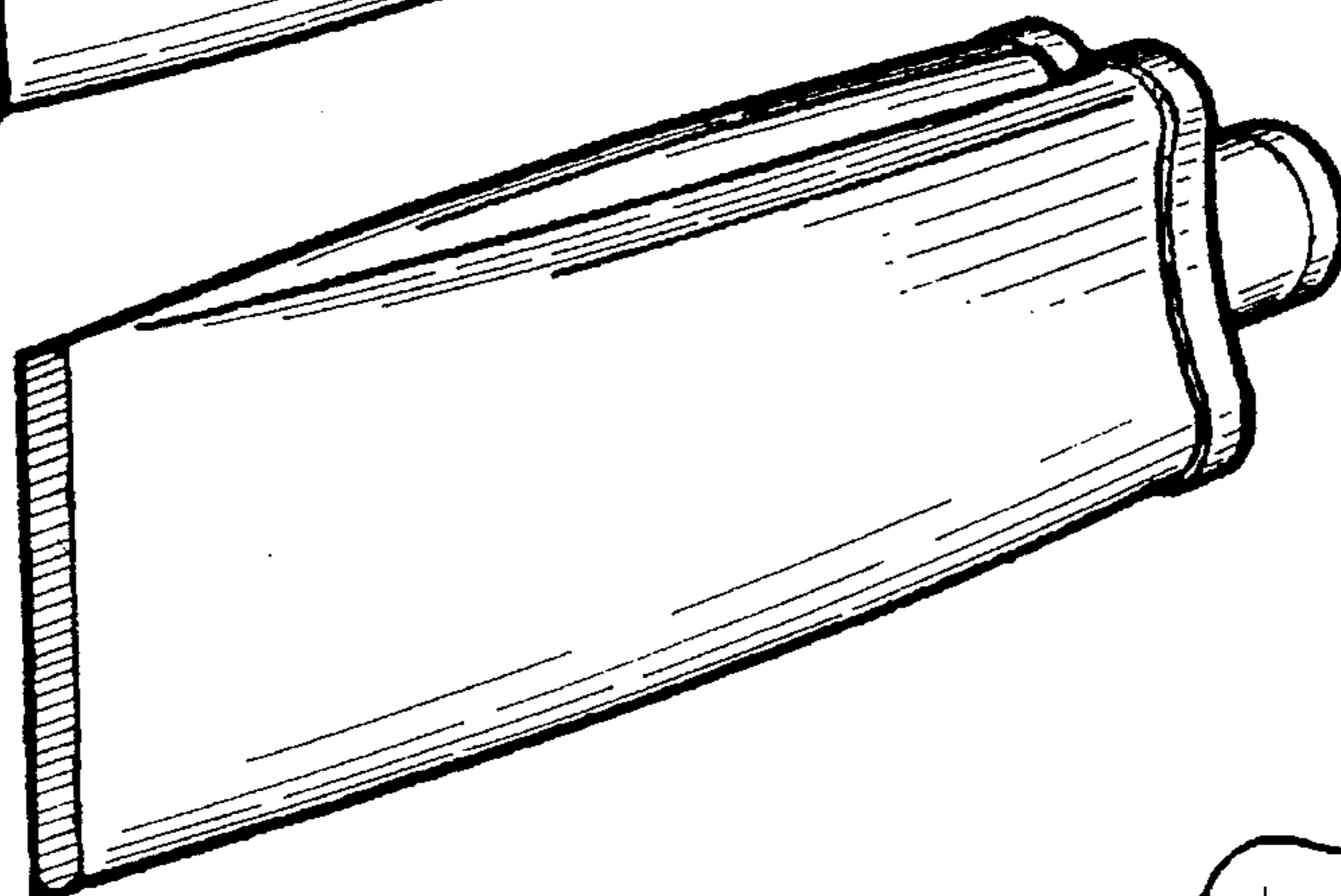

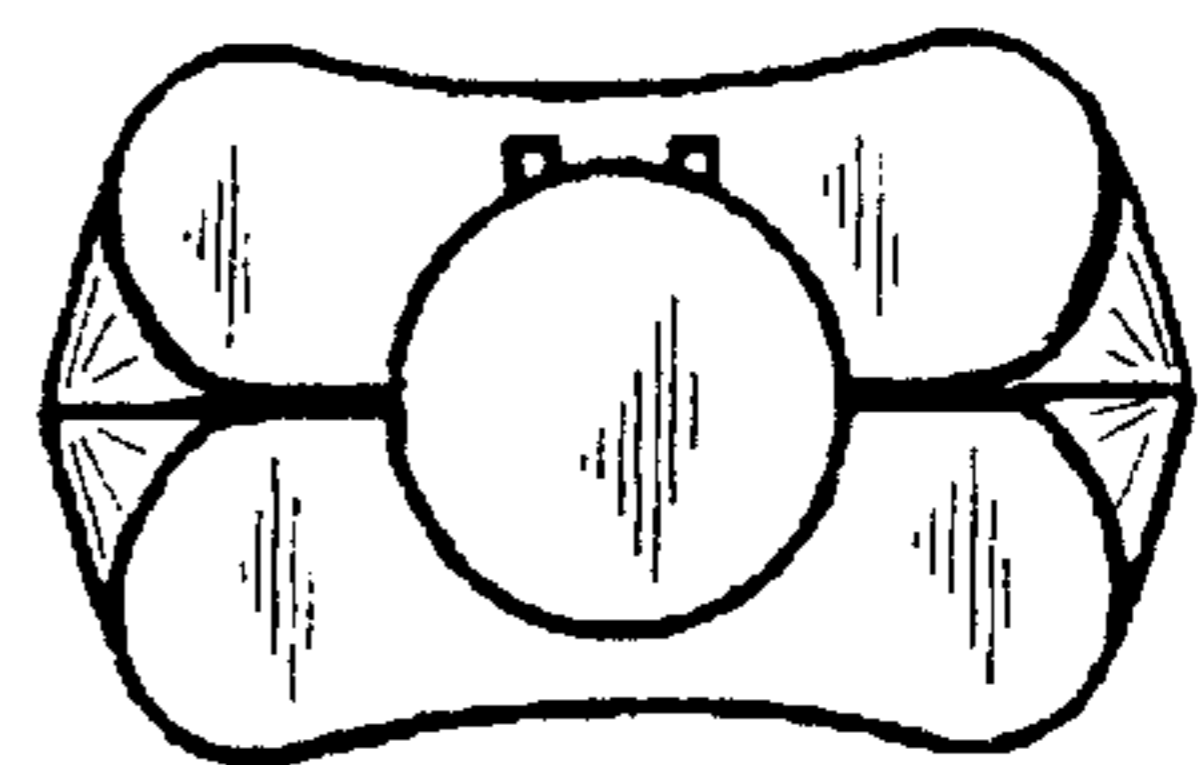

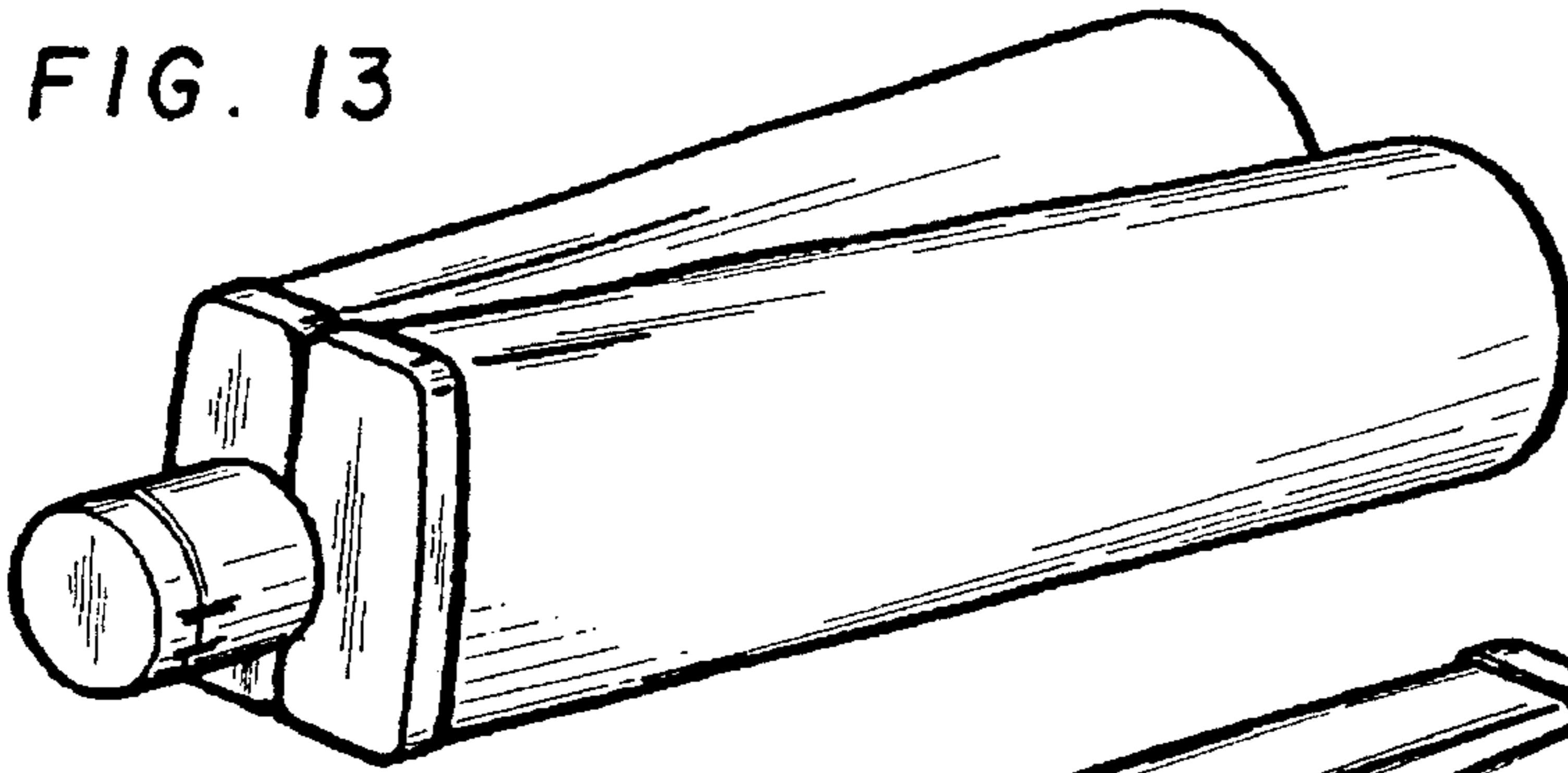

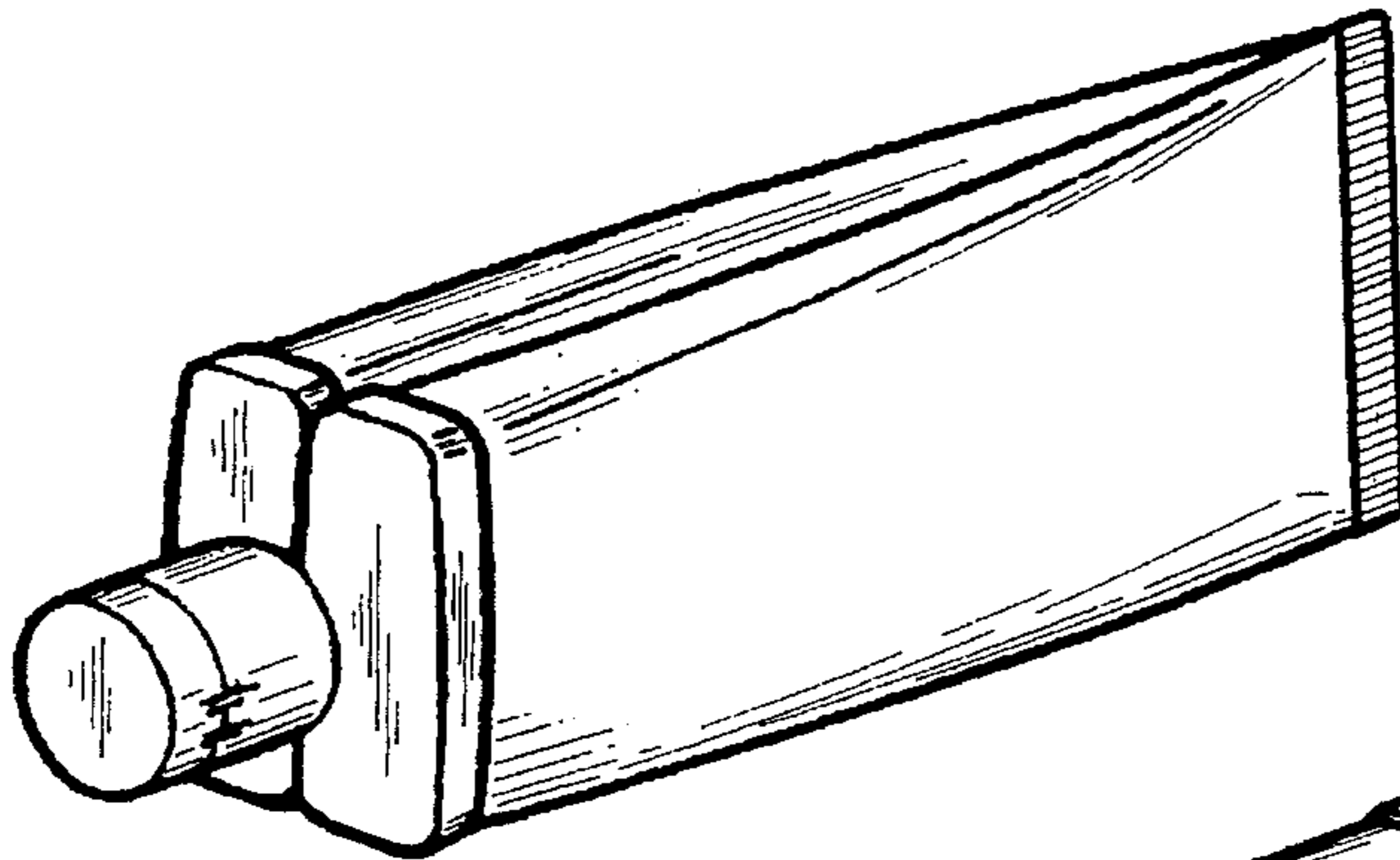
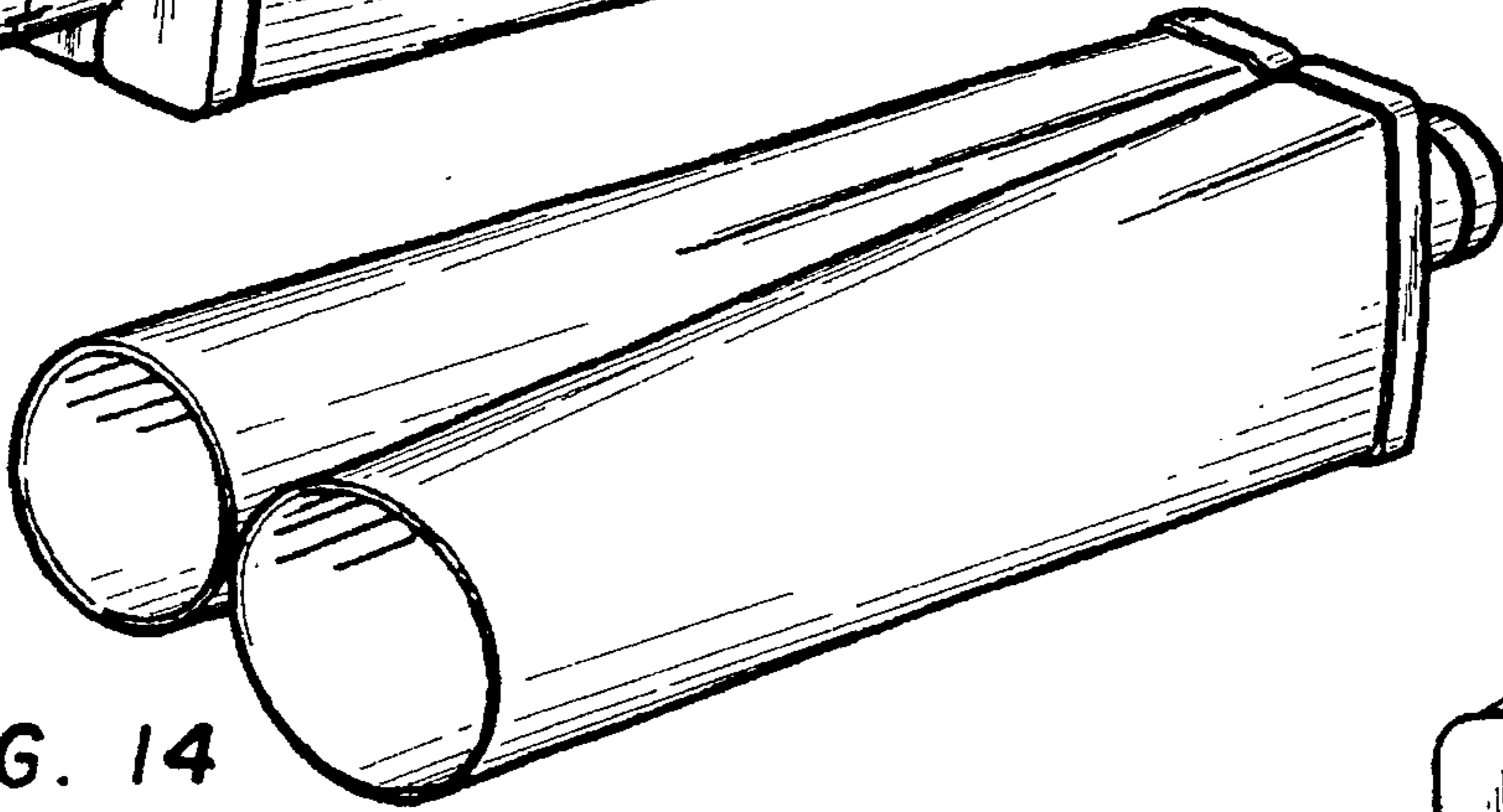

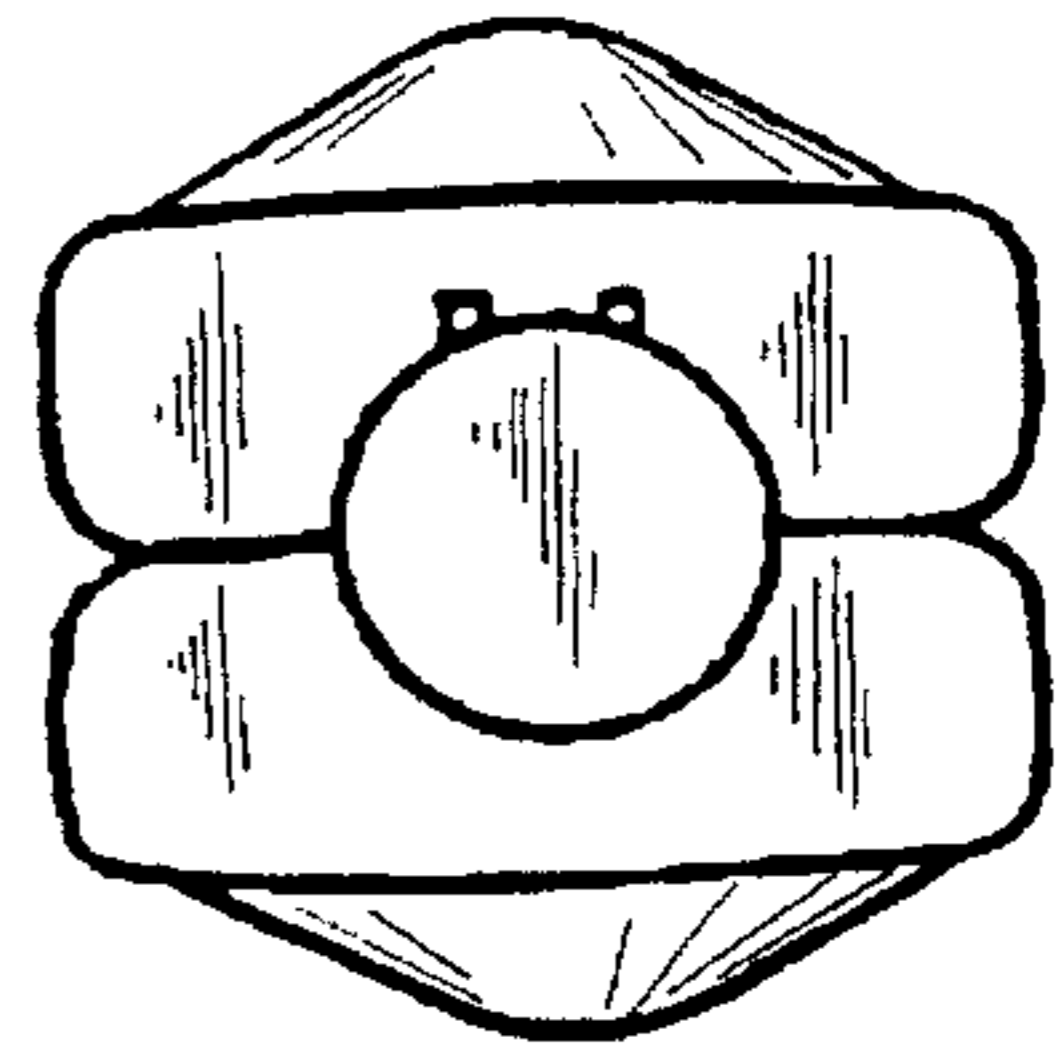
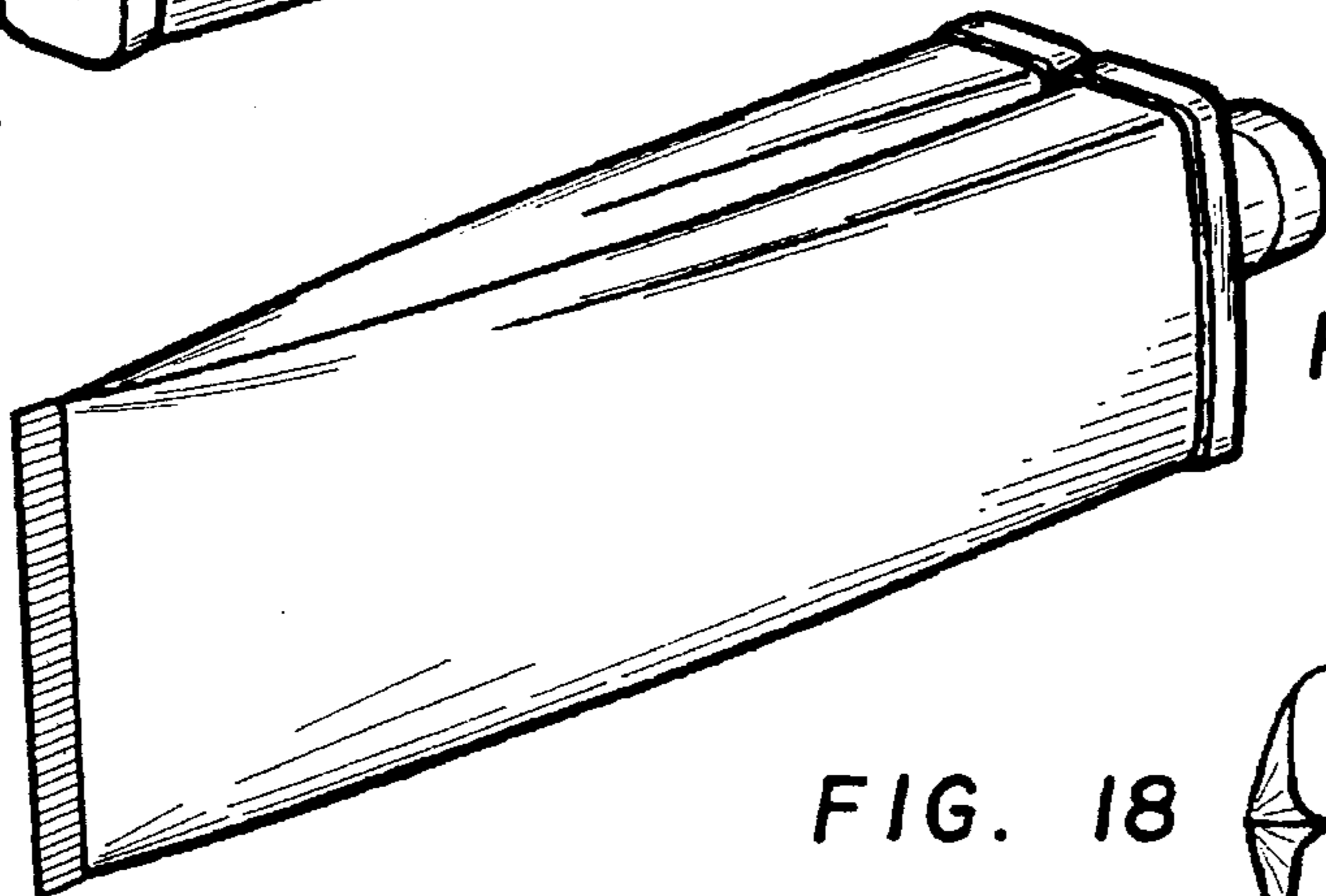

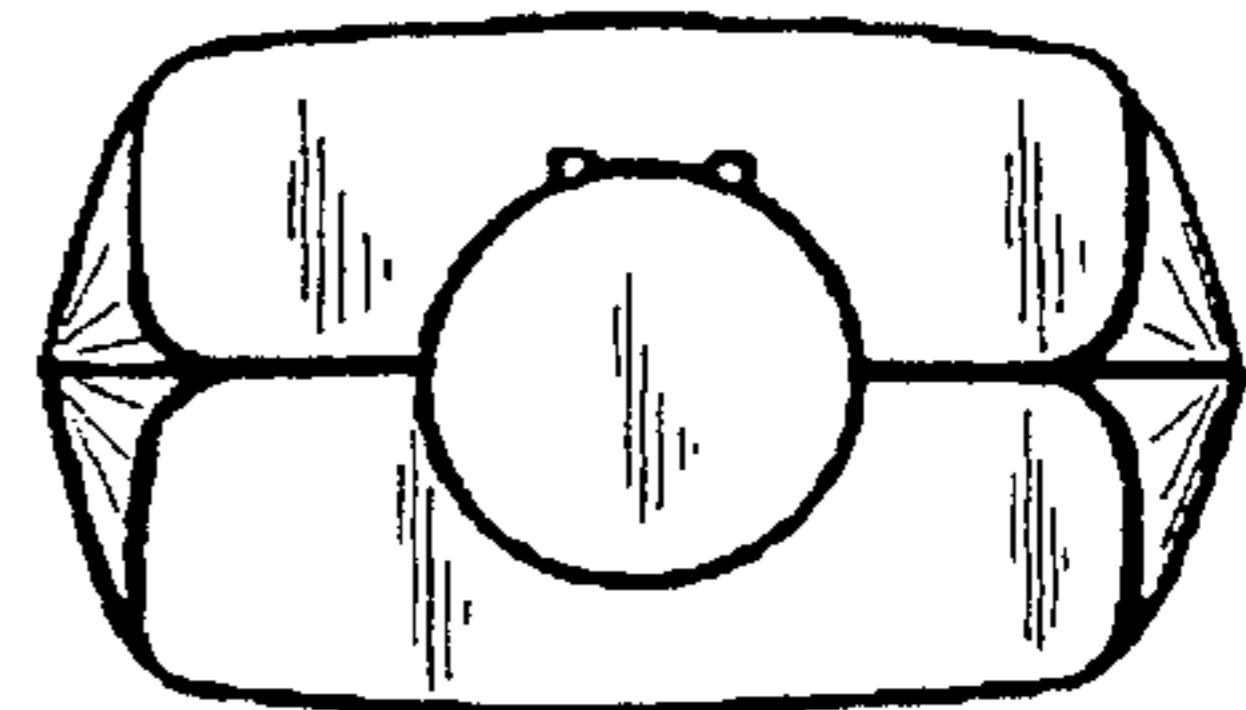

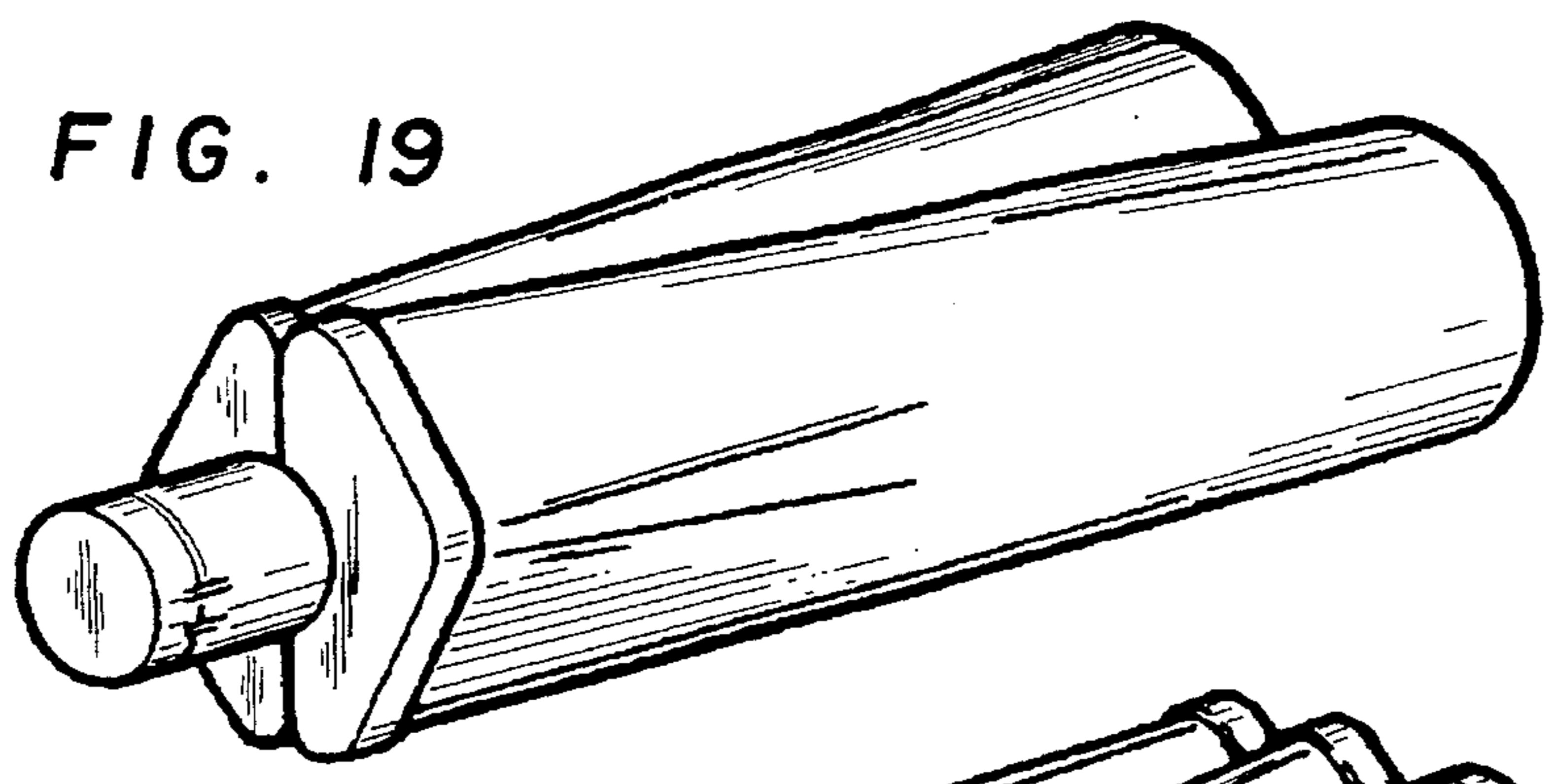

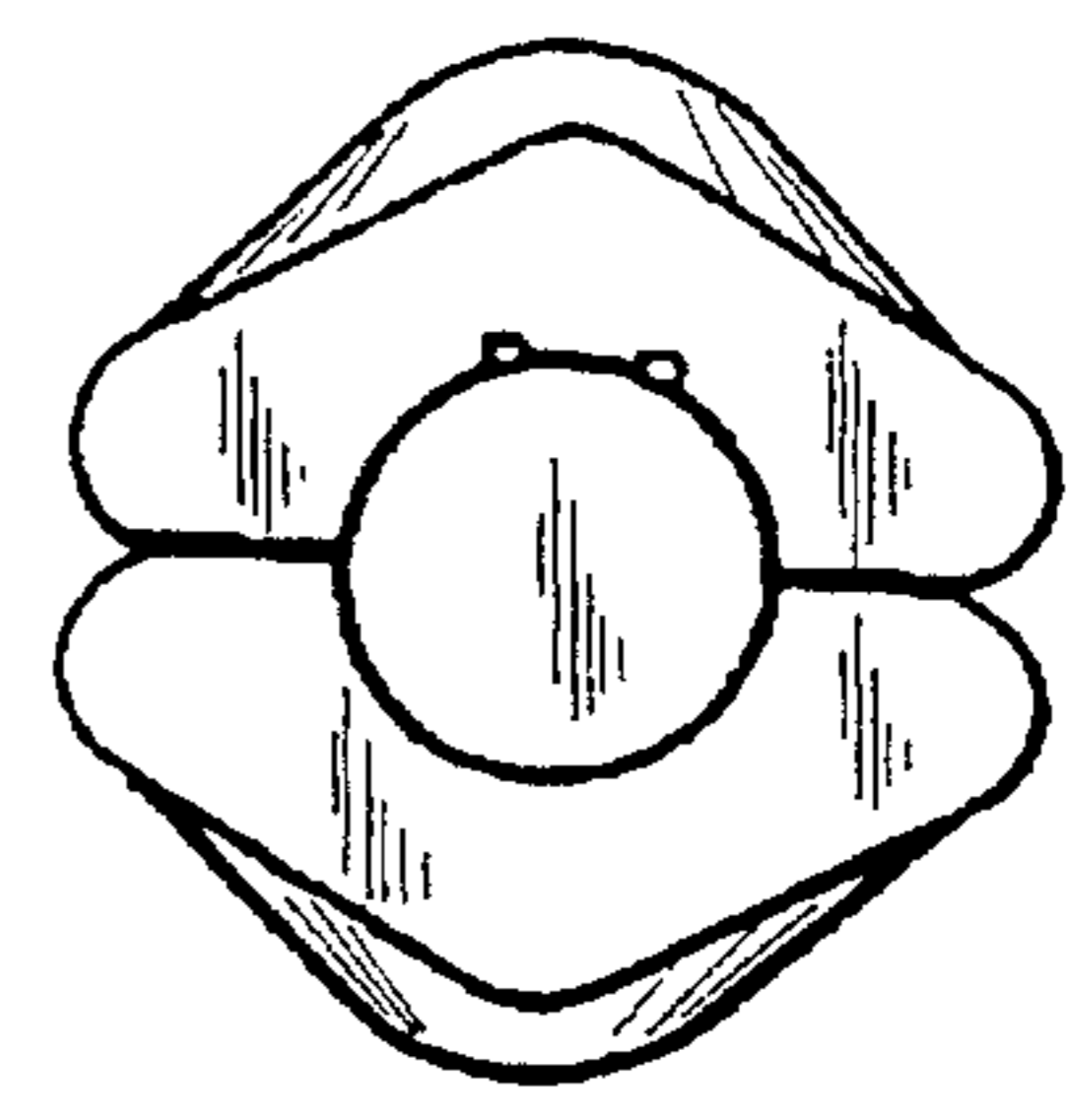
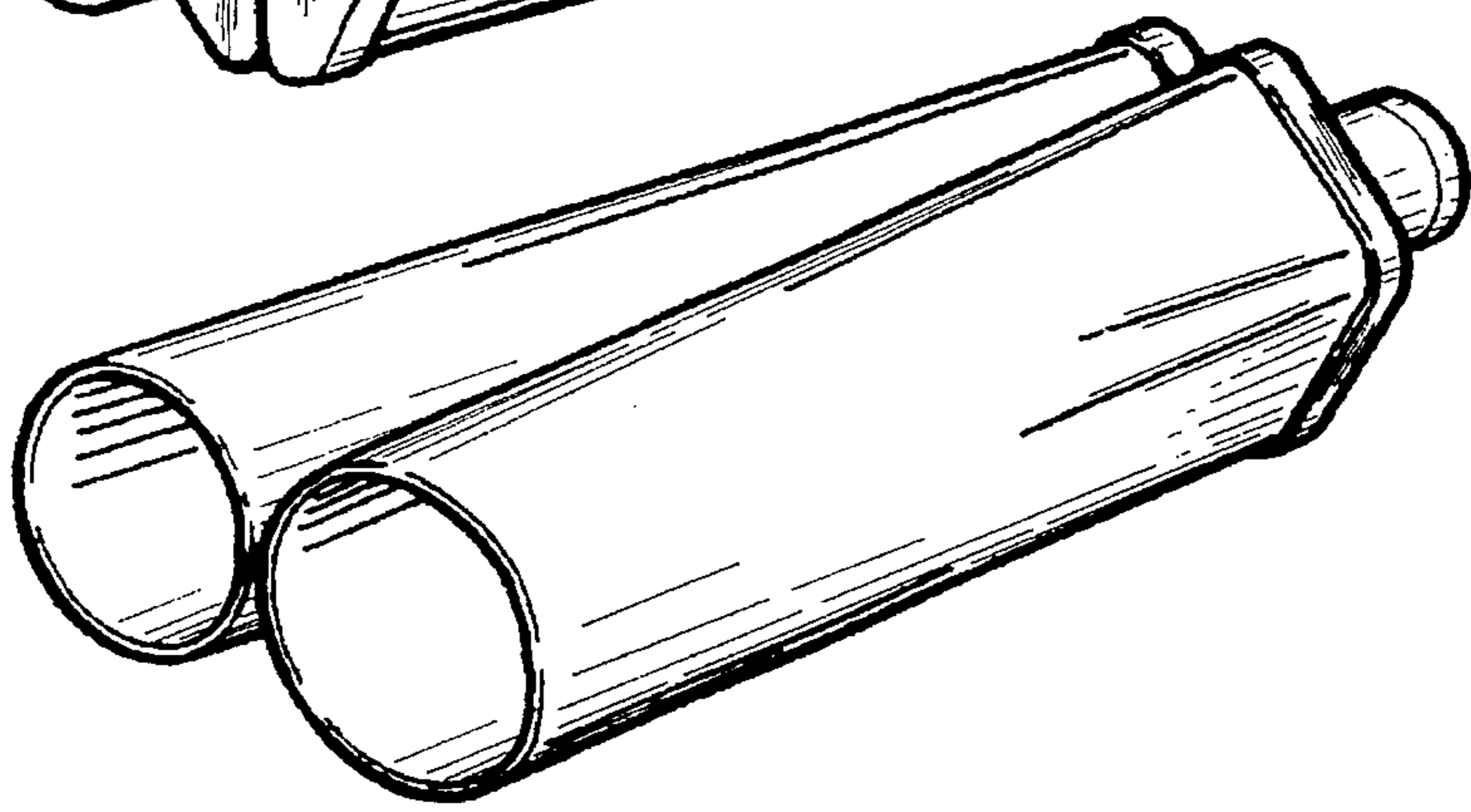

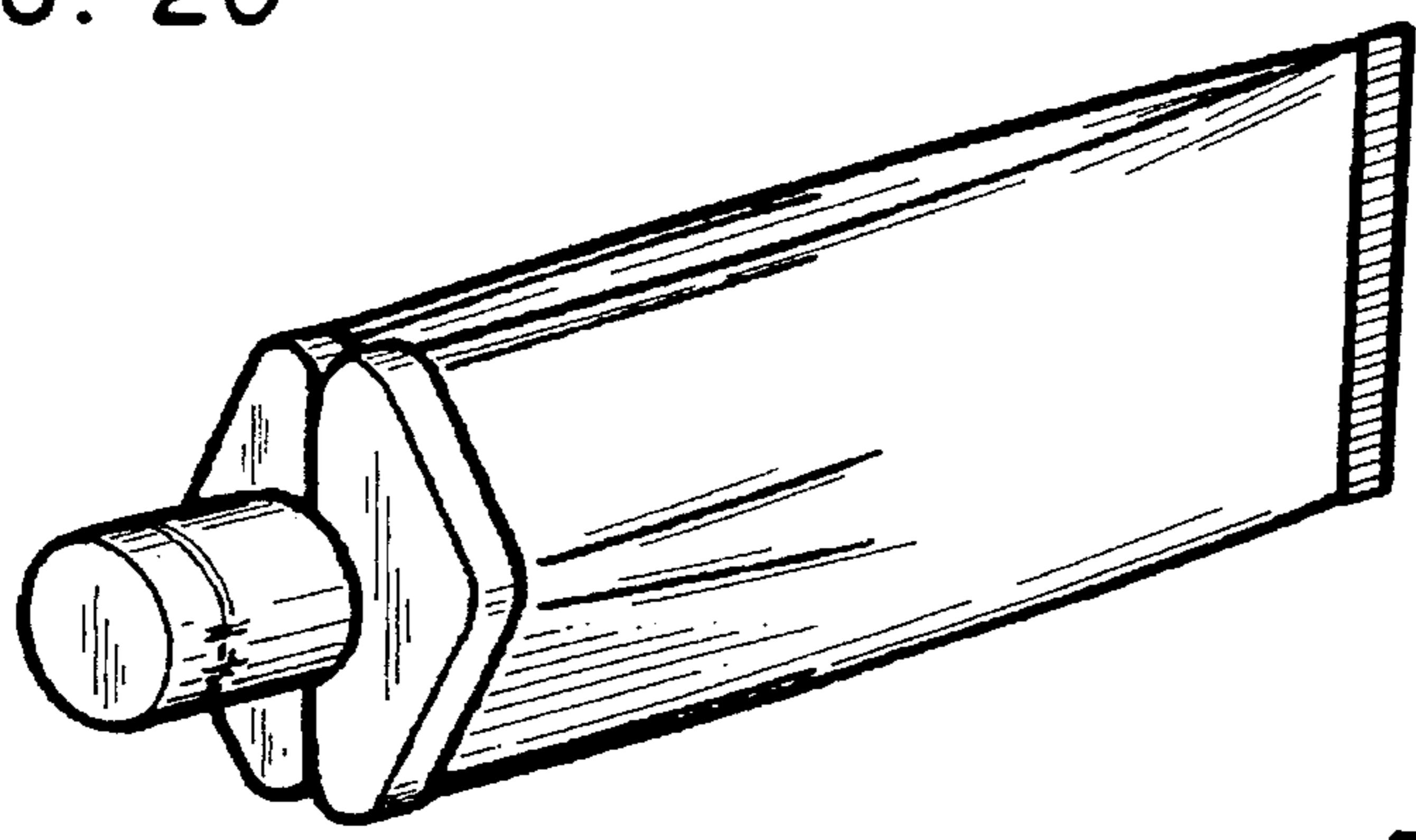

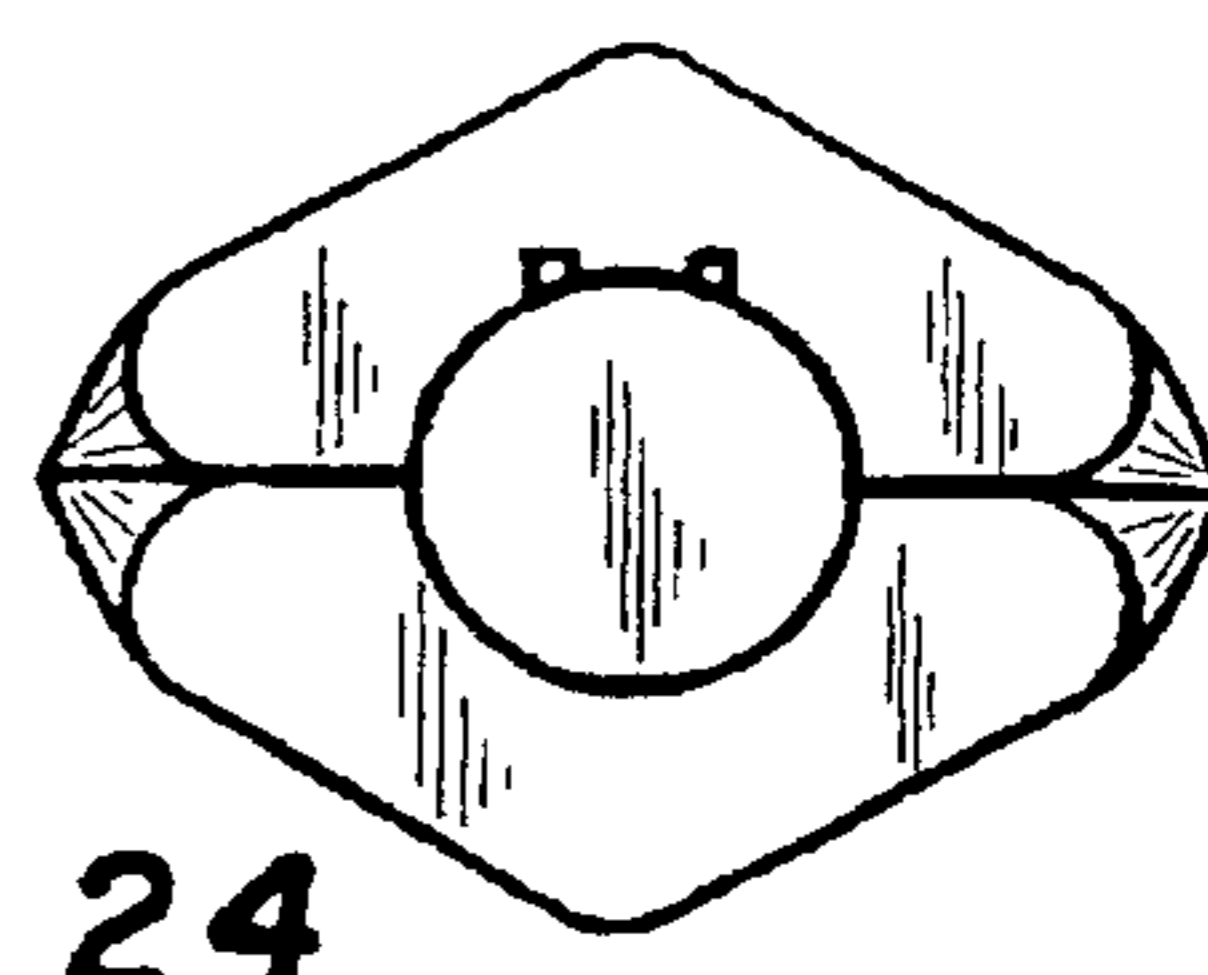
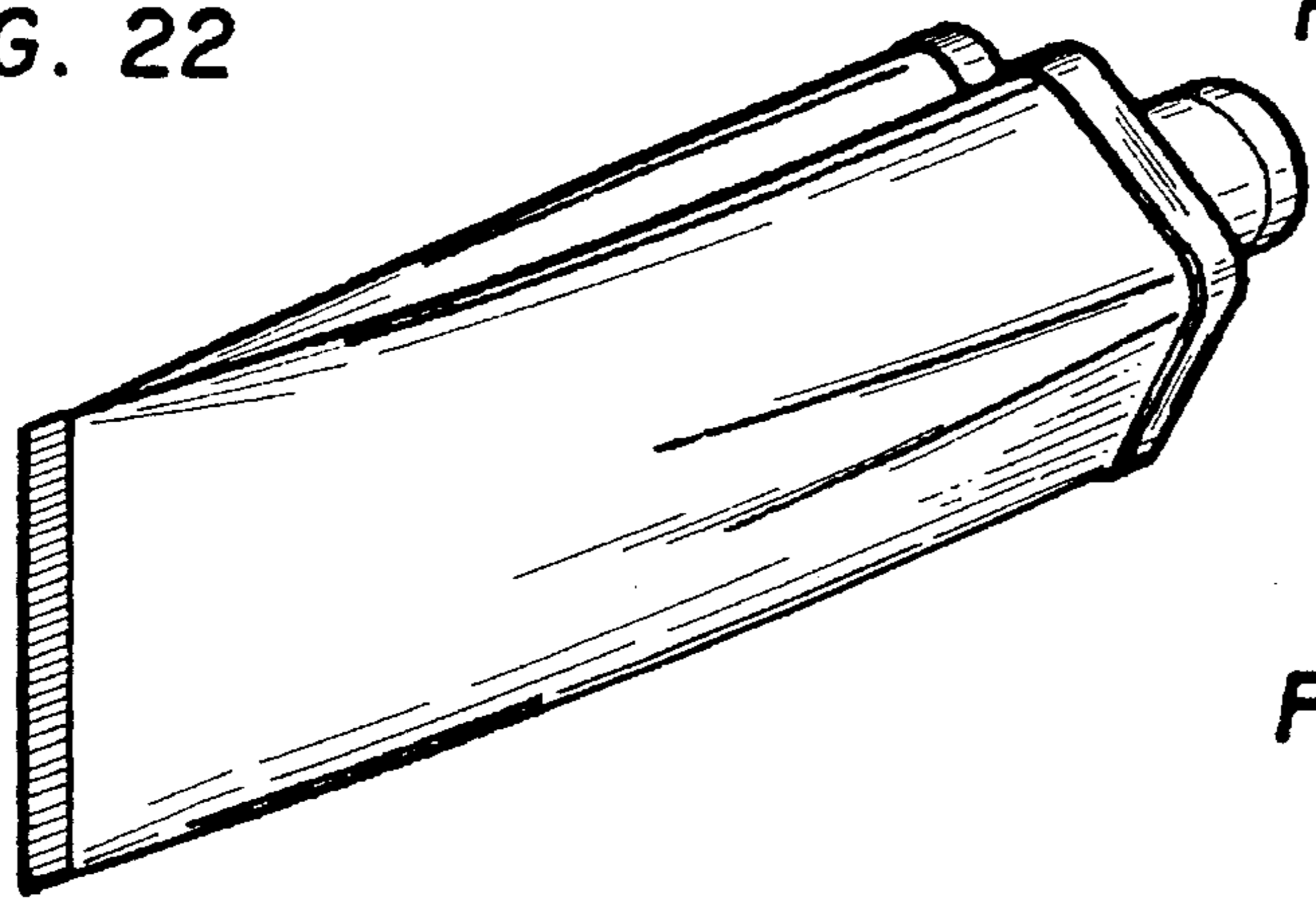
