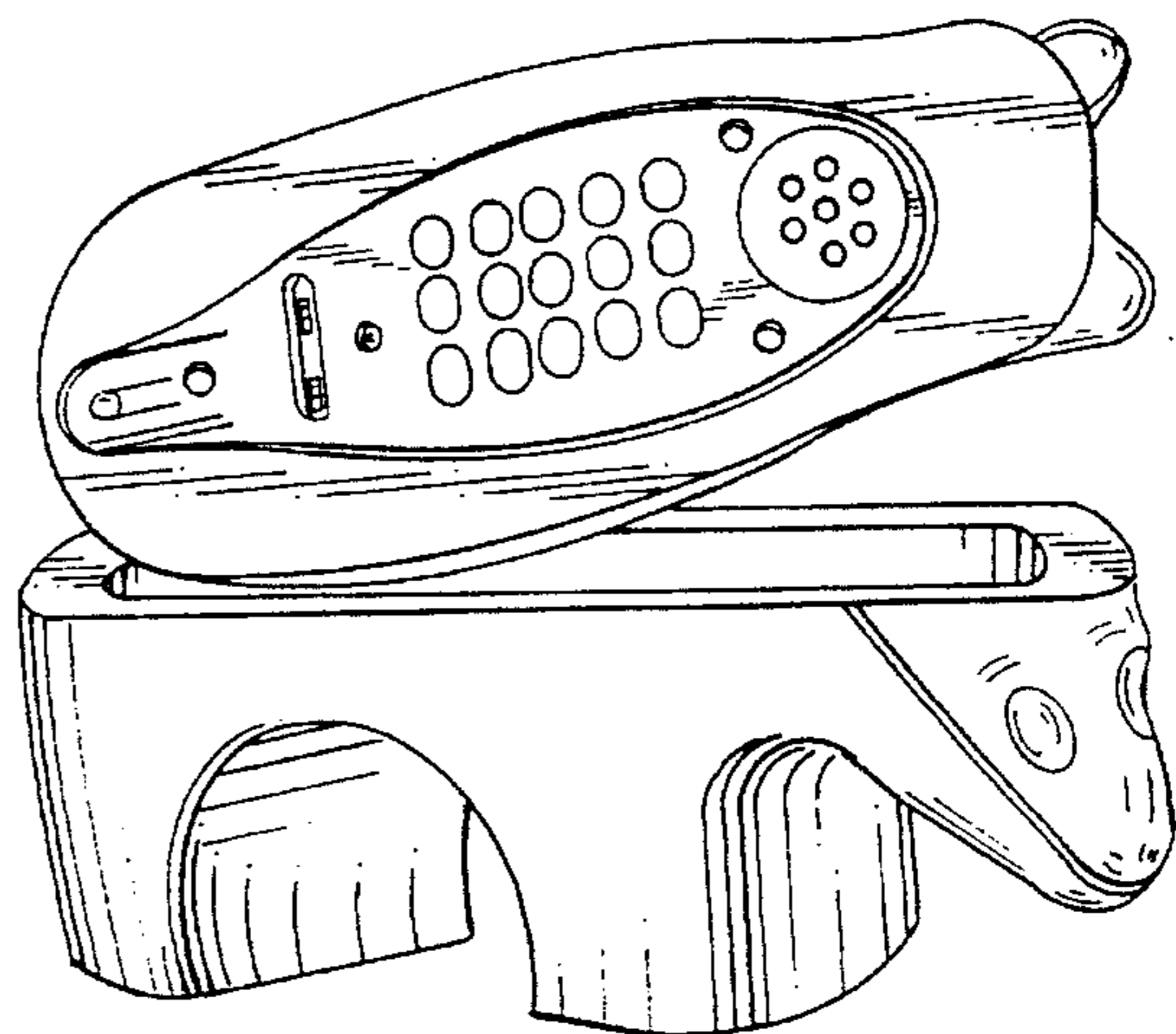
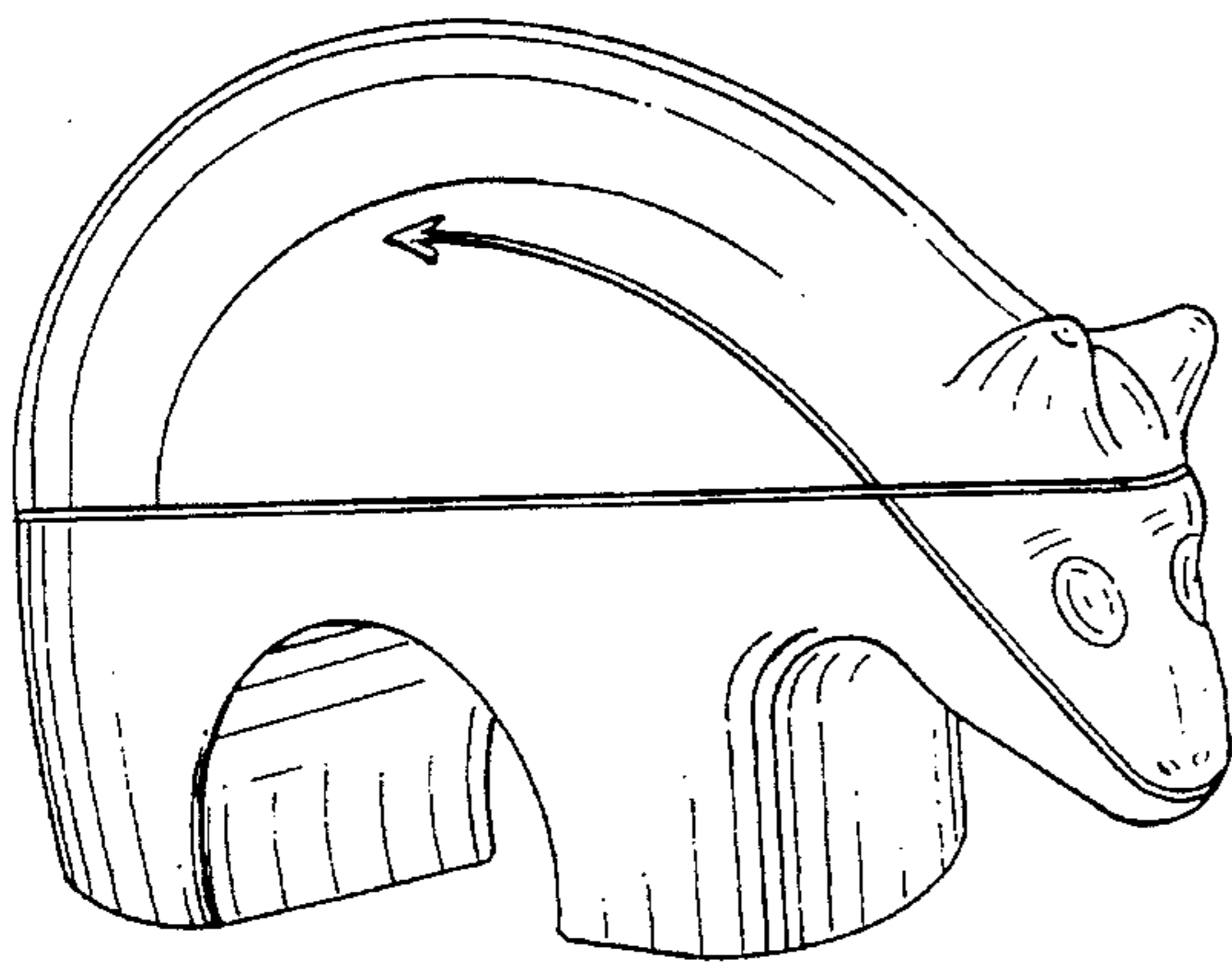
[57] **CLAIM**

The ornamental design for a bear shaped telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right side perspective view of a bear shaped telephone showing our new design;  
FIG. 2 is the perspective view of FIG. 1, detached;  
FIG. 3 is a right side elevational view the left side being a mirror image thereof;  
FIG. 4 is a rear elevational view;  
FIG. 5 is a front elevational view; and,  
FIG. 6 is a top plan view thereof.

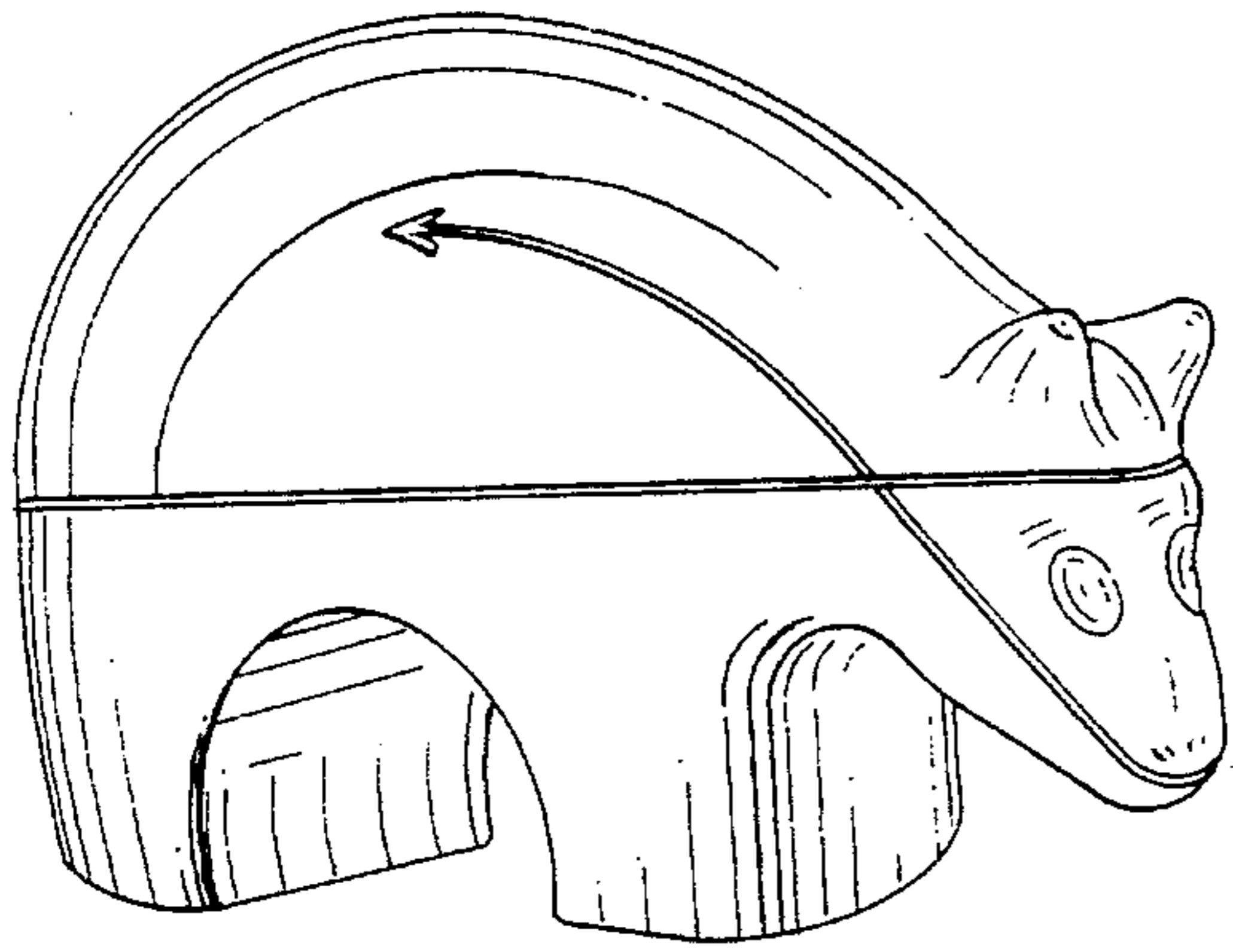

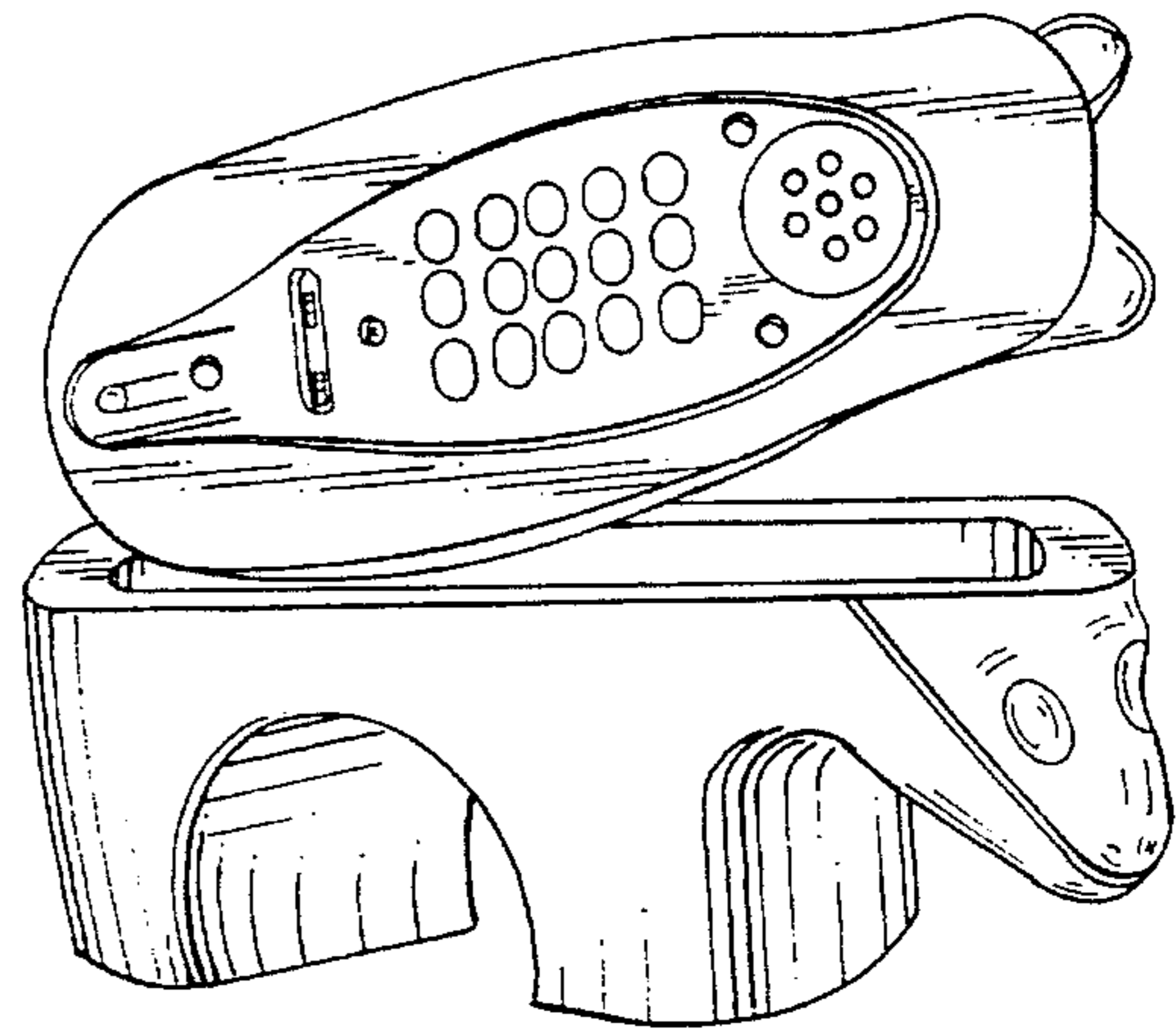

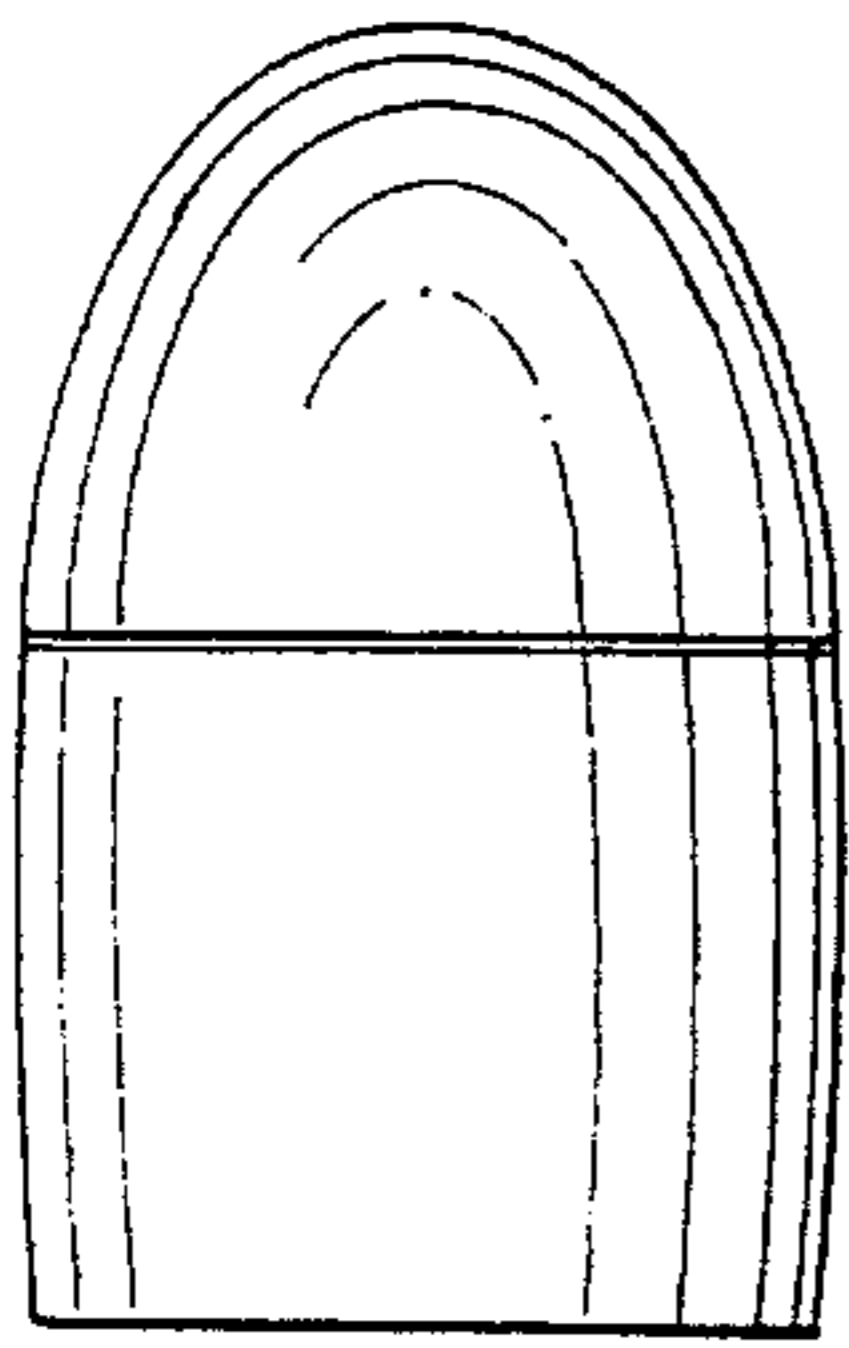

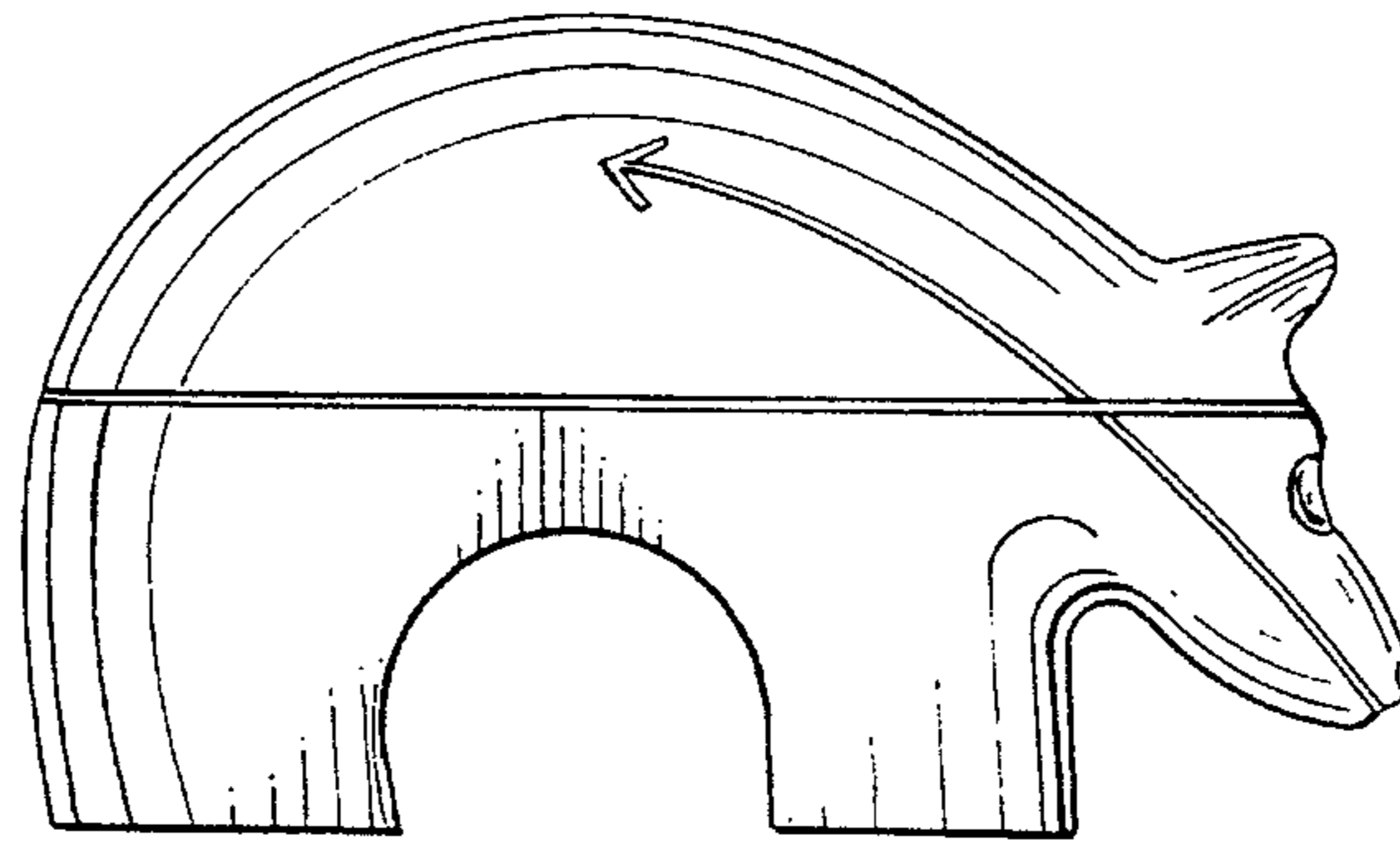

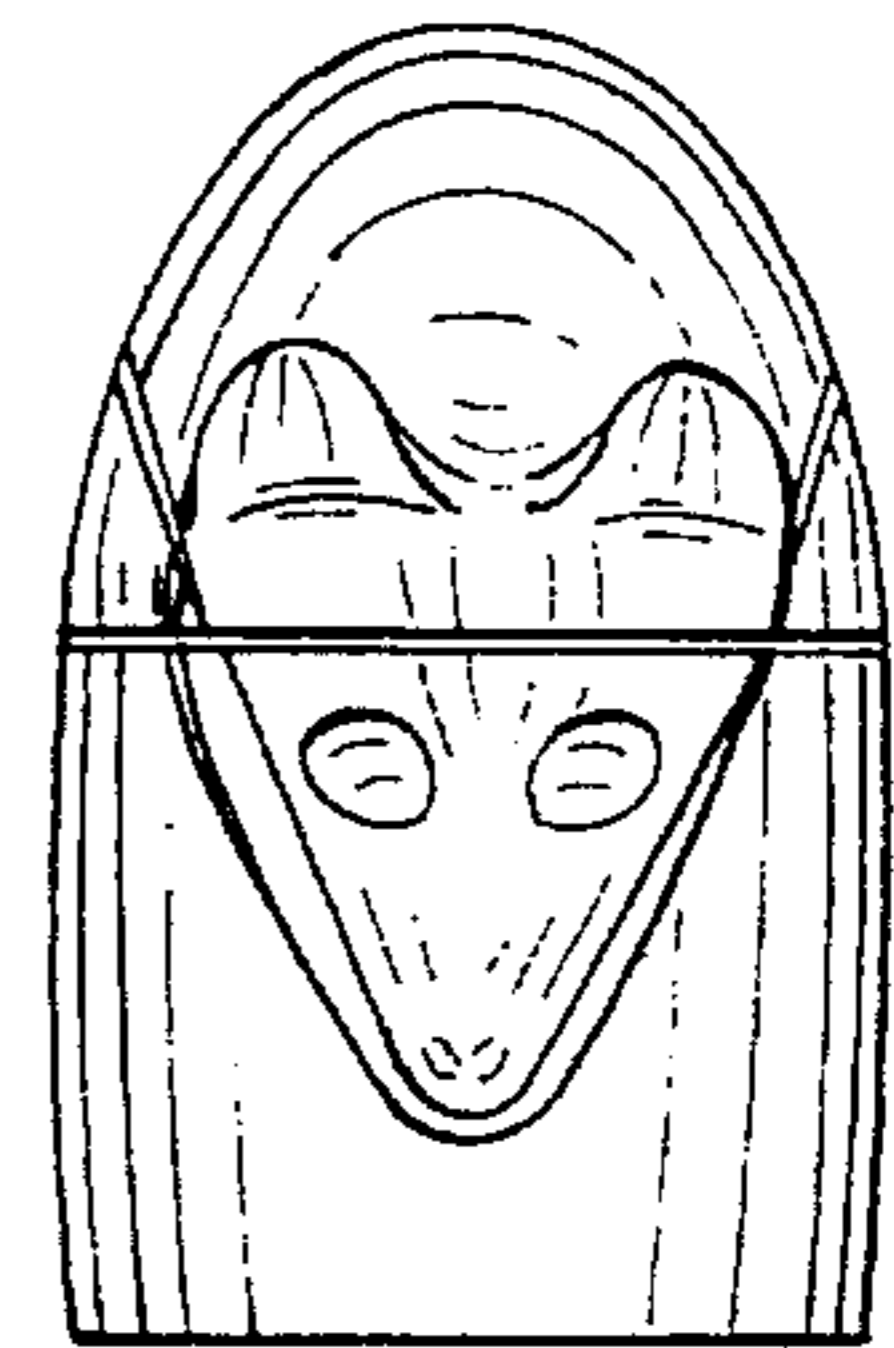

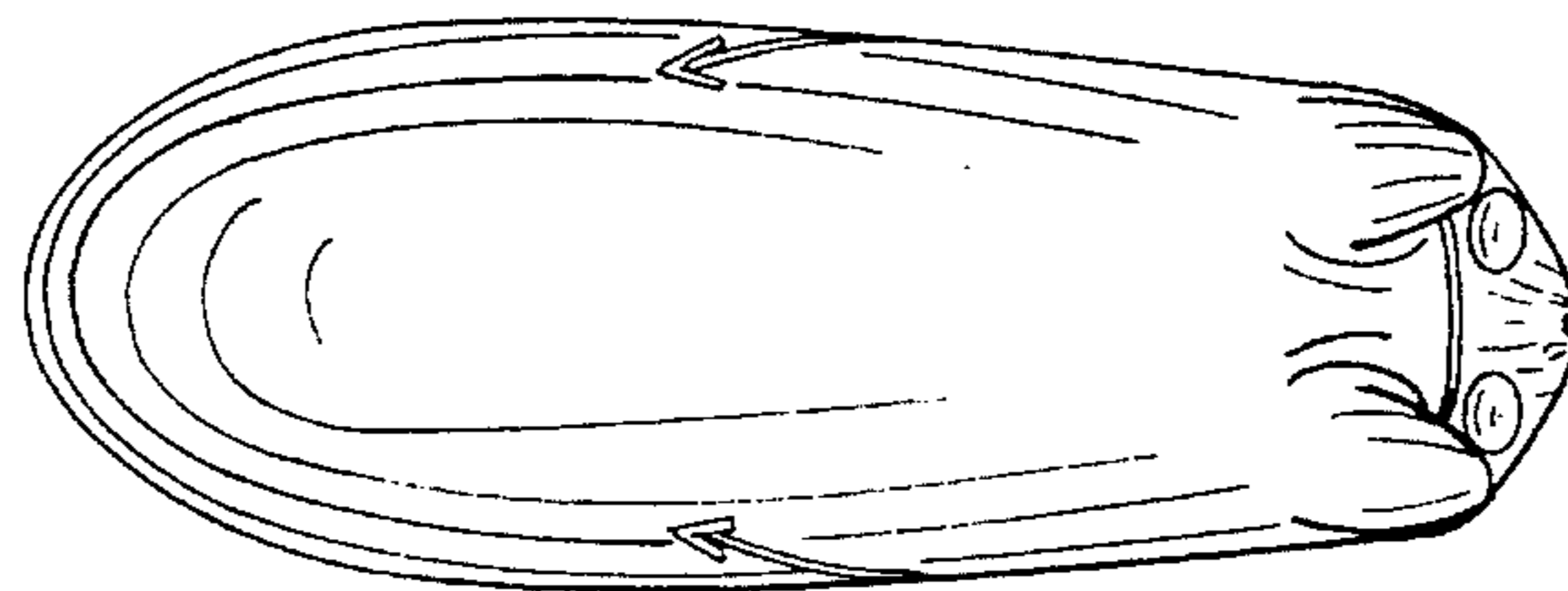
