[57] **CLAIM**

The ornamental design for a combined pendant and opener for a split ring key holder, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a combined pendant and opener for a split ring key holder showing my new design; FIG. 2 is a right side view; FIG. 3 is a left side view; FIG. 4 is a front elevation view; and, FIG. 5 is a perspective view shown in a position of use, the broken line showing of a key ring is for illustrative purposes only and forms no part of the claimed design.

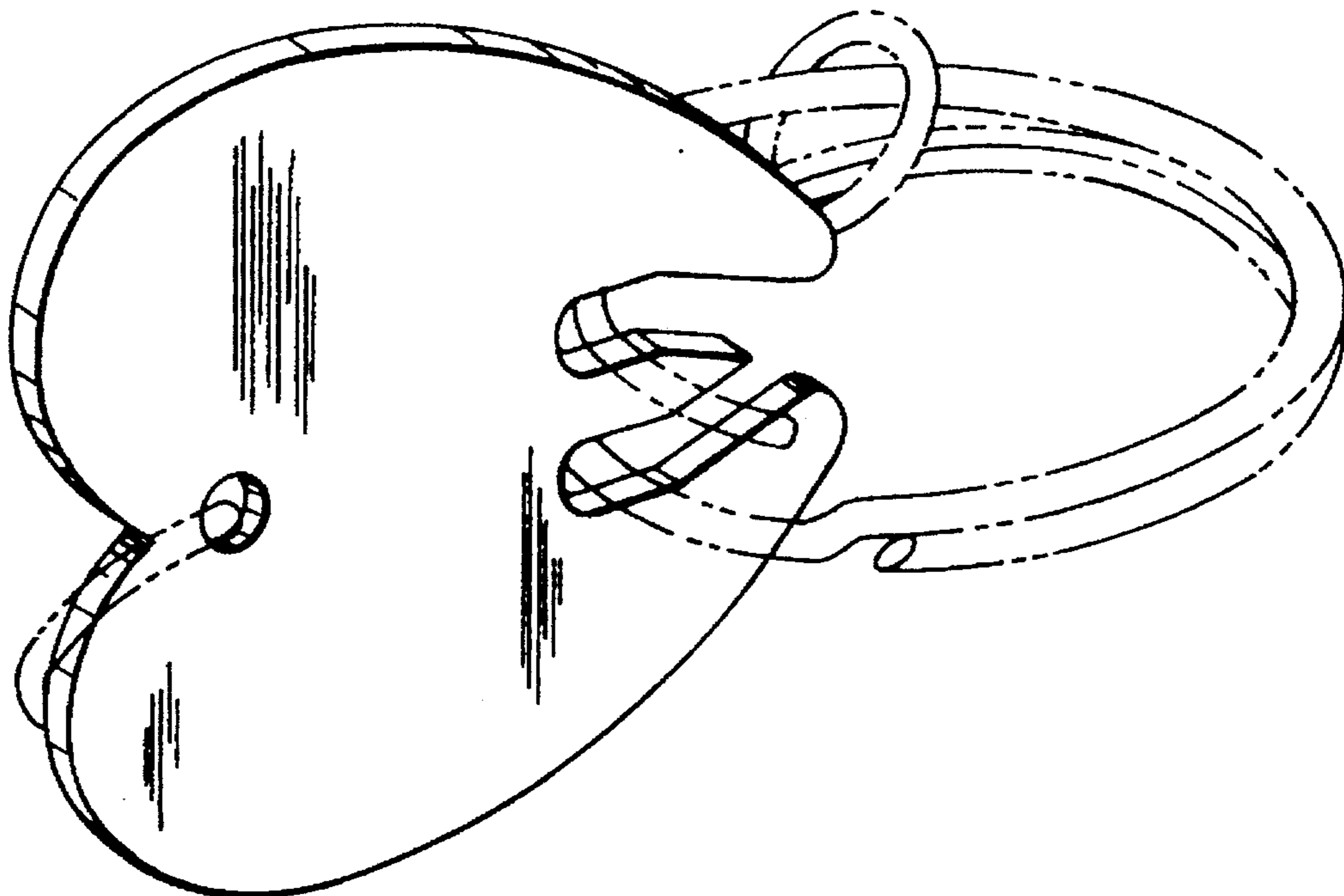

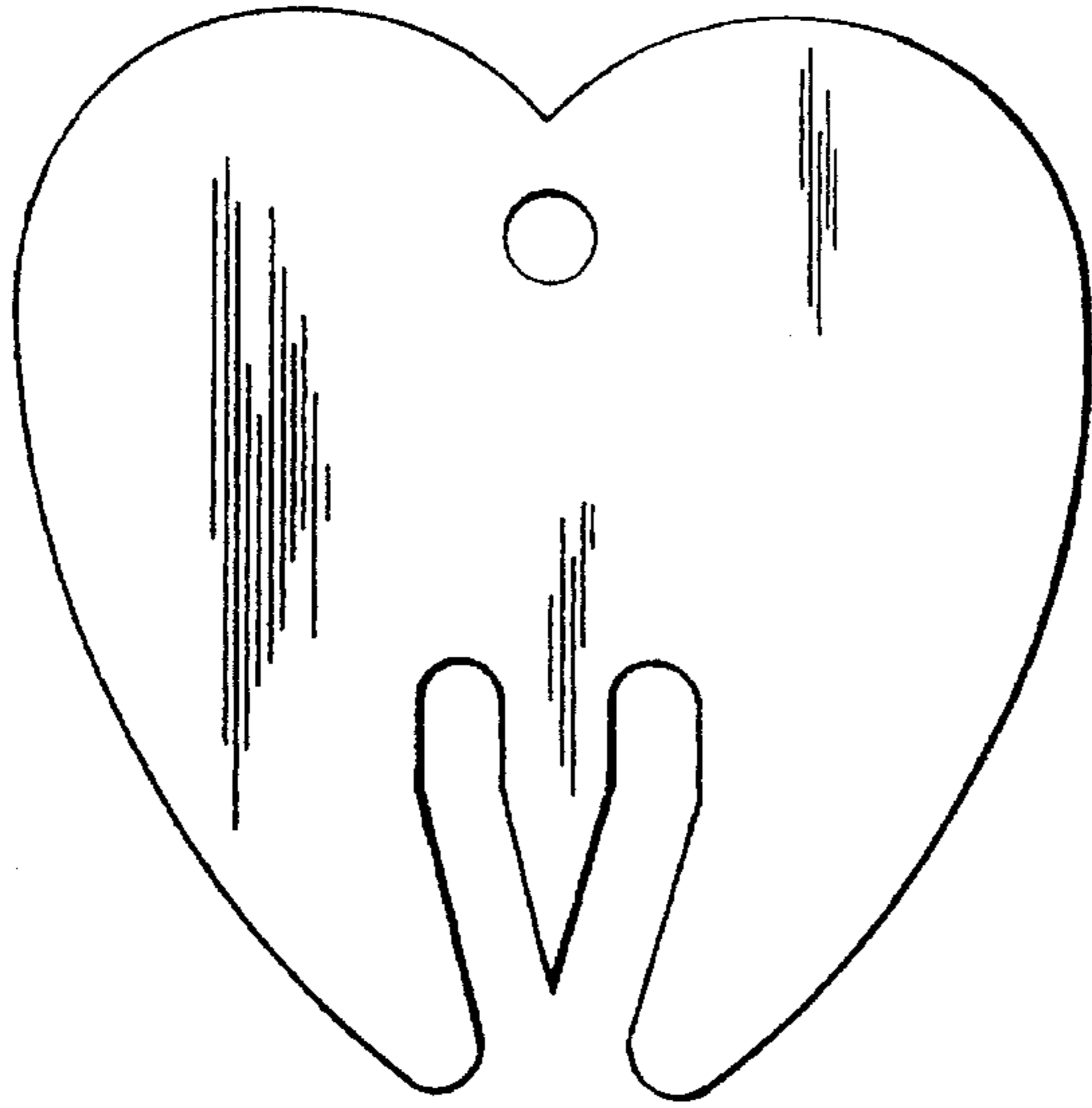
