[57] CLAIM

The ornamental design for ninety degree spout, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the spout of the present invention;
 FIG. 2 is a top plan view of the spout shown in FIG. 1;
 FIG. 3 is a rear elevational view of the spout shown in FIG. 1;
 FIG. 4 is a left side elevational view of the spout shown in FIG. 1, the right side view being a mirror image thereof;
 FIG. 5 is a bottom plan view of the spout shown in FIG. 1;
 FIG. 6 is a front elevational view of the spout shown in FIG. 1;
 FIG. 7 is a perspective view of the spout shown in FIG. 1 inserted into a top of a container; and,
 FIG. 8 is a perspective view of the spout shown in FIG. 7 at an open position.
 The broken line showing of a container top and triangular features is for illustrative purposes only and forms no part of the claimed design.

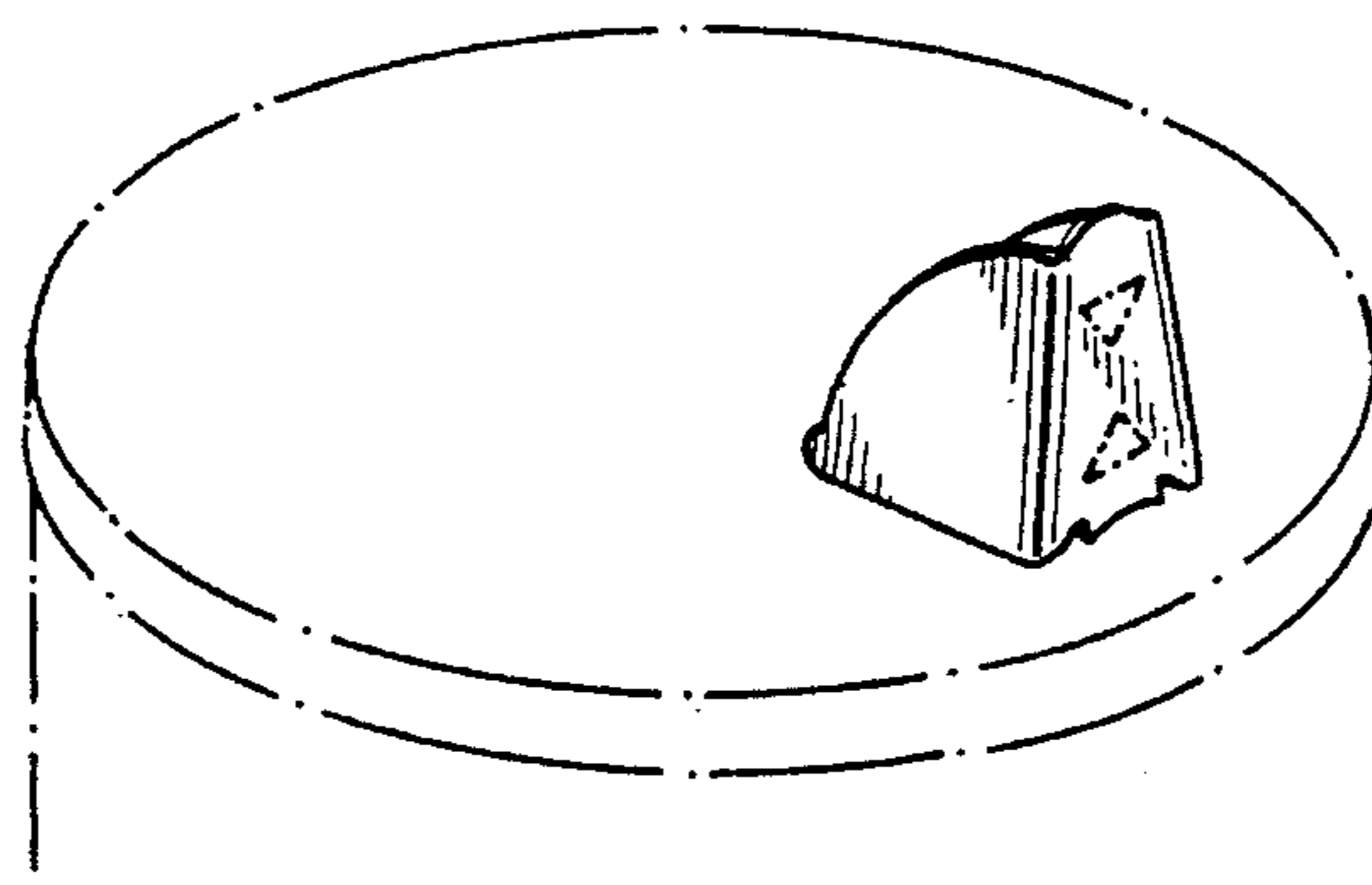
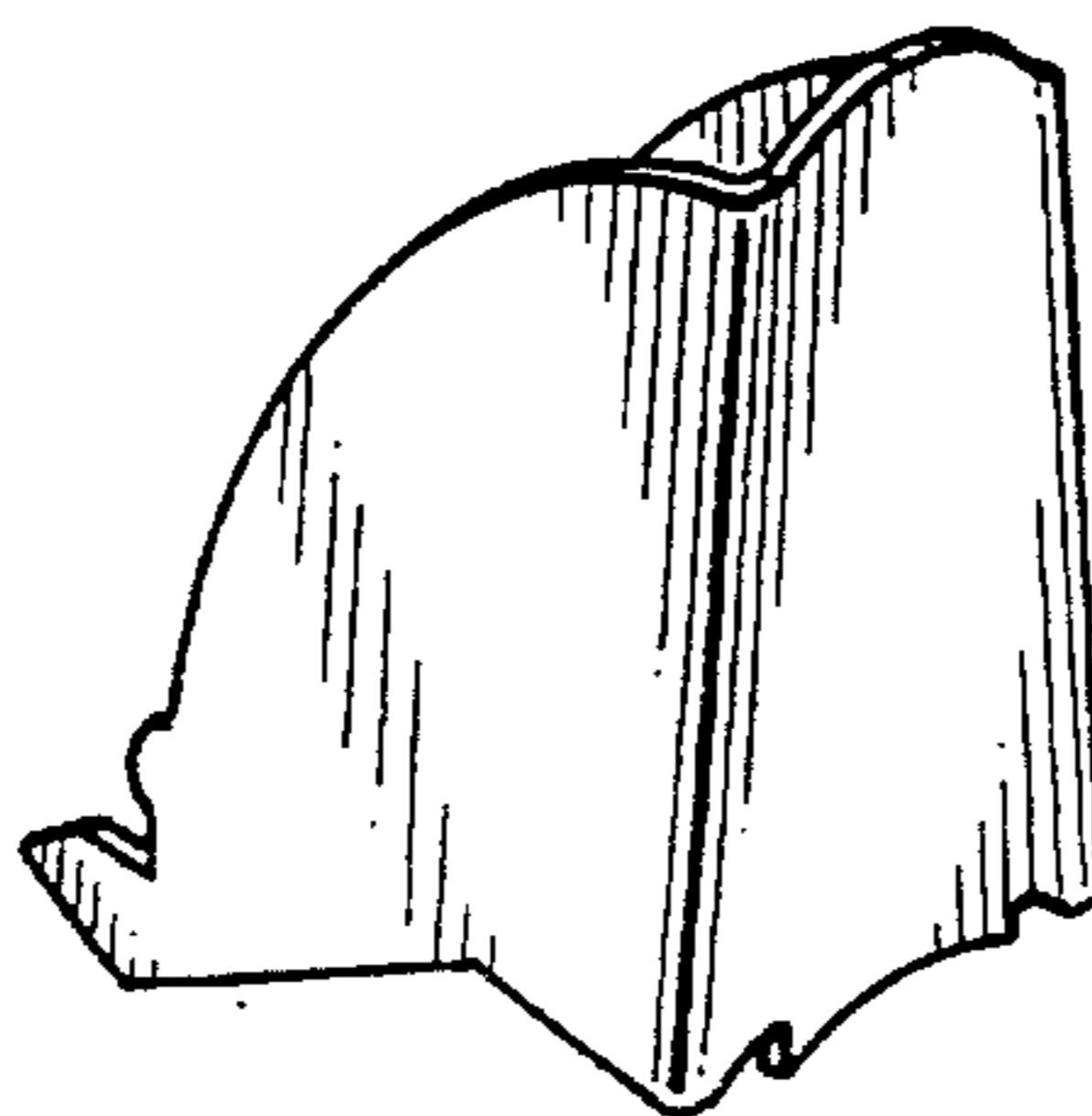

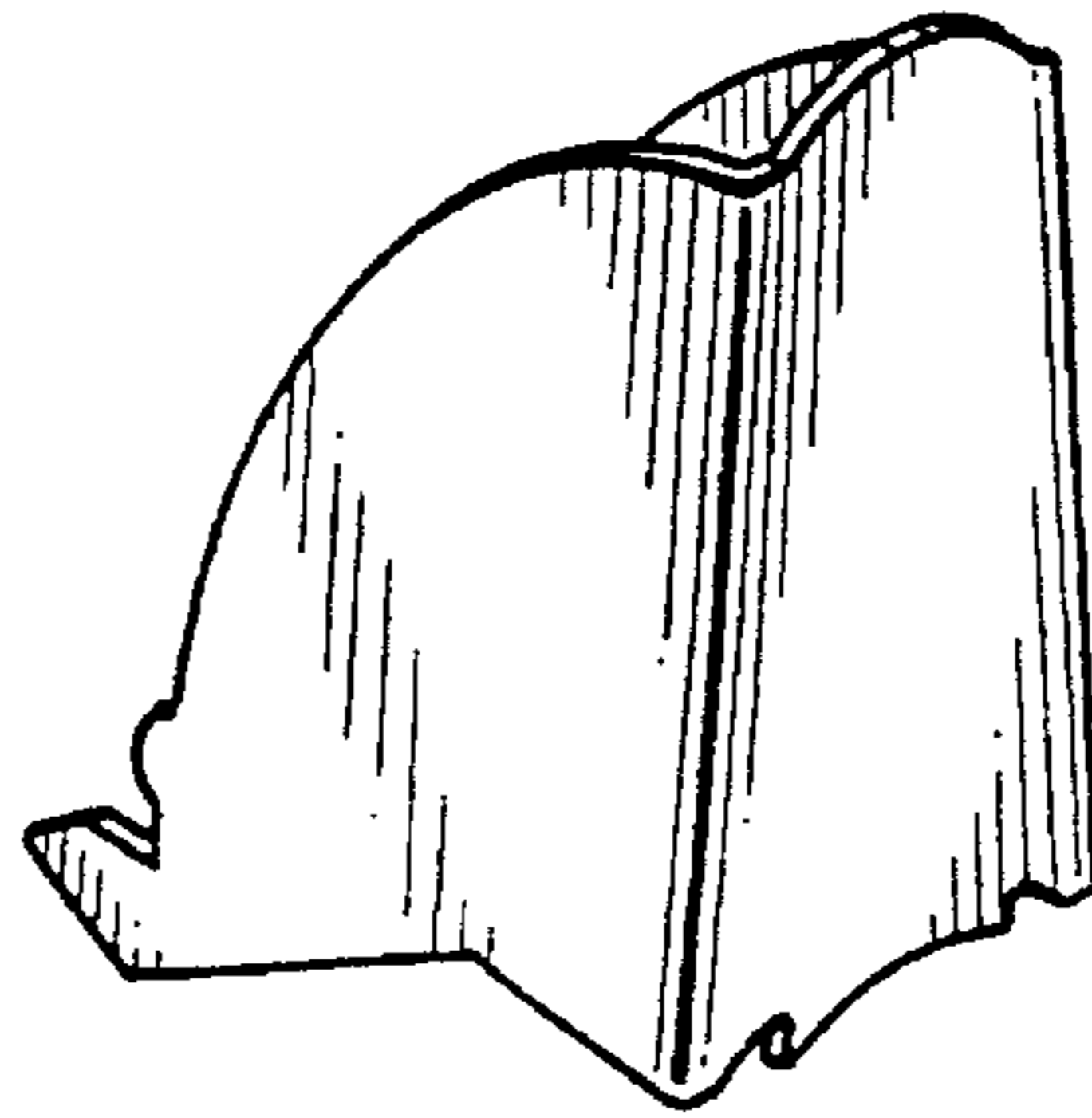

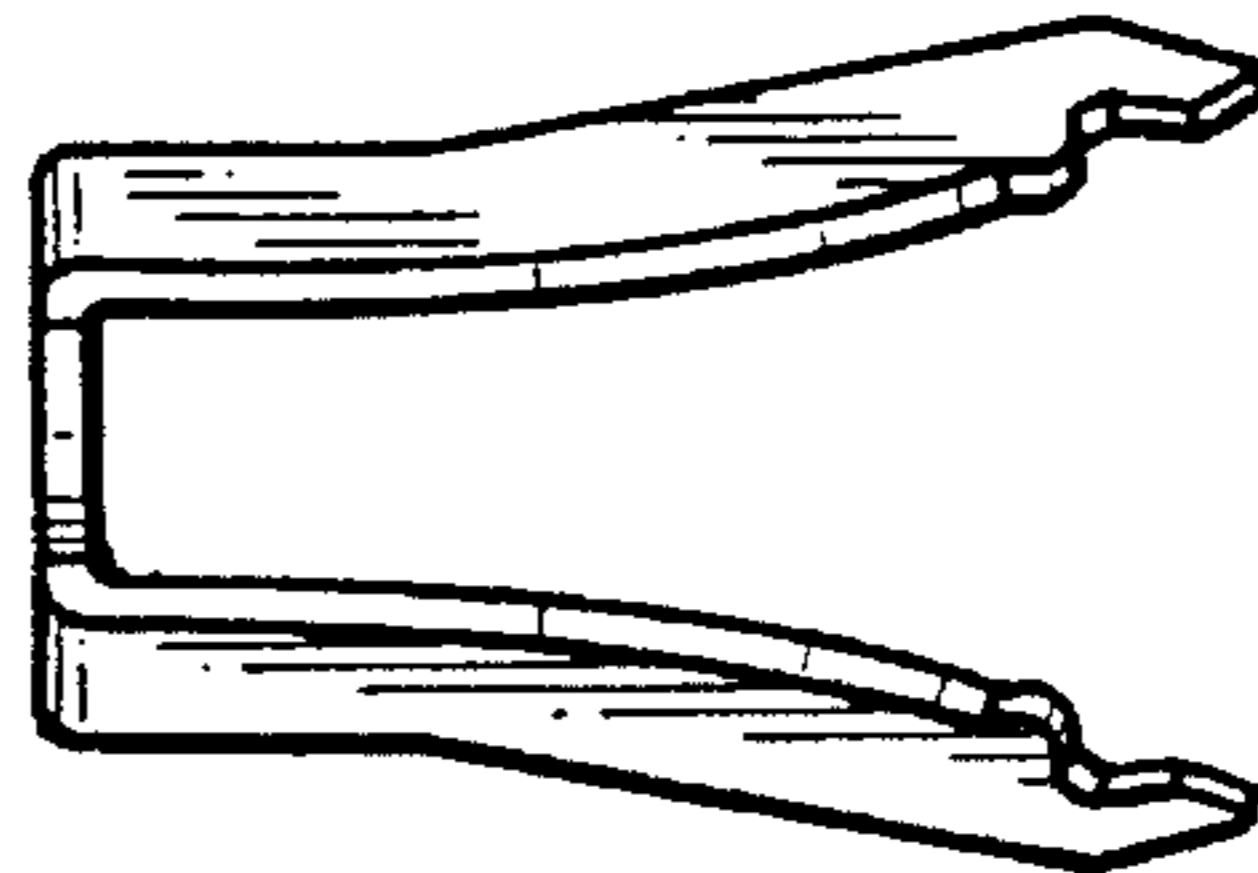

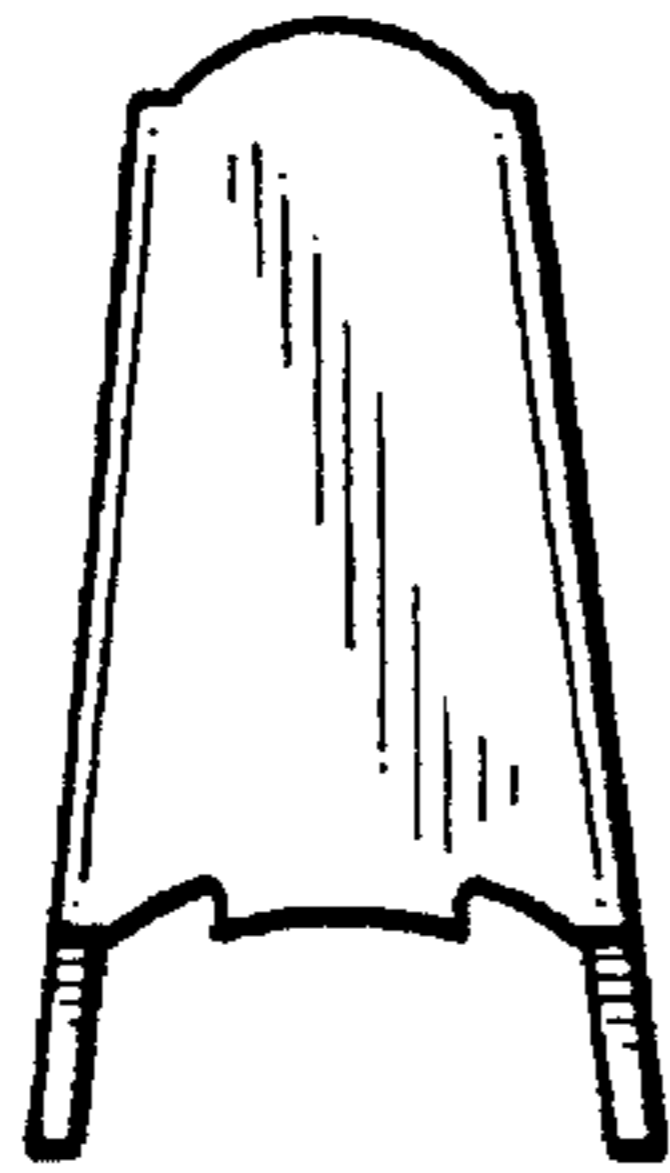

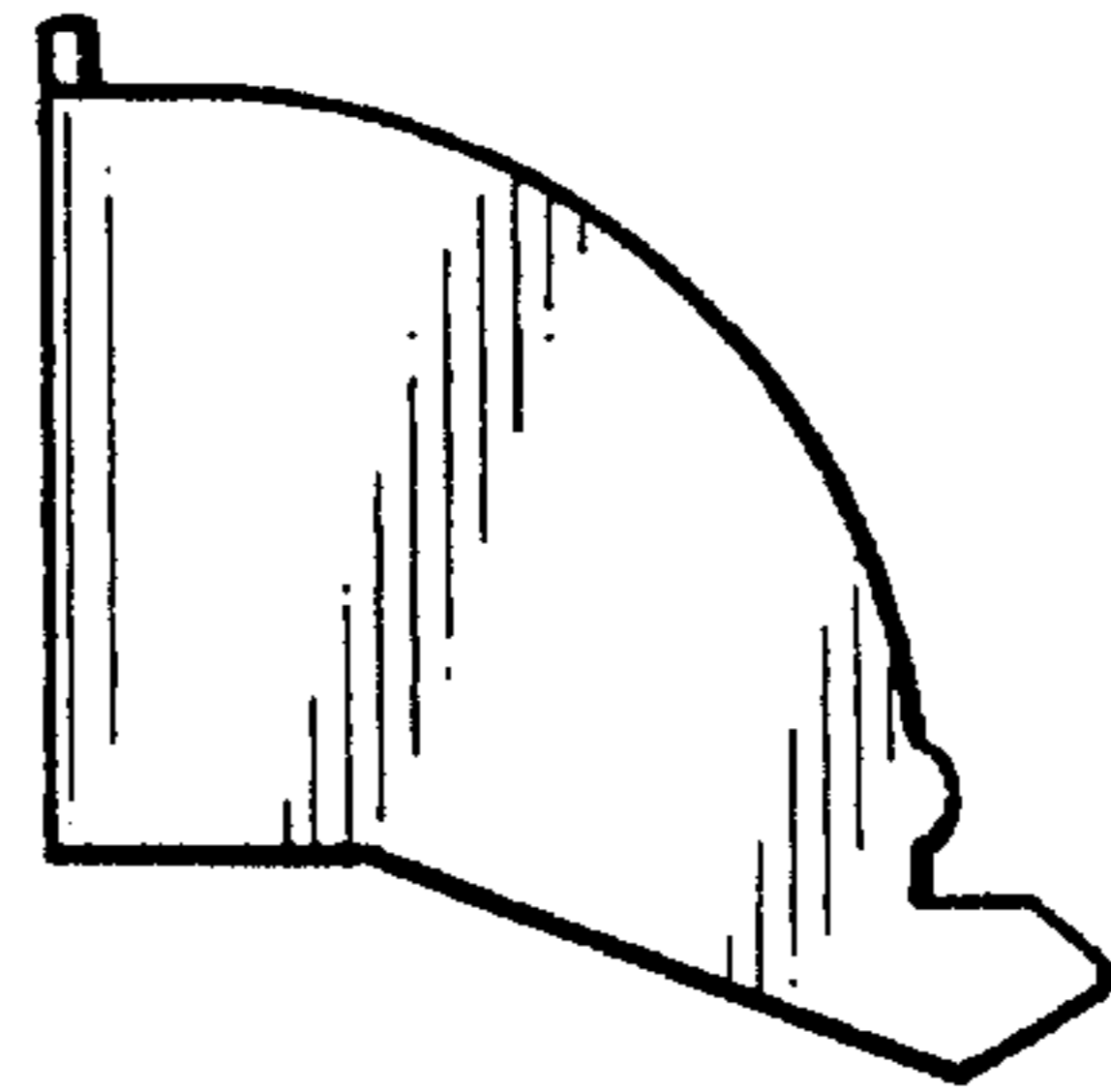

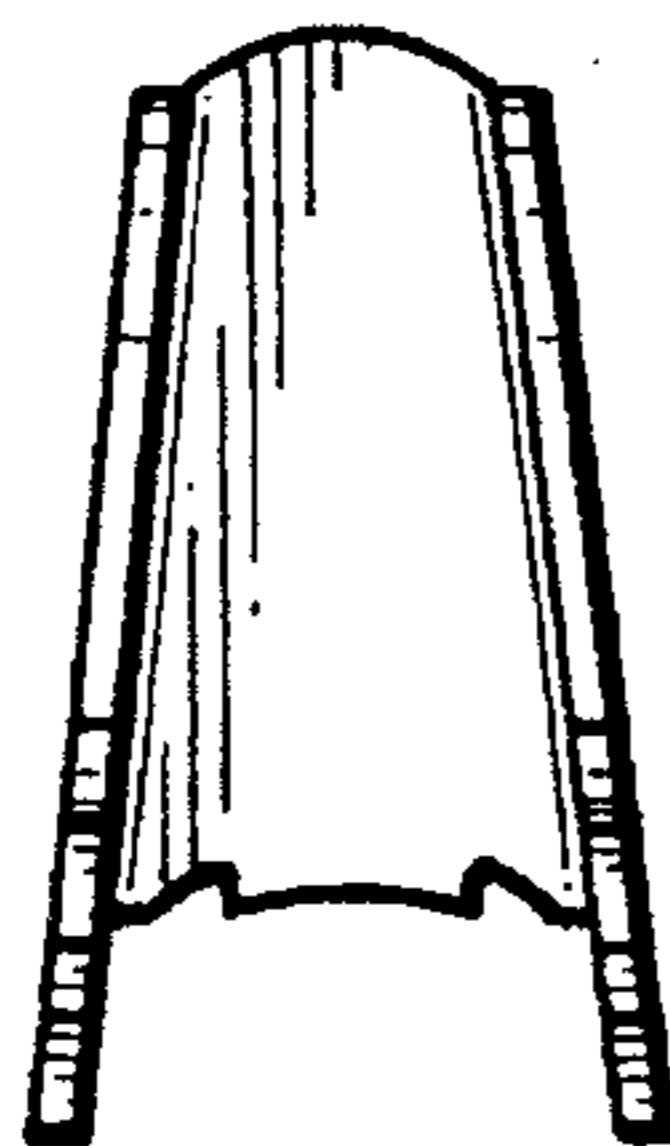

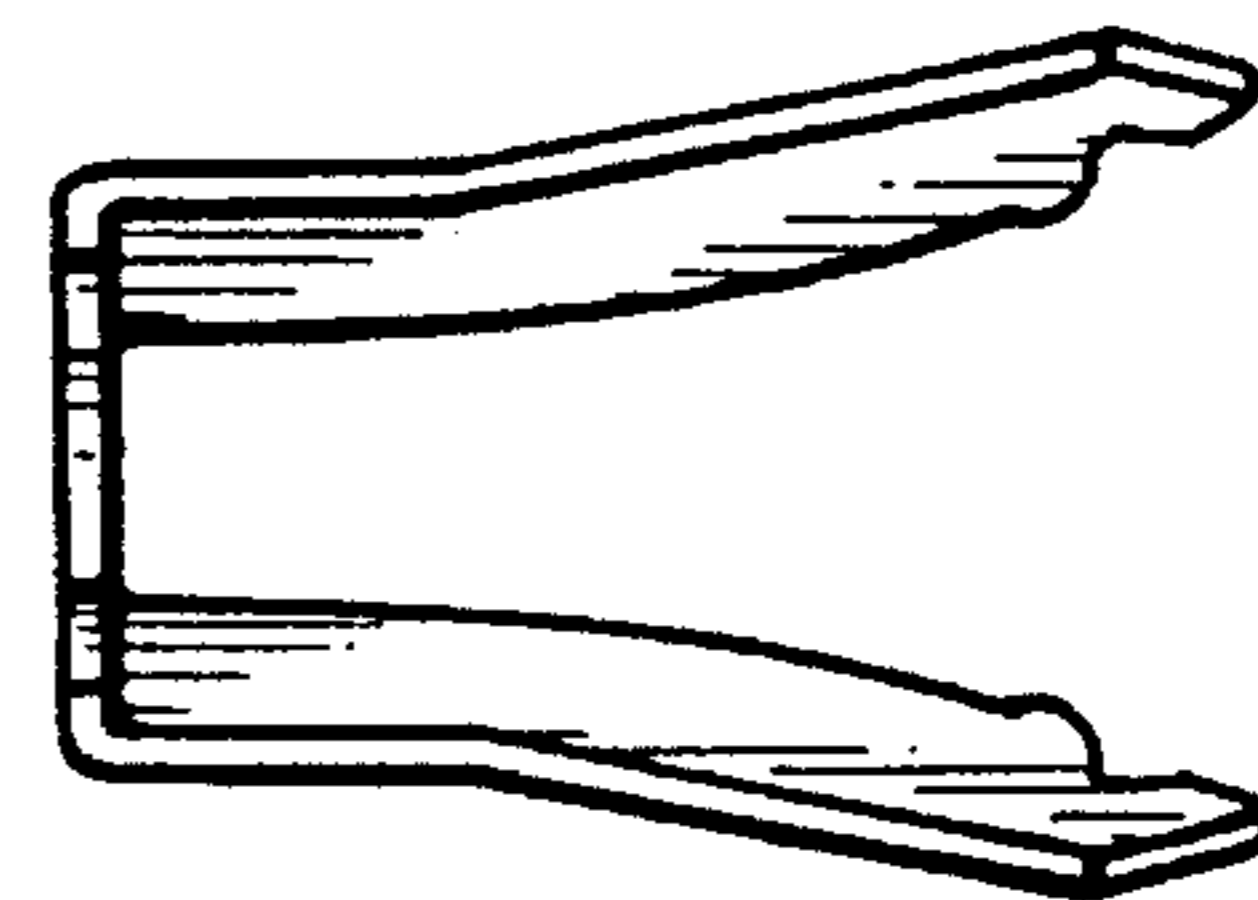

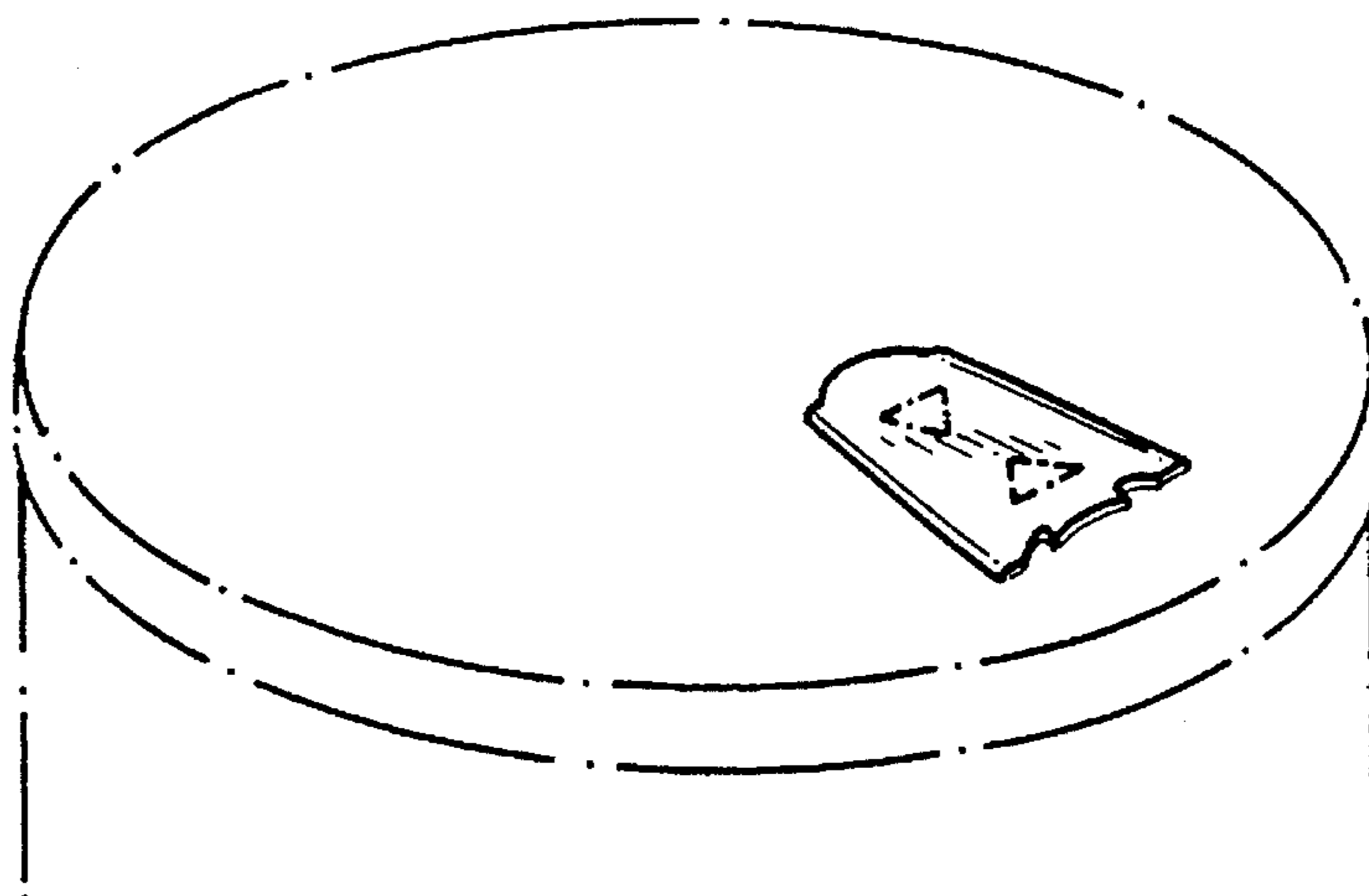
