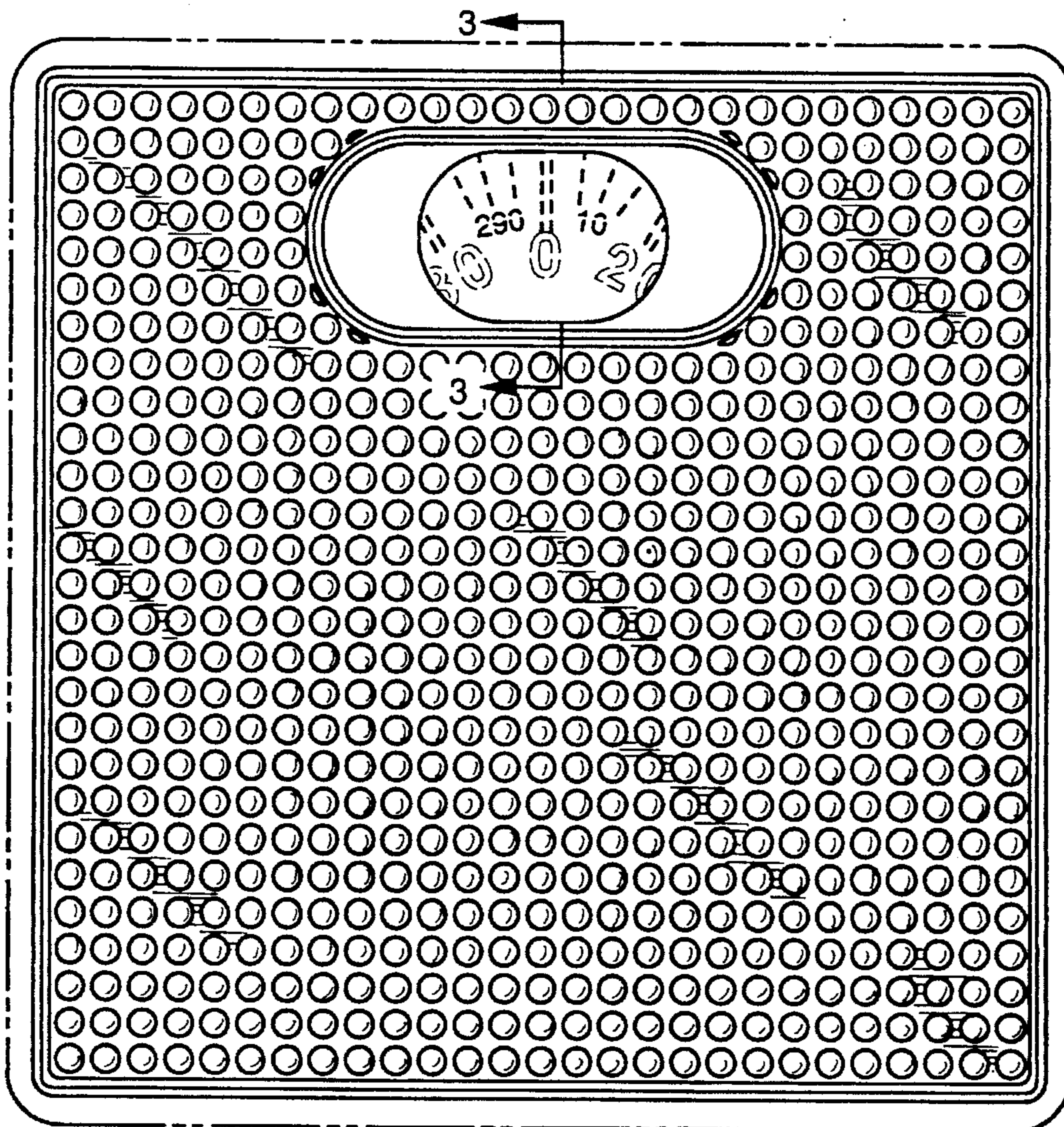
FIG. 8 is a partial sectional view of the mat shown in FIG. 6 along line 8—8;

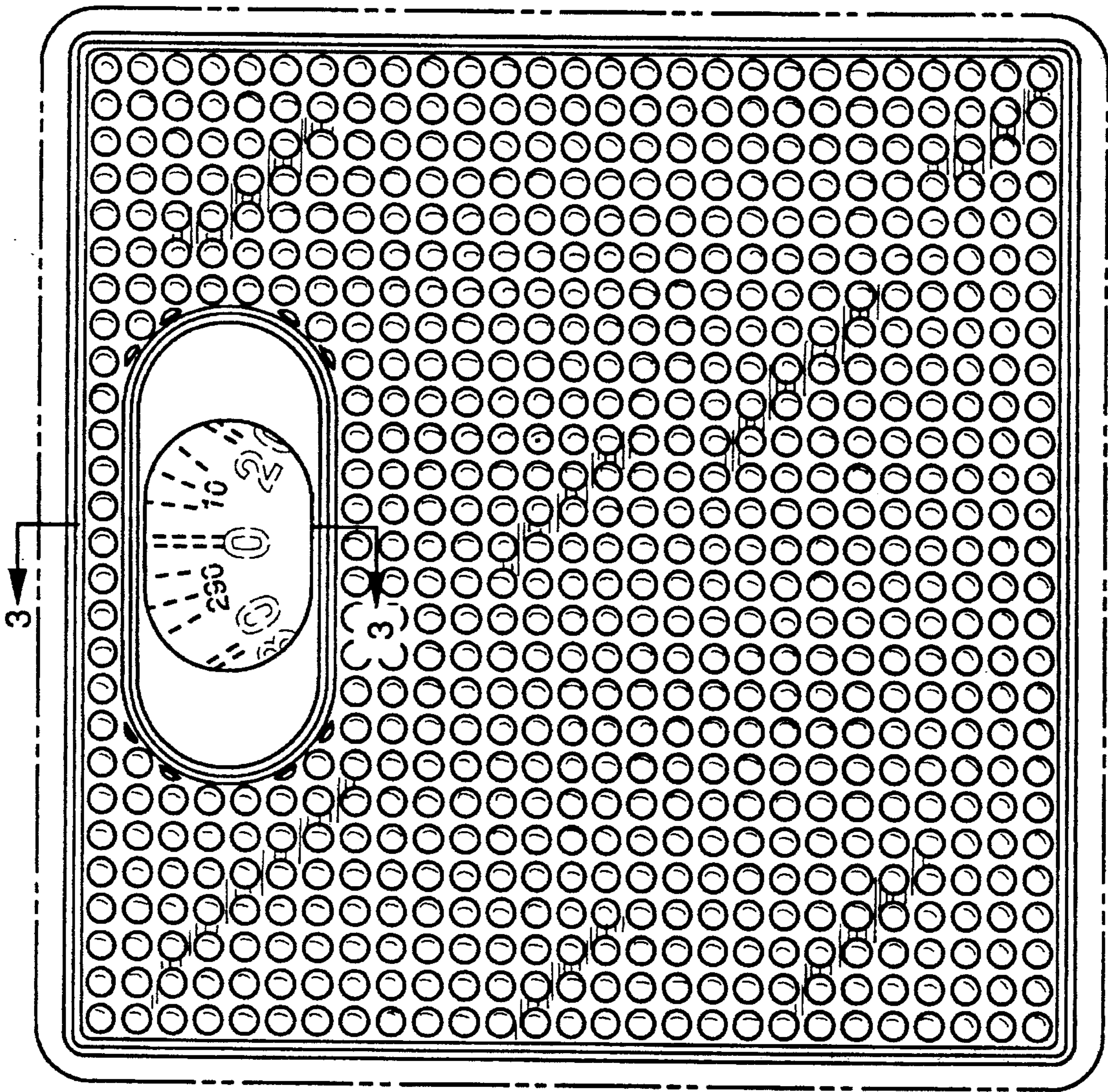

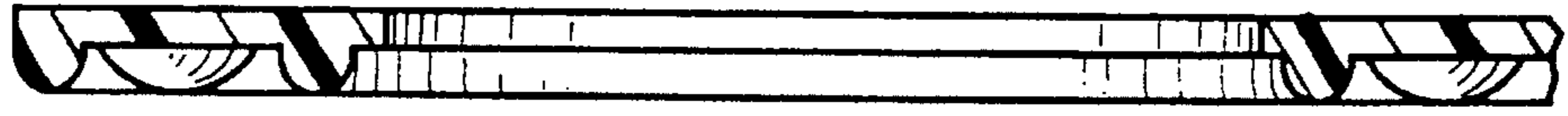

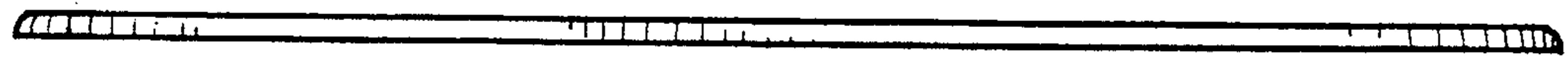

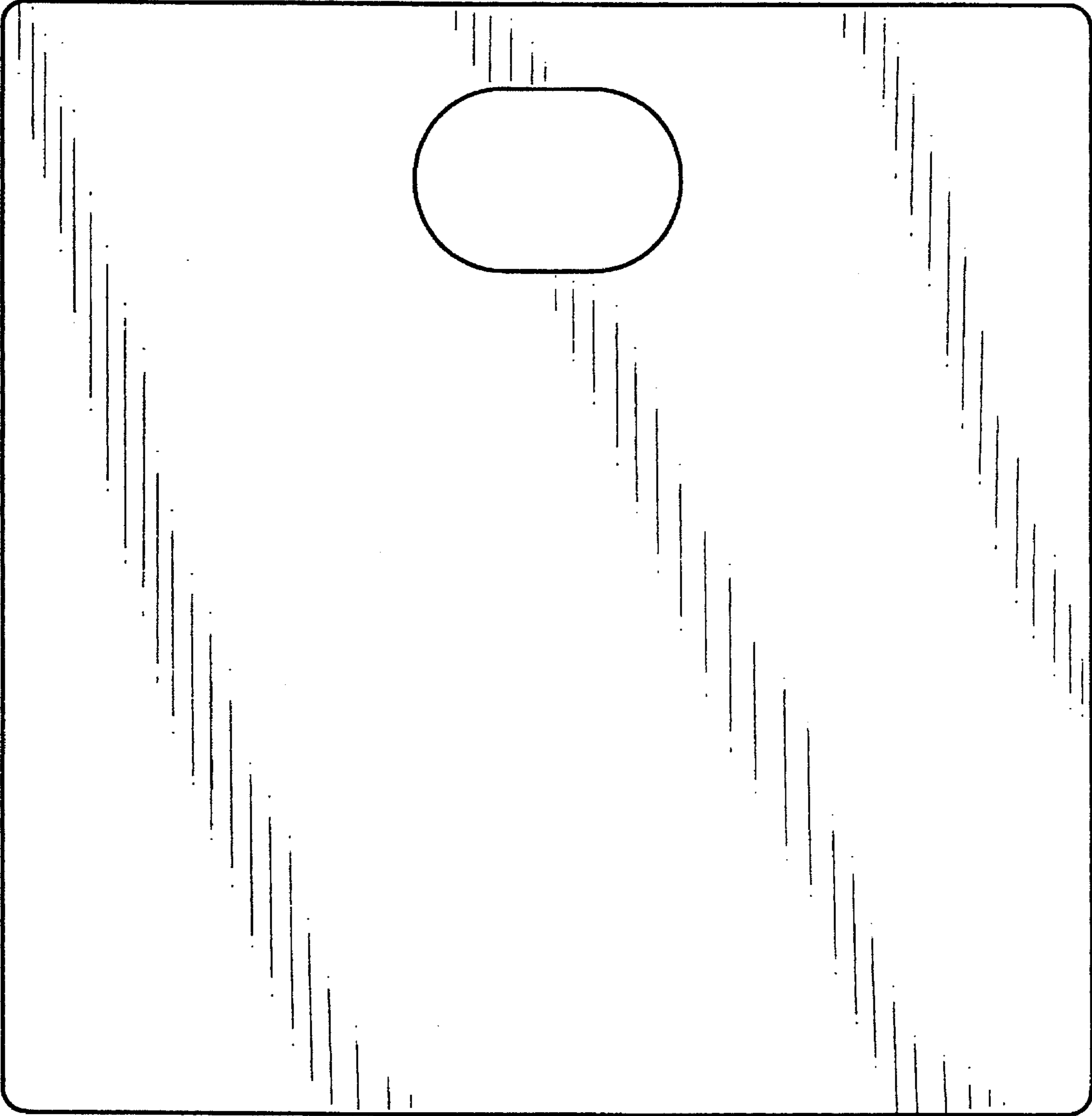

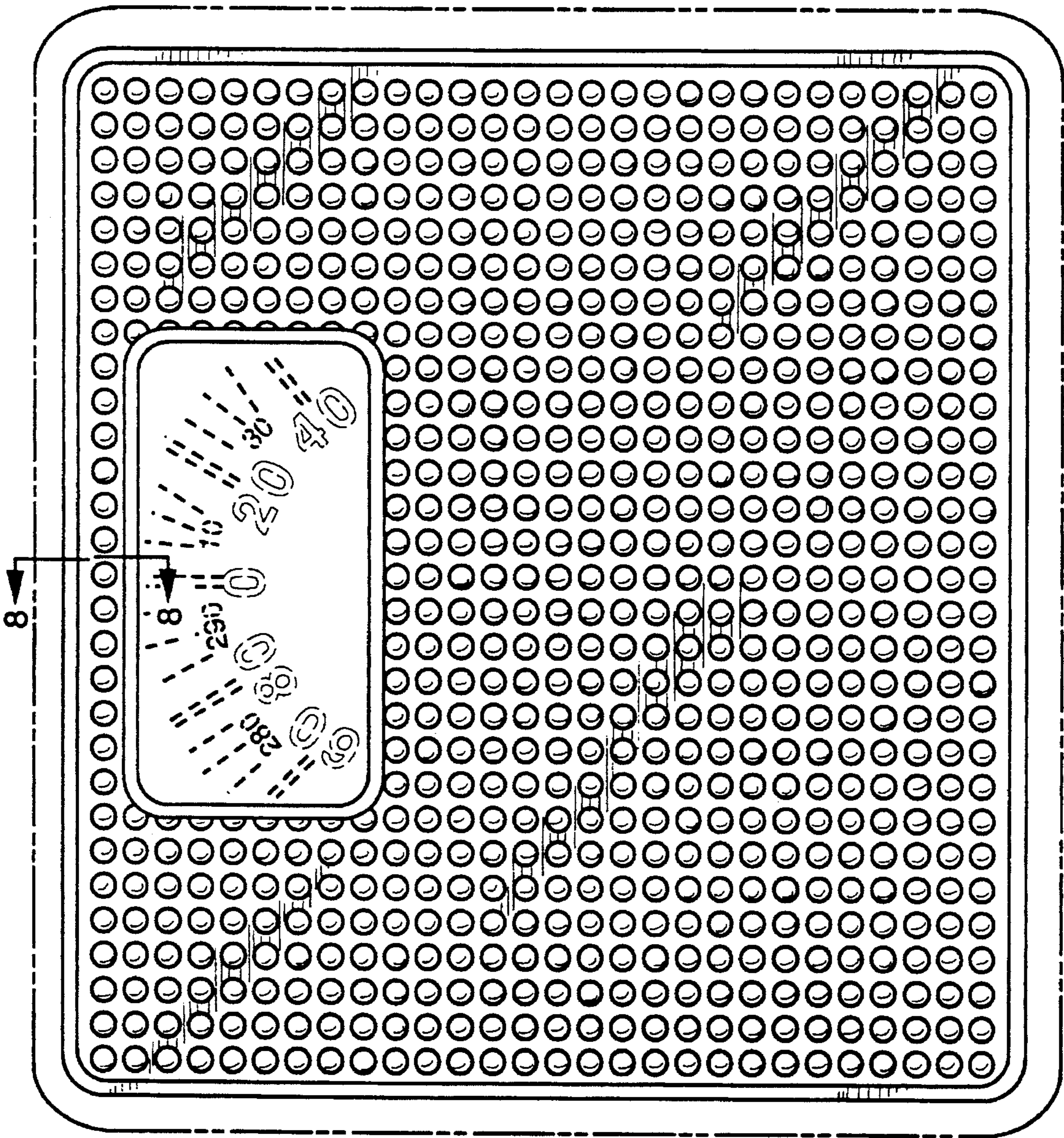

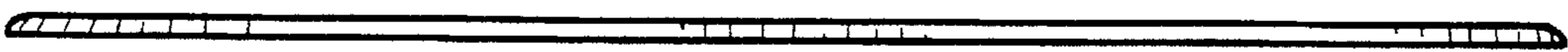

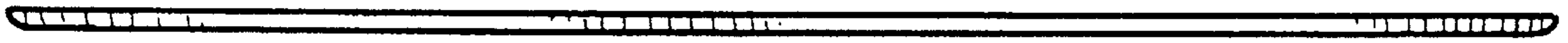

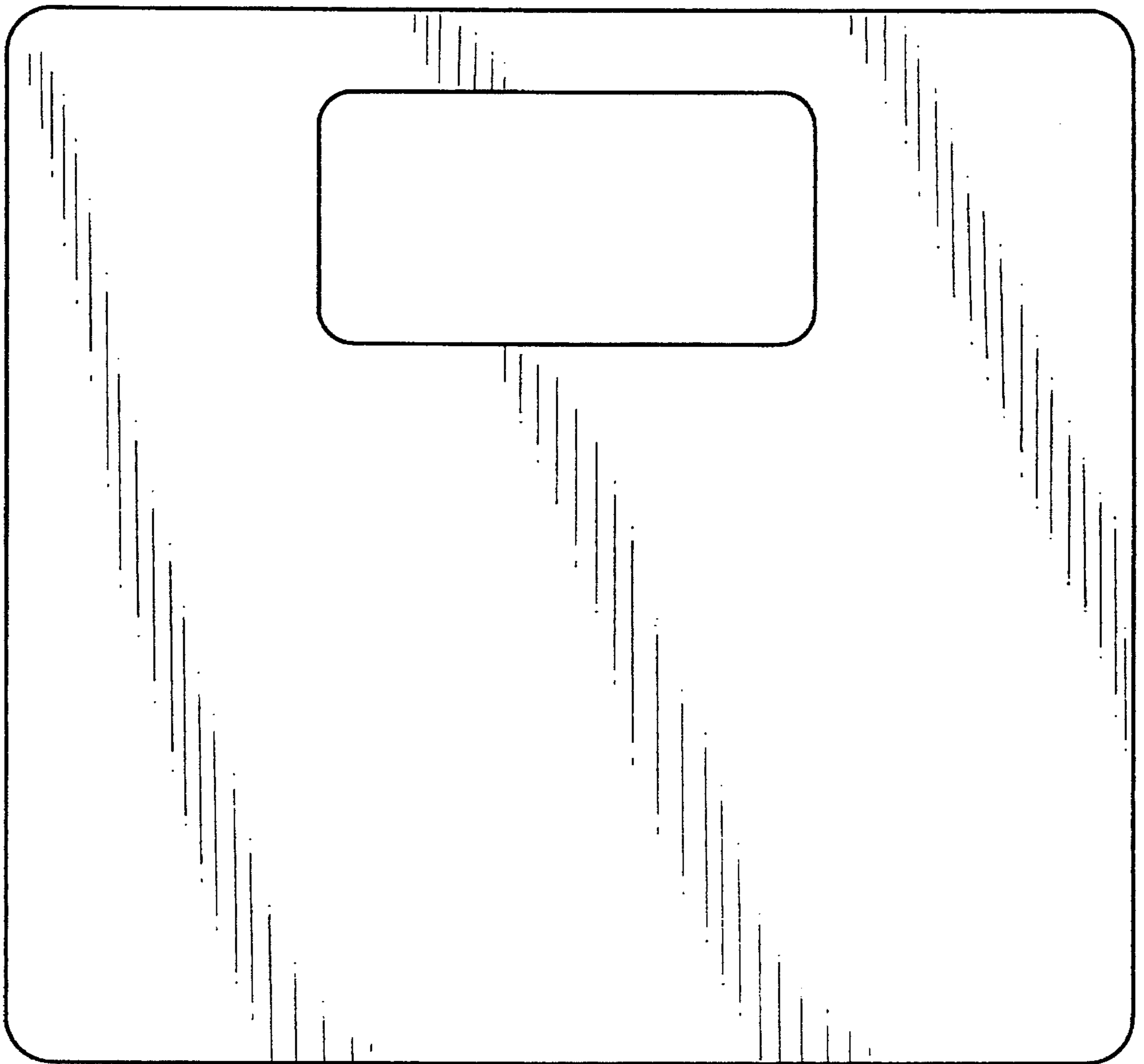
