## DESCRIPTION

FIG. 5 is a front elevational view thereof;  
FIG. 6 is a rear elevational view thereof;

FIG. 8 is a left side elevational view of the embodiment of FIG. 7, the opposite side is a mirror image of the side shown;  
FIG. 9 is a top plan view of FIG. 7;  
FIG. 10 is a bottom plan view of FIG. 7;  
FIG. 11 is a front elevational view of FIG. 7; and,  
FIG. 12 is a rear elevational view of FIG. 7.

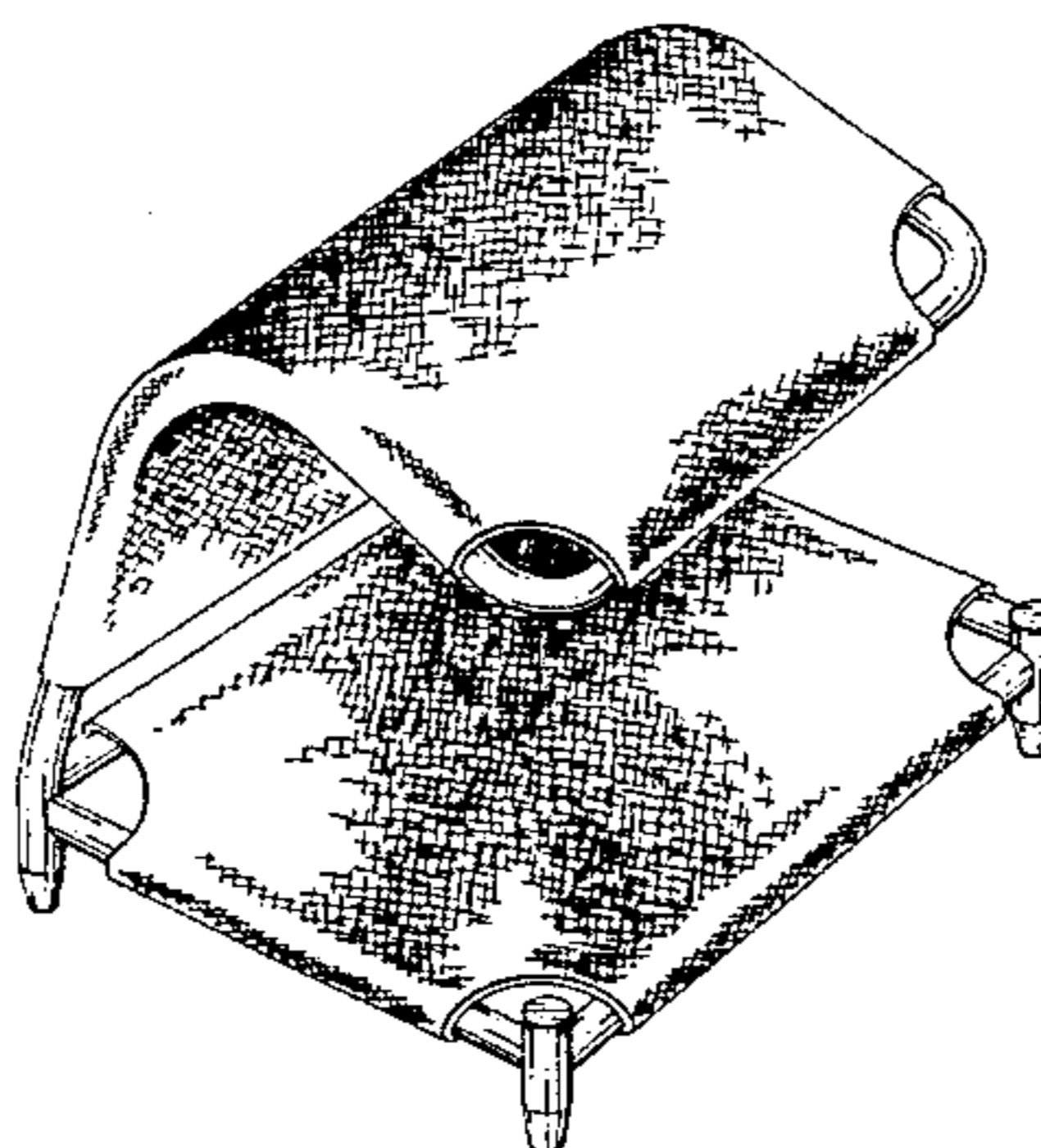
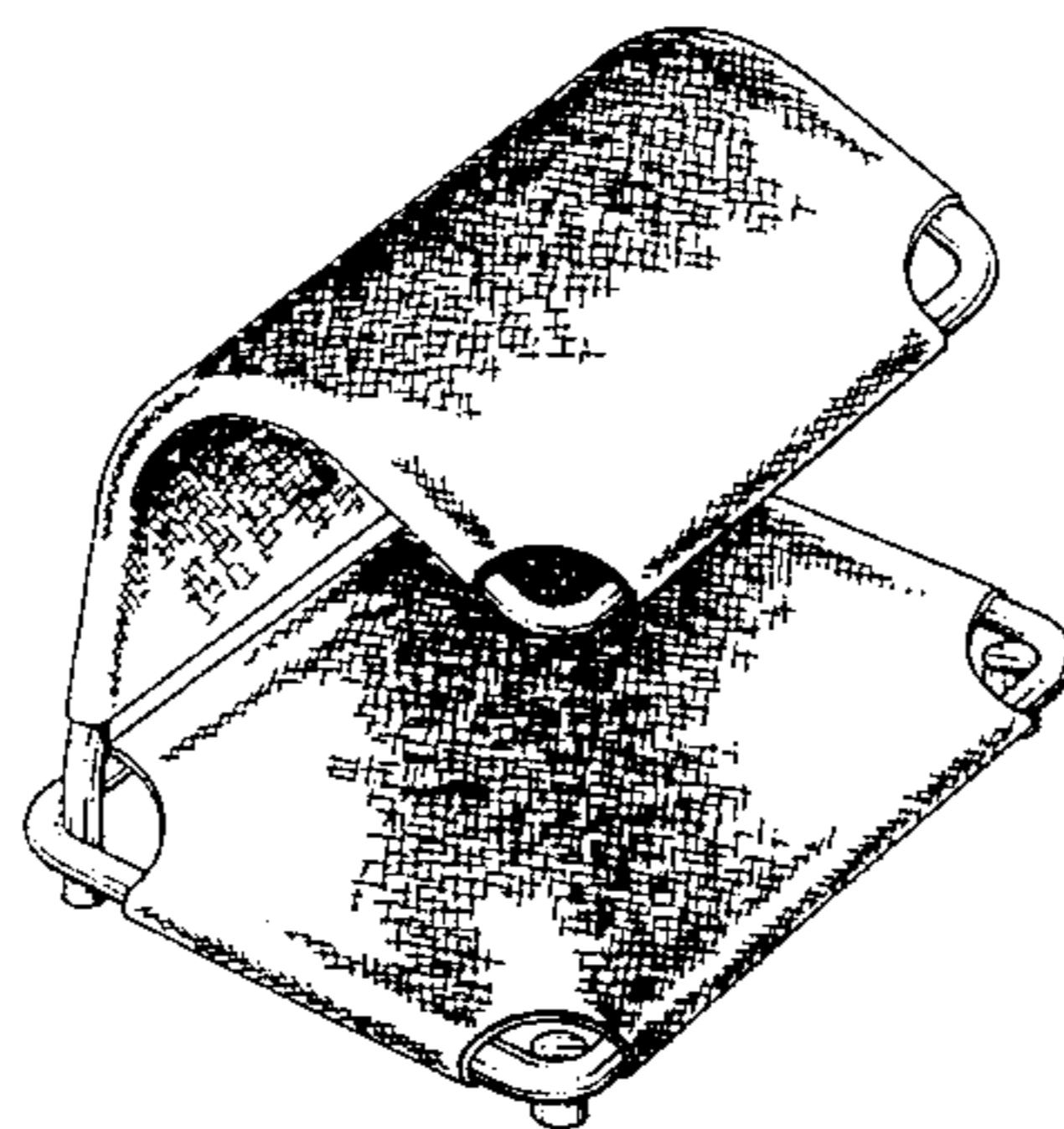

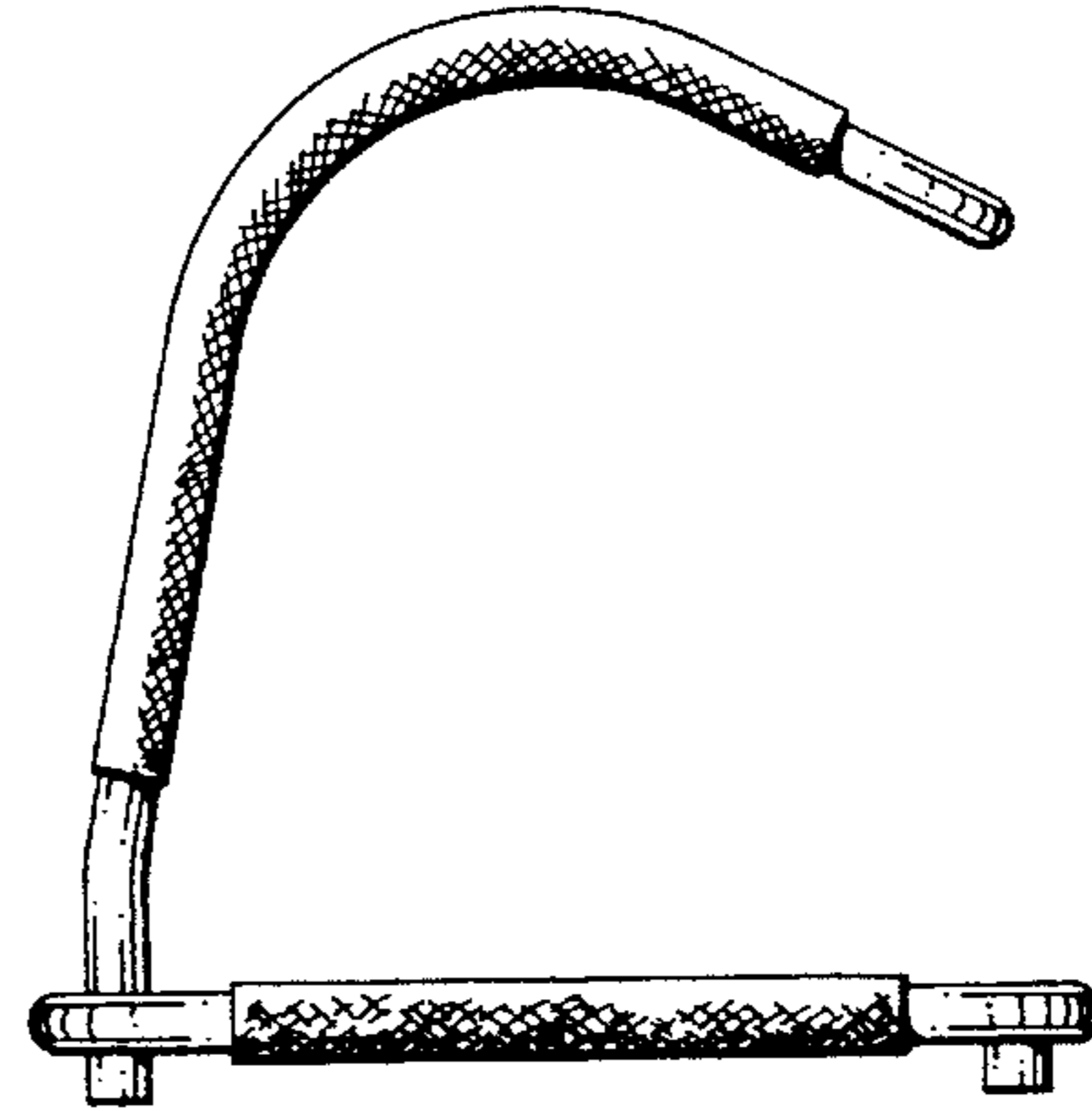
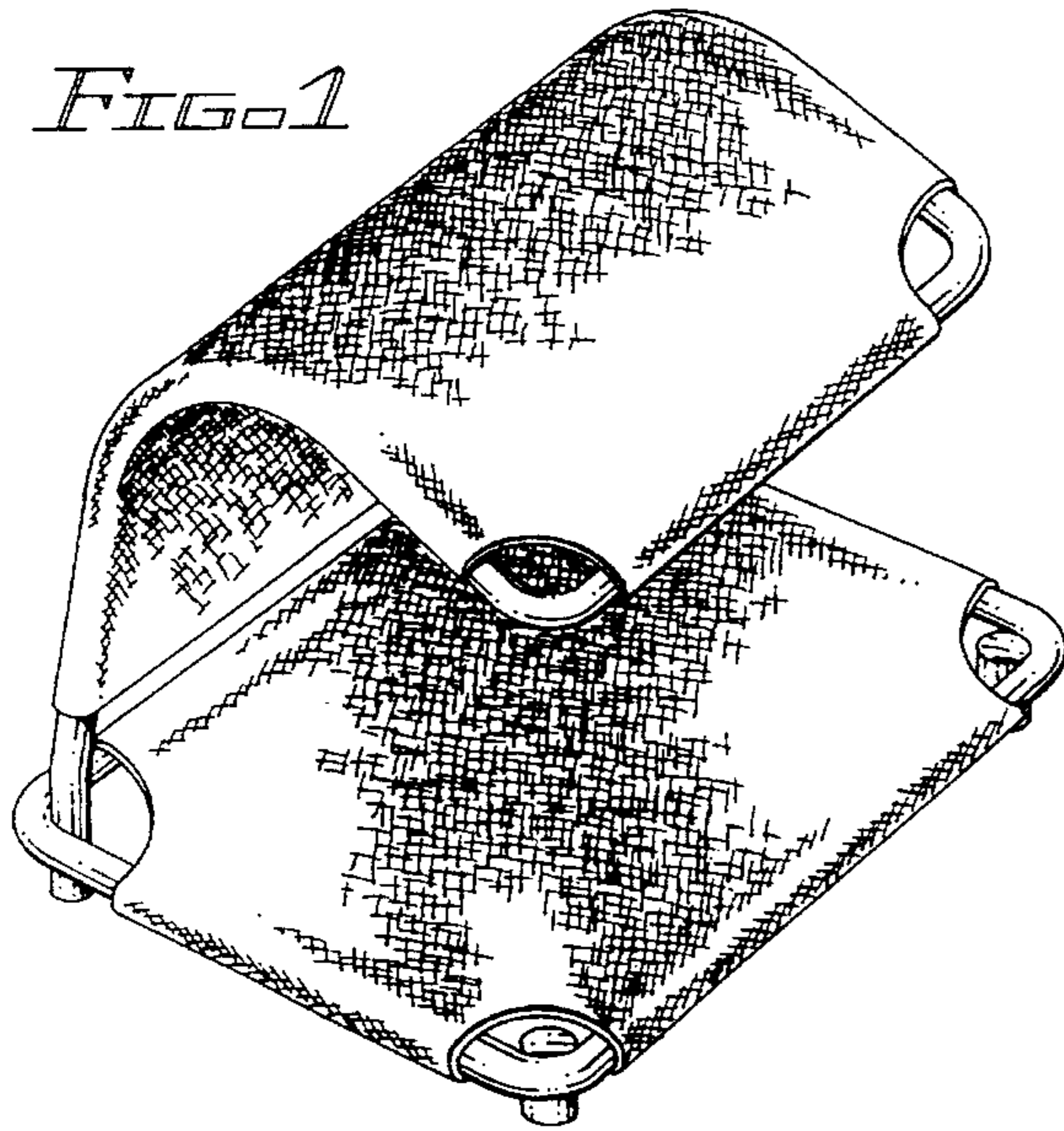

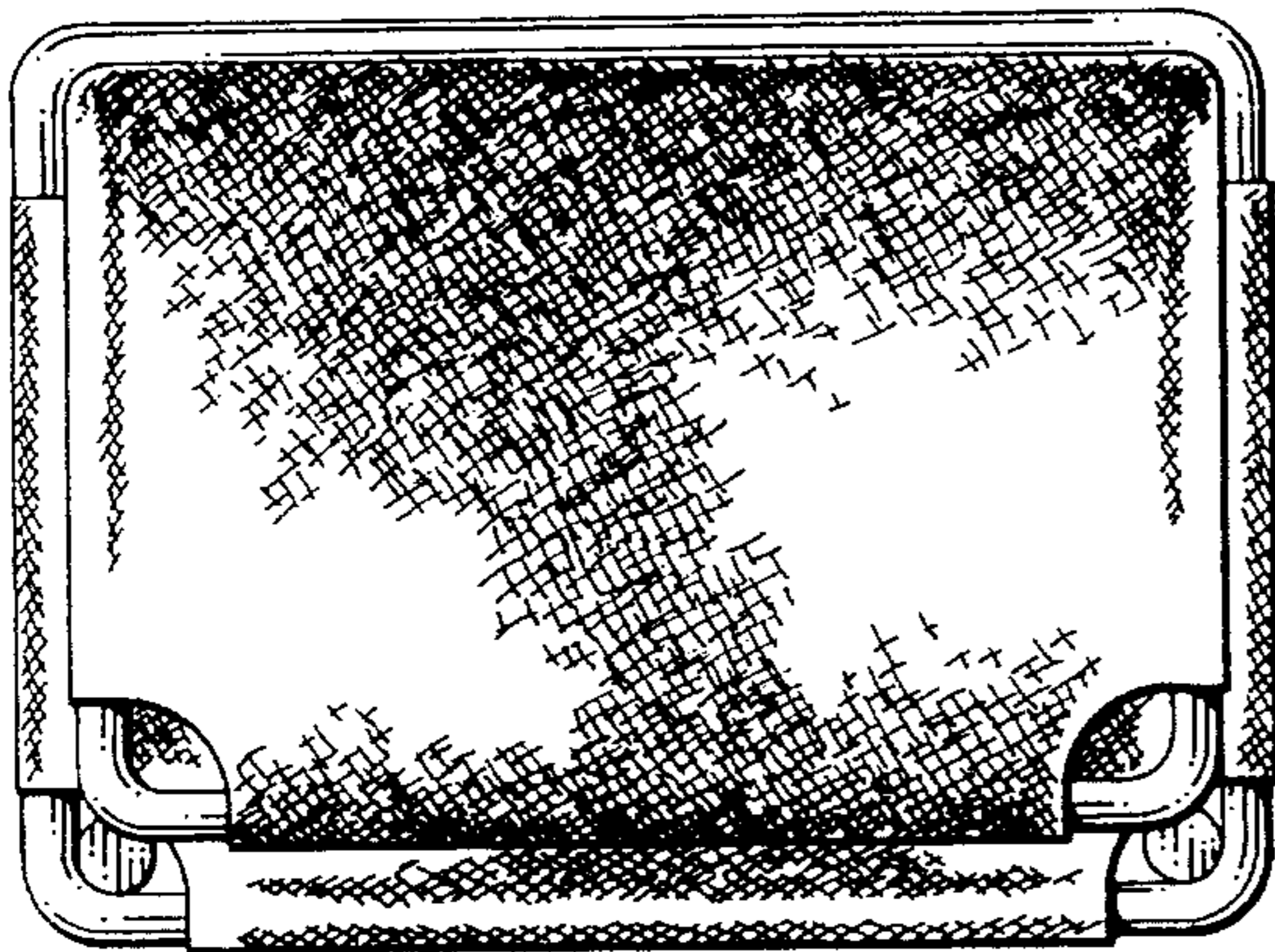

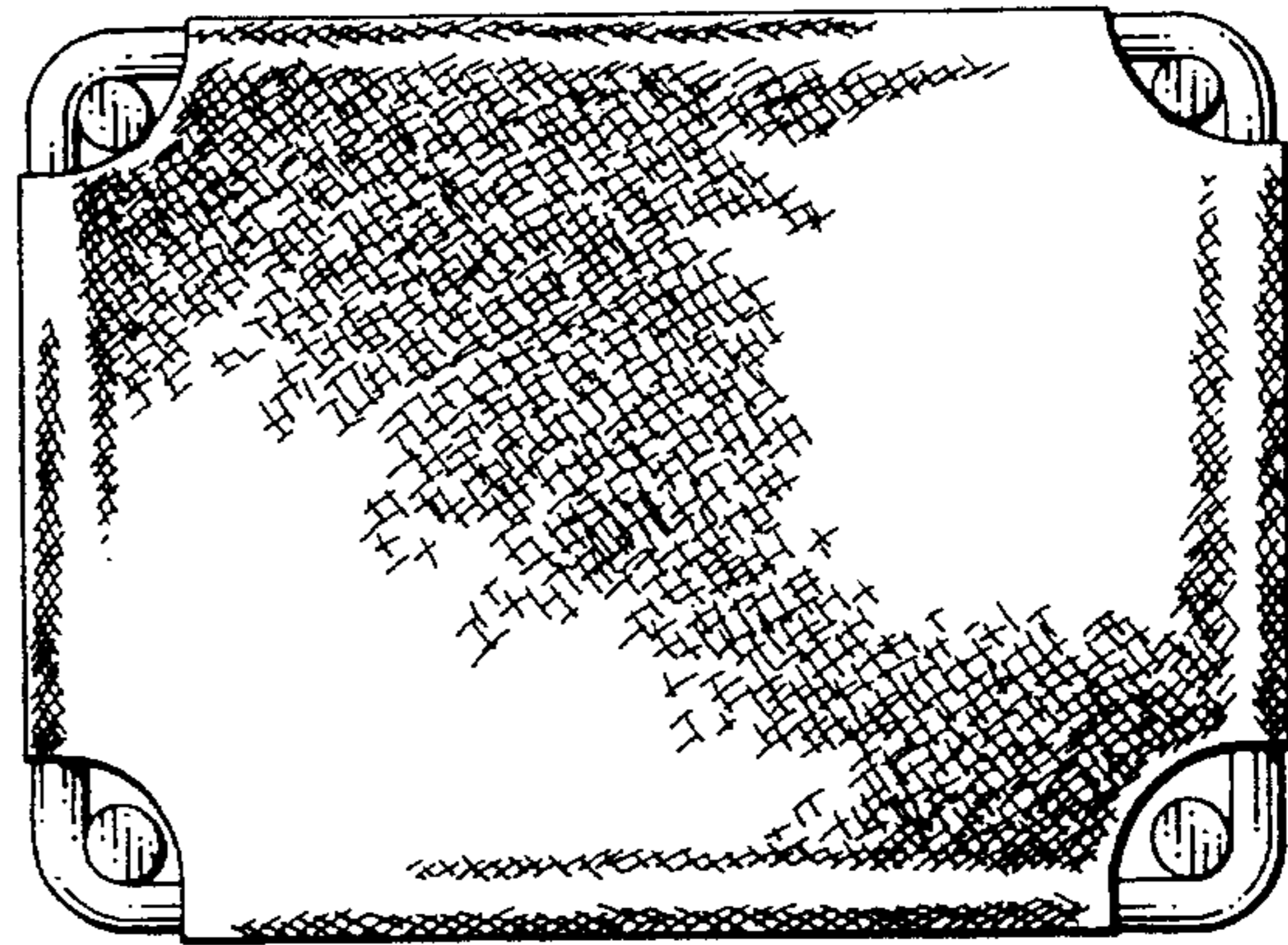




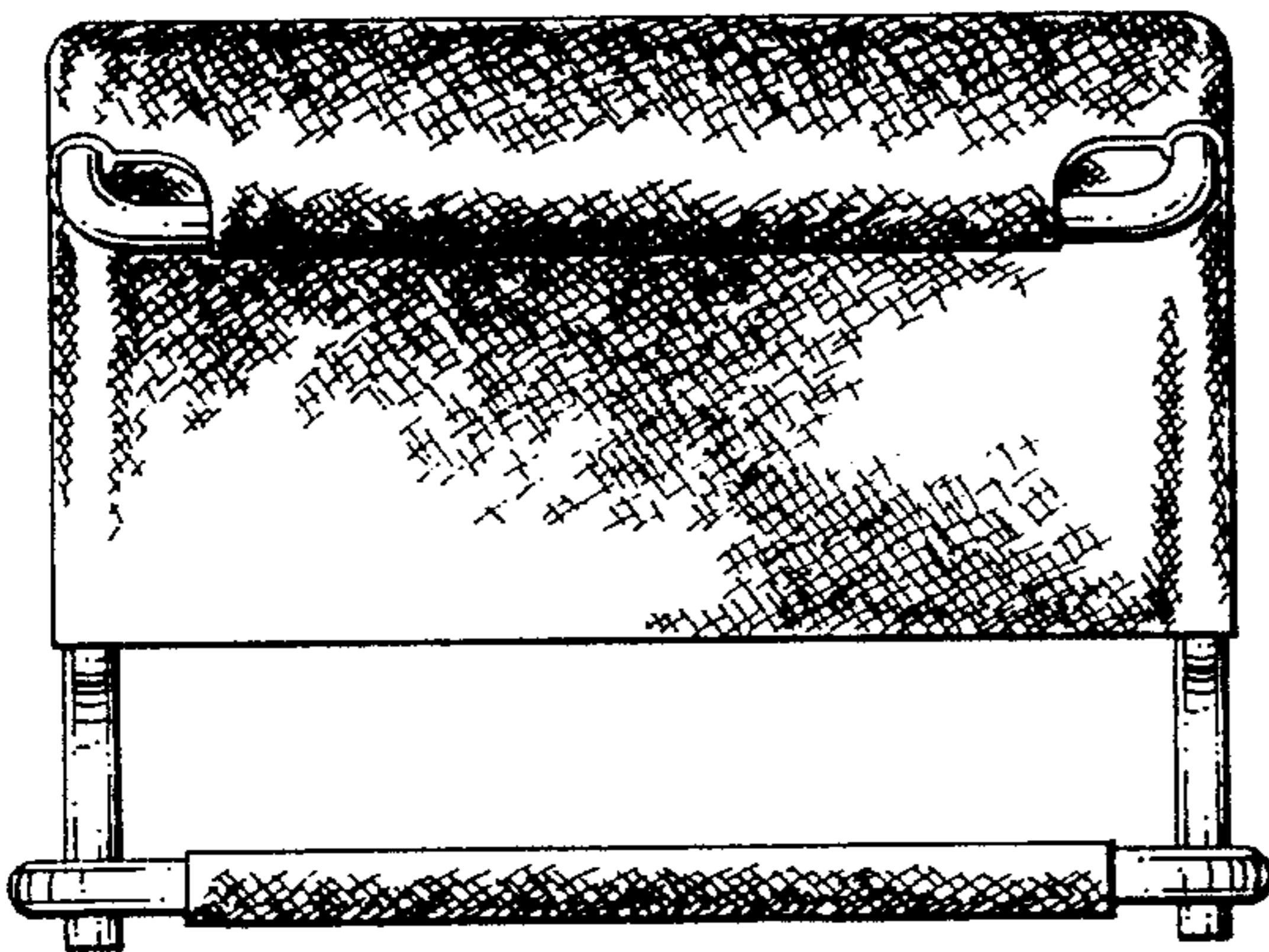

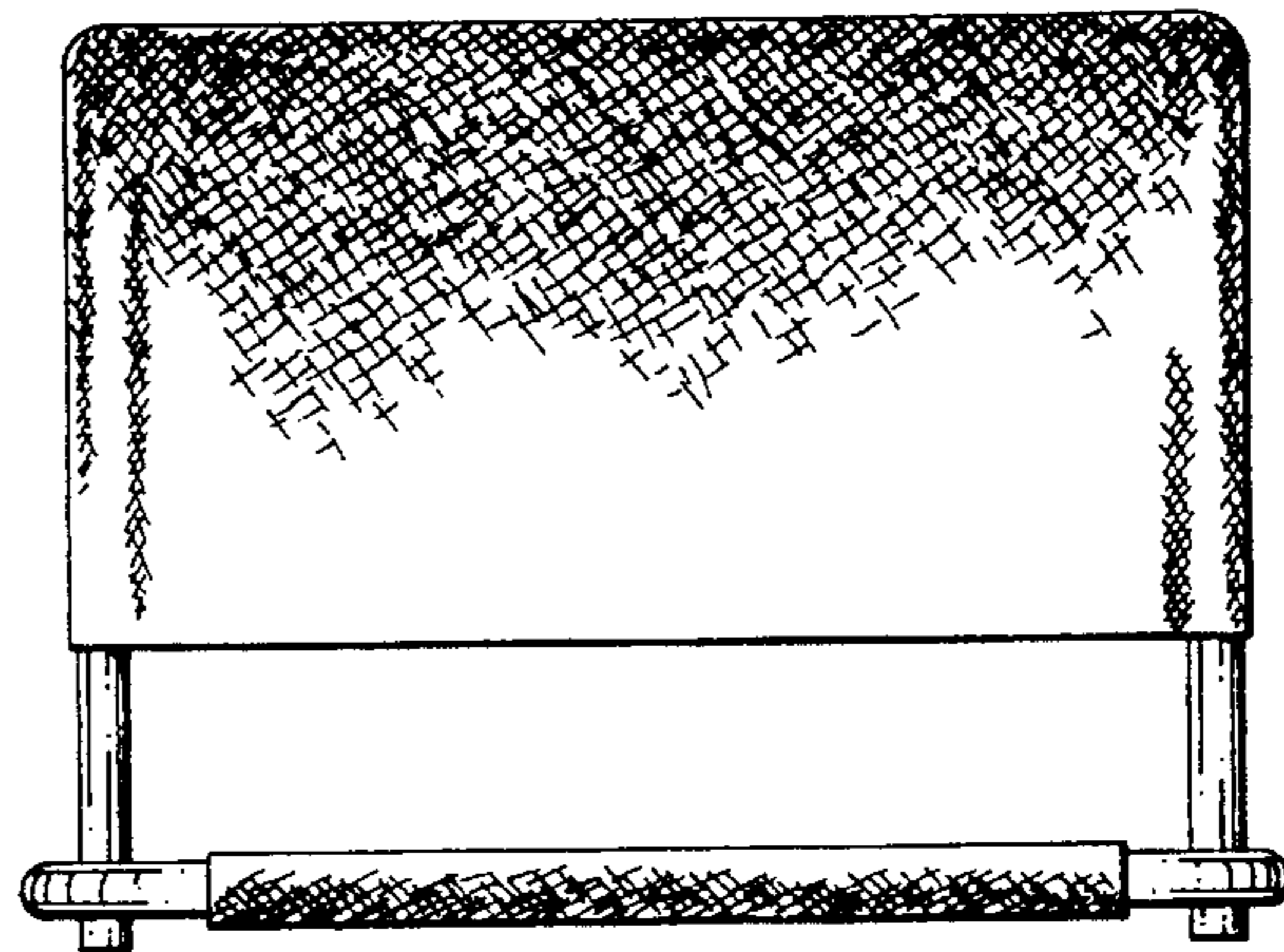

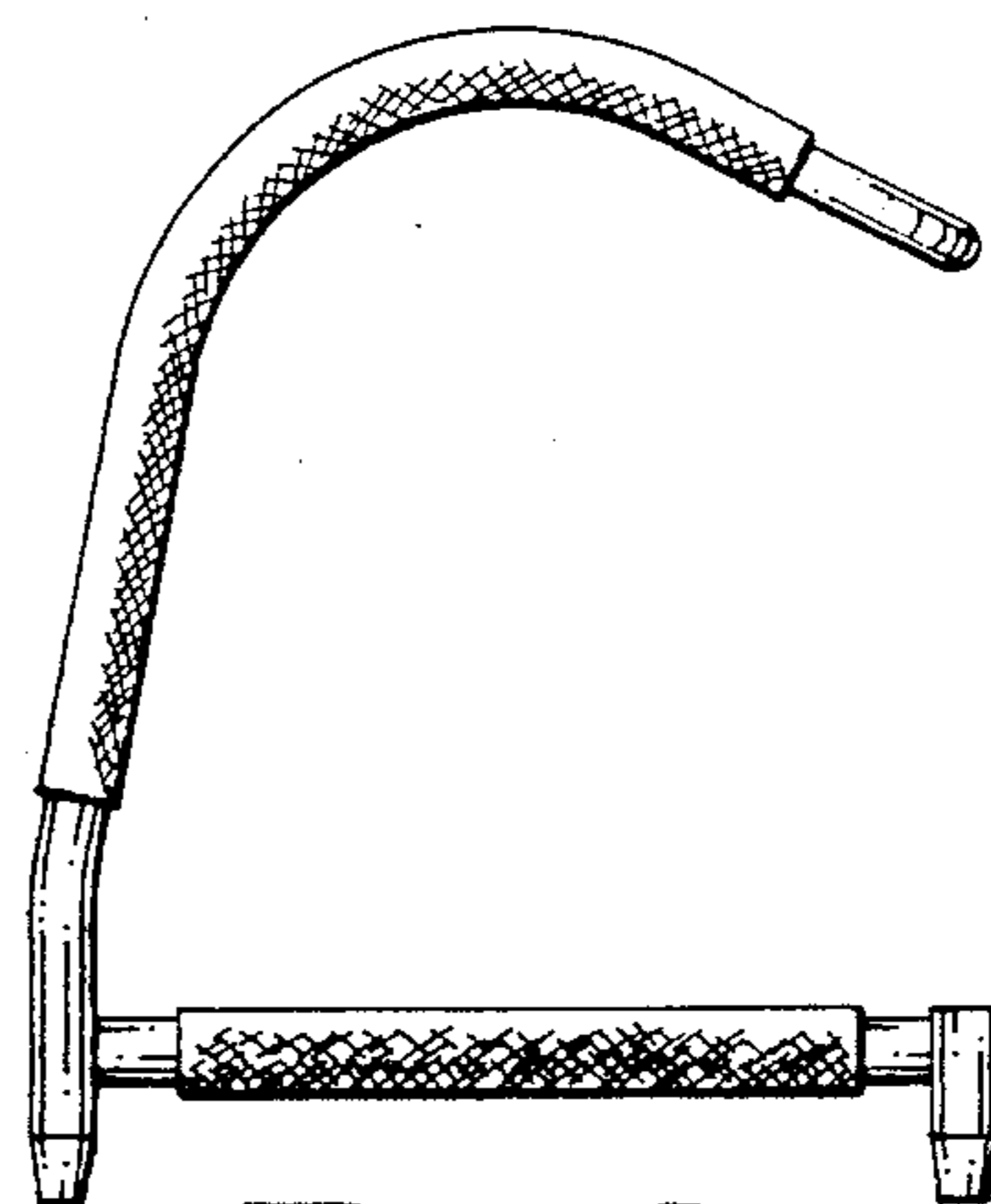
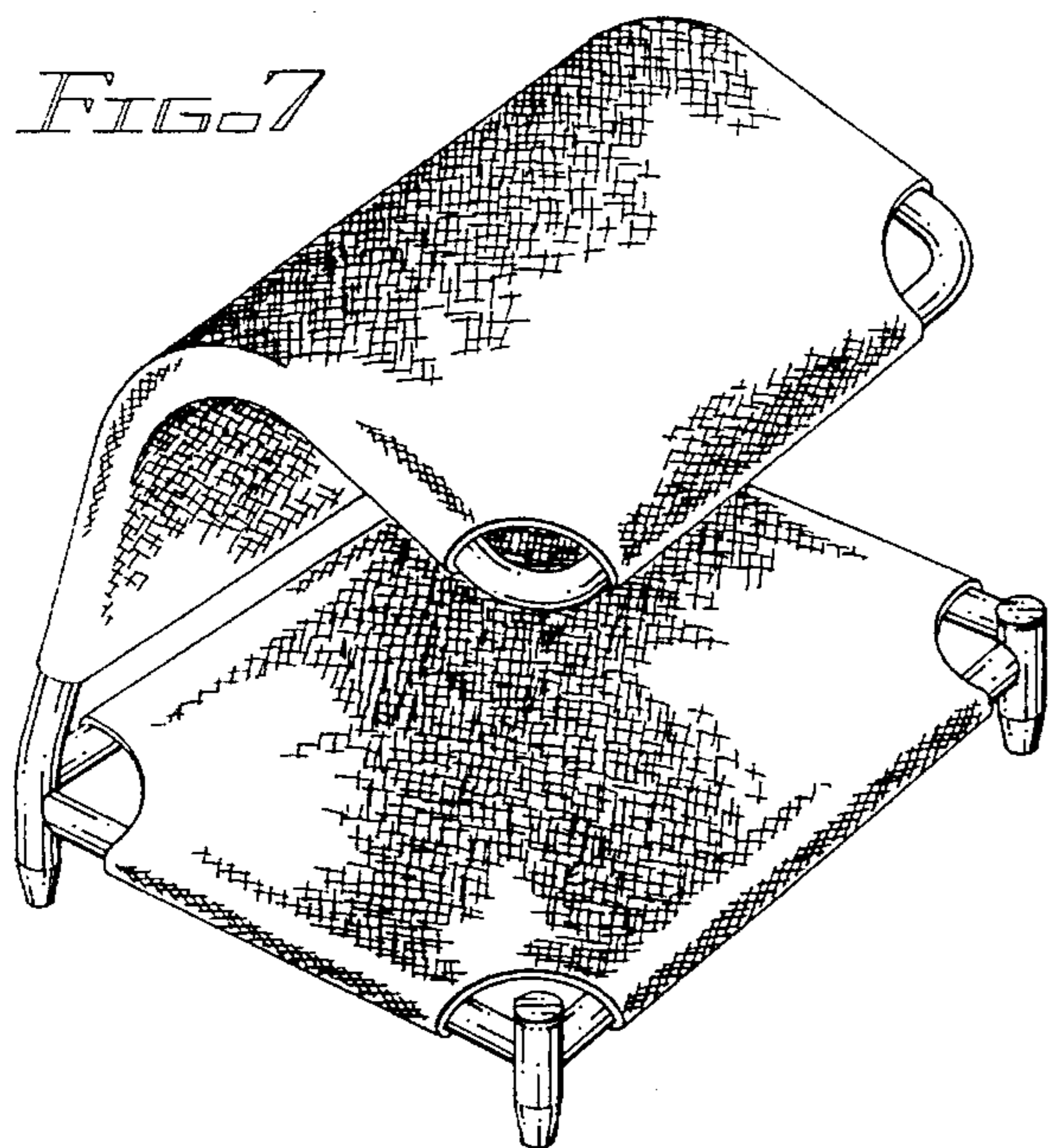

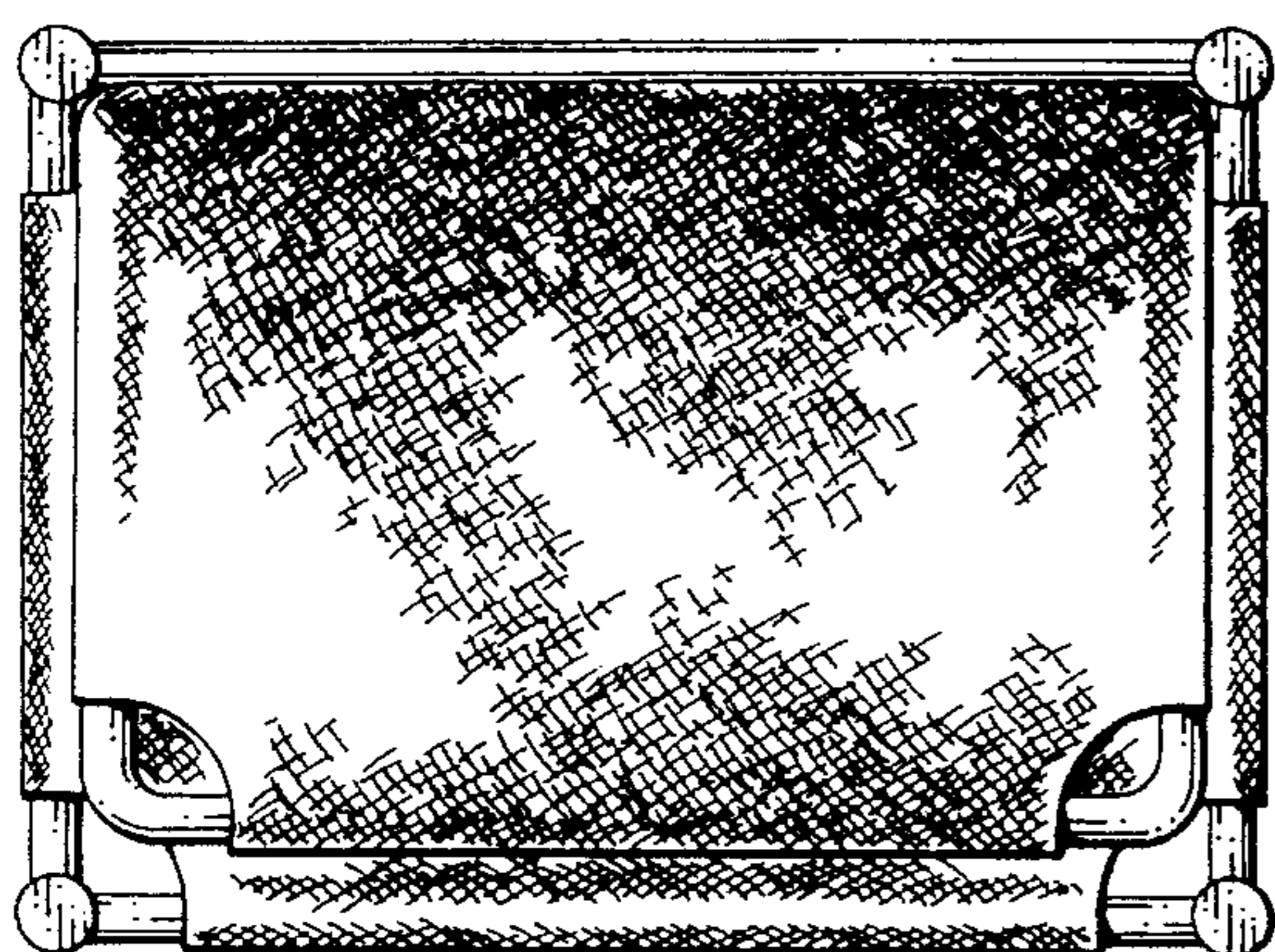

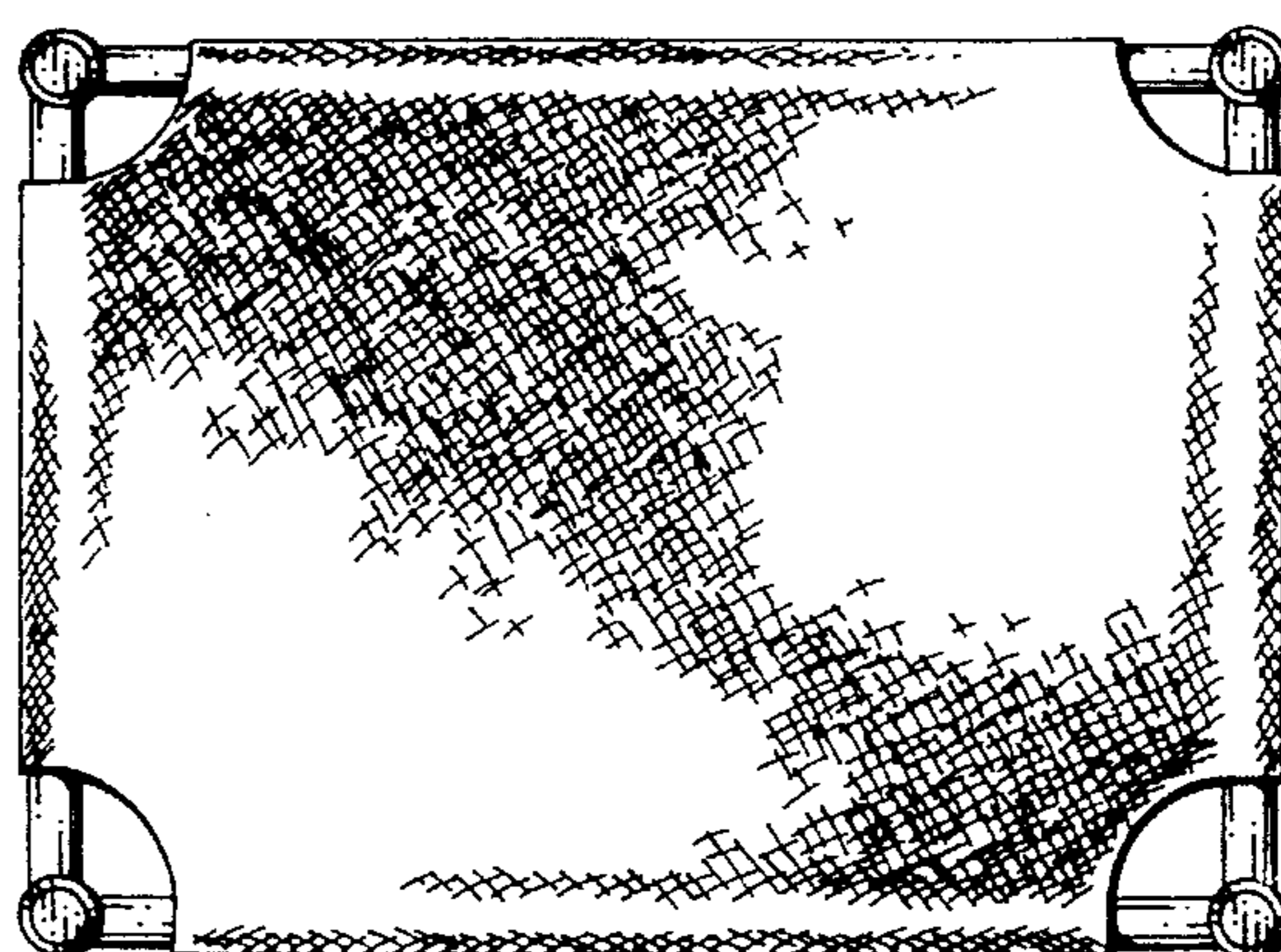

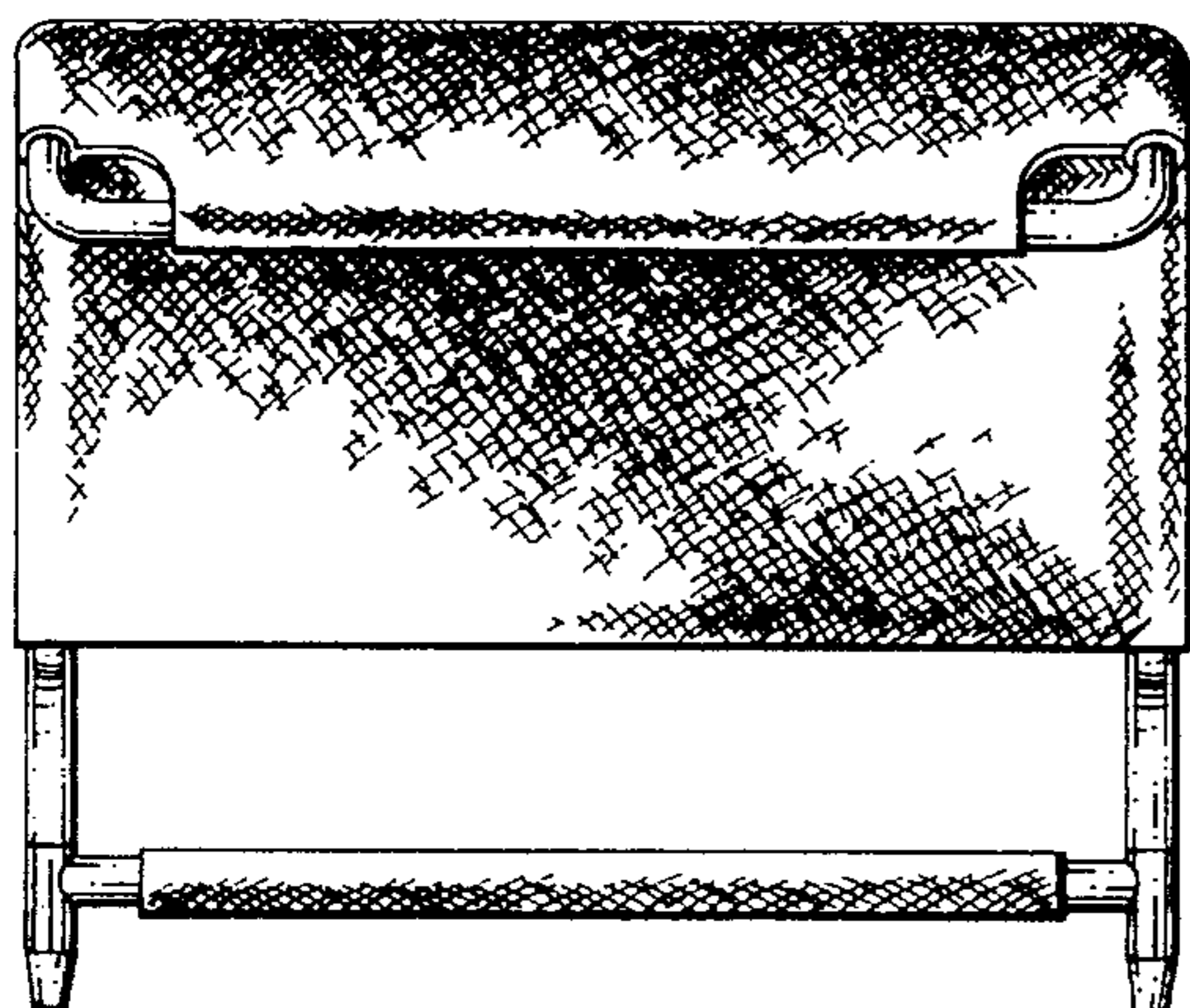

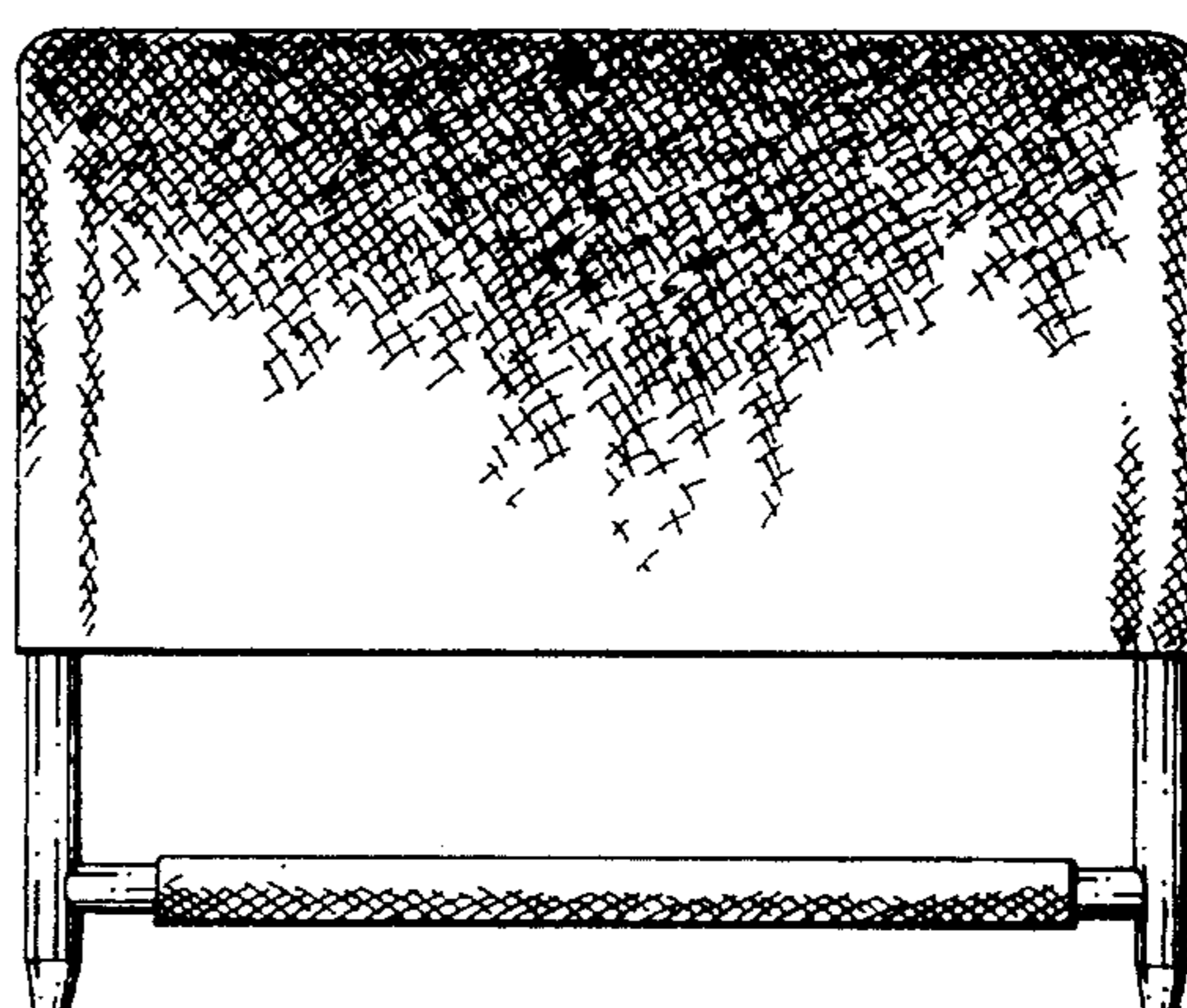
