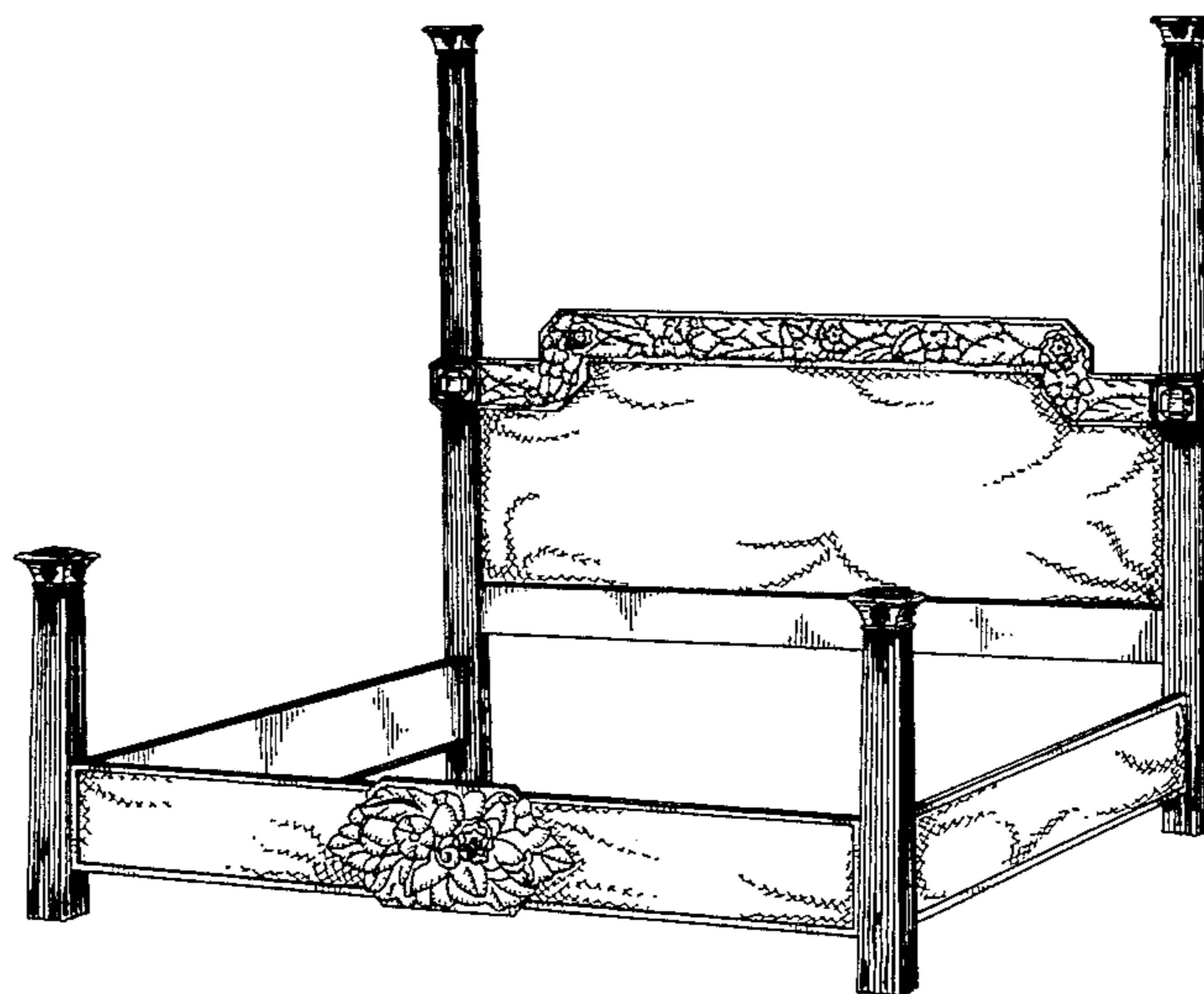
[57] CLAIM

The ornamental design for a bed, as shown and described.

DESCRIPTION

- FIG. 1 is a perspective view of a bed showing my new design;
 - FIG. 2 is a front elevational view of the bed of FIG. 1;
 - FIG. 3 is a right side elevational view, the left side being a mirror image thereof;
 - FIG. 4 is a perspective view of the second embodiment of the bed;
 - FIG. 5 is a front elevational view of the second embodiment of the bed;
 - FIG. 6 is a right side elevational view of the second embodiment of the bed, the left side elevational view is a mirror image thereof; and,
 - FIG. 7 is a perspective view of the third embodiment of the bed.
- The rear of the headboard and footboard are flat and unornamented.

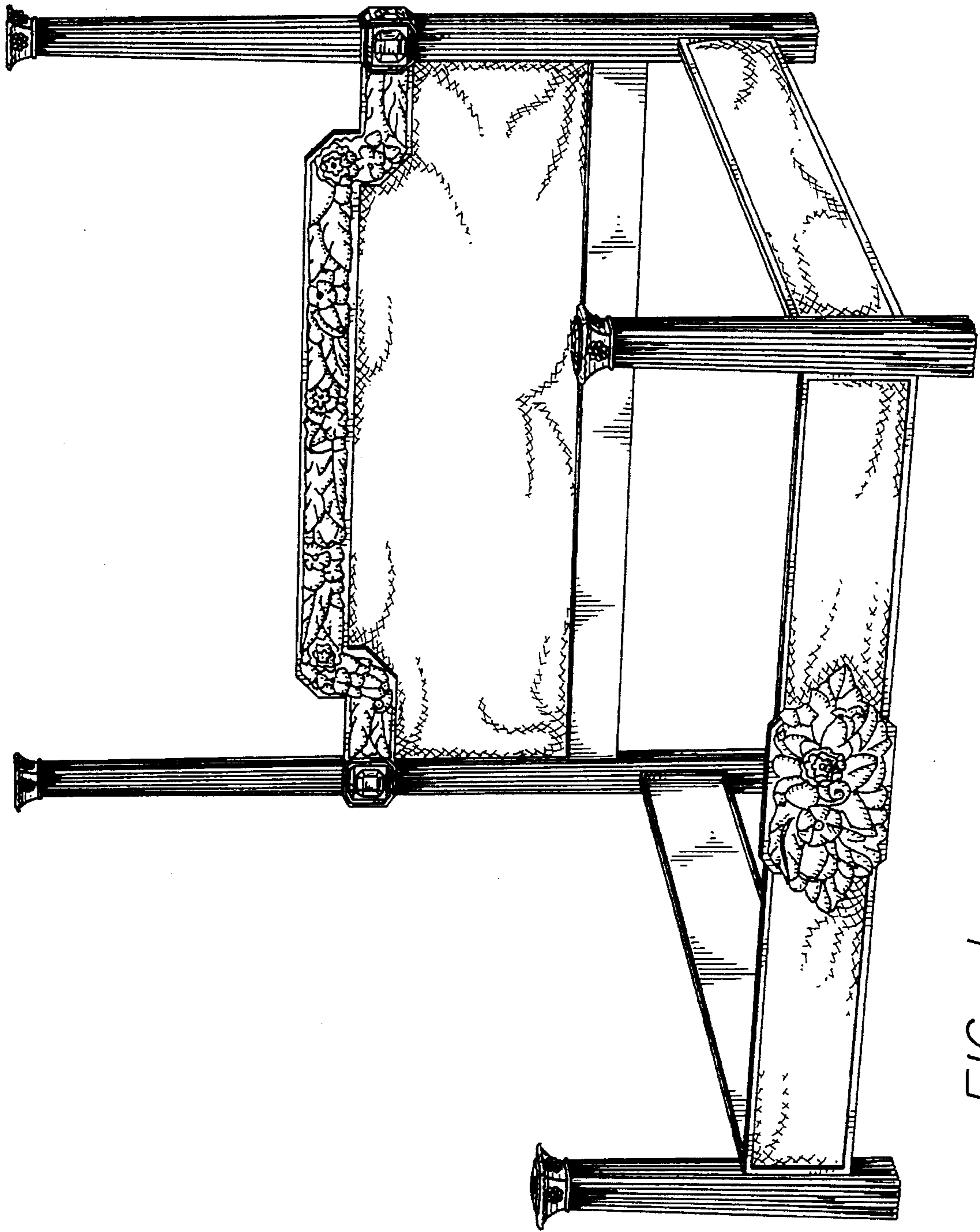

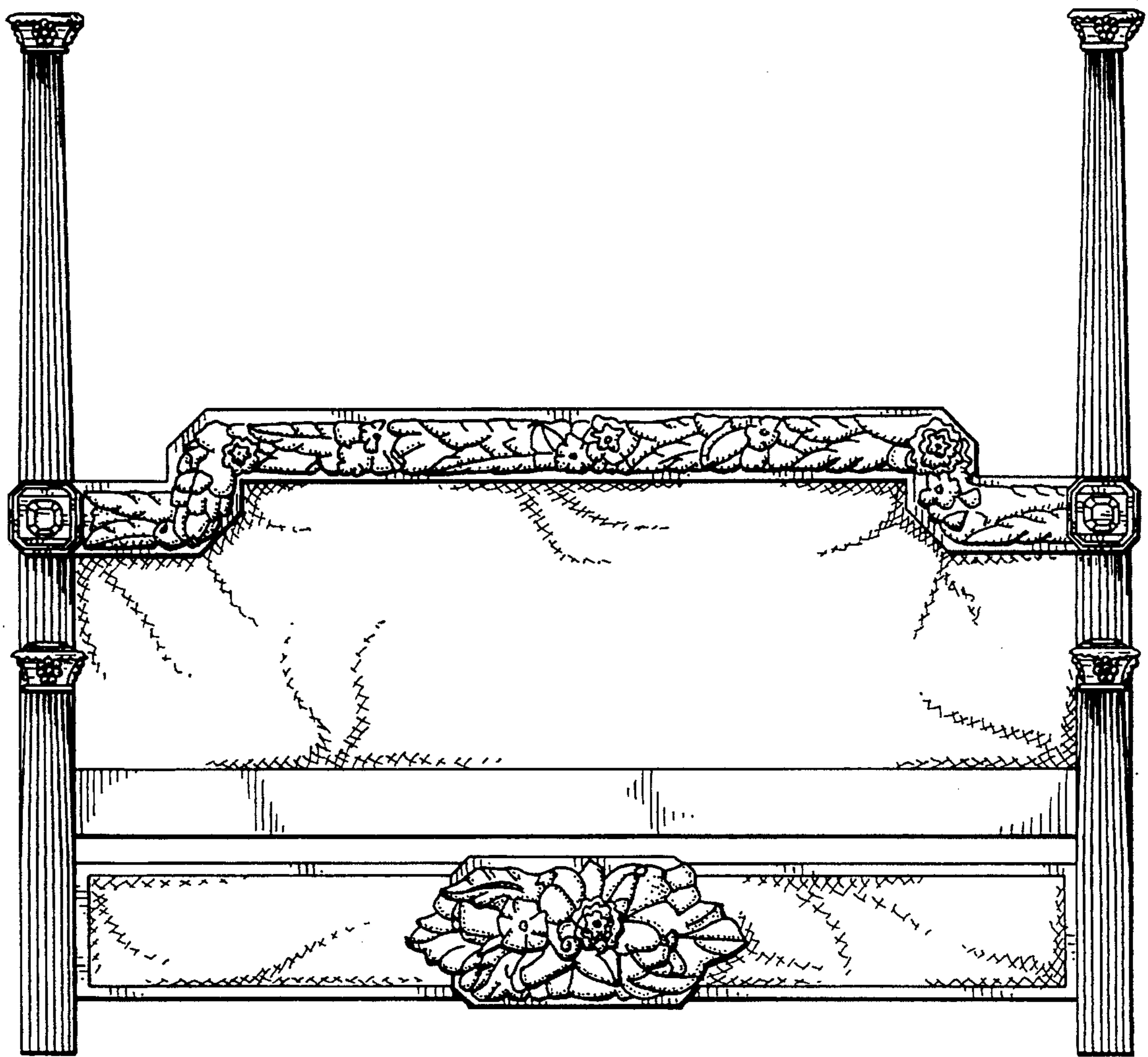

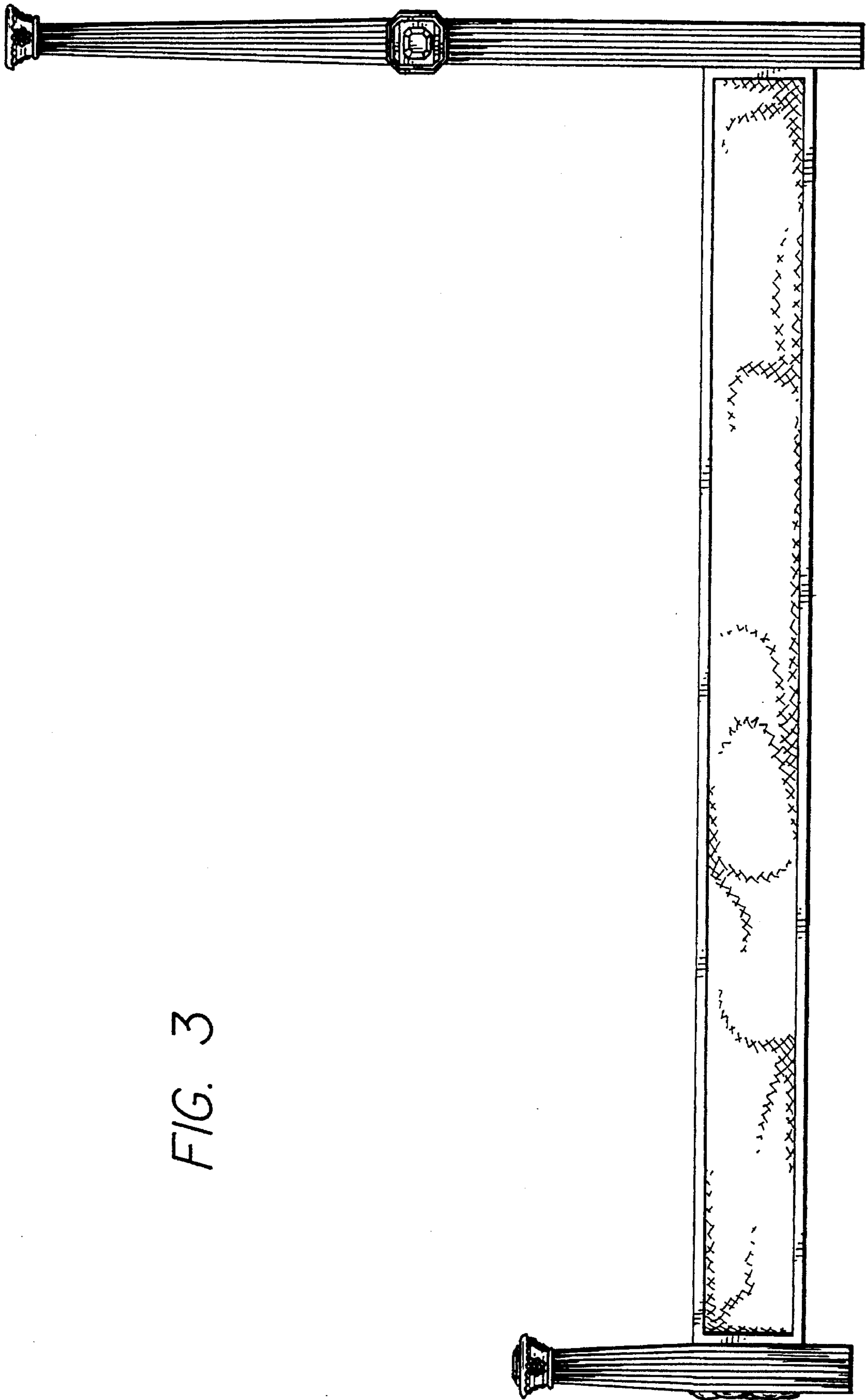

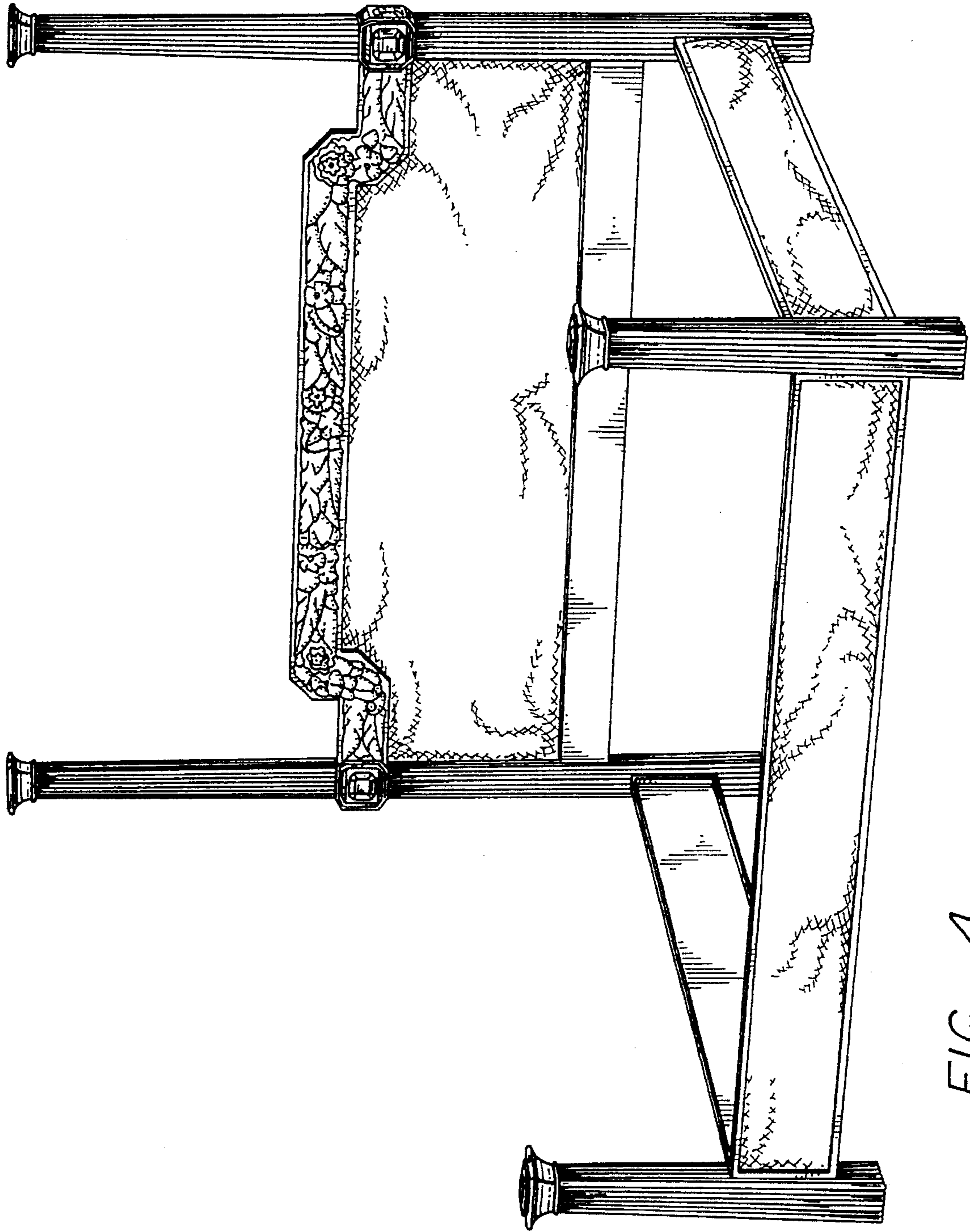

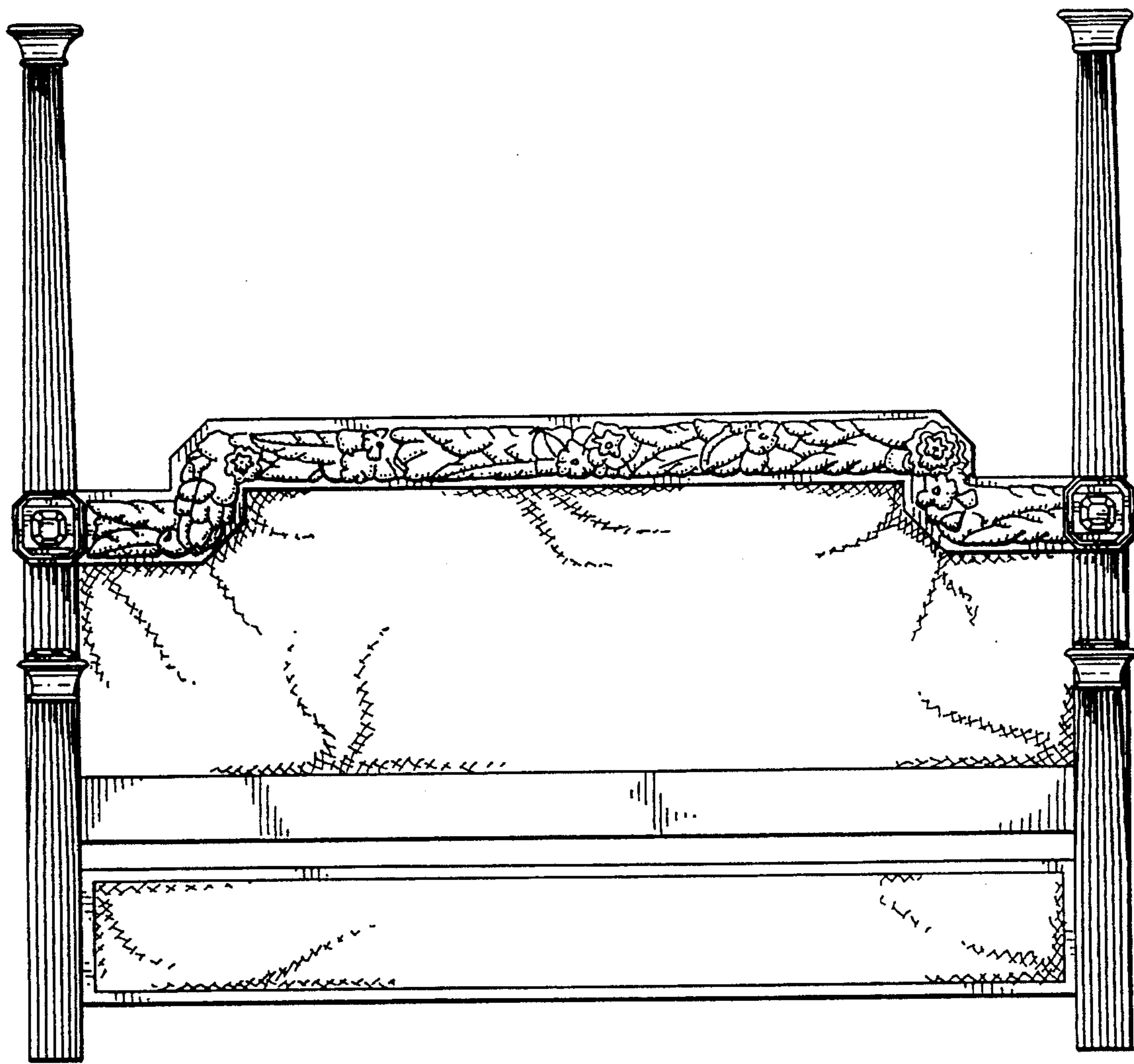

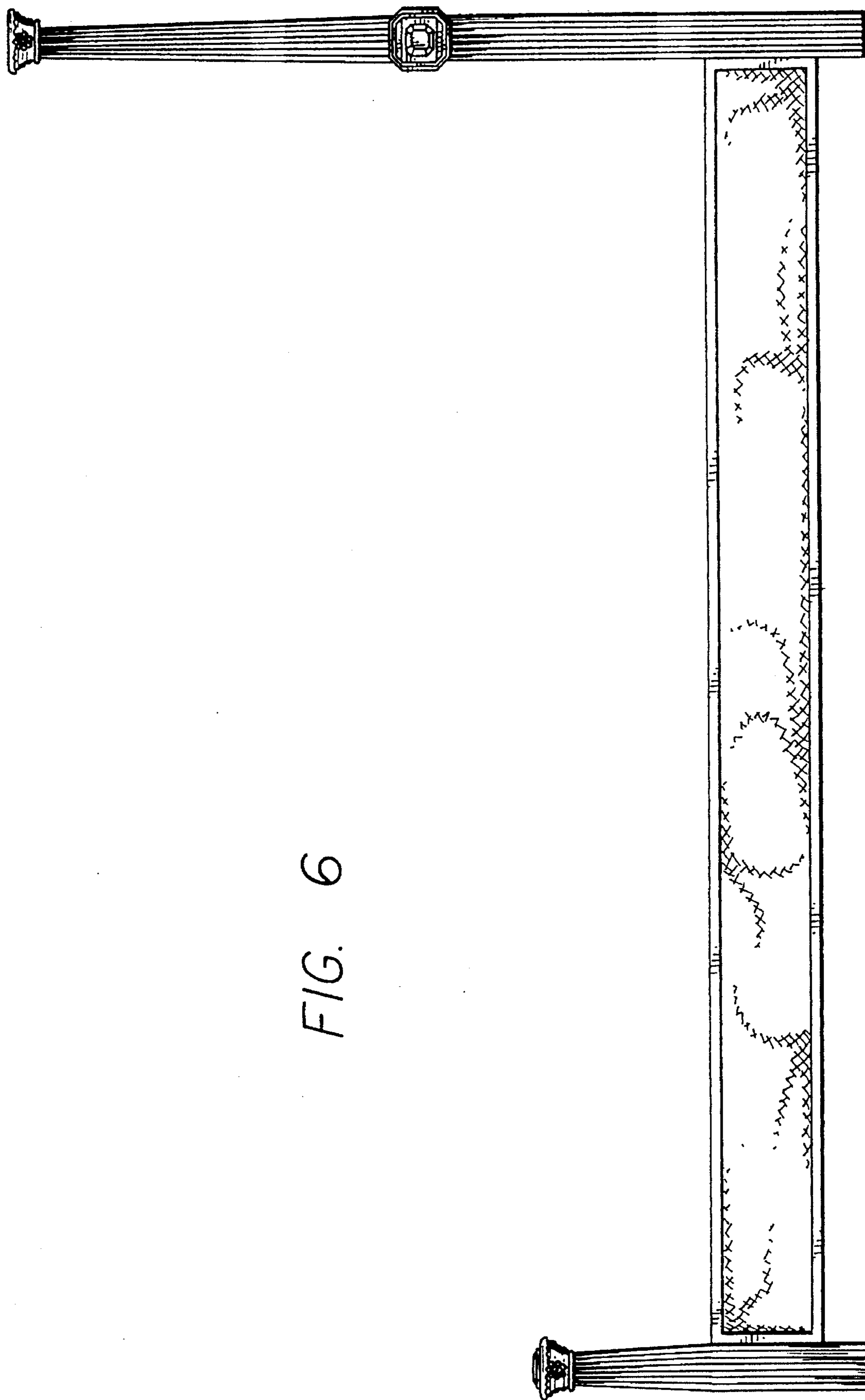

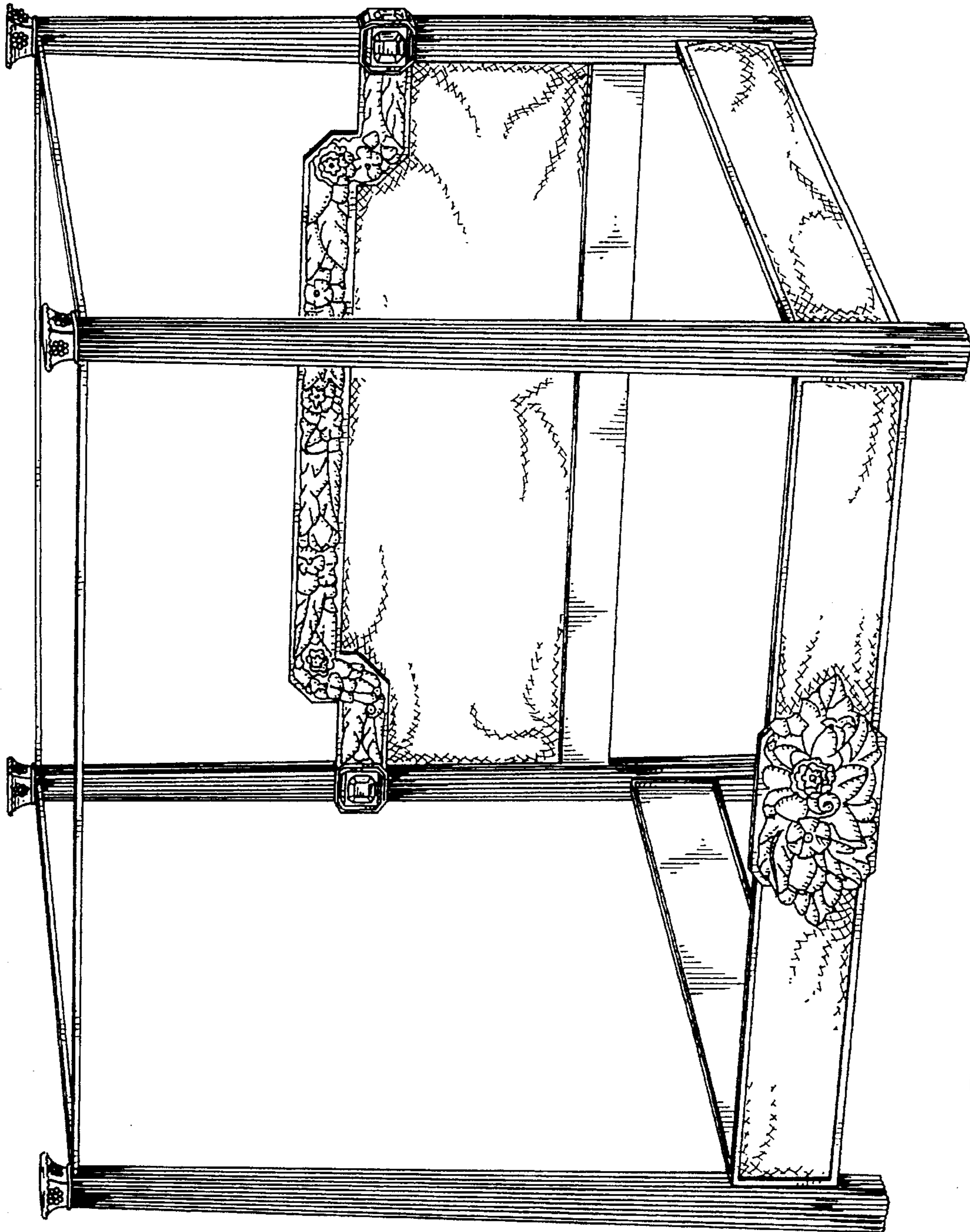
