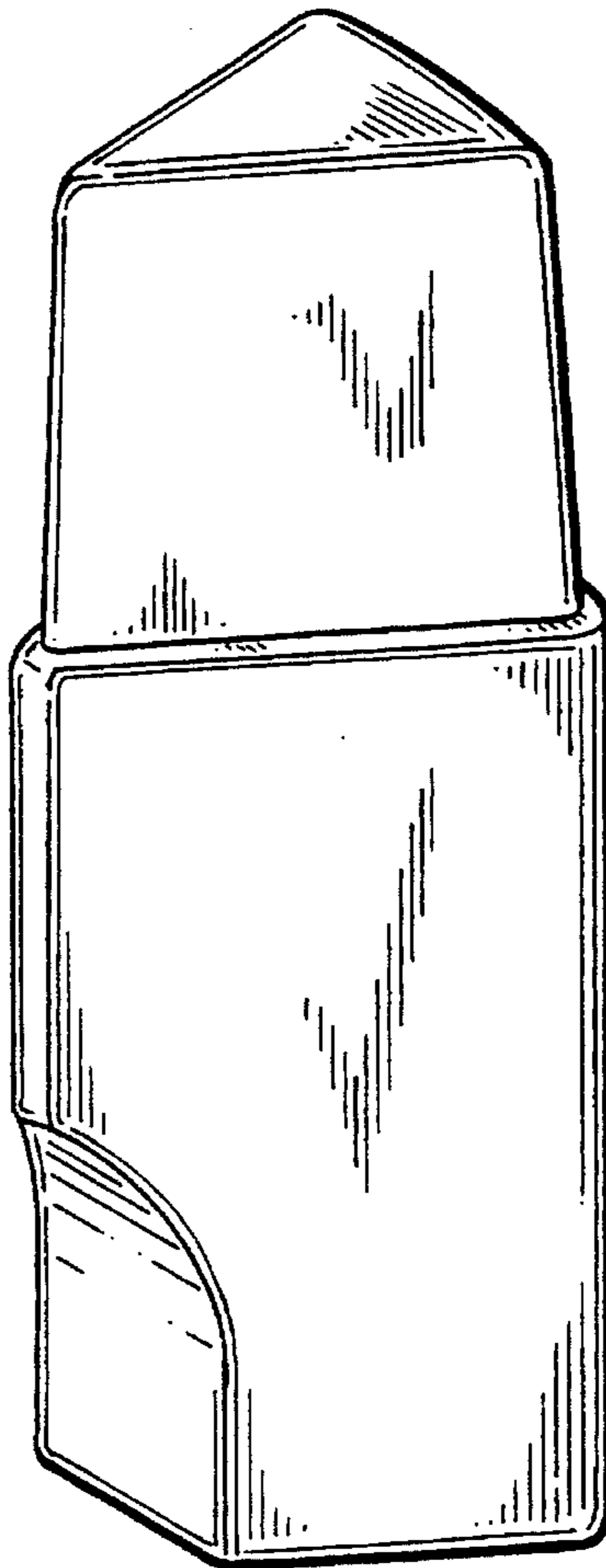
FIG. 1 is a perspective view of a spray bottle showing our new design, shown without a cap;

FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a perspective view of another embodiment of a combined spray bottle and cap showing our new design; and, FIG. 8 is a top plan view of FIG. 7.
FIGS. 1–6 are shown without the cap for clarity of illustration.

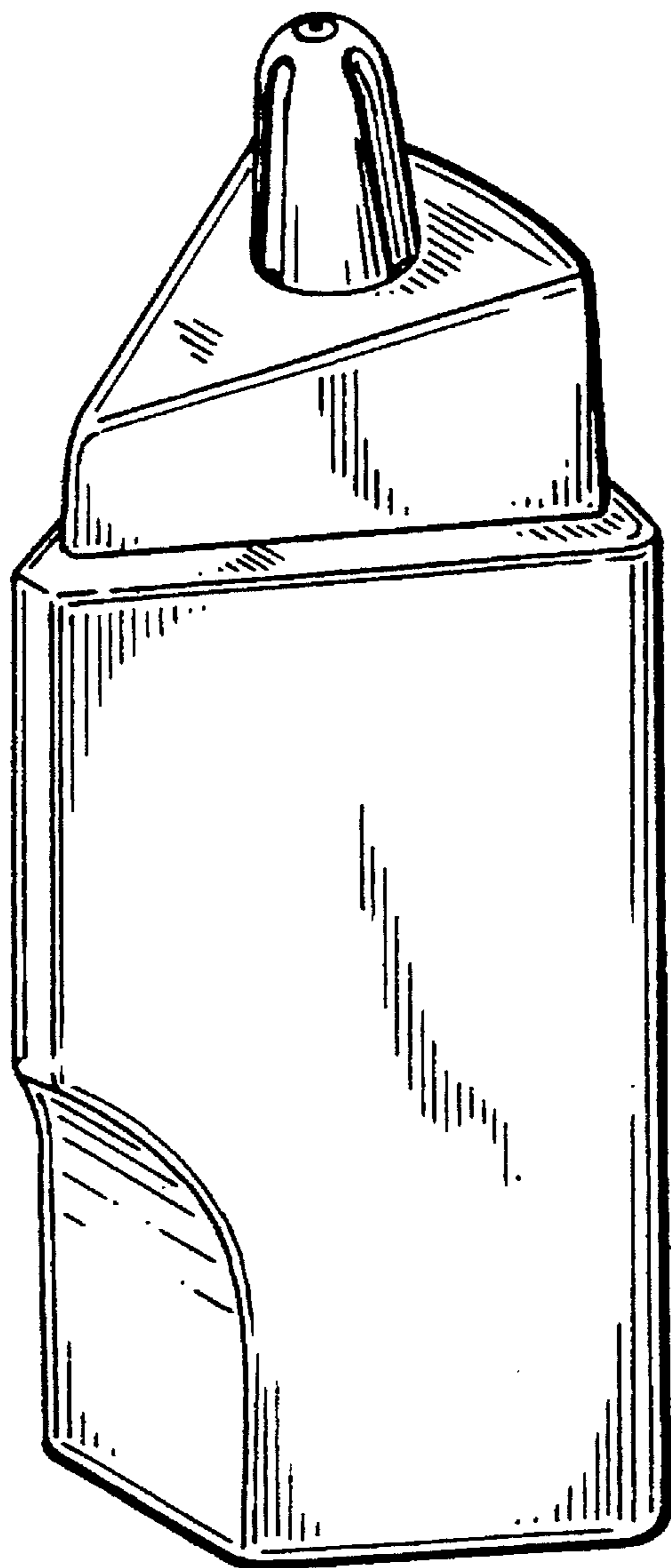

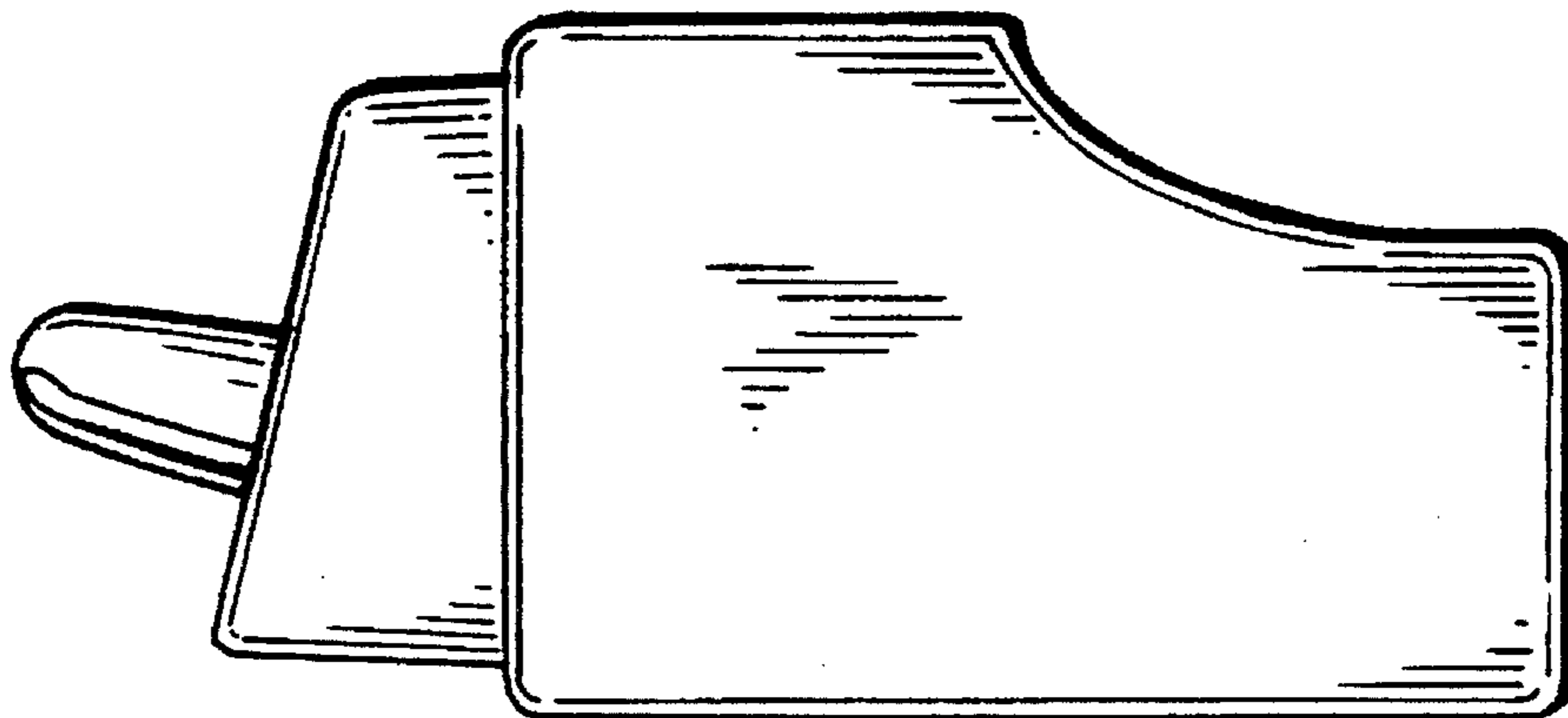

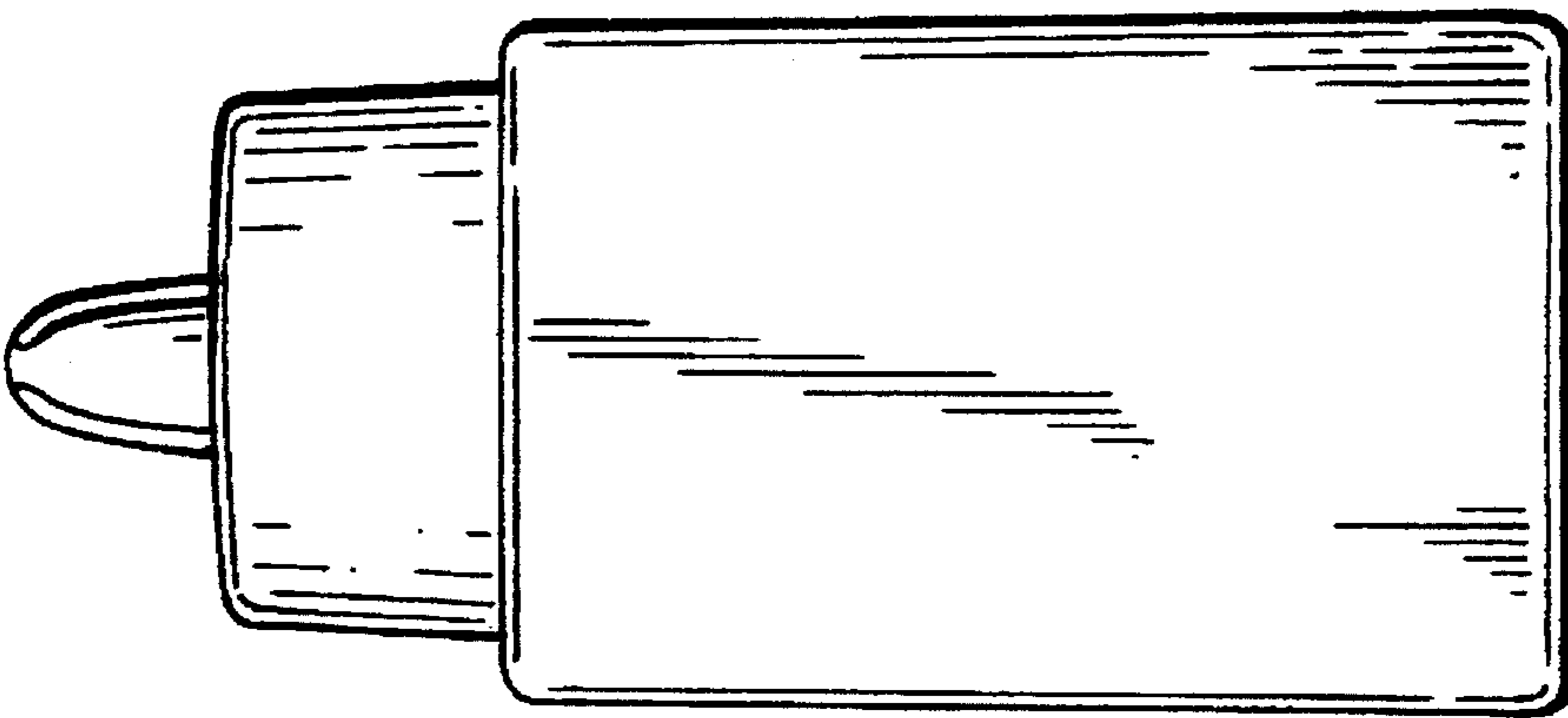

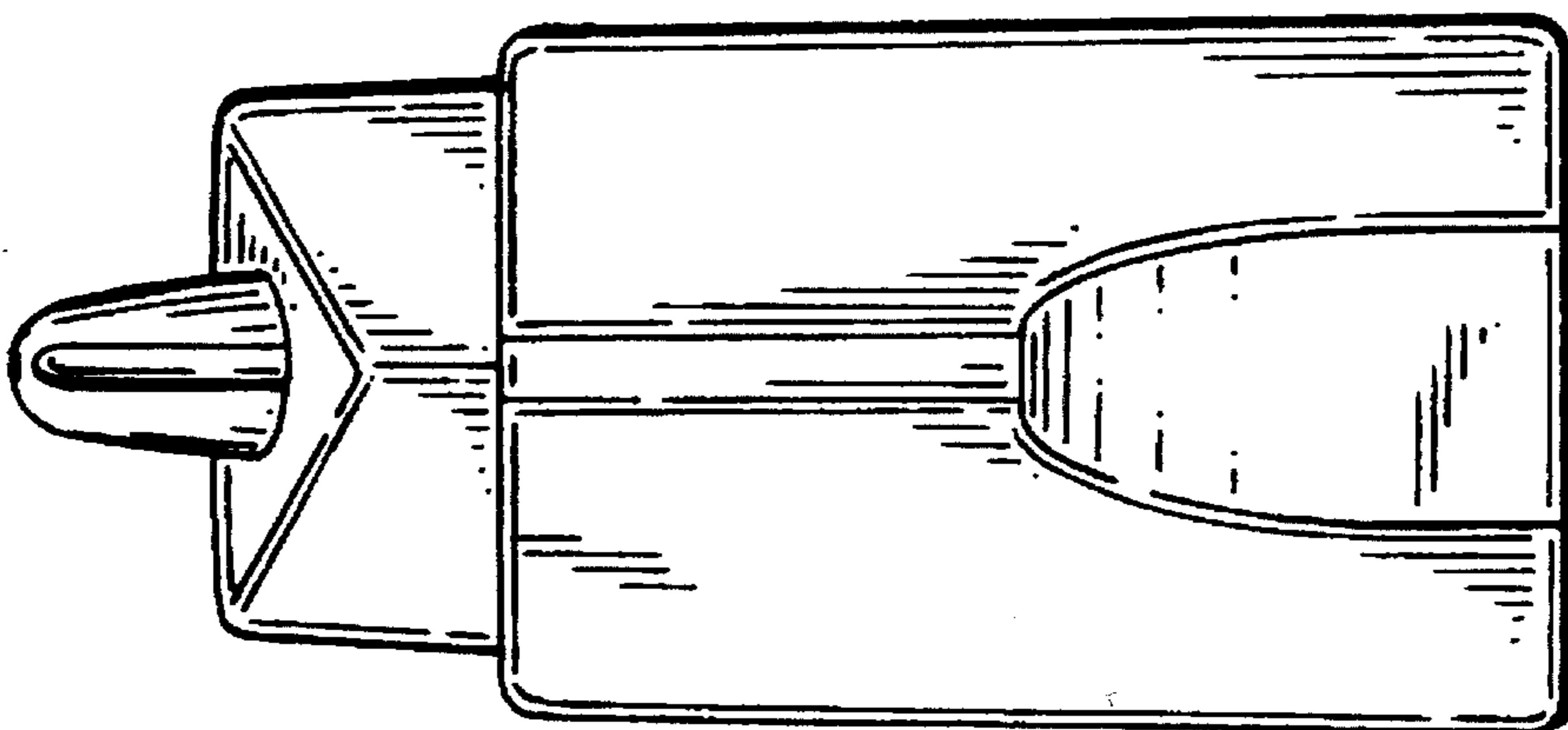

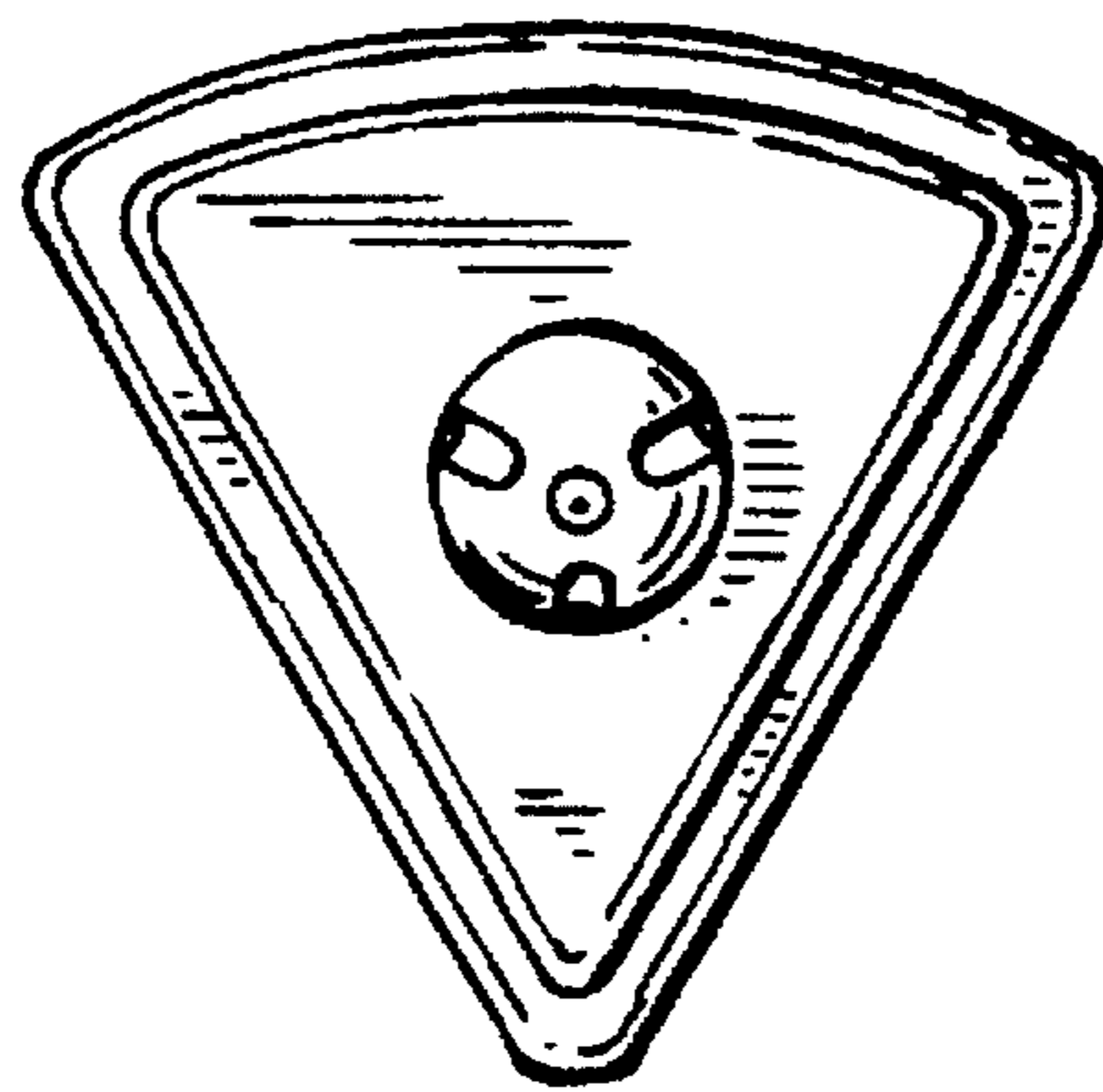

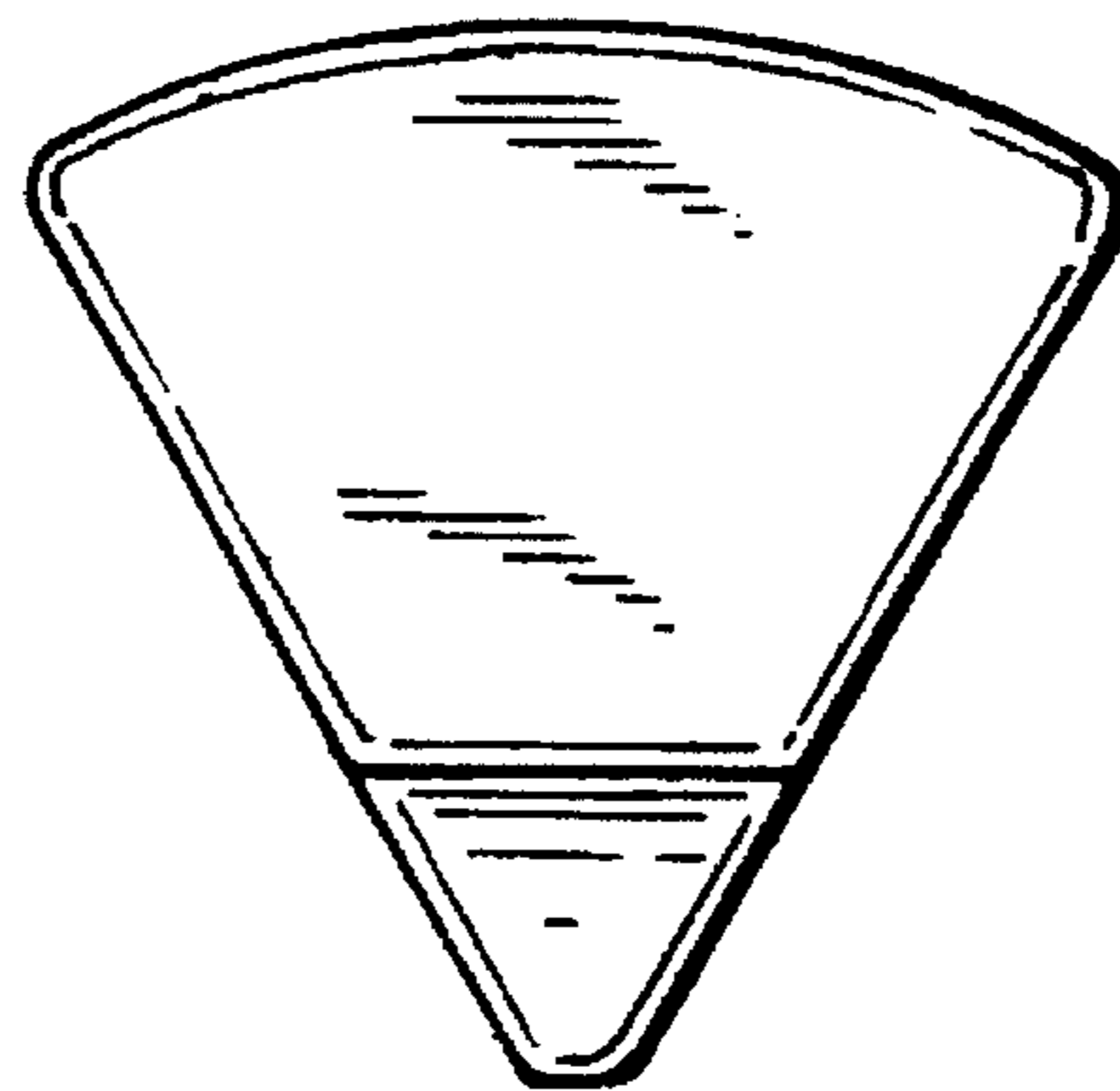

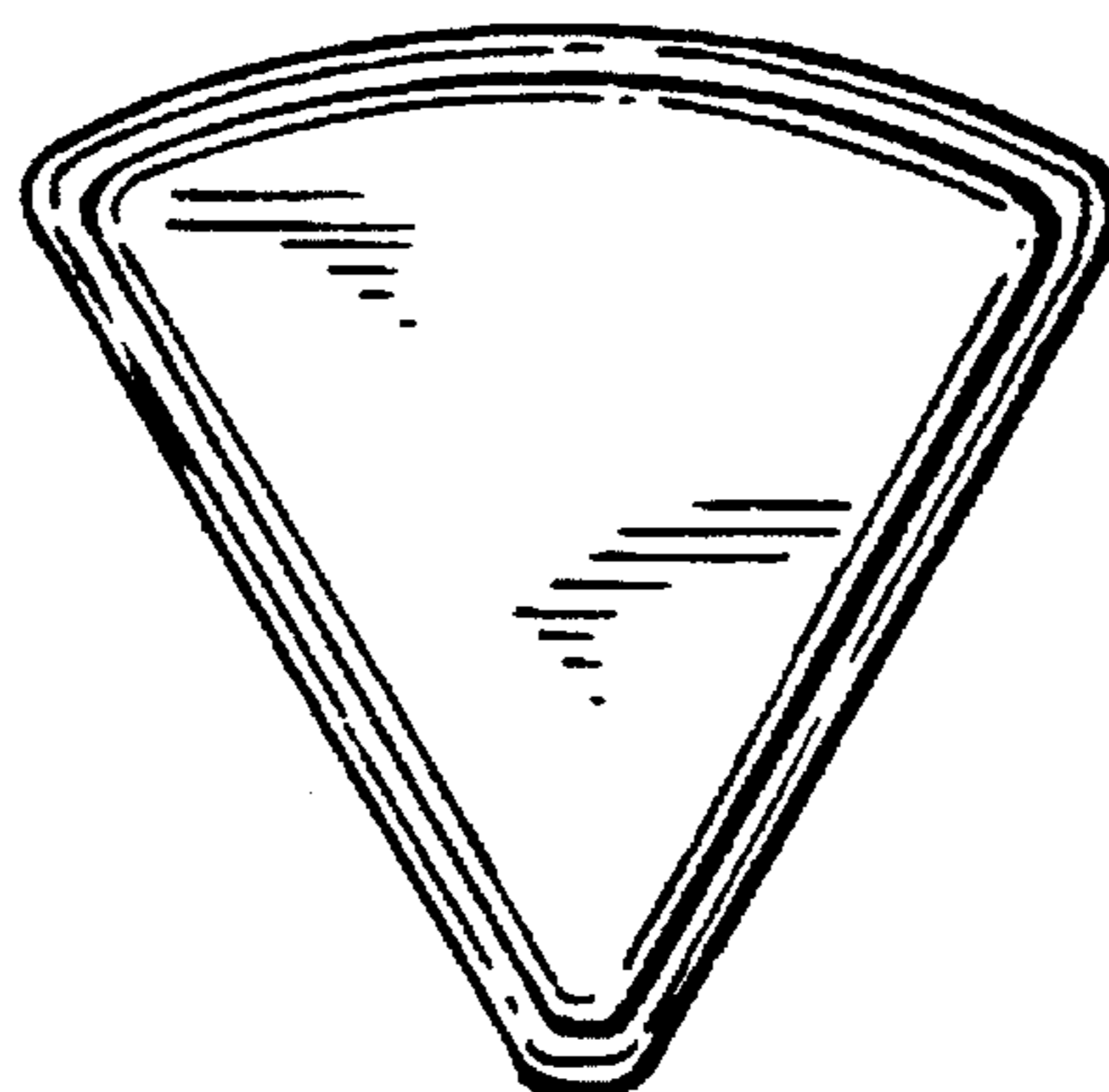

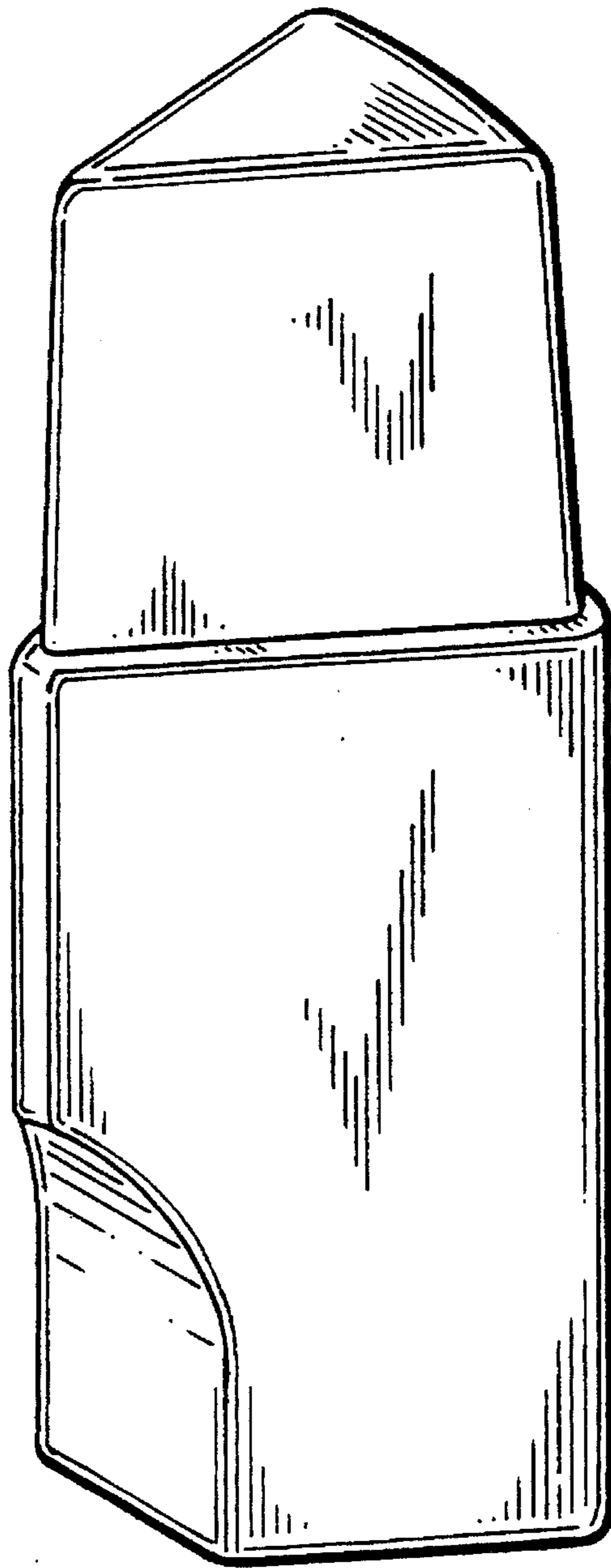
