The ornamental design for a closure, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the closure embodying my novel design;  
 FIG. 2 is an elevational view;  
 FIG. 3 is a plan view;  
 FIG. 4 is a side view taken from the the right in FIG. 2, the view of the opposite side being the same;  
 FIG. 5 is a perspective view of a second embodiment of the design;  
 FIG. 6 is an elevational view of the form shown in FIG. 5;  
 FIG. 7 is a plan view of the form shown in FIG. 5; and,  
 FIG. 8 is a side view taken from the the right in FIG. 6, the view of the opposite side being the same.

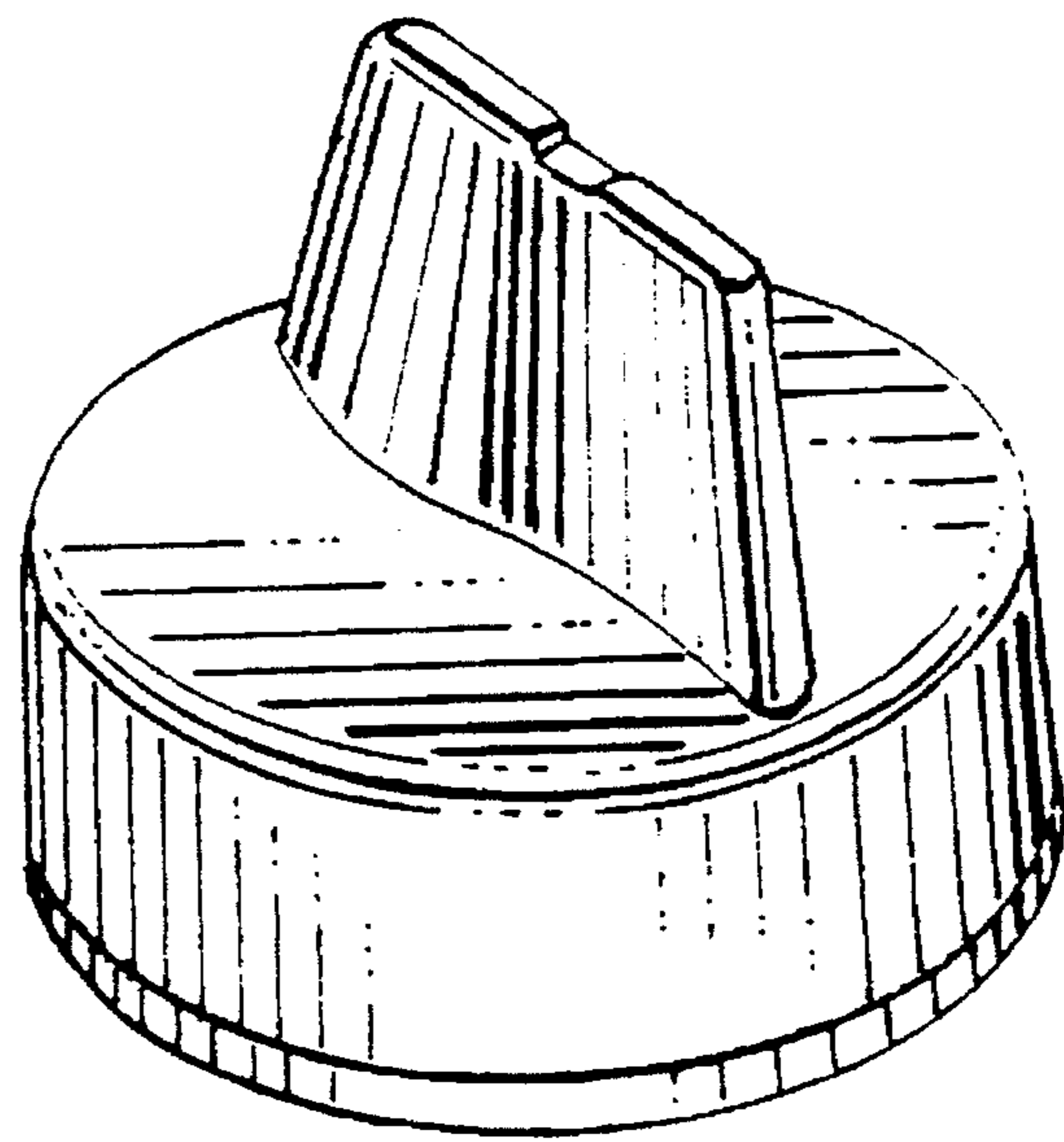
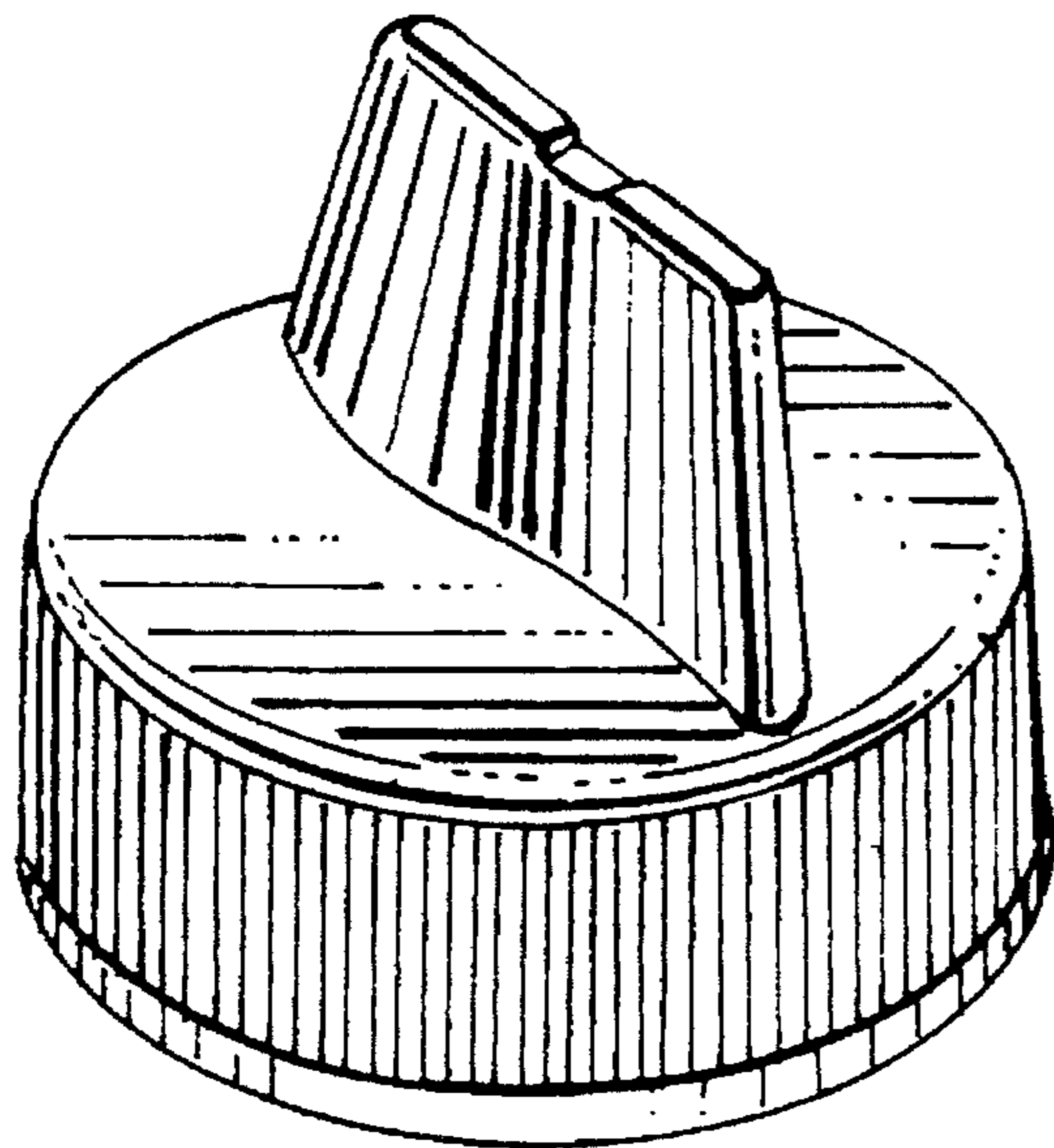

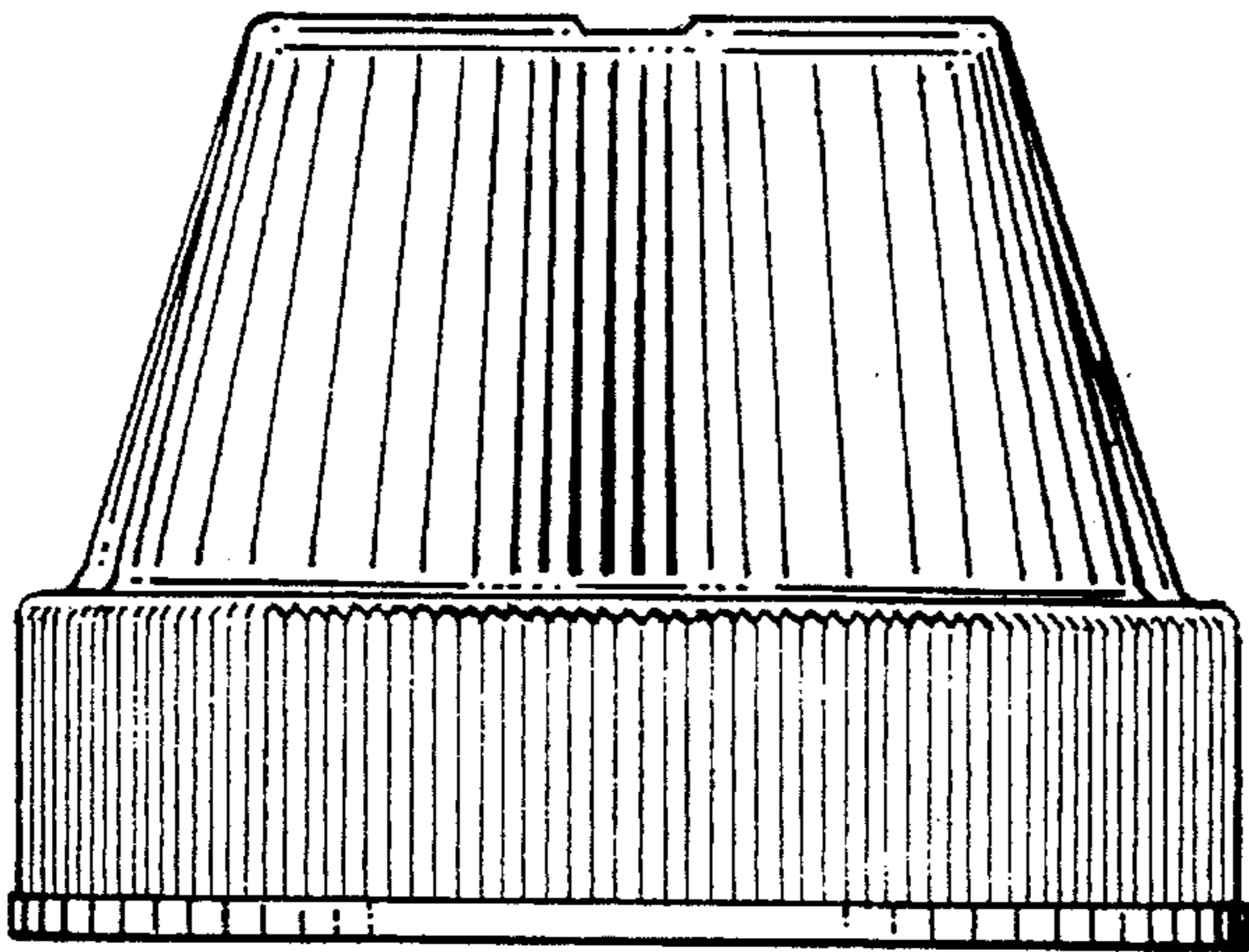

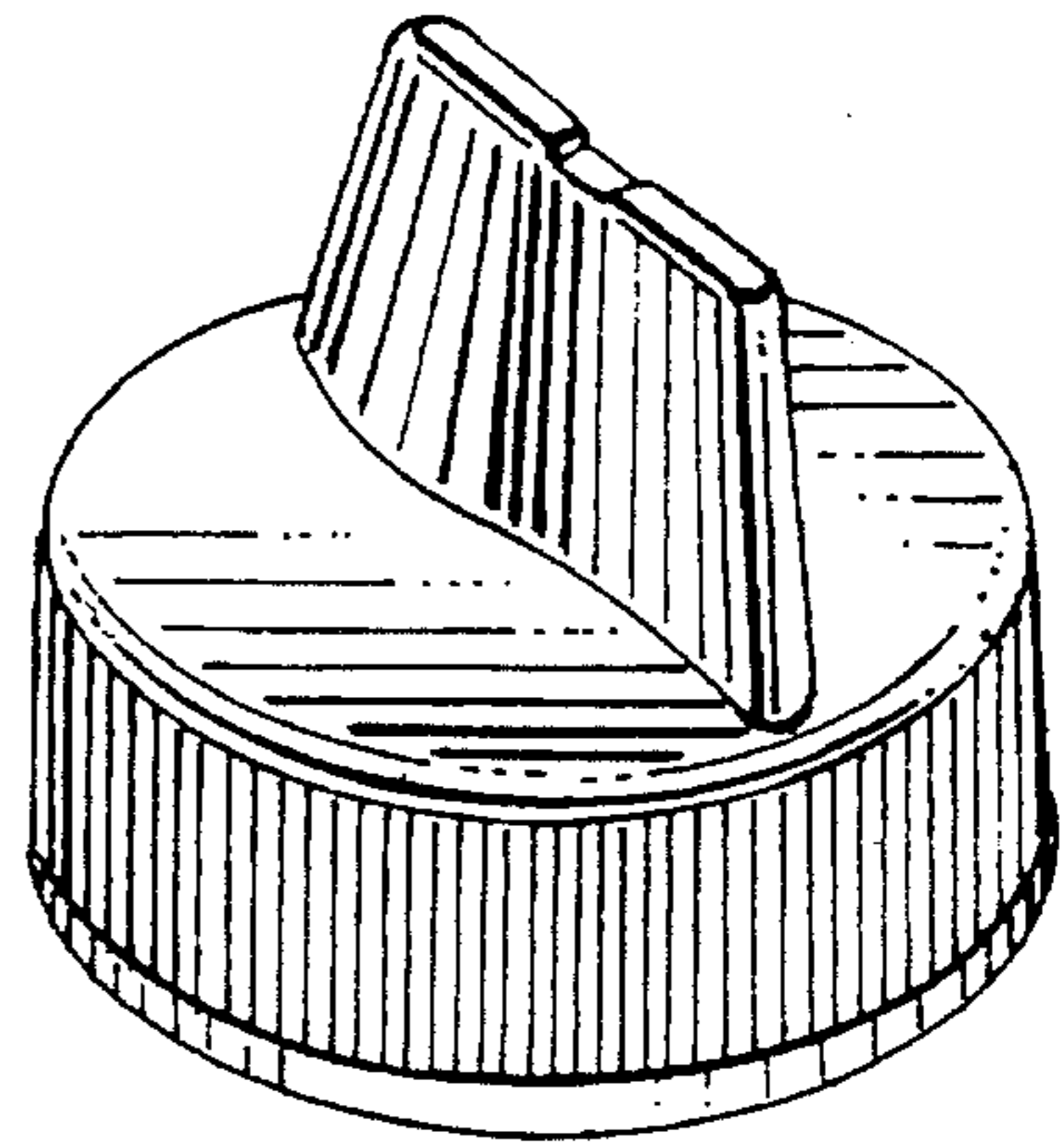

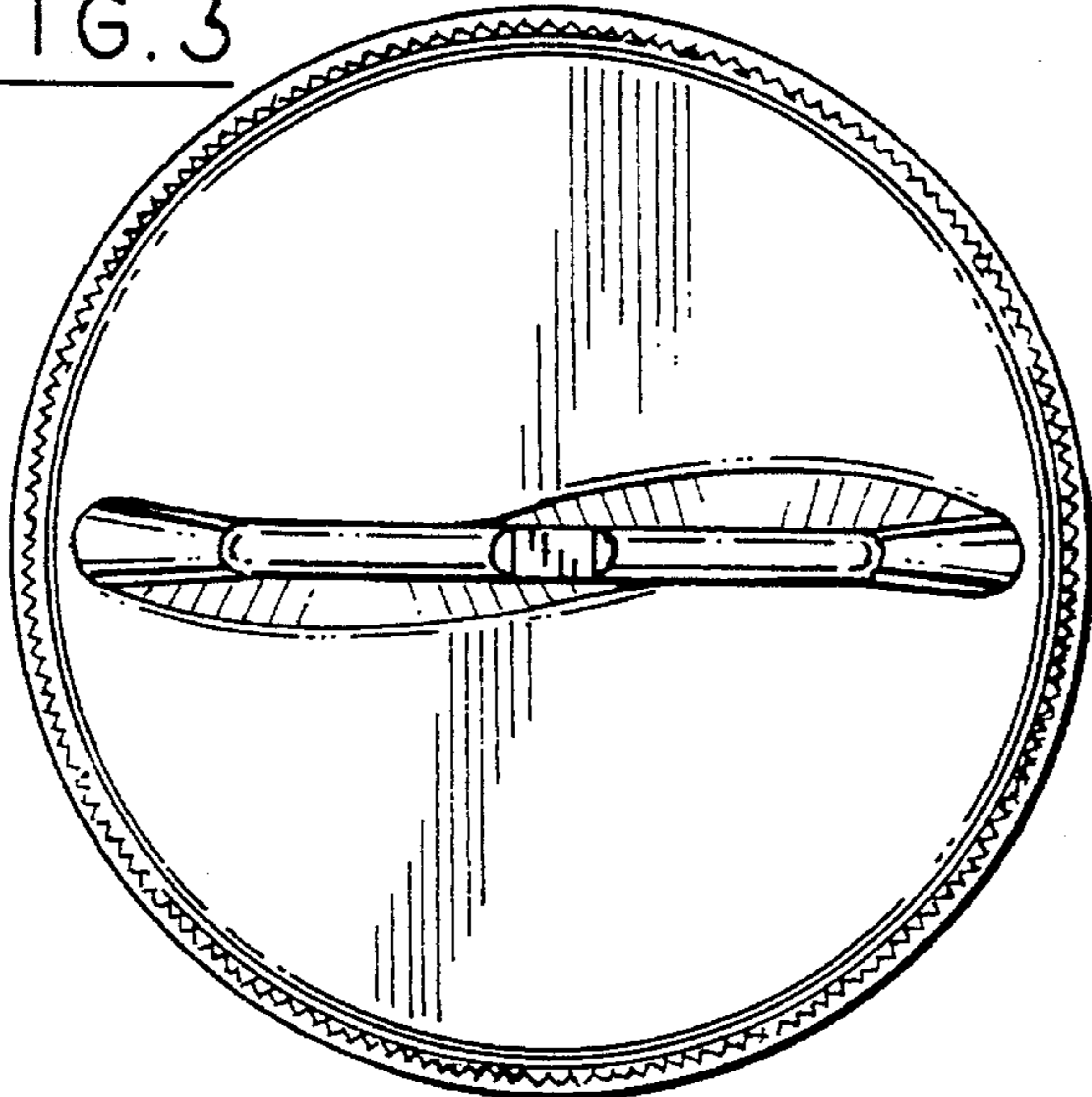

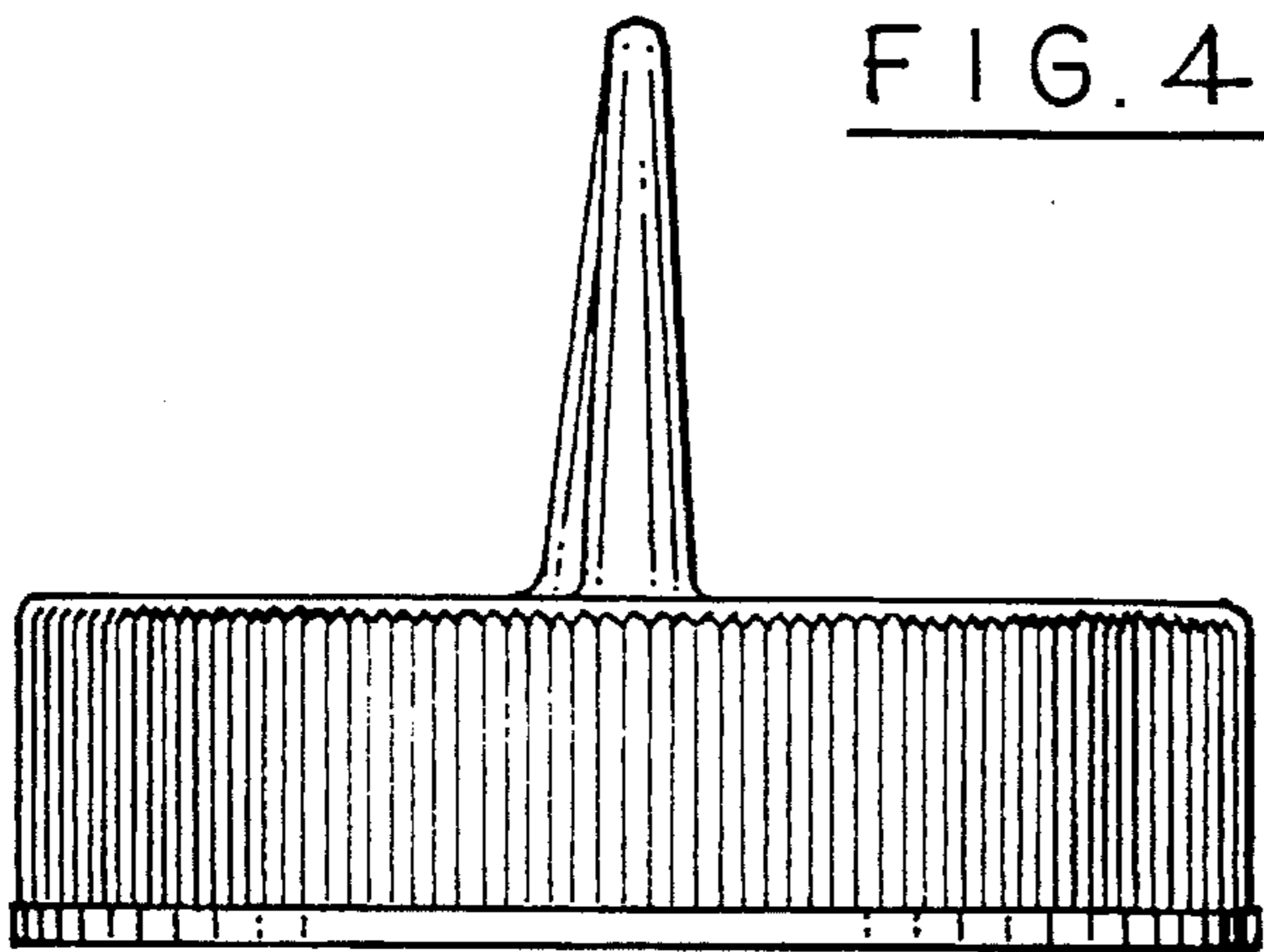

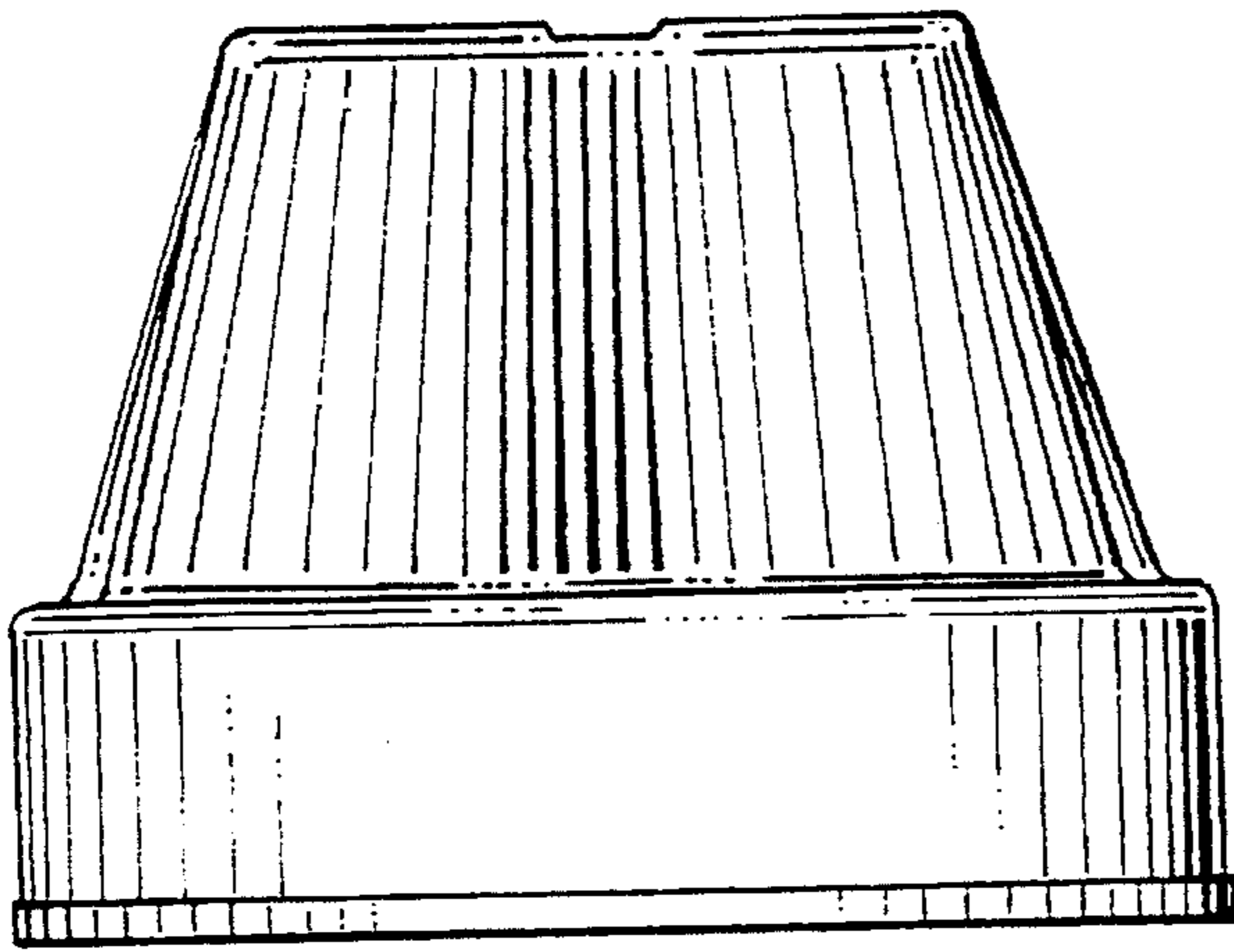

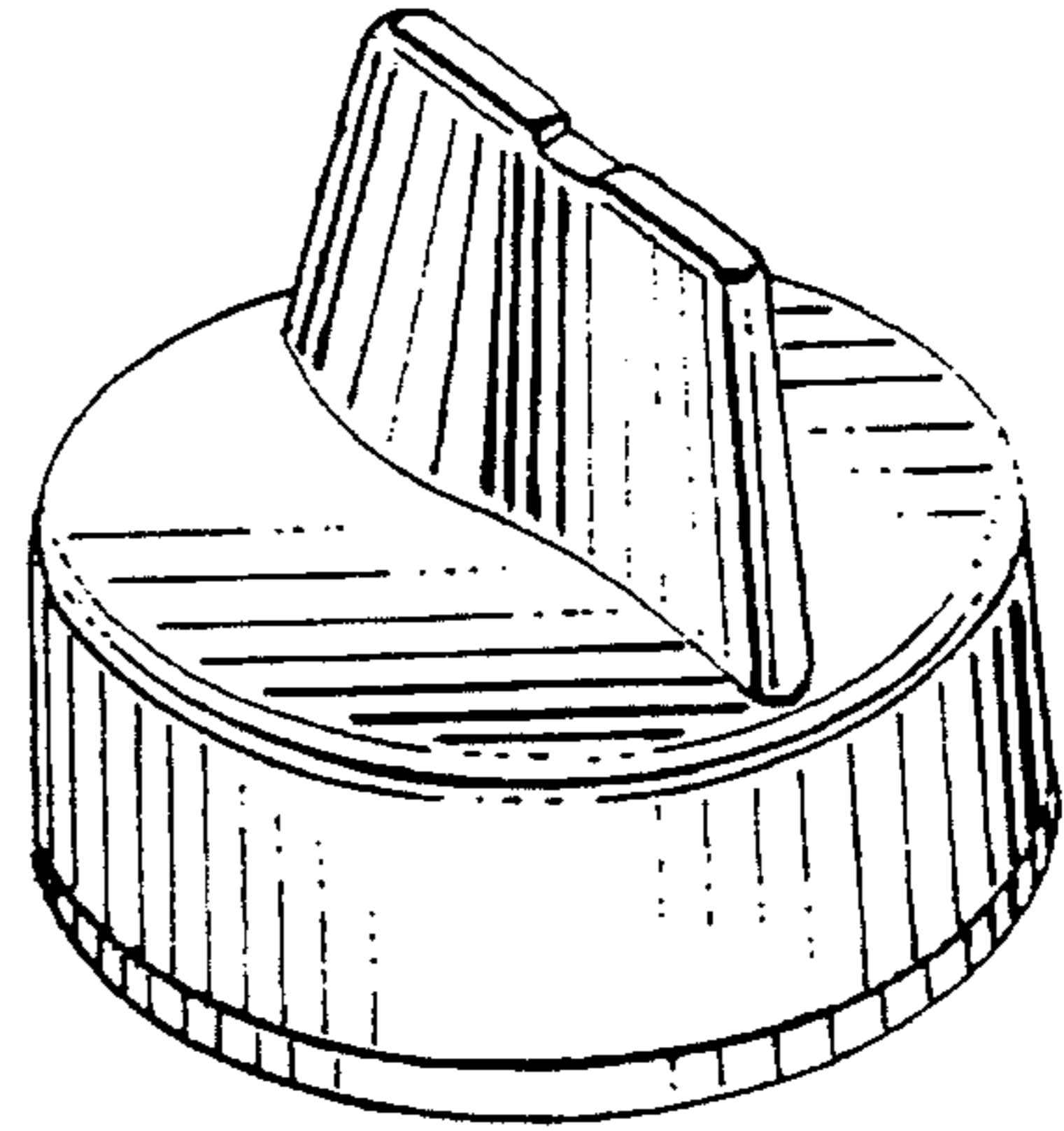

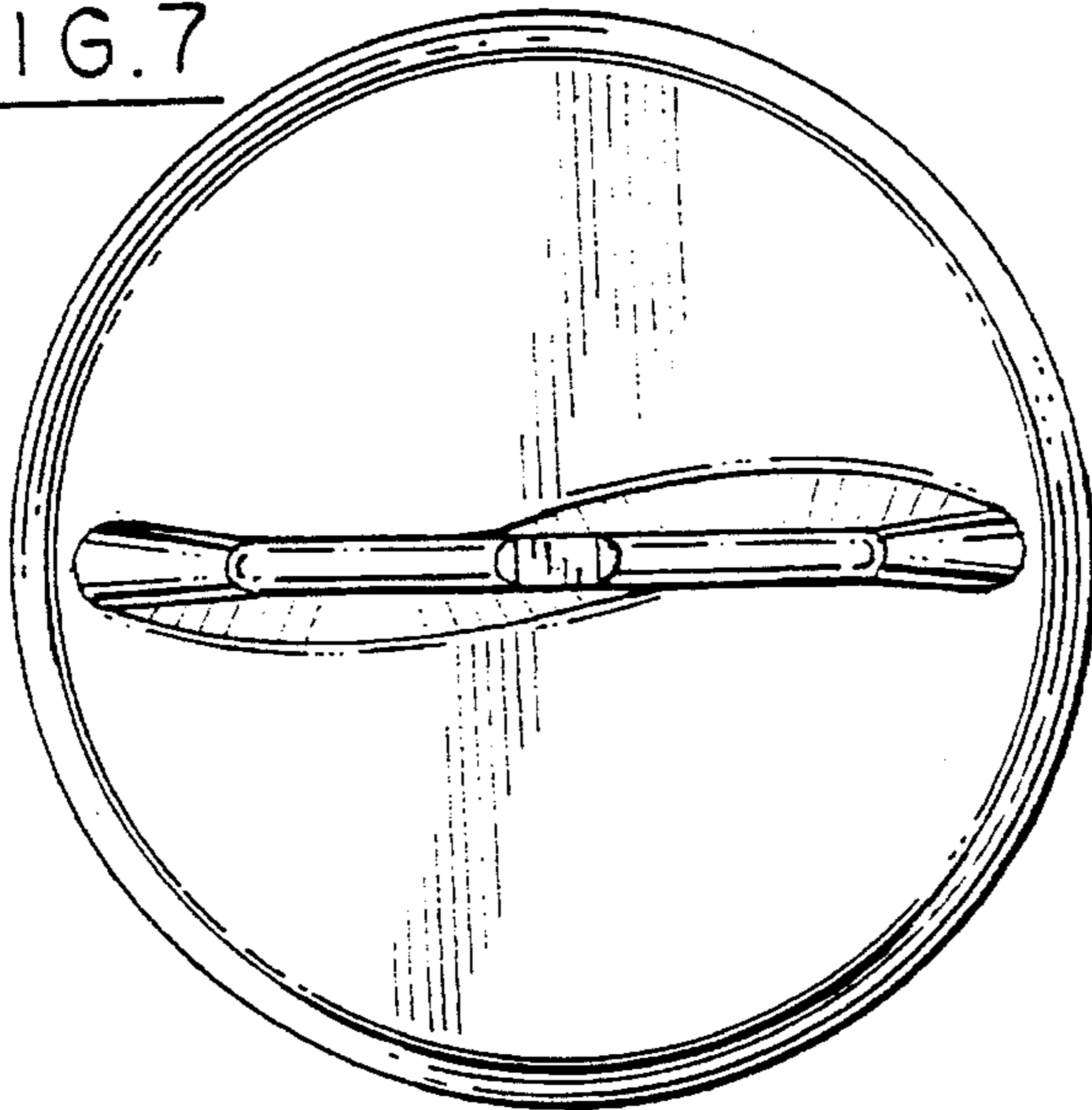
