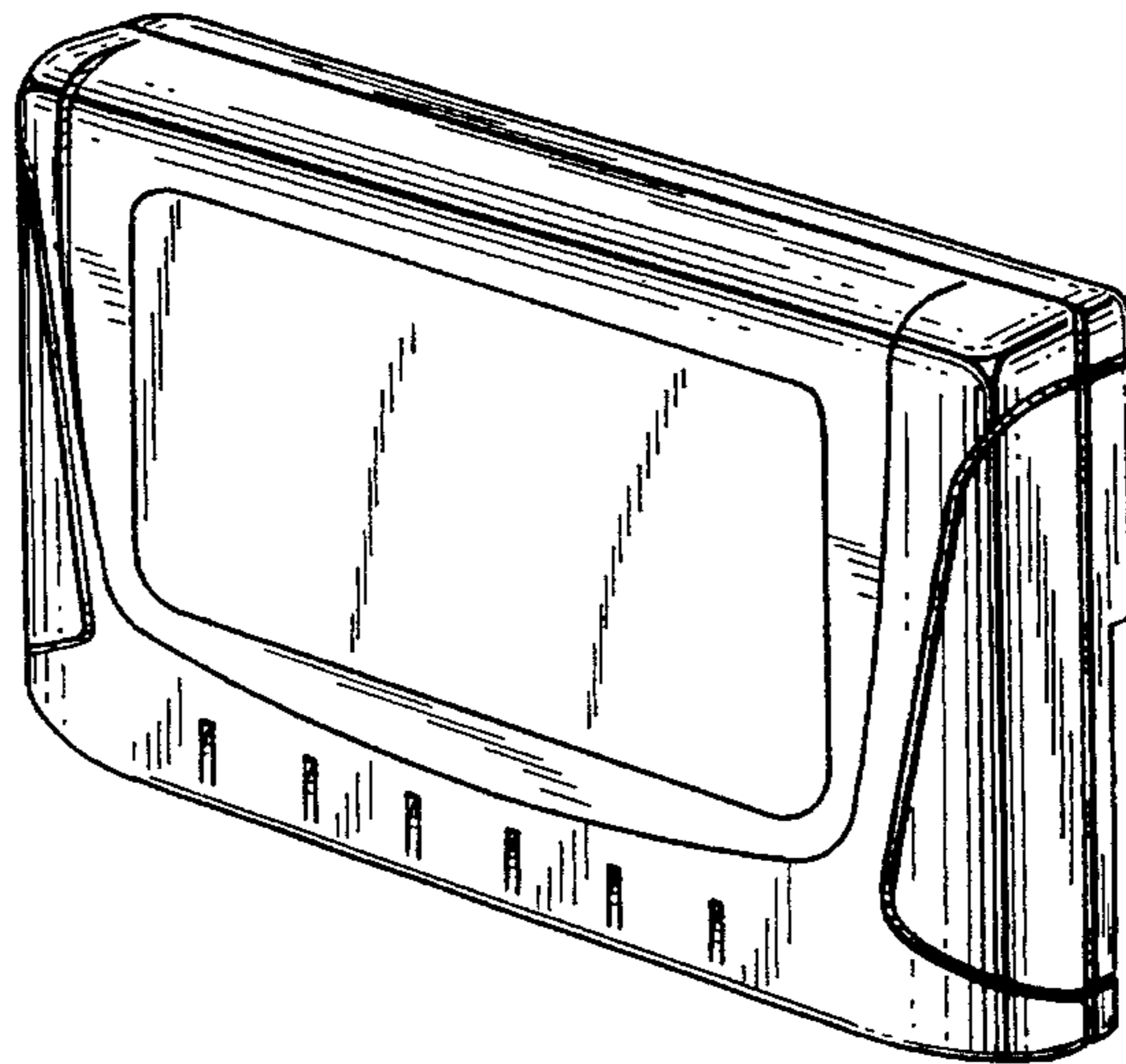
[57] **CLAIM**

The ornamental design for a cartridge for video game machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a cartridge for video game machine showing my new design;  
 FIG. 2 is a rear view thereof;  
 FIG. 3 is a top view thereof;  
 FIG. 4 is a bottom view thereof;  
 FIG. 5 is a left side view thereof, the right side view being a mirror image of the left side; and,  
 FIG. 6 is a top front and right side perspective view thereof.

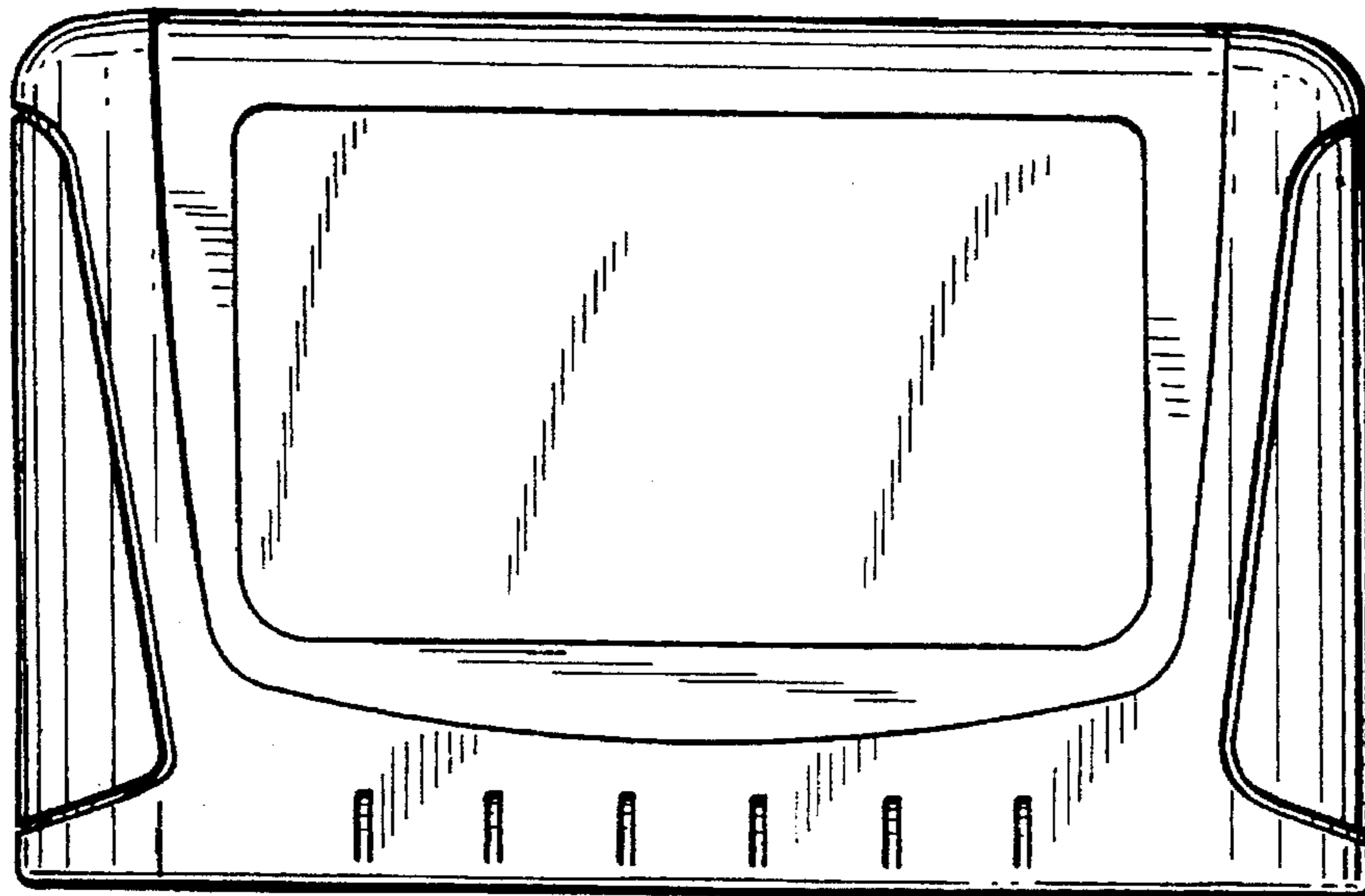

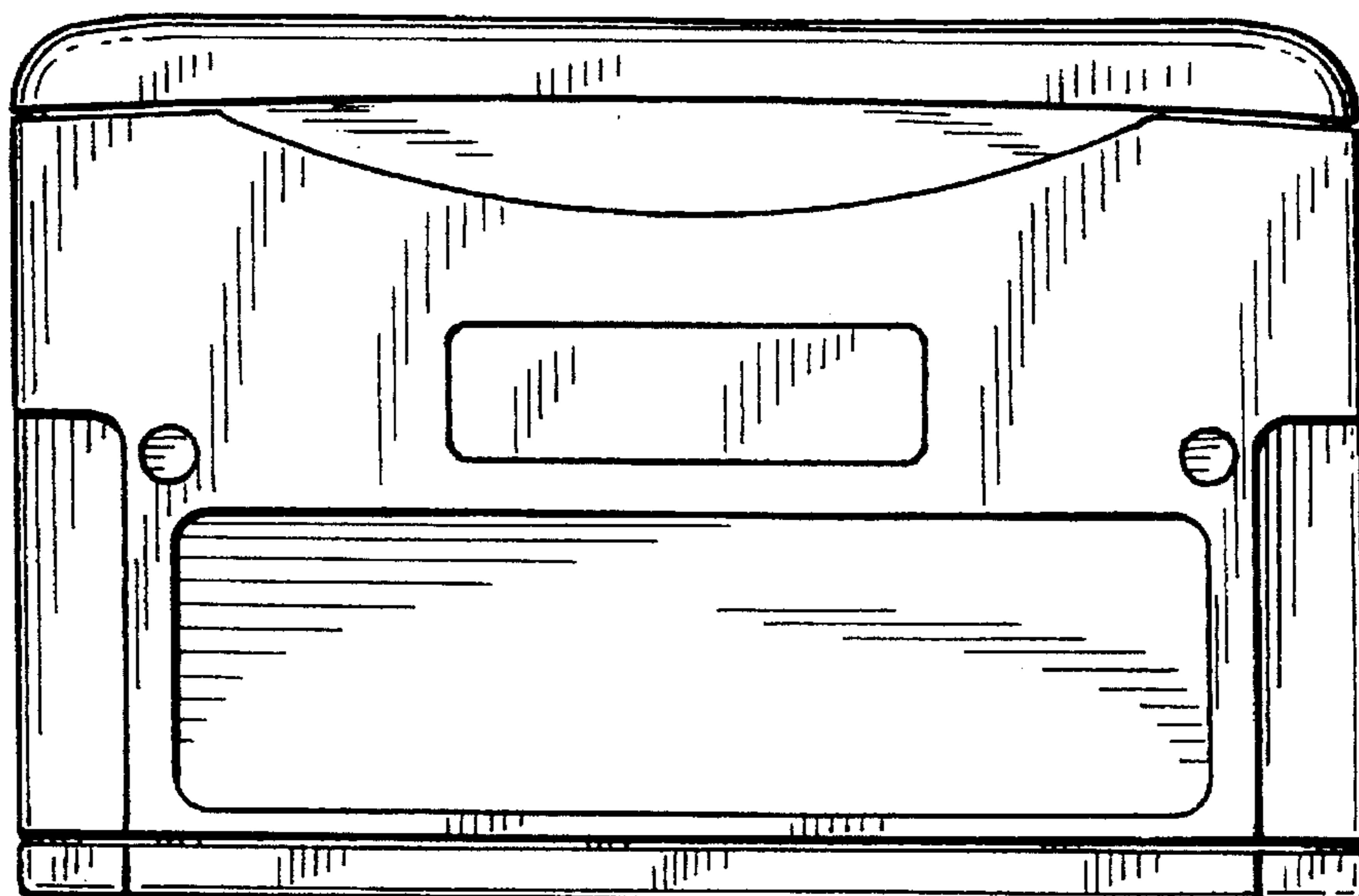

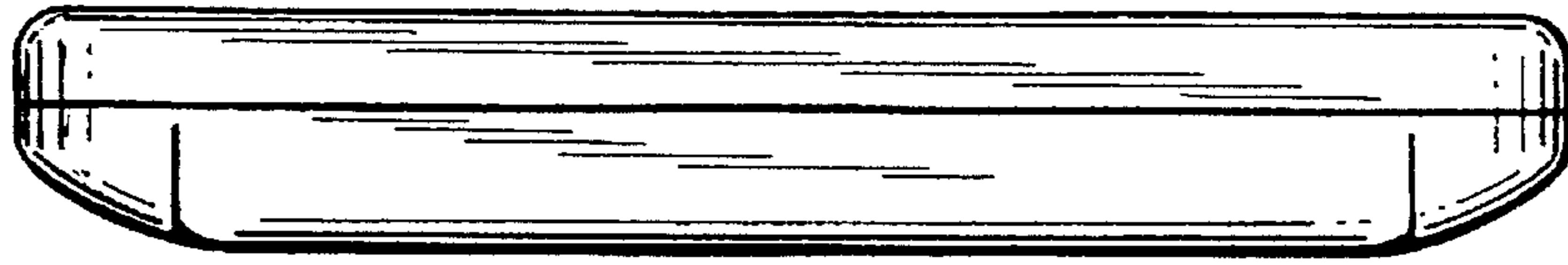

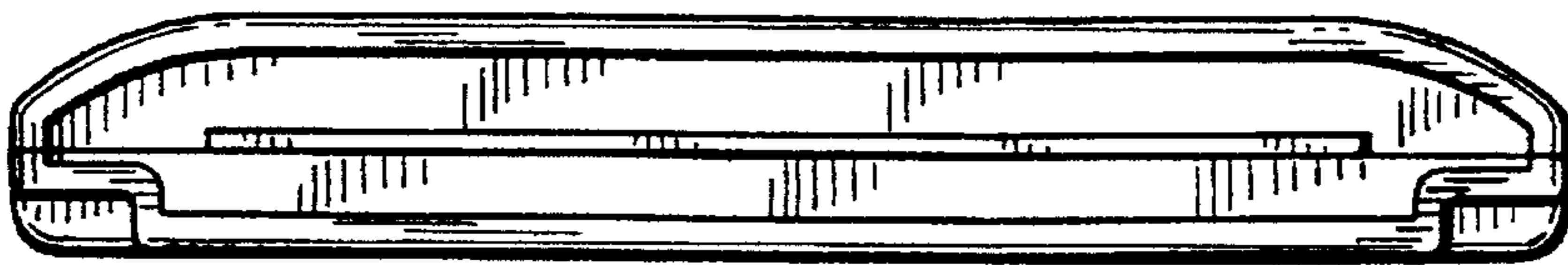

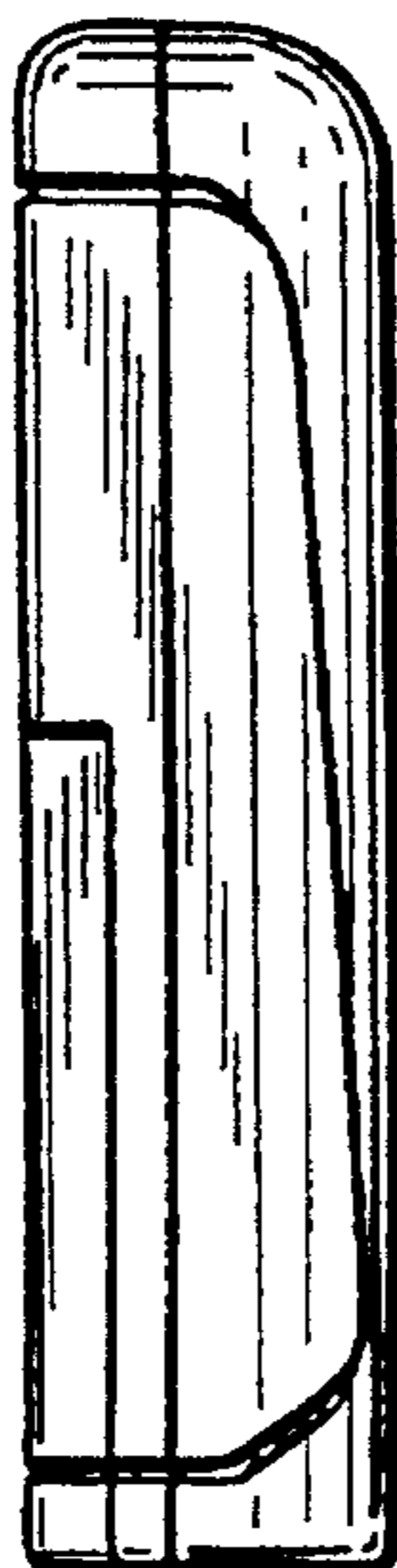
