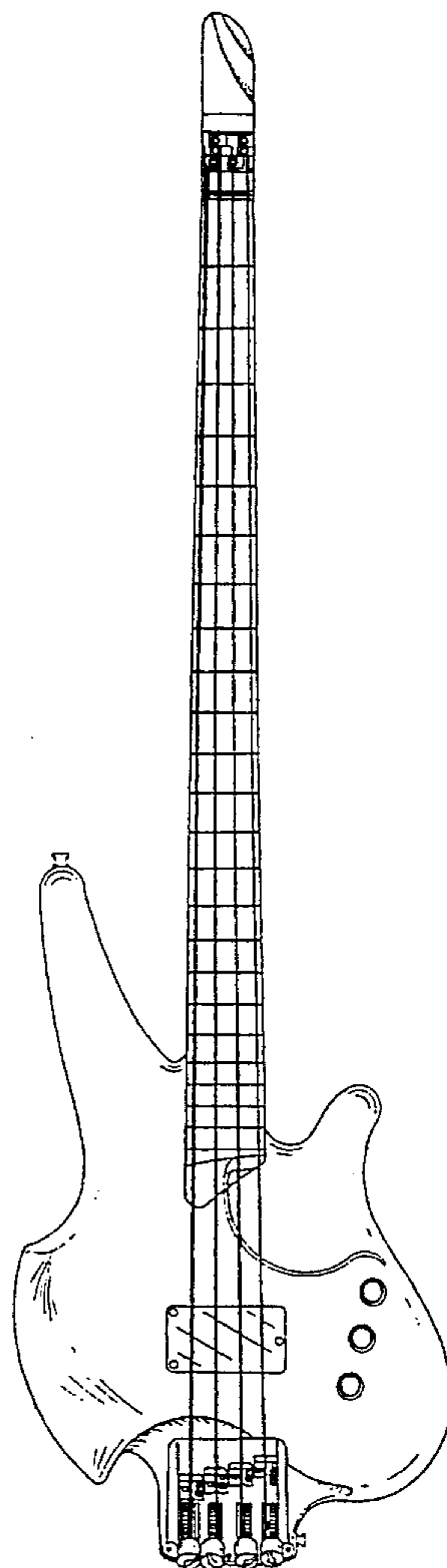
FIG. 1 is a front elevational view of a bass showing my new design;

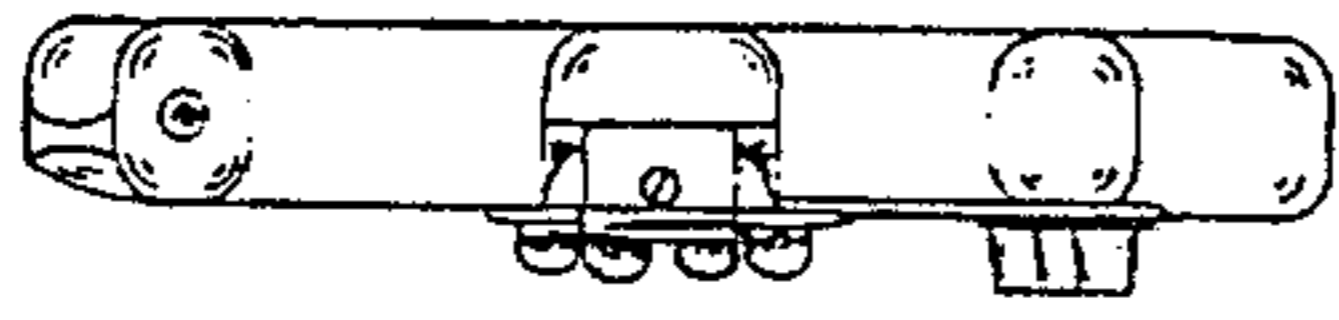

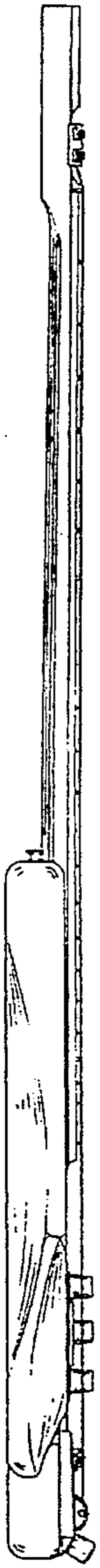

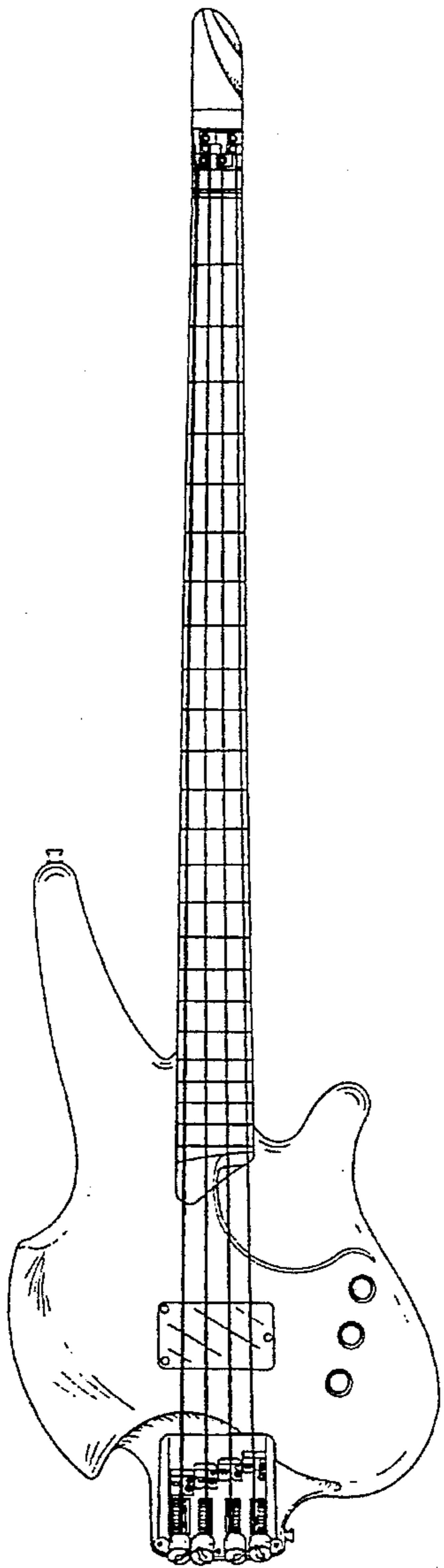

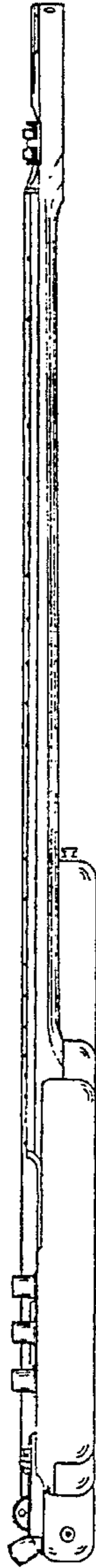

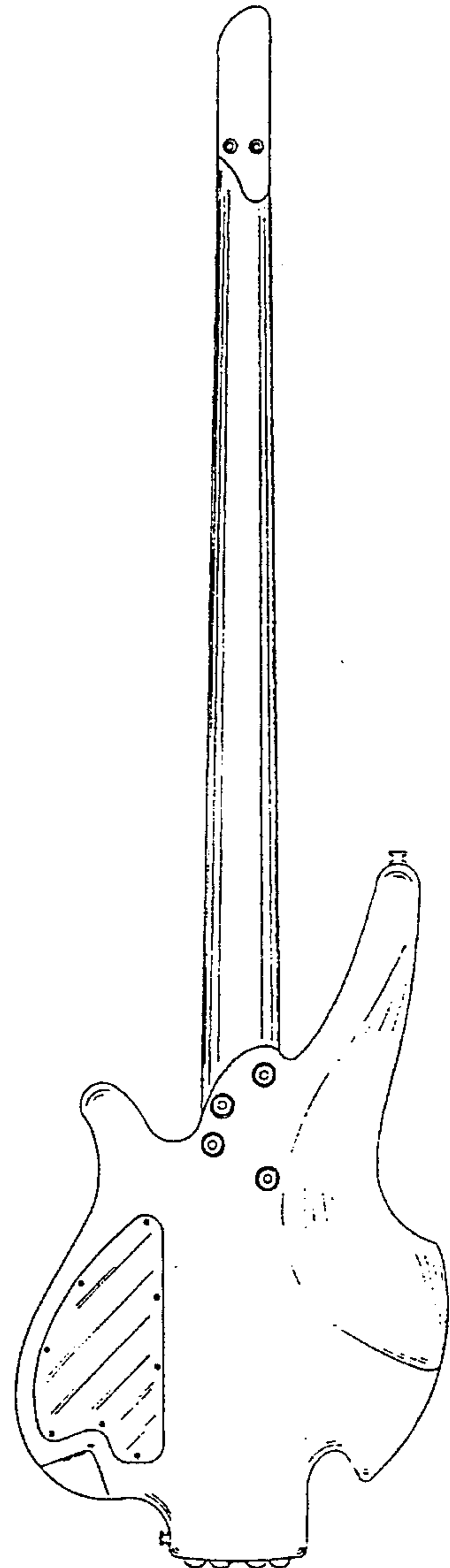

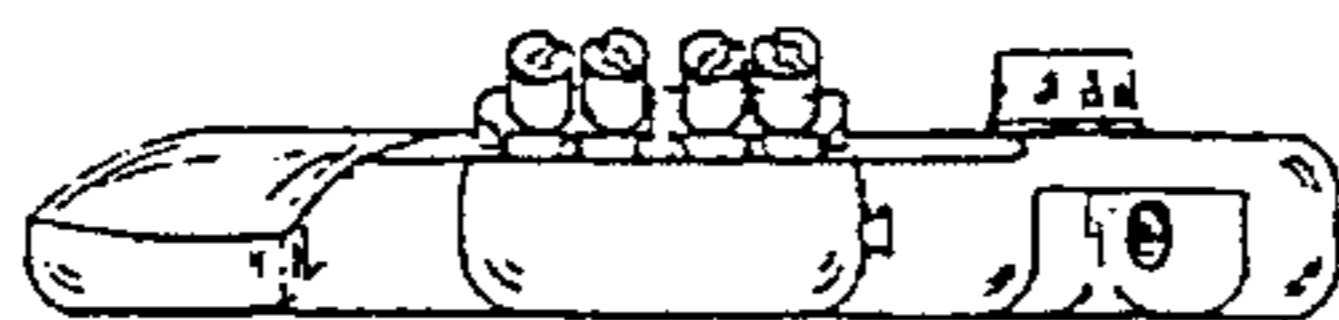

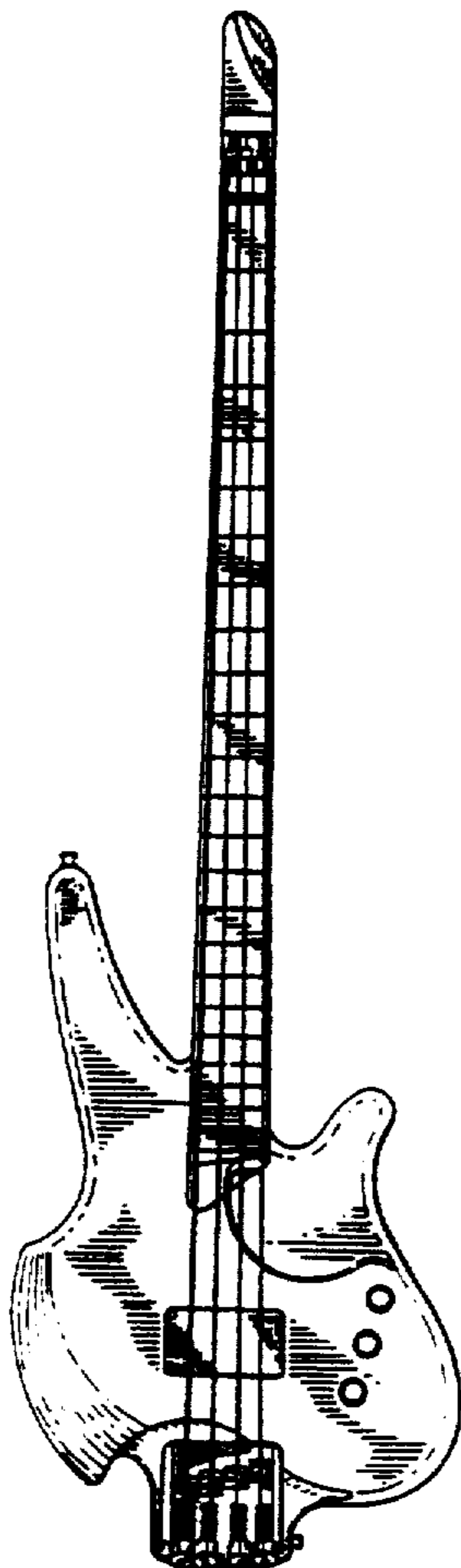

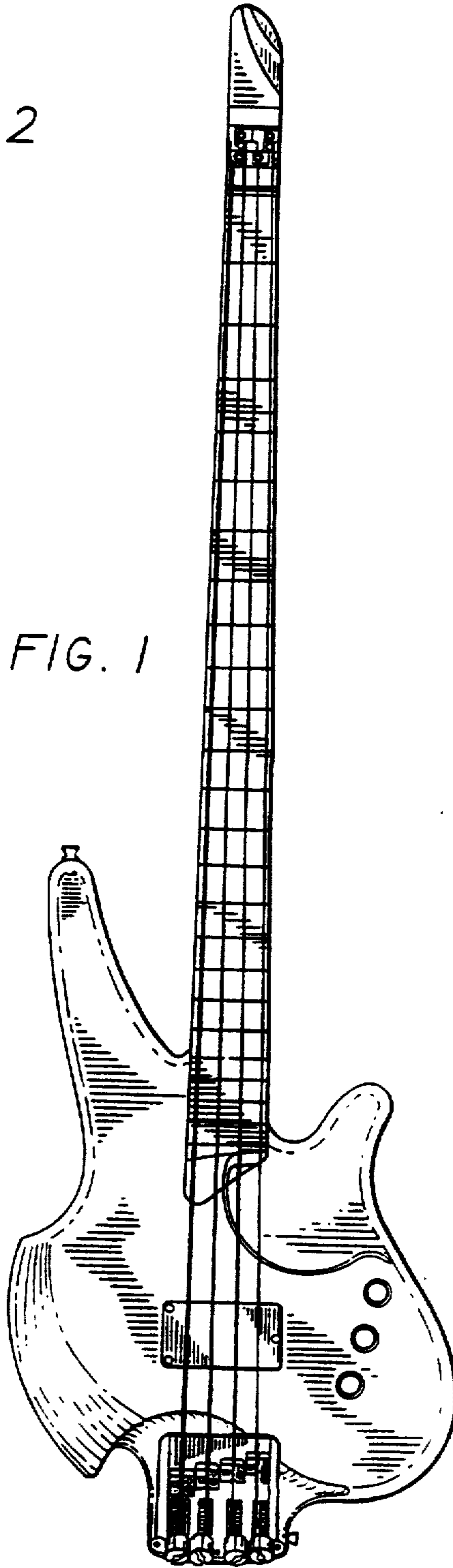

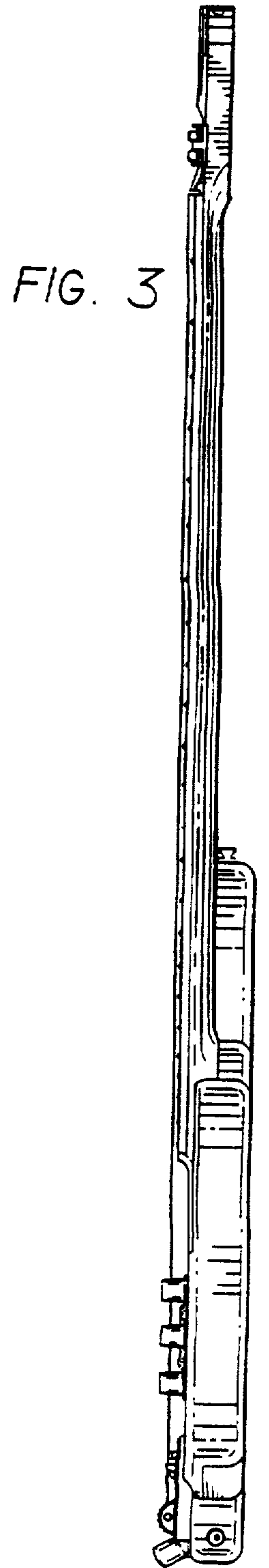

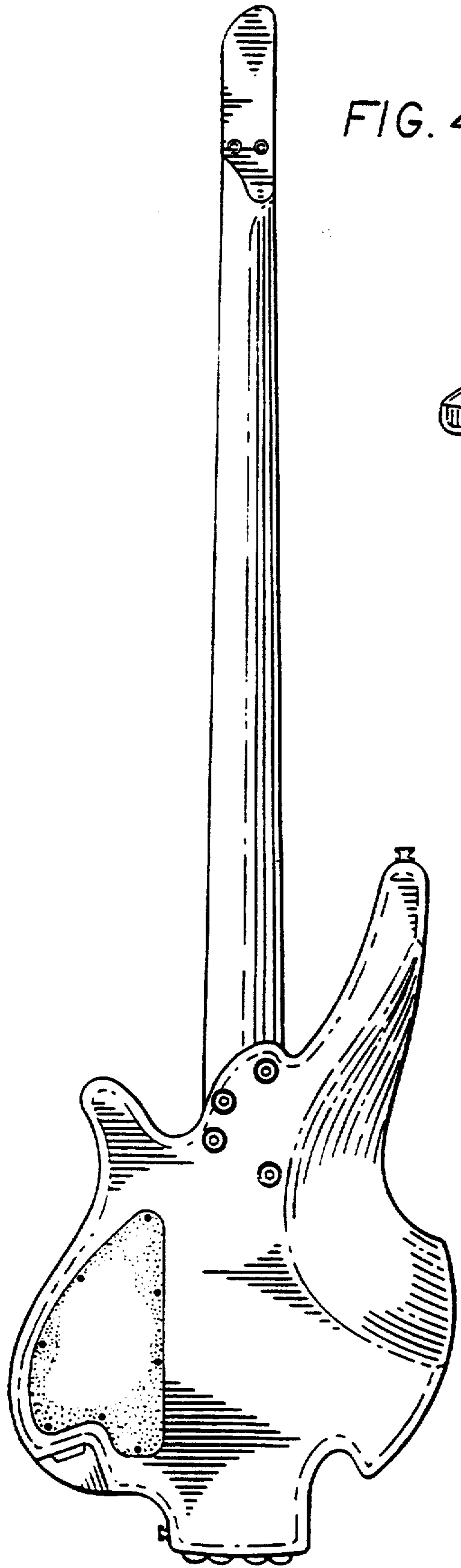

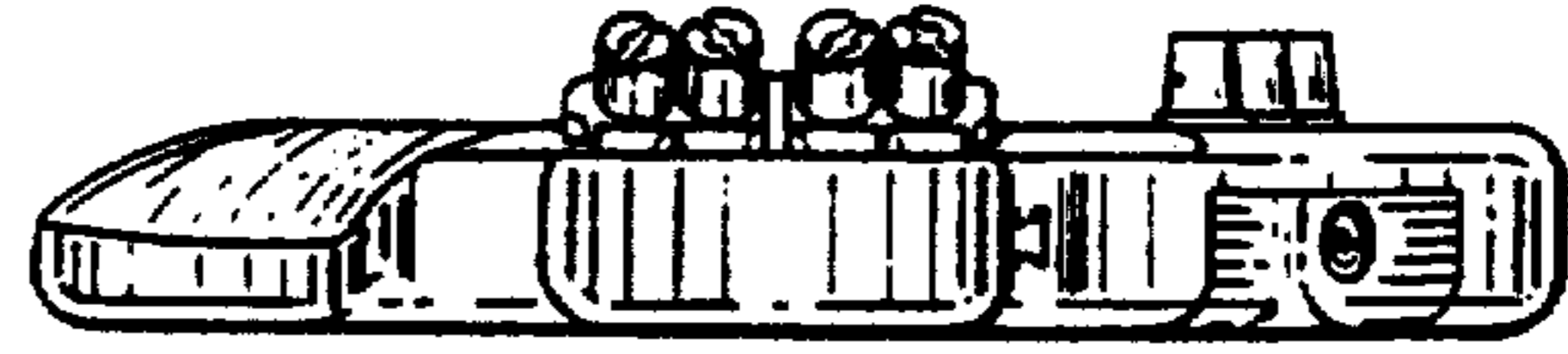

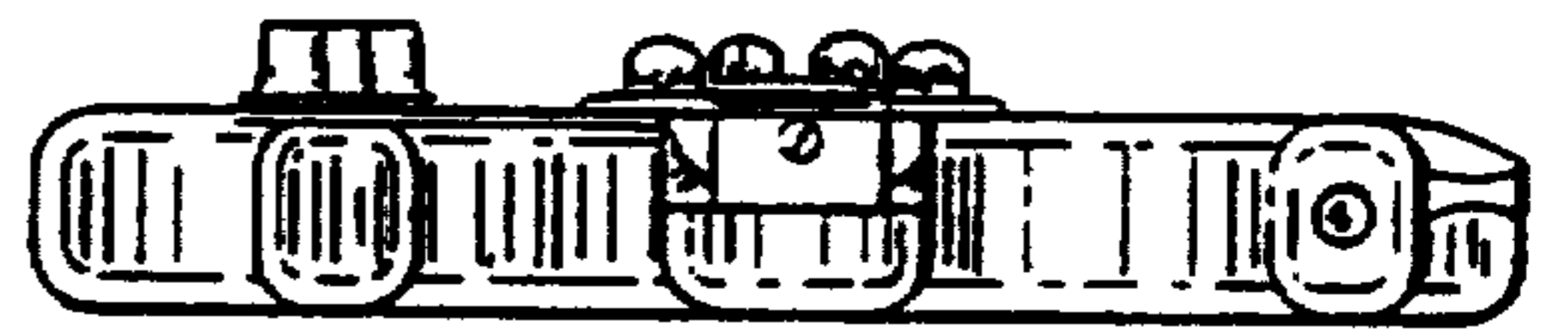
