[57] **CLAIM**

The ornamental design for a deck of playing cards, as shown and described.

**DESCRIPTION**

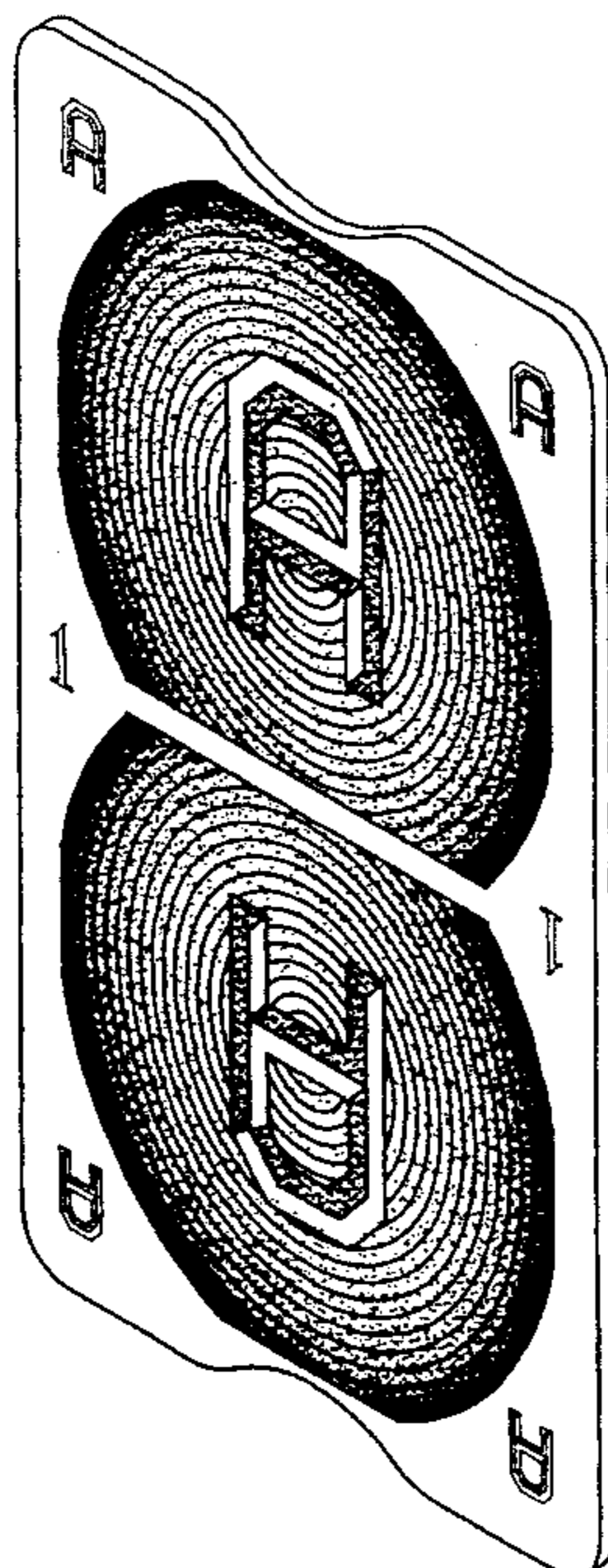

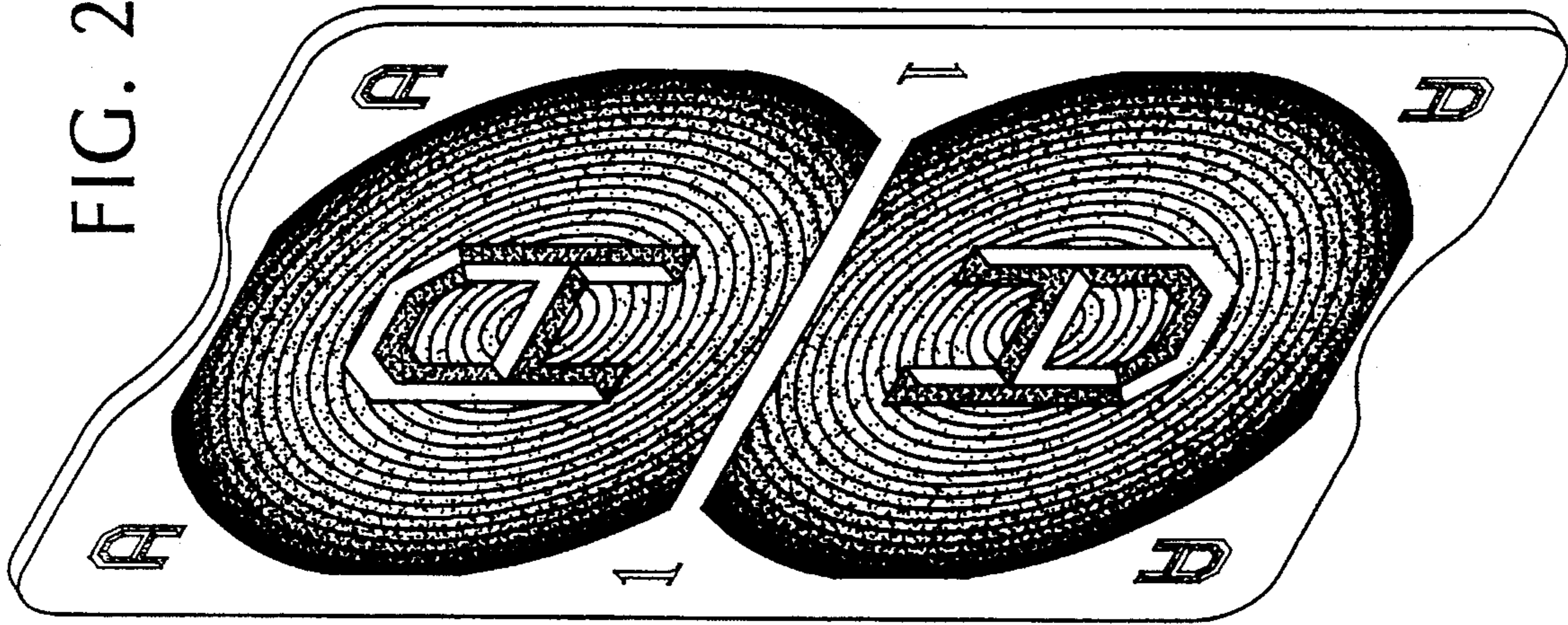

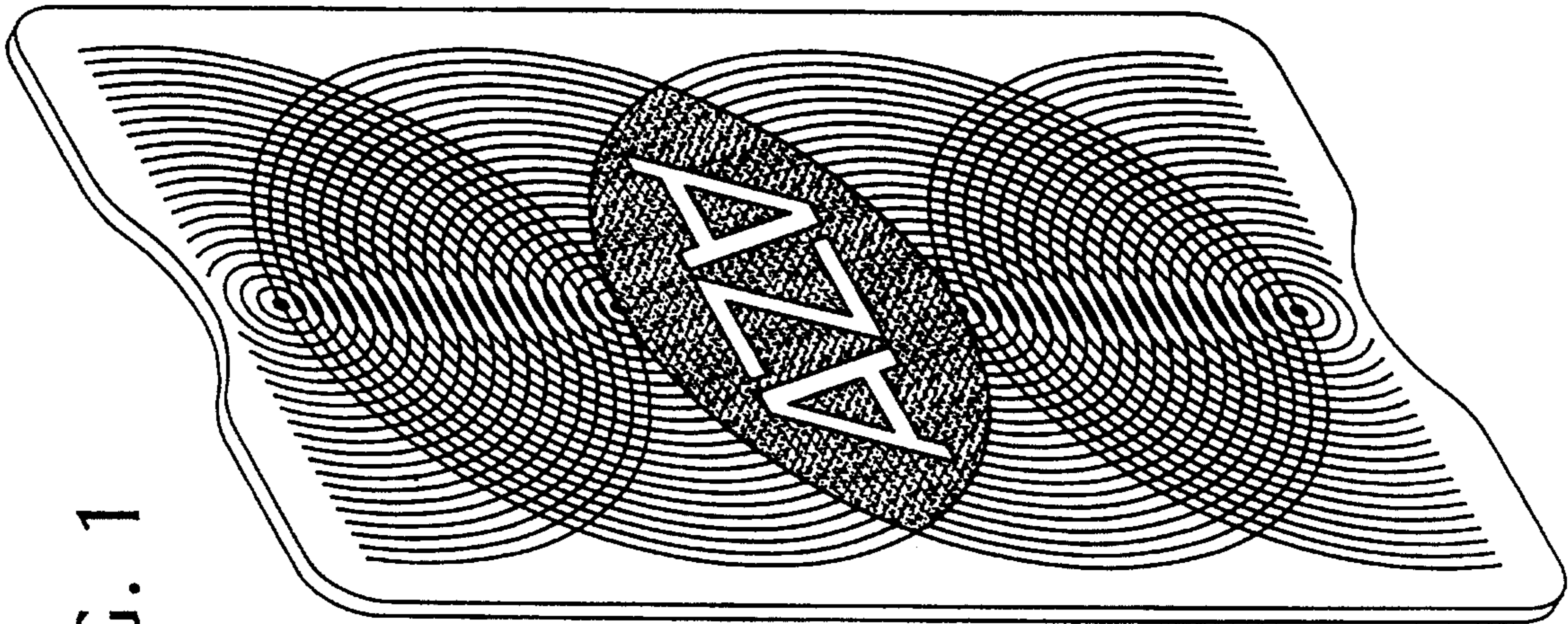

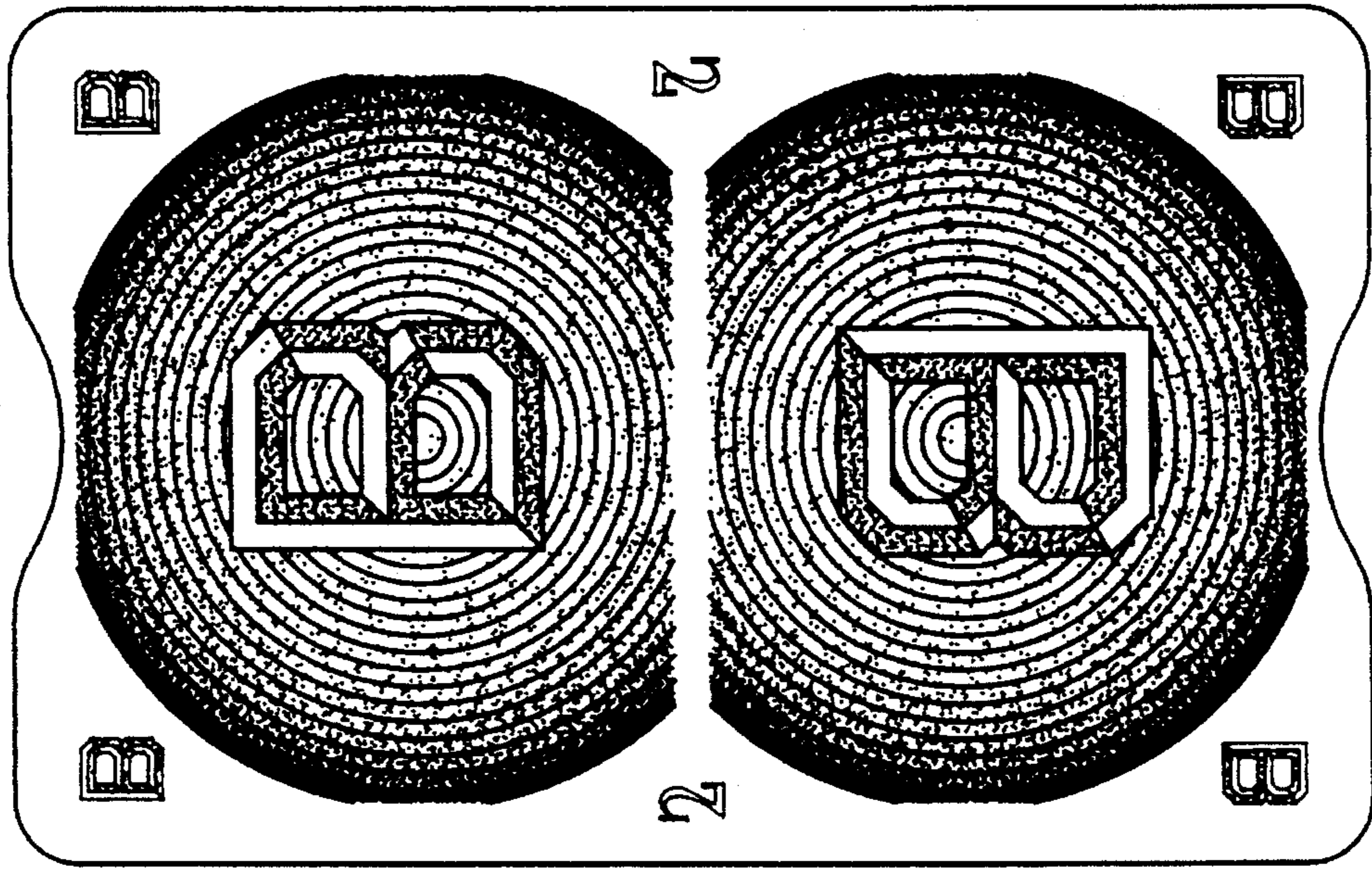

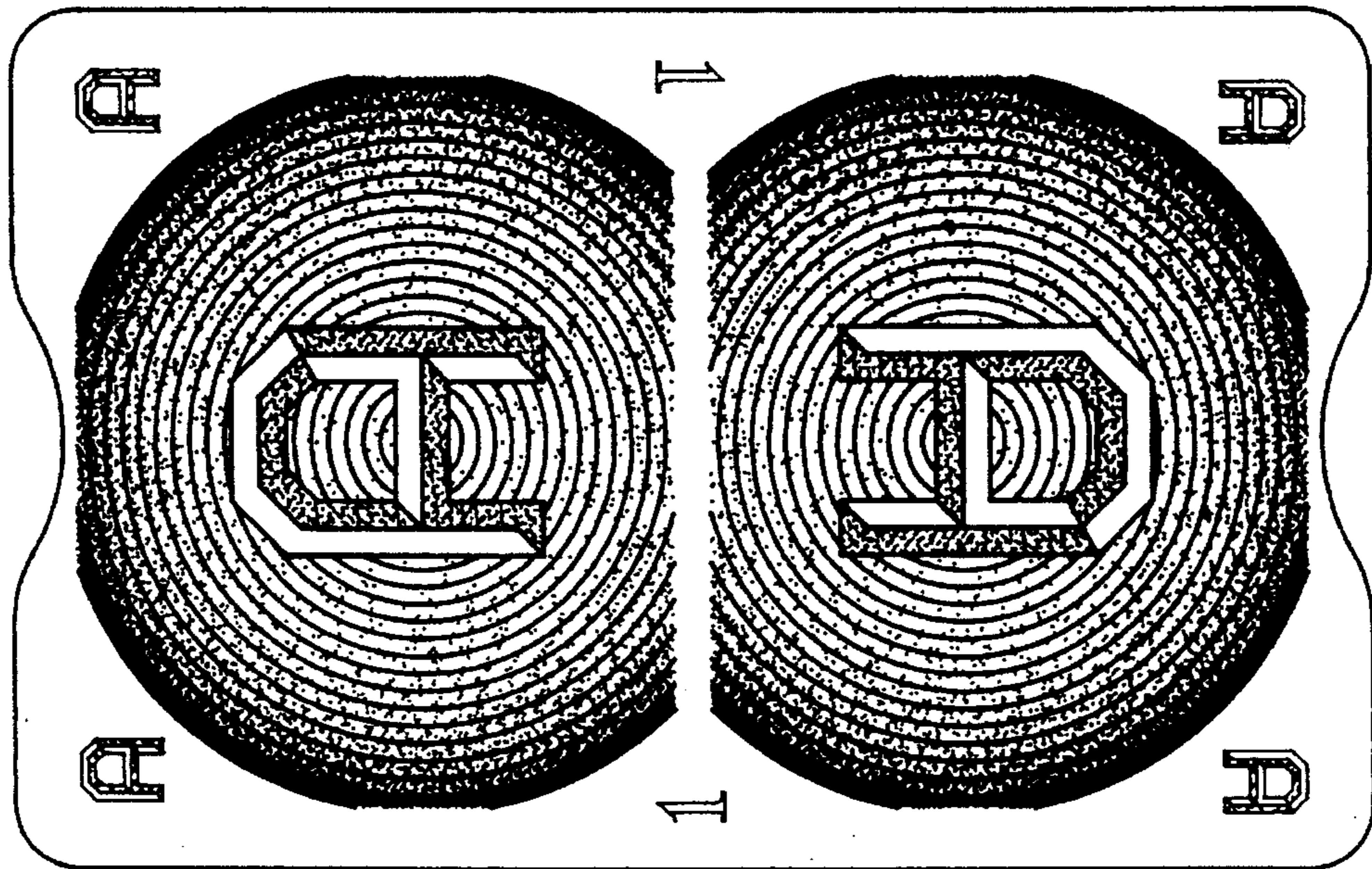

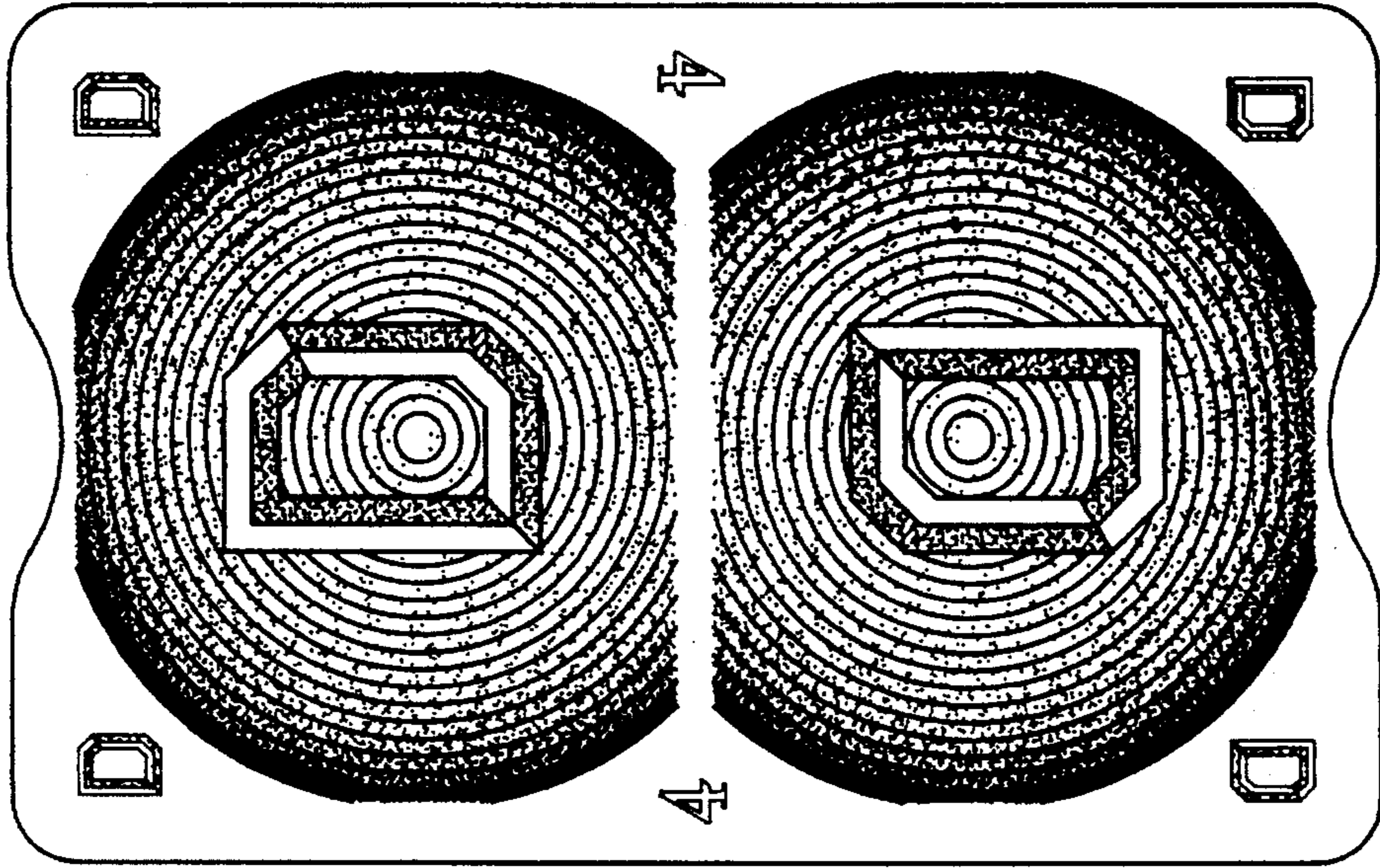

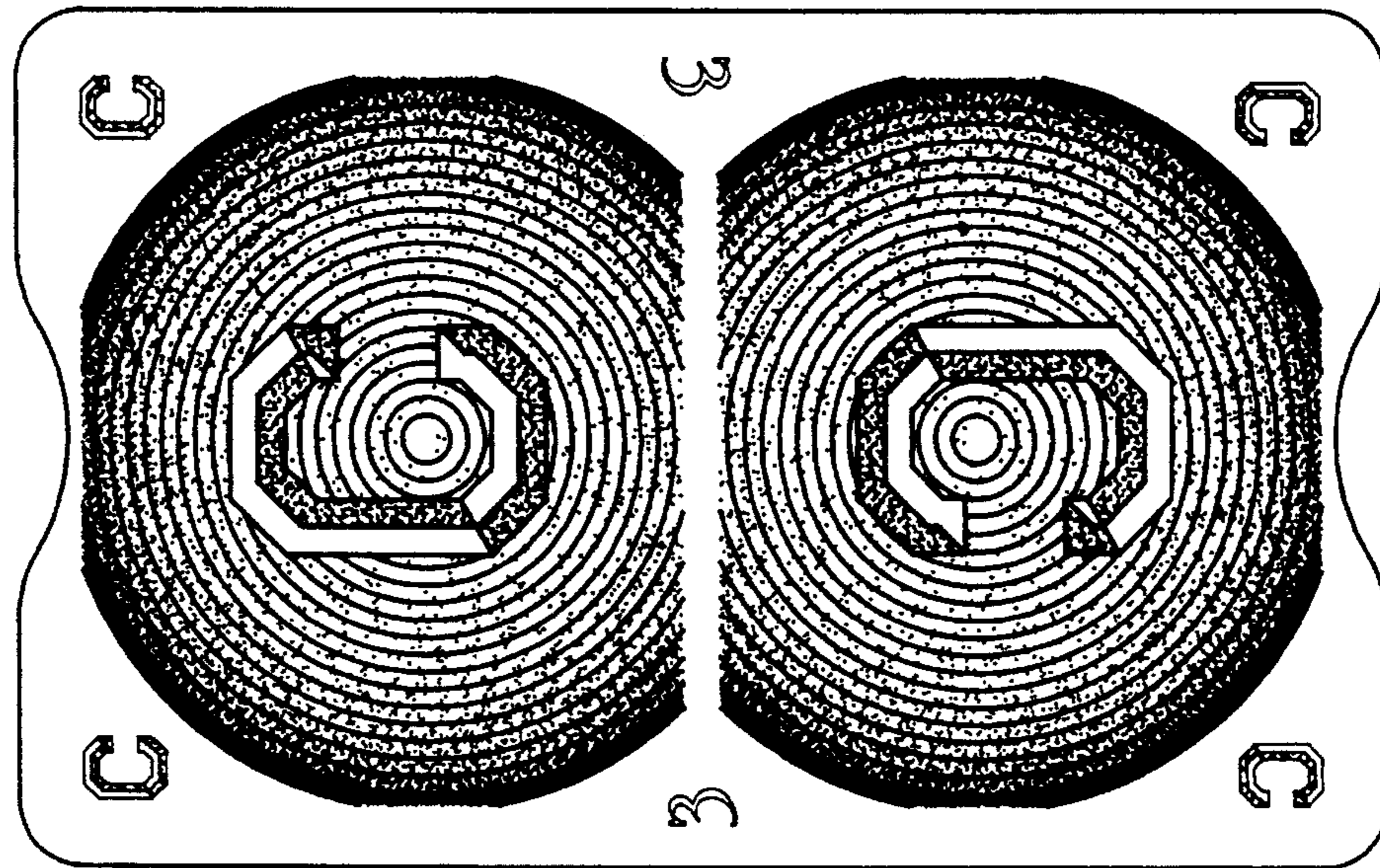

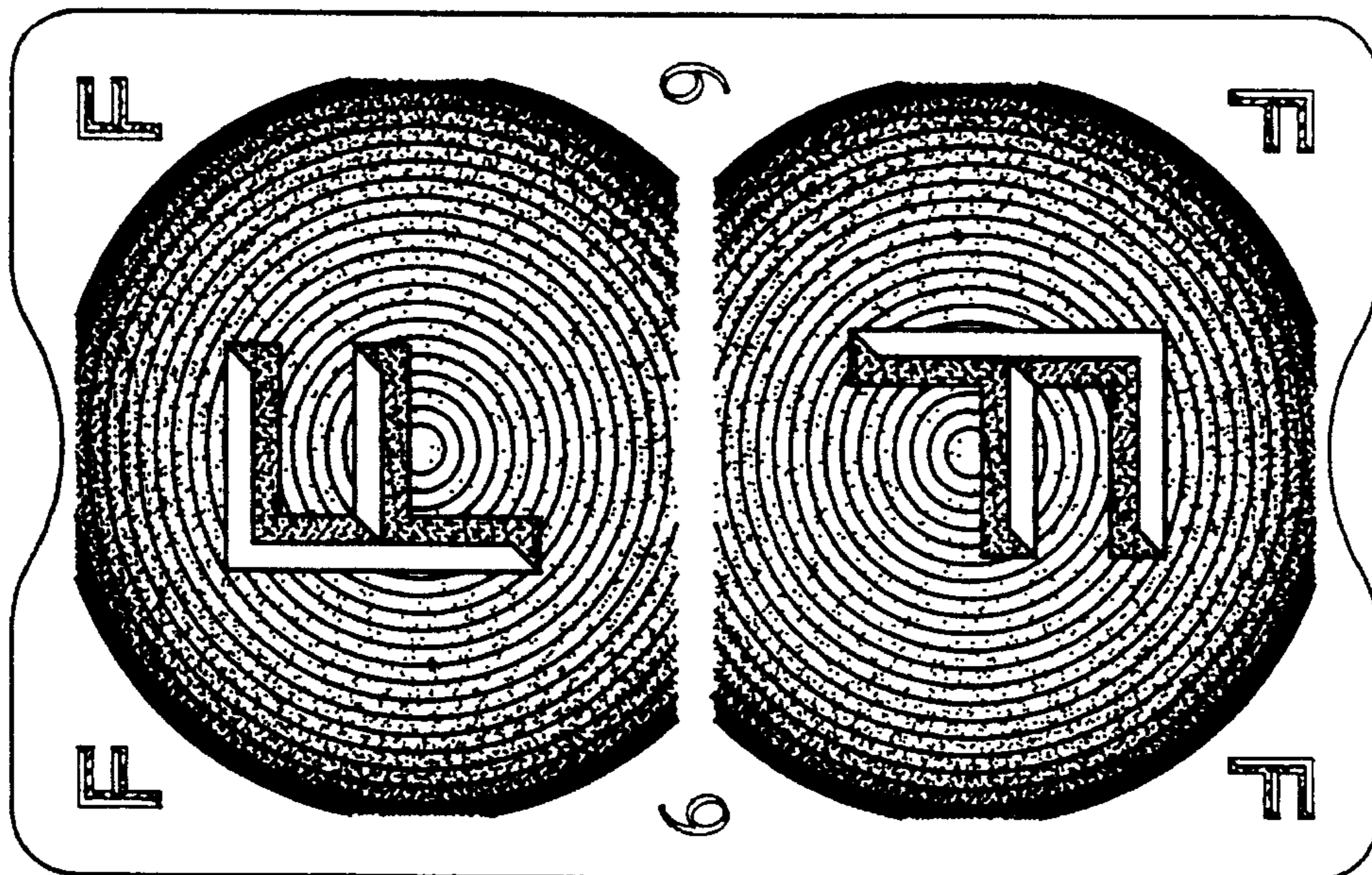

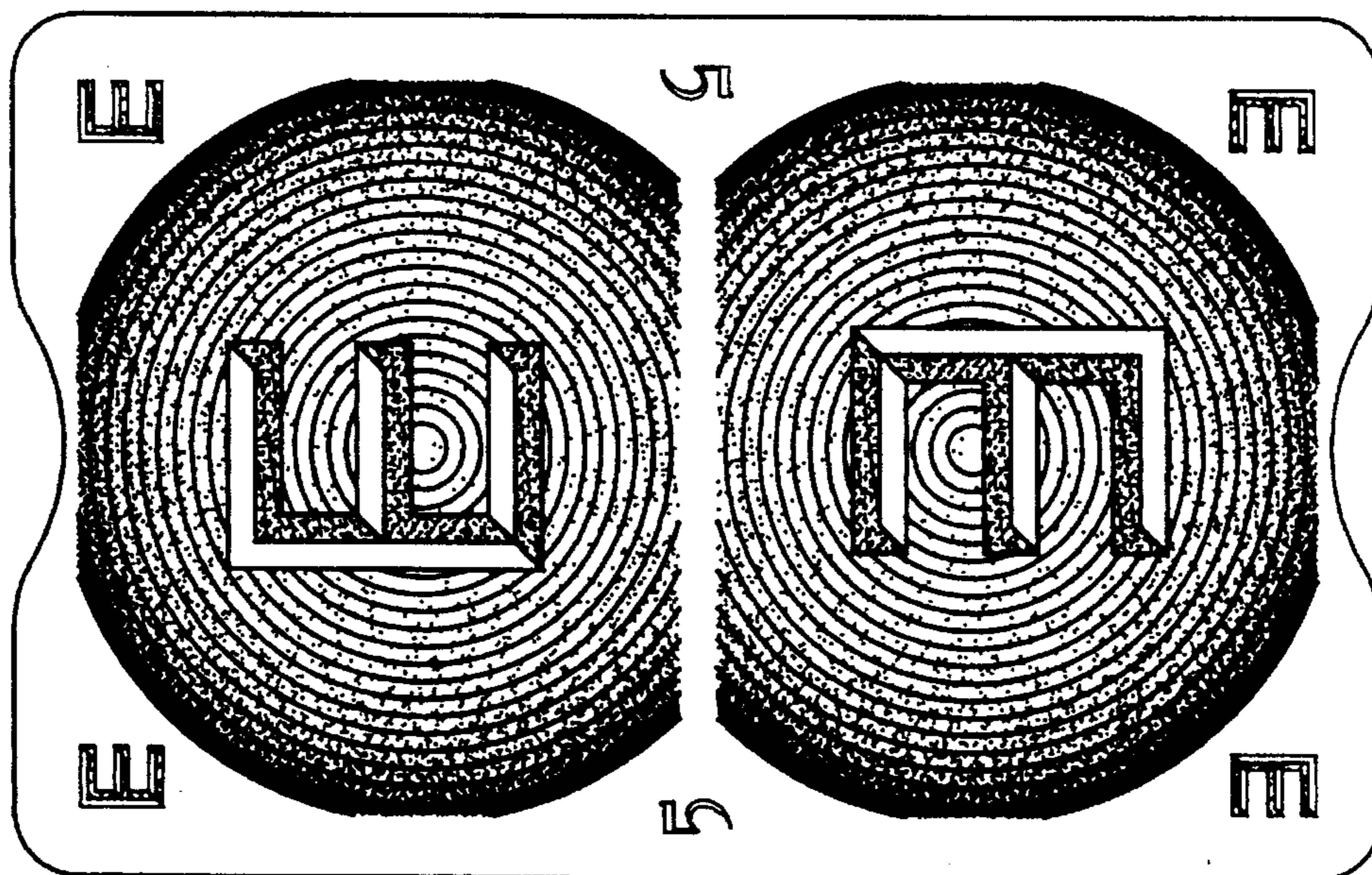

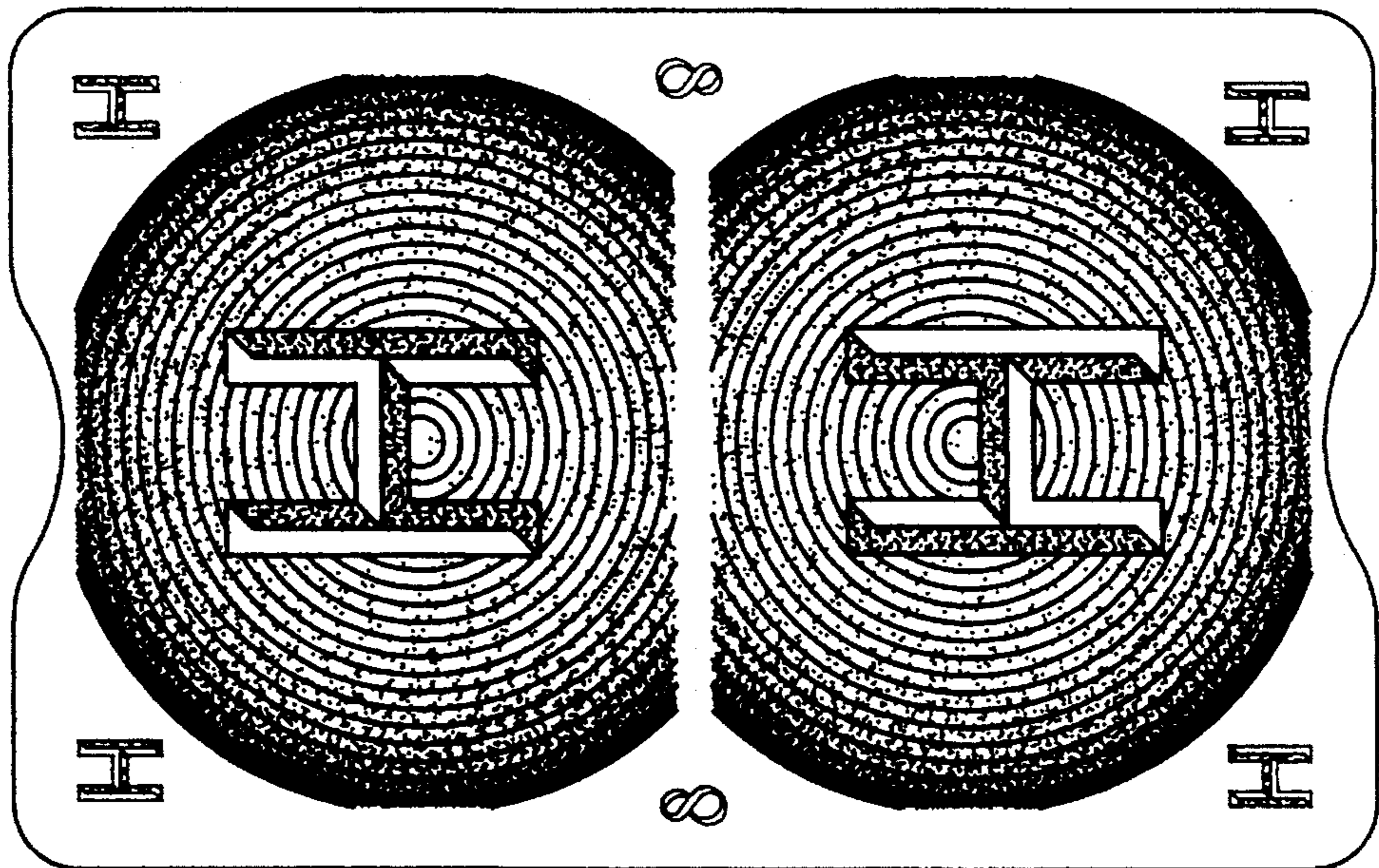

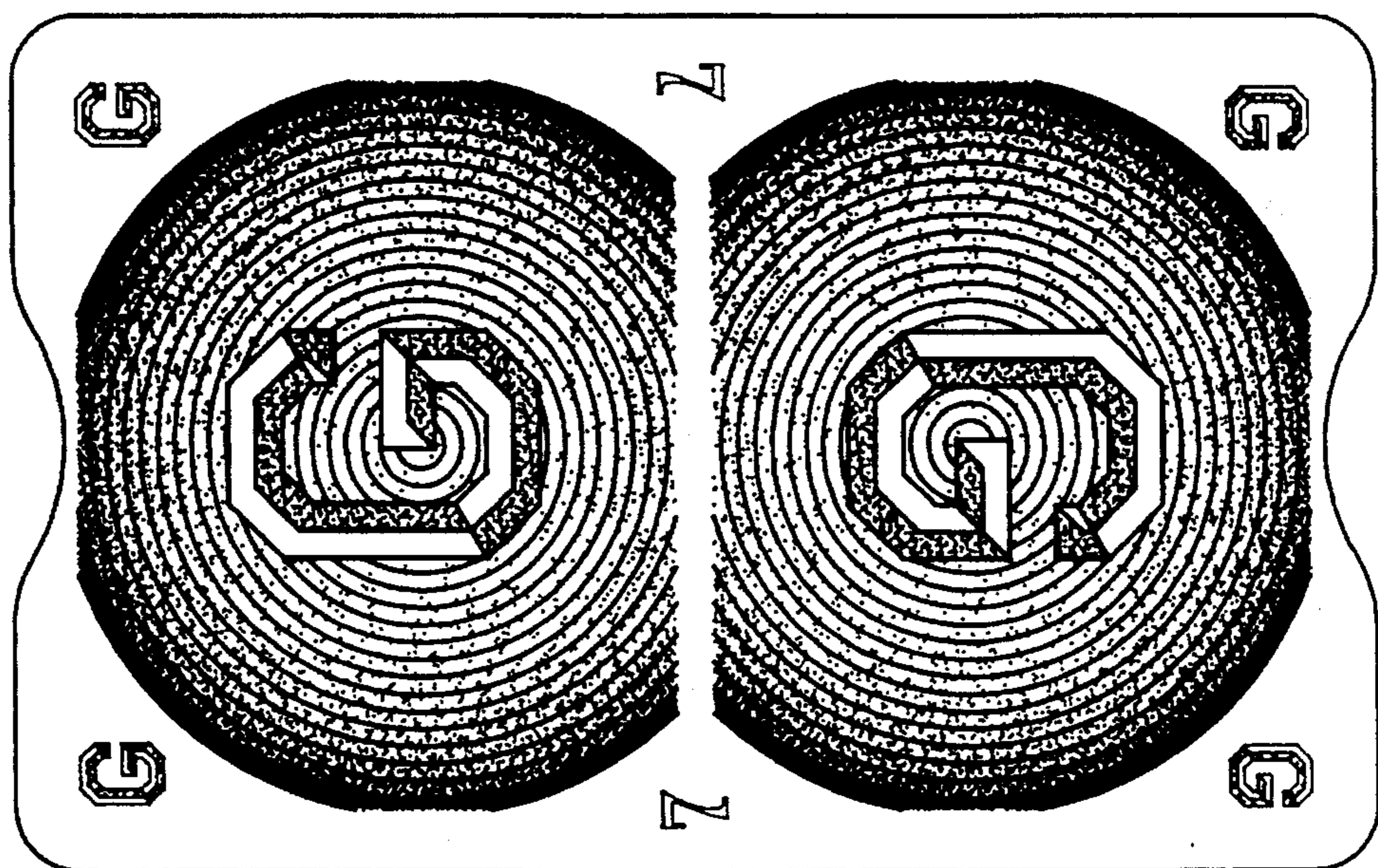

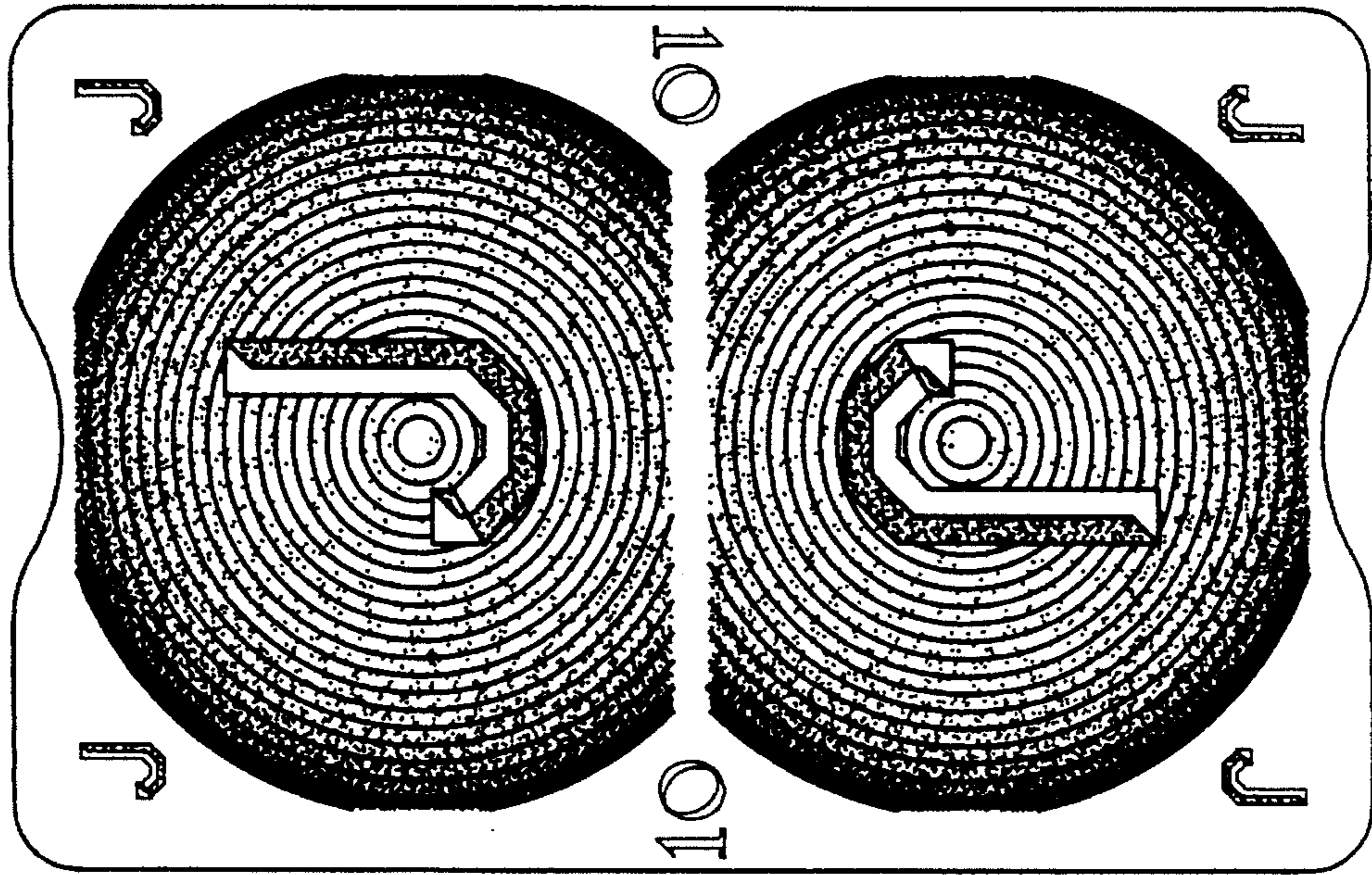

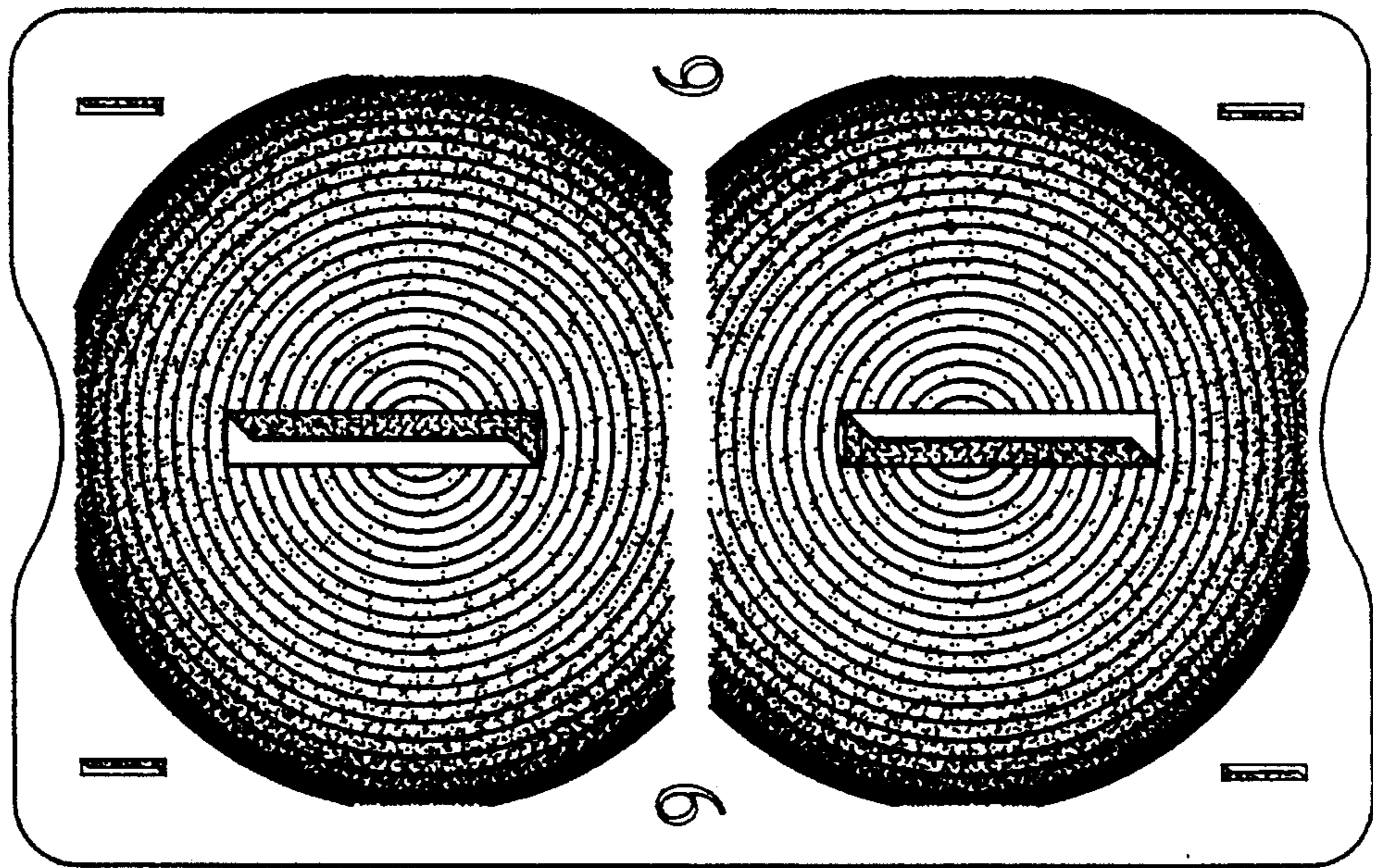

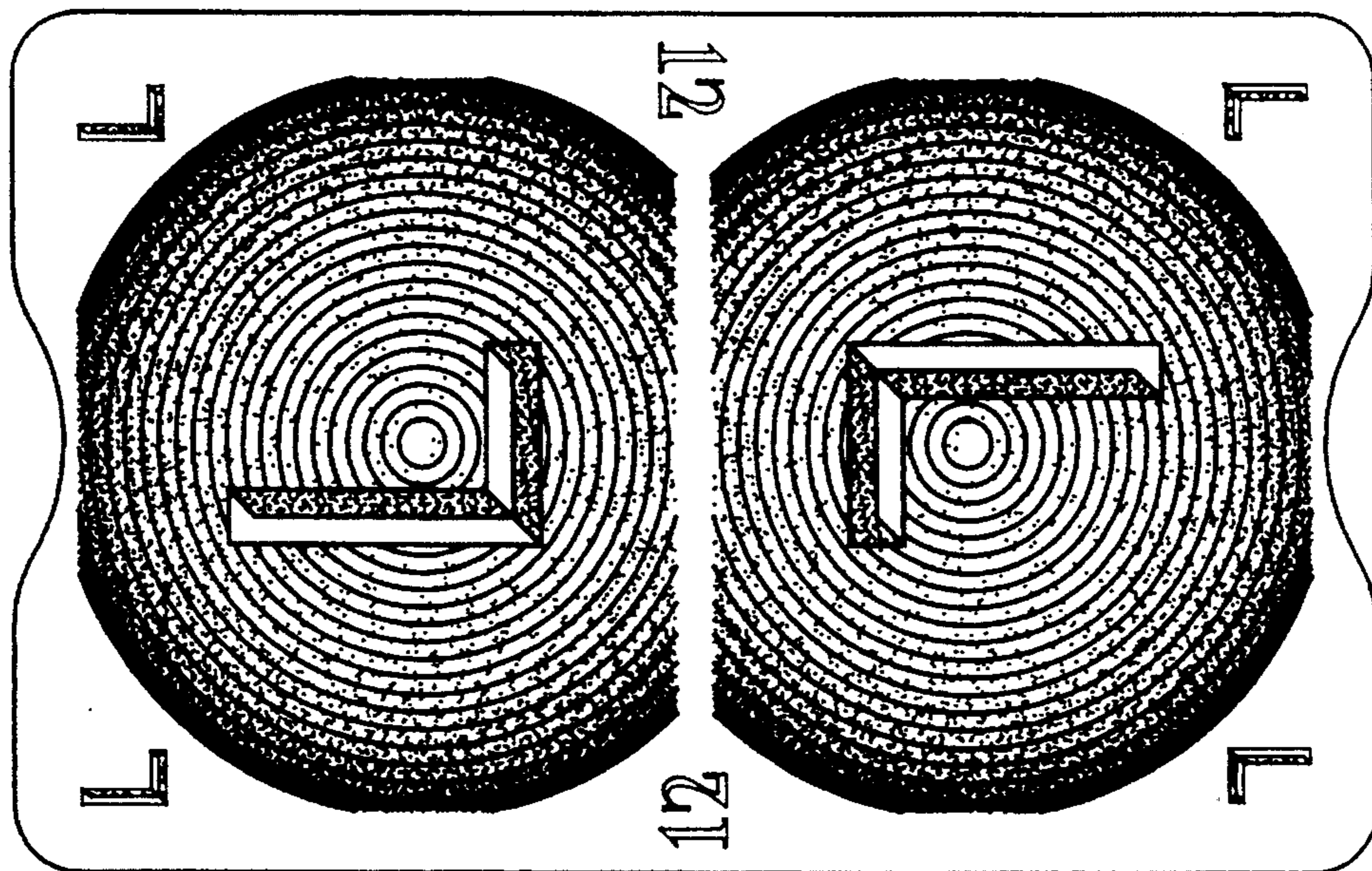

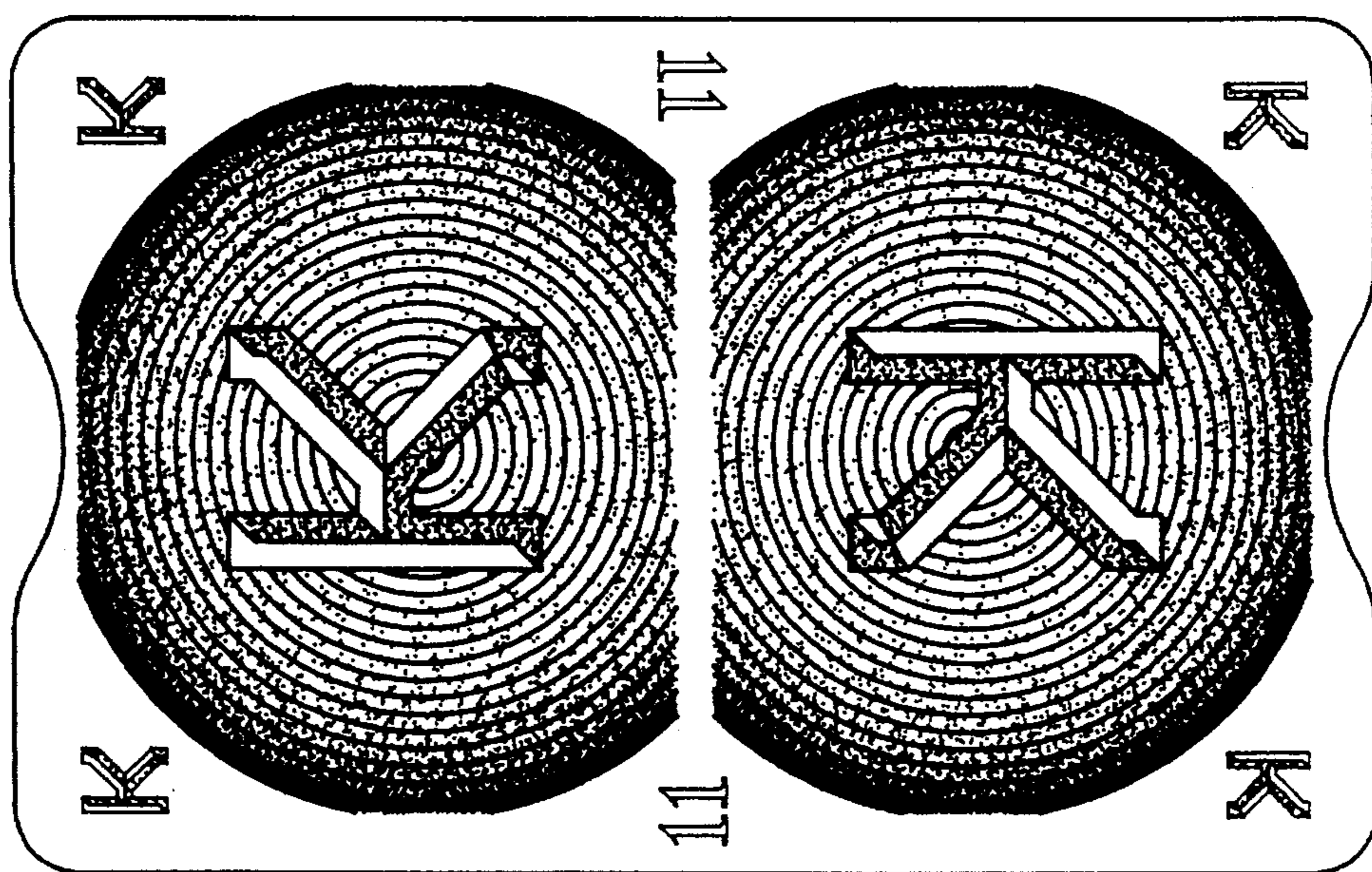

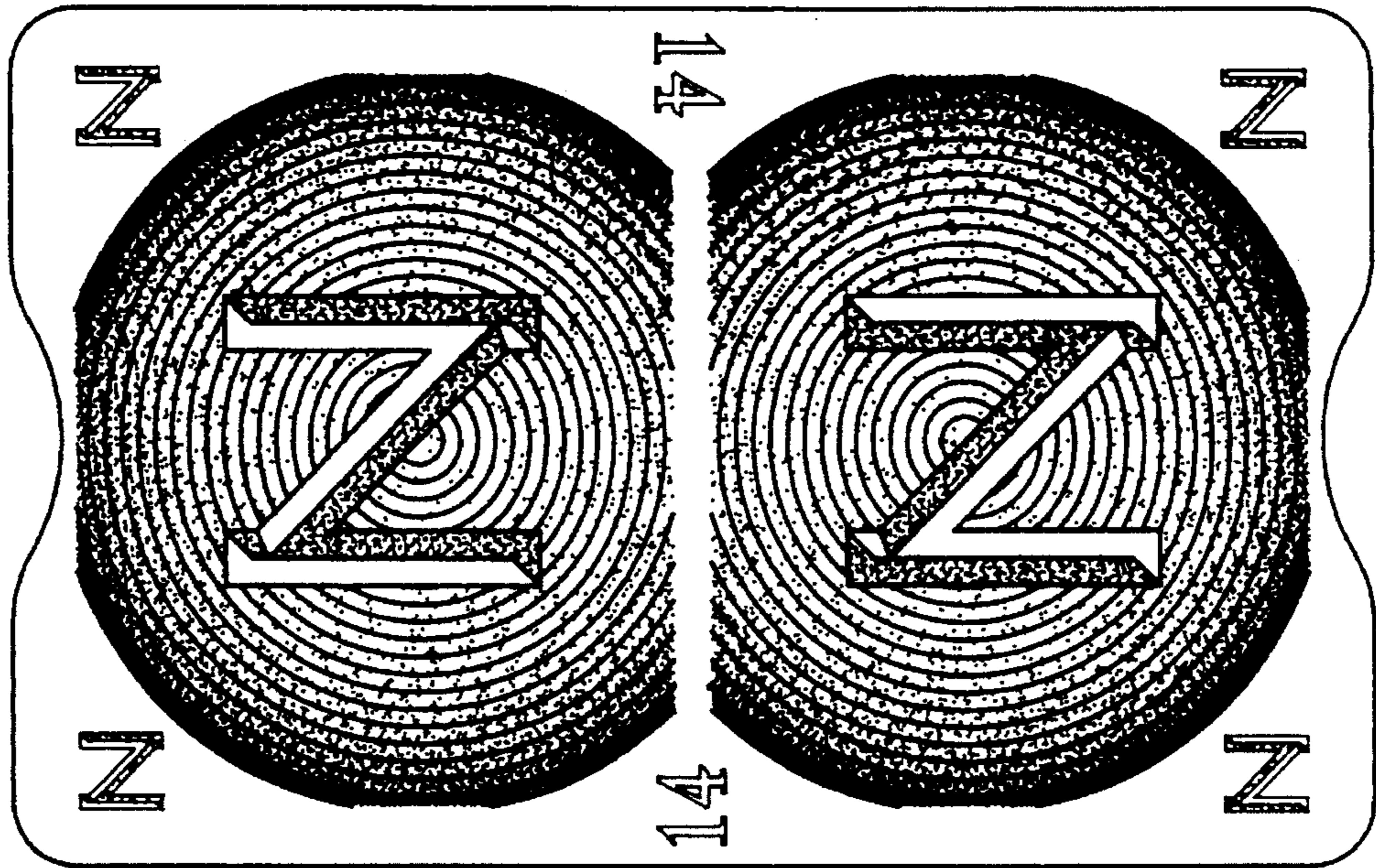

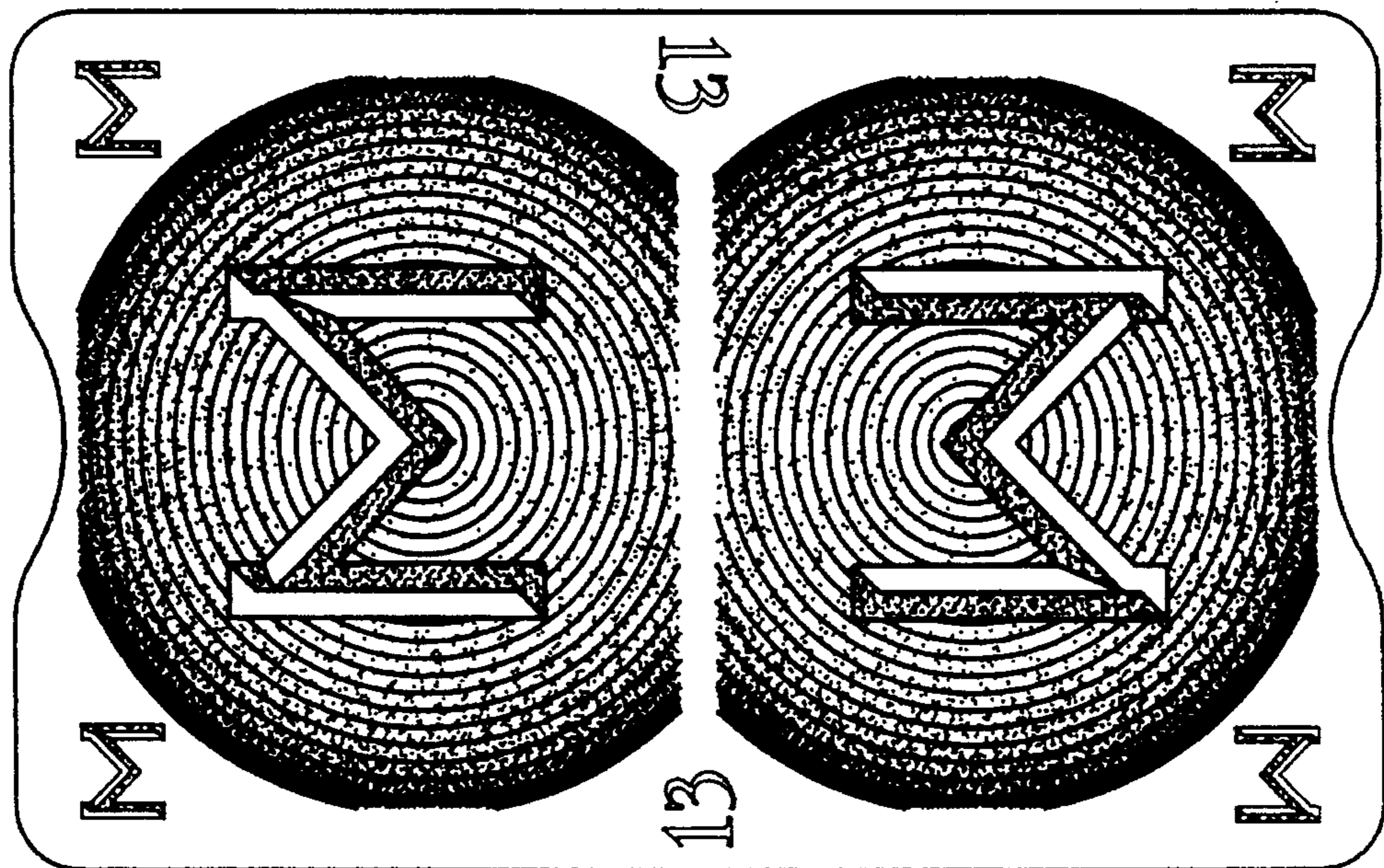

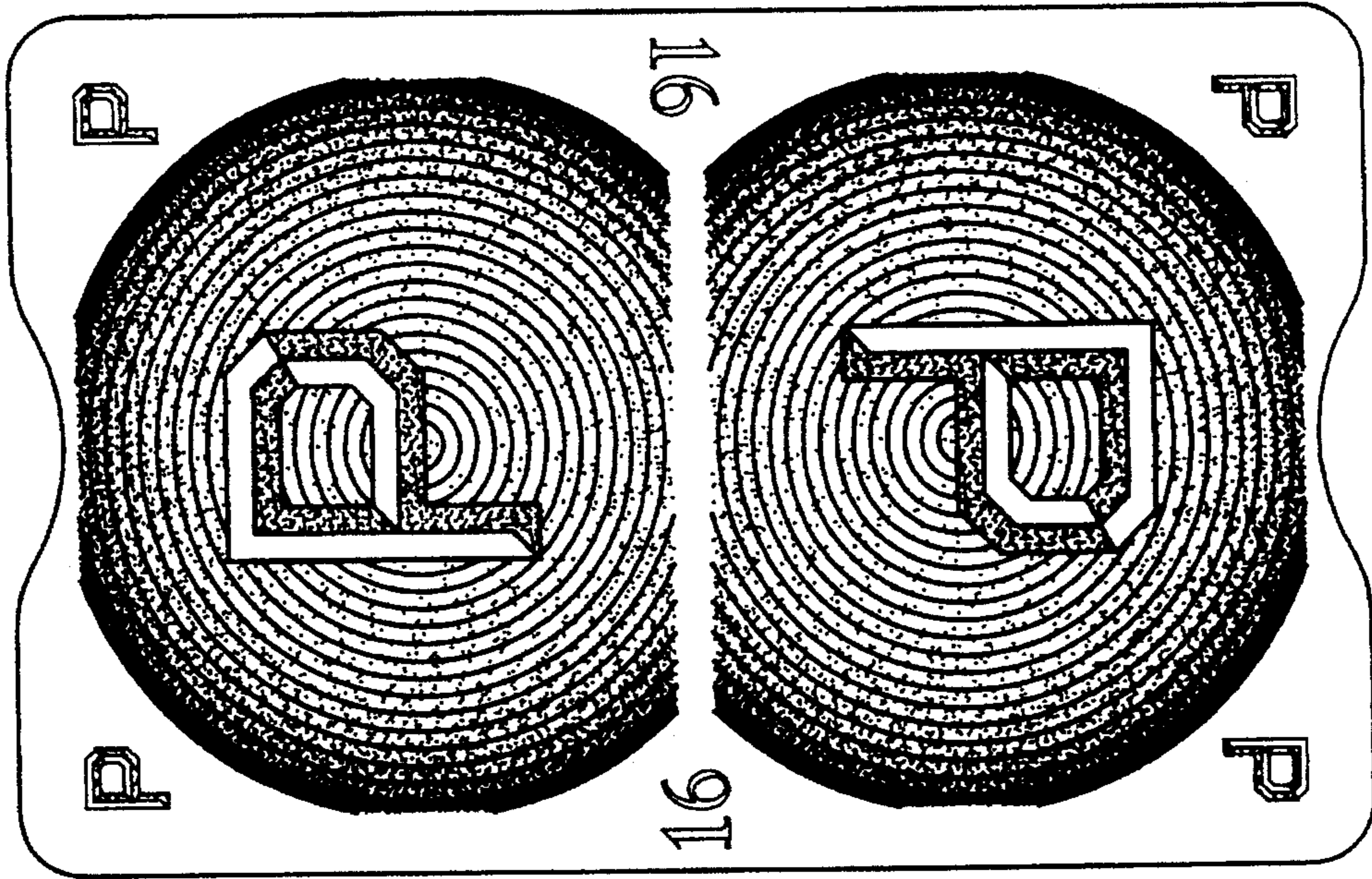

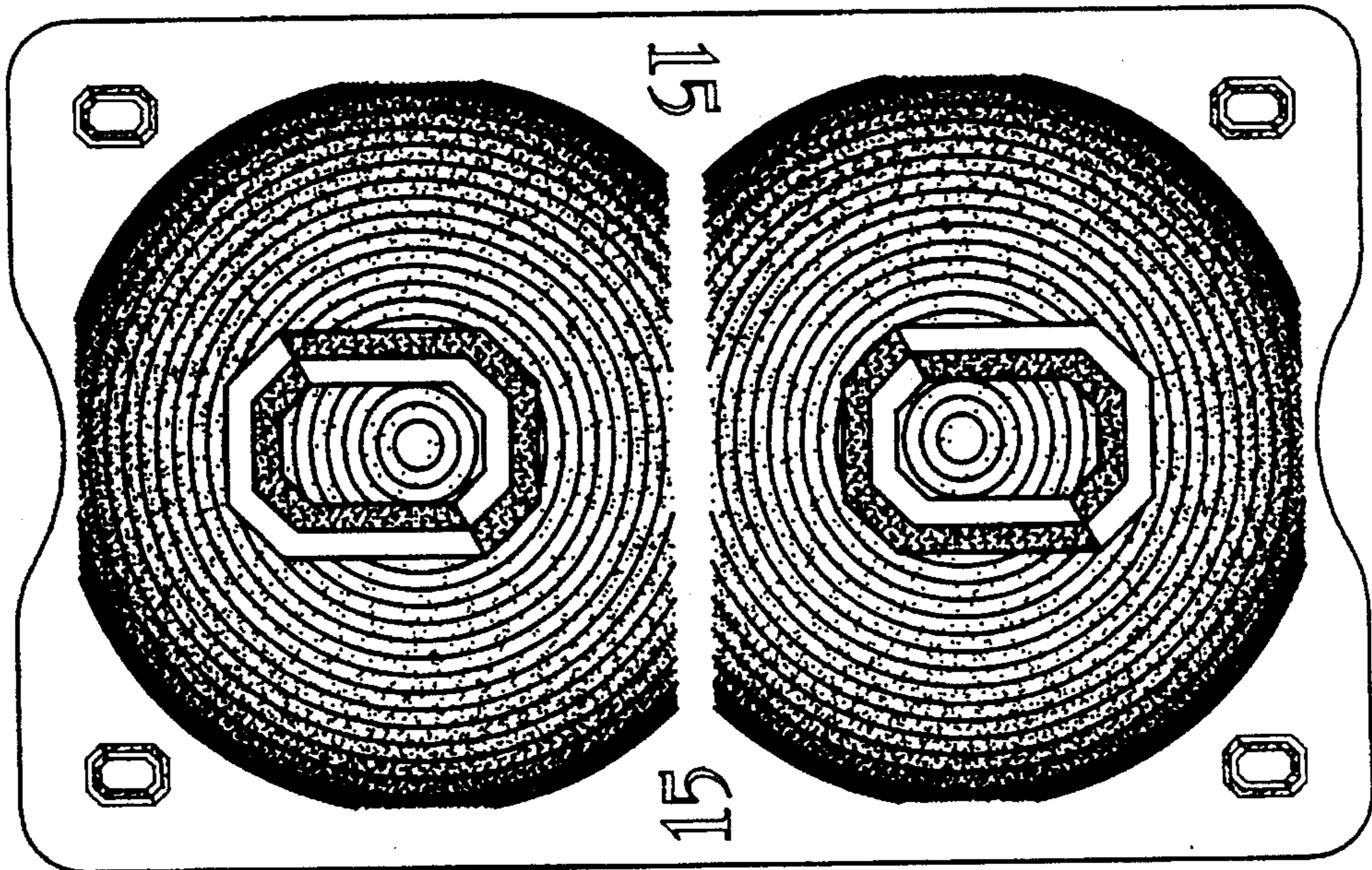

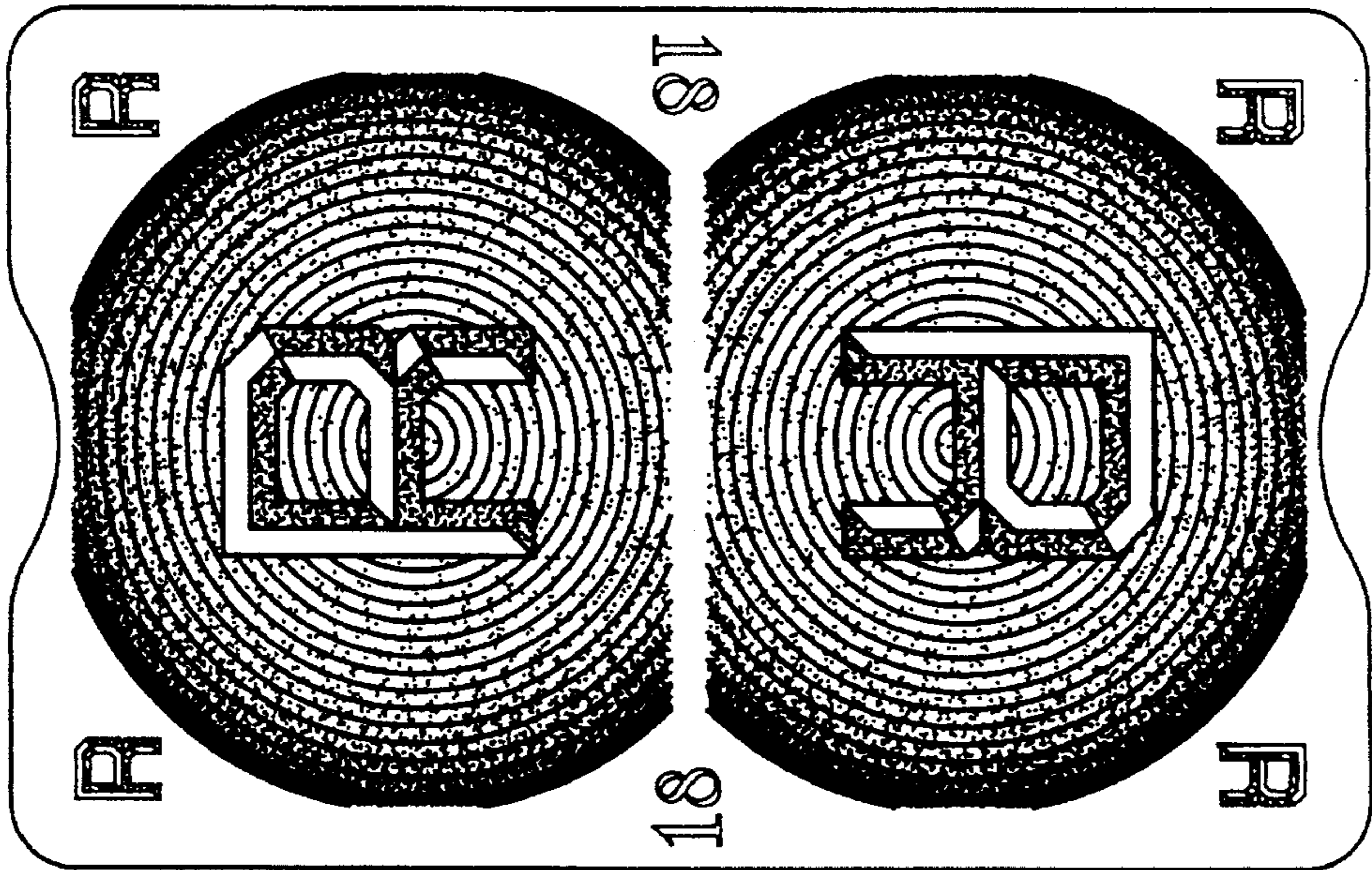

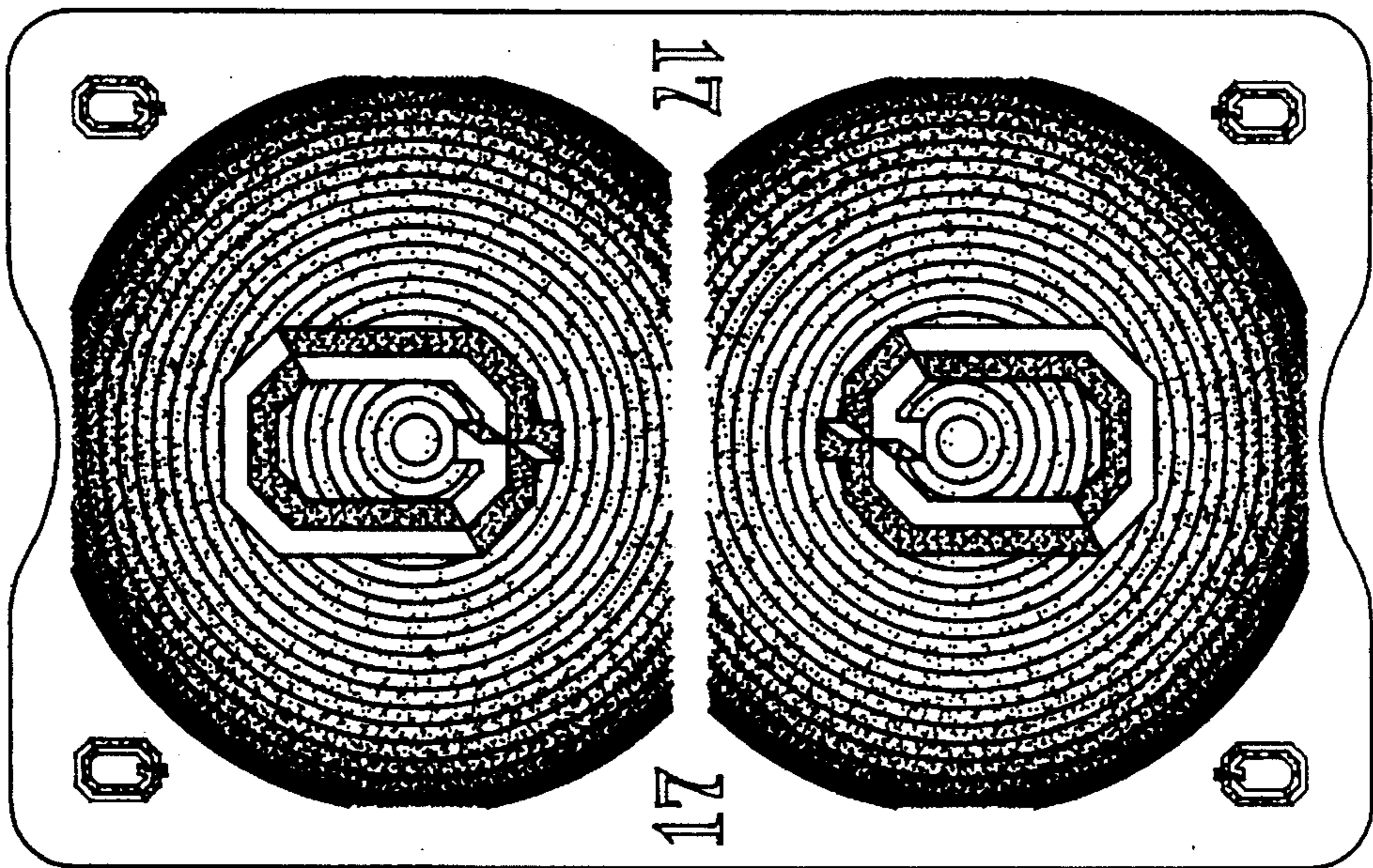

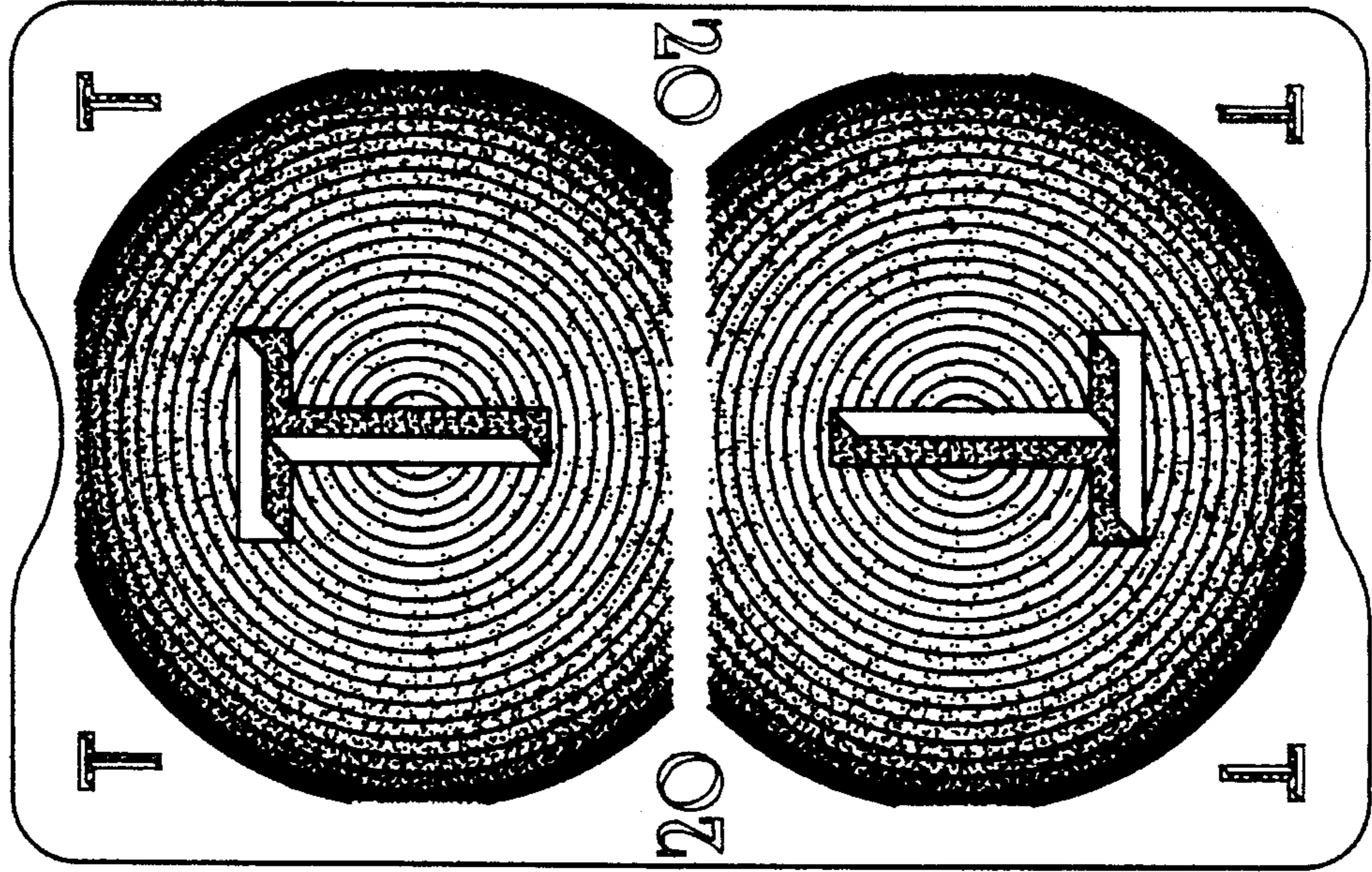

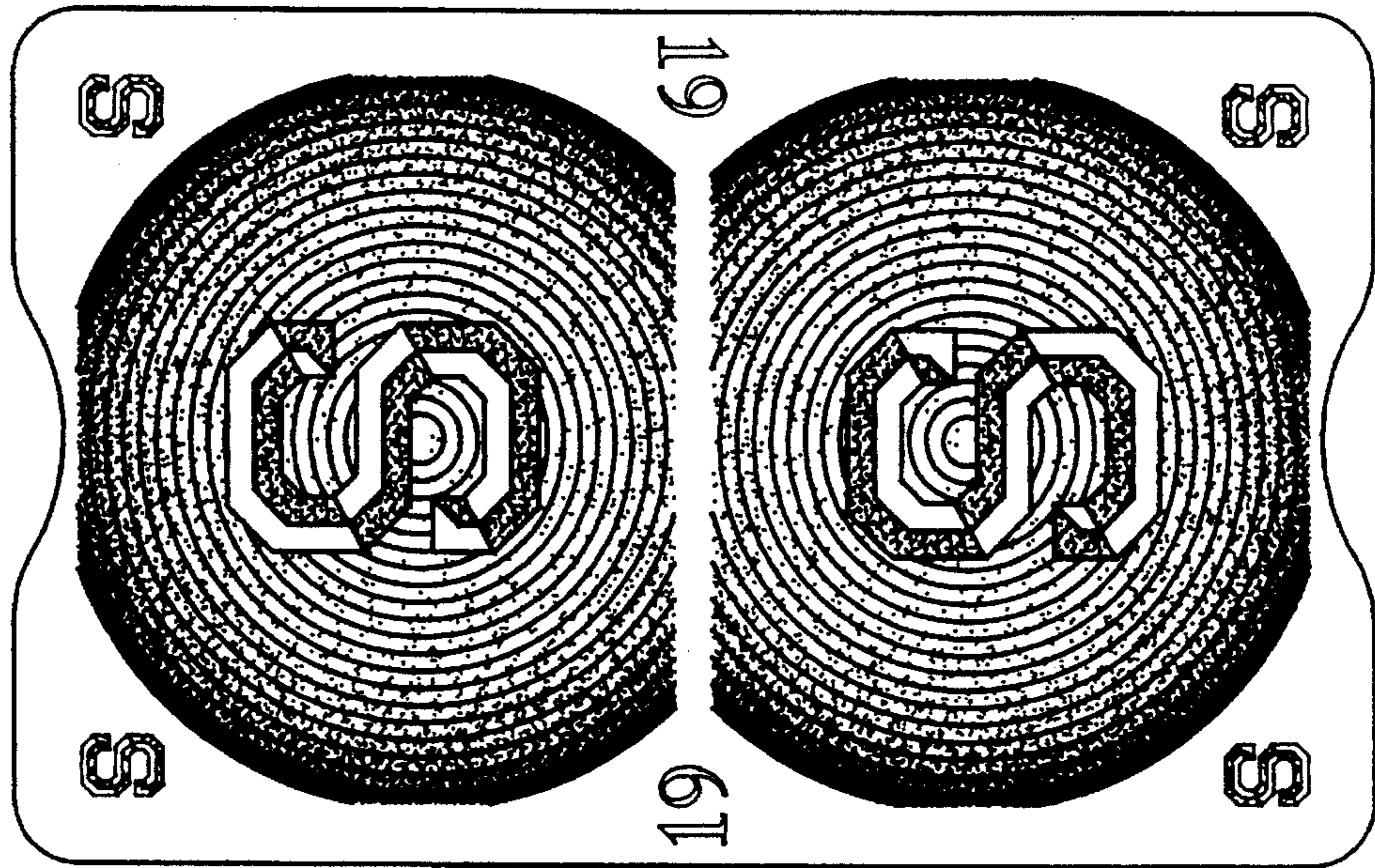

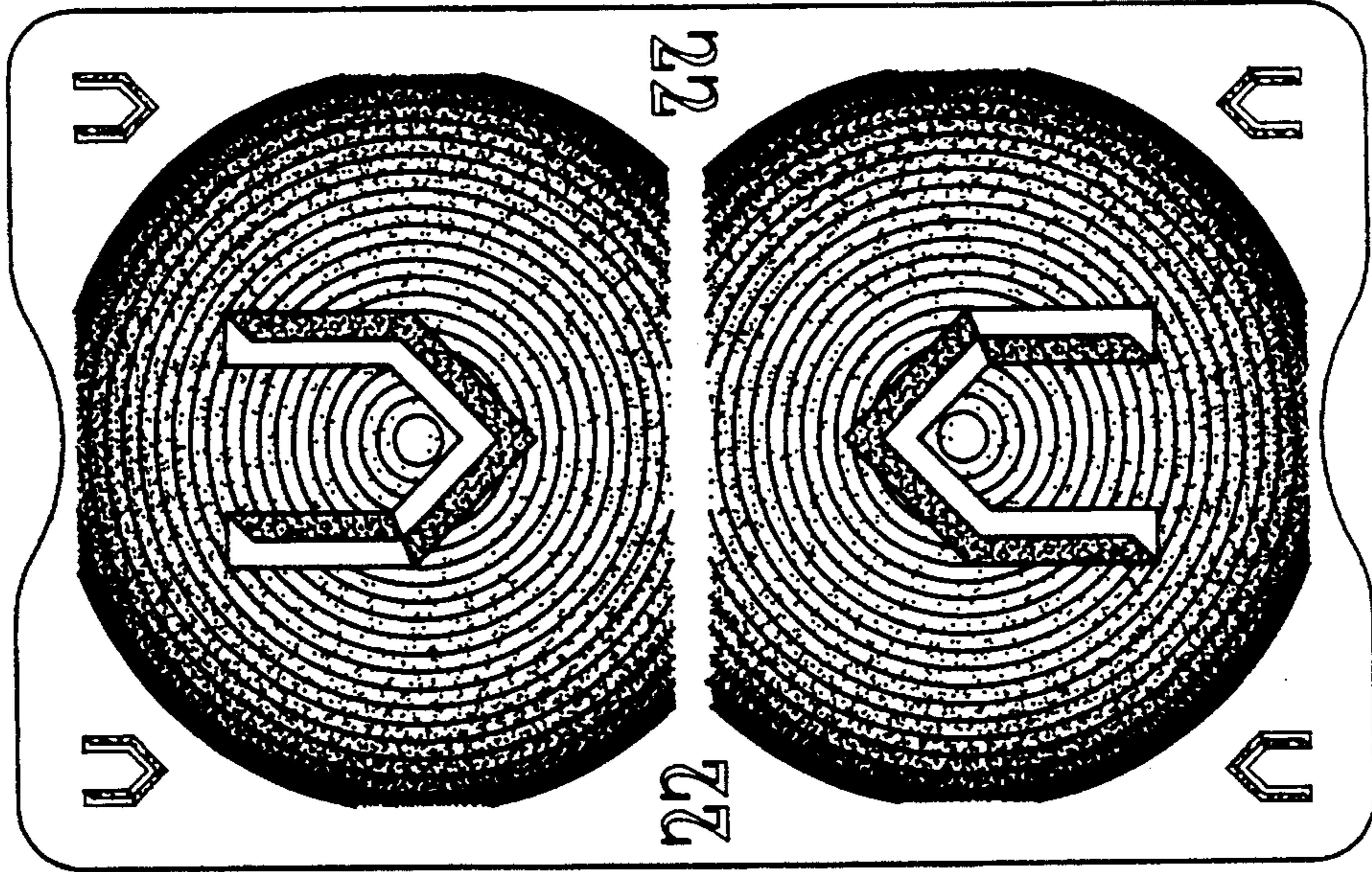

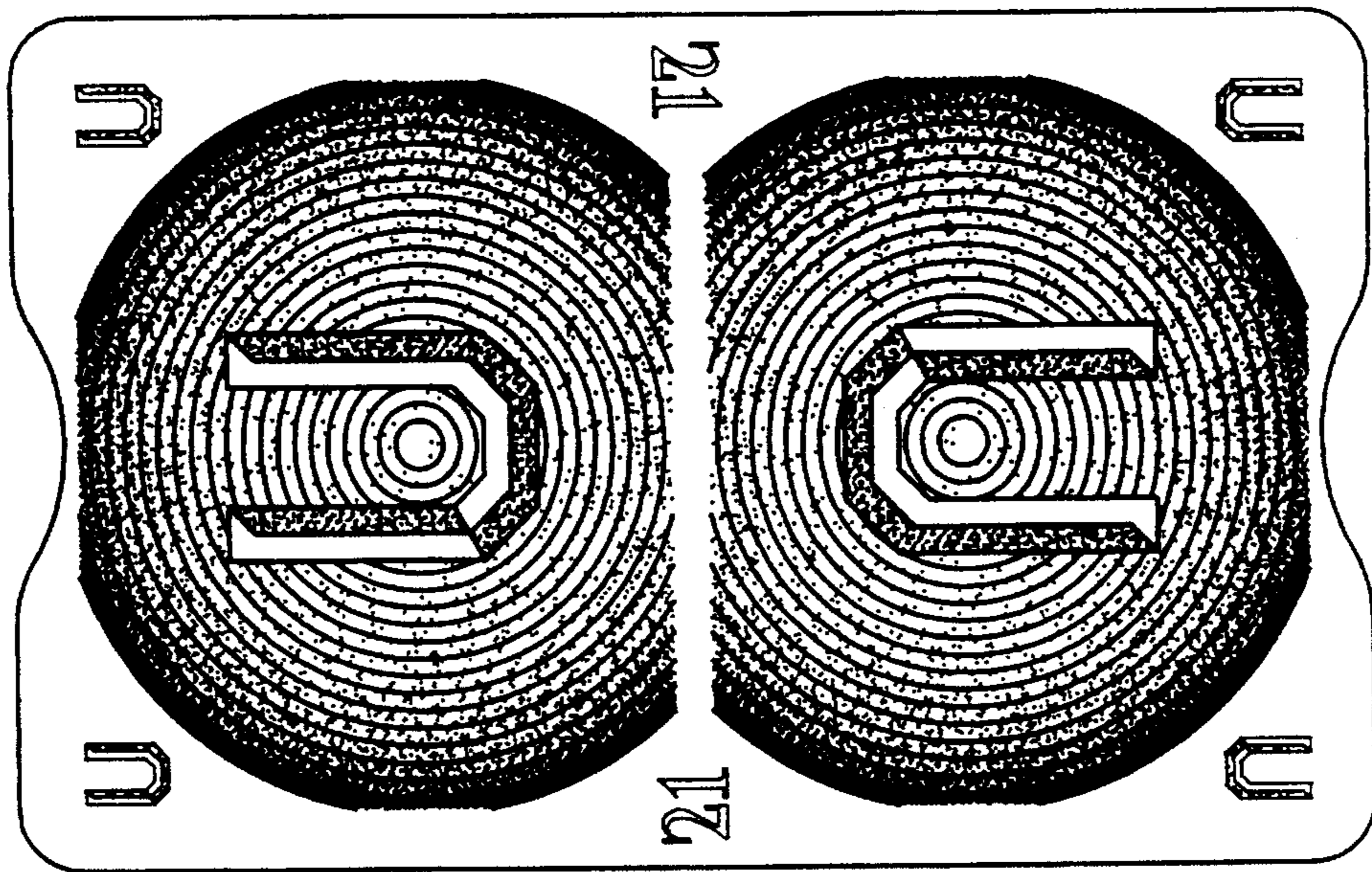

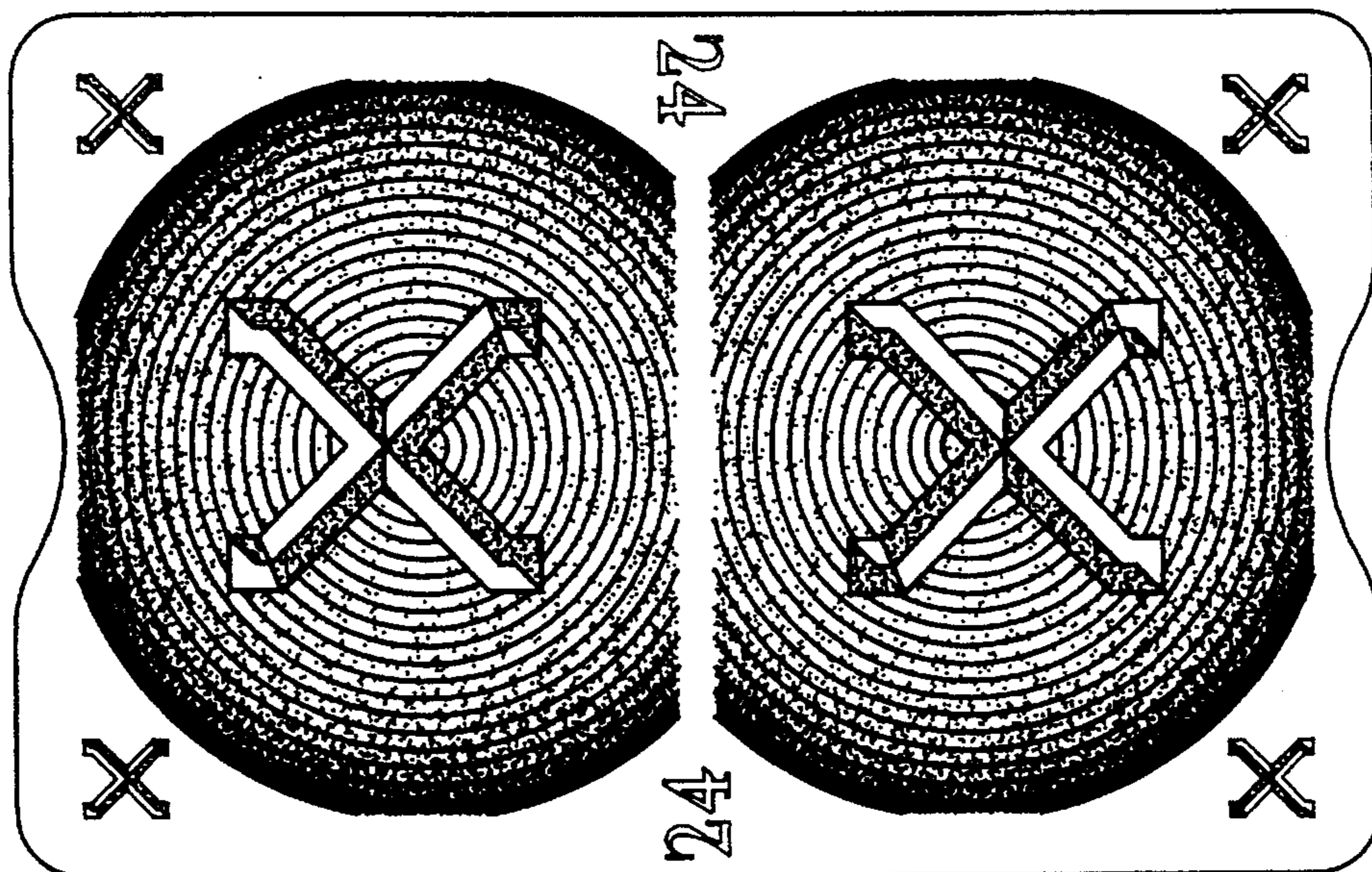

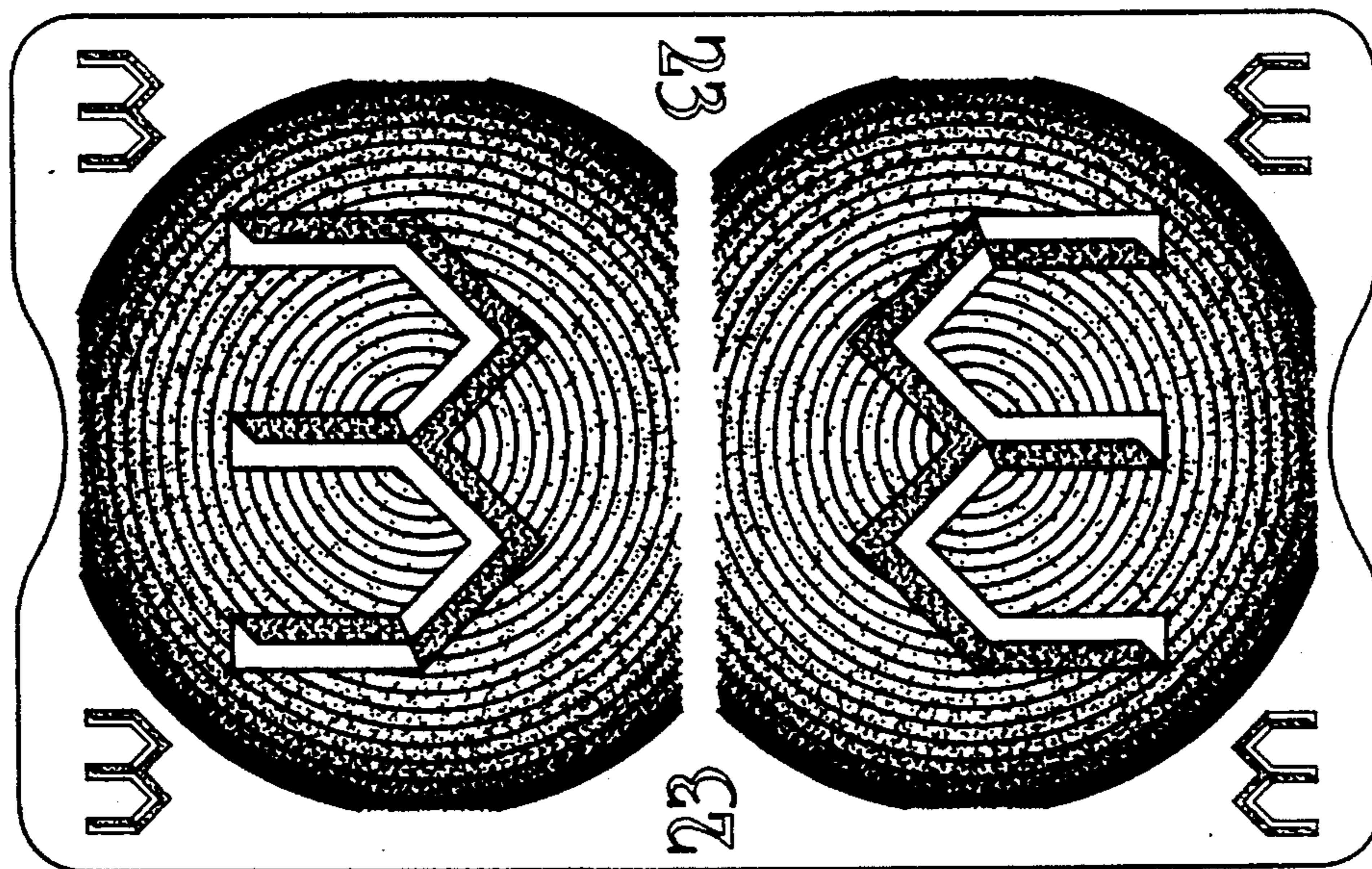

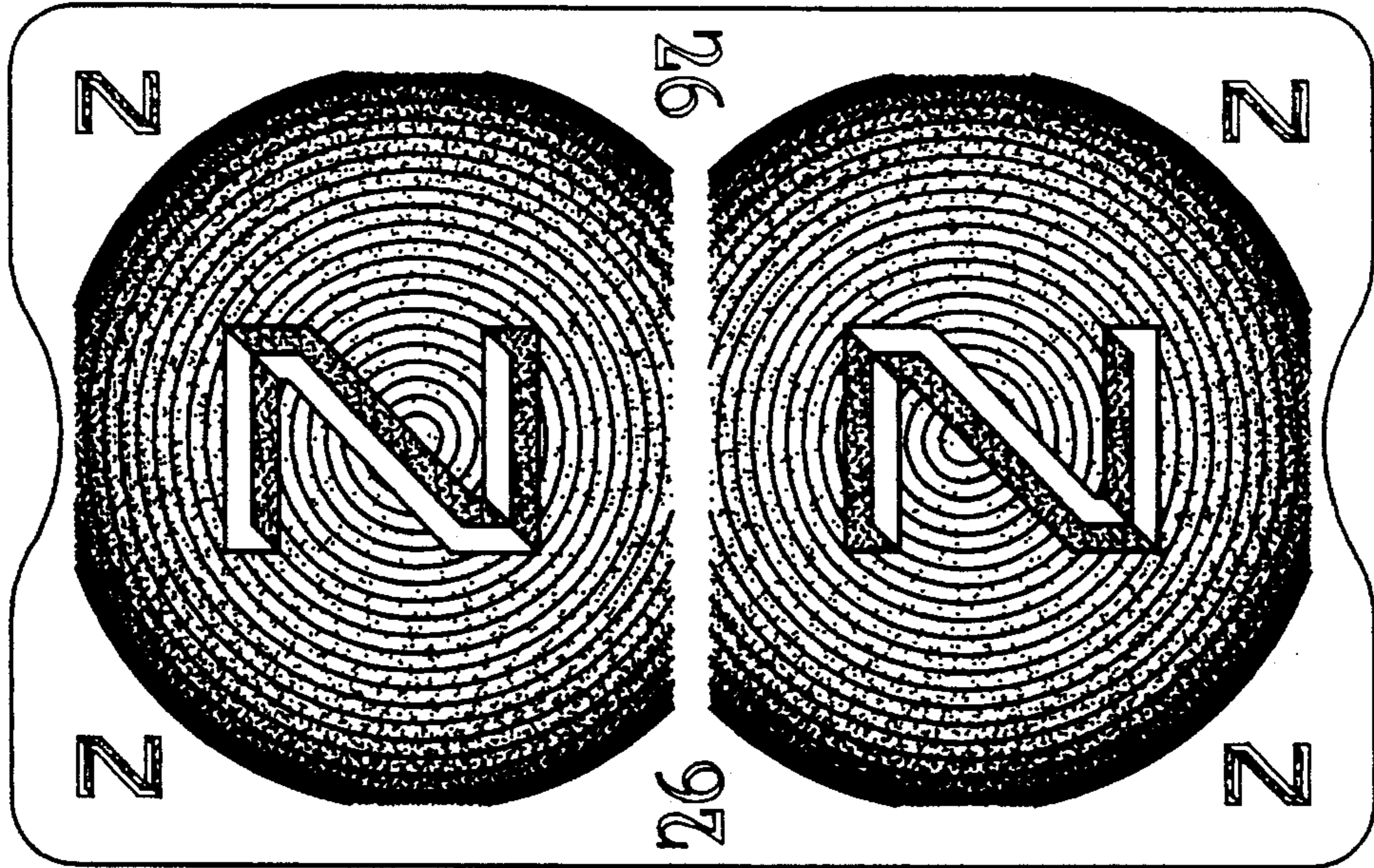

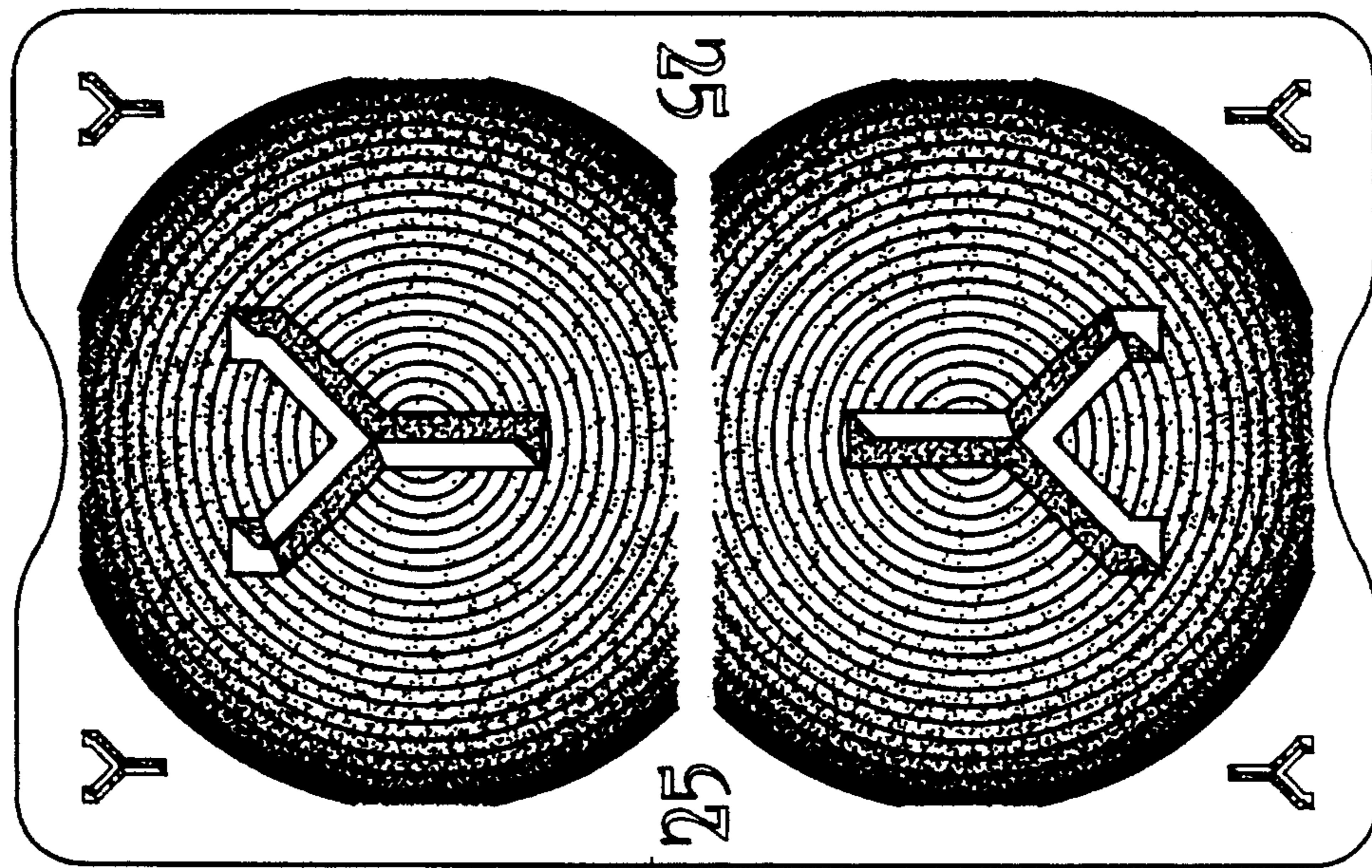

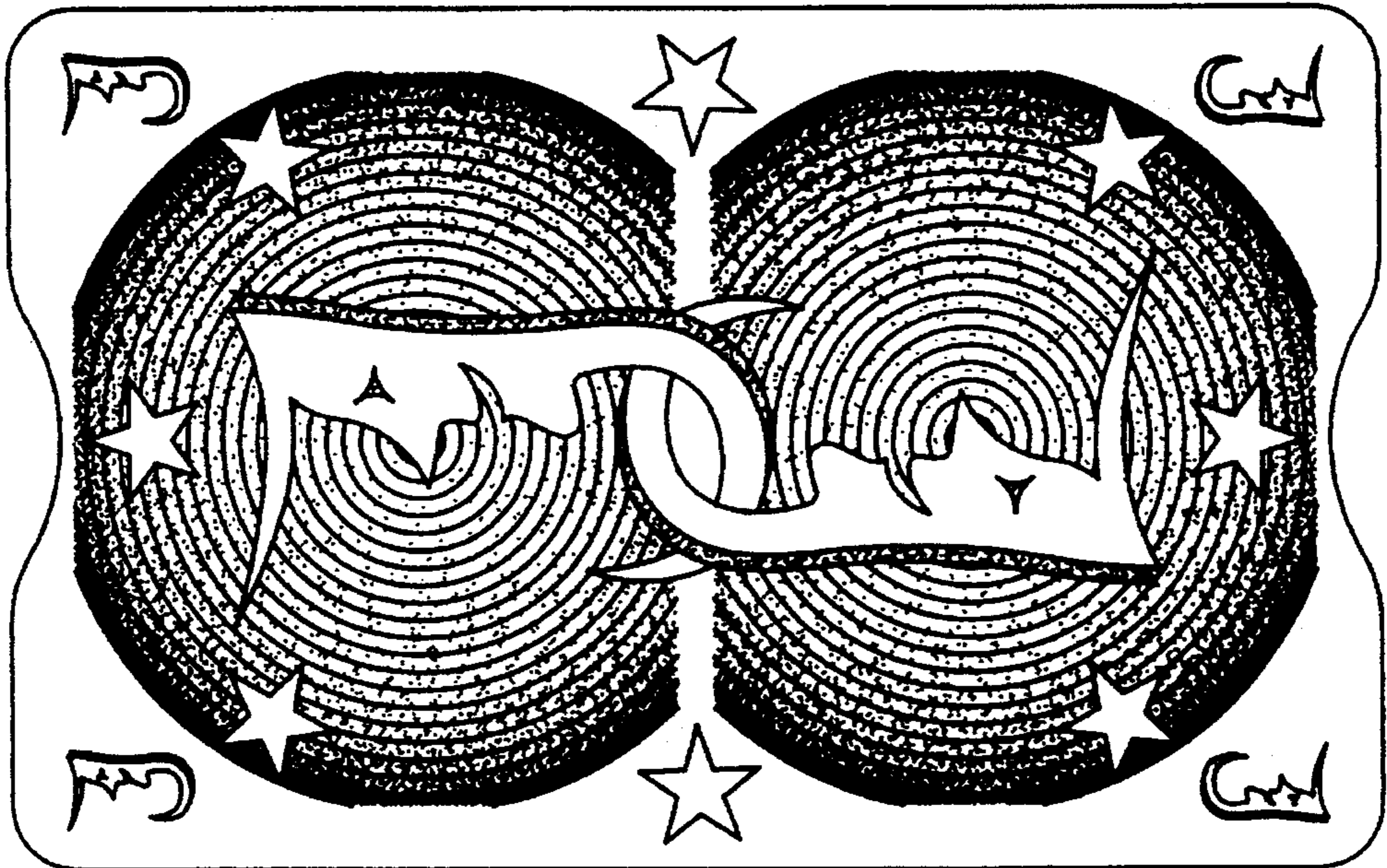

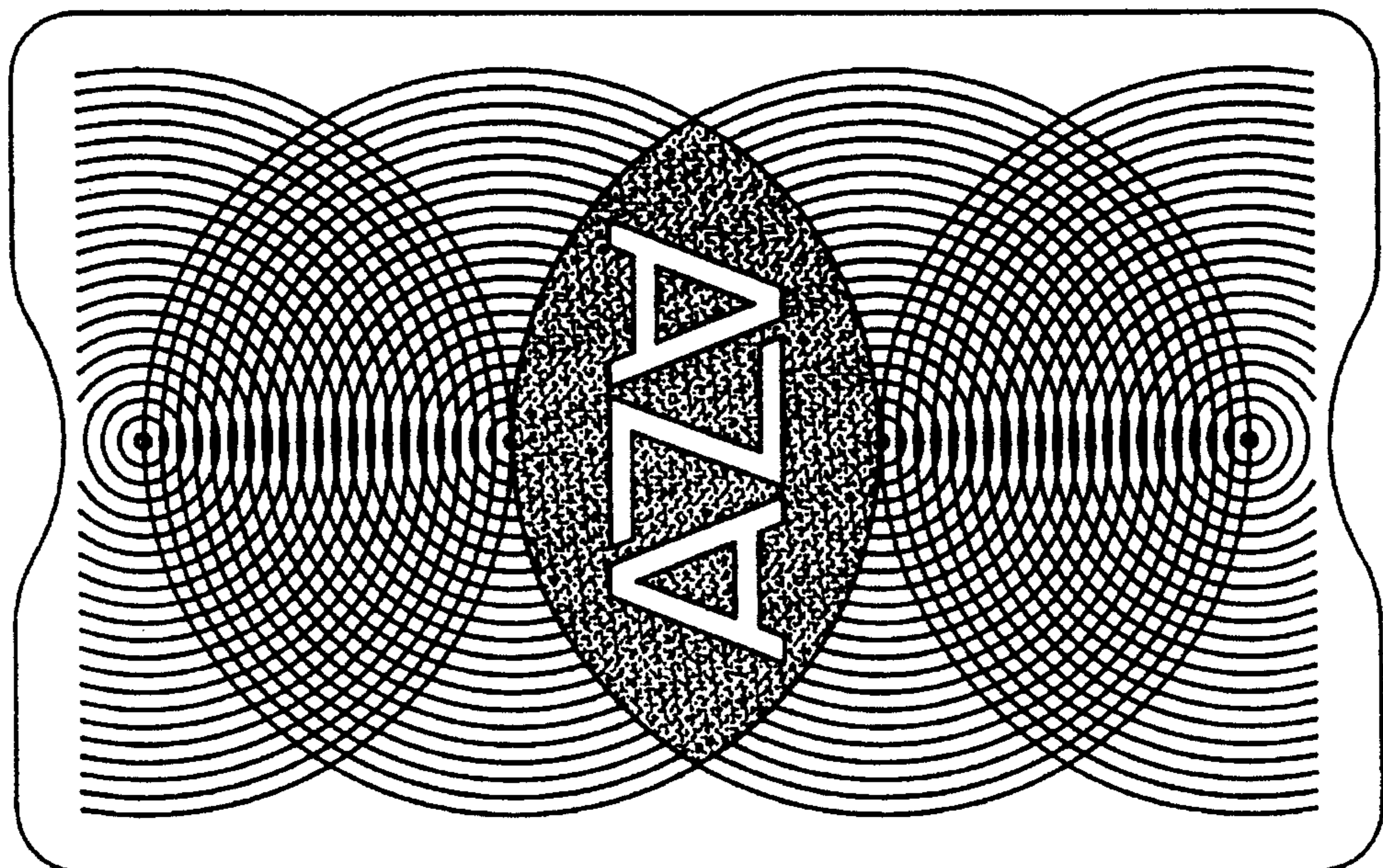
